#### PREFACE

LEONARD ABRAHAM BRADLEY was a descendant of Allen BALL through MARY BALL (daughter of DEACON STEPHEN BALL), who married ABRAHAM BRADLEY, his grandfather.

ABRAM BRADLEY, as he was generally known, was born in New Haven, Connecticut, March 14th, 1833, and graduated at Yale College in the Class of 1855, of which he was the Vice-Secretary for many years. After studying for a few months at the Union Theological Seminary of New York, he decided to follow the law as his profession. He graduated at the Yale Law School, '55-56, and was admitted to the Bar Association of New York in 1858, and to the Connecticut Bar in 1870. He resided in New York for thirty years and was for a long time in the office of STRONG & CADWALADER, whose Senior partner, MR. CHARLES E. STRONG, was his cousin. Mr. BRADLEY was a well known Real Estate specialist. He never married and passed away in New Haven, April 18th, 1898.

MR. BRADLEY commenced his genealogical studies soon after leaving College. This MS of the BALL GENEALOGY, dated October 21st, 1864, was the second of his studies on the subject, and it seems to have been then completed and ready for the press. Just about that period he began the study of the BRADLEY FAMILY. He first prepared his MS including many collateral groups of the family of ISAAC BRADLEY, but finding the work too voluminous, he reduced it somewhat, and in that abridged form it was found at the time of his death. MR. BRADLEY also prepared other MSS relating to his maternal ancestry, the SELLECKS and the ST. JOHNS of Norwalk, but they were left quite incomplete.

#### \* \* \*

The following pages give evidence of the thorough manner in which Mr. BRADLEY carried on his investigations about family history. As his copious foot-notes show, he consulted all available Historical, Real Estate and Probate Records and visited Cemeteries and places of interest connected with the HISTORY OF THE BALL FAMILY. It is a remarkable fact that, as far as our inquiries go, there has been no BALL GENEALOGY up to date as full and detailed as MR. BRADLEY's, which was written fifty years ago. It is true those inquiries have only related to the New Haven Branch of the BALL FAMILY in connection with the SHIPMAN FAMILY of New Haven, descendants of Edward Shipman, of Say Brook (1635).\* The only BALL GENEALOGY extant seems to be a fragmentary one in the New England Gen. & Bio. Reg. for April, 1907, and it is to be hoped that this issue may be the foundation for the work of some other BALL descendant who will continue the record down to the present time. It was deemed proper to publish this MS without additions, except an Index for easy reference, as it is desired that it should go forth as a MEMORIAL of our late cousin, LEONARD ABRAM BRADLEY, whose researches command our grateful admiration.

#### BALL FAMILY.

#### PART FIRST: THE SURNAME.

The name of Ball is suggestive of sports, and would incline one to think that the first of the name must have been a great ball player, and excelled in the game.<sup>1</sup>

But let us look at the manner in which the name is spelt on the New Haven Town Records. Here we find that the name was spelt formerly in divers ways, sometimes Ball, sometimes Balle, Bale, Baell.

Now we find that Baell corresponds to the Anglo-Saxon word Báel, which means a funeral pile; and Ball approaches the Saxon word Báld, denoting bold, audacious; and Lower, in his work on surnames, states that Ball is a diminutive of Baldwin, which latter name is an Anglo-Saxon word, meaning bold in battle (win-battle).<sup>2</sup>

I am of the opinion that the word Ball means bold, courageous, and implies that the first owner of the name showed himself to be possessed of these qualities in a remarkable degree.

## PART SECOND: THE PROGENITORS OF THE BALL FAMILY IN THE UNITED STATES.

There were many persons of this name who arrived in this country early in its history and settled at various points.

There was one Matthew Ball living in Dorchester, Mass., as early as 1652, and we find his name affixed to a petition to the General Court in 1664, but that is all we know of him.<sup>3</sup>

There was also one Richard Ball, who, with Mr. Christopher Ball, was added to the townsmen and commoners of Salisbury, Mass., in 1650. Richard Ball removed to Dorchester, Mass., in 1668, "where he remained," it is said, "only for a short time." He was taxed at Cochechae in 1668, and it is mentioned that he was a trader. Probably, by reason of his pursuit, he moved about from one place to another, and while having his residence in one place, his business would compel him to be absent therefrom in divers other places.<sup>4</sup> There was a Richard Ball, who was made a freeman at Wells, Mass., July 6, 1653.<sup>5</sup>

In the list of "passengers for Virginia, July, 1635," (who were to sail from England that year and who were "examined by the minister of the Town of Gravesend of their conformitie" to the established religion), there appears the name of Richard Ball, aged seventeen. 'He, with others, "embarked in the

Assurance de Lo: Isaack Bromwell and Geo. Bowsie, Master." As "New England in those times was often spoken of as North Virginia" and as many of the emigrants, given in the aforesaid list of passengers, did in fact settle in New England, we are led to presume that Richard Ball (whose name is given in the list aforesaid), also settled in New England, and that he was the same person spoken of above as of Salisbury, Mass., in 1650; of Wells, in 1653, and of Dorchester, in 1668.<sup>6</sup>

We have been unable to determine whether he left any descendants.

Again: There was a John Ball admitted freeman of Concord, N. H., in 1650. It is said that he brought over with him from Wiltshire, England, two sons: (1) Nathaniel, and (2) John. Bond says, that besides these "he probably had other children."<sup>7</sup> He died November 1st, 1665.

(1). Nathaniel Ball (son of the first John) "settled in that part of Concord which is now a part of Bedford." His wife's name was Mary. "By her he had John, who died July 27th, 1649; Nathaniel, born September 28th, 1649, who died at the age of two months; Ebenezer, Eleazer, John, born August 15th, 1660, and perhaps others.<sup>8</sup>

(2). John Ball (son of the first John) was a tailor and lived in Watertown, Mass. He married Elizabeth, daughter of John Pierce, and had the following named children, viz: John, born in 1644; Mary, Esther, Sarah, born in 1655, and Abigail, born April 20th, 1658, and died soon after. His wife

became insane and gave much annoyance to the family. After her death he married, October 3rd, 1665, Elizabeth, daughter of Thomas Fox, of Concord (afterwards of Watertown), and by her had Joseph, born March 12th, 1669-70. He removed to Lancaster in the month of October, 1665, "where he was killed by the Indians September 10th, 1675. His estate was administered by his son John, of Watertown, February 1st, 1677-8"<sup>9</sup>

Again: There was an Edward Ball living in Branford, Ct., as early as October 30th, 1666. His name appears amongst the signers of a "New Plantation and Church Covenant" for the town of Branford made January, 1667. He removed that year with many of the inhabitants of that town to Newark, New Jersey. He had the following named children, viz: Caleb, Abigail, Joseph, Lydia, Moses and Thomas, of whom the last named was progenitor of a great multitude.<sup>10</sup>

Again: Francis Ball, of Dorchester, Mass., removed to Springfield, Mass., and there married, in 1644, Abigail (daughter of Henry Burt). He had the following children, viz: Jonathan, born in 1645, and Samuel. Francis Ball was drowned in the Connecticut River October, 1648. His widow married next year Benjamin Mun, and afterwards, December 14th, 1676, Lieut. Thomas Stebbins.<sup>11</sup>

Samuel Ball (son of the said Francis) was admitted freeman from Northampton, Mass., in 1681. He died in 1689, leaving the following named children, viz: Francis, Mary, Elizabeth and Abigail. He also left him surviving his wife Mary, who married, April 11th, 1690, Benjamin Stebbins.

There was another Francis Ball living in Dorchester, Mass., in January, 1664. Whether he was related to the Francis Ball, who removed from Dorchester to Springfield, I have not been able to determine. 'His name appears among the signers of a petition presented by the inhabitants of Dorchester to the General Court held at Boston, October 19th, 1664. He married Abigail Salter January 27th, 1664, and had the following named children, viz: John, born April 15th, 1665, and died the next year; Abigail, born August 14th, 1667; Francis, born February 21st, 1669-70, and Benjamin, born August 30th, 1675.<sup>12</sup>

We come now to speak of those members of the Ball family who settled in New Haven, Ct.

Two brothers,<sup>13</sup> named respectively Alling (or Allen) Ball and William Ball, came over to this country probably with the Rev. Mr. Davenport and his goodly company in the year 1637, though their names do not appear on the New Haven Town Records until 1643.<sup>14</sup> It is said that they were members of the congregation that worshipped at St. Stephen's Church in Coleman Street, London, England, over which the

Rev. Mr. Davenport had been rector for some time prior to 1633, and which position he resigned on his conversion to the views of the dissenters. On the return of Mr. Davenport from Holland (whither he went to live on resigning his rectorship) to England, he prepared for departing to America, and many of his old parishioners determined to go with him. Among this company, as we have stated (tradition informs us), were the two brothers, Allen Ball and William Ball, and also Thomas Fugill and his sister Dorothy Fugill, who became the wife of Allen Ball.

This company of colonists, led by the Rev. John Davenport and his friend, Theophilus Eaton, "arrived at Boston in the *Hector* and another ship on the 26th of June, 1637." The company subsequently sailed from Boston for the spot previously selected for them by Mr. Eaton and others of their associates, in the spring of 1638, and arrived at their destination April 14th, 1638. The spot thus selected for the settlement was then known by the Indian name of Quinnipiac, and afterwards by that of New Haven in the Colony of New Haven.

On the 25th of October, 1639, the officers of the colony were chosen. Theophilus Eaton was chosen for Governor, and Thomas Fugill as one of the four Magistrates elected and as Secretary. Thomas Fugill<sup>15</sup> filled the office of Secretary for six successive years. He was also chosen one of the seven pillars of the church formed in 1639.

William Ball died in New Haven, intestate and probably

without issue, in the month of April, 1648. The inventory of his estate, taken on the 30th of April of that year, was presented to the Court held at New Haven. The amount of his estate was  $\pm 13$ . 0.-9d.<sup>16</sup>

The oath of fidelity was administered to Allen Ball on the first of July, 1644.<sup>17</sup>

It appears that the said Allen Ball, together with his wife, Dorothy Ball, and Goody Ball (perhaps his mother), were concerned as principal witnesses in a slander suit brought to trial before the court held at New Haven September 1st, 1646.<sup>13</sup>

Thomas Fugill (having fallen out with the New Haven authorities and been excommunicated and fined for taking more land than his proportion and falsifying orders) became exceedingly dissatisfied with his treatment by the rulers and determined to return to England. He returned to his native land in the year 1646, and we find that Allen Ball and his wife were present to see their brother off; for at a court held at New Haven October 6th, 1646, Allen Ball was complained of for several matters, one of which was "that he was late on training day in the afternoon," but he was excused as "he was with his *sister* Fugill upon her departure."<sup>19</sup>

Prior to the departure of Thomas Fugill for England, he exchanged certain of his lands situate in the town of New Haven, and known at present as Ball's Spring, for land owned by his sister, Dorothy Fugill, and situate in London. It is in

this manner that the Ball Spring property came into the Ball family and it has remained in their possession up to quite a recent period.

We proceed now to speak of the Balls of Virginia. Colonel William Ball, their progenitor (it is said), came over from England with his family about the year 1650 and settled at the north of Corotoman River in Lancaster County, Virginia, and died in 1669, leaving two sons, William and Joseph, and one daughter, Hannah (who married Daniel Fox). William Ball (son of the said Colonel) died leaving him surviving eight sons and one daughter. Five of the sons of the said second William had in the year 1779 male issue.

Joseph Ball (another son of the said Colonel William Ball) had male issue, but it was long since extinct. The youngest daughter of the said Joseph Ball was Mary, the mother of George Washington. Washington's mother was twenty-eight years old at the time of his birth on the 22nd of February, 1732, new style.<sup>20</sup>

We are told, on the other hand, by Irving in his "Life of Washington," that Mary Ball (the mother of Washington) was the daughter of Colonel *John* Ball, of Bridges Creek, Virginia. There is then a conflict between Irving and Lossing on this point, but Lossing is undoubtedly correct, as what he states is evidenced by written statements to that effect on the back of the coat of arms handed down in the Ball family of Virginia and given in his "Mount Vernon and Its Associations" referred to in the note.

Irving also states that the said Mary Ball was the second wife of Augustine Washington, of Bridges Creek, County of Westmoreland, Virginia, and was married to him on the 6th of March, 1730, and was then, to use his language, "a young and beautiful girl, said to be the belle of the Northern Neck." She was not only justly celebrated for her beauty, but was also at the same time known to possess eminent qualifications for her position as head of a family. "A lady of the 'old school,' possessed of a strong mind and sound judgment, she united with great simplicity of manner, energy, honesty, and truthfulness. Her house, the home of hospitality, was also the home of order, neatness, economy, and domestic industry. She was a strict disciplinarian, and by her decision and consistency of character, she obtained over her children and dependants an uncompromising but benign control."<sup>21</sup>

This model for American mothers departed this life in the month of August, 1789, at the age of eighty-three years.

#### PART THIRD: THE BALL COAT OF ARMS.

In speaking of the Ball coat of arms we shall confine ourselves to that handed down in the Virginian and New Haven branches of the family.

That belonging to the New Haven branch is Argent a Lion passant Sable on a chief of the second, three Mullets of the first. Crest—a stag trippant proper.

#### Motto: "Semper Caveto."

This was handed down in the family and a copper plate containing them is in the possession of Hon. Flamen Ball, of

Cincinnati, O., who inherited it from his father (Flamen Ball, Esq., of New York City), who died in 1816, leaving a will, dated February 19th, 1816, wherein he devises, besides other things, his family Bible and "copper plate with the Ball's arms thereon engraved" to his son, Flamen Ball.<sup>22</sup>

Mr. Ball, of Cincinnati, very kindly enclosed to me an impression of the arms taken from the copper plate mentioned.

According to the information given to Mr. Ball by his father this coat of arms was "granted some three or four hundred years since to Sir Richard Ball, Baronet, and has been in the family ever since."<sup>23</sup> I will hereafter notice why I think that this coat of arms was not granted to *Sir* Richard Ball, *Baronet*, three or four hundred years since.

And now as to the coat of arms as preserved by the Virginian branch of the family.

The following meagre description is given by Lossing in his work entitled "Mount Vernon and Its Associations:" "In the possession of a Virginia family may be seen a picture, in which is represented a rampant lion holding a globe in his paw, a helmet and shield, a vizor strong, and a coat of mail and other emblems of strength and courage, and for a motto the words from Ovid: "Coelumque Tueri."<sup>24</sup>

On reference to Burke's Heraldry the only description of any Ball coat of arms answering to either of those above named is the following: Argent a Lion passant sable on a chief of the second, three mullets of the first. Crest—Out

of clouds proper a demi lion rampant sable powdered with estoiles argent holding a globe or.

As Mr. Henry Hays, of New York City (one well versed in Heraldic lore), says: "The description given by Lossing of that in the possession of a Virginia family in every respect answers that above found in Burke, which also suits that in the possession of the New Haven family, the only difference being in the crests and mottos. The additions of a helmet and other like designs are not properly part of the coat of arms, but of necessity appertain to every one. And as to the different crests and mottos, it is to be remarked, that this amounts to nothing, as different members of the same family frequently adopted different crests and mottos. For instance: The Lord St. John of Bletshoe, England, wore the same arms as the Lord Bolingbroke (family name St. John), and rightly, but the two branches wore different crests and different mottos."<sup>25</sup>

Now, whatever may have been the reason why the New Haven branch of the Ball family adopted a different crest and motto (which is a matter of no importance), yet we find both branches possessing the same coat of arms, to-wit: "Argent a Lion passant sable on a chief of the second, three mullets of the first," and this identifies the two branches as belonging to the same immediate family, and makes the presumption very strong that the progenitors of the two branches were brothers. Probably the progenitor of the Virginian branch was the elder brother.

But, furthermore, respecting the person to whom the arms were granted, I would say, that on sending through Mr.

Henry Hays, of this city, to the Heraldry office in London, England, I learned that the above arms and crest as described in Burke's Heraldry were granted by Sir William Segar Garter, 22nd of December, 1613, to Richard Ball, Doctor of Divinity, the son of Lawrence Ball, of Northampton. From this it would seem that the information obtained by Hon. Flamen Ball, from his father, that the arms in his possession, as above described, were granted to Sir Richard Ball, Baronet, three or four hundred years since, is incorrect, and that they were truly granted to Richard Ball, Doctor of Divinity, in 1613.

We find the name of the grantee was correctly given, but not his rank nor the time of the grant.

From this further evidence of the grant and the name of the grantee coinciding with that given by tradition, we have still stronger evidence that the progenitors of the New Haven and Virginian branches were of the same immediate family and must have been brothers, for the time when the grant was made, in 1613, to Richard Ball, D. D., closely approaches the time when they settled in this country.

### PART FOURTH: GENEALOGY AND HISTORY OF THE BALL FAMILY OF NEW HAVEN, CT.

We have shown in the third part of this history the relationship subsisting between the progenitors of the New Haven and Virginia branches of the Ball family and we will not repeat here.

Allen, or Alling, Ball, as we have stated before, was the progenitor of the New Haven branch. In the year 1650 he became the farmer of the Rev. Mr. Davenport by appointment. The farm, of which he thus received the charge, was laid out in the year 1649 "on the East side of the East River," being a tract of land a mile square, containing six hundred acres, above Dragon (now Fair Haven). "While in Rev. Mr. Davenport's employ he was exempted from militia service."<sup>26</sup>

Alling Ball obtained a farm for himself in 1703, "north of the Davenport farm."<sup>27</sup> He was a prominent man in the . village of East Haven, and was often entrusted by his fellow citizens with matters of public trust, as was also his son, Alling Ball, Jr. It would be useless, however, to cite here the numerous instances in which the public confidence was . exhibited towards both father and son.<sup>28</sup>

From time to time they were enabled to add to the real estate which they already possessed, and the town records. indicate the growth of their prosperity.<sup>29</sup>

Alling Ball, Jr., was appointed a Captain in the militia service during the Indian difficulties in 1689, when the town. of East Haven "prepared a flying army, which stood ready to march at a moment's notice."<sup>30</sup>

We proceed now to give the genealogical history of this family from the first Alling Ball, tracing out all his descendants, so far as we have been able to do this, down to the year 1864—
