THE BEARDSLEY FAMILY IN AMERICA

WILLIAM BEARDSLEY, the progenitor of the family in America, was born in England in 1605, probably at St. Alban's, Hertfordshire. He was a mason by trade.

He sailed from England 2 April 1635 in the ship "Planter," and landed in Massachusetts a month or so later, accompanied by his wife Mary (age 26), daughter Mary (age 4), son John (age 2), and son Joseph (age 6 months).

He was admitted a freeman of Massachusetts in 1638; and resided there for several years. In 1639 he and seventeen others moved to and settled on a piece of cleared ground on Long Island Sound, and probably founded and named the place Stratford (Conn.)

Was deputy of the General Court at Hartford (equivalent to our Legislature of today) for eight sessions between 1645 and 1661; was one of the founders of the First Congregational Church of Strateford.

He died in 1661. In his will, probated 6 July 1661, he calls himself "William Beardsley, of Strat-ford...."

Children: Mary, b. 1631; John, b. 1633; Joseph, b. 1634; all three in England; Samuel, b. 1638, the first American-born Beardsley; Sarah, b. 1640, Cupheag, Conn.; Hannah, b. 1642, Stratford; and Daniel, b. 1644, doubtless also at Stratford.

JOSEPH BEARDSLEY (William), b. Nov. 1634, in England; came to New England with his parents in 1635; m. in 1665 to Abigail Dayton, of Long Island; took oath as freeman 4 June 1668; joined Congressional Church, Stratford, 1693; d. 29 May 1712,

Stratford. Children: Joseph, John, Hannah, Elizabeth, Thomas, Ephraim, Jonathan, Josiah.

JOHN BEARDSLEY (Joseph, William), b. 4 Nov. 1668; a blacksmith by trade; m. Abigail Wakelyn; d. 29 Nov. 1735. Children: Abraham, Jehiel, Caleb, Deborah, John, Andrew.

JOHN BEARDSLEY (John, Joseph, William), b. 9 Mar. 1701; m. Keziah Wheeler 29 Dec. 1725; resided at Ripton (now Huntington), Conn. Children: Augustin (or Austin), Obadiah, Patience, John, Jehiel, Eunice, Joseph, Charles, Paul.

OBADIAH BEARDSLEY (John, John, Joseph, William), b. 2 Oct. 1728, Stratford, Conn.; m. 1751 to Amy Calkins; for some years resided in Fredericksburg, Dutchess County, N. Y.; in 1790 moved to Monticello, Otsego Co., and finally to Richfield, and died there 1807. Children: Eunice, Jemima, John, Sarah, Levi, Obadiah, Partridge Thacher, David.

CAPT. LEVI BEARDSLEY (Obadiah, John, John, Joseph, William), b. 18 Mar. 1761; m. 10 Nov. 1784, to Sarah Smith; enlisted 14 May 1813 as Sergeant in 30th U. S. Inf., promoted to Captain, discharged 31 Dec. 1813; d. 23 June 1844. Children: Sally, Obadiah, Eunice, Jesse, Elisha, Sylvia, Levi Smith, and William D.

ELISHA BEARDSLEY (Levi, Obadiah, John, John, Joseph, William), b. 4 Aug. 1795; m. 9 July 1818, to Caroline Marvin; d. 9 Feb. 1882, Rock Island, Ill. Children: Polly, Phoebe, Eunice, Ezra Marvin, Asenath, Seth, Elisha I., Harriett M., James M.

LT. COL. EZRA MARVIN BEARDSLEY (Elisha, Levi, Obadiah, John, John, Joseph, William), b. 4 Oct. 1827,

Ashland, Genesse County, N. Y.; m. 8 Feb. 1848, Mercer County, Ill., to Sarah (b. 11 Nov. 1821, Allegany County, Penn., d. at Chicago, Ill., as the clock was striking midnight on the break between the 10th and 11th of Nov. 1911), dau. of John and Mary (Cline) Lemon (erroneously reported in the 1902 Beardsley Genealogy as Simon), gdau. of Isaac and Rebecca Lemon.

Ezra Marvin Beardsley moved with his parents and family to Rock Island, Ill., in 1844; elected Sheriff of Rock Island County, 1855; studied law and was ad-

mitted to the bar in 1859.

In 1861 he enlisted in the "three months service" and was commissioned Lieutenant in the 69th Ill. Vol. Inf.; was later Post Adjutant at Camp Douglas, a military prison near Chicago; on expiration of his enlistment returned to Rock Island.

Reenlisted 2 Oct. 1862, helped recruit six companies of the 126th Ill. Vol. Inf., was elected Lt. Col. of that regiment, and served with the Army of the Tennessee, being wounded at Shilo. His regiment was later transferred to Arkansas, and he was appointed Post Commander at Devall's Bluff on the White River.

He was honorably discharged 15 Aug. 1864, and resided in Rock Island until 1868 when he moved to Rushford, Minn. In 1869 moved to Parker, Montgomery County, Kan., where he was later County Commissioner, and served two terms in the state legislature, and in 1872 as U. S. Commissioner for Kansas and Indian Territory; 10 April 1872 was certified for the practice of law, District of Kansas; in 1876 moved to Cimarron, N. Mex., for a short time, and then to Siloam Springs, Arkl; in 1880 moved to Ottawa, Kan.; in 1883 to Lake City, Barber County, Kan., where he died 24 May 1885.

Children: Mary Catherine, Seth Marvin, Ezra Irving, William Lincoln, and Albert Lemon.

WILLIAM LINCOLN BEARDSLEY (Ezra, Elisha, Levi, Obadiah, John, John, Joseph, William), b. 4 Nov. 1860, Rock Island, Ill. Moved with his parents in 1869 to Kansas, resided in various places (see Ezra Marvin

Beardsley) until 1880 when he settled in Ottawa, Kan.

As a young man he worked in the division offices of the A. T. & S. F. Ry. in Ottawa, and was division storekeeper for several years until his resignation in 1898.

He married at the home of his bride's parents near Sand Creek, Franklin County, Kan., 30 Sept. 1884, to Maggie Olive (b. 16 Mar. 1867, in Honey Lake Valley, near Marysville, Cal., d. 26 Feb. 1950, Arnett, Okla.), dau. of Griffey Garten and Sarah Ann (Atterberry) Miller.*

In 1898 he moved with his family to a farm near Hopeton, Woods County, Okla.; in 1899 to a ranch on Eagle Creek in the same County; in 1900 sold out and moved to Medicine Lodge, Kan., for about a year, and in 1901 to a farm which he homesteaded about three miles west of Gate, Beaver County, Okla.

During the next few years he was engaged for a short time in the lumber, hardware and farm implement business in Englewood, Kan.; was engaged by the Beaver County commissioner to audit the county books for the first time since the county was organized; then to Gate, Okla., in the drug business, as publisher of the Gate Valley Star, and as U. S. Commissioner.

In 1907 he moved to Beaver City where he served two years as County Clerk, then back to Gate, Okla., in 1909; in 1912 to Forgan, Okla., as Land Commissioner for the newly built M. K. & T. Ry.; in 1922 was Grand Chancellor of the Oklahoma Knights of Pythias; in 1929 to Arnett, Okla.; d. 10 Nov. 1932, Shattuck, Okla., and was buried at Alva, Okla.

GRIFFEY GARTEN MILLER FAMILY

Griffey Garten Miller, son of James Griffey Miller and a Miss Garten, was born 1 April 1830, in Jackson County, Ohio; married 25 December 1853, at Warsaw, Ind., to Sarah Ann, dau. of Edward and Ann (Poor) Atterberry; and died 17 July 1909, Alva, Okla.

Leaving his family behind him in Indiana, he migrated by wagon train to California in 1859, and settled in Northern California. After a period of fruitless mining and prospecting for gold, he engaged in farming and trucking in the Sacramento Valley, near Marysville.

It was 1864 before he could arrange to bring his family out. His wife and two daughters went from Northern Indiana to New York, thence by boat, and across the Isthmus of Panama, to San Francisco.

In 1867 he recrossed the plains with his family by wagon train (of which he was made Captain), via Salt Lake City and Ft. Bridger, and settled in Lyons County, Kan. An infant child, Charles Wesley, died on the way and was buried at Ft. Saunders, Wyo.

In the fall of 1869 he moved to Osage County, and in 1874 to a farm near Burlington in Coffey County. In 1880 he moved to Siloam Springs, Ark.; to Ottawa, Kan., in 1883; in 1896 to a farm near Medicine Lodge, Barber County, but returned to Ottawa in 1891. In 1898 he returned to the farm in Barber County, but shortly after moved to Woods Co., Okla.

James Griffey Miller, father of Griffey Garten Miller, was born in Green Bryer Co., W. Va., in 1804, and died in Indiana in 1851. The surname of his wife was Garten, but her given name is unknown. She was born in Jackson County, Ohio, in 1807, and died in Marion County, Iowa, in 1868.

Sarah Ann Atterberry was born 20 Mar. 1837, reported by some as Albany, N. Y., and by others (including her husband's autobiography) as Era Co., N. Y., and died 4 May 1912, Alva, Okla. *** Her father, Edward Atterberry, was born in England, came to America about 1835, and died in Osage County, Kan. Her mother, Ann Poor, was also born in England, and died in Indiana. Among their children were Charles, Sarah Ann, Julia, Wesley, Edward, and Alonzo.

^{*}In the Griffey Garten Miller bible this is given as Plumas Co., but in his autobiography as Lassen.

^{**}In the Miller bible this is given as 1874, but in the autobiography as 1873—the latter probably being correct.

***probably means Erie Co., as there has never been an Era Co. in New York. Two grand-daughters have written records, presumably direct from the grandmother herself, which show Albany as her birthplace.
