### ANCELL

The first of the name in Virginia was Edward Ancell, who was born (so Family Bible) in Oxford County, England, Oct. 4, 1748. After a brief residence in Calvert Co., Md., he bought in Orange Co., Va., April, 1779, 200 acres of land on Taylor's Run, cornering on John Goodall's land (see Orange Co. Deed Book 17, p. 164). This was bought in conjunction with John Williams, whose interest was later bought by Ancell (Deed Book 21, p. 358). This John Williams (b. 1754, from Calvert Co., Md.; sergt. in Revolution; present at surrender of Cornwallis—Chalkley II: 499) was Ancell's brotherin-law, having married a sister of Ancell's wife: see Will of Mary Catterton, Orange County, 1812, and other records.

Edward Ancell the immigrant married Sarah Catterton (Family Bible) who was born in Calvert Co., Md., Nov. 15, 1755. He died in 1832; Will recorded Orange Co. Will Book 7, p. 451, reading as follows:—

"In the name of God Amen. I Edward Ancell of the County of Orange and State of Virginia being in a weak and infirm but of sound sense and memory and calling to mind the uncertainty of life the certainty of death, do make and ordain this to be my last will and testament in manner and form following: and first I bequeath my soul to God who gave it to me hoping at the general resurrection to receive forgiveness for all my sins and for what world goods it hath pleased God to bless me with. I give and bequeath in the following manner: Item, I lend the whole of my estate both real and personal to my loving wife Sarah during her natural life and at her death I lend the land whereon I now live to my daughter Mary and my son John, to be enjoyed by them during each of their single estate. Item, my will and desire after my wife's is that my son John should have my negro man Harry and my dark bay horse to him and his heirs forever. Item, my will and desire that the balance of my estate not already given nor loned away should be sold on twelve months credits, the purchaser giving bond and approved security and the money arising from such sale to be equally divided in ten parts after my just debts are paid giving one part to my daughter Ann Marshall, one part to my son Henry Ancell's

children, one part to my son Robert Ancell's, one part to my son Edward Ancell, one part to my son William Ancell's children, one part to my son Michael Ancell, one part to my son James Ancell, one part to my daughter Elizabeth Lacy, one part to my daughter Mary Ancell, one part to my son John Ancell, to them and their heirs forever. Item, My will and desire is after the marriage of my daughter and son John Ancell the land that I lent them is to be sold and divided as hereafter directed. Lastly I appoint my son Michael Ancell and John Ancell whole and sole executors to this my last will and testament, revoking all other will or wills heretofore made by me, acknowledging this to be my last will and testament. In witness whereof I have hereunto set my hand and seal this twenty-fifth day of December, 1831.

#### (Signed) Edward Ancell."

Witnessed by Jn. Mallory, Charles Parrott, & William Catterton. Proven and recorded March 26, 1832.

The marriages of Ann, Henry, Robert, and James are recorded in an old Register of Marriages, a thin unbound book in the office of the Clerk of Orange County. That of Edward C. is recorded in Fluvanna County Clerk's office, as well as in his Family Bible.

#### I. Ann Ancell married Thomas Marshall, Dec. 27, 1833.

The Orange Co. records show (Deed Book 20, p. 418, and other records *passim*) that this Thomas Marshall came from Arnold Co., Maryland, about 1794; and ten years later (Deed Book 23, p. 252) he with his wife Nancy had removed to Bedford Co., Va. From the records of the latter County it appears that he had several children by an earlier marriage, and that the only issue of his marriage with Ann Ancell was a daughter Elizabeth, who on Jan. 24, 1820, married George Pollard (Bedford Co. Records). Thomas Marshall died in 1819; will recorded in Bedford County.

Ann Ancell Marshall died about 1841; her will, from Bedford Co. records, is as follows:---

In the name of God Amen, I Nancy Martial of the County of Bcdford being through the abundant mercy and Goodness of God though weak in body yet of a sound understanding and memory do Constitute this my last Will And Testament.

Item I give to my daughter Betsey all the property That I have accumulated, since the death of my husband Thomas Martial Viz, One cow one yearling one bedstead Bed and furniture one chest one small table one small Pot and all other Household and Kitchen Furniture and also the rent of my plantation for this year 1837 And for the safe management of my Estate I do appoint George Pollard Executor of this my last Will and Testament In witness whereof I have hereunto set my hand and seal this second day of May one thousand Eight Hundred and Thirty Seven

The above Will was proved and recorded May 26, 1841.

II. Henry Ancell married, Dec. 31, 1801 (bond dated Dec. 28) Nancy Beazley, d. 1856 in Scott Co., Mo. She was the daughter of John Beazley and had a brother James and a sister Sarah who married Richard Williams. (Orange Co. D. B. 22, p. 346). From the will of Edward Ancell it is shown that Henry had children, living in 1831; he had removed to Todd Co. Ky., and his children removed to Missouri near Cape Girardeau, where they prospered.

The ANCELL family in Missouri, Scott County.

III. Pobert Ancell, in 1804, married Frances Pearson, daughter of Robert Pearson, who in his Will, dated Aug. 2, 1805, (Orange Co. W.B.4, p. 303) leaves Fifty Pounds cash to each of his grand-children Phelicia and Edward Ancell, to remain in the hands of Executors till they come to lawful age. These two children would be of age by 1829. Ancell's wife seems to have died before her father's will.

Albemarle County, May 12, 1835, one Robert Ancell married Harriet Boswell; and in September, 1835, these two unite in a deed selling to Edward Ancell of Orange County a tract of 146.5 acres of land for \$150: the land being immediately on the line which divides the County of Albemarle from Orange, a few acres of the survey being in Albemarle County. This is perhaps father selling to son; in which case we know that Robert Ancell was still living in 1835, though he does not appear again in the Orange County records.

Mr. Edward A. Lacy, son of Elizabeth Ancell Lacy, writes that the aforementioned Phelisha Ancell married a man named Huffman, and lived in Rockingham County.

Allen Lacy and wife Elizabeth sell their reversionary interests in some slaves devised to Sarah Ancell (mother of Elizabeth Lacy) by her sister Polly Catterton, which slaves were to go after Sarah's death to her daughter Elizabeth Lacy. (Albemarle Co. D. B. 26: 250).

IX. Mary Ancell & X. John Ancell. No court record has been found except that John joins in the sale of his father's land in 1836, so (see terms of his father's Will) he had probably married at that time. Mr. E. A. Lacy writes that these two while yet single went west, and perhaps stopped in Ohio. John was somewhat deformed, from a strain in shouldering a heavy load in youth.
