FOREWORD

CURTIS GENEOLOGY

This material consists of three parts. First are the records of James Curtis, born in 1773 in Plymouth, Mass., and who moved to Bristol, Me, in 1799. The second deals with his uncle Noah Curtis, who settled in Woodstock, Maine in the 1790's and his descendants lived in the West Paris, Maine area. The third is an outline of Harold E. Curtis' descendants as furnished by him.

Portions of the West Paris records were furnished by Harold E. Curtis of Madison, N.J., as well as by Ronald Curtis and Mrs. Ellsworth Curtis of West Paris, Maine. Since 1925 I have traced and collected data on James Curtis and his descendants. This material was obtained from the Curtis family, family Bibles, town and land records and cemetery inscriptions.

I am indebted to Harold E. Curtis of Madison, N.J. and also to my wife, Mrs. Hazel Ash Pickwick for her unstinted help.

Brocks (now Governor) commanded the regiment———that he left the service, having regularly resigned in September, 1780 at West Point———that he was in several battles———that from his reduced circumstances, he needs the assistance of his Country for support———He exhibited his commission, which are enclosed————William Curtis———and he needs the assistance of his Country for support. Plymouth-ss Nathaniel Pratt 17th Aug. A.D. 1820 who has the case of William Curtis age 78 yrs. in Pembroke, -----Wm. Curtis is wholey incapable of attending court or of taking oath that he has served as believed in the revolutionary war 5 years & 4 months in the regiments commanded by Col. Cotton, Col. Bond, Col. Alden & Col. Brooks as a Lieutenant all in the Massachusetts line----he was a shipwright but has not been from his house these 4 years, he has a daughter Hannah, aged 39 yrs. He has no other family, he is helpless and cannot move from his bed to his chair without assistance ----SCHEDULE-Real Estate none - Personal Estate- vis; - 1 cow - 1 pig - 1 desk - 4 chairs - 2 tables - 1 looking glass, crockery & iron ware-----Nathaniel Pratt- Aug. AD, 1820. Property valued at \$23.50, Dec. 29, 1820.

Plymouth Church Records, Vol. 1, p. 367; Gives this Oct. 18, 1787. At a Sacramental Lecture, the Church were desired to tarry after the Blessing, and the Pastor communicated to them the request of Brother Wm. Curtis, (now living in Pembroke) viz. that since by the providence of God. he is removed from us and not being satisfied with the Preaching of the minister of the Place, and becoming acquainted with a Baptist Society, among whom he thinks the Gospel is Preached in Purity, and as he has no prospect to returning to this place to live again, he requests a Dismission from this Church and to be recommended to the Baptist Church of which Mr. Robinson is the Minister----The Church took the matter into consideration and were, finally of the opinion that our Brother Curtis has been too hasty in this affair, not having consulted either the Pastor or his Bretherin on this subject before he had come to a fixed conclusion, that our Church were wrong as to the mode and subjects of Baptism and had determined to join them before he had made application to have any objections answered, or Difficulties solved, which he labored undered. The Church therefore voted: That the Pastor be desired to wright to our Brother Curtis and inform him of the Sentiments of his Brethren respecting this matter, and

his Conduct aforesaid-----and also voted to choose a committee of five, besides the Pastor, to discourse with him, and endeavor yet to answer the objections he has against our practice in regards Baptism, and convince him of the error in that he would by his Conduct, in joining them and being rebaptised, virtually declare this Church (with whom he declares himself to be in the fullest Charity) to be no Church----and infact, would implicity unchurch all the Churches in the land, that are not Baptists, The brethren chosen to be of this committee, in conjunction with the Pastor, were, John Cotton, Deacons Damin, Crombie, Spooner, and Wm. Watson.

Later this committee reported to no success with Brother Curtis in this matter.

Will of William Curtis

In the name of God Amen, the 19th Day of August Eighteen Hundred and Eighteen, I William Curtis of Pembroke in the County of Plymouth, Gentlemen, Call to mind the Mortality of my body and knowing that it is appointed for all men to die, being advanced in age but of sound disposing mind and memory, thanks being given to God for the same and First of all I recommend my soul into the hand of God that gave it and my body to the earth to be decently buried by the hand of my Executor hereafter named and touching such worldly estate as hath pleased God to bless me with in this life, I give and dispose of the same in the manner following:-

Item:-I give to my daughter Hannah fifty dollars to be taken out of my household furniture to be appraised to her to make her equal to my other two daughters Polly Trask and Lydia Crocker of what I have given them and is their shares in full of my estate as will appear by receipts.

Item:-I give to my son James and my son Jacob and the heirs of my son William deceased all the remainder of my real estate to be equally divided between them and to their heirs and assigns forever and I do by these presents impower my executor to make sale of such of my real estate for the payment of my debts as he may think best if he shall have occasion to sell the same and I order my executor to pay all my just debts and charges and if any of my children shall bring and demand against my Estate, except note or bond, they shall forfeit what I have given them in this Will and I do Constitute and Appoint William Loring Esq. Sole Executor to this my last Will and see me Decently Buryed when dead. In witness whereof I have hereunto set my hand and seal the Day and Year above written and Declair this to be my last Will and Testiment in presence of

The following is a letter written by Hannah Curtis, dau of William Curtis, who remained single. It was addressed to a Mrs. Emeline McGregor: Pembroke.

September 7th, 1832

My Dear Niece,

I received your letter and was glad to hear from you, and the rest of the family and I wish it were so that I could see you before you leave this part of the country for Eastward. I have been expecting to have a visit from you, and feel disappointed that you have not been here in the course of the summer. Should it be in your power to come, I think you need not hesitate on account of the colera, as that dreaded pestilence has not visited this place and I presume no other between it and the one where you are. It is truly time which calls for serious reflection and devotedness of life, but we ought to bear in mind that excessive fear is not the most suitable state of mind to meet any calamity which Providence in judgement sends to us, and it should be our first concern to endeavor to be prepaired for sickness and death at whatever time they are suffered to befall us. I feel obliged to you for your invitation to accompany you to the Eastward, but I am too far advanced in life to think of pulling up stakes, and moving to a new place particularly so far off as my brother and sisters are situated. I am glad they are all doing so well, and hope while they are increasing in the things of this world that they will be rich in faith. I have a home here and so long as I am able to work I am not concerned but that I shall get a comfortable living, and although my health is poor and I have no relatives to assist me, yet I feel that there are many friends still left me, for whom as well as for many other blessings. I desire to be thankful to Him who will never forsake any who really trust in his promises. If I do not see you again before you go, you must give my love to them all and tell them once more, particularly your dear mother for whom I feel much sympathy in her troubles, and would offer consolation if it were in my power, but she doubtless knows how little mere human beings can do

for each other unless they are assisted by the grace of God, a portion of which I hope she will experience to enable her to bear all the trials that may be allotted her in this world. It has been her lot to loose some of her children, but she has many more who will hope to live to comfort her and be useful in the world. Sister Olive Curtis is well and all her family. Henrietta and Hannah Churchill have both joined the Methodist Church, likewise a member of (paper torn-looks like-Jacobs Family). His wife professes to have experienced religion and he is very much reformed though he says but little of himself, his habits are good and he attends meetings and has them in his house. His third daughter is well married and has two fine children. Sister Olive daughter Beulah died last fall leaving one child a boy about 10, and her sister Lydia has since had a nice pair of twins. She has to work hard to care of so many children but I believe they live comfortably. Tell your Aunt Crooker I hope she will try to come up again and see us if your mother can't.

This was his farm and has been in the Goudie family for several generations. In his deed upon selling the place he reserved "aplot of land 1 rod square in which are 4 graves." Upon visiting this area we found 3 adult graves & 2 children's; indicating that he was buried here also. This is in the pasture near the road and above the house and toward Damariscotta and back of the present gravel Pit. (1950)

James Curtis was a master shipbuilder by trade in Bristol, Maine and vacinity. Deacon James was a decided religious man and was quite set in his views. He was brought up in Pembroke, Mass., as a Hard Shell Baptist which term perfectly describes his religion and character.

Will of Stoddard Curtis

In the name of God, Amen, I Stoddard Curtis of Newcastle, County of Lincoln being infirm in health, but of sound disposing mind and memory, do on this 4th day of September, A.D., one thousand eight hundred and sixty-one, make and publish this as my last Will and testiment, that is to say. In an unshaken faith and glorious hope of eternal life, thro the merits of a Crusified Redeemer, I commend my immortal Spirit to Almighty God. As to my worldly estate, my Will is that it be disposed as follows:-

First, I give and devise to my beloved son. Adoniram J. Curtis, for and during the term of his natural life so much of my farm as lies Easterly of the County road as is now in the occupation of the said Adoniram, to-wit commencing on the Easterly side of said County road at a point made by drawing a line from the Northerly side of the main dwelling house in such a direction (Easterly) as will strike the Westerly line of Ralph Harley's marsh at a point that shall be 34 rods from the Williams lot to the County road: Then Southerly by said road to the point of starting on said road. I also give and devise to said Adoniram for and during the term of his natural life, that portion of Southerly part of said farm as is thus described to-wit:-Commencing on the Easterly side of the County road at a point 22 rods Northerly of Kingsbury Donnell's North line, thense Easterly keeping a distance of 22 rods Northerly of said Donnell's land to the marsh, thense Northerly so as to encircle the marsh to Dyers river, thense Southerly by the river to said Donnell's land, thense Westerly to said Donnell's land to the road, thense, by the road 22 rods to the point began at.

Also I give bequeath and devise to said Adoniram for and in during the term of his natural life, the use and occupation of the Southerly one-half of the barn on the premises, on the Westerly side of said road, on condition that

the said Adoniram keeps that part of the barn in repair and good condition. Intending hereby that and during the natural life of said Adoniram he shall be entitled to the sole use of that part of the barn before described and the use and the product thereof during his natural life. And at the decease of said Adoniram Judson Curtis, I give and devise to his heirs and assigns, so much of the land hereby given him for life as shall be equal in quantity and value to one-fifth part of my whole farm, exclusive of the dwelling house, together with one-fifth part of the barn. To have and to hold the said one-fifth of said land and barn to them and their heirs and assigns.

I also give and devise said Adoniram the addition on the Northerly end of the house, on the West side of the road, with so much of the land as is covered by said part of the house, with a convenient right of way to the house on the Easterly and Northerly side of said addition, here devise to him on the condition that said Adoniram shall claim nothing as due from me for services rendered me, or for any other claims against my estate as a debt due from me to him.

I give and bequeath to my said wife all my household furniture and farming utensils and direct that all my debts be paid out of my other personal estate. The personal estate that shall remain I give and bequeath to my children in equal parts; to Jerusha Erskine wife of Jeremiah Erskine of Alna; Agustas S. Curtis of Alna; Ameriah K. Curtis of New Castle; and George B. Curtis of Placerville, Cal. I give and bequeath to my beloved wife Priscilla Chapman, one-third of my personal estate, that shall remain after the payment of debts.

The residue of my farm not heretofor given and devised to my son Adoniram J. Curtis or to his heirs after his decease, I give and bequeath to my four children, vis to Jerusha Erskine the wife of Jeremiah Erskine of Alna, Agustus S. Curtis, Ameriah K. Curtis and George B. Curtis herein before named, to have and to hold the same to them and to their heirs and assigns, subject nevertheless to the right of dower, to my said wife Priscilla Curtis. I also give and devise to my said wife Priscilla Curtis for end during the term of her natural life one-third part of a piece of woodland in said New Castle containing 36 acres, as described in the deed of Thomas N. Ayer to me dated May 20, 1851, with the right of her the said Priscilla, to cut upon and hall therefrom so much firewood as shall be necessary for her own use.

The said woodlot Subject to the right of my wife as herein before set forth, I give and devise to my four children, vis, Jerusha Erskine, Agustus S. Curtis, Ameriah K. Curtis, and George B. Curtis, to have and to hold the same to them and their heirs. I appoint my son Agustus S. Curtis sole executor of this my last Will and testiment.

in Bangor, Maine. D-March 1, 1888, in Garland, Maine. George Curtis was a very religious man. He was a deacon in the Congregational Church. His brother Stoddard was a deacon in the Baptist Church and considerable feeling was created between them over the fine points in their different religious views. George Curtis was 6ft. 2 in. in his stocking feet. He never was overstrong, never doing an enormous days work; but always doing a fair days work and kept the work of the farm well in hand.

In the first quarter of the Nineteenth century a new town, named Garland was being opened for settlement. In Company with a man by the name of Levi Johnson, he walked the distance from Bristol to Garland some 100 miles, entering the town from the South by way of Exeter. From Exeter there were no roads, so a young man guided them thro the woods by means of a spotted line or blaised trail as it was sometimes called. George Curtis stayed there two weeks and returned to Bristol for his clothing. March 31, 1827 was the first time he saw what was to be the town of Garland, Me. On coming back to Garland, George Curtis made bricks in company with Levi Johnson. Most of the bricks in the old houses in Gerland also the tile for the brick hearths were made by George Curtis. One of his old bricks molds is kept in Garland as a relic of the early settlements. In the Winter of 1827-28 George Curtis went back to Bristol to teach school; returning to Garland in the Spring, he bought a tract of land of 75 acres of Levi Johnson paying \$3.50 per acre. The farm is in the South part of the town, about a mile from the Exeter line. He cleared the land and built a farm and then a house which still stands and was in fair condition in 1921. While in Brownville, making bricks, George Curtis met Louisa Sutton Angove, whom he later married. George Curtis was a staunch Puritan in character, honest, industrious, shrewd, and saving, 18

On arrival home he developed typhoid fever and died. The following is a letter written to his brother, Ameriah K. Curtis of Damariscotta, Me.

Placerville, Oct. 19th/60.

My dear Brother

It is with pleasurable emotions that I sit down this eve to answer your kind letter at last. I had almost given up looking for letters from home. It was about three months that I had no letters from home. But I found your letter gratefully received and above all to flatter my delight was to find enclosed my dear Father & Mother & Guss pictures. I could not have had a more pleasing present than them. I send my sincere thanks to them for their thoughtfulness towards me. I have got them sat up before me while eating at the table against the petition my other partners have four to go with them so we have eight stretched out on a sheet of paper which makes quite a show case. I was pleased to learn that you and Gus were doing so well. I almost

wished that I were with you but I am not as you say perhaps we shall take jobs together again were I to respond it would be in the affirmative conditionaly if I do not strike something big here (using a Cala. term) though that is what I have given up but I hope I may be able to do a little something yet with prudence and good management. Well I do not know but I do but I will tell you one thing it is not the best judgment men that strike the best digging in the mines yet it wants the best judgment to keep the money. Saturday eve I will write a few more lines to answer a few of your questions 1st I have not decided when I shall go to Carson Valley again though I may go sometime 2nd, when I am going after that man to obtain my fifty dollars and I think I shall start for it when you go after that winters work at Georgia But I think I shall get mine first. had a letter from him the other day he wrote me that I should have it the first stake he raised 3rd, How I intend to get home I think I shall not tunnel through though our tunnel is running the right direction but I don't think we shall run it quite so far as home. I can tell how far we may run it if we do not strike gravel soon. I have told you how I thought I should not come home next in order is how will you I have had some thought about buy me a pair of mules and coming across the plains I don't like the idea of doing as Kingsbury Donnell thought I had ought that was to not ever see as much as Gardner or Bath but I might go ' to Damariscotta. I have seen some of the exteriors of our country now I would like to see some of the interiors which I think would be more interesting I should want to get about a dozen more to go with me so as to be safely protected from the Indians. It would take about two months to get to the Missouri River then I could take any conveyance that I should choose How do you like that way if you have got any more questions send them on, I think I can ans what few you may have satisfactory. Well I suppose you want to know how we are getting along with our tunnel. We have got in about two hundred feet. We have not got through the rim rock if you comprehend how that lays. The gravel which we are running for is next to a large hill and the bed rock on the other side comes up almost to the top of the ground and the gravel is about forty feet from the surface so we are running through this bed rock or rim rock so as to drain the water out of this basin where the gravel is so we had to commence about four hundred yards down the hill ir order to drain it. We think we must strike gravel in about a week as we know where the gravel lays. We know this gravel from the fact that is has been worked before but it was never drained the water troubled them bad we know that the gravel has got gold in it from the fact that we washed a little of it which they dug out of a shaft with a rocker and got \$1.50. We judge from the quality of it We have been at work ten weeks now and have not taken out a cent. You wrote that you thought that I might have done better had I stayed at one place. Neither you or I know that my prospect was

very poor when I left there or I should have never left there. I knew of no place that I could have made fifty cents a day neither of a chance to hire out, if I could have got wages there I should be there now but the chances to hire out in this country is very poor. I saw a man the other day said he traveled eight hundred miles to hire out last fall and then got a chance for three months and lost every cent of it. A man might get a chance very quickly and then again he might spend a good deal of money. an estimate maid at Montezuma before I came away to see how much more they were averaging per day. It was twenty five cents & board themselves though there were some doing very well. I will not try to demonstrate any more because I know you cannot have any idea of California without seeing it. but there is one thing that I have learned since I came here. That is to have more sympathy for those who return from Cala, poor because there is so many hard working & Honest men that do not get anything. Perhaps you may think by the tenner of this letter that I am getting discouraged, but not so. I am in good courage yet we have got a good cabin & Stove & Grub enough to eat and in good health. What more should any one ask for. I suppose it would be a little more money but these are worth more than money. Ames says that I shall be home directly without anything. Tell him he need not look for me just yet without anything though I shall not be an exception though I do. I guess I will not bring up any more arguments. Please give Mrs. Baker & Mr. Baker my best respects. Tell August that I don't see why he has not answered my letters which I wrote him in July 24th also Aug. 4th. I cannot hardly ask you to send your picture it would be asking too many favors but I would be highly pleased. Give my love to Father & Mother and others. Write often Amma and I will Ans. I believe I have answered every letter that I have had from home and have written five which I have not received any answer from yet except these few lines from you.
