NOTES ON THE COLEMAN FAMILY.

THE origin of the name COLEMAN is variously explained. Ferguson, in his Teutonic Name System, regards GOLD as the simple form of the name. This takes the form of GOLDIE—GOULD—GOULT—COLD—COLT. Compounded with man, it becomes GOLDMAN—GOULDMAN—COLTMAN—COULTMAN, in which form it appears as the name of some of the family.

Arthur, in his Derivations of Family Names, makes it a compound of humbler origin, COAL-MAN—COLMAN—COLEMAN, a dealer or workman in coals. Gaelic, *Colman*, a Dove.

It may be worthy of consideration whether the word be not a compound of the old Saxon Ceol, a ship, a boat, hence a keel; by the addition of man, Ceol-man, a ship-man, a boat-man, a sea-man, like Ceol-wulf, Ceol-noth, Ceol-red, familiar names in the Anglo-Saxon Chronicle.

Whatever may have been the origin of the name, it appears in the following forms of orthography: German, *Kohlman*, *Kohlmann*; Old German, *Coloman*; English, *Coulman*, *Coloman*, *Colman*, *Coleman*; French, *Collman*.

So far as is known to the writer, the name COLMAN first appears in history A.D. 664, as that of a celebrated Scotch bishop, of Lindisfarne, or Holy Island, on the northeast coast of England, below the Tweed. This bishop, in consequence of a vehement controversy, retired and built a monastery on the Island of Hii, Iona, on the west of Scotland; then another, on the Island of Inisbofinde, on the west of Ireland; and yet another on this island, now annexed to the Archbishopric of Tuam, in Ireland, where he died A.D. 676. Another, a bishop in Ireland, baptized by the former, built also another monastery in the island; a third was murdered with the Bishop of Würzburg, in Germany, A.D. 689. One of this name, from Scotland, in the eleventh century, went on a pilgrimage to Jerusalem, and was slain in Austria; and became a patron saint of the country A.D. 1015. These all

have place in the Roman Calendar. The 18th of October is still noted as the memorable day of the saint last mentioned. The name Kohlman early appears in German history, and again in the 12th century. It is at the present time a familiar and frequent name in Germany, Ireland, England, and the United States of America. In heraldry there are three coats of arms of different branches of the Coleman family. An important street in the City of London has from time immemorial borne this name.

There were many emigrants to New England of the name of *Coleman*, *Coultman*, or *Colman*, in its early settlement, some of whom have left long lines of descendants in the Eastern States. No evidence, however, has been adduced to prove that they were related to Thomas, of Wethersfield and Hadley, although they were, doubtless, lineal descendants of the same Norman ancestor. The old traditional family proverb, narrated by the posterity of every British emigrant, about "*three brothers coming to this country*," we believe to be wholly hypothetical as regards the *Coleman* family, and also in a majority of other cases.

Coleman.

Thomas Coleman 2d, or *Coultman*, as he wrote his name, was born in 1602, and came from Marlboro, County of Wiltshire, England, in the Ship *James*, which arrived at Boston, June 3d, 1635. He was denominated *Husbandman*, and settled first at Newbury, Mass., removing to Hampton, N. H., in 1660, and thence to Nantucket in 1662, where he died in the year 1685, aged 83. His first wife's name was Susanna, who died Nov. 17, 1650. His second wife was Mary, widow of Edmund Johnson, married Jan. 16, 1651; she died Jan. 30, 1663, when he married his third wife, Mary, widow of Thomas Rowell, who survived him. He left a numerous line of descendants. Children: 1. Tobias, born —, 1638; 2. Benjamin, born May 1, 1640; 3. Joseph, born Dec. 2, 1642; 4. John, born —, 1644; 5. Isaac, born Feb. 20, 1647; 6. Jemima, and probably 7. Susanna.

Edward Coleman, Boston 1651, and Barnstable 1662, married Margaret Lombard, daughter of Thomas of Barnstable, Oct. 27, 1648, and had five children: 1. Elizabeth, born Jan. 28, 1652; 2. Mary, born Sept. 12, 1653; 3. Martha, born Aug. 8, 1655; 4. James, born Jan. 31, 1657; 5. Abigail, date of birth unknown.

William Coleman (supposed brother of the preceding) came in the Ship *Assurance*, from Gravesend, England, July, 1635. He was then 16 years old, and settled at Gloucester, Mass., where he married widow Bridget Roe, Nov. 14, 1662. They probably had no issue. He died April 18, 1680, aged 61; his wife Bridget died May 16, 1680.

Samuel Coleman settled in Ipswich, Mass., before 1700, and died there. Children: 1. James; 2. Rebecca; 3. William; 4. Sarah, Mrs. Dow.

Joseph Colman came to New England in 1635, from Sandwich, in the County of Kent, England, with his wife Sarah and four children. He settled first at Charlestown, Mass.; removed in 1638 to Scituate, and thence to

Norwich, Ct., before 1690, where he died before 1700; had sons, 1. Joseph; 2. Zachariah; and 3. Thomas, and several daughters.

William Colman, with wife Elizabeth, came from London, Eng., in the Ship *Arabella*, May 27, 1671. He was son of Matthew and Grace Colman, of Satterly, County of Norfolk, Eng., and was baptized there Aug. 31, 1643. They had three children: 1. Mary, born Dec. 3d, 1671; 2. Benjamin, born Oct. 19, 1673; 3. John, born —.

Rev. Benjamin Colman, D.D., son of William and Elizabeth, was born in Boston Oct. 19, 1673, graduated at Harvard College 1692, preached first at Bath and Ipswich, in England, and returning to this country, was first settled at Medford, Mass., subsequently at Brattle Street Church, Boston, as its first minister, Aug. 4, 1699. He married, in London, June 8th, 1700, Jane, daughter of Thomas and Jane Clark, who died Oct. 26, 1731, and he married for second wife, Sarah, daughter of Richard and Sarah Crisp, May 6, 1732, being her fourth husband; she died April 24, 1744, when he married for third wife Mary, daughter of William Pepperell, of Kittery, Me., Aug. 12, 1745. Dr. Benjamin Colman died Aug. 29, 1747, and his widow married Judge Benjamin Prescott, of Danvers, Mass.

Dr. Colman was an eminent divine in his day, as well as a leading man in the direction of Harvard College for fifty years. He had by his first wife two children, and by the second one. Children: 1. Benjamin, Jr., born Sept. 1, 1704, died Sept. 8, 1704; 2. Jane, born Feb. 25, 1708, married Rev. Ebenezer Terrell, of Medford, Aug. 11, 1726; 3. Abigail, born Jan. 14, 1715, Mrs. Albert Dennie.

NOTE.—Seven of the name have graduated at Yale College, seven at Harvard College, and one at Amherst, a portion of whom had dropped the “e” from the name as entirely superfluous.

PEDIGREE OF THOMAS COLEMAN.

First Generation.

1. THOMAS COLEMAN, the emigrant ancestor of all who bear the name in Connecticut, and in Western Massachusetts, is said to have been a native of *Evesham*, “near the head waters of Shakspeare’s sweet stream of Avon,” County of *Worcestershire, England*. He emigrated to New England about 1634–5, and was found first at *Wethersfield, Conn.*, among the earliest settlers of the town, 1636, where he had lands assigned to him in the division of lots, 1639, and subsequently became one of the prominent men of the place. In 1639, Mr. Coleman was appointed by the Court to appraise damages; was a *Juror*, 1639–41–45–47 and 48. *Representative* of Wethersfield to the General

Court, 1650-51-52-53-56, and repeatedly afterwards: in fact, few if any gentleman was so often a member of the Assembly as Mr. Coleman, and few sustained a higher reputation in the colony. In 1654, he was appointed by the General Court "to join with the Deputy Governor (and two others), to see to the *pressing of men*, and procuring necessaries in Wethersfield, to attend the expedition to Narragansett, in the Ninigret War." He was often, also, chosen to take charge of the *administration of estates*, as well as appraiser of personal and landed estates. Notwithstanding the general popularity of Mr. Coleman in Wethersfield, and his high position in the colony, he was, however, like many of the early settlers, "given to litigation." In 1659, a portion of the Wethersfield Church, with their pastor, REV. JOHN RUSSELL, became involved in the "*Hartford Controversy*," so called; and so irreconcilable did the feud at last become, that a majority of his church (among whom was THOMAS COLEMAN) resolved to leave the colony. They met those from the Hartford Church, at Goodman Ward's House, Hartford, April 18th, 1659, and there entered into an agreement to remove with their families to Massachusetts; and about fifty families did remove, headed by GOVERNOR WEBSTER, and other eminent and wealthy settlers, to the *Connecticut River Valley*, above Springfield, and that year they laid the foundation of the Church and town of *Hadley, Mass.* What the precise nature of the controversy was, is not positively known; it was supposed, however, to relate to the reciprocal rights of the clergy and laity on the matter of baptism.

Mr. Coleman was *born in England*, about A.D. 1600. In the "Colonial Records of Connecticut" we find the following vote: "At the General Court, March, 1658, THOMAS COLEMAN was freed from *watching—warding and training*, if he proved he was over sixty years of age;" taking this fact "for granted," he was *born in 1598*, and was *thirty-seven years old* when he settled in Connecticut. He was made *freeman* in Massachusetts, 1661.

Thomas Coleman was *twice married*; the name of his first wife is not known. She was the mother of his four eldest children, and they were doubtless married in the Old Country; she is supposed to have died at Wethersfield, about 1640-1. His second wife (says Judd) was *Mrs. Frances Wells*, widow of *Hugh Wells, Sen.*, of Wethersfield, by whom he had *one other child, Deborah*.

Mr. Thomas Coleman died at Hadley, Mass., October 1, 1674, aged about 76.

Mrs. Frances (Wells) Coleman died at Hadley, Mass., March, 1678.

JOHN COLEMAN, eldest son of Thomas and — Coleman, was born in England, as supposed (about 1635), and emigrated with his parents, who settled at Wethersfield, Conn., and subsequently removed with them to Hadley, Mass., 1659, and may have signed the agreement, with the other settlers. John Coleman was made free in Connecticut, 1658, and in Massachusetts, 1672, and was, or became a deacon in the church. He married three wives;

first, *Hannah Porter*, daughter of John, of Windsor, Conn., May 29, 1663. She was born Sept. 4, 1642, and was slain by the Indians, with her infant daughter, Sept. 19, 1677, when he married second wife, *Mehitabel Root*, widow of Hezekiah Root, of Northampton, Mass., March 11, 1679. She was mother of his two youngest children, and died at Hadley, Aug. 4, 1689. Deacon Coleman married for his third wife, *Mary*, widow of *Thomas Stebbins*, of Springfield, and daughter of Robert Day, Dec. 16, 1696. She had previously been the widow of Samuel Ely, of Springfield, and deceased Oct. 17, 1725, aged 84 years. Deacon John Coleman died Jan. 2, 1711, aged 76.

NOTE.—From authentic records, it appears that they who constitute this lineage of eight generations, all have been professors of religion, and of the same religious denomination—all of whom have honored their Christian profession, and several have sustained responsible offices both in Church and State.

Of the descendants of Dr. Seth Coleman, of the fifth generation, who have attained to adult age, about eighty-two in number, all but four are, or have been members of the Church of Christ, of the same religious denomination, adherents to the faith of their Puritan forefathers; and the partners of those who have entered into the marriage covenant have sustained the same relation to the Church.

Charles Kilborn Coleman, of the ninth generation, still holds in lineal succession the venerable family Bible which Thomas Coleman, the first emigrant, brought from England in 1634. It is a reprint of the old Geneva Bible, first published in 1557, by refugees from England, which for a long time continued to be held in great estimation by the Puritans, after the publication of our authorized version. This copy was printed at London by Robert Baker, 1615.

The average age of the eight generations deceased is 75·7, the oldest being 92 and the youngest 63.
