It is not advisable to carry the records of descendants from FEMALE members farther than the third generation as they belong to the families whose name they bear, and this will be enough to enable them to connect themselves with their Crehore ancestry if desired.

All information sent to the undersigned will be carefully preserved in a special file for use in the future preparation of a more complete family history.

The writer has to acknowledge the welcome assistance of every member of the family whom he has addressed in relation to the work and especially to one whose complete memoranda regarding the earlier generations have much lightened his labors.

NOTE.—Numbers in brackets upon left side of page, refer to immediate Ancestors. *Numbers in brackets* on the right of page designate the record of the person in the numerical order. The names of such are in capital letters.

THE CREHORE FAMILY.

Between 1640–1650 there appeared in Dorchester a young lad who went by the name of Teague Crehore. He was said to be of Irish origin, but as no such name occurs in the United Kingdom. it is probable that his surname was given an erroneous orthography ; all the more in that he could not, at a later date, write it. The Irish surname “Krehaw” corresponds phonetically with Crehore especially as the latter is pronounced by old residents of Milton and Dor. On the other hand many have thought it might be a misspelling of “Creagh”. There is a tradition in the family that he had been abducted from his home and brought to this country when quite a child. The place of his birth and his true name must rest undetermined, probably, forever.

In regard to the date of his birth. An old Milton parish record gives his death as occurring June 3d. 1695, at the age of 55 years. As his widow took out Letters of Administration on his estate Jan. 22d. 1695; *Suffolk Probate rec. Lib. 10. fol. 723*, it is probable that the date of d. was Jan. instead of June. This would make his birth date about 1640. An old unrecorded deed formerly in the possession of Mr. Thomas Crehore, in which John Gill conveyed to T. a piece of Salt marsh, was dated Dec. 1660, at which time he was presumably of age. Among Suffolk Deeds Lib. 7, fol. 281, is the record of a conveyance by Teger and Mary Crehore to Robert Badcock of a piece of land bordering on the Neponset River, being the same bought by T. of John Smith of Dorchester, dated Jan. 21st. 1670.

He married, probably in 1665, Mary, said to be the daughter of Robert Spurr of Dorchester. There is no record of the marriage but her parentage seems to be generally admitted. Robert Spurr is mentioned in the Hist. of Dorchester, published by E. Clapp, Boston 1859, at pp. 232, 237, 279.

T. was buried in what is now the family lot in Milton Cemetery. There is no headstone and the exact spot is undetermined. Many of his descendants are buried about him. The Inventory of his estate extracted from the Probate record referred to above is as follows.

In Suffolk Deeds, Lib. 29, Fol. 186 is recorded a conveyance from Anne, Rebecca, Mary and Benjamin of all their interest in the estate of Tangué (Tauge?) Crehore &c. unto Timothy, eldest son of said deceased &c. This gives the names of the husbands of the daughters, specifies that those named were all of T's children then living, and shows that the mother, Mary, was alive at that date, Feb. 4th. 1714. Benjamin was unmarried at that date, as his wife, if he had one, would have joined in the release. He was then a resident of Roxbury. It is said that a Benjamin C. m. Rubamah ? at Roxbury and had son John b. April 1st. 1718, but all other accounts describe him as having never married. Mr. Lemuel Crehore had a mem. that "he disappeared and was never heard from." Of the daughters nothing more is known than appears above.

2.—TIMOTHY ² eldest son of Teague; b. in Milton October 18th., 1666. Yeoman.

In addition to his purchase of the homestead from his brother and sisters in 1714, *Suffolk Deeds, Lib. 29 Fol. 186*, he also bought a farm of 72 acres from John Vose, that adjoined the paternal estate, *Suffolk Deeds Lib. 33, fol. 159, also fol. 201, and Lib. 52, folios 21 & 175*. He m. Feb. 10th. 1688, Ruth Riol (Royal?) who d. June 27th. 1750. Both T. and his wife are buried in the family lot Milton Cemetery and their gravestones furnish authority for the dates given. D. Aug. 15th. 1739.

Aug. 25th. 1814, aged 81 years, buried in Wm. Crehore's tomb Mil. Cem. Jedidiah d. Sept. 28th. 1781. No record of burial.
