He married (1) June 13, 1644, Mary Newberry, born 1626, died Aug. 29, 1688, in Dorchester; was daughter of Thomas and Jane Newberry of Mypern, Devonshire, England; (2) 1689, Martha (Pitkin) Wolcott, widow of Simon Wolcott; who died Oct. 13, 1710, Windsor, Conn.
