## COALE

**WILLIAM COALE**, of Anne Arundel Co., Md., was an eminent Minister of the Society of Friends, and the minute-book of the "Meeting at the Clifts" contains a number of testimonies to his memory, recorded at the time of his death. He m., first, **HESTER** ——. Issue:
