Julia Ann Cunningham, 1826-1916, grandmother of the author and resident of the same household for many years, provided many facts and traditions. Some of the traditions were authenticated by records; others could not be proved. Her roots reach deep into the early history of this country.

Although this booklet presents some family lineages and many reference, it should not be considered a finished product. Much remains to be done, The parentage of John Shircliff, about 1780 to 1847, has not been definitely determined; the Raney lineage has been carried back to the Revolution only; and family lines in foreign countries have not been traced. Maybe the information given here will stimulate others to continue the search.

The first six generations in the above chart are documented in this publication. The seventh is confirmed by census records and by information supplied by relatives. The last four are from the authors own knowledge.

"The name Gough has ever been an honored one in the annals of American history-." Many members of this family distinguished themselves as colonists, patriots. statesmen. and leaders in agriculture, business, industry, and various professions.

William Gough was the progenerator of the Gough line. shown on page 2. He immigrated from England to Maryland in 1673. ABSTRACT OF CHARLES GOUGH WILL \*\*\* June 23. 1826; July 24, 1826 Washington County, Kentucky

To wife Mary the plantation as long as she lives and, at her death, to be sold and divided among all his children. Decedant expressed wish that son Ignatius live on home place and take care of his mother; also gave special consideration to son Isadore and daughter Julia. Daughter Mary Shircliff and other possible children were not specifically mentioned in the will. A search for final settlement of the estate in Washington County, Kentucky has been made without success.

### LAND GRANTS TO GOUGHS Land Office, Annapolis, Maryland

- 1. 1665, "I Barnaby \*Gough do assign over to Thomas Bradley or his assigns all my rights and title of land due me for transporting into the Province myself who came in the year 1659, Elizabeth Gough 1659, Barbara Wells 1660 Francis Rayston 1661. Walter Traverse 1661, Constance Fince 1663. (Liber 6, Fol. 107)
- 2. November 15, 1673-- Mary Gough was transported to inhabit the Province. Samuel Tracey of Baltimore County was to receive 250 acres of land for transporting her and two others. (Liber 17, Fol. 551)
- 3. March 26, 1677-- William Gough was granted 500 acres of land in Calvert County. (Liber 19, 433)
- 4. May 18, 1679--Hester Gough of Calvert County received 800 acres of land in Cecil County at the death of her husband. (Liber 20, Fol. 276, 277)
- 5. March 30, 1701-- Robert Gough obtained 200 acres of land in Talbot County. ( DD #5, Fol. 89)
- 6. April, 1714-- James Gough received 200 acres of land in St. Mary's County. (PL # 4, Fol 451)

They were followed by several other Goughs who settled in various parts of Maryland. The place of origin and the blood relationship of these early emigrants has not been established.

#### GOUGH-CARROLL BIBLE RECORDS

The Maryland Historical Magazine, in two issues, gives an account of a Gough-Carroll record, listing at least 40 births, deaths, marriages, and other items:

1927, Vol. 22, pp. 377-80; 1793-1866 1930. Vol. 25, pp. 302-304; 1745-1888

Thomas Gough, born in England of very great wealth, was the first of this line of Goughs in America. In 1704, he married Sophia Dorsey, daughter of Caleb and Elinor (Warfield) Dorsey of "Hockley in the Hole", Anne Arundel County, near Annapolis, Maryland.

To this couple was born Harry Dorsey Gough, one of the most influential Goughs in the History of Maryland. Shortly after he came of age, he was named residuary legatee of a large and complicated estate of Isaac Burger, a relative and woolen draper of Bristol, England. He was a prominent merchant in Baltimore and built the largest house in Maryland, Perry Hall in Anne Arundel County on Bel Air Road, north of the village of Perry Hall. Born in 1745, he married Prudence Carnan from the prominent Ridgely family. He died in 1808. His daughter married James Carroll in 1787. Ref.. M.H.Mag., March 1950, pp. 33-46.

An interesting sidelight is that James Carroll's real name was Mackabin. He was the son of Nicholis and Mary Clare (Carroll) Mackabin. He changed his name at the request of his uncle Charles Carroll. the Barrister and signer of the Declaration of Independence.

To James and Prudence (Carnan) Carroll was born a son, named Harry Dorsey Gough Carroll. He lived from 1797 to 1866. To him was born six children but only one survived childhood. Harry Dorsey Gough Carroll, Jr., 1819-1882.

This Gough-Carroll line seems to be different from the original William Gough line, page 2. If there is any blood relationship, it is likely very distant, dating back before William and Thomas came to America.

#### OTHER BRANCHES OF THE GOUGH FAMILY

The Daviess-Martin County, Indiana branch. In the author's youth, Thomas M. Gough (1838-1927) was the senior Gough in the Loogootee, Indiana area. He and Julia Ann Cunningham (page 2) claimed blood relationship; he called her aunt Julie but the records do not indicate a nephew-aunt relationship. It may therefore be assumed that the title was simply an expression of respect. His daughter-in-law, Mary (O'Neill) Gough, the 89-year old widow of William Gough, said in 1965 that Thomas M. was the son of Stephen Gough; also that Stephen married a Gibson. The wife was probably a sister of Thomas Gibson, a pioneer merchant in Martin County, Indiana\*.

<sup>\*</sup> According to Mary (O'Neill) Gough, Thomas Gibson had a general store in Mt. Pleasant and made shipments of farm produce from Hindoston, on the east fork of White River, to New Orleans. In 1850, he made an affidavit that he attended the wedding of John Shircliff and Mary Gough in Washington County. Kentucky, in 1822. Ref., General Services Administration, Washington, D. C.

Hindoston, located at a fall in White River, was an important trading post in the early history of southern Indiana. The town was completely wiped out by disease, called a "plague", about 125 years ago. Mt. Pleasant also disappeared. except for the cemetery and old stage house (now used as a home). Many of the inhabitants moved to Loogootee in the 1860's with the building of the B. and O. Railroad.

#### Thomas M. Gough was the father of seven children:

- 1. Frances, m. Patrick Sinnett; two children. Austin and Lillian.
- 2. Joseph, unmarried.
- 3. Mary Elizabeth, m. Matthew Clark; four children: Stinson (deceased), Stella, Mary, and Ernestine; family raised in Lafayette, Indiana.
- 4. Louise, m. John Doyle; seven children.
- 5. Angela, m. Michael Sinnett (brother of Patrick); five children.
- 6. William, m. Mary O'Neill; no children.
- 7. Ernestine, m. Dennis Cavanaugh; five children.

William, a prominent citizen in the Loogootee area, survived his brother and sisters. He died in 1961, age 90 years. His widow, Mary (O'Neill) Gough, is the only living person among the above seven children and their spouses.

The Union County, Kentucky branch. In 1963, Mrs. Agnes (Gough) Perkins\*, 213 North Kelsey Avenue. Evansville, Indiana, wrote that one branch of the Gough family, of which she is a member, settled in Union County, Kentucky. According to tradition three brothers named Edward, John, and Joseph emigrated from Ireland to Maryland. Soon after their arrival, they moved on to other areas. One of the three (name not indicated). with a bride of royal English birth, located in Union County.

Mrs. Perkins' grandfather was Joseph Gough and her parents were John G. and Harriett Lilly (Wight) Gough. She is the last surviving member of the John G. Gough family which consisted of the following brothers and sisters: Charles, Joseph, William, Robert, Emma, and Guidona. She has two sons and a daughter: John F. and William O., both of Evansville, Indiana and Elizabeth Lilly (Perkins) Gillooly of Louisville, Kentucky. Other descendants of the pioneer Gough in Union County include Mrs. Nell (Gough) Thompson and Mrs. Ottie (Gough) Stockton, both of Morganfield, Kentucky.

#### MISCELLANY

Edwin W. Beitzel's book, "The Jesuit Missions of St. Mary's County, Maryland," 1959, lists 30 different Goughs. Three of them-- John B., James, and Ignatius migrated to Scott County, Kentucky in 1786. John B. died in 1869 at the age of 102 years. Reference to the latter may be found in Hon. Ben. J. Webb's "Centenary of Catholicity in Kentucky", p. 89.

"A Dictionary of English Names" by Bardsley, Oxford University Press, indicates that "The Red Complected" is a nickname for Gough, and that this is one of the very few nicknames in Welsh dictionaries



John and Mary (Gough) Shircliff had eleven children. See the chart on page 2 for their names and for some of their descendants.

Dates in the above chart are mostly from wills. Some are the dates when the will was drawn; others when it was probated. Occasionally the date is taken from accounts. inventories, and other records.

Peter Shircliff's will specifically mentions his brothers John, William, and Thomas.

John Shircliff<sup>5</sup> moved from Maryland to Kentucky. Reasons for assuming that he was the son of Thomas and Elizabeth Shircliff are stated on page 11.

<sup>\*</sup> John and Ann (Goldsborough) Shircliff had a daughter named Ann.

The name Shircliff is derived from Shirecliff, Yorkshire, England\*. It is spelled in many different ways as Shercliff, Shertcliffe, Sheercliffe, Shereclife, Shurtcliff, and Shurtcliffe. These variations are due, in part, to the tendency of early writers to spell words as they sounded. It is not uncommon to find the name spelled in two or more ways in the same document. In general, this publication quotes spellings as they appear in the records.

#### FIRST SHIRCLIFF TO ARRIVE IN MARYLAND

Many generations elepsed between the arrival of the first Shircliff in Marvland and John Shircliff, great grandfather of the author. A footnote on page 240, "Jamestewn and St. Marys Buried Cities of Romance", by Henry Chandler Foreman says that Mary Troughton. a widow, on May 6, 1640 demanded and received a land grant because she provided transportation to the Province for herself and six, possibly indentured, servants, including John Sheercliffe. The footnote gives as references Maryland Historical Magazine, V. 369 and Liber AB and H., Fol.80 and Liber 1, Fol, 67. Another reference, Liber AB and H., Fol.8, Land Office, Annapolis, Maryland indicates that he arrived in 1646. Perhaps he returned to England and made a second trip with his family. Obviously he had a family before coming to America because his daughter Anne (not his first child, John was his oldest) was married in 1651. The name of John appears many times in the early history of Maryland, indicating that he was an influential colonist and owner of considerable real estate.

That John Sheercliffe (Shircliff) was born in 1617 or 1618 is documented in "Proceedings of the Provincial Court", 1658-1662, Archives of Maryland, volume 41, page 85. An item on that page says that John Sheercliffe was 40 or thereabouts on January 4, 1657. On page 590 of the same publication is another item that says John Shircliff of New Towne, St. Mary's County was 44 on August 5, 1662.

# JOHN SHIRCLIFF<sup>5</sup>

John Shircliff<sup>5</sup>, father of Julia Ann (Shircliff) Cunningham and an ancestor of the present-day Cunninghams named in this publication, was born in Maryland during or shortly after the Revolution. His parents are not definitely known but he is placed in the foregoing chart as the son of Thomas and Elizabeth Shircliff because the following facts point toward a parent-son relationship:

- (1) Thomas Shircliff's widow, Elizabeth; his daughter, Elizabeth; and John were the first Shircliffs of known record in Kentucky. Their marriages in Nelson and Washington Counties are shown in this publication.
- (2) The names of these three persons appeared in the records of St. Inigoe's Parish, St. Mary's County, Maryland. See "The Jesuit Missions of St. Mary's County, Maryland" by Edwin Warfield Beitzel, 1959, pp 82 to 85. It should be noted, however, that two John Shircliffs are listed as members of that parish and family relationships are not indicated.

John married (1) Jane Booth in Washington County, Kentucky in 1799, and (2) Mary Gough, daughter of Charles and Mary Gough in the same county in 1822; served as a Sergeant in Captain Peacock's Kentucky Militia at New Orleans in the War of 1812; moved to Barr Township, Daviess County, Indiana in 1823; and died in 1847. He had eleven children by his second wife (see chart on page 2) and, according to tradition, he had several children by his first wife but their names are not known.

This failure may be due to a fire that destroyed the courthouse in 1831. A copy of the will is on file in the courthouse in Nelson County, Kentucky. It does not reveal the children's names. John Shircliff is tentatively listed as one of them in the Shircliff lineage chart on page 10.

The early Shireliffs or persons with similar surnames arrived in America at various times and places. They had large families and, as the country grew. Shireliff names appeared in many areas.

Tradition dictates that one of the family lines started in the Bay Colony of Massachusetts. The first Federal census of 1790 lists 22 Shutliffs in that State Sometime during the next century, Decter Benjamin Shurtleff of Boston made a substantial donation to help found Shurtleff College, near Alton, Illinois. He graduated from Brewn University in 1796 and died in Boston, Massachusetts. April 12, 1847.

The first census, in 1790, lists Shirtliffs and Shurtliffs in New Hampshire; Shirtlefs in Maine; and Shurtlifs in New York. About fifty years later, in the mid-nineteenth century, census reperts show many Shurtliff, Shurtleff, Shirtliff, and Shertliff families in Boone, Brown, Clay, DeKalb, Edwards, Knox, Montgomery, Morgan, Peoria, Rock Island, and Tazewell counties, Illinois. No doubt, some of these families had their origin in New England; others, particularly those in the southern counties, prebably came up through Kentucky and had their origin in Maryland.

Allegany County, Maryland. Richard D. Mudd in his 1461 page book entitled, "Mudd Family of the U. S." says that Austin L. Shircliff of Flintstone, Karyland, writing in 1947 stated (1) he was the great great grandsen of William and Melinda (Mudd) Shircliff. (2) William and Melinda were married in 1783, and (3) they moved to Allegany County. On pages 1021 and 1022 of the book the children of William and Melinda are listed: Elizabeth, b. 2-18-1785; Mary, b. 12-25-1786; Leonard, b. 1788; Milly H., d. 4-17-1834; Francis, b. 3-17-1791; John B., b. 9-23-1792. d. 2-16-1840; A. L., b. 6-30-1794; William, b. 8-30-1803, d. 8-20-1879. Little more is known about this branch of the family.

Louisville, Kentucky. The City Directory of Louisville, Kentucky lists more than thirty Shircliffs and Shircliffes. Montgomery J. Shircliffe, a resident of that city, reports that his grandfather, Charles A. Shircliffe of Meade or Washington County. Kentucky added the "e" to the name to distinguish his family from the others in the area. He believes that most of the Shircliffs and Shircliffes in Louisville are related.

Indianapolis, Indiana. The 1963 Telephone Directory of Indianapolis, Indiana listed more than a dozen Shircliffs. Most, if not all of these are descendants of John and Mary (Gough) Shircliff of Daviess County, Indiana. The descent is through John and Mary's son Henry who was born in 1830, and lived most of his life near Hudsonville in Daviess County. Henry had four children: John W., Laury, Sally, and Mary. The latter married a Goodwin and some of their descendants may still be in that area\*.

Vincennes, Indiana. Thomas Maxwell Shircliff and Charles R. Shircliff are business men in Vincennes, Indiana. Thomas Maxwell is Chairman of the Board of Pepsi-Cola Allied Bottlers, Inc., with bottling plants in Bloomington, Seymour, and Vincennes, Indiana, together with very big operations in Charleston, West Virginia and Lynchburg, Virginia. Charles R. is Sacretary-Treasurer.

Both were born in Loogootee, Indiana, and are sons of Thomas Kevin and Laura (Mears) Shircliff. They are grandsons of Thomas Robert\*\* and Mary

Elizabeth (Sommers) Shircliff and great grandsons of Thomas and Catherine (Cissell) Shircliff. Their great grandfather was born in Kentucky in 1803. Tombstones, marking the graves of Thomas and Catherine Shircliff, may be found in the southeast part of St. Mary's cemetery, 30 miles northwest of Loogootee. Indiana. Most of the inscription on Catherine's marker is illegible; the inscription on Thomas' stone reads as follows:

Thomas Shircliff Died July 5 1857 54 yrs., 3 mo.

It may be that the great grandfather (Thomas) was the son of John and Narcy (Booth) Shircliff. After the death of Nancy, John married Mary Gough and migrated to Daviess County.

Thomas Maxwell married Martha Bayard Somes of Vincennes, Indiana. They have two sons and one daughter. The oldest son, Robert Thomas, is President of Persi-Cola Bottlers, Inc., Charleston, West Virginia. He is married and has two children, both girls, The other son, James Vanderburg, is a graduate student at the University of Virginia. The daughter, Mary Elizabeth, is married to William E. Glover, Boca Raton, Florida. The Glovers have five children, four boys and one girl.

Charles R. Shircliff is unmarried. The sister of Thomas Maxwell and Charles R., named Gail, is married to J. W. Ramsey, Charleston, West Virginia. They have no children.

#### MISCELLANY

Preserved in the Archives of Maryland are many records that provide clues to family history as well as interesting information on customs, practices, values, and descriptive terms that prevailed in that State when it was still a wilderness. The following examples from the Judicial and Testamentary Business of the Provincial Court, 1649/50-1657, Volume 10 are historic jewels:

Jan. 8, 1651. "John Sherteliff this day entreth upon the Record, one Black Cow Calf about eight Months old Crop't upon left Ear and piece Cut away square underneath and the right Ear Keel'd and Slit. And is for the use of Anne the Daughter of Said John Shercliff by the Gift of Ann and now wife of Lieu' Wm. Evans." p. 122.

John Shertcliff brought suit against Lt. Richd Banks Extor of John Codle Deft for remainder of 267 pounds tobacco and pail of salt. p. 147.

Jan. 22, 1651. "Memorandum that I Richard Spanne doe by these p'sence acknowledge to have given to John Shurtcliffs youngest child one Cowe calfe, Cropt on both Ears and Slit in the Right being colored black pyede with a star in the forehead, but if the said child doe chance to dye before it comes to age then John Shurtcliff his wife is to have the said Calfe and his increase for Ever as witness my hand the two and twenty day of January Anno Dni 1651 p.265 Witness

# THE RANEY FAMILY\* Origin of Name, Commentary, Coat of Arms

The surname Raney originated more than 1,000 years ago in central Ireland. It was derived from an ancestor called "Rayne", one of the chiefs of a large clan called the Muntear Boluis (family of Eelus). He ruled over a large area commising the baronies of Leitrim, Mohill and Carrygallen, and a portion of County Langford. The area borders on County Roseommon.

During those early years, the name took on many forms—some continuing to the present time. For instance, "Rayne" was a substitute for Reginald or Reynolds, a name of Teutonic origin from the form Reginwald and Raginwald. The sons of Chief Reginwald called themselves the MacRagnaill, the "Mac" meaning the son of. One branch of the same family varied the name to MacRaigne. The next generation of MacRaignes called themselves O'Raigne. The "O" meaning the grandson of. Other forms included Ryney, Reyney, Reany, Reaney, Rainey, O'Raine, O'Regnie, O'Regney, M'Reynie, McRanell, M'Ranald, MacRannell, McRanald, Reynoldson, Randals, and Ranold.

Prior to about 800 A. D., which corresponds roughly to the beginning of the Norman invasions into Ireland, there was little need for surnames. The population was small and everyone in a particular area knew everybody else. The individual was simply known as Art, Niall, Dermot, Brian, Maeve, Deirdre, Siobhan, Brigid, and Eithme. Then the name usually died with the individual. The origin of the name was often from the person's occupation, feature, or associated animal or object. There had, however, developed the unique clan system, based on kinship and family solidarity. No doubt, the Celts who arrived in Treland about 400 B.C. contributed to the system. Families of Gaels working and living on the same land formed a group known as a sept. Several septs made a clan, all joined by a bond of kinship. To the Irish goes the credit for being the first in Europe to adopt surnames. Variations in form may be partially accounted for by the attempt of the English to anglicise all names during the seventeenth century.

When Oliver Cromwell invaded Ireland in 1649, the Raneys were forced to give up their lands in the Leitrim area and to scatter into adjoining counties, including Roscommon. It also caused many of them to seek fortunes in British colonies in America, and in other lands.

In the fifteenth century it was customary for an Irish chief to adopt a Coat of Arms. That of the Raney family was a rearing lion between two shells at the top and one shell (sign of pilgrim) at the base; the Crest, a stag at rest; and the Motto, Favente Deo--"by the favor of God".

#### THE RANKYS IN AMERICA

The Raneys appeared in many colonies prior to the Revolution and at least three of undetermined blood relationship participated in that War: (1) Sergeant Jeremiah Raney, 5th. New York Regiment Captain John Raney, North Carolina, S32462 Pension Application; and (3) Captain John Raney, South Carolina, Pension No 4035. The descendants of these and possibly other Raney pioneers may now be found in most, if not all, states of the Union.\*\*

# JEREMIAH RANEY OF THE REVOLUTION AND SOME OF HIS DESCENDANTS

(Number to the right and above name indicates generation)

Jeremiah Raney<sup>1</sup> (Riney, Rainy, Rainey, or Rany) was born in Maryland about 1760; migrated to Kentucky between 1785 and 1793; married Mary Joan Sheehan Moore, widow of Alexander Moore, Washington County, Kentucky, December 23, 1797; moved to Martin County, Indiana (then Vincennes Territory) in 1818; and died in 1840. His grave is clearly marked in the old Mt. Pleasant Cemetery, about two miles southeast of Loogootee, Indiana.

Jeremiah served in the Revolution as a Sergeant in Captain James Rosecran's Company, 5th. New York Regiment, commanded by Colonel Lewis Dubois. He enlisted January 14, 1777 for three years, and was reported missing on October 6 of the same year. The following descendants, long deceased, were members of the Daughters of the American Revolution: Hester (Raney) Crooks, Martin County, Indiana, D.A.R. No. 202,463 and Maude (Mangas) Hagans, Lincoln, Illinois, D.A.R. No. 276,645.

He (Jeremiah) was related to Zachariah Riney\*, Lincoln's first school teacher, and probably the son of James, John, or Jonathan, early pioneers to Kentucky.

BIOGRAPHIES 28

Michael Cunningham, "the leading farmer in Barr Township," Daviess County, Indiana, was born in Roscommon County, Ireland in 1814 or 1815. He was the son of B. and Margaret (Coyle) Cunningham. His mother died in 1820, leaving two children—him and a sister about two years younger than himself. His father died ten years later, in 1830. He and his sister than lived for some time with their mother's brother. At the age of sixteen he started to work, and received \$5 a year for his services. By 1836, he and his sister had saved enough money to take passage, on the ship "Southerne", for the United States. Landing in New York, they soon obtained work. From New York, he moved to Providence, Rhode Island where he worked for a railroad. Returning to New York after a few months he carried the hod and received 75% per day; but in a few weeks, he and his sister left on the ship "Harve" for Mobile, Alabama. They arrived there when the City was having a severe outbreak of yellow fever\*.

In 1838, Michael Cunningham took a trip up the Mississippi, going as far northward as Chicago. He then worked about seven years on the Ohio and Mississippi (apparently from Louisville, Kentucky). In 1840, he wisited a friend in Daviess County, Indiana and while there purchased a 160 acre farm. In 1843, he moved to the farm where he kept house for himself for a short while. That same year, He married Julia Ann (Julianna) Shireliff, daughter of John and Mary (Gough) Shireliff. To this couple the following children were born: Mary, Patrick, Andrew, Elizabeth (Lyde), Louis, Michael, John, and Joseph F. (Called Frank). He was a successful business man. Ref. "History of Knox and Daviess Counties," 1886 by Orlan F. Baker.

Comments by the compiler: Although Michael Cunningham started with nothing, he was able to acquire a large acreage of land, left a farm to each of his eight children and to his widow. Sheep and mules were his specialties. He had hundreds of breeding ewes; he was one of the first mule buyers in southern Indiana, and sometimes broke (trained to work) as many as 60 young mules in a season. According to legend, he was a stern, thrifty Irishman. To his honor and memory, stands a huge granite monument in St. Mary's Cemetery, about four miles northwest of Loogootee. His name on the monument is mis-spelled, "Cuningham"

Patrick Hopkins, son of John and Julia (Skelly) Hopkins, was born in Langford County, Ireland. The exact place and date of birth are un-known. He came to America at an early age and after working at various jobs in New York, Pennsylvania, Maryland, Ohio, and Kentucky, bought a farm in Barr Township, Daviess County, Indiana. He married (1) Catherine Riley who died two years later, leaving one child, Julia Ann\*† His second marriage was to Elizabeth Mahala Raney, daughter of Felix and Mary (Neal) Raney. To this union the following children were born: John, Mary, Phoebe, Thomas, Elizabeth, James, Edward, Henry, Marguerite (Maggie), Catherine, Frances, Julian, Peter, Rose, and one who died in infancy. Ref. "History of Knox and Daviess Counties, Indiana", 1886 by Orlan F. Baker.

Comments by compiler: Patrick Hopkins had near relatives in America, pobably one or more brothers. In 1919, just after World War I, the author visited the second or third generation Hopkins in Newark, New Jersey. These included Loretta Hopkins (an un-married school teacher) and two of her sisters, one married to an C'Rourke, the other a Num. About the same time or earlier, Monsignor Eugène Hopkins, another relative, was located in the Chicago area.

FRANK CUNNINGHAM, the youngest child of Michael and Julia Ann Cunningham, was born in Daviess County, Indiana on March 3, 1866. He married Frances Hopkins (a school teacher), daughter of Patrick and Elizabeth (Raney) Hopkins on October 7, 1890. She died on January 26, 1899, leaving four children: Marie, Bernard, Carl, and Eugenia. He was re-married in 1900 to Effa Smith, daughter of John and Ann Smith. His living children from the second marriage are Glenn, Ralph, Catherine (Telfer), and George. He was guardian for Doris Cunningham, page 26.

Frank Cunningham's principal business was farming but he had many other interests such as banking, private loans, and community affairs. He was a member of the contracting firm that built the first improved, country road in Daviess County. It was 28 miles in length, of crushed stone construction, and cost \$60,000. He owned several farms and held stock in the Citizens Bank in Washington, Indiana and in the White River Bank and First National Bank in Loogootee. In the latter bank, he was a director. He was highly respected for his honesty and good judgement. During his latter years, heart trouble forced him to curtail his activities and he died suddenly on September 7, 1921. His grave is marked by a monument in St. Mary's Cemetery, Daviess County, Indiana.\*

#### CUNNINGHAM HISTORY

"Reliable Cunningham history can be traced back to the year 1150. This is about the year Cunningham Castle, Ayshire, Scotland was built -- located on the banks of the Garnock, two miles north of Kilbarney, Scotland.

The sheaf-fork is on the Cunningham crest of arms; "Over Fork Over", the motto. The significance of the motto and insignia is based on the following tradition: "Malcolm, son of Freskin, assisted MALCOMB, Prince of Scotland in making his escape from Macbeth. Later, King Malcomb Canmore conferred the name Cunnynghame" and the family took the indicated crest of arms. Ref., "Dictionary of the Peerage and Baronage" by Sir. Elizabeth (Meyer) Cunningham, wife of the author, is the daughter of the late Fred and Mary (Metzger) Meyer, Lafayette, Indiana. Her grandparents emigrated to America about the middle of the nineteenth century. They came from Alsace-Loraine.

Joan (Reeve) Cunningham, wife of David Cunningham, is the daughter of Edward Reeve, who died in Escandido, California in 1955. Her mother is Margaret (Brabant) Reeve of Vista, California. Joan is a descendant of John Michael Kull, 1814-1881. She has an ancestral chart.

Lillian (DeSitter) Cunningham, wife of Thomas Cunningham, is the daughter of Louis and Elvire DeSitter, LaGrange, Illinois. Her parents, of Flemish crigin, emigrated from northern Belgium shortly after World War I.

The Elizabeth Shercliffe (Shircliff), named in the Deed, appears in the marriage records (1) as the bride of Joseph Dant in Nelson County, Kentucky in 1792 and (2) as the bride of Richard Leake in Washington County, Kentucky in 1804.

John Baptist Dant married Elizabeth Shercliffe (Shircliff), widow of Thomas Shercliffe in Nelson County, Kentucky on July 26, 1791. This was a year before Washington County was carved out of Nelson County.

The names, Joseph and Thomas Shircliff appear many times in the early records of Nelson and Washington Counties, Kentucky. See pages 15, 16, and 17 of the publication, "The Cunningham Family of Daviess County, Indiana and Gough, Shircliff, Raney, and Hopkins Alliances".

Property names in the Deed may be significant. "Linstead" was probably the same tract as the one known as "Linstead Addition", bought by Henry Shercliffe, brother of Thomas Shercliffe, in 1755. See page 14 of the 1965 publication. This name may be the key to the place of origin of the Maryland Shercliffes (Shurcliffs). There are two Linstead parishes in County Suffolk, England. Linstead Magna is in East Suffolk, about 5 miles west of Halesworth. This parish recently had an acreage of 1325 and a population of 67. Linstead Parva is also in East Suffolk, 32 miles northwest of Halesworth. It consists of 567 actes and has a population of 113 persons. "Familiae Minorum Gentium", Vol. 4 lists many Shiercliffes in Suffolk County.

"Greens Lot", on the last line of page 31, might have been named after Henry Shercliffe's wife. Her maiden name was Mary Green. Henry Shercliffe's will was probated in 1767.

The data on these pages (33-37) were assembled in an unsuccessful attempt to identify the parentage of Jeremiah Raney, an early pioneer in Washington County, Kentucky and in Martin County, Indiana. Although the objective has not yet been accomplished, the data may still be useful in a continued search and, in addition, be helpful in other lineage studies.

Comments by the compiler: The Thomas Riney and Priscilla Riney wills were apparently made by husband and wife. Each names Robert Riney and Susannah Whatley (Wheatley). Other beneficiaries are not the same. This may be due to many circumstances such as opinion of parent that one child is more deserving or more needy than another, children are from different marriages, and one or more of the children have moved to another area and have broken all family ties. The Priscilla Riney will mentions three sons: Robert, Joseph, and Clement. These are probably the same Rineys (Raneys) that settled in Martin and Daviess Counties, Indiana about 1817-1818. An unpublished manuscript written in 1957 by Ruth Eileen Raney says that the Martin and Daviess County Raneys came from Washington County, Kentucky and that there were three brothers named Robert, Joseph, and Clement. See pages 35 and 36 of this supplement.

REFERENCES TO RINEYS (RANEYS) IN WEBB'S CATHOLICITY IN KENTUCKY\*\*

"In the year 1785, a league of sixty families was formed in Maryland--all Catholics and mostly residents of St. Mary's County"--, p. 27. The purpose of the league was to move to Kentucky.

THE EFFINGHAM, ILLINOIS RANEYS

R. J. (Jeremiah) Raney, D.D.S. Effingham, Illinois was born in 1886 in the Whitfield area, south of Loogootee, Indiana. He is a son of Jeremiah Raney, grandson of James Raney, and great grandson of Jeremiah Raney. Dr. Raney has four sons: E. H. Raney, M.D., Appleton, Wis.; Ronald Raney, civil engineer, Effingham, Ill.; James Raney, loan supervisor, Cedar Rapids, Iowa; and Tom Raney, mail clerk, Farmers City, Ill.

<sup>\*\*</sup> The wife of Jeremiah Raney had several names: Mary, Joan, Sheehan, Moore, Polly. The first two were probably her given names; the third, her maiden surneme; the fourth, the name of her first husband; and the fifth, a nickname.

<sup>\*\*\*</sup> Valentine Raney was the son of Joseph and Rebecca (Silvers) Raney. According to Ruth Eileen Raney, Valentine Raney married Eather Love and served as a Colonel in the Union Army, from Missouri; Edward Raney, a brother, served as a Colonel in the Confederate Army, from New Orleans.

#### THE WHITFIELD, INDIANA RANEYS

Whitfield is a small village on Route 231, about three miles south of Loogootee, Indiana. In this village lives Ruth Eileen (Nellie) Raney\*, the 90-year old widow of Frank E. Raney. She was born December 23, 1875 and was married October 11, 1897. Her children, eight in number, have distinguished themselves in various professions and other walks of life. See the History of Martin County, Indiana, second edition, 1966, by Harry C. Holt.

Mary Elvena Agnes Raney, born October 27, 1898-- Sister Angelica S.P., Providence Order, St Mary's of the Woods, Terre Haute, Indiana; stationed in Formosa.

Dr. Rupert Brendan Raney, born October 15, 1900, graduate of Creighton University, Omaha, Nebraska; neuro-surgeon in Los Angeles, California until his death in 1959.

Marguerite H. Raney, born June 7, 1903, dress designer; married Paul H. Schmidt, an attorney, Indian Hill, near Newburg, Indiana.

Vincent G. Raney, A.I.A, graduate of the University of Illinois; married Edna May Brown of San Francisco, Cal.; is a prominent architect in that city.

Paula Frances Raney, born in 1909, talented artist; married James Harold Newman, sales supervisor, Los Gatos, California.

Dr. Aidan A. Raney. born in 1911, graduate of Creighton University, Omaha, Nebraska; prominent neuro-surgeon in Los Angeles, California.

Irma C. Raney, born in 1915, Registered Nurse (R.N.); married Max Menz, sales supervisor, Fresno, California.

Ivana Victoria Eileen Raney, born in 1918 -- Sister Marguerite, Providence Order; teaches French in Indianapolis, Indiana.

The mother, Ruth Eileen Raney is of Raney-McGovern-Gootee descent. Her parents were Joseph Silas Gootee and Margaret Anastasia McGovern; her grandparents, John Gootee and Ruth Jane Raney; her great grandparents, Joseph Raney and Cecelia Cissell. Joseph Raney was probably the son of Priscilla Riney. See page 33.

The father, Frank E. Raney (1873-1940) was the son of John Raney and Martha Johnson; grandson of Col. James Raney and Mary Holland; and great grandson of Jeremiah Raney and Mary Joan (Sheehan) Moore. Col. James Raney was in the Mexican War and a recruiting officer in the Civil War. The brick house, which he built in 1840, still stands about two miles south of Loogootee on Route 231 and about 60 rods west.

According to Ruth Eileen (Nellie) Raney, Joseph and Jeremiah Raney were first cousins and among the first settlers in Martin County. She says that in 1817, five years before the County was organized, Joseph and his brother Clement went to the Land Office in Vincennes, Indiana and entered land in the area that was to become Martin County. Jeremiah Raney arrived a year or two later. The Raneys came from Washington County, Kentucky.

<sup>\*</sup> In 1957, Ruth Eileen Raney wrote a 42-page history of her family, which was never published. She gathered information from genealogical libraries in Boston, Cincinatti, Indianapolis, San Francisco and other cities.

William Gough, head of the Gough lineage on pages 2 and 30\*, was born in County Gloucester, England. Records disagree on the year of his arrival in Maryland. The "Tercentenary History of Maryland" says that he arrived in 1673; a record handed down by William Joseph Gough of Sacramento, California says that he arrived in 1664.

Gough and Octavia Streets, principal thoroughfares in San Francisco, were named after Louis and Octavia Gough (husband and wife) of St. Mary's County, Maryland. After helping to lay out the City, he returned to Maryland and, according to the "Streets of San Francisco" by E. M. North, lived in Bel Air.

William Joseph Gough, whose name appears in the tenth generation of page 30, died in Sacramento, California on November 29, 1965. He is survived by a son, William Mannix Gough, and a daughter, Margaret Gough\*\*.
