

Hopkins' History of the Kellogg Family, a book containing 30,000 names, gives the descent of Olive Kellogg as follows: Olive ⁷ Kellogg, Daniel ⁶, Daniel ⁵, Ensign Stephen ⁴, Lieutenant Joseph ³ of Hadley, Mass., Martin ² of Braintree, Essex, England, Phillipe ¹ of Bocking, Essex, England.

From Burke's "Ancient and Dormant Peerages":

It is said by some antiquaries that the head of this family was a Hungarian gentleman, who came to Scotland with Margaret, Queen of Malcolm Canmore about 1070. Their immediate ancestor, Livingus, flourished in the reign of Alexandrer and his brother David and possessed a considerable estate in West Lothian called Livingstone. His son, Thrustanus, witnessed the foundation of Holyrood House in 1128 and was the father of Alexander Livingstone, who first assumed the surname. His son, Sir William Livingstone, had three sons, (1) William, from whom descended the Livingstones of Livingstone, the last of whom fell at Flodden in 1513, leaving three daughters; (2) Archibald; (3) Adam.

Archibald was the father of Sir William Livingstone, who married a daughter of Sir John Erskine and left son and hier, Sir William, who accompanied King David II in an expedition to England in 1346 and was knighted under the royal banner and taken prisoner at the battle of Durham in 1346. He had a grant of the Barony of Calendar, then in the crown by forfeiture of Patric Calendar, whose daughter and heir (Christian) he married. His only surviving son and successer, Sir William Livingstone, of Calendar died in the time of King Robert II, leaving a son, Sir John Livingstone of Calendar, who married a daughter of Mentieth Carse and had issue:

- 1. Alexander, heir.
- 2. Robert, ancestor of the Livingstones of Westquarter and L. of Kynnaid, Earls of Newburg.
 - 3. John, ancestor of Livingstones of Bonton.

4. William, ancestor of Viscounts of Kilsythe.

The eldest son, Sir Alexander Livingstone of Calendar, after having passed through many political trials was finally restored to royal favor and appointed justiciary of Scotland and sent as ambassador to England in 1449. He married a daughter of Dundas of Dundas.

His eldest son, Sir James Livingstone of Calendar, County Stirling, had appointment of Captain of Royal Castle Stirling and tuition of young James II and was afterwards created a peer of Scotland as Lord Livingstone. He died about 1467.

William, sixth Lord Livingstone fought for Queen Mary at Langside. He married Agnes Fleming and had issue:

Alexander died in 1592, succeeded by a son, Alexander Livingstone, seventh lord, who was created Earl of Linlithgow, Lord of Livingstone and Calendar in 1600.

- 1. John.

James acquired high military reputation. Returning he was constituted one of the gentlemen of the bedchamber to King Charles I and created Lord Livingstone of Almond (1633) later (1641) received patent to Earldom of Calendar.

He married Margaret, daughter of James, seventh Earl of Yester, sister of first Earl of Tweeddale and dowager of Alexander, first Earl of Dunfermline, high chancellor of Scotland. He was succeeded by his nephew, Alexander Livingstone, second Earl of Calendar, who married Lady Mary Hamilton. He was also succeeded by his nephew, Alexander, third Earl of Calendar second son of George, third Earl of Linlithgow. He married Lady Anne Graham and had issue:

- 1. James, fourth Earl of Calendar.
- 2. Hewrut, unmarried.
- 3. Mary, married James Graham, Judge of Court Admiralty.

James, the fourth Earl, succeeded on the death of his uncle to the Earldom of Linlithgow, 1695. His estates were forfeited in the rebellion of 1715,

James---Lady Margaret Hay, daughter of John, twelfth Earl of Erroll. Their son, James, Lord of Livingstone, died in 1715. Anne married the fourth Earl of Kilmarnock and her son succeeded to the Earldom of Erroll. The great Callendar property was purchased in 1780 by John Forbes of Callender.

Though the strongholds of the Callenders and Livingstones are in ruins in Scotland, a flourishing branch of the family still remains in high honor and distinction in America.

Almond House of Callender County, the family home of the Callenders, is described in Grose's "Antiquities" as follows: "Almond House or Castle stands on an eminence about one-half mile south of the great road from Linlithgow to Stirling. It consists of two old towers with a modern addition, seemingly of the time of Charles I or II. Part of the tower is very ancient."

In 1715 James, last Earl of Linlithgow and Callender, who in 1713 was chosen one of the peers of the United Kingdom, true to his heriditary faith, joined the Earl of Mar. When that nobleman's enterprise failed his title and estates, with attendant rights and privileges, were forfeited.

From the Livingstone or Callender family are descended David Livingstone, the African explorer; John Callender of Craigforth, an antiquary of much renown, and numerous other prominent persons. From this family also are the Livingstones of Clermont, N, Y., who furnished a Governor, a Mayor and other prominent political leaders. Their manor house at Clermont is drscribed in Glenn's "Colonial Residences."

As early as 1669 we find living in Boston Rev. Ellis Callender a lineal descendent of Alexander, first Farl of Callender.

It was customary in Scotland to use the estate as a second family name. I cannot trace the exact descent yet, but the name Norman was a family name in the Callender and Livingstone families as far back as 1600

Rev. John Callender of Boston used as a book plate the Callender coat of arms engraved by Joseph Callender, who was a prominent engraver of the period.

Sprague's "Annals of the Baptists" gives the follow-

ing account of Ellis Callender:

"Elisha Callender was a son of Ellis Callender, who officiated as the principal speaker in the First Baptist Church in Boston while they were destitute of a pastor for about thirty years. Having tried in vain to get a minister, they called Ellis Callender as pastor. He was ordained in 1708 and continued in office ten years. He is supposed to have died in 1726, age about 80.

Elisha, his son, was born in Boston and educated at Harvard. He received the degree B. A. in 1710. He was ordained in 1713 and became pastor of the church his father was connected with for fifty years and teacher of for forty. This ordination was signalized by much friendly feeling between churches formerly on bitter terms, several Congregational ministers being present. Mr. Callender had but a feeble constitution, but was abundant in his labors. He preached frequently at Springfield, Salem and numerous other towns and baptized many. His own church was particularly prosperous while under his care. While his prospects were brightest he was cut off by death in 1738, in the twentieth year of his ministry. Mr. Callender was the first native Baptist minister who had recieved a collegiate education.

This Ellis Callender was the son of Michael Callender, who came to this country with Govenor Winthrop in 1630. Of the grandsons of Ellis Callender I have

only the names of three:

1. Eleazer, who was Overseer of the Poor for many years and one of the original members of the Society of the Cincinnati. He was the grandsire of the present Boston Callenders, several of whom are of some prominence.

2. Rev. John Callender of Newport, the most illustrious of the name whose "Century Sermon," reprinted by the Massachusetts Historical Society with an extensive biography of Mr. Callender by Romeo Elton, is still the only authority on early Rhode Island history.

3. Phillip Callender, who as early as 1718 was master of "Ye Sloop Mary Ann" plying between Boston and Newport. This Phillip. following the river up through Connecticut, settled in Sheffield in 1733 and

he and Daniel Kellogg were chosen Selectmen. These two were also, in 1735, selected as the first deacons of the church in Sheffield. Nathaniel Callender, his son, was married in Sheffield in 1743 to Ruth Winchell. Nathaniel, son of this marriage, married Deiedamia Dewey, daughter of Stephen and Joanna Dewey, who was born March 22, 1750. He died March 12, 1779. This couple had issue as follows:

1. Lovice, who married Dr. William Larribee. One of their sons, William M. Larribee, was a prominent

business man of Chicago.

2. Deiedamia, who married Martin Van Dusen. One of their sons, Captain Charles Van Dusen, lived at New Albany, Md., and afterwards at Chicago.

3. Jared, who left Vermont for Ohio in 1810 and was said to have settled in New Philadelphia, Ohio.

4. Jerusha, who married a man named Huggins.

5. Nathaniel, who was born in Sheffield, Mass., September 4, 1769, married in Sheffield December 20, 1791, to Olive Kellogg, and died in Harrison (now Carroll) County, Ohio, December 30, 1822.



The first of the Kellogg family in this country was Joseph Kellogg, who married as his second wife Abigail, daughter of Stephen Terry, who came to this country on the "Mary and John" in 1630. This Joseph Kellogg settled in Farmington and was Selectman there and also at Hadley, Mass., where he lived later. He was also Sergeant in command at the famous Turner's Falls fight with the Indians, May 18, 1676. His son, Ensign Kellogg, married Lydia, daughter of John and Lydia Belding, and settled in Westfield, Mass. His

son, Daniel Kellogg, born in Westfield December 15, 1704, was married in Sheffield, May 13, 1731, to Hannah Noble, daughter of Hannah Noble, who was the first white man in Sheffield, He spent the winter alone with the Indians and in the spring brought with him from Westfield through the wilderness his daughter, then aged 16.

Daniel, son of Daniel and Hannah Kellogg, was born in Sheffield, November 6, 1746, and married Rhoda, daughter of John and Mary Smith Callender, who was born November 23, 1751. He accompanied Arnold to Quebec as his orderly and died of exposure and disease on the retreat. He was buried in the snow by his cousin, Jesse Kellogg, who afterwards married his widow. She died September 14, 1813, leaving five children:

- 1. Olive, born February 29, 1772, married September 14, 1796, to Nathaniel Callender, and died in Meadville, Pa., April 21, 1849.
- 2. Daniel, born November 5, 1774, married Mary Kellogg and left eight children: Lorenzo, Daniel C., Parmela, Sylvester, Mary Matilda, Eli C., Jane M. and Daniel Alonzo.
- 3. Parmela, born May 25, 1780, married William B. Dimmick and had six children: Delia, William B., Rhoda, James Jesse, Mary Matilda and John Jay.
- 4. Sylvester, born April 13, 1785, married Celia Ensign and had three children: Alfred S., Ann Matilda and Robert E.
- 5. Matilda, born March 22, 1790, died single April 25, 1856. She was a teacher of languages in Baldwin Institute and a very learned woman.

Mercy, sister of Daniel Kellogg, married Joseph, brother of Rhoda Callender Kellogg, in Sheffield June 21, 1759. The ten children of this union, who were double cousins of Olive Kellogg, have many descendents in all parts of the United States. The only one of the name now in Sheffield is Guy Stevens Callender, professor of political economy at Yale, who has a summer home there.

Nathaniel and Olive Kellogg Callender had issue as follows:
