FOREWORD

An unseen hand has guided this book to completion.

Late in June, 1924, my father, Arthur Jay Carruth, made his customary noonday visit to my office in The State Journal, Topeka, Kansas. It was his habit to make me a daily call. Always immaculately dressed, he would enter the office about 12:30 o'clock. Greeting the employes in the business office, in the advertising department and in the offices along the hall that led to my department on the paper, he had a word of cheer for everyone.

On an evening newspaper the noon hour is a trying time. Reporters are coming in from their runs, the advertising columns have closed, space is figured for the day and the layouts are being completed for the "spot news" editions. My father knew all this. He loved the noon hour life in the news room. And, owing to his vast amount of general information, his knowledge of law, his wide acquaintanceship and his willingness to be of personal service to anyone at any time, the reporters often would await his visits. They valued his judgment and appreciated his spirit of co-operation.

On this particular day in June he entered as usual, borrowed an early edition from the telegraph editor, walked in my office, hung his walking stick on the filing cabinet and settled down for a half hour's scanning of the news columns.

I don't know what caught my eye that day but I remember studying his face with considerable concern. He seemed tired. I realized that he had been forced to postpone his annual visit to New York, where he was to be a guest of his brothers and sister and other relatives, because of considerable dental work he was having done. I realized, also, that he was planning to bring this genealogical record to a close that it might be ready for the printer in the fall.

"How are you coming along on the family tree?" I inquired.

He laid down his paper, settled back in his chair, rubbed his eyes and replied:

"I feel that I must set a quitting time on it. There is no end to the probing of these records. I find myself getting in deeper and deeper and I have been shocked recently with the realization that since I have assembled some of the lines there have been deaths. I don't see any way out except to bring it to a close."

Something almost tragic overwhelmed me while he was talking. I cannot explain the feeling of fear that seemed to envelop me at that moment. Now that I look upon the incident with retrospection I am most thankful that I was inspired to say to my father that noon:

"Dad, why not do this? Get your notes together—in order. Lay them out as you want them. I'll help you type them because Norma (my wife) and the children are away for a week or so and we can work together in the evenings. Arrange the copy, we'll take it to a Topeka printer, have it set in type, and when you are ready to go back east you can take the proof sheets with you. Back there you can make the final corrections, talk with Uncle Charlie and Uncle Clarence, and when you return in the fall the biggest part of the work will be complete. What do you say?"

He listened intently to my suggestion—as he always did to any suggestion or to any conversation. When I finished he made no comment. I could see that he was weighing the matter carefully. I turned to the telephone and called Charles L. Mitchell, a devoted friend of the family and the manager of a Topeka publishing house. I asked him if he would do this work and hold the type until fall. Of course he said he would. He was the kind of a man who never considered his own inconveniences when he was able to favor a friend.

I turned around to my father who had not spoken a word. He was smoking and as I watched him I feared that I had rudely interrupted a plan that had been uppermost in his mind for years. I felt guilty of trespassing. My own hasty action settled down on me suddenly and fearfully. It seemed that I was creating out of a man's life's work, a precipitated and superficial "extra edition."

I was called from my office at that moment and when I returned he was gone.

My urgent action haunted me-dazed me.

In an hour he returned. In a brief case he had his notes—part of them. He laid them out on my desk. He started to explain. I tried to follow his explanation. Scores of times he had talked to me of this work in genealogy. And as many times I only nodded my head in confusion.

"I'm afraid your idea is not practical," he summed up finally. "I can do all this you suggest but wouldn't it be better to wait until I come back from New York and we can push the book through?"

Again that unseen hand led me—again my mind was directed mysteriously and unconsciously.

"Your notes are bulky and unhandy to carry," I argued. "Proof sheets would be orderly and easily corrected. Furthermore, you would have a better idea of the size of the book, of the additional material you desired."

The next day Mr. Mitchell called me. He said my father had been at his office and he arranged an appointment for the three of us. We met, selected the type size and column widths and the paper stock. My father went straight to his rooms at the University club and laid out his notes.

He was still working on his typewriter when I called to eat dinner with him that evening.

Until dark we sat on the club veranda and talked. He was as enthusiastic as a child. We went down town and as we passed The State Journal building he noticed the linotype operators on the night shift at work.

"I want to talk with one of them about marking the copy for indentations," he said. "I believe I could save the publishing house operators work and time."

We entered the building and I was amazed at his knowledge of linotype machines and operation. So was the operator.

As a result, my father marked every line of his copy—the copy that has been transcribed in this book. He marked the ems of margin indent. It was a delightful piece of work for the operators. It pleased my father to know that he was helping them although it took him many, many hours to arrange the copy.

In less than a week the copy was typed and marked. Just before I left town to visit my family I had procured the first proof sheets for him. He read them, studied them, fondled them—loved them. His work was developing and unfolding before him.

Three days later I returned to Topeka only to find him seriously ill at his rooms in the University club. Rather than cut short my visit with my family he had suffered alone although I am sure he never knew the seriousness of his illness. The doctors who attended him at the club did not at first consider his sickness alarming. We removed him instantly to Christ's hospital. Following a consultation of doctors, my brother, Edgar W. Carruth, and I were told of his condition. Pneumonia had set in. His heart was not holding up under the strain.

The following day the last of the proofs were sent to my office. I took them to him at the hospital. His eyes brightened and calling for his glasses he read them through—word for word. He suggested corrections which I noted.

On the morning of July 18, 1924, a week after his removal to the hospital, he passed away.

My brother and I feel hopelessly incapable of arranging this product—this priceless treasure that cost its author so many months of effort and time and afforded him so many hours of pleasure and anticipation. Yet, it was his ambition to devote his late years to a "Carruth Book" and our constant aim always will be to carry on in the course he so generously laid out for us. His life was an inspiration.

The records contained herein are the facts he collected. They are, of course, necessarily without the intimacies he would desire. Scores of the dates printed herein were obtained after hundreds of miles of travel, hours of study, visits to homes and libraries and, at times, almost hopeless letter writing. These facts were most difficult to obtain, in many

instances, yet they afforded him delightful investigations and new acquaintanceships that developed quickly into love and affection and friendship.

May I relate one incident.

My father was on the trail of a Sutherland family. I cannot remember where he first picked up the clue but relentlessly he followed it. Acquiring the name and initials he sent his first letter. It was returned with the suggestion that he try a city in another far off state. Again the letter came back. Again he tried. Another envelope was necessary—and he used a large size for forwarding purposes. Finally one day the letter drifted to Topeka with the words across its face, "Try Burlingame, Kansas." Burlingame, Kansas—less than thirty miles from Topeka! I'll never forget the day he received an answer from Burlingame. Mr. and Mrs. Sutherland were charming people and with them lived a most lovable family. His visits to their home were among the brightest spots in his life.



GENEALOGY OF THE CARRUTH FAMILY.

CARRUTH was originally spelled CARRAIG, being a Gaelic word, "carr" meaning rock and "aig" being the diminutive, hence small rock.

As a surname it is not a contraction of Carruthers as some have believed, this latter being a Dumfriesshire, Scotland, name while the Carruth clan lived in Renfrewshire.

A booklet written by John Carruth Campbell of Muirkirk, Ontario, Canada, 1895, gives the account of the adopting of the name.

Near Renfrew close to the River Clyde in Bonnie Scotland is today a gentleman's house called Carruth. For many years the large and distinguished clan of Cunningham has lived in this vicinity. Early in the 17th century one John Cunningham who lived on the place called Carruth styled himself John of Carruth to distinguish himself from the many other John Cunninghams in that neighborhood. His descendants adopted Carruth as their surname.

We further learn from the Campbell booklet that the coat of arms of the Cunningham family was adopted, according to Frederick Van Bussan, a learned Norwegian who wrote of several Scottish families, from this history of the family.

One Malcolm, son of Freskin, assisted Malcolm prince of Scotland, (afterwards King Malcolm III, Ceanmor) to make his escape from Macbeth after the death of his father Duncan, who was slain in the battle at Bethgowan in 1039. Being hotly pursued, he took shelter in a barn where Malcolm concealed the prince by forking hay over him. The pursuers, not finding their prey, went to get hay for their horses and were in the act of uncovering the prince when Malcolm pointed to the other side of the mow, saying, "Over, fork over" (the hay is better over there). The prince eventually made his escape into England, still attended by the faithful Malcolm. When the prince became King, after

his victory over Macbeth in 1057, he rewarded his preserver with the Thanedom of Cunningham. Later the family was represented in the Barony of Kilmaurs and created Earl of Glencairn.

The Carruth coat of arms shows the connection with the Cunning-ham clan by retaining the hay fork.

The name Carruth is nowhere common but is to be found in New Zealand, Canada and the United States as well as in Scotland and the North of Ireland.

A branch of the family migrated from Scotland to the Plantation of Ulster in the North of Ireland during the reign of James I, 1615, and from this line sprung the Carruths listed herein.

JOHN CARRUTH 1.

With the Scotch-Irish who emigrated to Massachusetts in the early years of the 18th century and brought the potato to America, came John Carruth and his (by tradition) half-brother William. Both settled in what is now the town of Northborough, Worcester Co. William remained but a few years (his old farm is now owned by Thorton E. Mentzer), going to Shrewsbury in 1745 and to Barre in 1753 where he died in 1799. He has descendants around Boston.

John first appears in the records when he married Jemima Russell of Sudbury previous to 1734. Temple's History of North Brookfield and a Carruth Genealogy compiled by Wm. Ward Carruth narrate a family tradition, doubtless both from the same source, to the effect that Jemima Russell was the child of parents of more than ordinary means and was stolen on the streets of London by thieves who were attracted by the jewelry that she wore, and sent by them to America. With all respect for traditions it is hard to reconcile this one with the records.

From Paige's Cambridge, Hudson's Lexington, Bond's Watertown, Cutter's Gen., Temple's North Brookfield, Vital Records of Lexington and Northborough we learn: Jemima Russell, b Lexington 9-8-1714, bap. 9-12-1714, m John Carruth previous to 1734, d Northborough 9-19-1798, aged 84 years on the date of her death (11 days difference between O. S. and N. S.). Her father was James, b 7-23-1681, d 4-1-1748, m Mary Howe 1-10-1705-6. The father of James was Phillip, b Cambridge about 1650, d 2-7-1730-1 aged 80, m Joanna Cutler, 6-19-1680. The father of Phillip was William the emigrant ancestor b England 1605 settled in Cambridge 1636 where he died 2-14-1661-2.

Historians have John as living in Marlborough, Westborough and later in Northborough. He lived only on the farm that he bought of Jonathan Flagg, being a 30-acre "strawberry meadow," consideration 100 pounds, date 11-16-1736. He later purchased adjoining lands of Nathaniel Oak and Jonathan Oak. This place is located about one mile north of Northborough on the road leading to Berlin and is now occupied by George A. Brigham.

This section was once a part of the town of Marlborough, later being set off with the town of Westborough and is now a part of Northborough. The old house has been torn down to make room for the present home, but a barn built by the original owners is still in use.

John was active in township affairs, having been Selectman (then called Precinct Committeeman) 1759 and Collector 1751. He was one of the ten organizers of the Northborough Church, 5-21-1746, and was listed with his brother William among the largest taxpayers in 1752.

The date of his birth is not known and the record of his death was lost when the books of the church were destroyed by fire in the home of the pastor April, 1780.

WILL OF JOHN CARRUTH 1.

IN THE NAME OF GOD, Amen; The Tenth day of April, 1771, I John Carruth of Northborough, in the County of Worcester, and Province of Massachusetts Bay, in New England, Yeoman, being weak and infirm in body but of a sound and disposing mind and memory, Thanks be given unto God, and calling unto mind the mortality of my Body and that it is appointed unto all men once to die, I do make and ordain this my last will and testament, That is to say, Principally and first of all I give and recommend my soul into the hands of God who gave it, and my body I recommend to the earth to be buried, in a decent Christian manner at the Direction of my Executor: not doubting but at the General Resurrection I shall receive the same again by the Mighty Power of God, and as touching such worldly estate wherewith it has pleased God to bless me, in this life, I give, devise, and dispose thereof in the following manner and form:

Imprimis, I give and bequeath to my beloved wife, Jemima, all my Household Furniture and wearing apparel to be disposed of as she shall think fit; also the improvement of the East End of my dwelling House, also two cows, one of which to be kept, also two sheep, one of which to be kept, also I give her Twelve Bushels of Indian Corn, Four of Rye and half a bushel of Wheat, and half a bushel of Beans Yearly and also sufficient Wood for her fire Annually.

Item: I give and bequeath to my eldest son John, all my real estate and the rest of my personal estate, he paying all my just debts, and complying with the terms respecting his Mother as aforesaid and paying to the rest of my Children each a certain sum as below directed. Item: I give and bequeath to each of my other children the sums following, that is to say: to James Five Shillings, to Jonas one Pound, Six Shillings and Eight Pence, to Nathan one Pound Six Shillings and Eight Pence, to Josiah Six Pounds, Thirteen Shillings and Four Pence, to William Four Pounds, to Jemima Five Shillings, to Lucy, Sarah and Lydia Four Pounds each to be paid by my son John; that is to say to pay James, Jonas, Nathan and Jemima, in one year after my decease and to pay the rest of the children according to their respective ages, the particular sums herein given to them, making but a year between each payment. And I do hereby constitute and appoint my son John sole executor of this my last Will and Testament, revoking and disannuling all other and confirming this and no other.

In Witness whereof I have hereunto set my hand and seal this day and Year above written.

JAMES CARRUTH 2.

JAMES CARRUTH, 2, b 10-2-1737, d 12-6-1812, m Lucy (b 3-1-1751, bap. 1st Church Marlboro 4-28-1751, d 3-25-1803) dau. Aaron Gary, 10-5-1769. Aaron was a Minute-Man in the Rev. War from Lancaster.

James was a small man but very active. At the age of 22 he purchased of Joseph Farnwell of Groton, a 70-acre lot in the "township of Narraganset No. 6, Co. of Worcester, 2d division land No. 21 lying on Hides Hill," under date of 5-2-1760, the consideration being 19 pounds. To this purchase he added 20 acres from John Mead for 33 pounds, 6 shillings and 8 pence, 1768, 27 acres from Joseph Byam for 9 pounds 1769, 31 acres from Caleb Piper for 50 pounds 1781, 2 acres from Elisha Parker for 12 pounds 1783, 23 acres from Wm. Boardman for 40 pounds 1792, 12 acres from Seth Phillips for \$117, 1801, making his holdings total 185 acres.

On this property located about 1½ miles from the settlement called at various times Templeton, Gary and now Phillipston, he spent the remainder of his life. At the time of his original purchase this country was a wilderness and for nine years he lived alone clearing the land, building a house and preparing a home for the wife and family of his dreams. Of the family that he raised it is worthy of note that ten children were living with their first husband or wife when their average age was 50 years.

Under date of 5-11-1803 James deeded to his son James Jr. all his real and personal property to hold after his death, the consideration being the payment of \$20 to each of his children Lucy Farr, Sarah Phillips and Jemima Sawyer and \$780 to be equally divided among his other children Azubah, Patty, Amos, Levi, Levina and William.

His record as a Soldier:-

A Minute Man of 1775, private Capt. Ezekiel Knowlton's Co., Col. Nathan Sparhawk's Reg. marched on alarm of 4-19-1775 to Cambridge, Mass. Service 14 days. (Mass. State Rolls volume 3 page 1019.)

The large, two and one-half story house that he built with its massive beams and huge chimney has been made into a barn and the bricks of the chimney serve as a floor for the stock. This chimney is said to have contained 17,000 bricks and its size is still indicated by the large patch in the roof. The smaller house built by Russell 4 across the road is used as a farm home today. The place is still known as the Carruth Farm but the only ones of the name in that vicinity today are in the cemetery near the Church.

In this cemetery at the corner nearest the Green is a slab of slate and we read: "Mrs. Lucy Carruth, Consort of Mr. James Carruth, who died March 25, 1803 in the 53d year of her age. She was the first one buried in this cemetery." The stone has been reset so that the verses on the stone are below ground.

On the stone next to this we read: "Erected in Memory of Mr. James Carruth, Died Dec. 6, 1812, in the 76th year of his age. Beneath these clods of silent dust, I sleep where all the living must; The gayest youth and fairest face, In time must be in this dark place."

Azubah 3, James 3 and his wife Lucy and son Albert 4, are buried near.

Levi moved to Chenango Co., N. Y., in 1815 where for many years he owned three farms specializing in bee culture and the raising of sheep. He helped organize the First Presbyterian Church at East Pharsalia and with his wife joined by letter of recommendation. Appointed Elder and ordained by imposition of hands 8-6-1838. Also a trustee. He was a man of considerable means and assisted a number of worthy young men in gaining a college education, among them Judge Elliott Anthony for many years an eminent lawyer and jurist in Chicago. Every fall he and his wife drove to Mass. to visit their kinsfolk. It is told that his son Uri, when asked at such time as to the whereabouts of his parents, would answer "Gone back to 'Chusetts". The climate in Wis. being too severe for his health he moved to Vineland, N. J., where he edited and published the Vineland Independent for several years. Was much interested in fruit raising and in the work of the Patrons of Husbandry and published the New Jersey Granger for a number of years. Brother Arthur

"Because the years are few I must be glad; Because the silence is so near I sing."

"Wonderful lines," he called them—these of Katherine Lee Bates.

Our brother loved life and friends and good cheer, but beneath it all was the ever-present consciousness that the years are few and the silence near.

Although a wanderer, he never parted the ties of kin and place. Living at a distance, he rarely let a year pass without returning to review the old scenes and renew the old friendships. For the summer in which he passed away he had planned what he called "the big reunion" at the old home in Clinton. "The big reunion!"

"This book," he said, "is my tribute to the Carruth family." And, referring to the work involved, he wrote: "However, it is all worth while,

for I have met so many good kinsfolk, and have dozens of letters that I shall always keep." And again: "It is all fun, and I am doing a lot-of good work in getting the cousins acquainted. So often I write a person and tell them of a cousin near them, and they tell me afterwards how good it was to locate a kinsman." Later, evidently feeling the need of haste, he wrote: "The last data come in so slowly. . . . There are several loose ends and they are still coming in, but I feel that I must have it printed, for life is so uncertain, and I do want to see it completed." This was denied him, and the book is the loser. More interesting than the story of the family would have been the story of the book as he would have written it. "Those Yankee cousins down East," he wrote, "are still talking about that man who came out of the West and knew more of their ancestry than they ever dreamed of!"

Among the many tributes one has written: "His unhurried serenity, his wide and varied experience, his charming way of telling what he knew, his unvarying joy in life and his unfailing sense of humor made him one of the best of companions. One always felt in his presence that the whole man was visible, that there was nothing concealed, nothing paraded, that the dignity and nobility of his bearing was a true portrait of the inner man. Truly a prince in Israel is fallen, and we mourn with you his loss. One feels richer and better, one's hope of immortality is brighter for having known him."

He sleeps there on the brow of the hill where he would, among his kin, by the side of his Mother, her last born.

As was repeated at the services in Clinton:

"Father, in Thy gracious keeping Leave we now Thy servant sleeping."

It is with a deep feeling of sadness that I am called upon to announce the death of one of our most faithful and zealous Past Grand Commanders,

R. E. ARTHUR JAY CARRUTH,

which occurred in Topeka as the result of an aftack of pneumonia, on Friday, July 18, 1924. His sickness lasted but a few days, and the news of his passing away was therefore a great surprise to his friends, and will be to the Templars and others interested, when this memorial is issued.

During his tenure of office, which represented ten years of service from the time he was appointed Grand Captain of the Guard until he was placed at the head of the lines of this Grand Commandery, he was an active and ardent worker, and when he retired from the exalted station to which he had been elected he had to his credit, while serving in the several offices, the honorable record of having personally visited every Commandery in this jurisdiction. His devotion to the cause of Knighthood was exemplified, not only in his work as an Inspector, but in devoting a large portion of his spare moments in studying the Statutes, Ritual and Tactics, so that when called upon to assume the most responsible office within the gift of his Fraters, he was amply qualified to meet all conditions and administer justice and moderation to all. His term of office as Grand Commander was concluded with the distinction of having present at the Grand Commandery, the M.'. E.'. Grand Master, Leonidas P. Newby. As Chairman of our Committee on Triennial Affairs for the years 1923 and 1924, he had practically completed all arrangements for the accommodation of the Kansas delegation at the Triennial Conclave to be held in Seattle in 1925. He will be greatly missed from the councils of the Annual Conclaves in the administration of the affairs of our Grand Commandery.

As a valiant Knight and soldier of the Cross, he has sheathed his sword, laid aside his armour, and awaits the awards of a true and courteous Knight.

He was born at Vineland, New Jersey. April 30, 1868, the son of Uri and Lucy Ann (Robinson) Carruth. He was a direct descendant of the Rev. John Robinson, "Father of the Mayflower." After his father's death, Sir Knight Carruth moved to Clinton, New York, where he graduated from Kirkland Hall, an Episcopal college, and where he married Clara Belle Wilkinson. To this union two boys were born, Arthur Jay, Jr., and Edgar W., both of whom survive him. In 1889 he came west and practiced law and

engaged in the jewelry business in Colorado and Nebraska, but later returned to Buffalo, New York, where he practiced law with his two brothers. In 1896, however, he again came west, settled at Herington and engaged in the jewelry business, being associated in later years with his son, Edgar W. Arthur J. Carruth, past grand commander of the Grand Commandery of the Knights Templar of Kansas, a member of the bar of New York, Nebraska and Kansas, and who retired from active business at Herington and moved to Topeka three years ago, died of pneumonia at Christ's hospital today.

He passed away after the realization of two lifelong ambitions—to become grand commander of the Masonic body to which he was so ardently attached and to write a genealogical record of the Carruth family from the time his paternal ancestor left the highlands of Scotland and settled in Worcester county, Massachusetts, to the present date. He was grand commander of the Knights Templar of Kansas, 1921-2, and gave his entire time to the office he loved. After traveling in thirty-five states gathering records and writing hundreds of letters to all parts of the United States and Great Britain he, after many years, had completed the genealogy of the Carruth family.

His final proofs for his life-longed-for book were read at his bedside at the hospital this week.

He was taken ill at his rooms in the University club early Wednesday morning of last week. Although he rallied slightly after being taken to the hospital his condition never was considered out of danger by his physicians.

Arthur Jay Carruth was born in Vineland, N. J., the son of Uri and Lucy Ann (Robinson) Carruth. He was a direct descendant of the Rev. John Robinson, "Father of the Mayflower." whose son, Isaac, founded the family in America in 1631. His father was a newspaper man, and after five years as a "49er," published a newspaper in Berlin, Wis., and Vineland, N. J.

After his father's death at Vineland, Mr. Carruth moved to Clinton, N. Y., where he was graduated from Kirkland Hall, an Episcopal school, and where he married Clara Belle Wilkinson. In 1889 he was seized with the call of the west and practiced law and engaged in the jewelry business in Colorado and Nebraska. Then he returned to Buffalo, N. Y., and entered the law firm, Carruth, Carruth & Carruth, with his two brothers, Charles R. and Clarence U. The brothers are attorneys-at-law now in New York City.

In 1896 Mr. Carruth again heard the call of the west and moved to Herington, Kan. Here he was located in business and for a time in the practice of law until three years ago when he retired and moved to Topeka. In the later years of business in Herington he was associated with his son, Edgar W. Carruth, in the jewelry firm, A. J. Carruth & Son.

In Herington Mr. Carruth was active in the town's civic and Masonic affairs. He was mayor at one time and also established and supported for many years the Episcopal church, St. James The Less. Mrs. Carruth died in Herington in 1910.

Following Mrs. Carruth's death, Mr. Carruth traveled widely. A book was written from his travel letters in the Pacific. He also has written many magazine and newspaper articles of interest—among them a most charming story recently of the Goss book of birds and the Goss collection in Kansas. He was well informed, studiously read, enthusiastic about many subjects, took a great interest in Masonry, genealogy, politics, and the Episcopal church. He was a member of many Masonic bodies retaining most of his memberships at Herington. He was a member of the University club in Topeka, the

Sons of the American Revolution and was elected president of the Vermont club at its annual meeting this spring. He was a member of the Red Cross of Constantine at Topeka and held an office in the order. He was a member of Isis Temple, Mystic Shrine, at Salina.

He is survived by two sons, Arthur J. Carruth, Jr., managing editor of The State Journal, Topeka, and Edgar W. Carruth, associated with the Leonard Krower & Son, wholesale jewelry firm of New Orleans, La. Also two brothers and a sister: Charles R. and Clarence U. Carruth, of New York City, and May Carruth, of Buffalo, N. Y.

Funeral services at Herington Sunday morning at 10 o'clock will be in charge of the Herington commandery of the Knights Templar and the grand officers of the grand commandery of Kansas. Burial Tuesday in Sunset Hill cemetery in the Carruth family lot, Clinton, N. Y.

Arthur J. Carruth, Sr., for over a quarter of a century a resident of this city, died Friday morning at Topeka where he had been living the past three years. Death was due to pneumonia, followed by heart trouble. The remains arrived from Topeka Saturday afternoon and lay in state in the Masonic temple until the funeral hour Sunday morning. The casket rested in front of a wealth of flowers sent by Topeka friends and grand officers of the Knights Templar of Kansas.

Mr. Carruth was past grand commander of the grand commandery of the Knights Templar of Kansas. Pursuant to the known wishes of the deceased, the services were held in St. James The Less Episcopal church and the full uniform Knights Templar funeral ceremony was used.

After the service, the remains were sent to Clinton, N. Y., for interment, accompanied by Mr. Carruth's sons, Arthur J. Carruth, Jr., managing editor of The Topeka State Journal, and Edgar Carruth of this city and their wives.

The Rev. R. M. Botting, pastor of the Episcopal church in Dodge City, and grand prelate of the Knights Templar of Kansas, assisted by the Rev. W. J. Marshfield of Topeka, secretary of the diocese of the Episcopal church of Kansas, officiated at the funeral services. The Knights Templar of Herington and surrounding community attended in a body and escorted remains to the train. A choir composed of Mesdames P. H. Knuth, V. W. Huffman, and F. E. Beal and Misses Evelyn Morgan and Lurene Kingsbury, Dean, Isabel and T. J. Hughes, Jr., sang "Nearer My God To Thee," "Rock of Ages," and "Abide With Me," with Mrs. T. J. Hughes at the organ. The pallbearers were V. W. Huffman, W. N. Hawley, V. C. Kingsbury, Dr. L. D. Blachly, of Wichita, C. J. Ross and John Yoder.

The following grand officers of Knights Templar of Kansas were present:

Ezra B. Fuller, Leavenworth, deputy grand commander; E. Stotler, Kansas City, grand captain general; William E. Hutchinson, Garden City, grand junior warden; the Rev. Mr. Botting, Dodge City, grand prelate; Owen J. Wood, Topeka, past grand commander, and C. W. Miller, Hays, grand senior warden.

For over twenty-five years, A. J. Carruth occupied a prominent and unique position in this city. Coming here a comparatively young man, intellectually trained, fluent in speech and striking in appearance, he at once commanded attention and gained a distinct place in the community. For many years after he came here, he was the only man in town who could give an address that would really interest a public meeting. Consequently no banquet or gathering was complete unless he had a place on the program. After he served as toastmaster, one had stories to tell for months to come.

In late years he was much given to travel. He adopted the motto "See America First" and once or twice a year he would spend a vacation of some weeks in various points of interest in this country. A close observer, a student of men and affairs, one could spend no more enjoyable hour than to sit down with him and listen to his stories of travel. His comment on public men and issues was always illuminating and richly humorous. He was the best entertainer in the town.

He built up a thriving, lucrative business on the simple principles of sincerity and honesty. Without fawning at the feet of the public, he developed a patronage that was always loyal and true. He was positive in his convictions and exceedingly frank in expressing his opinions, whether they met with popular favor or not. In the common parlance of the street, he "stood up straight." He had color and individuality.

When A. J. Carruth passed on, his sons lost a father who was intensely devoted to them and their children, his friends lost a champion who was loyal and interesting, the Masonic lodge lost a member who gave all of his mature years to its welfare and society lost a citizen who was gifted and upright.

He was nationally known in Masonic circles and had devoted much of his time in recent years to work of the order. For nearly 30 years Mr. Carruth had been identi-

fied with the professional and business life of Kansas. He was active in civic affairs, in business, politics, his church and his Masonic bodies. He served as mayor of Herington. He also took lively interest in local, state and national campaigns. He was exceptionally well-informed, studiously read, and keenly concerned with world affairs. His interest was centered in Masonry, genealogy, politics and the Episcopal church.

The full burial ceremony of the Knights Templar followed the church service and held the tense interest of the crowded church; it was the first time ever given here and was beautifully and expressively read by Acting Prelate W. A. Thompson and Acting Commander J. M. Yoder, assisted by the pall bearers and the commandery membership. Following the services the Grand officers and escort accompanied the body to the Rock Island station where, accompanied by the sorrowing sons and their families, the long journey to the Sunset Hill cemetery, Clinton, New York, was started at noon, that he might sleep with his ancestors.

A wealth of exquisite flowers covered the coffin and made bright and fragrant the church, testimonials of love and affection from relatives, friends and fraternal organizations. Many visited the body as it lay in state in the Masonic Temple, who were unable to get in the small church.

Mr. Carruth was a resident of Herington for a quarter century. A prominent business man, he was one of the charter members of the Episcopal church of St. James the Less, a generous contributor at its building and a consistent and faithful worker until death, always a generous supporter and senior warden when a resident of Herington.

Mr. Carruth was an extensive traveler, an entertaining and informing writer and a man of affairs. He amassed a competence and the latter years were spent in comfort, making his home at the University club in Topeka and devoting much time and ability to Masonic affairs. He was also a member, in addition to those named, of the Red Cross of Constantine, Sons of the American Revolution and was president of the Vermont club of Topeka, at his death.

While living in Topeka, he completed his genealogical history of the family from the time the first one left Scotland over three hundred years ago to the present.

He was ill but a week or ten days; when taken down at his rooms at the club, he was immediately removed to Christ hospital where he had the best of nursing and medical care, and in addition his sons were with him practically all his waking hours, but the malignant nature of the attack was such that the doctors gave little if any nope from the beginning.
