

Ancient Kittery, lying across the Piscatagua River from Portsmouth, N. H., was among the first settled regions in It embraced the present York County towns of Maine. Kittery (incorporated 1647), Berwick (set off 1713), Eliot (1810), South Berwick, known as Newichawannock (1814), and North Berwick (1831). Its pioneers were men of heroic stuff, whose energy and courage conquered the wilderness, prominent among this sturdy stock being the Chadbourne family, various branches of which spread out into other Maine towns,* and later settled in many states. The family name, according to President Paul A. Chadbourne, signifies "the dwelling by the ford." A theory is also held that it refers to the race of St. Chad (or Ceadda), an English ecclesiastic, who died 672 A. D. In the old documents the spelling is variously Chadbourne, Chadbourn, Chadben, Chadbon, Chadborn, Chadboun, Chadboun, Chadburn, Chadburne, Chatbun, and Chatburn.

FIRST GENERATION.

William¹ Chadbourne, the ancestor from whom the Chad-1 bourne Family of America has descended, came to this country in 1634, and settled in what is now South Berwick. His son Humphrey had preceded him in 1631. Doubtless they came from Devonshire, England, many of the Kittery settlers having emigrated either from Dartmouth or Kingsweare, lying on opposite banks of the River Dart. William Chadbourne arrived at Kittery on July 8, 1634, coming with two companions, James Wall and John Goddard, in a vessel called the Pied Cow. The place where they landed is known as Cow Cove to this day. These men were carpenters, who had come over to build for the patentee, Capt. John Mason, what was probably the first saw mill erected in New England. The three came under a contract to work for Mason for five years, after which they were to have fifty acres of land on lease for the term of three lives (generations), paying an annual rent of three bushels of Mason, however, died the following year. The work corn. which they accomplished is quaintly described in the following deposition made by Wall eighteen years later:

THE DEPOSITION OF JAMES WALL: Taken the 21 of the 3. month, 1652.

This Deponent saythe, that aboute the yeare 1634, he, with his partners, William Chadbourne and John Goddarde, came over to new England vpon the accompte of Captaine John mason of London, and also for thenselues, and were landed at Newichawannock, vpon certaine lands there which mr. Joieslenn, Captaine Mason's Agente, brought them vnto, with the ladinge of some goodes, and there they did build vpp at the fall there (called by the Indian name of Ashbenbedick) for the use of Captaine Mason & our selues, one sawe mill and one stampinge mill for Corne, w'ch we did keep the space of three or foure yeares next after; and further this Deponent sayth, he builte one house vpon the same lands, and soe did William Chadburne another & gave it to his sonne in Law, Thomas Spencer, who now lives in it.

And this Deponent also sayth that we had peaceable and quite possession of that lande for the vse of Captaine Mason afforesaide, and that the saide Agente did buye some planted ground of some of the Indiands, wich they had planted vpon the sade land, and that Captaine Masons agentes servants did breake vp & cleered certaine lands there, and planted Corne vpon it, and all this is to his beste remembrance.

James wall sworne, whoe affirmed vpon his oath that the p'misses is true:

Sworne before me GEORGE SMYTH.

The date of William Chadbourne's death is not known. He was living in 1652, for the name of William Chatburne appears on the act of submission to Massachusetts signed by 41 inhabitants of Kittery on November 16 of that year.

William Chadbourne had three children, WILLIAM, JR., [2] HUMPHREY, and PATIENCE. William, Jr., lived in Portsmouth. He had a wife Mary and a daughter Mary, who was born in Boston in 1644, and married John Frost of Dover, N. H. This family probably returned to England. Patience Chadbourne married Thomas Spencer, who was planter, lumberman, and tavern keeper at Berwick.

SECOND GENERATION.

2 Humphrey² Chadbourne (*William*¹), son of the preceding, the great landowner and leader among men, was one of the most prominent citizens in the town of Kittery. He was born probably about 1600. He came over in bark Warwick, landing Sept. 9, 1631, three years before his father, and as chief carpenter for David Thompson, patentee, built what was called the Great House at Strawberry Bank, now Portsmouth, where he lived for several years. The Great House was a blockhouse for defense against the Indians, but probably became subsequently a "truck house," or trading post. Hubbard calls Humphrey Chadbourne "chief of the artificers." Thomas Bailey Aldrich, in his delightful work on Portsmouth, "An Old Town by the Sea," remarks: "It was not until 1631

that the Great House was erected by Humphrey Chadborn on Strawberry Bank. Mr. Chadborn, consciously or unconsciously, sowed a seed from which a city has sprung."

Eventually Humphrey Chadbourne took up his abode at Newichawannock, where he waxed prosperous. It is said that he succeeded Ambrose Gibbons as steward for Mason at this place. May 10, 1643, he bought of the Indian sagamore Roles (or Rowles) a large tract of land in Newichawannock. This land, in whole or in part, remained in the Chadbourne family for more than 200 years. In 1651-52 Humphrey Chadbourne received grants of about 300 acres of land in Kittery.

He took an active part in the affairs of the town, and is referred to by Miss Sarah Orne Jewett as "the lawgiver" of Kittery. In 1651 he was elected one of the townsmen or selectmen. He was Ensign of the militia in 1653, and unquestionably bore his part in the wars with the Indians. From 1654 to 1659 he was town clerk. He was a Deputy to the General Court in 1657, 1659, and 1660, and in 1662 was appointed one of the Associate Judges for the County of York. He signed the submission to Massachusetts in 1652.

His will, dated May 25, 1667, is a long and interesting Testator mentions his wife Lucy, his eldest son document. Humphrey, his younger sons, James and William, his "little daughters," Lucy, Aylce and Katherine. There was also a posthumous child. According to English custom he made his eldest son, Humphrey, his principal heir, supplementing his gifts of real estate with that of his saddle horse, "with all the furniture to him belonging." Provision was also made for the other sons and the widow, and to each of the daughters he left one hundred pounds. To his "ounckle," Nicholas Shapleigh, testator gave "one very good beaver hatt," and to his cousins, William Spencer and John Shapleigh, each "a good castor hatt, as good as can be gotten." Humphrey Chadbourne at the time of his death, in the summer of 1667, was owner of farms, mills, and timber lands. The inventory of his estate,

returned by the appraisers Sept. 12 of that year, placed the value of his property at 1713 pounds, 14 shillings, an enormous fortune for that time. The property included "900 acres of land by estimation."

Humphrey Chadbourne married Lucy, daughter of James and Katherine (Shapleigh) Treworgy of Kittery, who was much younger than himself. She married Thomas Wills of Kittery, who made a marriage settlement upon her April 1, 1669; and later, Hon. Elias Stileman of Portsmouth. She died 1708. Children of Humphrey Chadbourne:

3 Humphrey³ Chadbourne (Humphrey², William¹), son ot Humphrey and Lucy (Treworgy) Chadbourne, born in Kittery in 1653, and died there about 1694. Married Sarah, daughter of Joseph Bolles of Wells and Cape Porpoise, born Jan. 20, 1657. Children:

4 James³ Chadbourne (*Humphrey²*, *William¹*), son of Humphrey and Lucy (Treworgy) Chadbourne, resided in Kittery, where he received a number of grants of land, and was one of the trustees of the estate of John Heard. In a deed he describes himself as "The Proprietor or high Lord of the soyle." Married, between 1675 and 1680, Elizabeth, daughter of James and Shuah Heard, and granddaughter of John Heard. In a deed of 1680 he refers to Heard's two granddaughters, and states that he "did Mary (marry) with Elizabeth, the youngest of them too sisters." He died about 1686; and his widow married Samuel Small. Children:

5 Humphrey⁴ Chadbourne (Humphrey³, Humphrey², William¹), son of Humphrey and Sarah (Bolles) Chadbourne, born Sept. 2, 1678; married Nov. 6, 1712, Hannah Abbot; died Jan. 26, 1763. Was town clerk of Berwick for a number of years, and Representative to the General Court from Berwick in 1741 and 1745. His will was dated June 2, 1762. Having no children and his wife being dead, he divided his large landed property among his sister, Mary Dyer, and 22 nephews and nieces. He survived his brothers William and Joseph.

6 William⁴ Chadbourne (Humphrey⁸, Humphrey², William¹), son of Humphrey and Sarah (Bolles) Chadbourne, born about 1683. He married Mary — Both were baptized and owned the covenant at South Berwick, Nov. 21, 1714. Children:

James⁴ Chadbourn (James⁸, Humphrey², William¹), son 8 of James and Elizabeth (Heard) Chadbourne, one of the founders of the town of Sanford, Maine, and head of the Sanford branch of the family, was born Sept. 29, 1684, in Kittery, where he received a grant of land in 1703, and in 1732 was selectman. In 1739 he became one of the grantees of 40 "settlers' lots" of 130 acres each in the new town of Phillipstown (Sanford, incorporated 1768), receiving two lots, and moved thither with his family. He built Chadbourn's blockhouse, and also the second saw and grist mill in the town, the latter on the Mousam River, on a site now occupied by one of the mills of the extensive Goodall plush plant. He took an active part in town affairs and his four sons served in the He died before April 9, 1765. Indian wars. Married, Sept. 24, 1713, Sarah, daughter of Capt. John Hatch and widow of Joshua Downing, who survived him. Children:



Hon. Benjamin⁵ Chadbourn (William⁴, Humphrey³, 11 Humphrey², William¹), son of William and Mary Chadbourne, born in Berwick July 23, 1718, and died there March 16, 1799. He probably served as Captain in Col. Jonathan Bagley's regiment at Louisburg, 1745; was attorney and counsellor at law; Colonel in the militia; Judge of the Court of Common Pleas; Representative from Berwick for fifteen years between 1756 and 1771; member of the Governor's Council, 1780-1784; and one of the founders of Berwick Academy, established in 1791. For the Academy he gave ten acres of land in the finest possible situation, and a sum of money besides, to begin the subscription. Rev. John Lord, LL. D., in his historical address on Berwick Academy, refers to Judge Chadbourn as "a veritable patrician, with a great landed estate which his ancestors purchased from the Indians. He lived in a fine colonial residence, surrounded by noble elms. He sent John Hancock a large number of elms from his Berwick estate, to be planted on Boston Common, where some still exist." When his house was built, there was no house between it and Miss Sarah Orne Jewett has made Judge Chadbourn Canada. one of the characters of her historical romance, "The Tory Lover," picturing him as an "old man of singular dignity and kindliness of look." Married, Jan. 31, 1758, Hannah, daughter of Samuel Long of Portsmouth, born 1735, died April 9, 1814. He died March 7, 1810. Children:

In 1739 he removed to Phillipstown with his father, and subsequently purchased one of the settlers' lots there, the record being, "Sept. 30, 1757, James Chadbourn sold to John Chadbourn, Phillipstown, blacksmith, for £60." With his brothers James and Joshua he served in the Indian wars: in Capt. Jonathan Bean's company, 1747-48; as Sergeant in Capt. William Gerrish's company, 1759; and as Sergeant under the same Captain, on the eastern frontier, 1760. He was one of the owners of Chadbourn's mills. Feb. 29, 1756, with his brother Joshua, he united with the First Congregational Church of Wells. Married, Dec., 1741, Mary, daughter of Nathan and Elizabeth (Rummery) Spinney of Kittery, born in 1722 and died Jan. 10, 1789. Children:







He was instrumental in the reorganization of the Cemetery Association, and one of the first to contribute towards the permanent fund created to maintain and beautify the grounds, so that today, through his generosity, combined with others, Blue Earth has one of the best kept cemeteries in Southern Minnesota. C., Jan. 12, 1902. He was educated in the common schools of Sanford, and at Alfred and Phillips Andover Academies. In 1844 he went to North Carolina, entering upon the turpentine business at Shallotte. Later he removed to Wilmington, and being joined by his brother George, they established, in 1851, the lumber firm of James H. Chadbourn & Co., subsequently the Chadbourn Lumber Co., which has for many years been one of the most extensive lumber concerns in the south. Of this company he was the president at the time of his death. In 1871 another brother, William H., joined the firm.*

^{*}THE TOWN OF CHADBOURN.— Of the Wilmington branch of the Chadbourns it has been said that they are united in so many ways as to seem as one person. The various members have enjoyed many positions of trust and honor. As fast as the sons of the brothers, James H., George, and William H., grew to manhood, they engaged in business with their fathers. In 1882 the Chadbourn Mill & Railway Co. was incorporated, and a portion of the younger members, together with the older ones, engaged in operating saw mills on an extensive scale at a place on the Atlantic Coast Line, 53 miles from Wilmington, which they named Chadbourn. A railroad 51 miles long was also built and equipped by them, entirely within their own means. These enterprises were eminently successful, and continued until the Atlantic Coast Line became attracted by the prospects and business of the railroad, which runs through the best trucking section of North Carolina. Their proposals for the acquirement of the railroad property were accepted by the Chadbourns. After the supply of yellow pine timber along the line of the railroad was exhausted, the saw mills were sold and removed to Georgia.

CHADBOURNE-CHADBOURN.

Mr. Chadbourn was an important factor in Wilmington life. He was long a director in the Oakdale Cemetery Co., and a director in the Wilmington Compress & Warehouse Co., and other corporations. As chairman of an important committee on river and harbor improvements, he aided in the closure of New Inlet, which made Wilmington one of the most important ports on the coast. For 22 years he was chairman of the board of Commissioners of Navigation and Pilotage, and as such was originator of the plan to provide from the legal fees a trust fund for the benefit of widows and orphans of pilots. For 30 years a member of the school committee, he rendered invaluable service in building up the public school system of Wilmington, it being through his instrumentality that the property of the Tileston Normal School was presented to the city for a public high school. He was a vestryman of St. James Episcopal Church. "From the beginning of his life in Wilmington he was a man of broad benevolence. He was truly a benefactor and his life has been a blessing to Wilmington." He married, Nov. 18, 1858, Mary Ann Bluxome of Philadelphia. Children:

The town of Chadbourn is one of the most prosperous in the state, being the centre of a very rich truck raising section. All kinds of early vegetables are grown there, but the principal crop is the strawberry, of which, in 1903, more than 1000 car loads were distributed over the west and north. The Chadbourn berry has a high reputation everywhere, the rich soil giving it a peculiar color and flavor. Chadbourn has a bank, and as fine stores as are found in many large cities, and the farmers are the most prosperous in the state.

He worked on a farm and at carpentering until his seventeenth year, subsequently taking a two years' course at Phillips Exeter Academy, during which time he supported himself by copying law papers. He graduated from Williams College in 1848, being valedictorian of his class. For several years he taught in Freehold, N. J., Great Falls (now Somersworth) N. H., and East Windsor, Conn., meanwhile studying theology, and in 1853 he was licensed to preach. The same year he was elected professor of chemistry and botany at Williams; was

lecturer at the Western Reserve College, 1855-56; studied medicine and received the degree of M. D. from Berkshire Medical School in 1859; from 1859 to 1867 held the chair of natural history at Williams; and between 1859 and 1865 filled the chair of natural sciences at Bowdoin College, during which period also he was a professor in the Medical School of Maine and in Berkshire Medical School. Between 1855 and 1861 he conducted scientific expeditions of Williams students to Newfoundland, Florida, Northern Europe, Iceland and Greenland. For a number of years he was lecturer at the Smithsonian Institution, Washington; the Lowell Institute, Boston; and Mount Holyoke Seminary.

In 1867 Dr. Chadbourne was chosen president of the Massachusetts Agricultural College at Amherst, but relinquished that position the same year to become president of the University of Wisconsin, which he served in that capacity until 1870. In 1871 and 1872 he was professor of mental and moral philosophy at Bowdoin College, and also spent some time in Utah and among the Rocky Mountains. In 1872 he was called to the presidency of Williams College to succeed Mark Hopkins, filling that position for nine years, and administering the affairs of the college with conspicuous success and skill. In 1882 he again became president of the Massachusetts Agricultural College.

President Chadbourne amid all his multifarious duties found time for an active interest in manufacturing enterprises, and also in politics. He was a State Senator of Massachusetts in 1865 and 1866, was a delegate to the national Republican convention in 1876, and a presidential elector in 1880, the year of the election of President Garfield, whose intimate friendship, beginning in early life at Williams, he enjoyed. He received the degree of LL. D. from Williams in 1868, D. D. from Amherst in 1872, and D. C. L. from Oxford University in 1874. Dr. Chadbourne was a member of numerous learned societies, both in this country and abroad. He was the author

of a number of books dealing with the natural sciences and theology.
