In her excellent genealogical novel, The Winthrop Woman, Anya Seton makes this statement:

"It has startled me that our early emigrant ancestors are so often treated as though they arrived full-blown from a mysterious 'across the sea,' and suddenly turned into 'Yankees.'"

Unfortunately there is as yet no alternative to this approach in the case of Christopher Day. He first appears on the records so far uncovered as a landowner in Bucks County, Pennsylvania, in 1708. He probably arrived there not long before that and was quite possibly a Baptist from Wales fleeing from the religious persecutions of that time and place.

Intensive efforts to trace his origins have been made, principally by Miss Marion Day Mullins, 2306 Park Place, Fort Worth 10, Texas, and by Mrs. Sylvia Welch, 504 N. E. 23rd Avenue, Fort Lauderdale, Florida. I have tried too, and will keep trying. The information on the early generations listed herein has been supplied to me by Miss Mullins and Mrs. Welch, and I am indebted to them.

The following appears in Davis' History of Bucks County Pennsylvania (1876) in the chapter on Plumstead Township:

"In 1708 Clement and Thomas Dungan sold fifty acres to Christopher Day, who passed his life in Plumstead, and died in 1748. Day was a considerable landowner....."

This chapter also mentions an Arthur Day and a Richard Day as landowners in Plumstead at this same time. It has not been possible to trace a connection.

Proceedings of the Bucks County, Penna. Historical Society, Volume I, page 311, after describing the graveyard in

Plumstead Township, set up pursuant to the will of Christopher Day, in which he, Christopher Day Jr., and others are buried, states:

"A tradition is handed down that the early Welch Baptists of New Britain buried their dead in this graveyard until they organized a church of their own."

"Place Names in Bucks County, Penna." by MacReynolds (1955), page 309, states:

"First settlers of Plumstead included the Brown, Dyer, Doan, Shaw, Michiner, Child, Day, Huber, Carlisle, Dunlap, Rogers and Grier families. The pioneer English Quakers were soon followed by Scotch and Irish settlers, and lastly by Germans, mostly Mennonites."

Penna. Archives, 2nd Series, Vol. XIV, Bucks County Militia in the Revolution, shows on page 235:

"Non-associators in Plumstead Township, August 21, 1775; - - - Christopher Day - - - Meshuk Mitchener, Berak Mitchener, George Mitchener, Melen Mitchener - - - John Dyer - - -." (Note: this was presumably the original Christopher's grandson; "non-associators" were presumably people who did not join the militia, perhaps for religious reasons; Alice Day, daughter of Christopher Day, Jr., married Barack Michiner.)

A History of the Montgomery County Baptist Church (county adjacent to Bucks in Penna.) by Edward Matthews (1895) states on page 11:

"1741, Aug. 8 - Baptized Joseph Day and Dorothy, his wife."

The New Britain Baptist Church seceded from this church in 1754. Joseph Day was a son of Christopher Day, #2000.

Bound, typed "Records of the Courts of Quarter Sessions and Common Pleas of Bucks County, 1700-1730" in the Bucks County Historical Society, contain six references to Christopher Day: as "jur," rather than the more frequent "aff" (for Quakers who "affirmed" rather than being sworn in as jurors ???) at an inquest, as overseer of poor, as being elected assessor in 1730, etc.

In Mathew's "Township History of Bucks County" (typed, bound, 1946 - in Bucks County Historical Society) the following items appear:

Vol. III, page 26: Abigail Day, daughter of Joseph Day,

married, first, William Thomas, son of a Baptist minister, and soon after he died in 1764, married Philip Bitting.

Vol. III, page 95, there is a reference to a Christopher Day as administrator of the estate of Joseph Pool in 1848.

Vol. II, page 53, shows that Mathew Day (presumably the original Christopher's oldest son) owned land in Doylestown Township in 1756.

Marriage Certificates, Vol. VII, bound volume in Bucks County Historical Society, shows that Christopher Day was a witness at a Quaker wedding March 17, 1722.

Proceedings, Bucks County Historical Society, Vol. II, page 573, states:

"During the summer of 1848 the entire road (Buckingham and Doylestown Turnpike) was finished and C. Day first received toll at Pool's corner August 5."

The will of Christopher Day, dated September 1, 1746, and proved March 25, 1748, in Bucks County, is included herein as appendix "A."

Christopher's son, Nathaniel Day (#3000) apparently left Bucks County in the early 1750's, fought in the French and Indian War in northern Virginia, and died there. Nathaniel's children moved on south to what is now Pocahontas County, West Virginia, and settled in an area then and now known as Little Levels. They were apparently there as early as 1766.

John Day (#4000) served in the Revolution and in 1833, at the age of 91, filed an application for a United States Government pension. This revealing document, included herein as appendix "B," is on file in the National Archives as "Military Pension and Bounty Land Files, Portions of the pension and bounty land file, S 3252 BL Reg. 335 101-55 of John Day, Revolutionary War (RG 15A)." It includes the supporting affidavit of his son, John Day, Jr. (#5001).

The names of the descendants are listed with serial numbers corresponding to the generation: the 1000 series is reserved for the father of Christopher Day; Christopher himself is number 2000; his children have numbers in the 3000 series; his grandchildren in the 4000 series; etc. The order of the numbers within a series has no significance since they were assigned as the names were obtained.

So far as I know this is the first systematic collection of the names of the descendants of Levi Day (#5000), a great grandson of Christopher. The other lines are less complete in this listing.

DESCENDANTS OF CHRISTOPHER DAY (16 - 1746)

- 3000 Nathaniel Day married Susan Wyley, daughter of James Wyley (Willey?). Susan Wyley Day was killed by the Shawnee Indians about 1756 in Frederick County, Virginia; she was apparently a widow at that time. A Nathaniel Day of this family died in 1754 (Christopher Day - #2000 - was his executor) but this may have been another Nathaniel, possibly a brother of Christopher. There is indication Nathaniel - #3000 - served in the French and Indian War, which took place between 1754 and 1763.
- 4000 John Day, b. June 10, 1742, in Bucks County, Pennsylvania; served in the Revolution as an Ensign (an Army rank in those days) and as an Indian Spy in that part of Botetourt County, Virginia, which is now Pocahontas County, West Virginia; married Esther \_\_\_\_\_ prior to 1785 (there is some indication that her last name may have been Drennin); moved in 1785 to that part of Green County, North Carolina, which later became Jefferson County, Tennessee; in 1833 he applied for a pension as a Revolutionary veteran. The pension application and the supporting affidavit of his son, John Day, Jr. - #5001 - contain details of his Indian fighting, including the killing of his brother, David, and his mother, Susan Wyley Day, and the capture and rescue of his sisters, Sarah and Martha. This application is included herein as appendix "B." John Day died December 4, 1833, in Jefferson County, Tennessee. There is a court record in that county of the settlement of his estate.
- John Day had at least 10 children (#5000-#5009) and possibly one or two others (#5010 and #5011).
- 5000 Levi Day (1776-1854). See separate outline of his descendants.
- 5001 John Day, Jr., b. January 31, 1768; by the time he was a small boy he was in that sec-

tion of the Virginia frontier which is now Pocahontas County, West Virginia; married Elizabeth Howard (who was born November 28, 1776) on the Greenbrier River in Virginia; John Day, Jr., moved with his parents to what is now Jefferson County, Tennessee in 1785; was living in that part of Tennessee in 1833 when he executed an affidavit accompanying his father's application for a pension as a veteran of the Revolution; died in Hawkins County, Tennessee, in 1839.

6021 Isaac Newton Day, b. March 25, 1804, in Jefferson County, Tennessee; married Martha Thailor Johnson (called "Patsy") March 25, 1824 in Jefferson County; she was born August 26, 1807, in Grainger County, Tennessee, and died October 14, 1870 (or 1878) in Bradley County, Tennessee; Isaac Newton Day died November 23, 1872, in Bradley County.

7062 William Conway Day, b. December 18, 1827, in Jefferson County, Tennessee; married Mary Ann Parks; died June 7 1907.

7063 Sarah Elizabeth Day, b. March 12, 1829, in Jefferson County, Tennessee; married Richard T. Parks; died September 10, 1858.

7064 Isaac Osborn Day, b. March 8, 1831, in Jefferson County, Tennessee, married 1st E. A. Houston; 2nd, H. M. Doss; 3rd, J. H. Hunt; died September 3, 1895, Castle Rock, Washington. Marriage to Jemima Hannah Hunt was June 1, 1875 - she was born April 1, 1835, at Mifflin County, Pennsylvania, and died August 7, 1911, at Arroyo Grande, California. They had son as follows:

However, Mr. John Levi Day of Sparta, Missouri - #8006 - states: Joseph Day - #5004 - and Levi Day - #5000 - were taking a flatboat load of hogs to New Orleans to sell; on the trip Joseph died of cholera and was buried at Corinth, Mississippi; the market was bad and the hogs did not bring much but when Levi returned to Tennessee he sold most of what he owned and gave it to Joseph's widow to help her and her children - then Levi moved to Illinois. Other records indicate that Levi moved to Illinois as early as 1817 and no later than 1820, so this would indicate Joseph's death was before the 1824 divorce referred to above. Joseph's

widow moved to the Ozark section of Missouri.

Drennins lived in the same vicinity as the John Day - #4000 - family both in Virginia and Tennessee. The pension application of John Day - #4000 - refers to the killing of Whenny Drennin, wife of Thomas Drennin, in the Indian fighting in 1770 or later.

There is another deed in the same county from Levi Day and Ann, his wife, to David Enochs. Levi Day is listed in the St. Clair County, Illinois, Census for 1820, but not for 1818. There is a family story, related by John Levi Day of Sparta, Missouri, that Levi rode from Tennessee to Illinois with his three sons on horseback. Ann Enochs Day died at Hampton, Iowa, on December 12, 1886, at age 90. Three of her daughters are also buried there and a fourth at Bellevue, Iowa, not far away.

BE IT REMEMBERED That I, Christopher Day, of Plumstead, in the County of Bucks and Province of Pennsylvania, Yeoman, Being Indisposed in Body But of sound and disposing mind and memory do make and declare this my last will and Testament. I resign my soul to its creator in all humble hopes of its future, happiness and as to my body and my will is That it be decently buried at the discretion of my executor hereinafter named in a lot of ground hereafter described And as touching such means and estate as it hath pleased Almighty God of his Mercy and Goodness to bestow upon me after Payment of my just debts, I give and dispose thereof as followeth,

First, I give and bequeath unto my well beloved wife Martha, the house wherein I now live, and the spring house Together with the appurtenances to the said building belonging and the household goods in the mansion house contained (one bed and bedding and one iron pot only excepted) both which I give to my son Matthew Day for and during her natural life or widowhood. Also I give and bequeath unto the said Martha my wife 2 cows, her riding horse side saddle and a warming pan to be by her, her heirs, exrs, and adms or assigns peaceably and quietly hold and enjoyed forever. Also my will is that ten perches square of my land bounded Northward by the land of Cephas Child and my other land and Southward by the same and the Road called the Street containing 100 perches of land be and remain for the use of a burying place for ever and for no other purpose whatsoever. Also I give and devise unto my son Christopher Day the messuage, plantation and tract of land thereunto belonging whereon he now lives Containing 50 Acres, Bounded Eastward by the land of Alexr. Brown and to be divided from my other land by a Northeast or southwest line with the appurtenances, To hold to him the said Christopher, his heirs and assigns for ever. Also I give and devise unto my son Matthew Day the like quantity of land to be taken off the opposite end of my tract by a line extending the same course as aforesaid with the appurtenances. To hold to him the said Matthew Day, his Heirs and Assigns for ever. And I give and devise one moiety of the residue or remainder of all my land with the appurtenances bounded eastwardly by the land of Samuel Dyer the same being first equally divided by a NWest or SEast line unto my said son Christopher Day and to his Heirs and

Assigns for ever. The said Christopher paying yearly unto the said Martha my wife the sum of 3 pounds lawful money of Pennsylvania and getting and halling or causing to be got and halled one half of the fire wood which my said wife may have occasion to use during her natural life or widowhood. And all the rest and residue of my Estate both real and personal not hereinabove disposed of I give, devise and bequeath unto my said son Matthew Day and to his Heirs and Assigns forever. He the said Matthew paying unto my said wife yearly during her natural life or widowhood the sum of 5 pounds lawful money of Pennsylvania, maintaining the creatures above mentioned for her use and getting and halling or cause to be got and halled the other part of the fire wood which she may have occasion to burn. Also I give and bequeath unto my son Joseph Day and to my daughter Abigail Poe to each of them the sum of 5 pounds like money aforesaid to be paid by my son Christopher Day within 2 years after my wife's decease. Also I give and bequeath to my son Nathaniel Day and to my daughter Ursula Fenton to each of them the like sum of 5 pounds to be paid by my son Matthew Day within 2 years after my wife's decease. And I do hereby make ordain constitute and appoint my son Matthew Day whole and sole executor of this my resent Testament and last Will and do hereby revoke renounce and annihilate all former and other Wills legacies and testaments by me at any time heretofore made and given and do publish and declare this sheet of paper to be and contain my last Will and Testament and none other nor otherwise.

We followed said Indians, and when we came to the Indian camp aforesaid, there lay my mother dead, and striped naked, her head skinned; and we lifted her and laid her between two rocks and laid some rocks over her; And we followed on after the Indians, and the second day came in sight of them at their camp, and I raised my gun to shoot one of them, and just as I was about to draw trigger, I saw one of my sisters rise up right before the muzzle of my gun between me and the Indian; And I was so alarmed at seeing my sister rise before my gun that I involuntarily hollowed, which so alarmed the Indians that they broke and run, leaving the prisoners, and what they had at the camp, and run with all their might; And we got the prisoners, and what property the Indians left at the camp, and brought all safe to the fort.

After this I volunteered as stated above, under Captain Paxton, and in Company with Captain Hall, Col. Dickson, and other officers not recollected - There was a large supply of Beeves took along for rations perhaps 150, and a number of pack horses. We marched slowly until we came to the Point; Here we met with Genl. Hann; Major McDonel, Capt. Arbuckle, and other officers not remembered. While at the Point one white man was killed and Four Indians.

I cannot exactly tell when we left home on this Campaign as I have no papers to help my memory, but it was in warm weather and suppose it to be the latter part of the Summer, or fall of 1776 and returned home towards the next spring, and cannot tell the exact time we were on this expedition, but consider that it must at least be three months, and think it likely it might be more than three months - If I got any discharge I have lost it in moving from one part to another, and cannot tell what became of it. -And do not recollect that ever I received any pay for said Services.

While at the Point I recollect there was Capt. Renon and Captain Alexander Hamilton, and I served a part of the time under Capt. Hamilton before I left the Station at the Point.

After I returned home the Indians were still troublesome about Ellis's fort and Day's fort during the remainder of the British War and after it. And Captain Cook appointed me to range, or as Spy in Botetout County around the forts to discover if there was any Indian Sign in these parts, and under this appointment I acted during the remainder of



the British War and sometime after it was over; - the Indians were not at War so as to keep the people fortified all the time, but I consider that the times that I was acting as Indian Spy, in that time, would amount to about one year and six months but think the time if all added together would be more than one year and six months that I was on duty as an Indian Spy, in the Waters of Greenbrier River in Virginia. While I was a Spie John Bridges, and James Bridges were killed by Indians, scalped and striped within a mile and a half of the Fort, and I was near falling into the hands of the Indians, while helping others to escape from them. And in this time the Indians attacked Donley's fort 23 miles from Day's fort, took five prisoners, and killed one man named Whenny Drennen, the Indians got off with the prisoners. The Indians killed several other White persons at Donley's fort, killed a great many of the stock, and destroyed other property. The Indians would mostly leave that part in the fall, and the people would then move home out of the forts, and in the Spring the Indians would return and do mischief in the frontiers, and then the people would Fort. This was the common practice of the Indians during the British War; the Indians in them parts were so troublesome that as I understood the militia were left to guard the forts in them parts and not called to go to fight the British.

Ansr

Did you ever receive a commission and if so by whom was it signed and what has become of it. I received an Ensigns Commission from the Committee of Safety for the Colony of Virginia dated at Williamsburgh in October the 11th day in the year 1775, signed by Edm. And on the 24th day of June 1778 I took the oath of allegiance and fidelity, as directed by an act of General Assembly, Sworn to before Geo. Poage, a Justice of the Peace at that time in Botetout County, which certificate is here present.

Quest. 7 State the names of persons to whom you are known in your present neighborhood, and who can testify of your character for veracity, and good behaviour, your services as a soldier of the revolution.

Ansr The Rev. Elihu Millikan and John McFarland, Jur, are acquainted with me. Also the Rev. Ephram Moore - John Day, Senr.

John Day, Junior, being introduced to give evidence concerning the service of John Day, Senior, in time of the revolutionary war, being duly sworn on the holy evangalist of Almighty God saith on oath, saith that when he was a small boy he lived on the waters of Greenbrier River until John Day, Senior, moved from that County, which was in the year 1785, One Thousand Seven Hundred and Eighty-five, I recollect of his starting to go to the Point with a quantity of men that I understood was going there as militia volunteers, and my father, John Day, started to go with them, and I understood he was an Ensign in the Militia at that time; When he started the weather was not cold. - I remember the time he came back, I think it was before the ground had got green in the spring. The weather was cold while he was gone, I do not know exactly how long he was gone but from the best information I have I expect it must be three months, I thought it to be a long time, I think I was in my ninth year of my age when he came home which I consider to be in the forepart of the year 1777. When my father, John Day, Senior, returned and during the remainder of the British War, the Indians were frequently very troublesome about Ellis's Fort, Day's fort, Donley's fort in Boletout County, Virginia, and all the country round there. And said John Day, Senior, frequently went out as a spy under Captain Cook who was Captain at Ellis's Fort and he said John Day, Senior, served as a spy during the British War from the time he came home from the Point. And I have no doubt but his whole service as a spy would amount to one year and six months or more. During the time he was out as a spy Donley's fort was attacked by the Shawnee Indians (as I understood) at that fort two men was killed and one wounded, and killed the stock that was near the fort, I understood there was 350 Indians; and they rushed up to the fort - I understand there was nineteen Indians killed near the fort; and by 100 men coming to the assistance of the fort that night the Indians were driven off.

Hugh McKeever was killed near Day's fort and his family taken prisoners, which they carried off, and it was about two years before any of the prisoners got back. John Bridges, and James Bridges was killed within about a mile and a half of Day's fort - and Henry Baker was killed about twelve miles from there and several others at different times were shot at.

In the winter time we had peace but when warm weather would come in the spring the trouble with the Indians would again begin. They killed Wenny Drinnen, wife of Thomas Drinnen.

Botetout County was divided and a new county laid off half Greenbrier County. This county after it was laid off, included Ellis's Fort and Day's fort.

When John Day, Senior, moved from the waters of Greenbrier River he came to what is now Jefferson County in

Tennessee, it was then Greene County, North Carolina, and he has lived in what is now Jefferson County ever since, and is the same John Day, Senior, that has signed and sworn to the foregoing declaration in order to get the benefit of the Act of Congress of the 7th of June 1832.

I myself am about sixty-five years of age last January, and I believe John Day, Senior, to be ninety-one years of age, and that he served in the United States Service as he has stated in his declaration.

## APPENDIX C

JAMES ALLMOND DAY, M.D. (1869- )

Dr. James Allmond Day was born at Palmyra, Macoupin County, Illinois, on October 29, 1869, the son of William Charles Day, M.D. and Letitia Allmond Day. His father and his maternal grandfather, R. J. Allmond, M.D. each practiced medicine for over fifty years. The Allmonds descended from John Allmond who was one of the earliest settlers of the area near Wilmington, Delaware, having emigrated first from France to England and then, about 1686, from England to America. The Allmond ancestry has been compiled by Dr. Edwin Wallace Crum and Ferris Bertrand Crum, Ph.D., in "The Ancestors and Descendants of Reuben Jefferis Allmond" (1953).

Dr. J. A. Day received his early education in the public schools of Winchester, Illinois, and then attended Grinnell College in Iowa and Christian Brothers College in St. Louis College of Physicians and Surgeons. On the day he graduated he returned to his home in Winchester and the same night rode horseback five miles into the country where he delivered his first baby.

Following 10 years of general practice with his father in Winchester he decided to specialize in surgery. For two years he studied in the surgical centers of Europe - Berlin, Dresden, Vienna, Paris, Berne, and London - and then settled in Jacksonville, Illinois. For many years Dr. Day was chief surgeon of Our Saviour's Hospital in Jacksonville. He was also on the staff of Passavant Hospital, Jacksonville, and later conducted his own private surgical hospital in that city, handling not only all the surgery but the administration as well.

He married Frances Edna Wilmot, daughter of Benjamin Franklin Wilmot and Lucy Gale Wilmot. Their two sons were born in Jacksonville.

In 1917 Dr. Day moved to Springfield, Sangamon County, Illinois, where he had an extensive surgical practice prior to his retirement in 1940 after fifty years of active practice. He is a member of the Sangamon County Medical Society, the Fifty Year Club of the Illinois State Medical Society, and is a fellow of the American Medical Association. He is the author of numerous papers and lectures and has been a frequent contributor to medical publications.

Mrs. Day died in 1954 and Dr. Day lives alone in the home he has occupied for forty years at 1420 Lowell Avenue, Springfield. He is active and in good health, enjoying his

hobbies of reading and at times writing poetry. At the age of 80 he took up oil painting and did a number of portraits and still lifes. He continues to keep up to date with developments in medicine through his medical journals. Many of his surgical procedures were highly advanced for his time and he was a remarkable diagnostician, serving patients from a wide area in central Illinois.
