FIRST GENERATION

(1) LUKE DUNN

The original Luke Dunn of Cornwall, England, had six children:

- (1) Mary (1768-1797), married John Grigg (1770-1846); children, John (1792-1864), Mary (1794-1797) and Elizabeth (1796-1797). This second John Grigg was the Philadelphia book dealer, publisher and banker through whose efforts many of his mother's family settled in this country. In 1831 he married Nancy McClellan (1803-1896) in Woodstock, Connecticut. They had six children:
 - (a) Mary Louisa (1832-1833).
 - (b) Nancy McClellan (1833-1857).
 - (c) John Warner (1836-1869).
 - (d) Frances Ann (1838-1932), married (1) Theodor Lee (d. 1867), children, John Grigg (1857-1891) and a daughter; married (2) Gilman Smith Moulton (1834-1901).
 - (e) Emily Lovet (1840-1875) married Horace B. Fry, broker and playwright (1829?-1906); children, Nancy McClellan (1861-1917), married Marchese Carlo Torrigiani (1856-1927); and Reginald Grigg (1863-1906?). The Grigg line ended with this third generation.
 - (f) A stillborn child, 1 July 1843.
- (2) *Luke, married Elizabeth Bullen (d. 1831).*
- (3) Richard had four children. His family and their descendants remained in England, mostly around Newport, Cornwall.
- (4) Joseph and most of his family of six children also remained in England, in Launceston and Redruth, Cornwall; London; Ashburton, Devon. However, Daniel Bottrell (b. 1841) migrated to Cass county, Illinois, as did his brother Sampson (b. 1844) who married Elizabeth Dunn and settled in Mount Auburn, Illinois. George (b. 1821) and John Haines

- (b. 1823) settled in California. William Haines (b. 1830) moved to California.
- (5) Grace (Dunn) Borlase had four daughters;
- (a) Elizabeth married Thomas Knight; children, William Jury; Thomas married Emelin Haywood; John married Augusta Theibagt; Elizabeth Jane; Emily who died in New Orleans after the voyage from England. This family settled in Beardstown, Illinois, on land owned by John Grigg.
 - (b) Mary (Borlase) Gray, with her four children settled in Illinois.
 - (c) Jane (Borlase) Eddy. Of her six children John Grigg left England for Beardstown in 1857, where he owned a foundry.
 - (d) Grace (Borlase) Bishop remained in Charles-town, Parish of St. Austell, Cornwall, England.
- (6) Susan (d. 1850), married Henry Harris (d. 1853), six children, many of whom came to America and settled in Illinois and Indiana. One son, John Henry, banker, born in Cornwall 4 April 1833, came with his parents to America in 1838, going first to Louisville, Kentucky. In 1840 they removed to Sangamon county, Illinois. He became book-keeper for John Grigg in Philadelphia (as was Charles B. Dunn) and later one of Grigg's land agents in Illinois. He married (1) Phebe Padon, (2) Mrs. Ann Tull.

SECOND GENERATION

(2) LUKE DUNN

This second Luke Dunn, son of Luke, married Elizabeth Bullen who died 11 December 1831. In 1853 he was living in Trewint, Parish of Althernon, Cornwall, England. They had eight children:

(1861-1941) married Edwin E. Sudbrink; Harry Ellsworth Grant (1864-1899) married Susan Taylor; Charles Bullen (1854-1935) married Minnie Wright; Luke (1857-1942) married Mary Mildred Berry; William (d. 1950).
- (5) Henry settled in Beardstown.
- (6) Mary (Dunn) Haywood had a large family. Daughter Emelin married Thomas Knight, farmer of Beardstown (see previous page).
- (7) Emelin married William Elliott, broker, of Philadelphia.
- (8) Name unknown.

THIRD GENERATION

(3) ROBERT DUNN

Born 23 June 1806 in Trewint, Parish of Alternon, Cornwall, England, son of Luke and Elizabeth (Bullen) Dunn. Died 16 April 1877 in Saint Austell, Cornwall. Married at the manor of Laneast, "Gimlet Mill," Parish of Laneast, Cornwall, Mary Ann Rowe, daughter of Sampson Taylor Rowe (1778-1830) and Charity Rowe (1783-1841) granddaughter of Roger Rowe (1752-1812) and Mary Rowe (1756-1837) born 1806 in Lower Tregunnon (?), Cornwall, died 1885 in Saint Austell.

Married on 30 July 1856, Emma Matilda Martyn, daughter of Elias and Emily Sophia (Row) Martyn, born 24 July 1832 in Saint Austell, Cornwall, England, died 16 July 1897 in Upper Saranac, New York.
