John Williams Dean Hall, of Taunton, Mass., for information concerning those earliest settlers herein mentioned; and also to Mr. John Dean, of Deanville, Michigan, for records of the descendants of Silas Dean.

THE DEAN FAMILY.

IN the first centuries after Christ the Latin word *Decanus* (from *decem*, ten) denoted, *the chief of ten, one set over ten persons, e. g.*, over ten soldiers, over ten monks. This word became in Spanish Dean, and in Old French Dean or Dien, and in Norman and English *Dean*, and was used, even as early as the Middle Ages, of ecclesiastical offices next in dignity to that of a bishop. A rural dean was over ten parishes, and was president of the clerical assemblies. Then there was the dean of a cathedral, the dean of a monastery. When King Alfred, of England, ten centuries ago, ordered surnames to be added to Christian names, and established family names, it was natural that the name Dean would abound as a surname; *e.g.*, James de Dean. Prominent among these Deans was Robert de Dene, butler to Edward the Confessor, about 1050; Henry Dene, Archbishop of Canterbury, some 200 years later; Sir Richard Deane, Mayor of London, 1629; Admiral Deane, 1653; 20 years later, Sir Anthony Dean, Comptroller of the Navy; James Dean, a wealthy English merchant, died 1603; Moses Dean, about 1600, "in the

vicinity of Taunton, England, where the Deans had lived for centuries."

Among the Plymouth settlers, arriving November 1621, in the second vessel, the *Fortune*, were Rachel Dean, probably a widow, and Stephen Dean, who in 1632, set up the first "corn mill" in Plymouth Colony, and left three daughters.

The evidence is not quite perfect that we sprang from either of the brothers, John and Walter Dean, who came over about 1637 from Chard, twelve miles from Taunton, in Somerset County, England. They arrived in Boston, stopped about a year at Dorchester, and then went with others to Taunton, Mass.; and there took the Freeman's oath, December 4, 1638. In 1659 each had eight persons in his family.

John was born in England about 1600; died in 1660, Alice his wife surviving him. His Will directs "that in case heer be no settled ministry in Taunton" his administrators "shall have full power to sell either the whole or a part of these my housings and lands, so as my children and posteritie may remove elsewhere, where they may enjoy God in His Ordinances." This Will reveals the man. Among his children were John, Thomas, Israel, Isaac, Nathanael, and Elizabeth.

Deacon Walter, his brother, was born in Chard, England, between 1615 and 1617; married Eleanor Strong, of Taunton, England; was a tanner; was a selectman of

Taunton, Mass., eight years, and held other town offices ; lived at least till 1693. Among his children were Joseph, Ezra, Benjamin, and Abigail.

Other lines of New England Deans start from John, of Ipswich, 1641 ; Thomas, of Concord, 1635 ; Jonas, of Scituate, 1690 ; James, of Stonington, Conn., in 1672 ; John, of Dedham, 1677 ; George, of Salem, 1660 ; Thomas, in Connecticut, 1643 ; Samuel, of Stamford, Conn., 1650 ; Samuel, of Jamaica, L. I., 1660 ; Christopher, of Hempstead, L. I., 1685 ; Samuel, of Lancaster, 1653 ; Thomas, of Charlestown, 1668 ; Daniel, of Sudbury, 1663 ; William, of Woburn, 1670 ; and William, of Boston, 1668. Thomas, at Boston, in 1664, a son of James Deane, of Dean lands, Somerset County, England, had a son James.

In favor of the opinion that Deacon James Dean, of Rutland and Oakham, Mass., was a descendant of Walter Dean, of Chard, England, is the fact, known by members of the family, that he and Williams Dean, the latter of Rutland, Mass., used to visit each other as relatives ; but owing to the loss by fire of the records of Taunton, Mass., in 1838, it is impossible to trace out the line. Williams Dean was son of Elijah, who, before he came to Rutland, where he died, was jail-keeper in Taunton over thirty years, and was a descendant of Walter, of Chard, England.

Deacon James Dean married Agnes McIntire, who was born in Rutland, Mass., December 22, 1719, and was a

daughter of John and Grace McIntire, of Rutland. They were married July 16, 1747, and were one of the nine families who were the first settlers of Oakham, which till its settlement and incorporation was a part of Rutland. Tradition says it was named Oakham in remembrance of Oakham, in Rutland County, England, from the vicinity of which a large emigration came to the Massachusetts Bay Colony.

These first families that settled Oakham came here in October or November, 1750. James Dean settled in the south part, on or near the old Indian trail leading from Rutland to Brookfield; and the house built by him, a picture of which is given in this book, is still standing, 1889, and is the oldest house in the town, being now over one hundred years old. He was an earnest Christian man; he was deacon in the old Presbyterian church from its organization, August 28, 1767, till it was reorganized as Congregational, June 23, 1773. The Town Records state that he was in several campaigns in the Revolutionary War. His name also appears on the Town Books as Selectman and Assessor for several years. There is no record of any children by his first wife.

Agnes, wife of James Dean, died April 21, 1776, aged fifty-six years.

After the death of his first wife he married, May 25, 1777, Sarah Hardy, of Brookfield. There is no record of any children by his second wife.

Sarah, wife of James Dean, died June 24, 1786, aged fifty-one years.

After the death of his second wife he married July 16, 1787, Esther Partridge, of Oakham. Their children were James, John, Silas, and Lucy. The last five years of Deacon James' life, his oldest son, then married, lived with him on his place, building a house near his father's, and residing there his lifetime.

James Dean died February 9, 1812, and was buried with his first and second wives in the churchyard in the centre of the town. Esther, his widow, after his death married John Sargent, of Oakham, formerly of Hubbardston.

I. James, son of Deacon James and Esther Dean, was born in Oakham, June 25, 1788; married, Nov. 15, 1806, Azubah Sargent, of Hubbardston, whose father, John Sargent, we have just named as afterwards having married her husband's widowed mother.

Their children were,—1, James; 2, Luther, who died young; 3, Edmund; 4, Luther; 5, Mary; 6, Asa A.; 7, Sarah E.; 8, Lurana; 9, Harriet; 10, Persis A.; 11, Lyman; 12, Lewis.

Azubah, wife of James Dean, died Feb. 12, 1860, aged seventy-four years.

James Dean died August 28, 1868, aged eighty years, and both were buried in the south cemetery in Oakham.

James, son of James and Azubah Dean, was born in Oakham, April 10, 1808; married Keziah Stearns Hyde, of Hubbardston, October 21, 1832. She was born July 12, 1807; and they resided in Shrewsbury, Mass.

James Dean died November 20, 1879, aged seventy-one years.

Keziah, wife of James Dean, died January 14, 1879.

Edmund, son of James and Azubah Dean, was born in Oakham, January 29, 1812; married Amanda Brown of Sekonk, Mass., January 5, 1837, and resided in Oakham. Their children were,—1, Zelotes H.; 2, Daniel H.; 3, Edmund; 4, Charles F.

Edmund Dean died June 1, 1865, aged fifty-three years.

Amanda, wife of Edmund Dean, died September 30, 1874.

Luther, son of James and Azubah Dean, was born in Oakham, June 20, 1814; married Emeline M. Crawford, of Oakham, September 29, 1842, daughter of Alexander Crawford, a descendant of Aaron Crawford, who emigrated from the parish of Cappy, County of Tyrone, Ireland, in the

year 1713. They resided in Oakham. Their children were,—1, Emory L., who died young; 2, Gardner M.; 3, Helen F.; 4, Estella J.; 5, Emeline J.

Emeline, wife of Luther Dean, died November 16, 1880, aged sixty-six years.

Mary, daughter of James and Azubah Dean, was born in Oakham, September 6, 1816; married John Bridges, of Warren, Mass., September 1, 1840. Their children were,—1, Augusta; 2, Abner.

Asa A., son of James and Azubah Dean, was born in Oakham, Feb. 9, 1819; married Eliza Hapgood, of Marlboro, Mass., April 1, 1847, and resided on his father's old place, which has been in the family ever since the settlement of the town, till he sold it recently. Their children were,—1, Harriet M.; 2, Abbie J.; 3, Amanda A.; 4, Addie E.

Eliza, wife of Asa Dean, died May 13, 1877, aged forty-nine years.

Sarah E., daughter of James and Azubah Dean, was born in Oakham, March 14, 1821, died December 20, 1839, aged eighteen years.

Lurana, daughter of James and Azubah Dean, was born in Oakham, February 6, 1823; married Elbridge Brown, of

Concord, Mass., July 4, 1859. Their children were,— 1, Ida, born at Worcester, July 6, 1860; 2, George, born at Worcester, August 18, 1863.

Harriet, daughter of James and Azubah Dean, was born in Oakham, March 4, 1825; married Luther Hapgood, of Marlboro, Mass., September 28, 1848, and has long resided in Cambridge, Mass. He served three years in the 38th Mass. Infantry Volunteers, in the War of the Rebellion, in Louisiana and Virginia, and was on the police force in Cambridge, after the war, over twenty years. They had no children.

Persis, daughter of James and Azubah Dean, was born at Oakham, March 2, 1828; married William Hoyle, of Webster, Mass. They had two sons, who died in their youth.

Persis, wife of William Hoyle, died of consumption, at Oakham, July 17, 1858, and was buried at Webster.

Lyman, son of James and Azubah Dean, was born at Oakham, February 24, 1830, and married on December 18, 1853, Mary Elizabeth Fulton, who was of Needham, Mass., and was born April 16, 1836. Their children were,— 1, Nellie Elizabeth; 2, Etta Lurana.

Mary, wife of Lyman Dean, died August 21, 1872, aged thirty-six years. After the death of his first wife he mar-

ried Almeda J. Pierce, of Farmington Falls, Maine, March 31, 1874, and resided in Spencer, Mass.

Lewis, son of James and Azubah Dean, was born in Oakham, August 11, 1833; married Eleanor Beggs, of Charlestown, Mass., August 11, 1857, and resided in Worcester. He was a wire goods manufacturer. Their children were,—1, George W., who died young; 2, Henry E.; 3, Oliver M.; 4, John L., who died young; 5, Lillie A.

II. Dr. John, son of Deacon James and Esther Dean, was born in Oakham, November 3, 1789; married, February 2, 1819, Nancy Parks, of Mystic, Conn., who was born February 20, 1796.

Their children were,—1, Joseph; 2, John Newton; 3, Levi L.; 4, Lucy; 5, William E.; 6, Eliza; 7, Amos B.; 8, Homer L.; 9, Lydia; 10, Sarah E.

Dr. John Dean died at Oakham, January 3, 1860, of paralysis, aged seventy years, and was buried at North Brookfield.

Nancy, wife of John Dean, died in the West.

CHILDREN OF JOHN AND NANCY DEAN.

Joseph, son of John and Nancy Dean, was born at Harlem, N. Y., April 13, 1820; married Sarah Boise, of

Spencer, Mass., who was born March 3, 1828. They were married October 15, 1850. Their children were, — 1, Emma C.; 2, Addie J.

Sarah, wife of Joseph Dean, died April 28, 1858, aged thirty years. Joseph Dean died at Spencer, July 25, 1887, of paralysis, aged sixty-seven years.

John Newton, son of John and Nancy Dean, was born at Bellville, N. J., August 13, 1821; died December 21, 1832.

Levi L., son of John and Nancy Dean, was born at Stonington, Conn., January 21, 1824; married Jane Bigelow, of Spencer, Mass., in the year 1848. Their only child was a daughter named Ella.

Levi L. Dean died at Enfield, Mass., December, 1872, aged forty-eight years. He served in the War of the Rebellion, in Company H, 2d Mass. Heavy Artillery.

Lucy, daughter of John and Nancy Dean, was born at Stonington, Conn., July 13, 1826; died at Oakham, Mass., September 23, 1856, aged thirty years.

William E., son of John and Nancy Dean, was born at Norwich, Conn., September 3, 1829; married Lavinia Marshall, daughter of Abraham and Julia Marshall, of Caleado, Scioto County, Ohio, and resided at Asherville, Mitchell County, Kansas. He was a farmer. Their children were,— 1, Frank A.; 2, John J.; 3, Ida M.; 4, Henry E.; 5, Spencer W. M.

Eliza, daughter of John and Nancy Dean, was born at

Oakham, August 2, 1831; married Andrew Spooner, Jr., of Oakham; December 14, 1864. Their only child was a daughter named Lilla Bell, born September 4, 1868.

Amos B., son of John and Nancy Dean, was born at Oakham, October 2, 1833; married Frances Jenks, of North Brookfield, Mass., and lived at Hiawatha, Brown County, Kansas. Their children were, — 1, William; 2, Nellie; 3, Bertie. He served in the War of the Rebellion, in Company F, 15 Mass. Infantry Volunteers.

Homer L., son of John and Nancy Dean, was born at Oakham, March 27, 1836; married Maria Richardson, of New York, July 4, 1860, and lived at Long Island, Alabama. Their children were, — 1, Walter E.; 2, Alice I.; 3, Earnest E.

Homer L. Dean died February 17, 1876, aged forty years.

Lydia, daughter of John and Nancy Dean, was born at Oakham, May 4, 1838; married Charles Ayers, of North Brookfield, October, 1863. She died October 10, 1864, aged twenty-five years.

Sarah E., daughter of John and Nancy Dean, was born at Oakham, August 28, 1843; married David Burlingame, of Worcester, Mass., January, 1873, and lived in Camden, New Jersey.

III. Silas, son of James and Esther Dean, was born in Oakham, July 20, 1791; married Pamela Whitaker, of Oakham, September 9, 1810. They went to New York

State, where they had four children born. They removed, in the year 1818, to Canada, in the Niagara District, and afterwards to the township of Middletown, county of Norfolk, Canada. Their children were,—1, Cyrus; 2, John C.; 3, Lucinda; 4, William; 5, Hiram; 6, Comfort R.; 7, Pamela; 8, Mary A.; 9, Louisa; 10, Rhoda; 11, Silas; 12, Isaac; 13, Daniel; 14, Arsula.

Pamelia, wife of Silas Dean, died in Canada. He married afterwards there.

Silas Dean died at Middletown, Norfolk County, Canada.

CHILDREN OF SILAS AND PAMELIA DEAN.

Cyrus, son of Silas and Pamela Dean, was born in Oakham, Mass., May 17, 1811; never married.

John C., son of Silas and Pamela Dean, was born in New York State, February 19, 1813; married Mary A. Forbes, and had eleven children. He was one of the first settlers of Deanville, Lapeer County, Michigan, and an enterprising business man. He was engaged in the saw-mill business at Deanville; he built the saw and grist mills there. He was injured in the fall of 1872, by being caught in a belt in his mill, so that he died from its effects on December 22, 1872.

Lucinda, daughter of Silas and Pamela Dean, was born in New York State, October 31, 1814; married William Wood, and had six children.

William, son of Silas and Pamela Dean, was born in New York State, May 22, 1816; never married.

Hiram, son of Silas and Pamela Dean, was born in New York State, May 22, 1818; married Elizabeth Jones. They had nine children. His wife died, and he married again; had no children by his second wife.

Comfort R., son of Silas and Pamela Dean, was born in Canada, March 15, 1820; married Ann Ostrander. They had eight children.

Pamelia A., daughter of Silas and Pamela Dean, was born in Canada, December 15, 1821; married John Teall. They had three children.

Mary A., daughter of Silas and Pamela Dean, was born in Canada, October 31, 1823; married Peter Lawson. They had five children.

Louisa, daughter of Silas and Pamela Dean, was born in Canada, October 30, 1825; married Peter Nunn. They had two children.

Rhoda, daughter of Silas and Pamela Dean, was born in Canada, January 30, 1828; married Edward Ryan. They had one child.

Silas, son of Silas and Pamela Dean, was born in Canada, February 26, 1830; never married.

Isaac, son of Silas and Pamela Dean, was born in Canada, June 19, 1831; married first Sarah A. Ryan. They had eleven children. She died, and he married Catharine Vanhorn. They had three children.

Daniel, son of Silas and Pamela Dean, was born in Canada, September 1, 1833; married Sarah Shell. They had four children.

Arsula, daughter of Silas and Pamela Dean, was born in Canada, October 1, 1835; never married.

IV. Lucy, daughter of Deacon James and Esther Dean, was born in Oakham, Mass., November 13, 1793; married Daniel Parmenter, of Oakham, December 13, 1818. They went to Canada, and afterward to Northampton, Mass.

CHILDREN OF JAMES AND KEZIAH DEAN.

James Lorenzo, son of James and Keziah Dean, was born in Worcester, March 22, 1835; married April 23, 1863, Francelia Walker (daughter of Lowell and Harriet Bartlett Walker, of Shrewsbury), who was born March 1, 1839. He studied about two years at Amherst College, and was a teacher for some years; he has long lived in Shrewsbury, Mass. Their children were,—1, James Lowell, born February 4, 1868; 2, Charles Everett, born November 27, 1870; 3, Harriet Eva, born August 20, 1872; 4, Lorenzo, born July 5, 1876.

Theodore Lyman, son of James and Keziah Dean, was born in Worcester, Mass., May 8, 1837. Studied at Groton, Mass., South Woodstock and Newbury, Vt., and at St. Lawrence University, Canton, N. Y. (Theological Depart-

ment); married at Claremont, N. H., October 5, 1864, Sarah J. Ward, of Poultney, Vt.,—a descendant of General Ward of revolutionary fame. He enlisted December 16, 1861, in Company H, 8 Vt. Volunteers; served under General Butler at New Orleans; was discharged August 14, 1862, for disability. Before Ordination he preached at different places in Vermont, New Hampshire, and Massachusetts; was ordained at West Bridgewater, Mass., in 1867. His pastorates were Oxford, West Bridgewater, West Haverhill, and Chicopee, Mass.; Winchester, N. H., Afton, N. Y., and Scranton, Pa. He has been over ten years in the Paper and Stationery business, at Scranton. Their child, Rosa Etta, was born at Scranton, May 13, 1882.

Benjamin Angier, son of James and Keziah Dean, was born in Shrewsbury, Mass., November 4, 1838. Graduated at Amherst College, in 1862. Studied for the Ministry at Princeton, Union, and Andover Theological Seminaries; ordained in his native town, July 20, 1866; married, September 2, 1867, Ellen P. Palmer, daughter of Samuel and Eleanor Howard Palmer, of Woodstock, Conn. Served churches under the American Home Missionary Society seventeen years in Minnesota, Iowa, and Nebraska. He then preached in New Hampshire, at Meriden, Harrisville and Nelson, and at Brentwood, where he now resides. Their children were,—1, Rosa, born May 9, 1868, at Monticello, Minn.; 2, Florence, born at same place, July 20, 1869; 3,

Austin Phelps, born November 13, 1870, at Garnavillo, Iowa; 4, Grace, born March 22, 1872, died an infant; 5, Rachel, born March 9, 1873, died an infant; 6, Philip Redfield, born March 22, 1875, at Sibley, Iowa; 7, Horace Bunce, born November 18, 1876, at same place; 8, Arthur Benjamin, born April 19, 1882, died an infant.

Henry Edson, son of James and Keziah Dean, was born in Shrewsbury, March 28, 1841, died October 20, 1858, aged seventeen years.

Charles Augustus, son of James and Keziah Dean, was born in Shrewsbury, June 15, 1844; married Minnie Palmer, daughter of Samuel and Eleanor Howard Palmer, of Woodstock, Conn., September 21, 1875. They had one daughter, named Eleanor Howard, born April 6, 1879. He enlisted in Company H, 8th Vt. Infantry, January 6, 1862; served under General Butler in Louisiana; in battles Pattersonville and Iron Clad Cotton; and under General Banks in battle at Fort Bisland, expedition against Dick Taylor, in western Louisiana; and in the battles and sieges of Port Hudson.

In Carpenter's History of the 8th Vt. Regiment, page 131, we read that here "a canteen was seen lying on the flat land in front of the trenches; and several comrades asked who dared to run out and get it. Charles A. Dean, a young member of Company H, accepted the challenge, and got safely back with the trophy; though one of the Confederate shots sent after him cut a hole

through the tin." After the war he was employed by Chatfield & Woods, Cincinnati, in Paper business, for seven years,—1864 to 1871; in business in Rochester, N. Y., as Tower & Dean, Paper and Stationery,—1871 to 1875; in partnership with Hollingsworth & Whitney, Boston, seven years, Paper and Paper Bags; organized a corporation at their death, in 1882; and has managed and conducted their business to this time (1889).

Rosetta Adelia, daughter of James and Keziah Dean, was born in Shrewsbury, September 16, 1846; died April 9, 1864, aged seventeen years.

Jefferson Archibald, son of James and Keziah Dean, was born in Shrewsbury, September 18, 1849; married, June 2, 1872, Anna Maria Farrar, of Shrewsbury, born December 22, 1849. He has stayed on the home place (where his father and mother had lived forty years, and where they died). Their children were,—1, Edwin Lewis, born December 25, 1872; 2, Bertha Florence, born January 24, 1875, died March 30, 1881.

CHILDREN OF EDMUND AND AMANDA DEAN.

Zelotes Henry, son of Edmund and Amanda Dean, was born in Oakham, March 7, 1839; married Augusta Rawson, of Worcester, Mass., July 5, 1863, and resided in Worcester. He was engaged in the express business in

Ware, Mass., and Worcester, for many years. They had no children.

Daniel Harrison, son of Edmund and Amanda Dean, was born in Oakham, October 3, 1840; married Lizzie Reed, of Shirley, Mass., September 5, 1871. He was a dealer in groceries and provisions in Cambridge, Mass., for many years, where he now resides. They had one son, named Arthur Davis, born September 15, 1872.

Edmund, son of Edmund and Amanda Dean, was born in Oakham, March 9, 1844; married Nancy Leed Winnett, of Randolph, Mass., November 26, 1868. He was a baker by trade, and resided in Cambridge, Mass. Their children were,—1, Hattie Edna, born October 27, 1869, died September 3, 1874; 2, Laura Mabel, born November 8, 1873; 3, Herbert Welton, born November 12, 1883.

Charles F., son of Edmund and Amanda Dean, was born in Oakham, November 3, 1851. He lived in Worcester and Cambridge, Mass. He never married.

CHILDREN OF LUTHER AND EMELINE DEAN.

Gardner Milton, son of Luther and Emeline Dean, was born in Oakham, October 23, 1846; married Charlotte Emily Russell, daughter of Orlando and Fanny Russell, of Oakham, March 10, 1873. She was born January 19, 1844. Their children were,—1, Clarence Edgar, born March 5,

1874; 2, Minnie Gertrude, born August 20, 1875; 3, Warren Eugene, born September 7, 1876; 4, Sidney Irving, born May 4, 1879; 5, Mabel Josephine, born October 31, 1880; 6, Caroline Malvina, born August 12, 1883; 7, Emmerson Arthur, born February 19, 1885. Warren, Mabel, and Emmerson died in infancy. He served in the War of the Rebellion, in Company D, 17th Mass. Volunteers, and in Company B, 2d Mass. Heavy Artillery. Was in the battles of Wise's Forks, Kingston, and Goldsboro, N. C., and in the last campaign previous to the surrender of Gen. Joe Johnston's army to Gen. W. T. Sherman. Was under Generals Foster, Butler, and Sherman, in Virginia and North Carolina. He was a miller by trade, and afterwards a farmer and lived in Oakham.
