

### GENEALOGICAL NOTES ON THE DUNNING FAMILY IN AMERICA

The earliest mention of the name Dunning seems to be by the Bishop of Nelson, in his Life of Walter de Merton, p. 34, who says that "probably in the year 1269, he purchased the Norman Mansion(the present Pythagoras House, Cambridge), together with the estate of the Dunnings, who had held it from Conquest."

Bardsley's Dictionary of English and Welsh surnames, gives the following:

DUNNING, DOWNING.- the names Dunning, Dunnig (pronounced Dunning) and Dunnigs, occur as personal names in the "Hundreds Rolls" (1273):

John Dounynne ( I Edward III. Kirby's Quest for Somerset).

John Dunnyng (I Edward III. Kirby's Quest for Somerset).

Johannes Dunning, 1379 (Yorkshire Poll tax).

Alicia Downing, 1379 (Yorkshire Poll tax).

Johannes Downnyng, 1379 (Yorkshire Poll tax).

Hervey Dunning, 1273 (County Cambridge).

Richard Duning, 1273 (County Oxford).

John Dunning or Downing, sheriff of Norwich, 1432.

It seems probable that the Dunning family existed in England from a very early period and that men of the name scattered out over the British Isles and founded families whose relationship to each other cannot, at this late date, be definitely determined. Early in the reign of the later Stuarts, a family of Dunnings lived in Walkhampton, Devonshire, on the western edge of Dartmoor, from which arose the celebrated lawyer and parliamentarian, John Dunning, who became Solicitor-General of England and was created Baron Ashburton, Apr. 8, 1782. There is no evidence that any of the American Dunnings were directly related to this family, which was of the gentleman or landed class. At the same time, a number of families named Dunning, of the yeoman class, lived about 20 miles northeast from Walkhampton, and across Dartmoor, at Throwleigh and and South Tawton. As it is probable that several of the early Dunning immigrants to America were of the families from this vicinity, a description of these towns from the Devon Directory of 1889, is given below:

SOUTH TAWTON, 4 mi. s. e. Sampford Courtenay Sta; 4 mi. e. Okehampton, SW. Ry. In St. Andrew's church, the stained glass window is a memorial to Richard Dunning, d. 1871, ae. 102. The record of baptisms dates from 1540; of marriages and burials from 1558. One of the 7 "principal land owners" named is Richard Dunning of Barton, Throwleigh, resident; Richard Dunning, farmer, Week.

THROWLEIGH, 7 mi. s. e. Okehampton. St. Mary's church has a memorial window to the Dunnings of Barton. Register of baptisms begins 1653; of marriages 1654. Chief land owners, James Dunning. Esq. (Lord of the Manor), Wonston; Richard Dunning, Barton; Trustees of the late Wm. Dunning, Way; and 3 others. Private residents, Mrs. Dunning, Way; Richard Dunning, Barton; farmers, Thomas and James Dunning. Ash; yeomen, James Dunning, Wonston, Richard Dunning, Barton; area, 1884 acres; population, 317.

WINKLEIGH, 5 mi. n. w. North Tawton Sta. The Misses Dunning, Townsend Cottage; Mrs. Dunning, Hilliers; Mrs. Dunning, Townsend House; Richard Dunning. Baptisms registered since 1585; marriages and burials since 1569.

The prevaling opinion among those who have studied the early mention of Dunnings in America, seems to be that the earliest immigrants of that name came from Devon, England, and that they were probably of the class called Yeomen. Nothing authentic exists to show that these early Dunning immigrants were in any way related and hence, in considering the families founded by each on this continent, they are usually classified as distinct branches. While it is not here pretended that an exhaustive investigation and examination of records has been made, it is assumed on very reliable information that the following is about all we are ever likely to know concerning the early Dunning immigrants to America:

JONATHAN DUNNING (alias Singletary);—At the first settlement of Killingworth, Conn. (the part of the town now called Clinton), Jonathan Dunning drew the lot of land next to the parsonage. He had daughters born there in 1666 and 1668; was a soldier in an Indian war of 1676; and about 1682 is mentioned by Cotton Mather as one of a band of "Ranting Quakers" who pretended to perform miracles. In some of the records he is styled "Singletary" and the same man has apparently been traced in a family of Singletarys in Haverhill, Mass. No connection seems to have been established between him and any of the later Dunning families in New England.

HICKS DUNNING;—Sarah (dau. of Thomas Joy, who came to Hingham, Mass., 1638), married in 1648, Hicks Dunning, and to them was born, Mar. 31, 1672 a son Edmond, but no descendants have ever been recorded. Joy's will calls him Dunham or Denham.

ANDREW DUNNING;—Said to have been born in Devonshire, Eng: m. Susan Bond in England; came to America from Devon, Eng., in 1717; with 5 sons, landing at a place now called Georgetown, Me., near the mouth of the Kennebec river; blacksmith by trade; soldier in Capt. John Giles' Co., in the Indian war of 1723-24; subsequently moved to Brunswick, Me., and built a house at Maquoit; d. Jan. 18, 1736, aged 72, and is buried in Brunswick Old Burying Ground; descendants served in the Rev. War; many descendants today; for records apply to M. B. Dunning, M. D., Bedford, Iowa.

SAMUEL DUNNING;—Born in England; came to America early in life and settled in Kent Co. Del., near the present site of Dover; his younger brother Thomas, and sisters Deborah and Martha came to this country with him but died without issue. Samuel m. Tamar Wilson and died in Kent Co. Del., about 1734, aged 70. He is said to have had 7 children. Records of descendants of his son William, may be had from M. B. Dunning, M. D., Bedford, Iowa.

SOUTHERN DUNNINGS:-In the summer of 1730, a Wm. Dunning was Speaker of the South Carolina Legislature. In 1780, "James Dunning of Charleston S. C., was an Addresser of Sir Henry Clinton." Clinton captured Charleston early in 1780, and it was for the most part loyal, and these "Addressers" were doubtless Loyalists, though Clinton paroled them. During the Revolution, among some Loyalists who were captured in North Carolina, was one, Ensign John Dunning (named also as Denning and Downing). The Colonial and State Records of North Carolina, Vol. xi, p. 486, say that he was captured at Moore's Creek Feb. 27, 1776, with a great many others, nearly all Scotch Highlanders, who had been settled in N.C. after the defeat of the Young Pretender at Culloden, and were still coming to N. C. as late as 1775. In a report of a Committee of the N. C. Congress on the prisoners, it is set forth "that John Downing did actually take up arms and go to war as an Ensign to Capt. Seymour Yorke's Co; that he is a freeholder in Guilford and Orange Counties and lives in Guilford Co." In 1816, a Judge Wm. Dunning (b. 1794 in Guilford, N. C.) moved from Guilford. N. C., to Tennesee, and from thence, in 1822, to Bloomington, Ind., in company with three of his brothers, John, Thomas and Paris Chip-Wm. Dunning was Judge of Buchanan Co. Ind., 1844-1862, and d. man. 1879; John Dunning settled in Iowa; Thomas Dunning settled in Illinois; Paris Chipman Dunning, who is mentioned by Gen. Lew Wallace as being a sutler in the Mexican War, was elected Lieut-Governor of Indiana with Gov. Whitcomb in 1846, and on Gov. Whitcomb's election to the U.S. Senate in 1848, filled out the term, 1848-49, as Governor of the State. Sufficient investigation has never been made to determine the exact connection of these different families. Some of those who were Loyalists in 1776, may have fought on the other side at the battle of Guilford Court House in 1781. Descendants of Judge Wm. Dunning say that his grandfather and two of his uncles were killed in the Revolutionary war at the battle of Guilford C. H. Records of the descendants of Judge Wm. Dunning may be had from M. B. Dunning, M. D., Bedford, Iowa.

ABIJAH DUNNING;—came to America as a young man; m. 1763 in Salem, Mass., to Elizabeth Gregory (b. June 4, 1842; d. May 2, 1820); moved 1773-74 to Springfield, Mass.; thence in 1790 to St. Johns, Canada, with 4 sons and one daughter; thence in 1792 to Montreal; thence in 1801 to Cumberland, Ont., and later to Longueil, Treadwell's Seignory, a few miles south of L'Original, Canada, where he d. Dec. 18, 1809, aged 75; monument in old Protestant Burying Ground at the Four Corners. Most of his descendants in Canada today. Records and a fine Memoir of Abijah and his sons may be had from M. B. Dunning, M. D., Bedford, Iowa.

THEOPHILUS DUNNING;--(sometimes named as Downing and called "the fisherman"), had land granted him in Salem, Mass., 1642; had a son Theophilus, bapt. Mar. 13, 1642; dau. Ann (or Hannah) bapt. Sept. 8, 1644; and son Benjamin bapt. Jan. 17, 1647, all in Salem, Mass. Nothing further is known of Theophilus, but in the Town Reports of Boston Record Commissioners is found mention of a Benjamin Dunning, who, we assume, later moved to Long Island, where a Benjamin Dunning is mentioned at Newtown and Jamaica, L. I., in 1699, and again as late as 1708, when he is named as the father of Hannah Dunning who m. Isaac Hurd in Stratford, Conn., May 11, 1708.

OTHER DUNNINGS;—From Hanna, "The Wilderness Trail", Vol. II., 331, in a list of Indian traders is given the following: "James Dunning (sometimes incorrectly written as Denning, Demming, Denny, Dinnen, etc.) a trader at Allegheny 1734 to 1754; licensed in 1744 (Denning); robbed by Peter Chartier and the Shawnees at Allegheny, Apr 18, 1745; an unlicensed trader in 1747 (Denny) and in 1748; one of Forbe's and Bouquet's guides in 175S''; also, "Robert Dunning (and Donegal), trader in 1730, residence in what is now Carlisle, Pa."

The above comprise about all the Dunnings in America of early mention, but that there were later immigrants of the name in the U. S., is well known, these being mostly of Irish origin. The main branches of the family in America today, however, are the following:

- MAINE DUNNINGS, from Andrew Dunning who came to Maine in 1717.
- DELAWARE DUNNINGS, from Samuel Dunning who d. 1734 in Kent Co., Delaware.
- SOUTHERN DUNNINGS, from the family originating at Guilford, N. C.
- ABIJAH DUNNING family, mostly in Canada.
- FAIRFIELD COUNTY, CONN., DUNNINGS, from Benjamin and John Dunning who first appeared at Stratford, Conn., about 1700.
- ORANGE COUNTY, N. Y., DUNNINGS, from Michael Dunning who m. 1710 in Jamaica, L. I., and was of the party which founded Goshen, Orange Co., N. Y. in 1719; supposed to be a brother of Benjamin and John.

Modern descendants are fairly numerous from all the main branches but the best classified families of record are the Fairfield Co., Conn., Dunnings and the Orange Co., N. Y., Dunnings. These families are presumed to be descended from Theophilus Dunning, the English immigrant, granted land in Salem, Mass., 1642, and who probably lived and died there. Theophilus is therefore assumed to be the head of the family and is mentioned in these records as "Theop1".

As no further mention is found of Theophilus, Sr., or of his son Theophilus, we feel justified in further assuming that the younger son, Benjamin, bapt. Jan. 17, 1647, in Salem, Mass., on reaching adult years located in Boston, Mass., and in support of this assumption we find in the Town Reports of the Boston Record Commissioners, the following mention: "Benjamin, son of Benjamin and Mary Dunning, born in Boston, Mar. 3, 1679. Benjamin Dunning was a taxpayer in Boston in 1681 and 1685; he was elected Sealer of Leather, Mar. 12, 1682, and a tything man in Capt.

Turill's Company, Apr. 30, 1684." To connect the Benjamin Dunning of Boston with a Benjamin Dunning mentioned in records at Newtown and Jamaica, L. I., in 1699 and later, seems a rather long step, but the fact that two brothers, Benjamin and John Dunning, appeared at Stratford, Conn. (just across from Long Island) about 1700, and were baptized together (as adults) May 30, 1703, in Stratfield church, (now 1st Church of Bridgeport, Ct.), lends a very decided probability to the assumption that the Benjamin Dunning of Boston moved to Long Island where his family grew up. In 1708, Benjamin Dunning, of Jamaica, L. I., is named as the father of Hannah Dunning who m. Isaac Hurd in Stratford, Conn; and Benjamin and John Dunning who came to Stratford, Conn., about 1700, were very likely his sons, as was probably Michael Dunning who m. 1710 in Jamaica, L. I., and who was of the party which founded Goshen, Orange Co., N. Y., in 1719. We therefore place Benjamin Dunning, bapt. Jan. 17, 1647, in Salem, Mass., named in Boston records and later in records of Jamaica, L. I., as second in the line of descent, and refer to him as "Benj 2".

In explanation of the curious fact that the brothers, Benjamin and John Dunning, who came to Stratford, Conn., about 1700, were not baptized until they were adults, we submit the following report on the condition of Long Island from 1638 to 1700; contributed by S. Wright Dunning:

"The first settlers, 1638, were Dutch. It was nearly depopulated by an Indian rising in 1643. A colony from Connecticut came in 1652, under a charter from Gov. Stuyvesant and called the place where they settled Middlebury. When the English first took posession, they professed allegiance to Connecticut, whither nearly the whole colony had gone in 1643 because of the Indians.- After the establishment of English rule in 1664, it was named New Towne. When the Dutch resumed possession in 1673. only 23 out of 99 male adults took the oath of allegiance. Rev. Francis Doughty, who, with associates, claimed 13,332 acres of land in Newtown. was made minister of Flushing (adjoining Newtown) by Gov. Stuyvesant. He was an Englishman, banished from Massachusetts for his views on baptism. He went first to Long Island in 1642 and went with the Quakers in 1656. In 1702 the Governor attempted to establish an Episcopal minister in a parish including Jamaica, Newtown and Flushing. Wm. Urguhart, rector from 1704 to 1709, said that 'most of the inhabitants are Quakers who roam through the country from one village to another, talk blashphemy, corrupt the youth and do much mischief.' If Benjamin Dunning were one of these it would explain why his sons were unbaptized until they became adults."

In a publication called the Town Records of Jamaica, L. I., from 1656 to 1748, Vol. I., p. 143, it is mentioned that "Daniell Downing, in Mar. 1693, sold a brown horse to John Harreson of Jamaica." From the same source, Vol. III., p. 133, a deed was made by John Foster to John Messinger, one of the witnesses of which was "Machel Duning." The date of this deed is May 20, 1714, and the witness referred to doubtless was Michael Dunning who was of the party which founded Goshen, Orange Co., N. Y.,

in 1719. From another source, "Benj. Downing of Hempstead, L. I., (adjoining Jamaica), Apr. 28, 1755, had one female slave."

We have now reached a point where it is necessary to divide the family we are considering into 3 main divisions, these divisions being founded by the 3 sons of Benjamin Dunning of Jamaica, L. I. The given names in the families of these brothers are quite similar for several generations and each of the three men had a son named "Michael." While we do not know the order of birth of these brothers, the entry of their names on the baptismal record in Stratfield church was "Benjamin and John Dunning" which is pretty good evidence of their relative ages; hence we suppose Benjamin to have been the eldest, and according to the Boston record was born March 3, 1679; John, who accompanied Benjamin to Connecticut, being the second; and Michael who remained in Long Island, the youngest. As all were 3rd in line of descent from Theop 1, we describe them genealogically as "Benj 3", "John 3", and Michael 3". However they are also often spoken of in these records as follows: "Benj 3" is known as "Sergt. Benj." or Benj. Sr.; "John 3" is known as John (1), because he had a son John and a grandson John; and "Michael 3" is known as Michael of Orange Co., N. Y., or Michael, founder of the Orange Co., branch.

One of the most interesting groups of all the Dunnings in America is the one which had its origin in Fairfield Co., Conn., comprising the descendants of Benjamin and John Dunning who first appeared at Stratford, Conn., about 1700; were baptized together (as adults) May 30, 1703. by the Rev. Charles Chauncey in Stratfield Church (now 1st Church of Bridge-The record still exists, and that the brothers were adults at port. Conn). the time of baptism is proven by the fact that the same record does not name parents, but records the baptism of a daughter of Benjamin in 1707, and twin sons of John in 1713. In 1711, we find that Benjamin and John were of the party that first settled Newtown, Conn., about 20 mi. n. w, of Bridgeport, in that part which has since been made the town of Brook-They are both named in the early town records of Newtown, where field. they held town offices. Benjamin lived in Newtown all his life and d. Mar. 21, 1739. John moved to Norwalk about 1717 and d. there Jan. 1, 1734. The family records of the two brothers are given below:

BENJAMIN DUNNING 3 (Benj. <sup>2</sup> Theop<sup>1</sup>), b. Mar. 3, 1679 in Boston Mass; known as Sergt. Benj. and Benj. Sr; came to Stratford, Conn., about 1700; bapt. May. 30, 1703 with his brother John in Stratfield church: was one of the party which founded Newtown, Conn., in 1711 and d. there Mar. 21, 1739. First wife is unknown, but he m. (2) 1710 Elizabeth Miner (b. 1690, dau. Capt. John Miner) who survived him and married Obadiah Wheeler. Benjamin's will was executed Mar. 23, 1737: a codicil was added 1738; and was proved Mar. 30, 1739. It willed to his wife, Elizabeth, who was required to pay 20£ to his grandson Joseph Stilson when he became of age, and to his daughter Sarah (Holley) 10£. Benjamin willed further to sons Benj., David, Abel, John, Michael and Amos; Thos. Tousey and the son Benj. were the executors. The inventory of the estate foots up 2499 £., 16 s. Elizabeth, his eldest daughter, is not named and was probably dead, the grandson, Joseph Stilson, mentioned above, being her son. On Jan. 7, 1740, Elizabeth, relict of Benjamin, was appointed guardian of Michael and Amos Dunning; Thomas Skidmore, guardian of Abel and John Dunning; and Obadiah Wheeler, guardian of Benjamin Dunning, all sons of Benj, Sr. Of his family, given below, the first 2 children were by his first wife; the last 7 being by Elizabeth, second wife:

- I. Mary, b. July 6, bapt. July 20, 1707 in Stratfield church; not named in will.
- II. Benjamin, Jr., b, Aug. 9, bapt. Aug. 14, 1709; m. Sarah Burritt; d. 1782; called "Capt. Benj."; had 10 sons and 3 daughters.
- III. David, b. Sept. 6, 1711, bapt. May 11, 1712; m. 1736 Hannah Botsford; d. 1783; had 7 sons and 6 daughters.
- IV. Sarah, b. Aug. 14, bapt. Oct. 25, 1713.
- V. Abel, b.....?, owned the covenant, Nov. 6, 1743 and dau. Sarah bapt. same day; a son, Josiah, bapt. Sep. 22, 1745; Abel d. Sep. 2, 1759.
- VI. John, b.....?; several deeds of land in Newton between 1747 and 1752, in one of which he names Amos as his younger bro., and already dead; m. Sept. 2, 1747, Anna Kimberly; he d. 1764. Estate distributed Jan. 3. 1773 to sons Abraham, Philo, Isaac and James.
- VII. Elizabeth, b.....?; m.....Stilson.
- VIII. Michael; b. July 30, 1730; m. July 19, 1750 Abiah Kimberly; moved to Pownal, Vt., 1762, two years after first settlement of the town; had a 2nd wife; was a leading man in Pownal where he d. Feb. 28, 1810; had sons 7 and 3 or 4 daughters.
  - IX. Amos, b. Jan. 20, 1734; died young, before 1752.
- BENJAMIN DUNNING, Jr. 4, (Benj 3, Benj 2, Theop 1), b. Aug. 9, bapt. Aug. 14, 1709; m. (1) about 1730 Sarah Burritt (d. Mar. 12, 1773); m.
  (2) Oct. 13, 1773, a widow, Mary Bristol (her will proved April 2, 1782); called "Capt. Benj"; lived in Newtown and Brookfield, Ct.; he executed a will in Newtown, Oct. 9, 1782, saying he had no wife to provide for and willed to sons; will proved Nov. 5, 1782; family as follows:
  - 1. Ezra, b. Jan. 1732, bapt. June 15, 1734; m. Ruby----(1739-1818); d. June 16, 1796; had the following children:

  - g. Alucia, b Sep 27, 1809; d. Sep. 14,1814.

- vii. Anner, b. Oct. 19, 1772; m. Abiah Clark.
- viii. Parthenia, b. July 14, 1775; m. Abiram King; d. June 18, 1828.
- ix. John, b. Oct. 26, 1777; d. Sept. 11, ----?.
- x. Ezra, b. Apr. 20, 1780; d. Feb. 20, 1854; lived in Mass., near East Canaan, Conn; known as "Snap" Dunning.
- 2. Mary, b. Sep. 9, 1734; m. Jos. Hepburn of Brookfield; was living in 1786.
- 3. Eli, b. Aug. 8, 1736; moved from Brookfield, Ct., to Hudson, N. Y; his son Smith Dunning went to England to see about the estate of Lord Ashburton.
- 4. Jared, b. July 31, 1738; m. Mercy, dau. of Joseph Smith of Brookfield; issue as follows:
  - i. Clarinda, b. 1762; m. Andrew Northrop (1758-1825); d. Jan. 11, 1852.
  - ii. Wolcott, m. Matilda Pulmer; moved to Butternuts, Otsego Co., N. Y.
  - iii. Joseph, b. 1769; m. Hannah, dau. of John Dunning, died in New Haven, Ct.
  - iv. Mary (twin of Joseph), b. 1769; m. Isaac Babbitt; d. Nov. 2, 1812.
  - v. Asahel, m. Lucretia Judd of Watertown, Ct.: moved to Indiana, on the Wabash, and had 3 children, Elsie, Bevil Judd and Juliet; he went twice to the West Indies and in 1812 to Canada, whence he was forced to return by the war.

From this point, the narrative of the family becomes too voluminous to compress within the confines of a single essay. Not many of the sons of the two brothers, Benjamin and John, moved far from the home locality in Fairfield Co., Conn., but many of their grandsons did so, giving rise to numerous settlements of Dunnings in the states north and west. However it will be noted that Michael (1730-1810) son of Serjt. Benj., moved to Pownal, Vt., in 1762; and Michael (1726-1813) son of John (1), moved to Saratoga Co., N. Y., in 1770, both of them leaving Connecticut before the Revolution. A little later, when the tide of immigration to the newly opened country in New York and elsewhere, set in in earnest, many of the Fairfield Co., Conn., Dunnings followed, and to illustrate this exodus a note is here submitted by S. Wright Dunning, describing what took place in one of the families of the 2nd generation:

"It is notable that no less than 6 of the 13 children of DAVID, b. 1711,

(2d son of Sergt. Benj.) lived in the southern part of Vermont and in adjacent parts of New York. They were:

Abigail, m.—Murray; lived in Orwell, Vt., 6 mi. west of Ticonderoga. Silas, b. 1755; lived in Salem, N. Y., adjacent to Sandgate.

Hanna, b.—.? m.—.Hurd; lived in Moncton, Vt., much further north—about 15 miles from Lake Champlain at Vergennes.

At the same time, Matthew (son of John 1st) was in Williamstown, Mass., the town next to Pownal, Vt., on the south; Michael (son of Sergt. Benj.) was in Pownal; and Deacon Michael (son of John 1st) was in Stillwater and Malta (Dunning Street), N. Y. To understand this we must remember that this country was first opened for settlement by the close of the War which made Canada English; that an exceptionally large proportion of the Colonial troops, who had campaigned in this country were from Connecticut, and were therefore informed as to its attractions. People swarmed there from Connecticut as they did between 1850-60 to Iowa, between 1865-70 to Kansas and Nebraska, and after 1880 to the Dakotas, from states further east. I never heard it intimated that the children and grandchildren of Michael of Pownal, Vt., were aware that they were related to any of these other Dunnings,—yet Michael of Pownal, Vt., and Matthew of Williamstown, Mass., were first cousins."

The above note merely illustrates how numerous and how widely distributed are the modern descendants of the old Connecticut stock of the Dunning family. To go into the matter much further would be to write a book, giving under proper classification, the descendants of each son of the three brothers, Benjamin, John and Michael Dunning. We are satisfied that the foundation for such a work exists and with a united effort on the part of all the Dunnings interested, could be carried to completion. We desire, therefore, to make a definite call upon all who receive this publication, to furnish the records of their families as indicated on the attached blank, to the representative of the branch to which they belong; for the Fairfield Co., Conn. family to M. B. Dunning, M. D., Bedford, Iowa; for the Orange Co., N. Y. family to Mrs. Ella May Smith, Jefferson Ave., Columbus, Ohio; for all other branches of the Dunning family in America, please communicate with the authors.

Recently two groups of Dunnings in New York state have engaged the attention and study of the writer in trying to locate their ancestry from the Fairfield Co., Conn., family, and are as follows.

Dunnings in Yates Co., N. Y., are descended from a Lemon (or Leman) Dunning, (b. 1781; d. 1853); his father is said to have been a Samuel Dunning (b. 1753; d. about 1791), who married Desire Bradley in 1776. After the death of Samuel, his wife Desire married Abel Pulling in Conn., presumably in the vicinity of Newtown, and soon after brought her family to Saratoga Co., N. Y., from which locality, Lemon, mentioned above, moved in 1816 to Yates Co., N. Y. Our records seem to indicate that Samuel (1753-1791?) was of the family, (possibly a grandson), of John, b. 1710 (one of the twin sons of John 1st).

Dunnings in Wyoming Co., N. Y., and vicinity, are descended from a David Dunning, b. in Conn.; m. in Conn., to Susannah——; came to N. Y., in 1802 with 3 children and settled in Wethersfield, Wyoming Co., N. Y., where he ran a blacksmith shop for about 25 years; he then moved to Ohio with a son, Samuel, and settled at Fairview, Ohio, where he d. about 1858-60; had a family of 10 children of which a very good record exists. By the most careful analysis of our records, we are, as yet, unable to say to which Connecticut family this David belongs.

In conclusion we desire to urge all Dunnings who may peruse these notes, to begin a systematic classification of their families and communicate the results to the persons mentioned above. Records and information on any particular branch will be gladly furnished on request.

#### NOTABLE DUNNINGS IN THE REVOLUTIONARY WAR.

- JOSIAH DUNNING 5 (Michael 4, Benj 3, Benj 2, Theop 1), b. Oct. 7, 1755 in Newtown, Conn.; moved to Pownal, Vt., 1762; was a soldier of the Revolution and took part in the battles of Bennington, Ticonderoga and Saratoga; d. Feb. 27, 1842, in Sodus, N. Y.; monument in Pleasant View Cemetery, Williamson, N. Y.
- ELIAS DUNNING 5 (Richard 4, John 3, Benj 2, Theop 1), Capt. of the 5th Co., of the 13th Conn. Militia, which marched to and garrisoned Ticonderoga after its capture; entered service Aug. 12, discharged Sept. 16, 1776; Capt. Elias is buried in Woodbury, Conn., and the probate records contain his will.
- MICHAEL DUNNING 5 (Michael 4, John 3, Benj 2, Theop 1), b. May 20, 1750, Newtown, Conn.; moved to Saratoga Co., N. Y., about 1770; enlisted in 1777 at Stillwater, N. Y., in Capt. McCuen's Co., of Seth Warner's Regt: in the fall of 1779, while a Lieut., was captured by the British and contined in Montreal for 3 years; promoted Capt., Nov. 12, 1779 to rank from July 16, but never served with that rank; engaged in battle at Bennington and Hubbardton; placed on pension rolls, Mar. 25, 1835, and died Sep. 28, 1837, at Entield, Tompkins (now Schuyler) Co., N. Y.
- MATTHEW DUNNING 5 (Matthew 4, John 3, Benj 2, Theop 1), was a private in Capt. Sam Clark's Co., of Col. Benj. Simond's Berkshire

Regt., in 1777, also Corporal in 1777 and Sergt. in 1781 of same Company; took part in the battle of Bennington and was said to have been at the capture of Ticonderoga; he lived at Williamstown, Mass.

#### NOTABLE DUNNINGS DECEASED.

- MICHAEL DUNNING 4 (Benj 3, Benj 2, Theop 1), b. July 20, 1730, Newtown, Conn.; moved about 1762 to Pownal, Vt., where he became town clerk and selectman and is often mentioned in the town records; was the father of Josiah, the Revolutionary soldier; d. Feb. 28, 1810, and is buried in Pownal, Vt., where his headstone says, "Honest and industrious in life, a friend to the poor, a patriot of '76". Many of his descendants became prominent in public life.
- REV. BENJAMIN DUNNING 5 (Capt. Benj 4, Benj 3, Benj 2, Theop. 1), b. June 17, 1740, Newtown, Conn.; received A. B. from Yale in 1759; licensed to preach 1760; preached in Marlboro, Ct., and later during the Revolution at Pettipog (now Essex), Conn.: d. May 12, 1785, monument in old Essex Cemetery.
- RALPH DUNNING 7 (Tertius 6, Rev. Benj 5, Capt. Benj 4, Benj 3, Benj 2, Theop 1); b. 1811 in Middletown, Conn.; entered the engineering branch of the U. S. Army when Andrew Jackson was President, and long its chief clerk; assisted in building many fortifications at Savannah, Charleston and on the Pacific Coast; retired about 1880; d. May 4, 1905, at Brooklyn, N. Y.
- MICHAEL DUNNING 4 (John 3, Benj 2, Theop 1), b. 1726, Newtown, Conn.; moved about 1770 with 6 sons to Saratoga Co., N. Y., settling first at Stillwater (on the Hudson) and later founding the hamlet "Dunning Street," now Malta, N. Y.; d. Nov. 29, 1813, and is buried in Dunning Street Cemetery which contains 37 Dunning graves; was the father of Capt. Michael, the Revolutionary soldier, and is notable for very many descendants.
- REV. CHARLES URBANE DUNNING 7 (Urbane 6, Capt. Michael 5, Michael 4, John 3, Benj 2, Theop 1), b. July 31, 1829, Ithaca, N. Y.; educated at Hamilton College, Clinton, N. Y., and at M. E. Biblical Institute (now Boston University), Concord, N. H., where he graduated in 1855; ordained minister of the M. E. Church and served in the ministry and as presiding elder in New Hampshire and Mass.; d. July 8, 1905, Winchester, Mass.
- REV. HOMER NORTHRUP DUNNING, D. D. 8 (Herman 7, Michael 6, John 5, John 4, John 3, Benj 2, Theop 1), b. July 17, 1824, Brookfield, Conn.; received A. B. from Yale in 1848; Congregational pastor at Gloversville, N. Y., and at South Norwalk, Conn.; graduated at Union Theological Seminary in 1852: translated many Greek plays, the Old High German Nibelungen Lied and made a poetical para-

phrase of the Book of Job; he died Mar. 27, 1896, in South Norwalk, Conn.

- BENJAMIN DUNNING 5 (John 4, John 3, Benj 2, Theop 1), b. about 1745 at Newtown, Conn.; moved about 1767 to Warren, Litchfield Co., Conn., where he had 12 children by two wives; called "Benj. of Warren"; died before 1795 and chiefly notable for numerous descendants; his widow, Mercy Shove, and 12 children moved to Cayuga Co., N. Y., before 1800.
- LEHMAN HERBERT DUNNING, M. D. 8 (Oscar M. 7, Isaac 6, Benj 5, John 4, John 3, Benj 2, Theop 1), b. Apr. 2, 1850 in Edwardsburg, Mich.; graduated Rush Med. College, 1872; elected Professor of Gynecology, Med. Coll. of Indiana, 1890; abdominal surgeon and author; Pres. Amer. Assoc. Obstetricians and Gynecologists, 1903; died Jan. 6, 1906, in Indianapolis, Indiana.
- REV. CHARLES SEELY DUNNING D. D. 8, (Henry 7, John 6, John 5, Jacob 4, Michael 3, Benj 2, Theop 1), b. 1828 Wallkill, Orange Co. N. Y; A. B., Williams College, 1848; graduated Union Theological Seminary, 1852, and instructor in Hebrew there for a year; pastor of churches in Franklin N. Y., and Honesdale, Pa; d. June 1, 1886 in Metuchen, N. J.
- BENJAMIN F. DUNNING 7 (Benj 6, John 5, Jacob 4, Michael 3, Benj 2, Theop 1), of Warwick, Orange Co., N. Y: A. B., Union College; an eminent lawyer in the city of N. Y., and for a time the partner of Charles O'Conor.
