GENERATIONS ONE TO FIVE

- Page 17. (9). David, with others of the family, joined in 1696 the Dutch Reformed Church of Hackensack from their French Reformed of Kinderkamack. In the same year the church erected a church building; in the wall of it a stone was placed bearing the initials and date DMR 1696 within a heart-shaped border. It suggests the forwardness of the family in the membership of the church and in the erection of the house of worship. The stone was preserved through the years of successive edifices and now rests in the outer wall of the present one. As to the border shape, Dr. John Baer Stoudt of the Huguenot Society of Pennsylvania writes: "The heart date-stone is in the best pietistic tradition. Between the four arms of the earlier Huguenot crosses the heart appears very definitely. In the later crosses like the Languedoc as represented by the Pennsylvania and New Jersey societies the heart is less clearly defined but still there. The phrase Iesus is the heart of God appears again and again in the literature of the mystics."
- Page 26. (22). A descendant of Peter Lubbertse Westervelt and (22) Susanna Demarest and of Thomas Eckerson and (126) Maria Demarest is Mrs. Mary B. Gates, Staff News, Waldorf-Astoria, New York City. Peter De Baun, descended from both (4) David and (5) Samuel Demarest, m. Margaret Ten Eyck; their son, Walter De Baun, m. —; their daughter, Mary m. Thomas Peckham; their daughter, Mary B., m. Hobart Lincoln Gates.
- Page 40, Sup. 4. (62) Anna Marie Ziefle (Mrs. George) Winters b. September 13, 1869.
- Page 49, Sup. 4. (83) Jacobus Paulison (Poulese) m. (1) Maria De Moreewrong; she m. Jacobus Westervelt (pg. 108 (349)) Jacobus Paulison (d. November 13, 1808) m. Catrina Van I(E)mburg (d. July 18, 1837 aet. 99-2-11). Children: Paulus (a daughter Lavinia m. John I. (J.) Demarest); John J. m. (1) Alida (Aeltje, Altie), daughter of Abraham Ely and (166) Maria Demarest. Ref.: Lewis D. Cook.
- Page 51. (89) An article in the New York Sun by Miss Helen Burr Smith refers to the wedding token as necklace clasp, not forehead, calls attention to the maker's mark on the back, mark of Philip Goelet (1708-1748) of New York, and to the beautiful engraving of six-petal flowers. Reference is made to the clasp as one of the few known examples of gold workmanship of the early American craftsmen.
- Page 52. (91). This record, not fully accurate, was partly corrected in Supplement I, page 5. Family Bible in possession now of Mr. Howard I. Durie, Woodcliff Lake, New Jersey, gives children of Jacobus Demarest: 1765, February 18, David; 1766, August 16, Susanna; 1768, March 1, Johannis; 1773, March 25, Johannis; 1775, December 13, Abraham; 1779, October 16, Margrietje; 1781, September 20, Abraham. This corresponds closely with the record of (91). But their Bible record is of the children of Jacobus Davidse (son of David) Demarest while (91) is of Jacobus, son of Jacobus. Questions await satisfactory answers.
- Page 66, Sup. 5. (144) Lieut. Col. Reginald S. Huidekoper of Washington, D. C., d. September 28, 1943, South Dartmouth, Mass. Lawyer. Business executive. Served in World War I, General Headquarters A. E. F. in France. Law practice and official service in Washington, Son of Frederick

- W. Huidekoper and Virginia Christie; descendant of William Christie and (144) Catalyntie Demarest.
- Page 76. (166) Altie (Aeltje, Alida) Eli (Ely) m. John J. Poulesse (Poulison)
 b. April 18, 1773 d. December 19, 1852. A daughter, Trientje, b. March
 15, 1797 d. before 1835, m. John Ackerman. The father of J. J. Poulison,
 Jacobus (James) Poulison, in 1799 and until his death in 1808 owned
 the old Demarest house and its land and the burying ground.
- Page 90, Sup. 7. (230) Cornelius De Grauw b. July 8, 1742, Tappan, N. Y., son of Johannis De Gra(u)w and Rachel Van Hoorn of Tappan. (Sup., page 7, apparently error.) m. (230) Lea Demarest. - Page 95, 430-1. (273) Johannes (John J.) m. Bridget Bogert. Children as given pg. 430 and Supplement pg. 40 (672-675a). Son (675) James J. (I.) m. (1) Rachel Westervelt, m. (2) Elizabeth Brower, not Elizabeth H. Demarest. David, son of James J. and Rachel Westervelt, m. Elizabeth Hopper. Wallace, son of David and Elizabeth Hopper, m. Anne T. Mortimer. Correction to record pg. 431: child of Victor B. and Agnes Patton, David Wallace, not George Wallace. Additions: Loretta, daughter of Wallace, m. Michael Ladik, September 22, 1938; Agnes Mary, daughter of Victor B., b. August 16, 1939; children of Leonard J. McGarvey and Marian T. Demarest: David Demarest, b. September 24, 1940; Francis Xavier, b. December 5, 1941. Ref. Sylvia A. Demarest, 145 Hunt Ave., Pearl River, N. Y.

- Page 105. (340) David, b. September 10, 1756, d. March 1, 1823. Catherine Brouwer, b. November 28, 1765, d. April 9, 1857.
- Page 107. (347) Niclaes (Nicholas); his wife in usual reference is Simantha More; the family usually spelled the name Demorest.
- Page 109. (353b) Jacob Smock was a soldier in the Revolution 1777-1779, a sergeant in the 4th Regiment of Virginia troops. He was b. 1744, bap. at the Raritan Reformed Church, New Jersey, May 20, d. 1797. He and his wife, Catherine (Trientje) Demaree had six children, all of interesting, some of tragic, record: Lea, bap. May 15, 1774, Conewago; Daniel, b. October 7, 1776, Virginia; John, b. 1779, d. January 10, 1829, Indiana; Matthew (eldest son); Abram. Matthew was killed by Indians when a young man in Kentucky. Lea was scalped when abandoned by her Indian captors to whites who were in hot pursuit, but grew up and raised a large family. John and Peter, aet. 14 and 12, were kidnapped by the notorious chief Winemac, held captive for two years (Peter actually adopted by the chief as his own son), 1793 to 1795, then ransomed by their father for a keg of rum after Mad Anthony Wayne had defeated the Redskins in battle across the Ohio; John was one of the earliest settlers of Indianapolis, migrating from Kentucky, the earliest settler only one year ahead of him. September 11, 1837), child of Barent and Francyntje Forshee; that Barent (b. 1782, m. Susanna Storms), Francyntje (b. 1787, m. John Durie), Maria (b. 1789, m. Albert Bogert), Johannis (b. 1790, m. Leah Demarest) were their children. Samuel C. d. 1791-5(?); his widow m. (2) Samuel Durie (b. October 20, bap. November 16, 1775, at Paramus, d. October 26, 1845), son of John P. Page 118. (404). The will of Henry Oothoudt, January 18, 1797, probated August 14, 1801, mentions daughter Catherine, wife of David Bancroft, also grandchildren, Henry Oothoudt Demarest and Nelly Demarest. It thus appears that (404) Jan Demarest died or was no longer known prior to 1797, his wife being Mrs. David Bancroft in that year. December 13, 1862; she is buried in Bogert burying ground near Paramus. Peter C. De Baun (d. 1845) is buried with first wife, a second cousin, at Schraalenbergh. The will of Effie, widow of Peter C. De Baun, probated January 17, 1863, Hackensack, mentions children (Bogert): Rachel m. Isaac Demarest; James I. (deceased) and child Euphemia; also grandson Samuel P. Bogert and child Effie; also children of deceased son, John Bogert—Samuel I. and Isaac.

- Page 185. The pewter charger shown here has been during recent time a loan to the Albany Institute of History and Art, given a separated and central place among special exhibits. "The finest example we know of the early Dutch pewter in this country." (J. D. Hatch, Curator). "Your wonderful pewter plate... the finest piece of pewter I have ever seen." (Miss Helen Burr Smith).

- Page 198. (993). Rev. Dr. Edward Dwight Eaton, d. Fairfield, Connecticut, June 18, 1942, aet. 91. He is survived by his wife and four children: Allen Barber Eaton; Mrs. Harvey W. Hincks, Mrs. Charles F. Read, Mrs. Howard B. Lewis, Mrs. Donald M. Jack. He had a very distinguished career in the ministry of the Congregational Church, in its executive positions and in education, as trustee of many institutions, as author, editor and encyclopedist, as president of Beloit College. He received the degree of Doctor of Divinity from Yale and from Northwestern, and the degree of Doctor of Letters from the University of Wisconsin. His mother, Catharine Elizabeth Demarest, was a woman of much distinction. (See pg. 198.) He had deep interest in Demarest tradition. His last letter, April 27, 1942, when he was past 91, written in clear fine hand: "Last June I drove . . . to the farm of my great-grandfather, Rev. John Demarest, and the spot where he assisted in the disinterment of Andre, It was a deeply interesting experience. I value highly my Demarest descent through my beloved mother, whom I have almost idolized from my childhood." (See Supplement, pg. 55.)
- Page 205. (1085). David L., d. March 11, 1870, in his 76th year; Catherine, wife of D. L. Demarest, d. February 4, 1867, in her 75th year. (Inscriptions in Perth cemetery near Broadalbin.)
- Page 207. (1076). Louise Helliwell, d. December 1, 1942.
 - (1077). Cornelius is spoken of as the eldest son, should be (1073) or (1073a); the (1073) David d. infancy. Cornelius is said to have had a large family very active in church and temperance causes; also that a son David, not (1836) Samuel, m. Jane Clark, "a great woman." Ref.: Mrs. Susan V. - Page 208, Sup. 18. (1078). Demaree Bess, now one of the editors of the Saturday Evening Post. "Few men have a better background for writing on matters of international politics... For twenty-two years of his fifty years he has lived and worked abroad, ... went abroad for the first time in 1916, only two months after having been graduated from the University of Iowa... Since America entered the war, Mr. Bess has crossed the Atlantic four times, twice by Clipper, once on a battleship and once in an Army bomber." (Post, December 18, 1943.) "The coolest man I've ever seen in or out of the Army is Demaree Bess. During an air raid in Algiers I saw him standing in the street with flak dropping about him like hail. I tried to get him under cover, but he said 'Let me alone, I want to see this.'" (Reader's Digest correspondent.)
- Page 210. (1113). Samuel bought land from Squire Boone, Kentucky, moved in 1820 from Shelby County to Henry County, starting the community Pleasureville. He served in the War of 1812. From 1825 to 1835 he was a magistrate.
- Page 211. (1114). A daughter of Joseph H. Handley and Nancy Jane Carmine is Mrs. Joseph G. Forney, First Vice President General of the National Society, D. A. R., 85 Spencer Ave., Chicago, Illinois.

Harry McEwen of Louisville and Charles Julian of Frankfort were wounded by stray shots; two hours later Julian died. . . . Scott and Colson met at the desk and renewed an old grouch. . . . Bystanders rushed in to separate them when Colson drew his revolver and began to fire. The first shot struck Scott, who ran to the stairway and fell. Colson continued to fire and Luther Demaree, assistant postmaster at Shelbyville, a bystander, fell dead near the west window. . . . Demaree was a man of literary taste and attainment, a collector of source material as to Kentucky and especially the Demaree family. Making his home in Shelbyville from 1895, a man of character and religious devotion, he was in his tragic death mourned by a host of friends.

He quickly became of much scientific distinction, doing original work by unusual method in the study of glaciers, working in recent time at Yale University as a Sterling Research Fellow and then on a Guggenheim Fellowship while also acting head of the department of geology at Wesleyan University. He was a Fellow of the Geological Society of America. He had taught also at Michigan, Cincinnati, Princeton and North Dakota. He was author of important articles in scientific journals. "A brilliant glaciologist, Dr. Demorest . . . gave up last summer the prospect of an unusually successful scientific career to serve his country in the army." As a first lieutenant in the Army Air Corps he was sent on a "most important and secret mission and one for which he was the best qualified person. He could have chosen no better nor appropriate grave than that vast and silent field to which he had devoted so much constructive thought." It is inferred that he was sent to establish an inland station on the Greenland Ice Cap. His motor sled crossing an ice bridge crashed through into the crevasse. The personal character and spirit of Max Harrison Demorest, as well as his scientific genius and devotion, was acclaimed by all his associates, speaking of him with "affection, admiration and high hopes." His interest in the Demarest tradition was shown by his calling on the compiler of this research when he was at Princeton. (See New York Times and Herald-Tribune, December 11, 1942, and Memorial in Proceedings of the Geological Society of America, April, 1943.)

Letter of Lewis D. Cook: "Jacobus (James) Paulison, 1736-1808, in 1797 and at the time of his death in 1808, owned the farm on which still stands the old Demarest Homestead, lately acquired by the Demarest Family Association, and the French cemetery adjacent. How Paulison came into possession, whether by inheritance or by marriage or by purchase, I have not been able to discover, but the following data from the County Deed Book are related to the subject and seem to indicate that he bought it of James Demarest in 1794-97. By a deed dated 5 June, 1794, James Demarest of Hackensack Precinct, Bergen County, conveyed to Guilliam Demarest of same place, for 25 Pounds New York money, a 501/2 acre tract in said Precinct, reciting that 'Whereas David Demarest of the Province of Upper Canada was possessed of certain lands in Hackensack Precinct, County of Bergen and State of New Jersey, as by deed of conveyance thereof will fully appear, and did by a certain instrument or writing under his hand and seal convey the same in full to the above named James Demarest, now this indenture witnesseth,' etc., conveys to said Guilliam Demarest 'all that certain lot of land . . . to James Demarest,' etc., etc. (Recorded in Book O, page 285) 'bounded north by land of the said James Demarest, west by David Anderson, south by the French gentleman(?) and by Albert

Demarest, east by French brook.' In a mortgage placed on part of this lot, dated 1 May 1797, this Guilliam David Demarest as he is therein described, of the township of Hackensack, described it as being bounded on the north by land of Jacobus Powlisee." The David Demarest of the Province of Upper Canada is not surely identified (220? 586?). Likewise the James Demarest (583?). The Guilliam (Guilliam David) Demarest is probably (583). Who was the "French Gentleman"?

Helen Larue (Mrs. F. H.) Chapin, 2065 Hanover Drive, East Cleveland, Ohio, because of related LeRoux Huguenot line, is an interested and generous supporter of the Demarest Association and Foundation. "My interest in the Demarest family comes from my appreciation of what I believe your first American ancestor, David des Marest, did to befriend my first American ancestor, Jacques Le Roux (Larue), who arrived in Harlem 1672-73 . . . an orphaned lad of about 15 years with a younger sister and brother, Huguenot refugees, whose father, tradition says, died at sea. Jacques Le Roux went with David Demarest to the French Patent on the Hackensack River. I believe he was buried in that French cemetery on the Demarest land." Mrs. Chapin is a cousin of Louis S. Champine m. (2893) Emojene Demarest.

Just as this supplement goes to press new and interesting records are received concerning family line in Canada and the United States spelling the name Demaray, a spelling heretofore known to the compiler only among the well-known descendants of (800) Joost (Joseph) Demarest (Demaray), all in the United States. The line now made known is apparently descended from (783) Samuel Demarest. It is a migration before 1800 from Rensselaer County, New York, a settlement in the Province of Quebec, then in Ontario, a spreading in that area, and a considerable return to Michigan, Minnesota, Dakota, Nebraska. Knowledge of it now traces to recent inquiry from Mr. Melvin J. Demaray, of Dunning, Nebraska, and coincident letters from Dr. J Sheldon Demorest, of Foxboro, Ontario, whose instant search into records, the Ward-Munger-Varnum-Martin genealogy and the History of Middlesex County, Ontario, and personal correspondence secured convincing data. The Demarest Family, page 172, (783) Samuel Demarest was apparently in point, the marriage to Grietje Martin, the names of the children: Nicholas, Richard, Geesie, David. The record so far as received and understood, one descending line, far from complete, invites the interest and research of all descendants (one singular detail is the apparent marriage of a son and a grandson each to a Rebecca Varnum):
