Know all men by these presents that I William
Gaus Senr, in Craven County, Prince George Parish have
Bargained and sold in Publick and open market and by these
Presents do sell allanat and convai three negroes called and
known by the names of Toney, Hanor, and Cate unto Needham Gaus
his heirs and assigns forever in consideration of six Hundred
pounds lawful of this Province the receipt of which I do
hereby acknowledge and the said Needham Gaus Exonerate and
discharged and will forever warrent and Defend the said negroes
from any Person or Persons whatsoever, and that the said
William Gaus have good right and Lawful authority to sell and
dispose of the same negroes at the time of sale as witness my
hand and seal this tenth day of March 1761.

The above is proof that William Gause of Prince George Parish, Craven County, S. C. was the father of Needham Gause (b. 1755-dp. 9-3-1794) of Brunswick County, North Carolina

Will of Needham Gause

Brunswick County Court House Southport, N. C. Deed Book B - page 65

In the name of God Amen. I Needham Gause, being in a low stste of health but of sound mind and memory, blessed be God for it, but calling to mind the mortality of the body, and that it is appointed for all persons once to die, do make this my last will and testament in manner and form following. That is to say, after all my just debts be paid, then I give and bequeath unto my loving wife, Hannah Gause, one negro wench named Lucy during her life and no longer, also all my stock of cattle which is in my own mark- except what cattle is known by my sons to be given to my daughter Elizabethm also one horse Selim, one mare and colt, mare named Light with all my stock

of hogs, sheep, and goats. One two year old mare named dailey and all my house hold furniture, except four beds with some furniture. Iten, I give and bequeath unto my son Needham Gause one negro fellow named Andrew, also one half or morty of any land which I now live on, beginning at the mouth of the Indigo Branch, running up the same to the head thereof, thense a paraleed line to the back line, thense to the Eastermost corner, thense down to the marsh, thense to the mouth of the Indigo Branch the beginning, also one half of my beach tract, and one half of all my tide marsh and islands, also one feather bed and furniture with my wearing apparel. Iten, I give and bequeath to my son William Gause, one negro wench named Sylvia, also 150 acres of land that is to say the lower half of my cowpen place on Cow-caw Swamp, one horse called Redhead with his cattle. Item, I give and bequeath unto my son John Gause, one negro fellow called Esaw, also 150 acres of land on Caw-caw Swamp, the upper part of my cowpen place, also one bed and furniture, with the cattle in his mark and brand. Item, I give and bequeath unto my daughter Elizabeth Gause one negro wench named Chloe, one feather bed and furniture, one mare named piggin, with all the cattle in my mark which is called hers and known by her brothers. Item, I give and bequeath unto my son Bryan Gause one negro named Cain, also at the death of his mother one negro wench named Lucy with her increase, also one half of my lands whereon I now live which is the remaining half or mority of the lands I gave my son Needham, also one half of my Beach tract with one half of my tide marsh and Islands, one two year old horse called Elmoder with his stock of cattle with his brand, also

one feather bed and furniture. Also my will and desire is that the above negroes given to my different children should be kept on the Plantation with my wife Hannah until she should marry or move away or if any of my children should marry, then their negroes to be given up to them, also my will is my wife Hannah, son Needham, and son Bryant shall pay all the just debts that I owe, and I do nominate and appoint my loving wife Hannah Gause Executrix and my son Needham Gause Executor to this my last will and testament, revoking all other wills- do acknowledge this to be my last will and testament. In witness whereof I have hereunto set my hand and affixed my seal the 23rd day of September, 1794.

According to tradition Needham's second wife was
Hannah Frink, daughter of Nicholas and Deborah Pendleton
Frink, who came to South Carolina to the Little River
section before 1735 from Connecticut. Nicholas and Deborah
Frink had two children after they came to S. C., Hannah
and Jabesh.

Andrew Gold was from Scotland and was planning to go back with his wife and baby when he took typhoid fever and died.

To the wonderful the Justices of the Court aforesaid the Petition of Bryan Gause Guardian of Eliza Gold daughter of Andrew L. Gold Deceased humbly showeth unto your worship that the said Andrew L. Gold died sometime in the year 1833 without making any last will and Testament leaving four negroes and some perishable property - the negroes were as follows, Julia Ann, Hagar, Peggy and York - that at December Ten 1833 of said Court letters of Administration on the Estate of said decd were granted to Bryan Gause, and that he was duly qualified as such - Your Petitioner further showeth unto your Worship that the said Administrator by the permission & order of the said Court sold the two following negroes to wit Peggy and Hagar to satisfy the demands against the said Estate the amt. owing for the sale of the perishable property being insufficient to liquidate the debts of said Dec^d - and that the Administrator has fully administered and settled with the Court, as will appear by the report of the Commissioners appointed for that purpose - Your Petitioner further states that there/two negroes named Julia Ann and York with fifty eight dollars and twenty five cents to be divided between the said minor Eliza Gold and Margaret the widow of the said deceased - and that Bryan Gause was appointed Guardian to the said minor at the present term of the Court - and qualified as such - Your Petitioner therefore prays Your Worship that you grant an order appointing three Lawful men commissioners to allot to your Petitioner two thirds of the above described property and one third to the widow of said deceased as the

Law directs - Your petitioner further showeth that the said Margaret Gold widow of the said Dec^d has since intermarried with Uriah Morse, your Petitioner therefore prays Your Wordhip to issue ----- of subpoena to the said Uriah Morse and Margaret his wife to make their appearance before this Worshipful Court and abide the decree made on the premises and your Petitioner will ever Pray etc.

State of North Carolina) We the undersigned subscribers Brunswick County having been summoned as a Jury by the sheriff of sd County to lay off one third part of a plantation or tract of land, lying in the County aforesaid Shallotte District belonging to the Estate of Andrew L. Gold Decd as Dower in said lands to the use of Margaret Morse wife of Uriah Morse and late widow of the said Andrew L. Gold Decd. We having met on the sd premises proceeded to lay of the sd third part in the following manner to wit beginning in the mouth of the Spring branch running thense N 15 w to the edge of the ridge on the South side of the big swamp thense eastwardly with the edge of the said ridge on the S. side of said swamp and with Henry Nutt's line one hundred and eight Poles, thense South fifteen east to a large creek the Southern Boundry of sd lands thense westwardly along the edge of sd creek one hundred. & eight Poles, thense North fifteen west to the beginning, the mansion or dwelling and necessary out houses are included on the sd. third part. Also the land adjoining the above and

lying between the above mentioned edge of the ridge and South side of sd big swamp, and the back or Public road or thereabouts, to be divided by straight lines running from the South side of sd big swamp towards the sd Public road in a northwardly direction to the back line so as to divide the sd land in three equal parts and the middle division is to the use of the sd Margaret wife of Uriah Morse as Dower in sd lands.
