

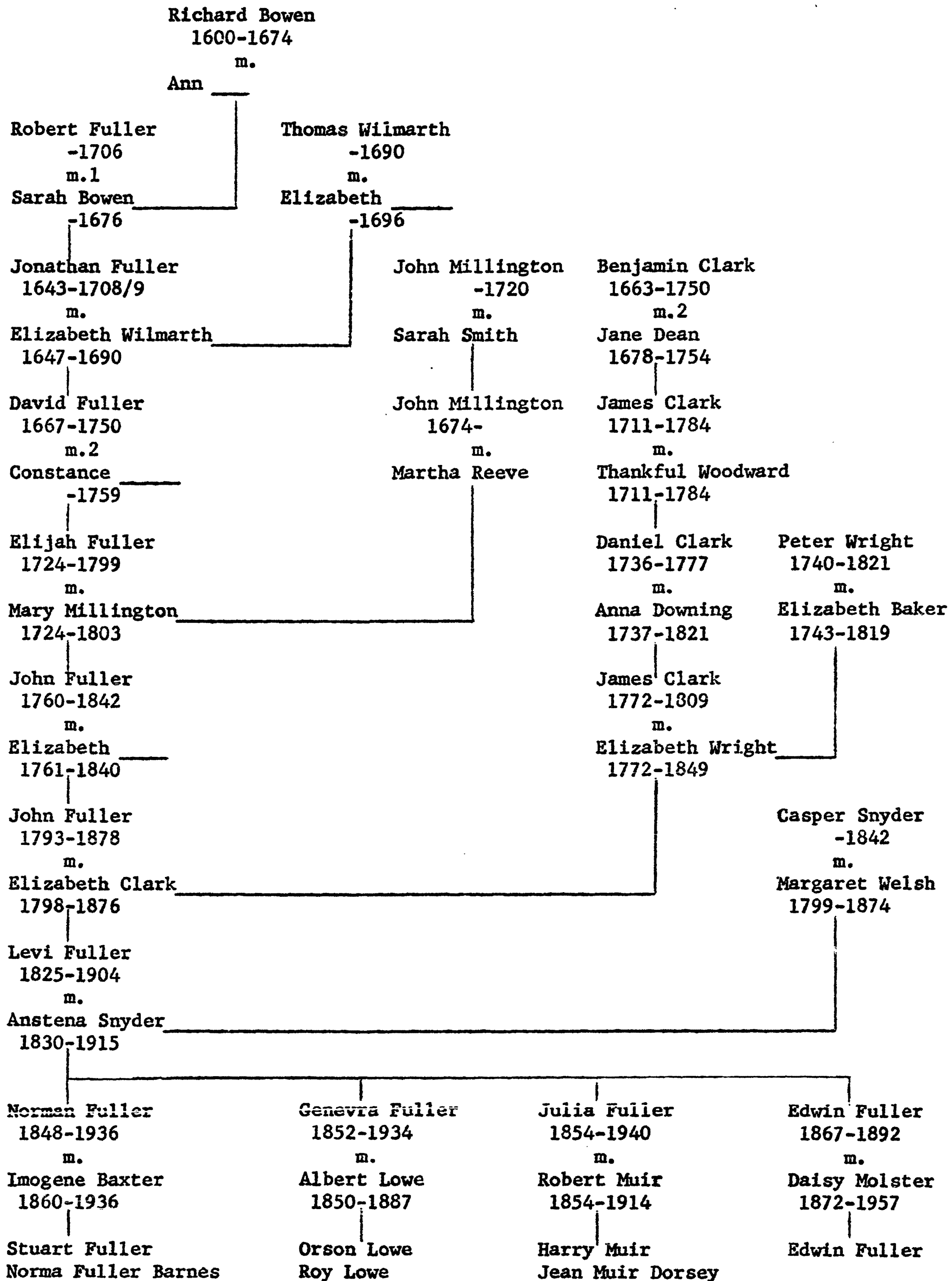

1. ROBERT¹ FULLER

b. in England; d. May 10, 1706, Rehoboth, Bristol County, Massachusetts.
Buried three miles from Seekonk. (Rehoboth Town Records)

m. (1) about 1642, Sarah Bowen, buried Oct. 14, 1676, Rehoboth, Mass.,
daughter of Richard Bowen, b. 1600 in Wales, buried Feb. 4, 1674, Rehoboth,
and wife, Ann, who came from Wales to Weymouth, Mass., in 1640,
and settled at Rehoboth, 1642. (Rehoboth Town Records) Thomas Bowen,
brother of Sarah, mentioned his brother-in-law, Robert Fuller, in his
will of 1663.

m(2) about 1678, Salem, Mass., widow Margaret (Felton) Waller, d. Jan.
30, 1700, Rehoboth, Mass. She appears as Margaret, wife of Robert Fuller,
in a Salem Court Record of June, 1680. (Essex Institute Hist. Collection
Vol. 69, p. 424)

Robert Fuller came from Southhampton, England, in the ship Bevis, in 1638,
and settled in Salem, Massachusetts. His name appears in a Salem Court Record of
November 18, 1639, when he requested a grant of 5 acres of land to plant. (Sidney
Perley, History of Salem, Vol. 2, pp. 74, 75)

He took a freeman's oath in Salem in 1640. On March 4, 1643/4, he was granted
twenty acres of land at Jeffry's Creek, if he dwell there, otherwise to desert the
land. He probably went away without coming into its possession. The next year he
and William Trask were appointed surveyors for North field by the town. (Ibid.,
Vol. 2, pp. 156, 160, 174)

Robert Fuller moved to Rehoboth about 1645, and returned to Salem in 1677. It
is said that he was the first and only bricklayer in New England for many years.
He purchased or held rights in land in Rehoboth as early as 1645, when his name
appears on the tax list of owners at a value of 150 pounds. On December 26, 1645,
Richard Wright was one of the seven townsmen in Rehoboth who declared "that the
house, lot, and land layed out to John Sutton was forfeited to the town." The pro-
perty was divided between Robert Fuller and William Devell. (Rehoboth Town Meetings
Bk. 1, p. 34)

On June 28, 1653, Robert Fuller signed a treaty to settle differences for Reho-
both with "Myles Standish capt: Thomas Willett and Josias Winslow." (Bristol Co.
Mass. Plymouth Colony Deeds, Vol. II, Pt. 1, p. 79)

He was one of the first proprietors in Rehoboth and drew shares in the general
division of land in 1658 and 1668. He was made a freeman in 1658. In 1673 he paid
a tax of 4 pounds, 10s, 3d, for the expense of King Philip's War. (G. H. Tilton,
History of Rehoboth, Mass., 1918) (James W. Arnold, Vital Records of Rehoboth, 1897)
(Richard L. Bowen, Early Rehoboth, Vol. III, 1948)

In 1676 the Indians attacked Rehoboth and burned the houses of the settlement. Robert Fuller lost his wife, his sons, John and Samuel Fuller, his son-in-law, Nehemiah Sabin, and his home. Following this disaster, he gave much of his property to his grandchildren and sons. Some of his property was held jointly with his son, Jonathan Fuller.

On October 26, 1676, Robert Fuller of Rehoboth deeded to his grandchild, John Fuller, son of John Fuller lately deceased, a tract of land upon the ten Mile River on the south side of Rehoboth when he comes to 21 years ... in interim land to go to my daughter-in-law, Abigail Fuller, late wife of deceased son, John Fuller. (Plymouth Colony Deeds IV, p. 61)

Soon after this he returned to Salem, where he was admitted by the Selectman of Salem as an inhabitant in 1677. On March 10, 1679, Robert Fuller of Rehoboth was admitted to the First Church in Salem. (Essex Institute Hist. Collections, Vol. 48, p. 230; Vol. 15, p. 78)

On May 20, 1679, Robert Fuller of Salem, deeded to his grandchild, Samuel Fuller, when he comes of age 21 years, a tract on the west side of Palmer's River in Rehoboth, Bristol County. He mentioned his daughter-in-law, Mary Redaway, who had married John Redaway after the death of her husband, Samuel Fuller. (Plymouth Colony Deeds IV, p. 263.) On December 1, 1679, he gave to his son, Benjamin Fuller of the town of Rehoboth, six acres of land and a dwelling on Mill River, and a number of other lots nearby, also 12 acres in the great plains and a part of his salt meadow, as well as lots in Rehoboth. (Bristol Co. Mass, Deeds 5, p. 68)

In September 1680 he took a freeman's oath in Salem, and in November 1682 he served on the Grand Jury. (Salem Quarterly Courts of Essex County, Vol. VIII, pp. 24, 43, 394) In 1683 his name appeared on the Tax List in Essex County. (Sidney Perley, History of Salem, Vol. 3, p. 422)

In 1682 Mr. Robert Fuller and Mr. Daniel Andrew were chosen and impowered to see the law concerning brick fully attended. On a number of occasions Robert Fuller received pay for work done on the Town House in Salem. On March 8, 1684, he witnessed the will of Anthony Buston and made an inventory of his estate. (Essex Institute Hist. Collection, Vol. 64, pp. 67, 205; Vol. 4, p. 65)

On July 26, 1687, Margaret Fuller, executrix of the last will of Christopher Waller of Salem, her former husband deceased, who had bequeathed to her his house and land, gave to Robert Fuller, her present husband, the dwelling house and out housing with ten acres of land called Leach. (Essex Co. Mass. Deeds 8, p. 5)

At the same time, Robert Fuller and his wife, Margaret, for love gave a ten acre lot to Mary Salmon, who had been adopted in childhood by Margaret Fuller before her marriage to Robert Fuller. (*Ibid.*, Deeds 8, p. 4)

On August 8, 1687, Robert Fuller of Salem and Margaret, his wife, transferred to Nathaniel Felton, yeoman, of same town, two acres of land. (*Ibid.*, Deeds 12, 36)

At a Town Meeting in Salem in 1691, Robert Fuller was chosen to serve on the Jury. When the assignment of seats was made in the Meeting House, Rob Fuller and Jer Meachem Senr. were seated directly behind the ministers. (Essex Institute Hist. Collection, Vol. 69, pp. 140, 147)

On March 30, 1697, Robert Fuller, bricklayer, of Salem, County of Essex, in New England, and Margaret Fuller, his wife, sold for 65 pounds to Lieut. Jacob Manning of Salem, Gunsmith, their homestead consisting of a dwelling house, barns, and ten acres of land, and also an adjoining tract known by the name of North Field, part of which is in orchard. (Essex Co. Mass. Deeds 11, p. 226)

Soon after this they moved to Rehoboth, Massachusetts, where Robert Fuller's two sons, Benjamin Fuller and Jonathan Fuller were then living. Apparently Robert Fuller divided all of his estate among his children before he died. No settlement of his estate has been found.

2. JONATHAN² FULLER (Robert¹)

- b. June 15, 1643, Salem, Mass.; d. Feb. 10, 1708/9, Attleboro, Mass.
 m. Dec. 14, 1664, Rehoboth, Mass., Elizabeth Wilmarth, b. Feb. 4, 1647, daughter of Thomas Wilmarth of Braintree, Mass., buried Oct. 4, 1690, Rehoboth, and Elizabeth Wilmarth buried there in 1696. (Braintree, Mass. Town Records; Rehoboth Town Records)

Jonathan Fuller, oldest son of Robert Fuller, went to Rehoboth, Massachusetts, about 1661, when the general division of land was made to the first settlers.

On May 28, 1669, he bought 3 acres of land at Wachemachett from John Sutton and wife. (Plymouth Colony Deeds III, Pt. 1, p. 146)

In 1674 he served as constable, and in 1676, he and his father, Robert Fuller, advanced money to the town of Rehoboth for support of the troops in King Philip's War. On November 1, 1686, Jonathan Fuller of Rehoboth bought 16 acres from Francis Stevens. (Bristol Co. Mass. Deeds 1, p. 54) On June 23, 1701, he conveyed 50 acres of land in Attleboro, Massachusetts on ten Mile River to his cousin, Abial Fuller of Plymouth County. (Bristol Co. Mass Deeds 3, p. 255½) On April 2, 1705, Jonathan Fuller, Rehoboth, yeoman, sold 24 acres to Benjamin Fuller of same town. (Bristol Co. Mass. Deeds 5, p. 67)

Jonathan Fuller died intestate in Attleborough, Massachusetts, His widow, Elizabeth Fuller, and son Noah Fuller, were granted letters of administration upon the estate of Jonathan Fuller on April 6, 1709. The bond was signed by Elizabeth Fuller (with her mark), Jonathan Fuller, David Fuller, and Noah Fuller. (Bristol Co. Mass. Probate Records) An account was presented by Elizabeth Fuller to the Probate Judge.

The inventory of his estate was made by Joseph Brown, David Jenckes, and Heziah Peck. It included wearing apparel, 2 bibles and other books, arms and ammunition, household goods, farm equipment, stock, home and homestead and lands. (Bristol Co. Mass. Inventory, Probate Records not recorded)

3. DAVID³ FULLER (Jonathan², Robert¹)

David Fuller lived in Rehoboth and Attleboro, Massachusetts, many years.

On March 3, 1716, David Fuller of Attleborough, County of Bristol, Massachusetts bought 93 acres of land from John Davis upon the Willimantic River in the Town of Coventry and the County of Hartford, Connecticut. (Bristol Co. Mass Deeds)

Soon after this he moved to Coventry, where he was chosen a Selectman. On March 12, 1735, he sold one home lot of 28½ acres to Daniel Roberson of Coventry. (Windham Co. Conn. Deeds) No settlement of his estate has been found.

4. ELIJAH⁴ FULLER (David³, Jonathan², Robert¹)

- b. Sept. 24, 1724, Coventry, Conn.; d. Apr. 8, 1799, Shaftsbury, Vt.
 m. Dec. 8, 1747, Coventry, Mary Millington, b. 1724, Conn.; d. May 16, 1803, daughter John and Martha(Reeve) Millington, Coventry, Conn.

Elijah Fuller lived in Coventry for about fifty years. All of his children were born there. On March 15, 1774, he sold 48 acres of land lying on the Willimantic River to Timothy Dimock of Coventry. (Windham Co. Conn. Deeds) A deed in the Town Clerk's office in South Shaftsbury, Vermont, dated May 16, 1774, shows that Elijah Fuller purchased 100 acres of land in Shaftsbury Township, Bennington County, Vermont. Soon after this the family moved to Vermont where other tracts of land were bought. A number of Elijah Fuller's married children went with them to Vermont. The Millington family and others went also. David Millington, a nephew of Mary (Millington) Fuller, was the first inventor of wax grafting; previously the only method was application of mud, swingling-tow and rags. For many years after he had perfected the system, the months of April and May witnessed an exodus of Shaftsbury grafters, 40-50 teams and 80-100 men annually throughout New England and some of the western states.

Elijah Fuller rendered service in the Revolutionary War in 1776, his name appearing on two payrolls of Captain Gideon Browson's Company, Green Mountain Boys. (Vt. Rolls of Soldiers in Revolutionary War, pp. 635, 832) The Bennington Chapter D.A.R. has marked the grave of Elijah as a Revolutionary soldier.

Elijah and Mary Fuller are buried in West Shaftsbury in a private burial ground in a mowing on the hillside a few rods south of Mr. Ed. Bouplon's house.

5. JOHN⁵ FULLER (Elijah⁴, David³, Jonathan², Robert¹)

b. Dec. 26, 1760, Coventry, Conn.; d. Feb. 14, 1842, South Shaftsbury, Vt.
m. Elizabeth _____, b. 1761; d. May 25, 1840. Both buried at Shaftsbury Center Cemetery.

The land records in the Town Clerk's office in South Shaftsbury show that John Fuller bought a number of parcels of land in West Shaftsbury. One deed in January 1828, shows that Seaman Wright conveyed to John Fuller 42 acres of land. This may have been the homestead of Peter Wright, where two of the sons, Nathaniel Fuller, and Josiah Fuller later lived. (See Wright Family Records)

A deed found in Cayuga County, New York, dated October 8, 1805, given by Samuel Cross of Shaftsbury, Bennington County, Vermont, to John Fuller of same place, indicates that John Fuller also owned land in New York State.

John Fuller rendered service in the Revolutionary War. His name appears on nine of the Bennington County pay-rolls. (Vt. Rolls of Soldiers in Rev. War, pp. 65, 126, 128, 336, 339, 484, 603, 608)

John Fuller died intestate, 1842. His son, Nathaniel Fuller, was appointed administrator, September 9, 1842. (Bennington Co. Vt., Probate Records 19, p. 374)

6. JOHN⁶ FULLER (John⁵, Elijah⁴, David³, Jonathan², Robert¹)

b. Aug. 15, 1793, Shaftsbury, Vt.; d. Jan. 23, 1878, Merton, Wisconsin
 m. Dec. 1816, Bennington, Vt., Elizabeth (Betsy) Clark, b. May 24, 1798,

After their marriage they went to Sennett, Cayuga, New York, where John's father had formerly purchased land. Many Vermont families were moving into New York at this time. All of their children were born here, and a number were married here.

In April 1842 their son-in-law, John Hall, and their daughter, Eliza Hall left New York to make their home in Waukesha, Wisconsin. A few years later, their third son, Levi Fuller, joined the Hall family in Wisconsin. A few years later, Elizabeth Fuller went to Wisconsin to visit her children and to see what the country was like. Shortly after she returned home, she and her husband sold their land and moved to Waukesha County, bringing their younger sons with them.

On March 28, 1856, John Fuller bought from Ralph B. Allen and wife Melinda, of the town of Merton, Waukesha County, Wisconsin, consideration \$6,500, the SE Quarter of Section 15 and that part of the east half of the NW Quarter of said Section 15 as lies south of the highway running through the same to Richmond's saw mill containing forty five acres, excepting and reserving the use of the spring near the house of Peter Weeks. (Waukesha Co. Wis. Deeds 18, p. 431) This land lay about three miles west of Merton, and near the John Hall farm. It also joined land bought by Levi Fuller. Here they built a spacious Colonial house, which is still standing. They later moved to the town of Merton, where they both died.

The will of John Fuller made March 19, 1877 left his estate to his granddaughter, Adelia Gillet and her husband, Joseph A. Gillet for the care of his son, John Wright Fuller as long as he lived. (Waukesha Co. Wis. Deeds 105, p. 279)

Levi Fuller left Sennett, New York, when a young man and bought 120 acres of wooded land near Ashippun, Dodge County, Wisconsin. While visiting his sister, Eliza Hall and her family near Merton, Wisconsin, he met Anstena Snyder and later married her. They went to live on his farm, where he cleared the land and built a one-room log cabin. Seven years later they sold this land to John Hayes, whose descendants still own it. On November 14, 1855, they bought a tract of 120 acres near Merton, Waukesha County, Wisconsin, from Adonirum Fisher and wife, Eliza, of Richland, New York. Later they added 40 acres to this. (Waukesha Co. Wis. Deeds 18, p. 241; Deeds 13, p. 435) This land adjoined his father, John Fuller's land. This land lay on Fisher Flats. They built a northern Colonial home on this farm, which is still standing. On June 29, 1888, they moved to Winnebago, Faribault County, Minnesota, where they had purchased 170 acres of land. They bought a house on Mill Street in Winnebago, where they retired from active work. For a number of years they made frequent trips to visit the relatives in Wisconsin, and many of the Wisconsin folks returned their visits. A close contact was maintained between the families as long as they lived.

Julia Fuller was educated in the schools of the day, and taught country school several terms before she was married.

Robert Muir was only three years old when his father died. He often told of taking his mother to church and how strict she was in the observance of Sunday. Church in those days was an all day affair and straight-back church seats grew very hard for young boys.

After attending country school, he entered Carrol College, Waukesha, Wisconsin, on January 1, 1874. His diary and papers show that he was especially interested in debates and politics. He was a member of several debating teams. Singing school and going to church were other activities he enjoyed.

On November 9, 1874, he passed the examination for a third grade certificate, and was licensed to teach in the County of Waukesha. He taught in a number of schools. In his diary he describes a trip by train to visit his brother, Dave Muir, in Hampton, Iowa. He was away from July 6, 1874 to the first of September.

Shortly before he was married, on February 25, 1878, he bought from Norman E. Fuller, 80 acres of Land on Fisher Flats adjoining the land owned by the Fuller family. This was where Robert and Julia Muir lived for a number of years. He continued his interest in the country schools and served as treasurer of the school district for a number of years.

They sold their land to Peter Lund on February 29, 1888. (Waukesha Co. Wis. Deeds 68, p. 640; 69, p. 206) On March 22, 1888, they moved to Winnebago, Minnesota, where they bought the Seth Austin farm, one mile south of Winnebago. After

living a few years in town, they moved to the farm. They built a new house, and added to their farm land by buying several adjoining tracts. Throughout his entire life, Robert Muir took an active part in community affairs.

In 1911, Robert and Julia Muir moved to Minneapolis. Their son, Harry Muir, and his bride, Florence Austin Muir, took over the management of the farm and are still living in the old home. This farm has been the home of the Muir family nearly seventy-five years.

Harry Muir was three years old when his parents moved from Waukesha County, Wisconsin, to Winnebago, Faribault County, Minnesota. He was graduated from Winnebago High School in 1902, and from the University of Minnesota in 1906. After his marriage in 1910, he lived on, and managed the farm south of Winnebago, purchased by his father, Robert J. Muir, in 1888.

In 1926 he was one of sixteen farmers, fourteen of whom were from Minnesota, and two from North Dakota, who were honored as "Master Farmers." They were entertained in St. Paul and presented with gold medals by "The Farmer", northwest agricultural publication, which sponsored the "Master Farmer" competition.

In 1933 he was appointed a member of the committee from the State of Minnesota to meet with a committee from other west states and Secretary of Agriculture, Henry Wallace, to formulate a National Agriculture Program.

Congress passed the Agriculture Adjustment Act and he was appointed as one of three members from the State of Minnesota to administer the program.

He served in this capacity from 1933 to 1938. Then he was appointed National director of the Farm Security Administration of Wisconsin, Michigan, and Minnesota, with offices in Milwaukee. He resigned this position in 1943 and returned to his home and other interests.

In addition to his local farm and stock corporations, he has been active in business and civic affairs of the community, where he has served as president of the Winnebago Farmer's Elevator, member of the Verona town board, officer of the Faribault County Farm Bureau, and president of the Winnebago Development Company.

On May 15, 1959, he was honored at a Kiwanis Club dinner for 50 years of public-spirited service in the community.

He was elected president of the First National Bank in Winnebago, January 17, 1961. He had been a director of the bank since 1914, served as vice president from 1938 to 1958, and been chairman of the board since 1959.

His wife, Florence Austin Muir, grew up on her parent's farm south of Winnebago. She was the daughter of Marion Austin, b. Dec. 28, 1858, Monroe, Wisconsin, son of Seth and Virginia (Wyatt) Austin, Monroe, Wisconsin, and Emma (Cotherman) Austin, b. Oct. 2, 1859, daughter of Samuel and Elizabeth (Bloom) Cotherman of Wisconsin and Winnebago, Minnesota. Seth Austin was the son of Elijah Austin, b. in Vermont, and Elizabeth (Watt) Austin. He served in the Civil War.

Florence Austin Muir graduated from Winnebago High School in 1906, and from the School of Agriculture, University of Minnesota in 1908.

BENJAMIN CLARK

Of Rhode Island and Connecticut
And Some of His Descendents

I. BENJAMIN¹ CLARK

b. 1663, place unknown; d. June, 1750 aged 87 years, South Plainfield, Windham County, Connecticut, (Tombstone Inscription, Fry Cemetery)
m. (1) c 1690 Kingstown, Rhode Island, Mercy Smith, d. c 1700, daughter of John Smith, d. 1677, and Margaret Smith of Prudence Island, R.I. Widow Margaret Smith, m.(2) John Snook and they moved to Kingstown before Sept. 6, 1687. It was here that Mercy Smith met Benjamin Clark. She was named in the will of her brother, Daniel Smith, made in Newport, R.I., May 13, 1695 and proved in East Greenwich, July, 1707. In his will he calls himself a mariner of Kingstown, R.I., and bequeaths to "my sister Mercy Clark, wife of Benjamin Clark of Kingstown, one-half of what was bequeathed me by my stepfather, John Snook, after my mother's decease." (John O. Austin, Genealogical Dictionary of Rhode Island, pp. 183,184) (The Shotwell Family Annals, p.35)

Benjamin Clark appears with a wife, Mercy (Mary) Clark, at Kingstown, Rhode Island, as early as 1691, when the records show that a daughter, Mary Clark, was born to them, January 24, 1691/2. (South Kingston R.I. Records)

On April 14, 1701, an indenture was made between Benjamin Clark of Kingston and Peter and Mary Lee who bound their son, William, to serve said Clarke unto the age of one and twenty, he being the age of six years said Clarke to have power to dispose of said lad, but not to send him out of New England. (North Kingston, R.I. Land Records, Bk. 2, p. 128)

Benjamin Clark, who called himself, carpenter of Kingstown of the Colony of Rhode Island, purchased 300 acres on the east side of the Quinnebaug River from Major James Fitch and his wife, Alice, of the town of Plainfield, Connecticut, on September 20, 1702 (Plainfield, Conn. Deeds 1, p. 38) On December 24, 1702, he was named among the freeholders residing on the east side of the Quinnebaug River in Plainfield, Connecticut. (New England Historical and Genealogical Reg. 15, p. 53, and Town Records of Plainfield)

Benjamin Clark, who was left with six young children when his first wife, Mercy (Smith) Clark died, soon married Jane (Jean) Dean. Benjamin Clark and Jane, his wife of Plainfield, were members of the first Baptist Church organized in North Kingston, Washington County, Rhode Island about the year 1710. A church

letter signed by Richard Sweet, Elder, North Kingston, January 17, 1730, states that they had been members upwards of Twenty years. (Original Church Letter was in possession of descendants of the family in New York City, 1938)

In a note book of Rev. Valentine Wightman, pastor of First Baptist church to be organized in Connecticut at Leyard, an entry stated that Benjamin and Samuel Clark of Preston, Connecticut, joined with him the year 1730 - which is the same year that Benjamin Clark withdrew from the Kingston church.

On September 12, 1733, Benjamin Clark of Plainfield, Connecticut, for parental love and affection conveyed to his son, Theophilus Clark of Canterbury, 100 acres, partly in Plainfield and partly in Canterbury. On January 2, 1743/44, he sold to James Clark of Plainfield, 100 acres, partly in Plainfield and party in Preston. Both deeds signed, Benjamin Clark. (Plainfield, Conn. Deeds, Bk. 3, pp. 132,172)

Benjamin Clark of Plainfield, County of Windham and Colony of Connecticut, yeoman, made his will January 13, 1743/44. It was proved July 3, 1750. He left the sum of five shillings to each of his sons, Benjamin Clark, Emanuel Clark, Samuel Clark, Jeremiah Clark, Theophilus Clark, and James Clark, and the same to each of his daughters, Mary Bennet, Sarah Page, Martha Aldridge, Ann Harrington, Hannah Stone, Rest Stone, and Abigail Dean, and the rest of his estate to his wife, Jean. His inventory presented June 22, 1750 mentions 13 sheep in the hands of Isaac Howard of Scituate, Rhode Island. (Plainfield, Conn. Probate Record Bk. 2, p. 111)

Jane Clark, widow of Benjamin Clark, late Plainfield, Windham County, Connecticut, made her will October 28, 1754, and it was proved December 10, 1754. She left her two sons, Theophilus Clark and James Clark five shillings each, and her daughters, Martha, Ann, Rest, Hannah, and Abigail, personalty and to her grandson, Isaac Parke, her grand daughters, Jane Parker, and Ann Harrington, personalty. She signed her will with her mark (Plainfield Conn., Probate Record Bk. 3, p. 19)

On November 12, 1755, the inventory of the estate of Mrs. Jean Clark, late of Plainfield deceased was recorded. James Clark settled the estate of his mother, and paid nine of her heirs taking receipts thereof. (Plainfield, Conn. Probate Bk.3, p. 19)

Benjamin and Jane (Jean) Clark lived in Plainfield over forty years. They are both buried in the old Fry cemetery, which is located on the Joseph Roode farm near Plainfield. This farm is now owned by his descendants. It lies back in the woods south of the road running between Plainfield and Jewett City. The cemetery which was visited in August, 1936, was enclosed with a high stone wall. It was overgrown with trees and bushes. Some of these were cut down around the two graves so that the inscriptions could be read and pictures taken of the stones.

The tombstones were large slabs of native stone with fairly good lettering. Jean was the spelling used on the headstone of Jane (Jean) Clark.

James Clark lived near Plainfield, Connecticut, although he is spoken of in deeds as of Preston. He was probably a farmer and lived on land lying between the two places, which were only about 12 miles apart. He received a deed of 100 acres from his father lying partly in Plainfield and partly in Preston on January 2, 1733. Land records show that he bought many small tracts of land between the years 1733 and 1777. (Plainfield Conn. Land Records Bk. 3, p.172)

The probate records of the Towns of Plainfield, Preston and Norwich show that he often acted as executor or administrator of estates of deceased persons. On April 26, 1760, Sarah Clark, Preston, widow of Jeremiah Clark, late of Preston, appointed her brother-in-law, James Clark to be sole executor. (Norwich, Conn. Probate Records Bk. 2, p. 503)

James Clark moved to Shaftsbury, Vermont, soon after 1777, where his son, Jeremiah had settled and where his son, Daniel Clark owned land.

James Clark died intestate. The inventory of his estate recorded in 1794 shows that he had a farm containing 41 acres with buildings valued at 279 pounds. Children named in the division of his estate were his son, Jeremiah Clark, daughters Lois, wife of Matthais Cobb, Peace, wife of Amos Huntington, Eunice, wife of Thomas McFarland, Haverhill, Massachusetts, and the ten children of his deceased son, Daniel Clark, each of whom received a tenth of their father's portion.

(Bennington Co. Vt. Probate Records)

Daniel Clark served in the French and Indian Wars, in Capt. Nathan Leonard's Company, which marched for the relief of Fort William Henry in August, 1757. (French and Indian War Rolls of Conn. Vol. 1, p. 232) Captain Benjamin Lee of Plainfield commanded the Seventh Conn. Co. in 1758. His report was made at Fort Edward, Oct. 19, 1758, and it shows that Daniel Clark was one of the company, and was sick in the hospital. (Ibid., Vol. 2, p. 64)

In 1765, Daniel Clark of Preston was mentioned in Plainfield's Town affairs as a new and helpful citizen. In 1766 a committee was appointed to lay out school districts. Daniel Clark and Jonathan Woodward were appointed on a committee, one for each district, to see that the schools were kept open. (E.D. Larned, History of Windham Co., 1880, Bk. 5, pp. 72, 75)

On Sept. 5, 1768, Daniel Clark and his wife, Anna, signed the covenant of the First Church of Plainfield.

Daniel Clark of Plainfield, Windham County, Connecticut sold 15½ acres of land to his brother, James Clark on January 17, 1767. (Plainfield, Conn. Deeds)


Daniel Clark of Plainfield, Connecticut served in Capt. William Belcher's Company on the alarm of April 19, 1775. He was 1st Lieutenant of Sage's Connecticut State Regiment, January to December, 1776; 1st Lieutenant of Latimer's Regiment Connecticut Militia, August 24, 1777; as Captain he commanded a detached Company of 56 men from August 24 to September 19, 1777; died September 21, 1777 of wounds received in the Battle of Stillwater, New York, September 19, 1777.

(Conn. Revolutionary War Records, pp.20,507)

A small leather-covered, trunk-shaped box, about 10 inches long, three inches wide and two inches deep, with a lock and key, that belonged to Captain Daniel Clark during the war was in possession of the family in Vermont. This was used for carrying money and at one time he swam across the Hudson River carrying this full of silver dollars to pay the soldiers in his company.

Daniel Clark had purchased a farm in the New Hampshire Grants before 1776, and placed his wife's father and mother, David and Anna Downing, in charge. After his estate was settled at Plainfield, his widow and children joined her parents at Bennington, Vermont. Several of the children went to the adjoining town of Shaftsbury to be near their uncle, Major Jeremiah Clark, and while there, Jeremiah's son Reuben Clark, age 20 years and Capt. Daniel Clark's son, Amos, age 13 years, were accidentally drowned together in the Waloomsac River, May 17, 1787.

Thomas Moffit, Benjamin Coit and Stephen Clark were appointed, July 7, 1778, to distribute the estate of Capt. Daniel Clark of Plainfield deceased. The heirs named were the widow, Anna Clark, sons Daniel Clark, David Clark, James Clark, Amos Clark, and George Washington Clark; daughters, Mary Clark, Esther Clark, Thankful Sunderland, Hannah Clark, and Anna Clark. (Plainfield, Conn. Probate Records 6, p. 534)

James Clark was a farmer at Bennington, Vermont, where he owned about 180 acres of land, which originally belonged to his father. He was a highway surveyor in 1795, 1799, and 1801, and served as selectman from 1804 to 1806. He was made freeman September 2, 1794, at Bennington. (Bennington, Vt. Town Records)

James Clark died intestate on February 6, 1809. Charles Dyer was appointed administrator of his estate and Elizabeth Clark served as administratrix.

The inventory shows that James Clark died possessed of four horses, all kinds of farm equipment, a well-furnished house, 202½ acres of land with buildings, and also 43 acres in Danville, Vermont.

On April 3, 1809, license was granted Charles Dyer to sell so much of the real estate as will pay the debts and provide support for the widow and children under 7 years of age. (Bennington Co. Vt. Probate Court Records 5, p. 314)

After Elizabeth (Wright) Clark married John Eldridge, they lived for a time in Pittstown, New York, a short distance west of Bennington, Vermont. (Bennington Co. Vt. Deeds 26, p. 381) Later they moved to Castile, Wyoming County, New York

Peter Wright was living in North Kingston, Rhode Island, as early as 1760, when he was listed as one of the rateable polls. (North Kingston Tax Record, 1760, Rhode Island State Archives)

Peter Wright and his wife, Elizabeth, were members of the Six Principle Baptist Church of North Kingston. Peter Wright signed the covenant on March 31, 1770, and Elizabeth Wright signed it on July 3, 1776. (J.N. Arnold, Vital Records of Rhode Island Town and Church, Vol. 8, pp. 286, 289)

The 1774 census of Rhode Island shows Peter Wright as living in North Kingston and having a family of twelve, seven males and five females. (North Kingston Census of 1774, Newport Historical Society, R.I.)

The Rhode Island war records show that Peter Wright was chosen Captain of the First Company, North Kingston Militia, on December 23, 1776. In August, 1777, he was appointed one of the recruiting officers of North Kingston. In May 1778, he served on a committee to check war supplies in North Kingston. (Colonial Records State of Rhode Island, VIII, pp. 73,299,392,414)

Peter Wright moved to West Shaftsbury, Bennington County, Vermont, some time between May 1778 and March 1779, since his son Joseph Wright was born in Shaftsbury, March 24, 1779. In 1779 Peter Wright bought the land confiscated from John Munro, the so-called Tory, and one of the first three settlers in West Shaftsbury.

The Vermont records show that Peter Wright continued to serve in the army in Vermont between 1780 and 1784. (Vt. Rolls of Soldiers in Revolutionary War, pp. 240, 398,805)

During the years 1781-1783; 1794-1798, Peter Wright of Shaftsbury, Bennington County, Vermont, was a representative in the General Assembly of the State of Vermont. (Records of General Assembly, Vermont State Library)

In 1786 he was Justice of the Peace for Bennington County. (Assembly Journal and Proc. State Papers of Vt., Vol. 3, p. 233)

Peter Wright was deacon of the White Creek Baptist Church. He gave the land on which the church was built and his name appeared on the deed, 1783. The church was founded by Elder Waite. In his will, Peter Wright gave to his sons, Joseph, Peter, and Seaman. "the right I own in a pew in the meeting house in the Center of the Town of Shaftsbury, and also the stall in the shed. And likewise the right I own in the Little White Meeting House to wit, one entire pew No. 2 on the broad alley, and half a pew in company with James Sweet, to use, occupy and improve the same equally between Them."

In 1801, Peter Wright built a large Colonial house which is still standing. The land of Peter Wright lies in the northwest corner of Shaftsbury Township.

Peter Wright distributed much of his estate among his sons and daughters during his lifetime. On April 13, 1804, he deeded to his sons, Joseph Wright, Peter Wright, Jr., and Seaman Wright, 130 acres of the west portion of the farm together

with a small house and smith shops situated thereon, also 62 acres of the northeast section of the farm, also one equal half part of the house in which he then lived. (Bennington Co. Vt. Deeds)

Peter Wright's will dated April 10, 1808 and probated September 5, 1821, provides for his wife during her natural life. He then states that he had made gifts of money to his several children before the making of his will: To son John Wright, \$1,300; to sons, Samuel Wright, Daniel Wright, Joseph Wright, Peter Wright, and Seaman Wright, \$1,000 each; and to each of the five daughters, Susanna, Hannah, Mary, Deborah and Elizabeth Wright, \$200. Then after putting the care and maintenance of his wife upon the three sons, Joseph, Peter and Seaman, he left to them all the rest of his estate and named them executors.

In January 1828, Seaman Wright conveyed 42 acres of land to John Fuller. This may have been the old Peter Wright homestead which was built in 1801, and which came into possession of the Fuller family.
