#### PREFACE

In preparing this record of the Fowler family I have consulted every English authority available, either here or at Boston, and have fully satisfied myself that the Henry Fowler Line is an entirely separate and distinct line from that of the three brothers, William of Milford, 1639, Joseph of Maspeth-Kill (Newtown), 1656, and Richard of Rye, 1662. A list of the authorities will be found in a bibliography at the end.

As to the question of Arms, it is stated in the *Miscellanea Gencalogica et Heraldica*, N. S. Vol. III, p. 345, that from 1400 to 1520 the Fowlers used the Arms of John Barton of Castle House, Co. Bucks, whose sole daughter and heiress married Henry Fowler of Foxley, Co. Bucks, about 1400. In 1520 Henry VIII granted Sir Richard Fowler the younger, of Rycote, Co. Oxford, the Arms now used by the Fowlers of Rycote, Bromehill, St. Thomas, Harnage Grange, Pendeford, Hambleton, Dalbury Lees, and Bisley. The Stonehouse Fowlers received a special grant.

Abraham Fowler, son of Rev. Richard Fowler of Barthomley, Co. Chester, and grandson of Wm. Fowler of Dalbury Lees, living at Salt, Pirehill Hundred, Staffordshire, April 1663, presented the Rycote Arms, viz: "Azure, on a chevron argent, between three lions passant guardant or: as many crosses formee sable" as those borne by his father and grandfather, but could not go any further back. William Salt Archaeological Society Publications, Vol. 5, Part 2, p. 140. Dugdale made the following note: "question of Arms respited for further proof." Mr. William F. Carter in Notes and Queries of Gloucestershire, Parts 7, 9, 12, 14, 15, 16, 18, 19, 20, has settled nearly all the disputed points in the Fowler Pedigree and this among them. It was the rule then, that the

person bearing a certain Coat-of-Arms must either produce a certificate or grant to himself or his immediate progenitor, or else show that they had been borne by his direct lineal ancestors for at least four consecutive generations.

The statement in Burke's Extinct Baronetage, p. 208, that the Fowlers trace their origin to Sir Richard Fowler, Knt, of Foxley, Co. Bucks, who accompanied Richard Cœur de Lion to Palestine and was Knighted by Richard at Acre in 1192, is a very pleasing tradition, but one for which no authority whatever exists. No such name appears in any list of Knights who accompanied Richard and Philip Augustus of France to Palestine in 1190, and, furthermore, Lipscombe's Buckinghamshire distinctly shows that no such place as Foxley existed in Bucks in 1190. Foxley was in Berks, and belonged to the Foxley family and after the marriage of John Fowler with Isabel Foxley, his great grandson, John, acquired an estate in Bucks about 1380 which he named "Foxley" after his ancestor's Manor in Berks.

## The Fowler Family

- I. REGINALDUS LE FOWLER, of Shryvenham, Co. Berks, is the first one of the line that can be definitely located. He d. 29 Edward I, 1301. In the Calendarium Genealogicum Henry III and Edward I., Master of the Rolls, Vol. 2, p. 602, we find the following: "Reginaldus Le Fowler de Shryvenham. Inquisition Post mortem: Johannes Le Fowler de Shryvenham filius prædicti Reginaldi est propinquior haeres ejus, et est ætatis triginta duorum annorum amplius, 29 Edward 1, 1301. Berks."
- II. JOHANNES LE FOWLER, b. at Shryvenham before 1269, was 32 years old at his father's death. We know nothing further of this man. His son
- III. JOHN LE FOWLER or FOWLER, of Shryvenham, m. about 1315, Isabel, daughter of Sir Thomas Foxley of Foxley, Co. Berks, who purchased Foxley Manor from Sir Ralph Dayrell in 1314. Sir Thomas de Foxley, Knt. of Foxley, Co. Berks, and Bramhill, Co. Hants, was M. P. for Berks, 1 Edward III, 1327-28; 11 Edward III, 1337-38; d. 1360, aged 55. His son, Sir John de Foxley, Knt, b. 1330, aged 30, 34 Edward III, 1360-61; M. P. for Hants, 38 Edward III, 1364-65; for Berks, 43 Edward III, 1369-70; for Hants and Berks, 47 Edward III, 1373-74; d. in Nov., 1378; will dated 5 Nov., 1378, proved at Southwark, 1 Dec., 1378; m. (1) Matilda, daughter of Sir John Brocas, of Beaurepere, Co. Hants, and had: 1. William; 2. Katharine (m. John Warbleton and had: Elizabeth who m. John Syferwaste and had: Margaret who m. Robert Breknoke, (see No. VIII, page 13); 3. Margaret, m. David Bullock; Sir John Foxley, m. (2) Joan Martin, and had: 1. Richard, d. s. p., 1408; 2. Thomas who m. Theobolda

- Marys; 3. John, m. his cousin, Isabel Fowler (see below). Topographist and Genealogist, Vol. III, p. 178-80. John Fowler had issue:
- и John, son and heir (see No. IV.)
- 2 Isabel, m. her cousin John Foxley, Jr., (see above) who d. in 1420, leaving one daughter, Alice.
- IV. JOHN FOWLER, (3d), of Shryvenham, b. before 1320. Mentioned in the will of Richard de Hartlegh (evidently his brother-in-law), Marshal and Citizen of London, who lived in the Parish of St. Sepulchre-without-Newgate. Will dated April 23d, 1361; entered on Roll 89, folio 68, Husting's Court of London, who makes among other bequests, 100 Geneva Florins (Florenosde Genevyns) to brother John Fowler to assist him in finding his (John's) son, if living. John had issue: Calendar of Ancient Wills, London, Vol. 2, p. 21.
- i John (see No. V.)
- 2 ROBERT, of Bray, Co. Berks, who d. in 1400. Wife's name, Agnes. A monument to this pair is still to be seen in the church of Bray, on which is inscribed, "Orate pro Animabus Roberti Fowler et Agnetis uxoris ac omnium fidelium defunctorum qui quidem. Robertus Obitt. Die Mensis . . . Anno Dni Millo MCCCC. Quorum Animabus pro propicietur Deus. Amen," and below are figures of 5 sons and 5 daughters. Ashmole's Berkshire, Vol. III. p. 16.
- V. JOHN FOWLER, (4th), of Shryvenham, Co. Berks, b. about 1350, acquired an estate in Bucks which he named Foxley; m. after 1375 and before 1380, Margaret, daughter of Henry Loveday, and d. in the reign of Henry IV, leaving a son and heir
- 1 HENRY (see No. VI.)
- 2 John, of Bray, Co. Berks. Wife's name, Alice. Their monument in the church at Bray, reads as follows:

- "Pray for the Soules of John Fowler and Alice his wife, which John decessed the 24 day of August in the yere of Our Lord 1479, on whose Soules Jesus have Mercy." Ashmole's *Berkshire*, Vol. III. p. 7.
- VI. HENRY FOWLER, of Foxley, b. before 1380; m. before 1400, Isabel, daughter and heiress of John Barton of Castle House, Co. Bucks, Lipscombe's *Buckinghampshire*, Vol. 2, p. 569, and used the Barton Arms as those of Fowler as did his heirs until 1520, viz: Ermine on a canton, gules, an owl argent. Had:
- I WILLIAM (see No. VII.)
- 2 John, settled in London, was an Alderman there, m. Alice of —. Their monument is still to be seen in the church the Grey Friars: "Johnannes Fowler civis et pellepar ij (sic), London. Alic ux ejus cu liberis Suis. Johannes Obitt 2d Jany, 1494: Alice Obitt 6 April 1490." Collectanea Topographica et Genealogica, Vol. 5, p. 285.
- 3 Walter, Bishop of Norwich, mentioned in his nephew Richard's will, 1477.
- 4 Sybell, m. to Richard Quartermayne, mentioned in nephew Richard's will.
- 5 Isabel, m. Henry Shatterbrooke, mentioned in nephew Richard's will.
- VII. SIR WILLIAM FOWLER, of Foxley and Castle House, b. about 1400; m. Cecelia, daughter and heiress of Nicholas Englesfield of Rycote, Co. Oxford, by Johanna, daughter of Nicholas Clark of Rycote, Co. Oxford, by Catharine, daughter and heiress of John Rycote, of Rycote, by Elizabeth, daughter and heiress of John Gernon of Wiltshire. Sir William was dead before 1470, (buried in St. Dunstan Chapel, Westminster Abbey) having had
- I SIR RICHARD, b. probably about 1420-22. M. P. for Oxford, 1467. Knighted by Edward IV, 1467, and made his Chancellor for the Duchy of Lancaster. He m. Joan,

daughter of Sir John Danvers of Calthorpe, Co. Oxford, and d. 3 Nov., 1477; will dated Oct. 10, 1477, proved 19 Nov., 1477, directs that masses shall be sung for the repose of his soul, and his father's soul, and his mother's soul for seven years: and that if mass is said by a deacon he shall have 5 marks; if by a priest 10 marks; states that his father lies buried in the chapel of St. Dunstan in Westminster Abbey: names his uncle Walter, Bishop of Norwich; Aunts Isabell Shatterbrooke and Sybell Quartermayne; brothers Walter, Henry, Thomas and William: sisters Sybell Danvers and Alice Rookes; daughter Sybell Chamberlain; daughter Jean to marry Edward Stradling his ward, now aged 15; son Richard, son Edmund; mentions his manors of Rycote, Castle House, Shobendon, Water Stratford, Stokholt, Stutely, Bourton, Mourton, Foscote, and Shaller. He was also seized of the Manor of Stanton Berry, Newport Hundred, by special grant of Edward IV, in 1467.

Sir Richard was a very generous benefactor to the church of St. Peter and St. Paul, at Sutton-cum-Buckingham, and in 1470 he added the very large cross aisle, 90 ft. long, to the church. Lipscombe's *Buckinghamshire*, Vol. 2, pp. 577-78.

There is now in the British Museum, London, Addition Charter, No. 20, 321, dated June 28, 27 Henry VI (1449), to which is attached the seal of Sir Richard Fowler, Knt, as Chancellor of the Duchy of Lancaster. (See opposite page.)

Sir Richard evidently took his Seal from the Rycote Arms, viz: "Argent three wolves heads, erased, gules," his father having married the heiress of Rycote and brought that estate into the Fowler family.

This seal proves conclusively that the commission given by Edward IV to Sir Richard, confering upon him the Chancellorship was not an *original* one but the renewal of a *former* one issued by Henry IV. *Miscellanea Genealogica et Heraldica*, New Series, Vol. III, p. 345. Sir Richard had issue:

- I Sir Richard, b. about 1460, who inherited Rycote, Foxley and most of the other Manors; called "Sir Richard the Foolish," as he was a great spendthrift, and lost nearly all of his estate. He m.   - 4 Bridget, m. Robert Hogan.
  - Sir Richard, m. (2) Juliana, daughter of Sir John Shaa, Alderman of London, and died in 1528. In 1520, he

received from Henry VIII a grant of the following Arms: Azure, on a chevron, argent, between three lions passant, guardant, or, as many crosses moline sable. These arms can still be seen on his tomb in Trinity Church, London. In the *Miscellanea Genealogica et Heraldica*, Vol. 3, New Series, p. 345, it is stated that prior to this time the Fowlers used the Arms of Barton, having none of their own. Isabel Barton who m. Henry Fowler of Foxley (see No. VI, p. 6), having been an heiress. Sir Richard Fowler by 2d wife had:

- VIII. WILLIAM FOWLER, was b. in Foxley, Co. Bucks, about 1445. The only thing about him we know of, is, that he was a joint tenant or owner of the Manor of Cleware, Co. Berks, which formerly belonged to his ancestor, Sir John Foxley, of Foxley, and by him willed to his daughter Katharine who m. John Warbleton and who in turn passed it to their daughter Elizabeth who m. John Syferwaste and they in turn passed it to their daughter and co-heiress Margaret who m. David Breknoke (see No. III), and had two sons, John and Richard. The two following

papers tell the story: I Calendar of Ancient Deeds, Vol. 2, B. 3690. p. 430. "Grant by Margaret, late wife of David Breknoke, deceased, and daughter, and co-heiress of John Syferwaste, to Richard Fowler, Thomas Fowler, William Fowler, Richard Chamberlaine, Thomas Rookes, Thomas Danvers and John Breknoke; of a moiety of Cleware Manor, Co. Berks: also Letter of Atty. to Thomas Wellesbourne, John Blackpall and William Rabbes, to deliver seisin of the same, 5 March, 16 Edward IV, 1475." Vol. I, B. 1112, p. 320, some of the above mentioned parties transfered their interest to Richard Breknoke. "Demise by Richard Chamberlaine, Thomas Fowler, Thomas Danvers and John Breknoke and Elizabeth his wife, to Richard Breknoke, brother of said John, of a moiety of the Manor of Cleware, Co. Berks, which they had of the late Margaret Breknoke, widow of David Breknoke, one of the daughters and co-heiresses of John Syferwaste, dated 9 May, 1 Henry VII, 1485." Vol. I, B. 1454, p. 354, we find the following: "Letter of Attorney issued by Thomas Broune, Clerk, to William Fowler and Nicholas Basewyk, joint tenants, to deliver to John Cotesmour Seisin of the Manor of Eselburgh, Co. Bucks, dated 16 May, 8 Henry VII, 1492." This William Fowler had issue, two sons and one daughter. He was also of Hambledon, Co. Rutland, in 1500. Mis. Gen. et Her., N. S., Vol. I, p. 450.

- X. THOMAS FOWLER, of Bisley, was probably b. there before 1520, as the Harmans, his mother's family, were natives of Bisley. We do not know whom he married or how many children he had altogether. The only three we have been enabled to identify are:

Salt, Archaeoligical Journal, Staffordshire, p. 38: "Octave of St. Michael, 10 James I, 1612, William Webb the younger, Humphrey Chritchley and Alice his wife; John Fowler and Frances his wife, Complainants, and Richard Webb and Isabella his wife, defendants. Amicable suit to transfer to complainant's lawful heirs of William Webb, Sr., all right, title and interest in and to 3 cottages, 3 gardens, 4 acres of meadow, 30 acres of pasture in Pipe Ediall and Burntwood for the consideration of £41." William Webb, Sr., also had a son Joseph who m. Mary, daughter of William Amphlet. Mr. Fowler d. in 1645; will proved by son Joseph who was sole executor; it is dated 20 June, 1639; proved in London, 1645, mentions wife Frances, son William, not then in England, son Joseph to whom he leaves the lands bought from his brother Henry, daughter Anne, wife of William Brown, son Richard, niece Rebecca, orphan daughter of brother William, daughters Isabel, Margaret, Alice and Judith; son Joseph, sole executor. His issue were:

XIII. JOSEPH FOWLER, was b. in Dalbury Lees, in Derbyshire, before 1610; under the will of his father he inherited the lands which the latter bought of his (John's) brother, Henry Fowler of Barthomley, Co. Chester. Mr. Fowler was in London in 1645, as he proved his father's will there in the Prerogative Court of Canterbury. He and his brother Richard came to New England about 1650, and are said to have first located in Rhode Island. There may be some probability in this statement as most of the early settlers of Newton, Flushing, Hempstead and Oyster Bay were from that Colony. He was in Maspeth Kill, now Newtown (Riker's Newtown, p. 38), in 1655; taxed £1 in 1656 for 20 acres at Middlebury; Dec, 12, 1657, he signed the remonstrance to the Governor of New York, protesting against the injustice to the Quakers. In the Town Records of Newtown, Book I, p. 452, is a deed from Joseph Fowler of Maspeth Kills to Robert Jackson of Hempstead for 40 acres at Middlebury, which the said Fowler purchased from his brother-in-law Richard Betts; said deed is dated April 10, 1660. Aug. 10, 1654, ordered on petition of Thomas Wandell to stay execution until Joseph Fowler appear to defend himself (Dutch His. Mss., Albany, Vol. 5, p. 322); Nov. 25, 1654, authorizing the inhabitants of Maspeth to notify Joseph Fowler to quit that place, he being a public disturber, and in case he refuse to have him arrested (Dutch His. Mss., Albany, Vol. 5, p. 444); June 4, 1655, attachment issued against the person and property of Joseph Fowler of Maspeth, at the suit of Thomas Wandell (Dutch His. Mss., Vol. VI, p. 51); Oct. 8, 1655, affidavit of Joseph Safford and Thomas Read of Maspeth Kill

that they have been informed by Joseph Fowler, Goodman Betts and his son William, that people from Gravesend had been to Westchester where they learned the unfriendly feeling of the Indians towards the Dutch (*Dutch His. Mss.*, Vol. VI, p. 91); Jan. 2, 1657, testimony of Joseph Fowler and Hannah Bradish in the petition of John George Baldwin for a divorce from his wife on the grounds of adultery (*Dutch His. Mss.*, Vol. 8, p. 417).

In the tax list of Flushing, 1698, we find William Fowler and wife Mary, sons William, John, Joseph, Benjamin, daughters Mary and Rebecca, negro boy Jack. Mr. Fowler m.
