#### GILES GODDARD.

On April 28th, 1680, Giles Goddard testified that he was then about thirty-two years old, hence he was born around the year 1648.

Giles Goddard was the immigrant, based upon the fact that Rose Collens heard him state that his master in old England owned a ring bearing a certain "posey."

Giles Goddard was in Boston, Mass. as early as the year 1678. On March 26th, 1685, he was living in Pemaguid, Maine.

Joseph Weeden testified that he saw Giles Goddard, Carpenter, at Nevis in the year 1683, and Thomas Price also testified that he saw Giles Goddard at Nevis in August or September of the year 1682.

Giles Goddard was a commissioner in Maine, in 1685. The Colonial Records of New York, at Albany, develope Giles Goddard in Cornwall County, between Saint Croix and Kennebec, in 1683, and as the settlement was under New York jurisdiction in the days of Andros and entitled to one representative in the General Assembly, Giles Goddard was chosen representative and carrying two petitions from Pemaquid, Maine and dependencies, was ordered to wait till the governor could visit Pemaquid at leisure. Andros did indeed visit Pemaquid, but as a refugee. Giles Goddard held commission as lieutenant of a military iss company in Cornwall County, in 1684. He was a commissioner to settle small causes, like the justice of the peace of to-day. He was captain of a foot company in New Dartmouth, Cornwall

County, October 22nd, 1684; also a surveyor and from James 11, held a commission, 1686, as justice of the peace.

Due to severe trouble with the Indians at Pemaguid, everybody left, and the Indians eventually completely destroyed the settlement of Pemaguid.

We again find Giles Goddard in Boston, Mass., taxed in 1691, 1695 and 1698. On October 1st, 1694, Giles Goddard, carpenter, bought from Nathaniel Newdigate of Boston, merchant, and wife, Sarah, for forty-five pounds, a tenement known by the name of Springhome Yard, with land, at the entrance of Sudbury Lane and near the orchard of Nathaniel Lynde; the front being of a circular shape, varying in breadth between forty-four geet and one hundred and nine feet, and all of the houses upon it, one part of the estate of Samuel Lynde, deceased, given to Newdigate's wife, Sarah, This property, Riles Goddard held till 1711, and then sold to Samuel Belknap of Boston.

Suffolk 22: 202: Henry Gibbs, late citizen of London, called planter, now of Boston, Mass., sold in 1701, on a mortgage, his estate to Thomas Child of Boston, a painter, sixteen acres in Roxbury, Mass., and buildings. It was bounded by land of Samuel Payson, Dorchester line, a highway from Roxbury to Fresh Meadow, and the highway to Dorchester from Fresh Meadow. Renewing a right of redemption in 1703, Child got the land by default of Gibbs, and ejected him in 1704, and it was sold to Giles Goddard for 16, 19s, 8d on March 17th.

Suffolk 22: 374: May 24th, 1705William Charter of Newport, a joiner, and wife, Anne, the eldest daughter of Joseph Goad, sold to Giles Goddard, of Boston, for sixty pounds, Anne's share of her father's estate, 1685 division, consisting of a barn, old orchard, swamp and meadow, bounded by land of Deacon Samuel Williams and Stephen Williams, etc., with the widow's thirds, adjoining seven acres in Roxbury.

Suffolk 30: 51: October 5th, 1715, William Whitcomb, upholster, of Boston, for fifty pounds, sold to Giles Goddard, housewright; William Young, glazier and William Hoar, bricklayer, and John Thompson, bricklayer, a mortgage on an estate in Beacon Street, The discharge has not been found.

Giles Goddard seems to have lived in Boston, Mass. until about the latter part of his life, and only by probate do we know that he had a son, John, called Captain of Roxbury, who administered his estate, June 9th, 1729, Suffolk 34: 181: with a small personal estate in the inventory.

Giles Goddard married Mary \_\_\_\_\_\_, and he also married again. He is recorded in the Presbyterian returns as marrting Lydia Chapin, in Boston, Mass., on August 2nd, 1721. In 1738, the estate was not settledin full.

He gave by deed "for love and good will," to his grandson, John Slaughter, a mariner, and to the heirs of the said John Slaughter, his home at the south end of Boston, "once belonging to Edward Taylor, where my grandson now dwelleth, on a lane running to the sea, next to widow Aliott's land and

Henry Wright's land. If he died without issue, his widow has the estate while a widow, and after her death or marriage, it returns to the estate." He reserved the end of the house next the street and the privilege of the well, etc., during his won life, which seems to show a place he occupied with his grandson, but where or when he acquired the property, I have not discovered. This property was deed to his grandson, John Slaughter, in 1714.

Suffolk 36: 164: in 1727, with the consent of his wife, Lydia, he sold to Elijah Vindall, of Hingham, Mass., land on Essex Street, on Rainsford Lane, his other land and near Worth's estate, agreeing with John Vandall of Scituate, Mass., apparently the father of Elijah, who in another paper turns out to be the grandson of Giles Goddard, to settle up all claims the Vindalls may have on the estate in Rainsford Lane, he to keep the north-west part of the house and a small garden spot fenced in, to go to Elijah after his death, and Elijah to pay his wife, Lydia, after Gile's death, in case she outlived him, ten pounds in two months.

Suffolk 38: 182: The contract of Lydia Chapin, single woman, July 1st, 1821, with Giles Goddard at the time of her marriage, is given, she to pay the ten pounds down for his use and that of his heirs. If the marriage fails to come off, she is to have it again, and the east end of the tenement is reserved for her use while she is his widow. If she marry, the tenement is returned to the Goddard family, and she to have what she brought with her

and what he may give to her later. Her clothes and any gifts added to her ten pounds, and she to release all claims on dower thirds. These Vindalls and Slaughters appear to be all of the daughters' families I can find.

Suffolk 53: 170. General Court, May 26th, 1736, has a petition signed by Elizabeth Slaughter of Boston, widow of John, Samuel Button or Butler, with wife, Mercy, referring to May 7th, 1713, as the date for the purchase by John Slaughter for seventy-five pounds from Giles Goddard and William Parkman of Boston, the executors of the Edward Taylor estate of the Essex Street estate at the South End. The attorney acting for the Slaughters was keeping the deed, as John was a mariner, and apparently turned it over to Giles Goddard, now deceased, and the deed was lost and she prays for relief. Elijah Vinall, the cousin, brings up his adverse claim and the House of Representatives asked him to show hy he thought he owned the place. Vinall produced the 1722 dead, properly recorded, and the Slaughter heirs got a record somewheres. So the Vinall heirs bought up the Slaughters, with consent of Mercy and her husband, Samuel.

I am unable to state when or where mary, the wife of Giles Goddard, died.

Letters of Administration upon the estate of Giles Godgard late of Boston, Mass., housewright, deceased, were granted unto John Goddard, of Roxbury, Mass., coedwiner, son of the deceased Giles Goddard, on June 29th, 1729.

Inventory returned by Captain John Goddard, Administrator,

December 14th, 1738. Amount twenty pounds, seventeen shillings, of his father's, Giles Goddard's, estate.

Giles and Mary Goddard had the following children:

John Goddard, married Sarah Farrington.

William Goddard, born August 4th, 1678; married Elizabeth Fairfield.

Goddard, (daughter), married Goddard Vinall.

#### SECOND GENERATION.

John Goddard, the son of Giles and Hary Goddard, was perhaps born in England. He married (1) Sarah Farrington, the daughter of Mathew and Sarah (Potter) Farrington. Their marriage intention was dated June 19th, 1697. She was born in Lynn, Mass., on September 20th, 1677, and she died on May 22nd, 1732. She was buried in the Eliot Cemetery, Roxbury, Mass. John Goddard married (2) Susannah Gill, the daughter of Thomas and Susannah Wilson. She married (1) Obadiah Lincoln, on June 19th, 1707, and she married (2) John Goddard on November 16th, 1738. She died in Roxbury, Mass., in 1754, leaving no issue by John Goddard. The will of John Goddard of Roxbury, Suffolk County, Providence of Mass., was signed on August 5th, 1741, and proved on July 4th, 1745. He mantions his wife, Susanna; his two sons, Giles and John; to John, if ever he should return home again, the remainder of my real estate; if he should not return, then to son, Giles, who is to pay to three hundred pounds to the children of son, John, as they shall come to the age of twenty-one years; daughters Sarah Bailey. Mary Chubbuck and Elizabeth Shaw.

John Goddard seems not to have entertained a very cordial admiration of his son-in-law Jeremiah Chubbuck of Hingham for he directed that his daughter, Mary Chubbuck, should not receive her legacy during her husband's lifetime. The executors account showed that it had been paid on April 6th, 1748. In the probate files of the estate is one paper, adted June 15th, 1745, Jeremiah Chubbuck's caveat against proving Captain Goddard's will.

In numerous papers, John Goddard is called "Captain."

Due to the old papers not clearly stating the parentage of John Goddard, I will endeavor to show, below, clear proof that he was the son of Giles and Mary Goddard.

William Goddard, the son of Giles and Mary Goddard, wasborn in Boston, Mass., on August 4th, 1678.

July 26th, 1748, Thomas Clapp, one of the executors of the will of Captain John Goddard, of Roxbury, Mass., charged for "going to Boston to settle with Mr. William Goddard, brother of the deceased, who lay claim to the estate."

May 24th, 1705, Giles Goddard, of Boston, carpenter, for sixty pounds, bought of John Charter, of Newport, R. I., and Anna, his wife, eldest daughter of Joseph Goad, late of Roxbury, said Anna's interest in her father's estate, or about seven acres of land and a barn. The adjoining owners were Deacon Samuel Williams and Stephen Williams.

February 15th, 1725, John Goddard, of Roxbury, cordwainer, and wife, Sara, for one hundred pounds, sold a piece of land in Roxbury, containg about eight acres, to William Patten of Boston, innholder. This was bounded by lands of Samuel Williams and Capt. Stephen Williams, and also Jonathan Davis and the highway.

July 30th, 1745, the inventory of the estate of John Goddard of Roxbury, gentleman, showed two tracts of land in Roxbury, one of twenty acres; theother, about eight acres, bounded by Capt. Williams. This latter tract was appraised by Stephen Williams and Eleazer Williams at three hundred and sixty pounds.

The inscription on the tomb-stone of Sarah (Farrington) Goddard's, states that she was the wife of Lieutenant John Goddard.

John and Sarah (Farrington) Goddard had the following children:

Giles Goddard, born in Lynn, Mass., on December 28th, 1698; married Hannah Pratt.

Sarah Goddard, born in Lynn, Mass., on November 14th, 1700; married James Baylie, at Boston, Mass., on April 13th, 1720. He was a clergman, who had the chance to teach or to assit the North Andover pastor, and his first child was born in Andover, Mass.

Mary Goddard, married Jeremiah Chubbuck, of Hingham, Mass., on October 14th, 1725, in Weymouth, Mass. He graduated from Harvard that same year. He was a school teacher in Hingham, Mass.

John Goddard, born February 14th, 1714; married Lydia Polden.

Elizabeth Goddard, born in Roxbury, Mass., on February 17th, 1716/17. She married a Shaw of Scituate or Hungham, Mass. lines, in 1735.

## THIRD GENERATION.

Giles Goddard, the son of John and Sarah (Farrington)
Goddard, was born in Lynn, Mass., on December 28th, 1698,
and he died in Roxbury, Mass., during the year 1750.
Giles Goddard married Hannah Pratt, of Malden, Mass., on
December 23rd, 1720.

Giles and Hannah (Pratt) Goddard had the following children:

Giles Goddard, born in Boston, Mass., on December 22nd, 1721; married Elizabeth Williamson, on December 2nd, 1747, in Boston, Mass.

Mary Goddard, born in Boston, Mass., on November 15th, 1728; married James Bucknam, of Malden, Mass., on September 17th, 1747.

Hannah Goddard, married (2) John Reed; alive in 1797.

John Goddard, born in Boston, Mass., on December 10th, 1725; married Sarah Sargeant.

John Goddardm the son of Giles and Hannah (Pratt) Goddard, was born in Roxbury, Mass., on December 10th, 1725, and deied prior to the year 1797.

John Goddard married Sarah Sargeant, the daughter of John and Sarah (Dexter) Sargeant, of Malden, Mass, during the year 1745. Their marriage intention was dated July 10th, 1745. She was alive in 1797.

John and Sarah (Sargeant) Goddard had the following children:

Ebenezer Goddard, born in 1752; married (1) Sally Curtis; married (2) Vashti Collins or Colson.

John Goddard, born in Bedford, Mass., in 1743.

Hannah Goddard, was the widow of a Whitemarsh in a 1797 deed.

Sarah Goddard, baptised in 1752 at Trinity Church, wasthe widow of Isaac Wendall of Boston, Mass., in 1797. They were married in Roxbury, Mass., on November 26th, 1771.

Polly Goddard, baptised at Trinity Church, married Aaron Sargeant of Lancaster, Mass.

Lydia Goddard, married Ebenezer Fuller, of Roxbury, Mass., on May 5th, 1793, at Roxbury, Mass.

Abigail Goddard, single in 1797. Baptised on June 29th, 1780.

Ebenezer Goddard, the son of John and Sarah (Sargeant)
Goddard, was born in 1752, and died in Roxbury, Mass. on
April 8th, 1827. He married (1) Sally Curtis, on September 30th,
1778, in Roxbury, Mass. He married (2) Vashti Collins or Colson,
on May 18th, 1800, in Roxbury, Mass. Sally Curtis was born in
1755, and she died in Roxbury, Mass. on November 1st, 1799.
Vashti Colson was born in 1767, and she died in Roxbury, Mass.,
on April 1st, 1834.

Ebenezer and Sally (Curtis) Goddard had the following children:

Sally Goddard, born \_\_\_\_; married Rufus Foster, on January 10th, 1796, in Roxbury, Mass.

Ebenezer Goddard, born in 1779; married Susannah Channel, on April 14th, 1799.

Susannah Goddard, born 1785; died in Roxbury, Mass., on November 26th, 1803. Never married.

Ebenezer Goddard, the son of Ebenezer and Sally (Curtis)
Goddard, was born in 1779. He married Susannah Channel, the
daughter of Lewis and Susannah Channel, on April 14th, 1799,
in Boston, Mass. Ebenezer Goddard died in Roxbury, Mass., on
December 15th, 1838. His wife was born in 1771, and she died
in Roxbury, Mass., of the consumption, on December 11th, 1849.

Ebenezer and Susannah (Channel) Goddard had the following child:

Ann Goddard, born in Roxbury, Mass., on June 27th, 1800; died in Roxbury, Mass., on August 26th, 1831; She never married.

### THIRD GENERATION.

John Goddard, the son of John and Sarah (Farrington) Goddard, was born in Roxbury, Mass., on February 14th, 1714. He married Lydia Polden, the daughter of John and Lydia (Tilson) Polden, on November 10th, 1735, at Plymouth, Mass. They were married by the Reverend Nathaniel Leonard. Lydia Goddard was born in Plymouth, Mass., on April 20th, 1710, and died in Plymouth on August 29th, 1775. John Goddard died in Plymouth on February 3rd, 1747. They were both buried on Burial Hill, Plymouth, Mass. John Goddard, for a time, was goaler of Plymouth, Mass. He was also a mariner.

On December 14th, 1745, John Goddard, of Plymouth, Mass., mariner, for one hundred and thirty-two pounds, sold to Giles Goddard of Malden, Mass., all his interest in "the housing and lands which my honored father, John Goddard, deceased, gave to me in his last will and testament, bearing date of August 5th, 1741, the said housing and lands lays and is situated in Roxbury, Mass. etc." Lydia Goddard, wife of the within named John Goddard, released her right of dower, December 19th, 1745.

This is clear proof that the John Hoddard of Plymouth was the son of John Goddard of Roxbury, Mass.

John Goddard, Sr., of Roxbury, Mass., in his will, adted August 5th, 1741, gave his son, Giles and John, liberty to sell the property to each other.

John and Lydia (Polden) Goddard had the following children: John Goddard, born August 8th, 1736; married Mary Polden.

John Goddard died intestate in 1795. Administration was granted to John Goddard, of Carver, Mass., physician, on the estate of his father, John Goddard, late of Plymouth, deceased, intestate, September 3rd, 1795.

John and Mary (Polden) Foddard had the following children:

John Goddard, the son of John and Mary (Polden) Goddard, was born in Plymouth, Mass., during the year 1770. He was a doctor and a surgeon on the U. S. Frigate "Boston," and died in Gibraltar Bay on June 15th, 1802. He married Grace Hayman Otis, the daughter of John Otis, on June 19th, 1796, at Plymouth, Mass. She was born in 1771, and she died on February 8th, 1851, and was buried on Burial Hill, Plymouth, Mass.

John and Grace Hayman (Otis) Goddard had the following children:

Harriet Otis Goddard, married Abraham Jackson, on October 18th, 1818, at Plymouth, Mass.

Mary Goddard, married Arthur French, of Boston, Mass.

## FOURTH GENERATION.

Lemuel Goddard, the son of John and Lydia (Polden) Goddard, was born in Plymouth, Mass., on September 30th, 1739. He was a shipmaster, and lived in Scituate, Mass. He moved to Halifax, Nova Scotia in April of the year 1775, due to being a Tory. His wife and five small children were brutally treated and plundered of their clothing in Plymouth, Mass.

The British Government granted Lemuel Goddard a parcel of land in Shelburne, Nova Scotia, in 1783, and his family were living in Shelburne as late as the year 1786.

Sometime during the year 1780, Lemuel Goddard entered the British Naval Service, under the patronage of Sir William Snape Holland, then Governor of Hallfax, and served until peace was declared. Later, he moved to England, and finally came to America, settling in Baltimore, Maryland, where he died on September 25th, 1819.

Lemuel Goddard married Nancy Kingston, the daughter of Elias and Sarah (Ballard) Kingston, of Boston, Mass., on July 1st, 1762, at Plymouth, Mass. They were married by the Reverend Chanlder Robbins. She was born in Boston, Mass., in 1742, and she died in Baltimore, Maryland, on October 6th, 1828. She and her husband were buried in the burial grounds of Saint Paul's Church, Baltimore, Maryland.

John Goddard, the son of Lemuel and Nancy (Kingston)
Goddard, was born in Halifax, Nova Scotia, on September 30th,
1779. He was a merchant, and died in the city of New York, N.Y.,
on May 5th, 1861, and was buried in the Woodland Cemetery,
Philadelphia, Penna.

John Goddard went, with his father, from Halifax, Nova Scotia to England, and later returned to the United States, with his father, and resided, for a time, in Baltimore, Maryland. He then moved to Philadelphia, Pa., where he married Mary Beck, the daughter of Paul and Margaret (Parker) Beck, on September 16th, 1807, atbthe Christ Episcopal Church, Philadelphia, Pa. She was born in Philadelphia, Pa., on March 29th, 1789, and she died in Philadelphia, Pa., on April 7th, 1825, and was buried in the Woodland Cemetery, Philadelphia.

Shortly after thedeath of his wife, John Goddard settled in New York City, where he died. His funeral was held from the home of his son, John Lemuel Goddard, Williams and Walnut Streets, Philadelphia, Pa.

John Lemuel Goddard, the son of John and Mary (Beck) Goddard, was born in Philadelphia, Pa., on November 24th, 1821, and he died in Philadelphia, Pa., on July 17th, 1867. He married Ellen Ewing, but they did not have any issue.

Ellen (Ewing) Goddard died on December 4th, 1867, and she and her husband were buried in the Woodland Cemetery, Philadelphia, Penna.

Kingston Goddard, the son of John and Mary (Beck) Goddard, was born in Philadelphia, Penna., on April 20th, 1814, and he wied at Richmond, Staten Island, New York, on October 24th, 1875.

He married Matulda Susan Seaman, the daughter of William and Elizabeth Brewerton (Benson) Seaman, of New York City, on December 6th, 1936. They were married in Saint Luke's Episcopal Church, New York City, by Rev. Bird Wilson.

Matilda Susan Seaman was born in New York City on July 16th, 1814, and she died on August 25th, 1889. She and her husband were buried in the Woodland Cemetery, Philadelphia, Pa.

Kingston Goddard was educated in the schools of Philadelphia, and the University of Pennsylvania, from which latter institute of learning he was graduated with the honors in 1833. He was, in 1836, graduated from the General Theological Seminary of the Episcopal Church in New York City. His first charge, while still a deacon, was that of Saint Anna's, Fishkill Landing, New York, 1835-1837, after which he served acceptably in the parishes of Christ Church, Brooklyn, Emmamual Church, Brooklyn, The Atonement, Philadelphia, and Christ Church, Cincinnati, Ohio.

While at Cincinnati, the call came to him from Saint Paul's Church, Philadelphia, Pa.

He was elected a member of the American Philosophical Society in 1857, and Kenyon College conferred upon him the degree of Doctor of Divinity in 1860. He was also Grand Chaplain of the Grand Lodge, F. and A. M. of Philadelphia.

Reverend Goddard, in 1866, acdepted the rectorship of Saint

Andrew's Church, Richmond, Staten Island, New York, at which post he died.

Matilda Susan (Seaman) Goddard died at Bergen Point, New Jersey, on August 25th, 1889, and she and her husband were buried in the Woodland Cemetery, Philadelphia, Pa.

In 1769, she resigned the business to Carter, and removed to Philadelphia, Pa., where she died on January 5th, 1770, at an advanced age. On the following day, her remains were interred in the burial grounds of the Christ Episcopal Church, Philadelphia, Pa.

William Goddard, having served his apprenticeship with James Parker, a printer in New York, removed to Providence, R. I., and on October 20th, 176 2, established the first printing press in that town, where he commenced the "Gazette and County Journal." Not meeting with sufficient encouragement, he went to New York, and associated himself with John Holt in publishing the "New York Gazette and Post-Boy."

In 1766, he removed to Philadelphia, Pa., where he issued, on January 6th, 1767, the first number of "The Pennsylvania Chronicle and Universal Advertiser." It was published at ten shillings per annum, and had four columns to a page, instead of three, as hitherto been the practice. For two out of three years, it was printed in quarto form, and the fourth year it returned to folio, which was the original form in which it had been printed. Joseph Galloway and Thomas Wharton were secret partners of Goddard in this enterprise, but the partnership did not continue long. The partners quarreled and deparated, and Goddard turned his batteries in the "Chronicle" upon Galloway, who was denounced through the columns of the paper which he had helped to establish.

In 1770, Benjamin Towne was admitted to the firm, and, becoming dissatisfied, the paper suspended publication in February, 1773.

While Goddard was publishing his paper in Philadelphia, Pa., some political use was made by Joseph Galloway out of the circumstance that an annonymous letter had been sent him demanding the loan of fifty pounds for a year, with directions to leave it for the writer at a certain time under the five mile stone on the road from Philadelphia to Chester. Galloway offered fifty pounds reward for the discovery of the author, and Governor Penn offered one hundred pounds for the same purpose. The occasion was embraced to maliciously impute this trifling affair to William Goddard, Galloway's former partner in the publication of the "Chronicle," but who was now his open enemy. Goddard was arrested and gave bail, but Galloway, ashamed of the business, and without any evidence against Goddard, abandoned the presecution, and no indictment was found. Goddard specially devoted himself, previous to each election, to the publication of articles against Galloway. but without avail. Indeed, at the election in October, 1772, Goddard, who was a candidate for the Assembly in Philadelphia, was defeated, while Galloway was returned for Bucks and placed in his old position as Speaker of the House.

The first direct information that the East India Company intended to send some cargoes of tea to America was received in a letter from London, and published on the 27th of September, 1772, in the "Chronicle." Goddard was a warm friend of the Colonies at this time, and denounced the "pernicious business" in unmeasured terms

in his journal.

William Goddard went to Baltimore, Maryland, insolvent and helpless to begin anew, as he relates, "on the small capital of a single guinea." He managed to secure the materials in the printing establishment of a widow named Hasselbocht, and added to it the small stock owned by Enoch Story. In May, 1773, he opened a printing office at the corner of South and Baltimore Streets, where the Sun Iron Building now stands, "nearly opposite Mrs. Chilton's," where "printing was done in all its branches." He was encouraged to publish a newspaper, and on July 15th, 1773, he issed his prospectus of "The Maryland Journal and Baltimore Advertiser." ON Friday, August 20th, 1773, the first newspaper published in Baltimore was distributed throughout the town. The first number was handsomely printed on stout paper, in good, clear type, and contained twelve broad columns. Its was a weekly, and the salutatory promised much.

During the publication of his paper in Baltimore, Goddard was twice mobbed by the citizens of that town. The first time, in March, 1777, for publishing an anonymous communication reflecting on the conduct of the war by the Americans, and again on July 6th, 1779, for publishing General Charles Lee's "Queries, Political and Military." Goddard continued his connection with the "Journal" until August 14th, 1792, when he sold his interest to James Angell, a relative.

He was elected a member of the Rhode Island Legislature in 1795, and, having changed his residence to Providence, continued to

live there until his death.

General Charles Lee, whom he had endeavored to serve, as we have seen, at no ordinary personal risk, remained his friend and bequeathed him a portion of his landed estate in Virginia. General Lee also made him one of his executors, in which capacity Mr. Goddard came into possession of General Lee's papers. He issued proposals for publishing selected parts of them into three volumes, for for some reasons, the design was never executed. For many years, the papers remained in the possession of the family of Mr. Goddard's only son, the late Professor William Giles Goddard, of Providence, R. I. William Goddard was the founder of the present United States postal service.

William Goddard, while in Philadelphia, fought Galloway bitterly through two elections, and pursued Wharton as vindictively. The latter he dubbed "the Marquis of Baratatia," probably in part allusion to the fact that Wharton's father, Joseph Wharton, of Walnut Grove (where the Mischianza fete came off), was populary called, from his haughty ways, "The Duke." It was related of Joseph, the duke, that hwm when-he held-his-hat-in-his-hand, when he called on Sir William Draper ("Junius'" victim) he held his hat in his hand, and the knight with great complaisance, told him that as it was contrary to the custom of his society to do so he would dispense with this remark of respect; whereupunthe duke replied that he had his hat off not out of respect for Sir William Draper, but because it was a hot day.

The simple fact that she continued the "Journal" during the most trying and critical periods of the Revolution, and that she was intrusted by her brother with the sole management of his business when the exigencies of his occupation elsewhere, or the political hostility which occasionally forced him to flee Baltimore, made it necessary for him to intrust it to other hands proves that she possessed extraordinary judgment, energy, nerve and strong common sense. Miss Goddard had also responsible and difficult duties to discharge as postmistress, but she seems to have been fully equal to the tasks imposed upon her, and, indeed, appears to have had a full measure of her brother's courage, industry and indomitable will.
