INTRODUCTION.

In "the sixties" the late Captain William Frederick Goodwin, of Concord, N. H., who died in 1872, began preparing a genealogy of the descendants of Daniel Goodwin, who settled in Kittery, Maine, about 1652. He published some of his notes in his history of "Narragansett Number One, now Buxton, Maine," and also in the October, 1868, number of Dawson's "Historical Magazine."

In the search for my own ancestry, commenced a few years ago, I found traces of Captain Goodwin's work and finally obtained his four volumes of manuscript books through the courtesy of Miss Alice Peabody Goodwin, of Franklin Falls, N. H., and Miss Sarah Louise Kimball, of San Francisco, to which I have made numerous additions and from which most of the following data is taken. Much remains to be done before these generations are wholly correct, and this part of the collection is printed in the hope of obtaining corrections and needful information *and is not issued as an authoritative record.*

The ancestry of Daniel Goodwin, the Immigrant, is in doubt. Captain Goodwin states that Daniel's father and grandfather were both Daniel Goodwin, the former marrying Dorothy Barker and the latter being of Great Oakley, Sussex Co., England. Unfortunately for this statement, Mr. Henry F. Waters, the well-known genealogist, shows in his Introduction to "The Goodwins of Hartford, Conn.," that Daniel Goodwin, who married Dorothy Barker, was a son of John Goodwin and not of Daniel

Goodwin, of Great Oakley, and Mr. Waters' "Gleanings" disclose the fact that Daniel Goodwin, of Great Oakley, had neither a son nor a grandson named Daniel.

I myself am inclined to the opinion that Daniel Goodwin, of Kittery, Maine, was a brother of Richard Goodwin, of Gloucester, Mass., and that they were sons of Bridget Goodwin*, who afterwards married Henry Travers, and later still, Richard Window, and that her Goodwin husband was one of the Torrington, England, Goodwin family. Briefly, my reasons are these: Tradition says Daniel came to Kittery, Me., from Massachusetts, leaving brothers behind him *near Plymouth*. Richard Goodwin, of Gloucester, about the same age as Daniel, had, among other children, a Daniel and a Richard, Jr. This Richard Jr. settled in Newbury, Mass., and had also a Richard and a Daniel, of 1711. This latter child is not given by Savage in his Genealogical Dictionary, but Captain Goodwin's record states positively that this Daniel of 1711 was a son of Richard, of Newbury. I have found the descendants of this Daniel of 1711, who are now living in Nova Scotia, and they say that the ancestors of Daniel of 1711 came from *Plymouth, England*, near where the Torrington branch of the Goodwin family had resided for generations. This seems to fix the family of Richard, of Gloucester, as being from near Plymouth, *England*, and as Daniel, of Kittery, had a son Daniel and grandsons Richard and Daniel, and, as tradition says he left brothers near *Plymouth*, I am inclined to think that it was *England* and not *Massachusetts*, and that this tradition, taken with the constant repetition of the names of Richard

*Bridget Goodwin was certainly the mother of Richard Goodwin, and died in Gloucester, Mass., her estate being appraised August 9, 1673. Richard was younger than Daniel and perhaps remained with his mother when Daniel left home, if my supposition of relationship is correct.

and Daniel in both families, indicates strongly that the first Daniel and Richard were brothers from Plymouth, England. Perhaps Mr. Waters will be able to learn the name of the husband of Bridget Goodwin and the birth records of his family. Complete records of the Torrington family are in existence in the possession of Rev. Augustus Jessup, Scarning, England, but my letters to him remain unanswered.

Captain Goodwin could not identify Abiel Goodwin, of York Co., Me., but gave him in "Narragansett Number One" as from Reading, *Conn.* He was from Reading, *Mass.*, and was a descendant of Christopher Goodwin, of Charlestown, Mass.

No attempt is made in the following pages to do more than give in the briefest form the family records. Biographical data is omitted entirely. No information concerning families of the daughters of each generation has been collected.

The expense of this publication has been borne by Mr. William Hobbs Goodwin, Jr., of Boston; Mr. Almon Goodwin, of New York; Mr. Harold Goodwin, of Philadelphia, and Mr. Warren Foster Goodwin, of Chicago.

The thanks of the entire Goodwin family are due to Mr. James J. Goodwin, of Hartford and New York, a descendant of Ozias Goodwin, who has published the "Goodwins of Hartford, Conn.," who made it possible for Dr. Tyler, President of William and Mary College, to publish my manuscript records of the "Goodwins of Virginia" and who has contributed to the publication of this pamphlet; and to Rev. George Lewis, of South Berwick, who has so patiently copied the old records for me, corrected the many errors and courteously and promptly answered my many letters, I render public thanks.

While the Goodwins of Maine seem not to be related to my own family, I have taken considerable pleasure in the acquaintance the preparation of this work has made me, and trust that the family will accept the results with renewed assurances of my most distinguished consideration.

GOODWIN FAMILIES OF NEW ENGLAND.

It may save confusion if brief mention is made of the immigrants who have left Goodwin families in New England. It is exceptionally difficult to keep the tribes separate in New Hampshire and Vermont, for in some instances three different families have had representatives in the same town. The "three brother" story is of course long since discredited.

1632. William and Ozias Goodwin, brothers, settled eventually in Hartford, Conn. A genealogy of this family has been published—"The Goodwins of Hartford, Conn.," by Mr. James J. Goodwin, of Hartford.

1633.—Christopher Goodwin settled in Charlestown, Mass. His descendants removed to Boston, Reading and Marblehead, Mass., and York, Me.

1652.—Daniel Goodwin settled in Kittery, Maine.

1660.—Richard Goodwin resided in Gloucester, Essex County, Mass., marrying in 1666. His descendants reside principally in Newbury and Rowley, Mass., and in North Yarmouth, Maine, where the name is Gooding.

1660.—Edward Goodwin resided in Amesbury, and his son, Richard, in Salisbury, Essex County, Mass. Family is widely scattered through New Hampshire and Vermont.

1712. John Goodwin settled in Boston. Descendants in Dresden and Fairfield, Maine.

1713.—William Goodwin, brother of John, settled in Marblehead, Mass.

DANIEL GOODWIN was in Kittery, York Co., Maine, in 1652. He married, first, in Kittery, Margaret Spencer, daughter of Thomas and Patience (Chadbourne) Spencer; she was a daughter of William Chadbourne. Daniel married, second, after March 1670, Sarah Sanders, widow of Peter Turbet. Daniel died about 1712. He was a surveyor, an innkeeper and a large landed proprietor.

- 3 DANIEL GOODWIN (*Daniel 2, Daniel 1*), born June 13, 1685, in Berwick, married Abigail ——— and resided in Dover, N. H. Name spelled *Guding*. (*See Pg. 259, Vol. 6, N. E. H. & G. R.*) They baptized their first six children in Berwick, October 18, 1722. The seventh child was baptized September 27, 1724. Daniel died in Somersworth, N. H., in 1737.

- 4 DANIEL GOODWIN (*Daniel 3, Daniel 2, Daniel 1*), born September 29, 1713, was in Somersworth in 1740. Data of his descendants, if any, greatly desired.
- 5 JAMES GOODWIN (*Daniel 3, Daniel 2, Daniel 1*), born June 22, 1724, is untraced unless he is the "James Goodwin of Newmarket, Rockingham Co., N. H., aged fifty, in 1775." This tallies very closely with his age, but see James 21. Data of the descendants, if any, of this James, greatly desired.
- 6 MILES GOODWIN (*Daniel 2, Daniel 1*), born July 31, 1687, in Berwick; baptized in Berwick, August 12, 1736. His children were baptized in Berwick the following month. Wife's name not given at baptism, indicating her previous death. John, Samuel and *Miles* Goodwin were petitioners in 1752 at Penobscot; perhaps this Miles. I can not identify positively either John or Samuel. Evidently we are missing some children of the third generation.

- 7 CALEB GOODWIN (*Miles 6, Daniel 2, Daniel 1*), who was baptized in Berwick, Me., September 28, 1736,

seems to be the Caleb who took land in Arundel, Me., January 14, 1754, settling thereafter in Bowdoinham. Family tradition says that the Caleb of Bowdoinham was born in Scotland, came to America with his two brothers, had a son Caleb, Jr. and three daughters, and lived in Clinton and Fairfield, Me.; that Caleb, Jr., was taken by an uncle when he was seven years old from Bangor, Me., to Clinton, "to prevent the English authorities from carrying him back to England." Tradition fails to chronicle the heinous crime of this seven-year-old fugitive from justice. I think the true explanation is that Caleb, Sr., was son of Miles 6, and had the two brothers, Daniel and Stephen, and that Stephen took his nephew, Caleb, Jr., at the age of seven, Caleb, Sr., perhaps being then dead. I find that Stephen and Caleb, Jr., were both living in Castine in 1763, and that Caleb, Jr., with his wife and eight children left Castine in 1770. I also find that an Abigail Goodwin, born in 1763, was married in Fairfield in 1782 to David Emery. Her ten children are given on page 57, Emery Genealogy. I show her here as one of the three daughters of Caleb, but she may have been a niece, or what is still more likely, a grand-daughter of Daniel or Stephen.

- 8 CAPTAIN CALEB GOODWIN (*Caleb 7, Miles 6, Daniel 2, Daniel 1*), born in Bowdoinham, resided in Castine where Stephen Goodwin 10 lived, thus tending further to identify Caleb, Sr., as the brother of Stephen and son of Miles, and removed with his wife and eight children in

1770 to Bangor. He died in Boston, of smallpox, during the revolutionary war.

9 DANIEL GOODWIN (*Miles 6, Daniel 2, Daniel 1*), baptized in Berwick, August 28, 1736, evidently went into the "Eastern Country" and is wholly untraced. A Daniel Goodwin married Prudence Wyman in Brunswick, Me., March 11, 1758 (*Vol. 4, Bangor Hist. Mag.*) I can not find any other Daniel than this of age to marry in 1758.

10 STEPHEN GOODWIN (*Miles 6, Daniel 2, Daniel 1*), baptized September 28, 1736, in Berwick, is probably the Stephen Goodwin who was living, October 3, 1763, on Bagaduce Bay, now known as Castine, Me. Descendants, if any, untraced.

11 NATHANIEL GOODWIN (*Daniel 2, Daniel 1*), born October 29, 1689, in Berwick, married Mary _____ and resided in Berwick. I think he had other children, Paul and Joshua, older than the ones given here, who went to Wells, Me., and perhaps John, Jr., who married Martha Nason, was another son. I cannot otherwise connect any of the Wells families with the Immigrant. The Berwick church records show that Nathaniel and *Margaret* baptized a daughter Margaret March 25, 1752. Capt.

Goodwin says it was *Nathan* and Margaret and not Nathaniel and that Nathan was the son of John 58. See also Appendixes A and B for discussion of other probable children.

- 12 NATHANIEL GOODWIN (*Nathaniel 11, Daniel 2, Daniel 1*), baptized January 16, 1724, in Berwick, married (Published) Nov. 12, 1734. Mary White of York. They removed about 1745 to Kennebunkport. He and his brother Benjamin built the Goodwin Mills at Lyman. The history of K. says one daughter married *Gideon Wakefield*. Capt. Goodwin's records show that Mary married *Nathaniel Wakefield*.

- 13 BENJAMIN GOODWIN (*Nathaniel 11, Daniel 2, Daniel 1*), baptized January 16, 1724, in Berwick, is said by his descendants and by the history of Kennebunkport to have married Sarah *Nason* but the South Berwick church records show that Benjamin Goodwin and Sarah *Herle (Earl)* were married August 27, 1747. It seems probable that this last Benjamin was somewhat younger than Nathaniel's son, but I have no record of any Benjamin of the fourth

generation except Nathaniel's son. This indicates incomplete records. Benjamin resided and died in Kennebunkport.

- 14 SOLOMON GOODWIN (*Nathaniel 11, Daniel 2, Daniel 1*) was married June 5, 1747, in South Berwick, to Abigail Hooper, daughter of John Hooper, of Berwick, who was a shoemaker, and who made a pair of shoes after he was 102 years old, then residing in Nason's Mills. Solomon Goodwin resided in Arundel, Me., dying November 2, 1772.

* Capt. Goodwin gives name as Sarah Bickford. William Goodwin removed to Vermont October 1, 1807. This is the William Goodwin who settled in Waterbury, Vt., and whose grand-daughter, Mrs. Abbie J. Yaw, daughter of Jotham Goodwin, resides in Mansfield, Vt. William Goodwin's wife was Sarah Bickford, not Tibbetts.

descendant of Abraham Preble of Scituate, Mass.; of Nathaniel Tilden, the first, of Scituate; of Hon. Edward Rishworth, of York, Me., and of Rev. John Wheelwright, the founder of Exeter, N. H. They resided in Arundel (Kennebunkport) and York. John Goodwin was a soldier of the revolutionary war. He died about 1801 in Bath, Me., where he was at work.

14b MARY GOODWIN (*John 14a, Solomon 14, Nathaniel 11, Daniel 2, Daniel 1*), born January 20, 1784, was married to Jonathan Ross of Shapleigh and Harrison, Me., a son of Jonathan Ross of Berwick, a Revolutionary soldier and lineal descendant of Hugh Ross of Belfast, Ireland, and Kittery and Berwick, Me.; of Maturin Ricker of Cocheco, N. H., killed by the Indians June 4, 1706; and of Anthony Emery of Newbury, Mass., 1635. Mary Goodwin died September 17, 1864.

Henry Bond Ruggles was a lineal descendant of Thomas Ruggles, Esquire, of Sudbury, Suffolk, England, 1547; of Thomas Ruggles of Roxbury, Mass., 1637; of Henry Adams of Braintree, Mass., d. Oct. 8, 1646; of John Alden of Plymouth, 1620, and of John Kingsley of Dorchester, 1635, and Taunton, Mass. Henry Bond Ruggles and wife resided in Boston and Wakefield, Mass. - 15 SAMUEL GOODWIN (*Daniel 2, Daniel 1*), born May 27, 1695, in Berwick, married, first, September 13, 1719, Sarah Davis; second, November 7, 1734, at York, Mrs. Judith (Preble) Smith, daughter of Benjamin Preble. Perhaps this is the Samuel who was a petitioner at Penobscot, in 1752, together with Miles and John, as a Miles and a Samuel were brothers, but who was John? Samuel resided in South Berwick until after the death of his first wife and then removed to York. Do not know where he died.

A stray sheet in one of Captain Goodwin's books says that a Samuel Goodwin was one of the witnesses to a treaty with certain Indian tribes at Casco Bay, October 16, 1749, subsequently at Fort St. George in 1752 and at Falmouth on July 2, 1754.

20a SARAH GOODWIN (*Amaziah 20, Samuel 15, Daniel 2, Daniel 1*), born July 22, 1782, resided with the family of Wingate Frost, Quakers, of Limerick and married Joseph Mills of Waterborough, in January, 1800. He was born October 12, 1779 in Biddeford, a son of Eligood and Mary (*Dyer*) Mills. He was a farmer. He died in West Brooksville, May 14, 1836. She died in Cape Elizabeth November 18, 1828.

*It seems probable that this statement of ancestry of Sarah Butler is incorrect. Dr. Butler thinks her mother, Sarah Goodwin, was Sarah, born in 1722, the daughter of Daniel Goodwin 3 and not the daughter of Adam, but a Bible entry gives Sarah Goodwin's birth at 1729. A family tradition says that Moses Butler on February 7, 1750, married Sarah Goodwin, born in 1729, the sister to Amaziah, by whom he had among others a daughter Sarah. That when Moses Butler and his wife removed to Frenchman's Bay in 1764, they left this young daughter with her grandfather, Samuel Goodwin, 15, and that she afterwards, in 1778, became the second wife of her half-uncle, Amaziah Goodwin 20. This tradition is borne out by the records:—"Amaziah Goodwin of York, and Sarah Butler of a place called Frenchman's Bay, now resident in York."

- 21 JAMES GOODWIN, (*Daniel 2, Daniel 1*), born July 15, 1697, in Berwick, is wholly untraced. His brother, Daniel, settled in Dover and had a son James 5 born in 1724. There was a James Goodwin of Newmarket, Rockingham County, N. H., "aged 50 in 1775," which so accurately described James 5 in age that it seemed probable he had gone to Newmarket from Dover; but other records show that James Goodwin and James Goodwin, Jr., were in Newmarket as early as November 21, 1746. This indicates positively an older James than James 5. It is possible that James 21 may have settled in Newmarket, and in 1746, then 49 years of age, have a son old enough

to be mentioned as James, Jr., born in 1725, and 50 years old in 1775. James, Jr., might also be the James 5, "junior," to his uncle James 21. It should also be noted that a James *Gooding*, (a very common way of writing the name Goodwin in early days), married Elizabeth ——— and resided in Portland, Me., having three daughters: I. Margaret, born June 13, 1733; II. Sarah, born March 7, 1835, and III. Sarah, born February 20, 1737. I cannot yet identify definitely these several men bearing the name James.

- 22 THOMAS GOODWIN, (*Daniel 2, Daniel 1*), born August 5, 1699, in Berwick, was married December 20, 1722, to Abigail Seward of Portsmouth, N. H. (*See Vol. 23 or 24 N. E. H. & G. R.*) Descendants, if any, untraced. If this man's family record could be obtained it would doubtless clear up a number of obscure points. I am strongly inclined to think that he married Hannah Wells for a second wife. See Appendix A and diagram.

DESCENDANTS OF THE SECOND SON OF DANIEL,
THE IMMIGRANT.

- 23 JAMES GOODWIN (*second son of Daniel 1*), was married December 9, 1686, in Berwick, to Sarah Thompson, daughter of Miles Thompson. He resided in Berwick and died there July 31, 1697. It was *his* widow and not Sarah, the second wife of Daniel 1, as Captain Goodwin supposed, who was the "widow Sarah Goodwin" admitted to church in 1703, as Daniel 1 was then alive. No children have been credited to this James by Captain Goodwin or in any records, but there are so many branches of the Goodwins of Maine which cannot trace to Daniel and the other children of Daniel are so thoroughly unidentified that the only possible explanation is that this James had several children. Certainly "Mary, daughter of Sarah Goodwin, baptized April 5, 1703" (*Berwick Records*), was this man's child.

I have therefore taken the liberty of giving this man just the family he needed to help me out. He has been dead too long to object, and, unless subsequent investigations make it appear that it was not necessary for him to have had so many children, I shall always think he *should* have had them. His failure to write down the facts concerning himself and family has been the cause of most of our woes. The N. E. H. & G. R., Vol. 23 or 24, says, "John Davis, of Bristol in Great Brittain, and Mary Gooding, of Neckswamick, were married 23rd of October, 1718." I can find no other Mary of marrying age

than the one baptized April 15, 1703, and I so dispose of her.

Some of his descendants removed to Lebanon, Me., and they were claimed as relatives by the other Maine Goodwins. I know not whose son he was unless of James 23. See also Appendix O.

- 25 RICHARD GOODWIN (*Richard 24, James 23, Daniel 1*), born April 19, 1724, in Dover, N. H., married Keziah Tibbetts of Somersworth, and resided in Somersworth and Rochester, N. H. The names of his children indicate relationship with the Kittery family.

Elisha Hayes of Lebanon wrote Captain Goodwin in 1871 that Samuel Goodwin, born 1753 and married Sarah Hodsdon, was a cousin to Thomas Goodwin who married Anna Hodsdon, sister to Sarah. This statement was evidently a mistake as Thomas Goodwin was the son of Elisha 36, who was eldest son of Thomas 35 (*son of Thomas 34*), and this Thomas 35 had no son Richard, so

far as my investigation goes. Thomas 34, third son of Daniel 1, married Mehitable Plaisted perhaps about 1685-7. She was captured by the Indians in 1689-90 and then had an infant son whom the Indians killed. She was a prisoner for five years, returning in 1695. She had son, Thomas 35, in 1697. Captain Goodwin's records show that Samuel, born 1753, was a son of Richard 25, and the Dover records show Richard 25 as a son of Richard 24, who was undoubtedly a grandson of Daniel 1, but unless Richard 24 was the son Thomas and Mehitable *before* her capture, which seems unlikely, I can only account for him as a supposed son of James 23.

26 JOHN GOODWIN (*James 23, Daniel 1*) was a petitioner with Miles and Samuel Goodwin in 1752 from Penobscot. Miles and Samuel were apparently those of that name of the third generation and sons of Daniel 2. Neither of them had a son John so far as I can learn nor can I find a John of their generation except their cousin, John 58, who married Patience Willoughby and resided in

* Daniel Goodwin was evidently the Daniel Tibbetts Goodwin, born in New Hampshire, who had a brother Samuel, and whose mother was a Tibbetts and who married Mary Crafts in New York, settling in Auburn, Ohio, where he died in 1844. His youngest son, Hon. James A. Goodwin, resides at Spencer, Iowa. Full data of this branch is given on pages 205 et seq. of the Crafts' Genealogy.

Berwick. Inasmuch as this John was contemporary with Miles and Samuel and was not their brother, there is only one conclusion to be drawn and that is that he was a son of one of their father's brothers, and the only one to whom he could belong as far as our knowledge now goes is to James 23.

- 27 JAMES GOODWIN (*James 23, Daniel 1*) is given simply as a guess. We have record that a James Goodwin was born in Dover in 1724, who might have been of Newmarket, N. H., in 1775; but who would have been too young to have been the Portland, Me., James of 1733. James Goodwin 21 may have been the senior of the James and James, Jr., "being in Newmarket in 1746." This leaves the James *Gooding* of Portland, who had children in 1733-35-37, unaccounted for. I suggest, pending further investigation, that the James Gooding of Portland, who married Elizabeth ———, may have been a son of James 23. Whether so or not, James of Portland had

- 28 THOMAS GOODWIN (*James 23, Daniel 1*) resided in Berwick and married Elizabeth Abbott before 1723. He is called "Junior" on the Berwick records; perhaps junior to his uncle, Thomas 34, or to his cousin, Thomas 35. He is called "Senior" in 1729, according to Captain Goodwin's copy, but Rev. George Lewis copies it for me as "Junior." I simply cannot place him, unless he were a son of James 23, as Thomas 22, son of Daniel 2, married Abigail Seward, and Thomas 35, son of Thomas 34, married Elizabeth Butler, and these

29 HENRY GOODWIN (*Thomas 28, James 23, Daniel 1*), baptized November 21, 1723, in South Berwick, was married by Rev. Jeremiah Wise at South Berwick February 28, 1748, to Elizabeth Weymouth. Descendants, if any, untraced.

30 SUSANNAH GOODWIN (*Thomas 28, James 23, Daniel 1*), was baptized May 23, 1725, in South Berwick. I find in the history of Saco Valley this statement: "Susannah Goodwin married in Saco, Me., March 13, 1784, Robert Patten. She died in Biddeford, Me., March 9, 1813, aged 88." This fixes date of birth of Susannah as same as this daughter of Thomas 28.

31 DANIEL GOODWIN (*Thomas 28, James 23, Daniel 1*), was baptized December 25, 1726, in South Berwick where he married Martha Peirce, September 14, 1747. Their children, Eunice and Sarah, were evidently baptized as adults. The ancestry of Daniel 31 seemed beyond finding out until I chanced upon this entry in the Berwick church records: "Sept. 3, 1757, Hannah Goodwin, grand-daughter of Thomas, Jr. and Elizabeth (Abbot), upon this account was baptized." From Captain Good-

win's record I learned that this Daniel 31 had a daughter, Hannah, born between Thomas, 1756, and Daniel, 1759, and from these two records it appears that Daniel Goodwin's daughter, Hannah, was grand-daughter of Thomas 28 though it does not appear why the grandparents offered her for baptism—unless to help us out in getting the records straight.

R.*), as being in New Hampshire in 1761-2. A Gideon Goodwin, Jr., married "Ellis" Ayres in Portsmouth, N. H., Sept. 17, 1785. The June, 1898, *Putnam's Historical Magazine*, page 178, says Gideon Gooding married Elizabeth Jenkins Aug. 17, 1753, in Portsmouth, N. H. (*South Parish*). This seems to be our Gideon 32 and Gideon, Jr., was probably a child of this marriage.

33 THOMAS GOODWIN (*Thomas 28, James 23, Daniel 1*), was baptized October 5, 1732, in South Berwick. I cannot give the name of his wife with certainty, but I think he is the Thomas who married Mary Hicks in South Ber-

wick July 29, 1754. The date and place point to him strongly. No further data of him or of the Thomas — Mary Hicks marriage. See diagram in Appendix A.

I think the reader will agree with me that it is a matter of necessity to give James 23 a family, so as to provide for all of the foregoing Goodwins who are undoubtedly descendants of Daniel of Kittery, but whose descent I cannot trace unless the above suppositions are reasonably correct.

III.

DESCENDANTS OF THE THIRD SON OF DANIEL, THE IMMIGRANT.

-
- 34 THOMAS GOODWIN (*Daniel 1*) was born in Kittery. He married about 1685 Mehitable Plaisted,³ daughter of Lieut. Roger Plaisted,² Ichabod.¹ In 1689-90 Mehitable was taken captive by the Indians, together with her infant son whom the Indians killed. She was kept a captive for five years and then returned to Berwick. In December, 1711, Daniel Goodwin 1 and Sarah, his wife, made a deed to Thomas. He was known as Ensign Thomas. It has been impossible to get full data of his children. Olive, Mary and Bial are given on authority of the Berwick church records; Thomas, Ichabod and James are given in Captain Goodwin's records. Moses Cooper (b. 1787) wrote Captain Goodwin in 1867 that his grandfather, John Cooper, married Ichabod's sister, who was then the widow Abbott, and that another sister married a Shapleigh of Eliot. A grandson of Ichabod states there was another sister who married a Davis. The *N. E. H.*

& *G. R.*, pg. 359, Vol. 24, says "Timothy Davis of Portsmouth, and Olive Goodwin of Berwick, married December 7, 1727." Also "John Davis of Bristol, in Great Britain, and Mary Gooding of Neckswamick, were married 23 October, 1718." I think this last must be an older Mary than the daughter of Thomas 34—perhaps "Mary, baptized April 15, 1703" by Sarah, widow of James Goodwin, 23. Perhaps Mary, daughter of Thomas, married first, Mr. Abbott; second John Cooper. I have so shown her in the list but I cannot be certain that she was not the one who married Mr. Shapleigh. The data concerning the sons of Thomas 34 seem to be positive and beyond dispute.

35 THOMAS GOODWIN (*Thomas 34, Daniel 1*), born July 12, 1697 in South Berwick; married December 2, 1722, Elizabeth Butler, daughter of Thomas and Elizabeth () Butler. The "Butler Genealogy" confuses the children of Thomas Goodwin 28 and Elizabeth *Abbott* with Thomas Goodwin 35 and Elizabeth *Butler* and gives all the *Abbott* children and none of the *Batler* ones. Captain Goodwin omits the eighth, ninth and twelfth child, but the Berwick church records say they were baptized by Thomas and Elizabeth, and Moses, the fourth child, in his will in 1766, mentions the twelfth child as "Sister Mollie," so I put them all in. It makes a big family in

a very short time. I think I have the girls married correctly. I am extremely anxious to get data about the second child, Thomas 37.

MARY MERRICK GOODWIN (*Daniel Raynes 41f, Samuel 41a, Dominicus 41, Ichabod 40, Thomas 34, Daniel 1*), born February 19, 1842, in Brunswick, Maine, was married October 12, 1864, at Philadelphia, Pennsylvania, by the Rev. C. A. L. Richards, to William Canfield Spencer, born December 15, 1838, in Rome, New York, a son of the Rev. Theodore and Katherine (*Vosburgh*) Spencer.

By occupation he was a surgeon in the Regular Army of the United States; in politics, a Union man, and in religion, a Presbyterian.

They resided at various points, as they were ordered about in the course of service. At Washington, D. C.; Fort Delaware, Del.; Camp Douglas, Utah; Fort Sanders, Wyoming; Chicago, Illinois; Fort Snelling, Minn.; Fort Trumbull, New London. Dr. Spencer died at Fort Trumbull in the spring of 1889. His widow resides at Cambridge, Mass. Dr. Spencer was one of the brightest young men in the Army, and highly esteemed by all his colleagues and superiors. Returning to Franklin he founded the Merrimack "Journal" in 1872. While in Washington he wrote a history for schools of the colored population in the District of Columbia. He was a fine writer of biographical sketches as is shown in the Memorial to Dr. Timothy Kenrick, which he prepared in 1879. He also wrote for the "Statesman," published at Concord, N. H., and for the Granite State Monthly. He was always greatly interested in schools and gave all his daughters an excellent education at Academy or College.

I am indebted primarily to Miss Alice Peabody Goodwin for the books of record compiled by her uncle, Captain William Frederick Goodwin.

61d CAPTAIN WILLIAM FREDERICK GOODWIN (*Nathan 61b, Joseph 61a, Joseph 61, John 58, William 48, Daniel 1*) was born September 27, 1823, in Limington, Me., was graduated from Bowdoin College in 1848; entered the Harvard Law School; was admitted to the bar and settled in Concord, N. H., where he had previously spent several years as Principal of the High School. He practised his profession until the War of 1861, when he enlisted as Lieutenant, 16th U. S. Infantry. He was wounded in 1863 at Chickamauga; was made Captain for gallant and meritorious service May 14, 1864; retired February 11, 1865, on account of disability. He published the first volume of

the Buxton Record, edited the October, 1868, number of Dawson's Historical Magazine, and intended publishing the Goodwin and Bradbury Family Histories. It is wholly to his untiring endeavors that the Goodwins of Maine owe the collection and preservation of their family record. He died March 12, 1872. His wife, Ellen Noyes Peabody, whom he married September 7, 1854, died in January, 1859. She was a daughter of Kendall Osgood and Alice (*Blanchard*) Peabody.

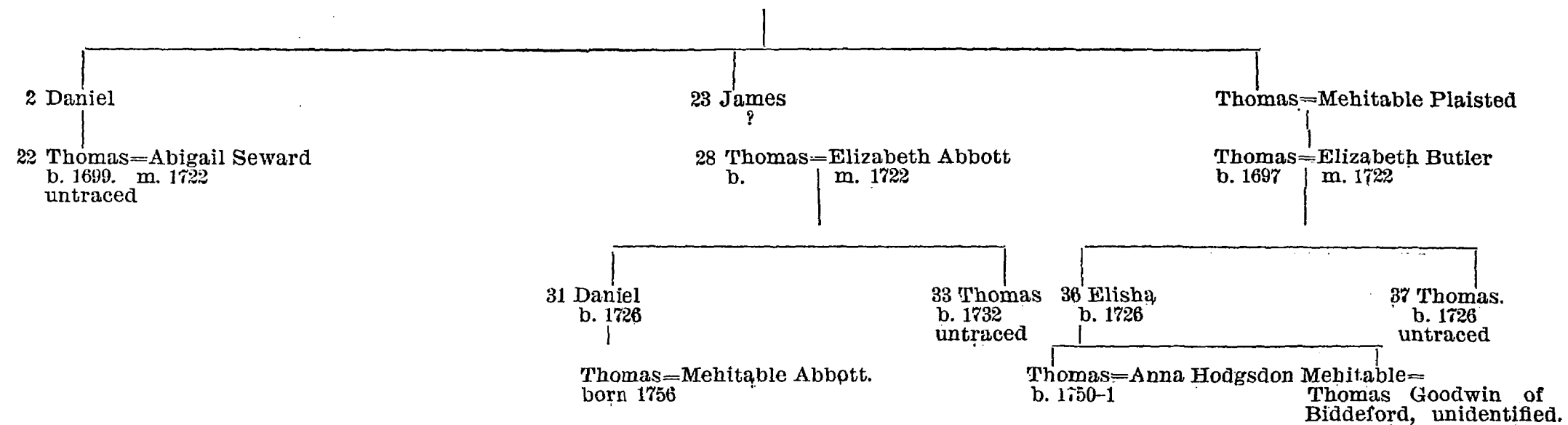

THE GOODWINS OF WELLS, MAINE.

In approaching this branch it may be well to say that every guess or hypothesis I have made concerning its origin has been upset by later data. One family has the tradition that it comes from the eldest son of Daniel of Kittery, but has no records. I think this tradition is correct but simply give what I have collected and trust to the future for "more light."

- 76 THOMAS GOODWIN (———, *Daniel 1*) was residing in Wells probably by 1730. He married Hannah Wells, daughter of John and Mary (*Peck?*) Wells. The will of John Wells, dated May 10, 1748, mentions his daughter's "heirs" and makes a special bequest to "grandson Thomas Goodwin," mentioning deed to this Thomas dated January 27, 1743-4. This will, of course, shows that Hannah (*Wells*) Goodwin had more heirs than Thomas, Jr., and indicates that Thomas, Jr., was the eldest. He, Thomas, Jr., married in 1753 and one of his descendants says he was twenty years of age when married. I am not sure that this statement was tradition or a result of confusing him with Thomas 28, baptized 1732. In either event it would fix the date of the Hannah Wells marriage as early if not earlier than 1732, and prove that her husband, Thomas Goodwin, was not later than the third generation. I know of only three Thomases of that generation. One is Thomas 28, called "Junior," who married

Elizabeth Abbott in 1722, and "Thomas, Jr., and Elizabeth" were baptizing children in Berwick up to October 5, 1732. The fact that Elizabeth's name is mentioned indicates that she was then alive, and it is very improbable that, even if she died immediately thereafter, her husband could be the father of Thomas, of Wells, who married in 1753, then twenty years old or over. Another Thomas is Thomas 35 who married Elizabeth Butler and his family is traced. That leaves us only Thomas 22, son of Daniel 3, the eldest son of Daniel, of Kittery, who married Abigail Seward in 1722 and whose descendants are untraced. It is perhaps reasonable to suggest that this Thomas and Abigail had children, and that after her death he contracted a marriage with Hannah Wells before or around 1730. Granting this, he could not have been the father of Paul and Joshua, of Wells, for they were even older than the date of the marriage to Abigail Seward, and this would indicate an older son of Daniel 2 as their father. The data leading to settlement of these matters will probably include John Goodwin, Jr., Appendix B, as a relative.

The history of Saco Valley says that Mary Goodwin of Wells was a sister of Samuel Goodwin of Wells and married Joseph Haley, their daughter Mary marrying (*Downing*) Goodwin, grandson of Thomas and Hannah (*Wells*). It also appears that Downing's sister married a John Goodwin of Wells. I suggest that Hannah (*Wells*) Goodwin's "heirs" may have included Thomas, Samuel and Mary, and that Thomas, son of Downing, married Mary's daughter, Mary Haley, (which fact is beyond dispute) and that Thomas' daughter, Sarah, married Samuel's son, John. I do not offer this with any weight, for I do not know that Samuel ever married or had a son.

79 JOHN GOODWIN (*Downing 78, Thomas 77, Thomas 76, ———, Daniel 1*), born August 31, 1794, in Topsham, Me., was married, first, to Abigail Brown, born November 21, 1792, a daughter of Ephraim and Huldah (*Richardson*) Brown. She died December 14, 1833, and Mr. Goodwin married, second, Sarah Cole Chace, born August 25, 1798, who died July 11, 1840. Mr. Goodwin married, third, Eliza Richardson, born August 11, 1808, a daughter of Elisha Richardson. She died April 6, 1867. Her youngest son, Newton, had an office in the Rookery Building, Chicago, as had also Horace B. Goodwin of the Hartford Goodwins, and the writer. It was the “chaffing” of New-

ton and Horace which first really determined the writer to discover his own ancestry, if possible. Newton was one of the finest specimens of physical manhood it was ever my fortune to see, but, poor fellow, the current of events seemed to run against him in those days of misfortunes, and on a beautiful summer day he voluntarily laid down the burdens of life. Horace was perhaps the last person he spoke to as he left our building, but he gave no evidence then of his intention. He was worthy of a better fate, and to the memory of him, the first of the three to go, I lay this branch of laurel with the cypress. Mr. John Goodwin married for his fourth wife Clarinda Buzzell, who survives him, but by which marriage there were no children. He resided in Baldwin from 1817 for over forty years, being in trade with Lot Davis at the "Corner." He kept a tavern from 1830 to 1853, removing thereafter to Limington.

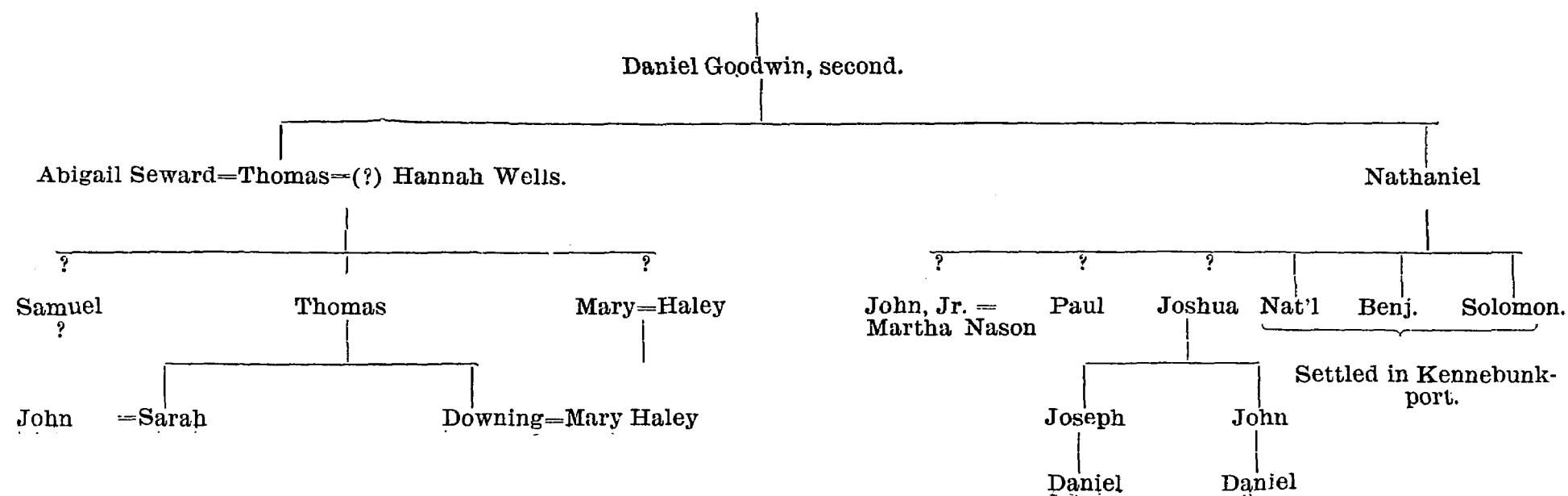

NOTES.

It appears that the Wells families were founded by Goodwins born between 1700 and 1720, and it is claimed that they were descendants of Daniel 2. This is not only probable but almost a necessity, as James 23 died in 1697, and the children of Thomas 34, William 48 and Moses 73 seem to be traced safely beyond 1720. Turning to Daniel 2, we find Thomas, untraced beyond 1722, who could have been the founder of the Wells family I. The other Wells families were apparently those of grandsons of Daniel second, and we have no complete record of Miles 6, born 1687, and Nathaniel 11, born 1689. This last man baptized four children in 1724, but one of them married in 1734, so that he must have been fully twelve years old at baptism. We find one more child not baptized, and, as all of these children went to Kennebunkport and as the Wells Goodwins made several marriages in Kennebunkport, it seems a plausible theory that Nathaniel 11 had more than the four children baptized and the one not baptized, and that among those other children were Paul, family II, and Joshua, family III, and perhaps John, Jr., Appendix B. I append a diagram showing the suggested relationship and ask for further data. The descendants of Paul and Joshua claim relationship, as do the descendants of Joshua and John.

He married Martha Nason, daughter of Benjamin Nason, and they resided in South Berwick until about 1754 when “Martha Goodwin, wife of John Goodwin, Jr., was dismissed and recommended to ye second Church in Wells, November 24, 1754,” but they settled in Kennebunkport and not Wells. He was called John, “Jr.”, to distinguish him from John 59, who also married a Martha. I find a Simeon of 1743, baptized by John, Jr., and Martha, but no record of the Simeon born in 1746. That date is given by Simeon’s descendants. It may be the same child or the first Simeon may have died young. I am not able to trace the ancestry of Sarah or Deborah Goodwin who married sons of John, Jr. Mark is given in the Berwick Records as baptized by “John and Martha,” but he is otherwise identified as a son of John, Jr. Undoubtedly John, Jr., was a son of one of the grandchildren of Daniel 1, but of which one? See *diagram in Goodwins of Wells*.

THE GOODWINS OF NEWBURY, VT., AND HAV- ERHILL, N. H.

It has so far been impossible for me to identify this family with that of Daniel of Kittery. No sooner have I thought its place absolutely fixed than some new data came to hand upsetting the arrangement. Were it not for the name Willoughby, which only appears, so far as I have found, in the Maine family, I would be tempted to say that this branch was from Essex County, Massachusetts, and did not belong to the Maine family.* I am not positive that Samuel Goodwin was a brother of Captain Simeon and John, who were brothers. These latter ones were soldiers in New Hampshire as early as 1755, indicating their birth around 1720,— perhaps grandsons of one of the sons of Daniel 1. Captain Simeon's son Asa

89 CAPTAIN SIMEON GOODWIN (——— 88, ———, *Daniel 1?*) was a soldier as early as 1755; was in Newbury, Vermont and Haverhill, New Hampshire, in 1763. He was a very prominent man in his locality. He removed in 1802 to Marietta, Ohio, where he died. Much of my information concerning this branch has come from Mr. John M. Goodwin of Newbury, who wrote that Captain Simeon's daughter Mary married her cousin *Willoughby* Goodwin. Captain Goodwin's MS. contains a statement of *Samuel* Goodwin, showing that his grandfather, Deacon Willoughby Goodwin, married twice and neither wife was Mary Goodwin. Upon submitting this to Mr. John M. Goodwin, he saw Mr. Miller of Ryegate, who insisted that Mary married Willoughby, and that Deacon Willoughby was of another branch. The name Samuel would indicate that Deacon Willoughby was a son of Simeon's brother (?) Samuel.

THE GOODWINS OF LEBANON, MAINE.

- 94 THOMAS GOODWIN “*Tertius*” (*Thomas*, ———, *Daniel 1*) resided in Berwick and on July 15, 1761, he was married by Rev. John Morse of the 2nd Church of Berwick to Eunice Lord. As one of their children, Reuben, was offered for baptism by Benjamin Lord and wife, it is probable that they were the parents of Eunice, who had died before 1769, as, on August 2, 1769, Thomas was married 2nd by Rev. Mathew Meriam at Berwick to Mehitable Goodwin, born in 1727, a daughter of Adam and Sarah () Goodwin 67. He resided in North Berwick at the foot of Beach Ridge, removing to Lebanon. His birth is given as 1721 and 1734, neither date tallying with any other Thomas. To make the confusion greater, a Thomas Goodwin “3d” was married at the Church of Christ, of Berwick, to Mary Hicks on July 29, 1754. None of the descendants of Thomas *tertius* have any record of the Thomas 3d marriage, so that it is not probably the same man with three wives. It is possible that Thomas 37 is this Thomas *tertius*, as that Thomas had a twin brother Elisha and brothers Reuben and Moses,—names of the

* His son, Reuben H., was father of Mrs. Nellie F. Emery, West Buxton, Me.

first three children of Thomas *tertius*; but another child was named Gideon and that name only appears as the brother of Thomas 28, who was baptized in 1732. An unexplained circumstance is that in Lower Bolton, Canada, the descendants of James Goodwin, Appendix G., have an old family Bible in which is recorded most of the data of this Thomas *tertius* but no word of explanation of the relationship between Thomas and James is given.

It is probable that the Moses given among the children of the second wife is the son of the first wife, but baptized among the second brood. Further data of this family is desired. If I can obtain the name of a brother or sister of Thomas *tertius* or of his mother, I can place him at once. He was certainly a son of one of the Thomas Goodwins, but I do not know which.

Lord and had ten children by her. . The fourth child was Nahum, born March 11, 1795, who married 1st, Mehitable Littlefield and 2d, Elizabeth Tibbetts. He had four children by his first wife and nine by the second wife; the next to the youngest child being Nahum F. Goodwin, born March 3, 1841, in Lebanon and married to Amanda Hall. They have five girls and two boys. They reside (1898) in East Lebanon.

MOSES GOODWIN has three wives assigned to him by Capt. Goodwin who states that Moses lived in Lebanon, Waterborough and Lisbon and "left children." The Captain was quite right as to the last remark for Moses had *two* wives and left twelve children by each wife. I am indebted to Hon. Oliver B. Clason of Gardiner, and Miss Jennie Briery of South Gardiner, for the data of Moses' family. The first wife was Emma or Eunice *King* (Miss Briery suggests *Keene*) and his second wife was Susan Murray of Windsor, Me. The children were twelve sons and twelve daughters. I can get only half of his first family—Gideon, Benjamin, Jonathan K., Joseph, Isaac and Clarissa. By his second wife he had Moses, Aaron, John, Jordan, Oliver, Elizabeth, William H., Eunice, Thomas, Mary, Phoebe and Charity. The son Jonathan K. married Rachael Towne and resided in South Gardiner and Dixmont. His third child, Rachel, married Uriah Briery and was the mother of Miss Jennie Briery of Randolph, Me. Gideon, the eldest son of Moses, never married. He was a devout and godly man, albeit an irrepressible joker, as the following will illustrate:

WHAT BROKE THE MEETING UP.

One seldom hears a story more piquantly flavored with the real old New England humor than that told in the Gardiner Reporter Journal about Uncle Gideon Goodwin, who, fifty years ago, was one of the "characters" of the town. At that time the Methodists used to gather at the houses to hold their prayer-meetings,

and as Gideon was a devout worshiper of that creed he was a regular attendant. One night the meeting was held at the house of Harlow Harden, and Gideon was there.

In those days excitement ran high, and just as the enthusiasm of the assemblage was wrought to the highest pitch "Uncle Harden," as he was always called, arose to his feet, and lifting up his hands, shouted in a voice full of fervor, "Glory to Gideon!" Hardly had the chorus of amens which this utterance called forth died away when Goodwin, bound to return the compliment, jumped up and said, "Glory to you, too, Uncle Harden!" That broke up the meeting.—Lewiston Journal.

SAMUEL GOODWIN (*Thomas, Thomas*), born April 12, 1789 at Old Fort, now Brownsville, Fayette County, Pa., was married, first, at Lebanon, Ohio, to Eunice Pearson, born 1796, died 1814. Samuel was married, second, March 19, 1815, at Lebanon, to Mrs. Eleanor (*Wiles*) Moon, widow of Phineas Moon and daughter of

John and Eleanor (*McKinley*) Wiles, Jr. John Wiles, Jr., is said to have been the only son of a John Wiles who was killed in the revolutionary war, and whose wife is thought to have been an Aiken. Eleanor McKinley was daughter of Rodger and Eleanor (*Shaw*) McKinley of Baltimore, Md., Rodger being a son of James McKinley, born 1708 in Ireland, died 1812 in Lebanon, O. Samuel Goodwin settled in Brookville in 1816 where he died June 26, 1851. His widow died May 18, 1873.

REV. WILLIAM REES GOODWIN, D. D., (*Samuel, Thomas, Thomas*), born July 7, 1832, in Brookville, was married first, August 5, 1856, at Brookville, by Rev. S. T. Gillet, to Susan Ann Keely, born April 4, 1838, in Mt. Carmel, Ill., a daughter of Rev. John Wesley and Elizabeth (*Fisher*) Keely ⁵, *John* ⁴, *John* ³, *Sebastian* ², *Michael Keely* ¹, and died at Lincoln, Ill., Sept. 29, 1868. Her father's mother was Ann Iddings, a descendant of Dr. Thomas Wynne who came with Penn in 1680, in the "Welcome," and was speaker of the First Assembly in 1682-3. Dr. Goodwin was married, second, June 24, 1869, at St. Louis, Mo., by Rev. B. F. Crary, D. D., to Mrs. Mary (*McAdams*) Smith. By occupation he is a

teacher and minister, in politics a Prohibitionist, and in religion a Methodist. They reside (1898) near Los Angeles, Cal. Dr. Goodwin was graduated from the Indiana Asbury University in 1856; was principal of the Goshen, Ky., Academy for one year; was president of the Brookville college; Professor of Belles Lettres in the Illinois Wesleyan University; twenty-five years a member of Illinois Conference; delegate to the General Conference; five years a member of the Rock River Conference and stationed at Park Ridge, one year; Austin, two years and at Chicago, three years. He is one of the best known contributors to the periodicals of the Methodist Church.

JOHN SAMUEL GOODWIN (*William Rees, Samuel, Thomas, Thomas*), born March 16, 1858, in Edinburg, Ind., was married October 7, 1880, at Danville, Ill., by Rev. William Rees Goodwin, D. D., to Mary Elizabeth Forbes, born June 9, 1858, in Danville, a daughter of Thomas Richard and Anna Eliza (*Robinson*) Forbes⁷, *Thomas Chester*,⁶ *Benjamin*,⁵ *Elijah*,⁴ *Joseph*,³ *John*,² *James Forbes*,¹ of Hartford, Conn. By occupation he is a lawyer, and in religion a Methodist. Mr. Goodwin was graduated from the Indiana Asbury University in 1877, the valedictorian of his class. He resided in Beloit, Kansas, from 1878 to 1888; was appointed judge in April,

1879; spent some time abroad in 1885-'86; resided in Danville, Ill., until January, 1891, and in Chicago thereafter. He is law partner of General John C. Black, ex-Commissioner of Pensions and at present United States District Attorney. He is interested very extensively in the breeding of registered Aberdeen-Angus cattle. He is the compiler of the genealogy of the Goodwins of Virginia and of the Goodwins of Kittery, Maine.
