The aim of this little volume is to present in as clear a form as possible the record of the Gresham Family in Virginia, and to show the English line from which they sprang.

The mutations of time and the ravages of war have made it impossible to secure full and complete records even of the Virginia branch of the Gresham family, and hence these records must of necessity be imperfect.

The booklets on this large and interesting family, which have previously been published by Mrs. W. H. H. Bagwell, of Richmond, Va., and by Alexander Taylor Strange, of Hillsboro, Ill., have been of considerable aid, as has the splendid English publication in two volumes, "The Life and Times of Sir Thomas Gresham," by John William Burgon.

Authority for the other data furnished has been obtained from the Virginia Historical Magazine, the William and Mary Quarterly, Crozier's Virginia Records, the vestry books and parish records of New Kent, Middlesex, etc., and from the original records on file in the Archives Department of the Virginia State Library and the Virginia Land Office, as well as from original wills from the counties.

These words of acknowledgement would be incomplete without mentioning the valuable assistance rendered by Mr. Wm. Broaddus Cridlin, author of Colonial Virginia.

Like most works of this character it is probable that many facts have been left out that should have been put in, while other data has been used that perhaps were better left out, but we believe that in all essential points the record is authentic.

ORIGIN OF NAME

LE GRESSE (Norman French), meaning: The Green.

In England there was added the suffix HAME—Home, House. Compounded: GREENHOME or GREENHOUSE. Thus we have GRES-

HAM(E), a combination of Norman and Saxon.

We have a survival of HAME in HAMLET; Old Saxon HAM(E); Old French Hamel, with the dimunitive ET. Also as a suffix in many names of places, as: GOTHAM, WESTHAM, etc. GRESHOLME, an island off the coast of PEMBROKESHIRE, Wales.

- I. EDWARD GRESHAM. Was living in County of Norfolk, England, temp. Edward III. (b. 1312, d. 1377) and Richard II (b. 1366, crowned 1377, d. 1400). Married and had issue.
- II. JOHN¹ GRESHAM. Gent of Norfolk. Living in County of Norfolk in latter part of fourteenth century. His will, dated 11-4-1492, mentions no heir, but James must have been a son of John. Married and had issue.
- III. JAMES² GRESHAM. Seated at Hole, County of Norfolk. Married: 1st.—Mary Rookwood.

V. SIR RICHARD'S GRESHAM, Knt. Sheriff of London 1531. Lord Mayor 1537. Died 2-20-1548.

The first mentioned seems correct, as it was Osterly Park that SIR THOMAS (12) constructed his palatial mansion "OSTERLY HOUSE", where Queen Elizabeth was elaborately entertained at a celebrated house party, an account of which may be found in the Encyclopedia of Biography. No issue.

VI. STR JOHN" GRESHAM.

Married: Francis, daughter of Sir Thomas Henry Thwaites, Knt. of Lound on the Wolds. She died Oct. ——, 1580.

16. ELIZABETH, married Sir Henry Neville, Knt., of Billingbere, Berks., a brother of Edward, Lord Abergavenny. It was from this marriage that the Lords of Braybrook were descended, (Burke's Peerage).

Sir John was knighted on Musselburgh Field Sept. 28, 1547. He died 1560, and leaving no male issue was succeeded by his brother:

VI. SIR THOMAS¹² GRESHAM, "one of the most opulent and eminent citizens of his time." He lived in London. Knighted in 1559. Founded the Great Mart of London, later called the Royal Exchange. Its foundation was laid in 1566. Description of the elaborate ceremonies can be found in "Extinct and Dormant Baronetage, etc.," p. 226. He erected at Osterly the magnificent structure still standing and owned by the Earls of Jersey. (See note under caption of Richard (8).

17. RICHARD, who died in 1564, at the age of 16 years. SIR THOMAS died Nov. 21, 1579, and is buried under a large monument in the Parish Church of Great St. Helens, London. Leaving no male issue, and his brother William having died, the succession reverted to his Uncle John (10) or his male issue.

· VI. CHRISTIANA¹⁴ GRESHAM.

Married: Sir Thomas Thynne, of Longleaf, Wiltshire, ancestors of the Marquesses of Bath. She inherited the estates of her brother, SIR THOMAS.

V. SIR JOHN¹⁰ GRESHAM became the head of the house upon the death of SIR THOMAS (12) as the male line from SIR RICHARD⁵ had become extinct. He having died prior to the death of Sir Thomas, his grandson, William³³ became his heir. (See later). Sir John was knighted in 1537. Sheriff of London 1537, (the year his brother Thomas was elevated to Lord Mayor). Became Lord Mayor 1547, and died Oct. 25, 1556. His wife died Sept. 21, 1538.

Married: Mary, daughter and co-heir of Thomas Ipswell, of London.



Sir John Gresham died September 20, 1801, leaving no male heir and there being no male heir in the direct line of the three brothers, Richard (8), Thomas (9), or John (10), nor in the line from the 6th generation the Barony became extinct. The only descendants in the male line were living in Virginia. Apparently no claim was ever made for the line of succession.

^{*}In Burke's Landed Gentry, pp. 488, it is claimed that Catherine Maria was the daughter of Sir Thomas Gresham, bart. In Burke's Extinct and Dormant Baronetcies, p. 228, statement is made of the full pedigree, and shows she was the daughter of Sir John.

IV. WILLIAM⁵ GRESHAM. It is reported in Burke and several other genealogies of the English family of Greshams that William (5) died young, saying nothing in regard to his marriage or as to any issue. The will of his widow, Agnes Porter, made in 1520 (Aug. 6), discloses the fact that he left issue as follows:

This branch of the family could not succeed to the baronetcy vacated at Sir John (67) death, as the first Kt. Sir Richard (8) was of the 5th generation, whereas William (5), father of James (74) was of the 4th generation. Only those of descent direct since the 5th generation could succeed. The next chapter will treat of the Emigrants, John and Edward.

JOHN GRESHAM47a

John Gresham was the head of the Maryland branch of the Gresham family. He came to America with his son John, before 1640.


He was a son of Sir Thomas Gresham⁴³, the son of Edward⁴⁰, and not the son of Sir Thomas Gresham¹², the founder of the Royal Exchange and

of Gresham College, as some writers have stated.

Probably no member of the Gresham family was more familiar with the family history than the late Peter Hoss Gresham, who for many years was in the employ of the U. S. Government at Washington. He had gathered together, both in this country and in England, the material for a Gresham book, which was destroyed in a fire.







ARCHIBALD GRESHAM

From a letter written by him to a relative we quote the following interesting data regarding the line of the John Gresham branch of the family:

"While in London in 1888 I visited the Royal Exchange, Gresham College, The Guildhall of Gresham, and other places of interest to the Greshams, all founded by Sir Thomas Gresham."

"John Gresham in 1641 was a member of the General Assembly of Maryland, which met at St. Mary's under Governor Leonard Calvert. In 1648, he, with others of the Protestant faith, were severely prosecuted by Gov. Thos. Greene, a Catholic. His home on Kent Island was seized and he was forced to remove to Virginia for a time. The land on Kent Island had been given to John Gresham and to Col. Claiborne by King Charles. for meritorious services. Their possessions, however, were afterward regained.*

"John Gresham, Gent., son of the above, born in England, came to America with his father and mother, and was afterward known as John Gresham, Sr. In 1864 he resided, according to the records, in his home near Annapolis, known as "Fortuna." He took patent for 500 acres of land on which he expected to found an institution of learning, modeled after the "Gresham College" of London, but owing to his early death in 1713, his ambition was never realized. He was a vestryman in St. Ann's Church, Annapolis.

^{*} Col. Claiborne never regained his possessions.

"John Gresham, Jr., son of the above was 'High Sheriff' of Annapolis from 1705 to 1723, when he died in office. He left six children; the sons were John, Thomas and Richard. He left a will which I was permitted to examine. His wife on her death also left a will which I inspected. Both of these wills gave to their son Richard, certain lands at Gravesend, England, and in Kent, Md. The descendants of this Richard Gresham still live in Kent Island and some of them on the very lands bequeathed in these wills."

"Following the above in the line of descent there were Thomas Gresham, son of John Gresham, Jr., from 1752 to 1806, then John Gresham,

son of Thomas Gresham, from 1770 to 1863."

"My wife, Rebecca Gresham, who is my fourth or fifth cousin, was the daughter of Hoss. R. Gresham and Ann Eagle Gresham, and was the youngest of nine children. The place of her birth was in a long brick house on Chesapeake Bay, being in the same house where her father, and I think her grandsather, were born."

"The Gresham College Tract, was near Abbington, in Hartford County,

where Baltimore was first started, now known as 'Old Baltimore."'

"The wife of Ex.-Governor Brown, now senator from Georgia, was the daughter of Rev. Joseph Gresham, a descendant of the Maryland Greshams."



From this line has sprung the Greshams of the Middle West, so ably depicted in the interesting booklet issued by one of their descendants, Alexander Taylor Strange, in 1913, and among whom were Mr. Strange's grandfather, Archibald Gresham, and the well-known scholar, Peter Hoss Gresham, pictures of whom we print as types of the "Middle West Greshams."



Gresham (HASKINS)

- I. EDWARD⁴⁷b. Son of Sir Thomas⁴³. 10th generation from Edward (1), emigrated to Virginia about 1650, and located in New Kent County. He purchased 500 acres of land which had been patented by Robert Joanes in 1658, which patent was renewed by patent direct to Edward Gresham, issued by Sir Wm. Berkeley, Governor, Mch. 18, 1662—L. B. 4, 276. June 10, 1675, he received grant from Gov. Berkeley, of 111 acres in New Kent adjoining above grant. (L. B. No. 6, p. 556). In 1690 he was granted 640 acres in New Kent, same locality as above, in which patent reference is made to his patent of 1662 above mentioned. (L. B. No. 8, p. 98.) We find no record of his marriage, but as his estates were just across the Peanketank from Christ Church in Middlesex, entries in the register of that Parish would indicate that he had issue:
- II. THOMAS GRESHAM, and probably others.
 On June 16, 1704, he with Jno. and Peter Rogers, Edw. Pigg and Jno. York, were granted 1525 acres on the Mattapony River, about two miles from Doeg Town, for transporting thirty-one people to the colony. His wife was named Mary Elizabeth.

 - JOHN® GRESHAM, son JOHN (91). Patented land in Goochland Co., June 16, 1744, on north branch Willis Creek adjoining lands Henry Cary, etc. On the formation of Albemarle that same year this land was in the new county, and in 1761 when Amherst County was formed from Albemarle this land was in the latter county. (L. B. No. 22, p. 101). He had a son JAMES GRESHAM (100), who also patented land adjoining his father's in Goochland County. John (99) was a Colonial soldier. (Hening VII, p. 23).

EDWARD³⁶ GRESHAM, son Thomas (98). Born at Briar Hill, King and Queen Co. Patented land in Amelia County on Harris Creek on September 5, 1747. (L. B. 27, p. 346). This land was in Prince Edward County when that county formed in 1754. No record as to who he married.

- V. LAWRENCE¹⁰¹ GRESHAM. U. S. Census shows him in Prince Edward in 1785 with five males over 16 years of age.

WILLIAM¹⁰² GRESHAM. U. S. Census shows him in Halifax in 1782 with 7 males over 16. In 1785 he is shown with only six, so that one must have branched out or have died.

ANTONY¹⁰³ GRESHAM. In Halifax in 1785 with 10 males over 16.

PHILLIP¹⁰⁴ GRESHAM. Living in Halifax in 1767 and in 1782. Had a son named Thomas with him as early as 1767. In that year there was also a Thomas, son of Thomas living there, and a John, son of Thomas. The record spells Gresham in Thomas' name with an "e" and in John's name the letter "i" is used.

ASA¹⁰⁵ GRESHAM. Lived in Brunswick County. His will dated Jany. 15, 1815, probated the 23 Jany. 1815. (Will book 8, p. 125) mentions sons Gregory and John, daughter Christianna Watkins, wife Elizabeth and grandchildren William J. Gresham and Louisa G. Watkins. The will of his wife, Elizabeth Gresham (W.
