INTRODUCTION

To all descendants of the late Thomas Dunbar Green and Julia Dismukes Green, his widow, the writer offers this imperfect sketch of their respective ancestries. Thanks to the lively interest which both shared in genealogy, there was ample data from which to put together this study. Much of it being fragmentary, some research was necessary, but the work presented herewith is essentially that of a compiler rather than a researcher. It is hoped that among their descendants there may be in each generation someone with the interest to continue the record, and to these dedicated kinsmen I hope the present work will be of some assistance.

There are those in this iconoclastic age who consider genealogical research a form of snobbery or, at best, a waste of time. If there are such among you, I would point out that the study of the history of our country is not a sign of chauvinism nor is it considered a waste of educational effort. Those of us whose forebears helped even modestly to shape the destinies of this great nation have a heritage of which we can be justly proud. To discover among our own kinsmen a signer of the Mayflower Pact, an early colonial governor, the first president of the oldest college in this country, two signers of the Declaration of Independence, the most respected general of the Civil War, a celebrated, albeit eccentric, portrait painter is, in a way, a reward for our interest. But the great satisfaction which we should get from this study is that the farmers, the doctors, the educators, the businessmen who were our forebears were among the intrepid colonizers of this hostile land, the soldiers who fought for its freedom and the men of vision who built the resulting nation in a comparatively short time to its present eminent position of world leadership. We owe these ancestors of ours more than the oblivion which is the eventual fate of all but the great historical figures. The least we can do for them is to keep their memories green within the family, if you will excuse the pun.

Presented in the standard form the charts should be easy to follow. Each name is numbered for convenience in referring to the biographical sketches in the next section. An account of the origin of the Green (Greene) family begins the work, and at the end will be found an exercise in "advanced genealogy", the tracing of one line into the remote past. While all other lines are traced only to the "immigrant", many are susceptible to further research beyond the sea, notably the Bolling, Lee and Johnstone lines.

It is hoped that you will all derive some interest from a perusal of these pages; and to those whose interest leads them to further research - good hunting!

ORIGIN OF THE GREENE (GREEN) FAMILY

According to Lora S. La Mance, author of "The Greene Family and its Branches" (Mayflower Publishing Co., New York, 1904) the founder of the family was Lord Alexander de Greene de Boketon, who received his titles and estates from King John of England. All that we know of the shadowy figure of Alexander is that he was a Knight at the king's court, and was the great-grandson of one of the Norman nobles who invaded England with William the Conqueror in 1066. King John bestowed the estate of Boketon in Northhampton upon him in 1202 (Ref: "Pedigree of the Family of Greene," by Surgeon Col. John Joseph Greene of Dublin, Ireland, 1899). When we remember that mean, parsimonious King John had a way of rewarding a dirty deed done in his service by an extravagant gift filched from some noble who may have offended him, and when we recall that the date of Lord Alexander's patent followed on the heels of a peculiar crisis in King John's history, we may safely assume a connection of these events. Lord Alexander was a Great Baron and as such held a minimum of six thousand acres, probably many times this. He assumed his surname after his chief estate, Greene de Boketon, which literally translated into modern English means Park of the Deer Enclosure. A greene in the early days was a park, and boketon is an old word meaning bucks' (bokes) paied-in enclosure. Boketon became Buckston and later Boughton, its present name. For a coat of arms the Lords de Greene chose a device that suggested the Boketon part of their name. It was three bucks trippant or (gold) upon an azure field. For a long time the full name de Greene de Boketon was used in legal documents. In everyday speech, however, it was shortened to de Greene. During the reign of Henry VI (1422 - 1471) with its attendant French wars, the de Greenes dropped the patrician "de" as too gallic in sound for patriotic Englishmen.

Alexander's son, Sir Walter, the second Lord de Greene, is thought to have been a knight in the seventh Crusade which ended in 1240. He is listed in old rolls of the twentieth year of Henry III (1236) and the forty-fifth year of the same king (1261). The third Lord, John, a grandson of Alexander, was undoubtedly the "Sir John de Boket" who records show accompanied Edward I on the last great crusade and died in Palestine in 1271 *(Ref: Halstead's Genealogy, 1585). Sir John left an infant son,

* Robert Halstead was the pen name of the second Earl of Peterborough, himself of the blood of Greene. His Genealogy which stands at the head of English works of this kind, abounds in verbatim copies of official state records, most of them in Latin and Norman-French.

Thomas, who became the fourth Lord de Greene in 1272. Sir Thomas was succeeded in turn by his own son, Thomas, born in 1292. This fifth Lord de Greene contracted a high marriage with one of royal descent and when about forty was made High Sheriff of Northampton (1330 - 1332). Halstead tells us, "The office was not as in these days, but esteemed equal to the care of princes, an office of great trust and reputation, and justly esteemed honos sin onere." Halstead further states that Lord Thomas' marriage to Lucie, the daughter of Eudo de la Zouche, and Millicent, one of the sisters and heirs of George de Cantelupe, Lord of Abergavenny, brought him further estates. Lady Lucie traced her ancestry to the Capetian kings of France. The only son of this marriage, Sir Henry, the sixth Lord de Greene, became Lord Chief Justice of England in 1353 and received many honors from King Edward III. He was Speaker of the House of Lords in two parliaments (1363 - 4) and later the King's nearest Counsel. He established the Boughton Fair, an annual event which became second only to the London Fair itself. He was early married to Katherine, the daughter of Sir John Drayton of Drayton. By Katherine, the Lord Chief Justice had four sons and two daughters: Sir Thomas, the heir (1369 - 1417), who became the seventh Lord de Greene; Henry, afterwards knighted by King Richard II, and made heir to his uncle, Sir Simon Drayton; Nicholas and Richard, who never married and supposedly died young; Margaret, who married Lord de la Zouche, and Amabila, who married Lord Ralph Raynes of Clifton. Lord Chief Justice de Greene acquired the Manor of Norton from Baron Morley, and changed its name to Greene's Norton. It was ever after the seat of the Lords de Greene, and Sir Henry, who died in 1370, was the last of the line to be buried at Boughton. There is an old and handsome church at Greene's Norton and here the Greenes, from Sir Thomas on, are buried. Some of these tombs of rare marble support effigies or recumbent statues representing those buried beneath.

Sir Thomas, the seventh Lord de Greene inherited only Boughton and Greene's Norton, while for some unexplained reason the Lord Chief Justice bequeathed to Sir Henry, the younger son, the bulk of the estates, over thirty manors, each of which today would support a baronetcy. Sir Thomas married Sir John Mablethorpe's daughter. Their only son, Sir Thomas, became the eighth Lord and there followed a succession of Thomases, ending with the sixth to bear the name, who was the last Lord Greene. This final Sir Thomas, in the last year of his life, was thrown into prison by King Henry VII on a charge of plotting treason. Ironically, the old Lord's granddaughter came to sit on the throne of

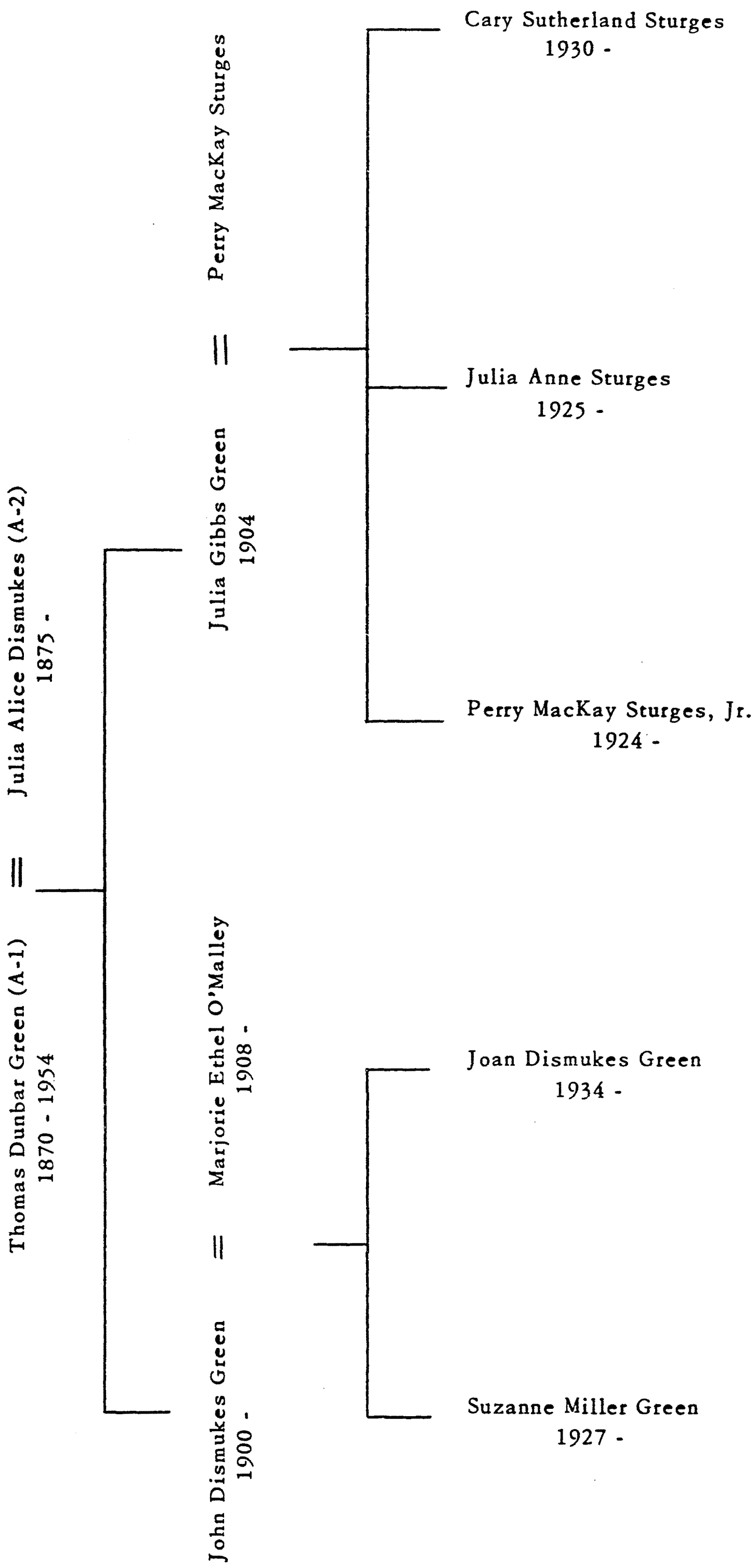
England as the wife of the harsh king's son. Though the last Lord Greene had no male heir, he had two daughters, one of whom, Matilda, married Lord Thomas Parr. They had one son and two daughters, one of whom married William Herbert, Earl of Pembroke, and the other, Catherine Parr, became the last Queen of King Henry VIII.

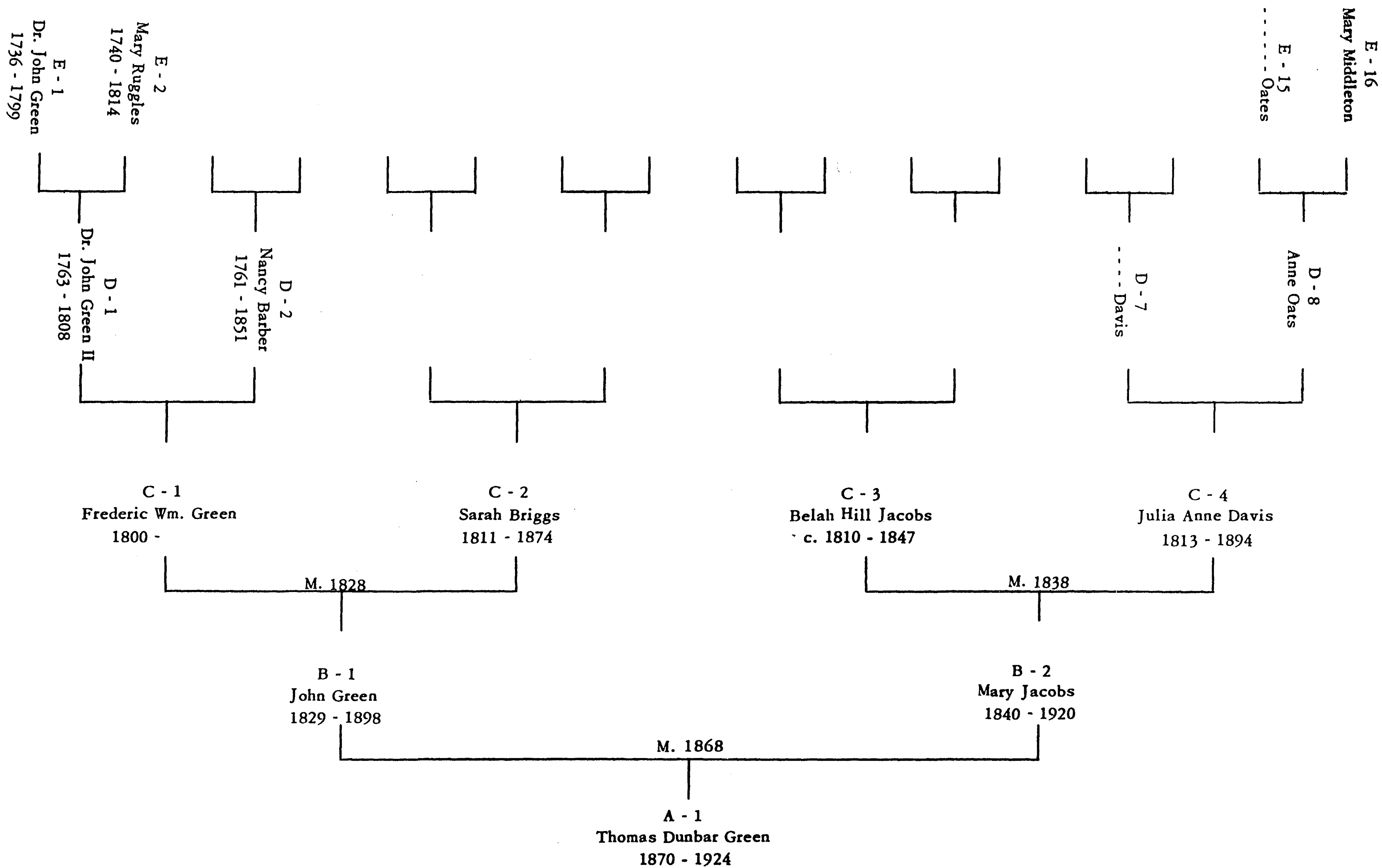
Let us go back now to the Lord Chief Justice's second son, Sir Henry. He married Matilda, sole heiress of her father, Lord Thomas Manduit. Through his childless uncle, Simon, Lord of Drayton, Henry inherited the latter's title and estates. It was this Sir Henry de Greene who was beheaded by Bolingbroke for his loyalty to Richard II (See Acts I and II of Shakespeare's "Richard II".)

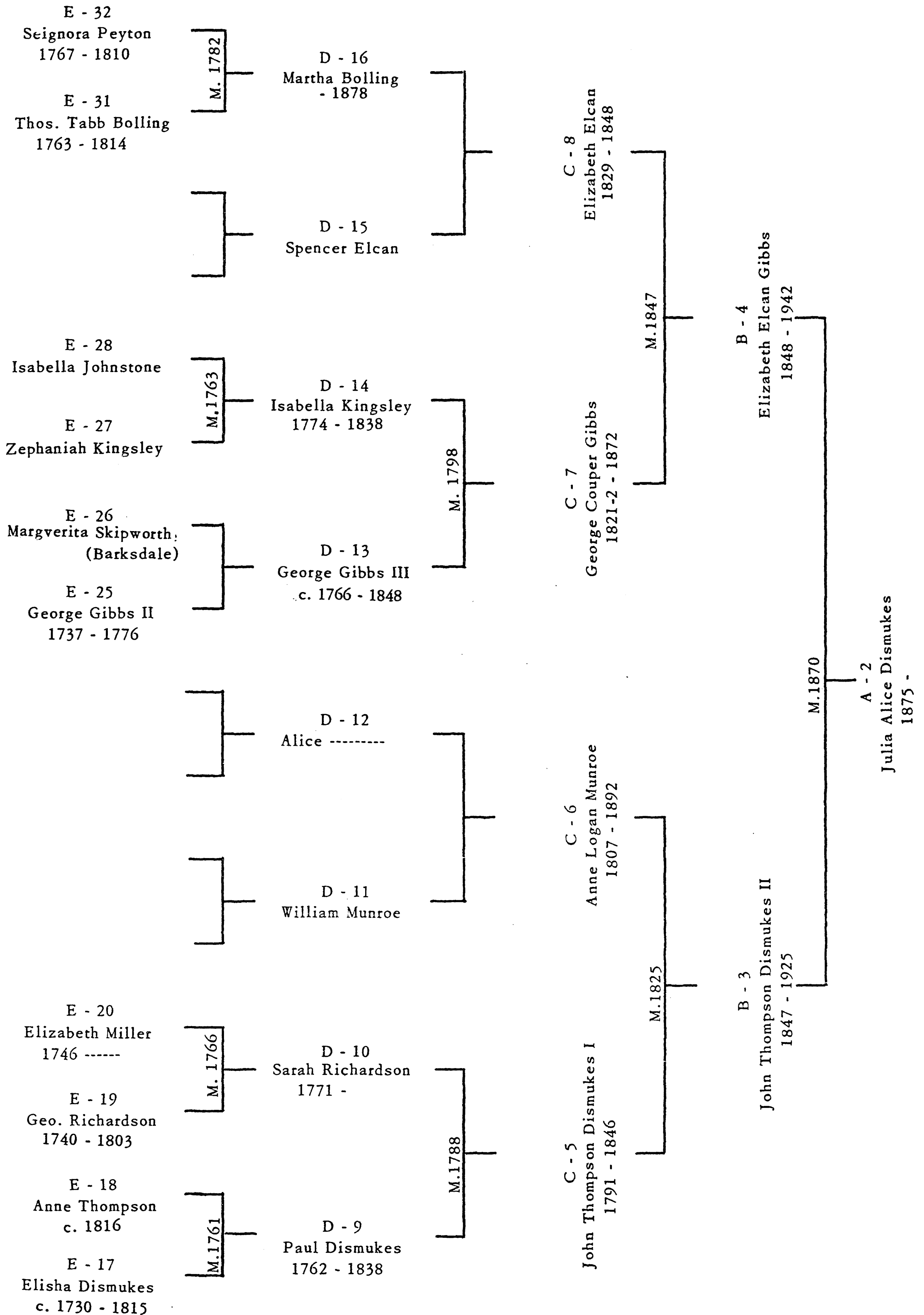
The beheaded Sir Henry de Greene and Lady Mathilda left seven children; Ralph, John, Thomas, Henry, Eleanor, Elizabeth and Mary. Two of the daughters married noblemen; Ralph and John were successively Lords of Drayton. The great estate, one of the largest in England, in the end passed through the last heiress of John's line to the Earls of Wiltshire and Peterborough, her descendants. Of Henry, the youngest son of Sir Henry, we know no more. He probably died in some of the wars of the "bloody Century", leaving no children.

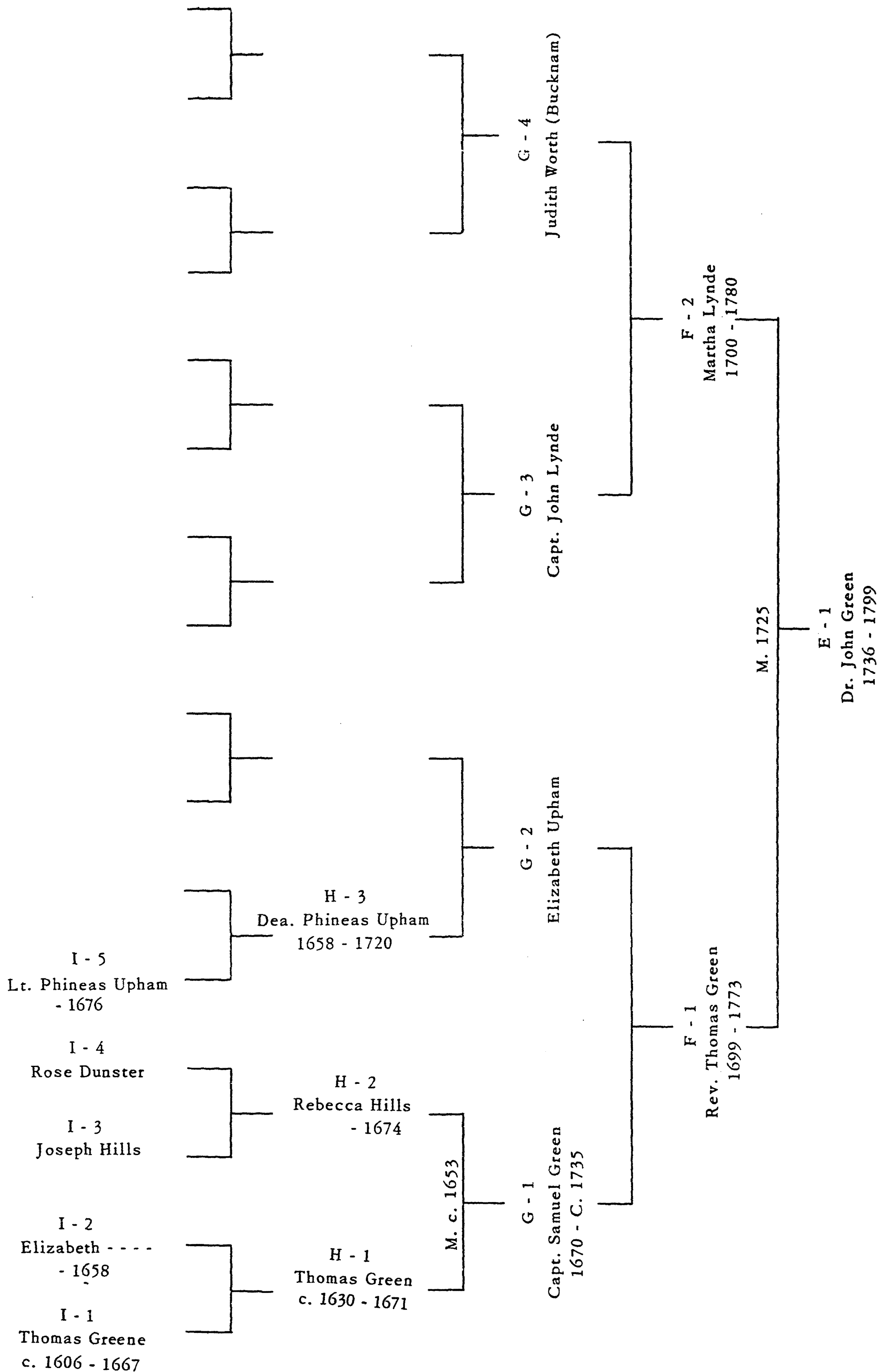
Thomas, the third son, was the ancestor of what Mrs. La Mance refers to in her book as the Gillingham Greenes, that branch of the family of which several members migrated to New England circa 1635. According to this author Thomas Greene, senior, (I-1) and Thomas Green, junior (H-1), of Malden, were not of this branch but were closely related to Ruling Elder John Greene who came to Charlestown, Mass., in 1632. (Ref: P. 39, The Greene Family and its Branches). Elder Greene, she goes on to relate, traced his ancestry to one of the younger sons or grandsons of Sir Alexander, the first Lord de Greene. While it is anticlimactic to learn that the crusading knights, Sir Walter and Sir John, the Lord Chief Justice and the beheaded Sir Henry were our collateral rather than direct ancestors, it is interesting to follow the fortunes of this rich and powerful medieval family which gave the American Greenes (and Greens) the legacy of their proud name and coat of arms, if not their long since dispersed fortune.

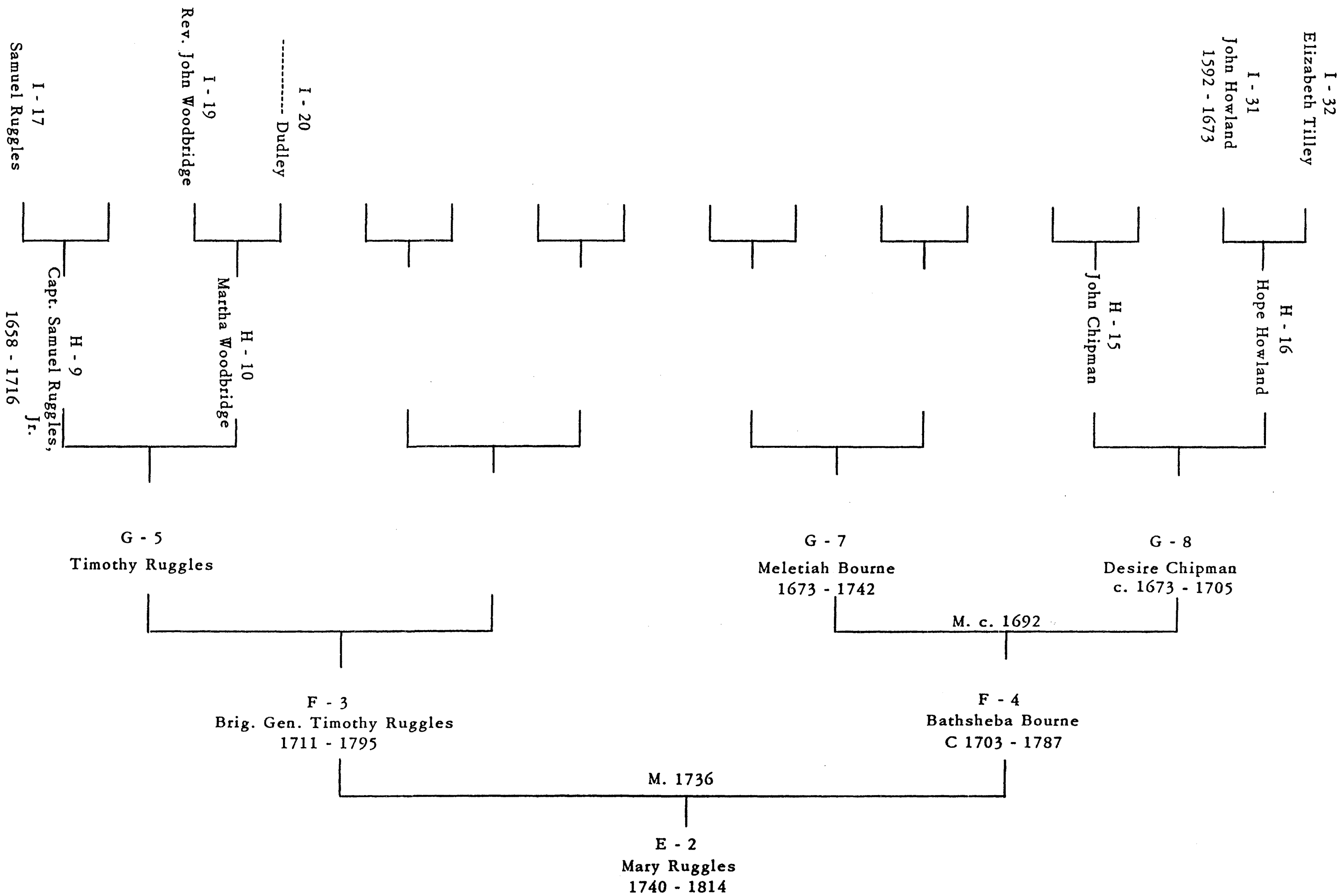

Thomas D. Green was obliged to leave school at fifteen to support his mother and younger sister and brothers when his father's health failed. He later entered the hotel business at the Battery Park in Ashville, N. C. He moved to Virginia at about the time of his marriage and to New York in 1903 where he made his permanent home. He first managed the Woodward at Broadway and 55th St., which hotel he later purchased. He was President of the Hotel Association of New York City for several terms and in 1926 was elected president of the American Hotel Association. From an ineffective, deficit-ridden organization representing only two-thirds of the hotels in the country, he converted A. H. A. in a few short years to a powerful trade association numbering as its members all of the representative hotels of the United States, Canada, Mexico and the Islands. With his close friends and associates, E. M. Statler and John McE. Bowman (of Biltmore fame), Mr. Green purchased the Hotel Red Book for the benefit of A. H. A. and made it the Association's official directory. He served the American Hotel Association as President for fourteen years and continued as President of the Red Book corporation until his death. For his civilian war work in World War I, Mr. Green was made a Chevalier of the French Legion of Honor, a Commander of the Order of the Crown of Italy and of the Order of the Crown of Belgium.

John Green was adopted at an early age and brought up in Worcester, Mass. by his father's brother, Dr. John Green, eminent physician (Brown University, 1804; elected vice president of the Medical Convention of the United States at St. Louis, 1854; later "retired with an ample fortune")*

John Green went from Worcester to Mississippi as a young man, and later returned to Columbia. He was in the Confederate Army during the Civil War. Lived the rest of his life in Columbia, where, until his health forced him to retire in 1885, he operated a cotton mill.

John T. Dismukes was prominently identified with the banking business in Florida. Founder and President of the First National Bank and the Peoples' Bank for Savings in St. Augustine, he was for several years a member of the Executive Council of the American Bankers Association.

George Couper Gibbs was born while his parents were on a visit to the Couper plantation at St. Simon's Island, Georgia. In those days of difficult coach travel, such visits often lasted several months. He was named Couper in honor of his parents' host.

In the Civil War he was Colonel of the 42nd North Carolina Volunteer Regiment, Confederate States Army. Toward the end of the war, he commanded the troops of the post at Andersonville, Georgia, where the infamous prison was in charge of the controversial Capt. Wirz, who was tried by court martial in Washington after the war and hanged. Col. Gibbs testified at this celebrated trial that Wirz "had sole authority under (General) Winder over all the prisoners; that dogs were kept to hunt down escaping prisoners (Ref. "This was Andersonville", by John McElroy, McDowell, Obolensky, Inc., New York, 1957; p. 291). Also at the trial ". . . Col. Gibbs . . . and numerous other witnesses testified as to the prisoner (Wirz) ordering men into the stocks and the chain gang. In some cases men subjected to this treatment were very greatly debilitated, and in other cases they had just been brought back wounded by the hounds". (Ibid. p. 315)

Col. Gibbs's daughter, Elizabeth Elcan Gibbs (Dismukes) (B-4) told the writer that her father would have been brought to trial with Wirz had several former Union prisoners not testified as to his humanity in a situation not his own making.

George Couper Gibbs was a first cousin of Anna McNeill Whistler, subject of the famous portrait "Whistler's Mother", and a first cousin, once removed, of the artist, Whistler's grandfather McNeill having married a sister of George Gibbs III (D-13)

Known to her friends in Memphis as "Pretty Betty Elcan", this vivacious young lady of eighteen was first seen by her future husband, George Couper Gibbs, then a lieutenant in the Army on his way to Mexico, at a Ball in Memphis. When he and his companion, Lt. Kirby Smith, also of St. Augustine, first saw her she was washing her face from a bowl of water which had been brought to the ballroom floor at her request - to prove to the admiring throng that her rosy complexion was her own. Lt. Gibbs swore then and there that he would marry this girl if he returned safely from Mexico. And marry her he did, several months later, bringing his bride back with him to St. Augustine.

She died just one month after the birth of her baby.

Page 183 of the Memoirs of Gen. J. Gardner Swift makes the following reference to George Gibbs.

"Early in Sept. established my family on Brooklyn Heights at the house of a friend George Gibbs Esq. and placed my sons at Mr. Armour's School. On the 14 of this month (Oct) I purchased from George Gibbs the place where I was living with him on the Heights, for ten thousand dollars - sixteen lots forming a square overlooking the East River and the city harbor - and on 1st Nov. took possession and commenced housekeeping there with my family, and commenced trimming a large grape vine that Mrs. Gibbs had transplanted from Gen'l. Smith's garden in Smithville, N. C., and I gave the cuttings of the vine to Wm. Prince, the florist and gardiner at Flushing, who wished to name the grape "The Louisa" for my wife, but both she and myself deemed Mrs. Isabella Gibbs entitled thereto, and accordingly the vine was named The Isabella, and I gave the cuttings to many of my neighbors in Brooklyn. Thus originated the Isabella grape."

"Thomas Green acquired a knowledge of medicine and surgery from two surgeons of the English Buccaneers who boarded with his father for many years, having come in, and surrendered themselves under an offer of pardon from the English government to such as should surrender themselves within a specified time. These surgeons instructed Thomas in what they knew of those sciences, and gave him a few medical books. With this preparation, added to a vigorous intellect, and uncommon practical wisdom, he was enabled to enter upon and pursue the practice of medicine with great success. His practice extended to various parts of the province, and even to Rhode Island and Connecticut.

"He was not more eminent as a physician than as a divine. Having embraced the sentiments of the Baptists, he organized a church and society of that denomination in South Leicester, and was ordained their pastor in 1736. He supplied his pulpit many years, he disseminated his principles through a wide circle, and his church became large and flourishing. He gave a house and a farm for a parsonage, a lot of land for the meeting house and for a burial ground. He and his wife were buried in the lot thus given; but their remains and those of his father, Captain Samuel Green, have recently been removed by his descendent, Dr. John Green, to the rural cemetery in Worcester. The inscription on his grave was "Erected in memory of Doctor Thomas Green. He was pastor of the Baptist Church in Leicester and a noted physician. He departed this life August 19, 1773, aetatis 74"

Green of Worcester, which thus distinguishes him from other Samuel Greens, "that Samuel Green which married Elizabeth Upham". That township was granted by the General Court, February 10, 1713 - 14, and Captain Green was one of the committee (with Col. Wm. "There are reasons for supposing that Thomas Green(e) came from Leicestershire, but no proof of the fact. The time of his arrival in this country is also uncertain. The first record in which his name appears, so as to identify him, is 1653 when his youngest daughter, Dorcas, was born. Yet he doubtless came many years before, probably 1635 or 1636. We are inclined to the opinion that he lived in Ipswich until 1649 or 1650, and then removed to Malden. He certainly lived in Malden as early as October 28, 1651, when his wife, Elizabeth, their daughter bearing the same name, signed a petition to the General Court. (Ref. Bi-centennial Book of Malden, p. 140)

"He had a farm of 63 acres in the north part of Malden, in that part which is now the town of Melrose. Part of this farm remains to this day (1858) the possession of his descendents. He was selectman of Malden in 1658 and was several times on the grand jury of the county of Middlesex.

"In many, perhaps most of the earliest records, the name was spelled with the final "e", but the great majority of the descendents of Thomas Green(e) have not used the final vowel."

He almost never saw these shores as he fell overboard during a storm in mid-Atlantic and was saved from death by catching hold of a halyard which was trailing in the water. He was the 13th signer of the Mayflower Compact. John Carver, the first Governor and his wife died in that first terrible winter, and it is thought that Howland inherited the Governor's estate. In 1626, he was one of "ye cheefe(s) of ye place" along with Bradford, Brewster, Standish and others. In 1630 together with Edward Winslow and John Alden, he was appointed as an alternate to Myles Standish, who was the attorney for the Warwick Patent sent over by the Council for New England. During 1633-35 he was an assistant or member of the Governor's Council, and from 1641 he was frequently a deputy or representative to the General Court. Howland and his wife, Elizabeth Tilley, had ten children, all of whom lived and had descendants.

In their declining years, they lived with their son, Jabez Howland in a house on Sandwich Street, Plymouth, Mass., which had been built in 1666 by Jacob Mitchell and acquired by Jabez Howland in 1667. This house was used as a residence continuously until 1912 when it was bought by the Pilgrim John Howland Society and restored to its 17th century appearance.

Dudley became interested in the formation of the Massachusetts Bay Company, and in 1630 he sailed on the Arbella with Winthrop, Saltonstall and others of the chief men.

They arrived at Salem, June 17, and first settled at Newtown. Before leaving England, Winthrop had been elected Governor and Dudley Deputy Governor. He was elected Governor in 1634, 1640, 1645, and 1650. When the New England Federation was formed in 1643, Dudley was one of the two commissioners chosen by Massachusetts to confer with the other colonies. He was one of the committee appointed in 1637 to consider the establishment of a college at Cambridge. He was one of the first Overseers of Harvard, and in 1650, as Governor signed the charter for this institution.

Dudley was an able man with marked executive ability. He was something of a scholar and wrote poetry. In him New England Puritanism took on some of its harshest and least pleasant aspects. He often won approval but never affection. He was positive, dogmatic, austere, prejudiced, unlovable. He dominated by sheer strength of will as a leader in the community.

This vessel brought the new governor, Sir George Yeardley, and about 100 passengers, among whom were Dr. John Woodson, of Dorsetshire, and his wife Sara, whom he married in Devonshire. Dr. John Woodson matriculated at St. Johns College, Oxford, March 1, 1604. Dr. John Woodson located at Fleur de Hundred, on the south side of the James River, in what is now Prince George County. He and his wife, Sara, and six negro slaves were registered at Fleur de Hundred in 1623. Col. Lee was a member of the House of Burgesses for York County in 1647; for Northumberland County in 1651. He was Attorney-General of the Colony in 1643; Secretary of State, 1649 - 1652; Member of the Governor's Council, 1651 - 1664. (Ref. Stanard's Colonial Virginia Register, pp. 21, 25, 36, 66, 68). Col. Lee made frequent visits to England; while there in 1663 he made his will (Ref. Lee of Virginia, by Edmund Jennings Lee, p. 63)

*Richard Lee II was the father of Thomas Lee who built Stratford, and, through him, the grandfather of Richard Henry Lee, who introduced the resolution for independence and who, with his brother, Francis Lightfoot Lee, signed the resultant Declaration of Independence in 1776. Richard Lee II was also the father of Henry Lee I, whose son Henry Lee II was the father of "Lighthorse Harry" Lee of Revolutionary War fame. General Robert E. (Ref: Stanard's Colonial Virginia Register, p. 56: Journal of the Virginia House of Burgesses, 1619 - 58 - 59). Capt. Thomas Purefoy I named one of his estates of 1000 acres "Drayton", doubtless after the place of that name mentioned by Burke as the seat of the Purefoys. Lucy Purefoy, wife of Thomas Purefoy I, made a deposition, dated 1642, in which she said she was about 42 years old, and had been in Virginia as early as 1629; in 1656 she was spoken of as the relict of Captain Purefoy. In 1675 a petition was presented to the court in behalf of the orphans of Thomas Purefoy, deceased. (Ref: Virginia Magazine of History and Biography, Vol. I, pp. 417-8) This refers to Thomas Purefoy II. In 1656 a grant was made to W. Moore for land on Old Poquoson, which had been assigned to him by Lucy, relict of Capt. Purefoy, and confirmed by Thomas Purefoy II, his son and heir.
