GOODRICK OF LINCOLNSHIRE AND CAMBRIDGE.

P.C.C. (Doggett 29.) Dated 8 October 7 Henry VII. [1491].

Will of John Goodernte made at Bolingbroke. To be buried in the p'isshe churche of Bolingbroke. To the p'son of the p'ish church of Bolingbrooke for my tithes forgoten xx3. To the churche werke of the Cathedrall Church our Lady of Lincoln iij's iiijd. To the Orfaunts of Saint Kat'yn of Lincoln iijs iiijd. To the church werke of Bolingbroke vjs viijd. To the church werke of Kyrkeby vjs viijd. To the church werke of Hareby vjs viijd. To the church werks of xx p'isshe churches to ev'y church iijs iiijd. To ev'y of my God sonnes and God doughters xxd. A priest to be found "to singe for the soules of me my wif and for the welfare of my wif's children." etc., for x yeres. To Agnes my wife c marks. To William my sonne xli. To Richard my sonne xli. To Johanne my dought' xlii. To Margaret my dought' xxii. To Elizabeth my dought' xxii. To Ales my dought' xii. To Edward my bastard sonne xxii. "Money bequeithed to the said Johanne Margaret and Elisabeth to be paid to them" at 21 or marriage. (Provisions in case of a daughter's death before then.) Said wife to have "the rule and guyding" of my children and hers and my ex'ors to "bere the coste and charge of their said finding of my goods," etc., "withoute abatement of any of thos sumes which I have afore bequethed if it may be borne of the residue of my goodes, if not then it to be taken of that that Enderby and Bolingbroke for terme of her lif"after her death to son Richa and his heirs—remainder to son Willm and his heirs. Agnes my wife to "have all my household" during her life-what remains after her decease "to be devided amonges my children." I "ordeine" Andrew Dymmoke the elder, to whom I bequeith xii, and William Gooderyke my sonne, to whome I bequeith x11, ex'ors. Residue to wife and children "after the will and plaisure" of sd ex'ors.

Proved 8 July 1493 at Lamehith [Lambeth] by William Gooderike, son and executed (power reserved for Andrew Dymmoke).

P.C.C. (Bennett 9.) Dated 9 September 1508.

Will of Richard Coolergite of Bolyngbrowke. "In the name of God Amen The ixth day of the moneth of Septembr In the yere of or Lord mlveviij I Richard Gooderyke of Bolyngbrowke m'chaunt of the Stapull of Caleis in goode and hole mynde make my testament in this wise first I bequeth my soule to Almighty God and to his blissed moder our lady Seynt Mary and all the holy company of heven and my body to be buried in the church of Bolyngbrowke. Also I bequeth in the name of my mortuary my best horse. Also I bequeth to or lady werks of the monastery of

lincoln xx^d. Also I bequeth to the moderlasse childern att Seynt Kateryns w^tout the walls of lincoln viij^d. Also I bequeth to the high ault^r of the church of Bolyngbrowke xij^d. The Residue of all my goods not yet willed ne bequethed I will and geve theym to Alice Goderyke my wif whome I ordeyne and make myn executrice. And the said to pay all my detts and to bryng vpp my childern. And the saide Alice to dispose for me in the pleasure of Almighty God and helth of my soule and all xp'en soules Amen. In wittness of this my last will I haue sette my seale, thies beyng p'sent William Gooderyke of Estkyrby, Robert Coup', p'son of Bolyngbrowke, and Robert Wright of the same, and other."

Proved 17 November 1508 at Lamehith [Lambeth] by Thomas Ostrich, procurator for Alice, relict and executrix.

P.C.C. (Ayloffe 7.) Dated 20 March 1517.

Will of "**Tailliam Goodryk** m'chaunt of Kyrkby." To be buried "in the Chapell of Ih'us in my p'yshe Church of Saint Nicholas." Legacies "for tithes and offerings forgoten," to our lady of Lincoln, to the orphans of Saint Cateryn, to the orders of Freres at Boston, etc., etc. I will "that John and Henry my sonnes have at Caleis eche one of theym twenty serplers woll clere." Son John to have "all my lande in Inglande" and half "my housinge at Caleis"—remainder to son Henry in tail—rem^r (after taking out x marks yearly for a priest "to synge for me my wyfe and childern fader and moder," etc.) to son Thomas for life—rem^r to my dau. in tail. Son Thomas "to be founde at scole till he be xxxii yere old so that he will be preest by that tyme," etc. Anne my dau. to have ev'y yere owte of my purchased lands in Kyrkby xiijs iiijd. Margaret and Elizabeth my dau'rs each to have £10. All goods I have of my fathers and of my mothers Dame Margaret Wyske "to be disposed for them as shortely as is possible." Legacies to servants and apprentices. Residue "to goo to prests singinge and cheritable werks." John and Henry Goodryk my sons ex'ors. Sir Robert Dymmock, supervisor. Legacies of plate to sons Henry and John.

Proved 7 May 1518 at Lamehith [Lambeth] by Henry Goodryk, present in person, and John Goodryk in the person of John Renching, his procurator.

P.C.C. (Alenger 7.) Dated 11 May 1540.

Will of "John Goderveke yonger marchaunt of the Staple at Calies." To my brother lx". To my brother Richard Godericke cccli. To my brother John bradley lxli. To my brother Martyn Bradley threscore pounds. To my suster Anne Banyster threscore pounds. To my syster Dorothe Chapman threscore pounds. To my syster Elizabeth Blancharde threscore pounds. To Agnes Bryan the doughter of Thomas Bryan decessed of Bullyngbroke threscore pounds. I remytte and forgive Edward Godericke of Bullyngbroke all the debts he owith me. Also I remytt all debts which Mestres Anne Wutton widowe and Kateryn her doughter owith me. To Thomas Godrycke my godson of Bullingbroke ten pounds. To John Bryan my godson five pounds. To Thomas Porter my godson fyve pounds. To Will'm Tupholme son to my partener John Tupholme £10. "Vnto the fynding of one ffree scole to teache children at Bullingbroke ccli." To brother Richard Godericke "my Lease of the patent which I bought off Robson," also "all myne apparell." To my Lord of Elyes Chaplains, Will'm Mey, Will'm Lord, Thomas Cottysford, Gyles Ayer, John Clercke, and Nicholas Walpolle, Clercks, xx* a pece to bye them gownes. To Thomas Pawfreman ser'unt to my Lord of Ely vili xiijs iiijd-xxli to be equally devided amongest my Lord of Elyes househould ser'unts. To George my ser'unt iiiji. Resydue of all my goods I bequeyth to be distributed amongs poore people where my mother and my brother Richard Goderycke shall thynke

most nede whom I do ordeyn and make myne Executors of this my last will at the oversight of my partener John Tupholme whom I do make superuisor of this my will and "to hym for his paines taking in this behalf twentye nobles," etc.

Proved 5 June 1540 at London by Richard Godricke, executor.

P.C.C. (More 10.) Dated 24 April 1 Mary [1554].

Will of "Thomas Gooderyck Bysshope of Ely." To my brother Henry Goodryck 100 marks and "in remembrance of me a standing cuppe with a boye having a shild in one hande and a clubbe in thother" and I forgive him all such debts as he oweth me. To sister Elizabeth ffulnebie £20 and a standing goblet which she hath already in her custody-also to her, her dwelling house at Downham called the Lodge which was purchased of Nicholas Megges, for her life, and after to Marmaduke ffulnebie her son to whom I also bequeath £30 and a copyhold in Ely called Marshalls. To Christopher Fulnebie my nephew £20 and "my soreld horse stoned" which he hath already and "the best harnys that he can chose in my Armarie," etc., and I remit him all sums he oweth me-also I bequeath him "a square salt gilted weyng xv ounces." To Barbera Ovarton, Kateryne Wilkes, and Mary Steward, £20 each. To Rich⁴ Goodrick my nephew my second stoned horse, etc. To John Goodryk his bro. Saynt Augustine's works which I bought of Mr Briggs, Saint Jerome's Works, Saint Ambrosse Works, and Cyrill's Works which be at London. To Thomas Goodrick Clerk of my Kytchyng the land which I purchased of the King lying in Somersham with "sometyme did belonge vnto the Chaunterv of the Grene in Ely." To Nicholas Goodrick his bro. the copyhold lands in Somersham which sometyme was Robert Amores. To Henry Roydon, Prentice in London, "because I suppose he shall sustayne some losse by my neglygence, ten pounds." My ex'ors to deliver to Mr John Whitwell, Clerk, £16, to be distributed amongst the poor. I forgive Mr Henry Oglee of Wysbitche £10 he oweth me. I forgive Mr Hand "sometyme my Chapleyne" all money he oweth me. Sr Nicholas Stened the same. Whereas John Ruggs my servant owes me viij", I forgive him iiij". (Legacies to other servants.) To Barrow my nephew "a stonding cuppe with a woman in the cover and a naked sword in her hande." Whereas my officers have received Lead of the College of Ely to thuse of my late buylding ther, I give unto the said Collage in recompence for the leade so receyved, the Residue of my Books vnbequeathed so that they will make vp their "Lybrarye," etc., and "yf the deane and chapter refuce my said bokes for recompens I will that they be solde" by myne ex'ors and the Dean and Chapter "resonable recompenced," etc. To John Belgrave and Edward Hall iiiji "for their paynes takyn in my Syknes." To the poore men's box in Ely £20. To "the povertie" at Downham £5. To the poore men's box in Somersham £5. (Provisions in case any "legatories" or servants prove troublesome to the ex'ors.) Residue to be distributed amongst the poor. Thomas Barrowe my nephew, Mr Osbert Moundeford esquier, and Edward Leedes my chauncelor, ex'ors—and to each of them £20. To Mr Richd Wylks my Surveyor £20. In witness, etc.

Witnesses, Lyon Goodrick, Thomas Palfreman, Richard Wilks, Thomas Myddelton, and Chrofer Barton.

(Then follows a long list of pecuniary and other legacies to Thomas Myddelton my Steward of Howsehold, Mr Edmond Perpoynt my Receyvor, the "Gentilmen Wayters," "Yomen Officers," "Yomen Wayters," etc.)

Proved 13 October 1554 at London by the executors.

P.C.C. (Streat 15.) Dated 14 November 1556.

Will of Richarde Goodricke of London esquier. To Dame Dorathie Blage my wife my mansion and house, etc., "within the circute cumpas and procinte of the late Whitefriers nere flete strete in London" for life-remainder to Richard my son-remainder to dau. Elizth-remainder to Dame Dorathe my wife. Also to sd Dorothy houses, etc., adjoining my garden for life—remainder as before—provided if my sd wife, by the advice of my friend Nicholas Bacon of Redgrave co. Suffolk Esq. and my bro. in law Robt Badbie of Stiforde co. Essex, sell the sd houses, she is to bestow the proceeds as by my will appointed—my sd wife to buy land worth £100 to be conveyed to her for life-remainder as above. To dau. Elizth £100 at marriage or 24-if she die before, sd son Richd to receive the sd £100. Residue to sd wife, she to bring up "her own children and her children and myne" in "vertue and godlynes" and to "cause them to be well taughte and broughte vpp in lerninge of the lattin tonge at the leaste," etc. My sd wife Dorathie Blage sole ex'trix. Friend Mr Bacon aforesaid and bro. Robert Badbie, overseers, and to each of them "a Ringe of golde worth xls a pece, with ij hands the one taking thother engragen and enamiled as may well appere with this worde aboute the Ringe Till then farewell. Witnesses, my cosen Xpofer Goodricke and my cosen Thomas Palframan. "And whereas the Quene's Maiestie that now is hath lately given and graunted to me and my assignes the wardeshipp and marriage of Edwarde Goodricke sonne and heire apparante of Lyon Goodricke deceased, and so from heire male to heire male, And likewise the wardeshipp and marriage of Anne Goodricke daughter to the saide Lyon, yf it happen the saide heire male so faile I give and bequeath the same wardeshipps and marriages of the saide Edwarde and Anne and of either of them to my saide wief Requiering her, as she will answer before almightie God for them, to see them well broughte upp in lerninge, as my trust is in her for the better discharge of her owne concience and myne." My sd wife to be good to my servants especially to Ellice Bocher and George Webb and to bestow upon them a good farm at the manor of Chew in co. Somerset.

Proved 8 June 1562 at London by George Harrison, notary public, procurator for Dorathee Blage, relict and executrix.

P.C.C. (Loftes 31.) Dated 16 December 1560.

Will of "Lyon Gudric of Este Kirkebye in the Countie of Lyncoln Esquire." To be buried in the Chappell at Estkirkby and to the maintenance of the church there xxs. To the poor of Estkirby iijii and xxs yearly for xix years. My wief Winnefryde to have my manc'on howse in Kirkby, etc., for xix years next ensuing paying as follows: manc'on howse, etc., xiijs iiijd, for every acre of pasture ijs vjd, for every acre of meddoe grounde xijd and for every acre of Areable grounde vjd yearly to my ex'ors. To sd wife "the occupieng of all my leaces in est Kyrkbie and Hagnebie during sd term of xix years, and afterwards the sd leases to my heir." To sd wife "all myne apparrell Juells and olde golde" except that which I give hereafter-sd wife to have all my lands given to her "in feofment" during her natural life "which lieth in Wayneffete, thorp, Halton, Enderbye, Malvis, and Witherne." To sd wife and son Edward all stock and household stuff equally between them except certain implements, etc., mentioned in schedule below "which shall remain holy vnto my sonne." To se wife and son all my plate saving to se Edward "my best nutte with the cover and a ring of gold with my armes grauen in hit." To Anne my dau. £200 at marriage—she not to marry before 18. The sd £200 and all other legacies to be levied out of my lands in Stickney. If sd Anne does not marry she is to have the sd £200 at 21. If both children die I give their legacies to Steuen Brinkley and Anne Palfryman my cosen equally and my wife shall have the lands given to my heir for her life. To dau. Anne a ringe of golde"iij dozen of silver spoons to be bought weinge euery dozen xij ounces hauing a lyon and my woolle marke vppon them;" whereof one doz. to bro. Thos. Goodricke his daughters, another doz. to bro. Palframan's daughters Anne and Sara, and the third doz. to Steven Brynckley. (Legacies to servants.) To Richard Nicholson in recompence of his father's goods remaining in my hands vjli xiijs iiijd. My wife Winnefride, bro. in law Mr Willm Bryan, and my bro. in law Mr Edward Sapcote, ex'ors—and they to have all my lands, etc., for xix years to bring up my children. Residue to son Edward. (Directions as to management of lands, etc.) Sr Edwarde Dymmocke knyghte and my cos. Richarde Gudric esquier to be supervisors, and each to have "a tonne of wynne either gascoine or else frenche." In witness, etc.

(Then follows an Inventory of the articles about his house in Kyrkbie which the testator appointed to belong to his heir.)

Memorandum dated 26 Aug. 1561, by which testator leaves to "mother Gennet" 5^s yearly for life, to Bartholomew Snodon annuity of 20^s, and to Grace Collen annuity of 4^s. To bro. Edw^d Sapcotts "my second best mare." To cosen Anne Banester one ring. To Wynnefride my wife £20 "that William Saunders owes me." Sir Edward Dymocke and my cousin Rich^d Goderick to have the bringing up of son Edward. (Directions as to son's marriage.) I now appoint Winnefride my wife and my bro. in law Marten Hollengworth ex'ors. To mother Sharpp yearly for life in consideration of "one lease which she hath yelded into my hande" 6^s 8^d and "her howse rome" so long as she shall live. To Harry Dorante xl^s "in remorce of concience."

Proved 25 October 1561 at London by William Towers, procurator for Winnefride Goodricke, relict, and Martine Hollingworth, executors.

Wynefred Goodrick married secondly Humphrey Littleburn (?), Esq., of East Kirkby, whose will, dated 1568, is given at p. 82 of "Lincolnshire Wills, 1500—1600," by Rev. A. R. Maddison. 1888. See also pp. 62, 127.

P.C.C. (Daper 4.) Dated 26 December 1571.

Will of "Thomas Goodericke of the holie trynitie p'ishe in Elye." To the augmentac'on of the poore men's stocke of trynitie parish vili xiijs iiijd. To Alice my wife the messuage in which I now dwell for life, also the great close on thisside Newbarnes containing 80 acres and 2 other closes on thisside that containing 10 acres each and the saffron close, etc.—also the rents of tenements and leases in London Ely and elsewhere except those named hereafter. To Danyell my son after his mother's death the messuage I now dwell in. To sd Daniel at 24 my interest in the mansion house of the manor or Grange of Newbarnes, etc.-also 100 ewes or £20, etc. (provisions in case of sd wife dying before sd Daniel come to 24). To son John at 24 Tucks house, etc., which I bought of Lawncelote Tucke—also lands in Chetcham field, land in Rossell, etc. Thomas a moiety of my part of Chetcham Busshes, messuage in Downham, grounds in Holborn "neare vnto London" provided he pay moiety of rents thereof to his bro. Lionell. To son Lionell my other moiety of part of Chetcham Busshes, house at Wisbitche and copyholds I bought of Mr Robert Stywarde sometyme Yaxlers. To Anne my eldest dau. "towards hir marriage wth Beniamyn Pryme" £200. To "the other fine" of my daughters £200 each at 20 to be raised out of my 22 closes in the furlonge next Kettlesforde, etc. Legacies to servants. To Letteis Fretton 58 and to Annis Flaunders x5. Residue to Alice my wife whom I make ex'trix. The right worshipfull M^r Doctor Perne Deane of Elye and James Speighte M^r of Arte and Schole M^r of the Churche of Elye to be supervisors. (Provisions as to s^d wife giving security to the s^d supervisors for the payment of debts and legacies, etc.)

Proved 8 February 1571-2 at London by Robert Buck, procurator for Alice, relict and executrix.

P.C.C. (Meade 27.) Dated 16 August 13 James [1615].

Will of Edwarde Goodricke of East Kirkby in the county of Lincolne Esqr. My worldly goods to my son Lyon Goodricke he allowing to my dau. Washburne out of those my goods in Suffolk £35, I having laid out to her use £15 weh make £50 over and above the £400 wen is in Sr Thomas Jermynes hands of her porc'on-my sd son also paying my debts, etc. My dau. Allen to have one of my beddes, etc. To my daughters Elizth Wynefride Hester and Frauncis "beinge all married, two Jacobuses as tokens of my love." To dan. Goodricke my hoope ringe "weh was my wives." To cosen Richd Palframan 56s he owes me. To my godson Nathaniel Palframan "one peece of twenty shillings"—same to John Tupholme my servant. To Elizth Maye £10 at her marriage. My sd son to bring up my grandchild Edward Willan. My grandson John Goodricke to have my manor of Stickney, etc., at age of 22, in meantime cosen Richd Palframan to hold said manor, etc., by a "lease pareill" paying to sd son Lyon Goodricke "a pennye a yeare." If sd Richd Palframan think fit to sell sd manor or any part thereof for purchasing lands in Kirkbye or elsewhere to the use of st grandchild John, etc., I will that he have power to do so. If sa grandson John die, sa manor to the heirs male of son Lyon—remainder to heirs male of bro. Richd Goodricke of Suffolk. Provided always my son Lyon and his wife and the survivor of them shall enjoy sed lands for their lives. If the issue male of bro. Riche fail then sed lands to the heirs general of son Lyon. "I will that two dozen of the little Catechisms in meeter be given to see many poore children in this Towne or elsewhere." Son Lyon Goodricke and cosen Richd Palframan ex'ors. In witness, etc.

P.C.C. (Byrde 116.) Dated 16 August 1624.

Will of Baniell Goodricke of Ely. To the poor of Trinity parish in Ely £10. To Frauncis my wife "my nowe dwelling house for life—also all household stuff, etc. Also to s^d Frances for life certain closes and pastures lying on both sides of Newbarnes lane (very full description of the property). After her death s^d closes, etc., to son Thomas and s^d wife in meantime to pay £4 yearly towards the Lords rent and said Thomas to give security to my s^d wife before the renewing of the grand lease for performance of my grant to her. To dau. Elizth Goodricke £120. To son John the leases of 23 closes called "Kettlesword Cloases" (fully described) "which I bought of my father Bracken and are parcell of the grand Lease." To s^d son John £200. To bro. John Goodricke £10. To bro. Lionell Goodricke £10. To my servant Rob^t Golding £10 a year for life. To son Thomas my interest in the scite and mansion house of Nue Grange commonly called Nue barnes. Son John shall always enjoy the s^d 23 closes and son Tho^s shall make a lease of the same to him. I charge son Thomas to deal honestly with my bro. John concerning the land of which s^d bro. John has a lease from me which was my father's

gift to him. Residue to "my eldest son" Thomas whom I make ex'or. Sir Thomas Steward knight and Mr Daniell Wigmore Archdeacon of Ely supervisors. In witness, etc.

P.C.C. (St. John 19.) Dated 23 October 1624.

Will of Thomas Goodricke of Ely wthin the Isle of Ely in the countie of Cambridge gent. To be buried "in the Chappell neare vnto my late deceased father." To the sd Chapel £40 and to the poor of Trinity parish in Ely £8. To poor of parish of St. Marie in Ely 40s. To sister Ms Elizth Webb £40 to be paid to Sr Thomas Steward knight Mr Daniell Wigmore Archdeacon of Ely and my cosen Will'm March gent. as feoffees in trust for her. To Lyonell Goodricke my uncle annuity of £4 out of my lands in Ely. To cosen Daniell son of sd Lyonell Goodricke annuity of 40s. To cosen Lionell son of sd uncle Lionell annuity of 40s. To cosen Mary Goodricke my goddau. £20 at marriage or 18. To my mother in law Ms Francis Goodrick £5 to buy her a mourning suite, etc. Legacies to servants. To Rob't Gowldinge "in regard of his trust and true service to my father and my selfe" £5. To Isack Barrowe, my uncle John Goodricke, my cousin John Brakyn, cousin Richard Pryme, cousin Thomas Stones, cousin Henry Goodricke 40s each for rings. To cousin and godson Robert March £5 at 21. My bro. John Goodricke sole ex'or. Mr Daniell Wigmore Archdeacon of Ely and cousin Mr Will'm March supervisors and to each 22s.

P.C.C. (Coventry 71.) Dated 12 March 15 Charles [1640].

Will of John Goodricke of Ely in the Isle of Ely and County of Cambridge Esquire. To poor of Trinity parish in Ely £10. Whereas I have a Lease of the farm or Grange of Newbarnes in Ely held of the Ld Bishop of Ely I bequeath same to son Daniel. Mary my wife during minority of sd son (viz. till he is 17) to take rents, etc., and maintain him "vntill hee shalbe put to the Vniuersitie of Cambridge," etc. If sd son die before 17, the sd lease to two dan'rs Katherine and Anne Goodricke-my sa wife to keep sa lease renewed. To my sa son copyholds in Ely "which either discended or came to mee after the death of my father or my brother or were purchased by me." St wife to be guardian of st son. To dau. Katherine £500. To dau. Anne freehold house, etc., which I purchased of William March Esq. commonly called Crowne Corner also lease of gardens, etc., one acre in Priest meadow field and farm of Chetesham, etc., purchased of sd Wm March. Robyn Hunter my servant and sergeant of housbandry at Ribston to have the next "farmehold" void by the death

of any of my tenants in Hunsingor or Cattall for his life, etc. Residue equally between my sons and Richard Letheley my servant whom I make my ex'ors. In wytnes, etc.

And for default etc. then to the only use of the heirs of the body of the said Sir Henry Goodricke kt. lawfully begotten or to be begotten. And for default etc. then to the sole use of the right heirs and assigns of the said Sir Henry Goodricke knight for ever. And Sir Henry Goodricke levied a fine in Trinity Term 17 Charles 1st (1641) Between Thomas Wentworth knight and Thomas Metcalfe gentleman plaintiffs and the said Henry Goodricke knight and Jane his wife deforciants of the Capital messuage of Gt. Ribston aforesaid. And of divers enclosures with the appurtenances in Gt Ribston and Walshford commonly called Parsons Crofte, Hayes Inges, Calfecloses, George Garth, Vinsbergarth, Niddfield, Sandbarrs to the same adjoining, Eshefield, Gt Arfetts, little Arfetts, Arfetts Crooke, Sandbarrs adjoining the north part of Eshefeild, Snawden, Sandbarrs Burne, Sandbarrs, little myers, and lingeerofte, by the names of two messuages 2 gardens 120 acres of land 50 acres of meadow 40 acres of pasture 100 acres of furze and heath and Common of pasture for all beasts in Gt. Ribston and Walshford. Henry and Jane acknowledged the premises to be the right of Thomas Wentworth and have quitelaimed to the said Thomas and Thomas and the heirs of the said Thomas Wentworth for ever, as appears by exemplification of the said fine and by an Indenture dated 15 June last past

And the Manor of Whaltonhead and the other premises in Whaltonhead are held of the very noble Algernon Earl of Northumberland as of his Manor of Spofforth by fealty only in free and common soccage and are worth per annum (clear) £5. And the premises in Hopperton are held of Thomas Maliverer, Baronet, as of his Manor of Allerton Maliverer, but by what services the Jurors do not know and are worth per annum (clear) 10s.

Note.—Sir John Goodricke and the Civil War. The Journals of the House of Commons record that Sir John was a prisoner at Manchester 21 January 1642-3, and was committed to the Tower by order of the Parliament 14 August 1643. The "Mercurius Civicus" of 25 January 1644 says he made his escape from the Tower, but was recaptured at Wickham (High Wycombe) on his way to Oxford and reimprisoned in the Tower. He was disguised in the habit of a butcher, and there were found in his pocket fourscore pieces of gold. The "Parliament Scout" of 26 January 1644 and the "Weekly Account" of 1 February 1644 also give similar accounts. He was released from imprisonment under order of the Parliament dated 26 March 1646. Vide Journals of the House of Commons, vols. ii., iii., and iv. Sir John visited the English College at Rome 23 June 1647. He was M.P. for Thirsk in the New Parliament called by Richard Cromwell to meet 27 January 1658-9, and M.P. for York County 25 March 1661.

Note.—Altofts Hall was built by Admiral Frobisher, who, it is said, resided there. It was anciently called Brackenhill Hall (vide W. R. Registers, Wakefield, Book K, 182, 240). It was purchased by Sir Francis Goodricke, 2 February 1669, for £1450 (Close Rolls). In 1673 Sir Francis bequeathed this property, and all the family portraits at Altofts, to his nephew John Goodricke (afterwards the third Baronet), who resided there. It continued some time in the possession of the Goodricke family, and was "in jointure" to Dame Sarah, 1728, but it appears to have been sold by her son Sir Henry Goodricke, fourth Baronet, to John Smith in 1737. My wife Dame Mary Goodricke and the Rev^a Dr Matthew Hutton, Rector of Spofforth, Rev. Dr Jaques Sterne, and Rev. Mr Francis Wanly, Vicar of Hunsingore, Ex'ors.

Oct. 1st 1719. My sister Elizabeth Goodricke married in Ribstan Chapel to Mr William Thomson of York.

*Henrietta Goodricke married first to Rev^d M^r Hill, and second to Johnson, Esq., of Liverpool & died about 1762.
