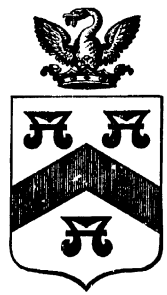
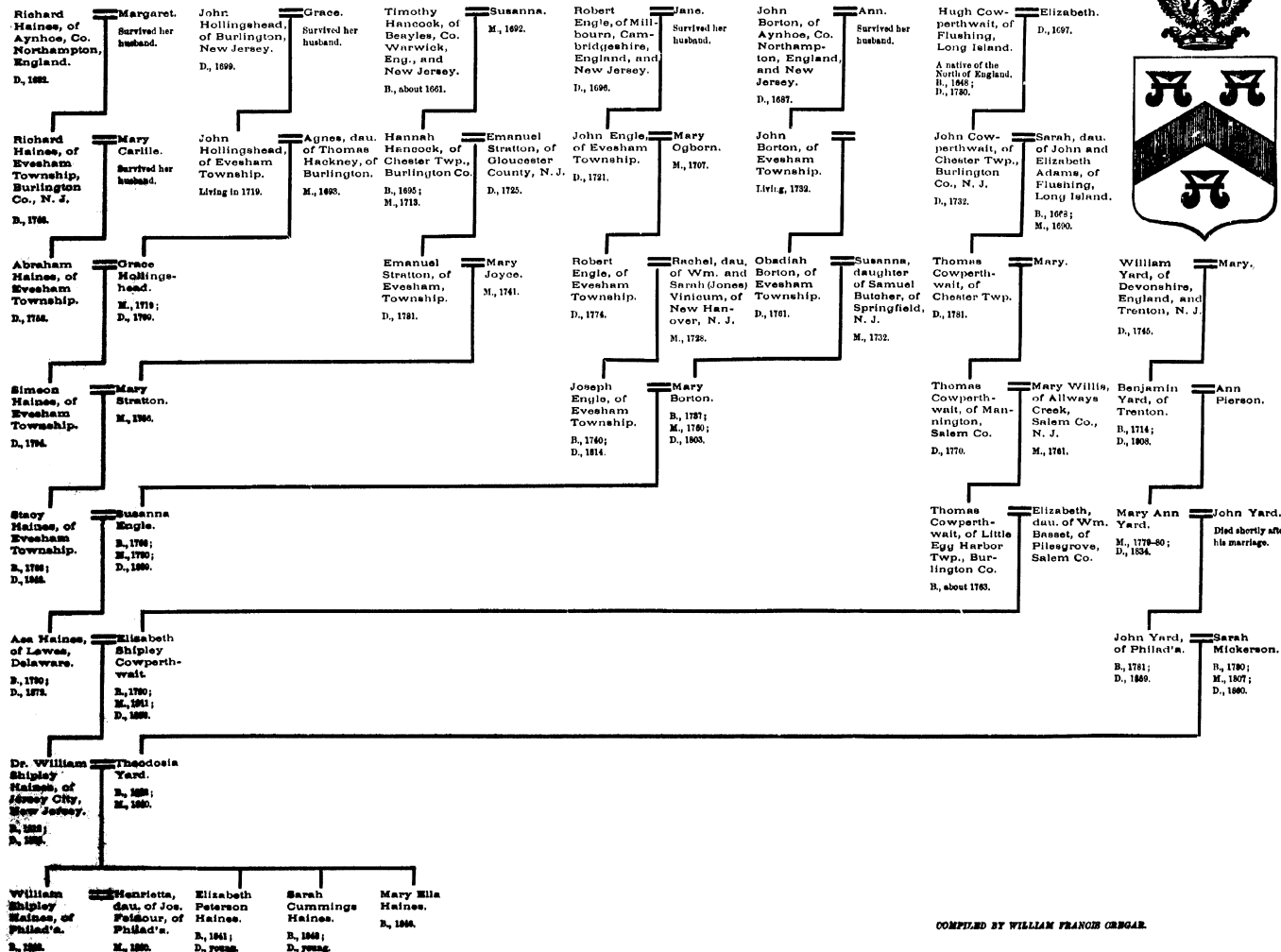

THESE researches were commenced with the object of preparing an account of a branch of the Haines Family, but the compiler in the course of his investigations obtained some knowledge of the history of several other families, and has been permitted to incorporate the information thus acquired in this pamphlet, which he now submits to those interested. Though he does not claim to give a complete account of any of the families, he has endeavored to state plain facts correctly as far as they have been discovered, and in all cases has given reference to his authorities.

CHAPTER I. HAINES FAMILY.

I. RICHARD HAINES, of Aynhoe on the Hill, in the County of Northampton, England, though styled husbandman in a deed of 1682, was in all probability descended from an ancient family of Haynes residing in that locality, which had made illustrious marriage connections, but had increased so rapidly in numbers that all its members did not, at the date of the deed, occupy the high estate of their ancestors. In the marriage certificates of his widow, Margaret, and his son, John, the name was spelled Haynes, but the form was shortly afterwards changed to Haines, which has since been adhered to by the family in this country. Richard Haines became a member of the Society of Friends some time prior to 4th mo. (June) 18, 1676, O. S.,* when the birth of a daughter, Mary, was recorded at Banbury Monthly Meeting, and 5th mo. (July) 5, 1679, O. S., signed the certificate of removal of his neighbor, John Borton, who with his family emigrated to Burlington County, in the Province of West New Jersey.† His eldest son, John, either accompanied or followed the Borton family to West Jersey, settling in Evesham Township, Burlington County, and afterwards marrying John Borton's daughter, Esther.

Richard Haines received such favorable accounts of the Province from his son that he decided to join him, and in April, 1682, went to Gravesend, with his wife and children, embarking on the ship "Amity," Richard Diamond, master, which set sail from the Downs on the 28d of April.‡ Before leaving England he obtained from Edward Byllinge two grants for 100 acres in West Jersey. The deeds, now in the possession of one

of his descendants,* were dated April 20 and 21, 1682, and indorsed "For Richard Hayns, an Oxfordshire friend at Gravesend "or on Board Richard Diamond's ship." †

Richard Haines died during the voyage, and his youngest child, Joseph, was born; but his widow and children arrived safely in West Jersey, where they joined his eldest son. ‡ His widow, Margaret, m., secondly, 8d mo. (May) 6, 1685, O. S., Henry Bircham, of Bucks County, Pennsylvania. §

II. RICHARD HAINES, of Evesham Township, Burlington County, New Jersey, yeoman, (second son of Richard and Margaret,) came over with his parents in the "Amity," and settled near his elder brother, in Evesham Township, where he d. at an advanced age in 1746, his will being proved April 22d of that year, and dated December 18, 1744. He bequeathed the sum of five shillings to each of his children, for whom he had amply provided during his lifetime.* Richard Haines m. Mary Carlile, who survived him.†

CHAPTER II. HOLLINGSHEAD FAMILY.

I. JOHN HOLLINGSHEAD, SR., of Burlington, New Jersey, merchant, a member of the Society of Friends, arrived in New Jersey, in a ship from London, some time during the year 1678, and settled near Salem, but did not remain there long, as in 1682 he was living in the neighborhood of Rancocas,* from whence he removed to the town of Burlington, where he d. in the latter part of the year 1699, his will being dated September 20, and proved February 22, 1699, O. S. He appointed his wife, Grace, executrix.†

CHAPTER III. STRATTON FAMILY.

EMANUEL STRATTON, of Gloucester County, New Jersey, yeoman, a native of Long Island* and a member of the Society of Friends, is said to have been descended from a William Stratton, of Stratford, England, four of whose sons emigrated to America.† Emanuel Stratton d. in 1725, appointing his "lone brother," Mark Stratton, of Evesham, executor of his will, which was dated April 5th, and proved November 26th, of that year.‡ He m., November 6, 1713, Hannah, dau. of Timothy and Susanna Hancock. § See that family, *Chapter IV*.

CHAPTER IV. HANCOCK FAMILY.

CHAPTER V. ENGLE FAMILY.

I. ROBERT ENGLE, of Evesham Township, Burlington County, New Jersey, yeoman, was a member of the Society of Friends; came from Cambridgeshire, in England, and d. in 1696, his will being dated April 4th, and proved June 1st, of that year. He bequeathed all his estate to his wife until his son should attain the age of 21 years, after which she was to have the use of one half of the property so long as she remained his widow. In the event of their son's death under age and without issue, he left her a life interest in the whole, with power to will one half; the remaining portion reverting to his "brothers, Peter Nevell and Henry Nevell, of Millbourn, in Cambridgeshire, old England."* His widow m., secondly, 9th mo. (November) 23, 1703, O. S., Henry Clifton, of Philadelphia.† Robert Engle m., in England, Jane ———, by whom he had issue an only child, John, *of whom hereafter.*

II. JOHN ENGLE, of Evesham Township, yeoman, (only child of Robert and Jane,) was b. in England, and d. in January, 1721, O. S., his will being dated 11th mo. (January) 19th, and proved February 1st, of that year. CHAPTER VII. COWPERTHWAIT FAMILY.

I. HUGH COWPERTHWAIT, a native of the North of England,* was b. in 1648, and emigrated to Long Island in 1674, settling at Flushing,† where he acquired a considerable estate‡ by his exertions as a schoolmaster and tailor.§ He was also a minister of the Society of Friends, in that capacity making frequent visits to the Quaker settlements in New Jersey and Pennsylvania. He d. May 20, 1730, and, in the minutes of the Flushing Monthly Meeting, is described as having been a substantial Friend, a minister for nearly forty years, and universally beloved. He left the meeting a legacy of £100, as appears by the minutes of a monthly meeting held on the 6th of the 5th month, 1738, though no record of his will can now be found. ||

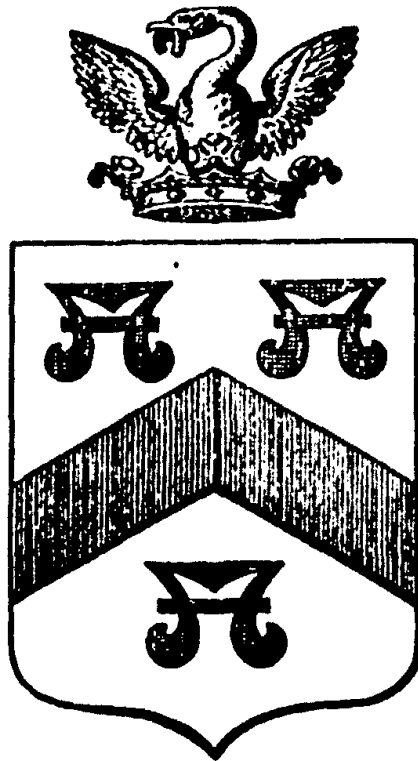

CHAPTER VIII. YARD FAMILY.



SOME extracts from a work entitled *The Worthies of Devon*, probably in the handwriting of Mr. Joseph Yard, who visited England after the close of the War of Independence,* show that the Yards accompanied William the Conqueror into England and established themselves at Yard, near Marlborough, in the County of Devon. "One proof of the antiquity of the family is that "there has issued nineteen or twenty generations in the direct "line, whose fruit is also seen in' many fine spreading branches "it has yielded at Bradley, Trusbur, Whitney, and Exeter." Their arms, as given above, have been used by the American family as of right belonging to them, being engraved on an old seal, which is said to have been brought to this country two hundred years ago, and is now in the possession of Edward S. Yard, Esq., of Trenton, a retired officer of the United States Navy, to whom the compiler is indebted for this account of the English family of Yard.

*Joseph Yard returned to America in 1700, and d. at Philadelphia in 1885, aged 75 years.

Joseph Yard, with his wife and children and younger brother, William, *of whom hereafter*, came from the neighborhood of Exeter, in Devonshire, and settled at Philadelphia some time prior to August 4, 1687, O. S., when he purchased a lot of ground on Third street. He d. in May, 1716, O. S., leaving a widow, Mary, and the following children, viz.: Joseph, removed to New Jersey and had issue; William, removed to Burlington, N. J., and d. without issue in 1732; John, living in 1620; George, of Philadelphia, d. in 1758, leaving issue;* Benjamin, had issue; James, styled "Mariner," in 1720; Elizabeth, m. ——— Fox.†

I. WILLIAM YARD, of Trenton, New Jersey, came from the neighborhood of Exeter, Devonshire, and with his elder brother, Joseph, settled in Philadelphia, remaining at that place until about the year 1710,‡ when he removed to what is now the city of Trenton. In 1712 he purchased two acres of land on Second (now State) street, extending to Assinpink, and between Green and Warren streets; building his residence on Front street; was afterwards a purchaser of other large portions of land, so that when a name was to be given to the town it was a question for a time whether it should be Yard's-town or Trent's-town. Mr. Yard was prominent in the affairs of the town, a zealous supporter of the Presbyterian Church,§ and died in 1745, his will being proved July 4 of that year, and dated February 12, 1742-3, O. S. || William Yard m., in England, Mary ———.
