#### HOWIE GENEALOGY:

The name Howie is a local place name from Ayrshire, Scotland; and is derived from a huge Estate owned by the founders of the family who were Waldenses and had fled from the religious persecutions in So. France, in the Fourteenth Century. It is evident that they had been Wealthy and Prominant people in France, as attested by their vast Estates and holdings in Scotland. Plus the fact that they use a Fleur de Lis in their Coat of Arms. A privilage in France, reserved for Nobility and Court-Powerful families only.

The original family name is lost to history. But, the name they adopted is the same today as it was then, with slight variations in the spelling.

A good portion of the following material was taken from the 'Surmames of Scotland, by George S. Black, New York Public Library, 1948.' and 'Lowland Lairds, (printed in scotland) by Sir James Mc. Ferguson, 1951.' Scottish Parochial, Town, and County Records. And 'Scots Worthies, from 1732 to 1803, by Sir John Knox Howie of Loch-goin, Scotland.' Plus many present day Personal-Family Records.

The earliest account of our family starss with one William Howye, who was a witness in Brechin, Scotland, in 1519; and his brother Johnne Howy; who in 1526 was "Master at Arms", for the Earl of Cassilis. Of the parents there is no record. All reference numbers hereafter refere to the Book Index in 'The Surnames of Scotland.'

william Howye, b. prob. 1490, in Ayrshire, Scotland; was a wit-ness in Brechin, Scotland, in 1519. He is on record in 1526 as Ser-geant of the Town, and appears again two years later (1528) as Wil-liam Howie, Burgess. (Re B., II, 172, 180-181).

Dand Howie, (Johnne), b. abt. 1523, in Ayrshire, Scotland; son of Johnne and Lady Margaret (dau. of the Earl of Cassilis) Howie of Ayrshire. He became a tenant on the Crown-Estate of Cramond, under the Abbey of Kelso, 1540, near Edinburgh. A Very singular occurance was the cause of this branch of the family getting their noteworthy Coat of arms, and their present Estate, which has since passed into the female line.

(Reference, First Series of Tales of A Grandfather, vol. 3, p. 37, Sir Walter Scott, Bart.)

1540, Howie of Cramond, near Edinburgh, ancestor to Howieson of Braehead in Midlothian, 1822.

Another adventure which nearly cost him his life, King James the Fifth of Scotland, that is, took place at the village of Cramond, near Edinburgh, where he had rendered his addresses acceptable to a pretty girl of a lower rank. Four or Five persons, whether relations or lovers of his Mistress is uncertain, beset the gisguised King as he returned from his rendezvous. Naturally gallant, and an admirable master of his weapon, the King took post on the high and narrow bridge over the Almond River, and defended himself bravely with his sword. A pensant, (Dand Howie) who was thrashing in a barn close by, came out upon the noise, and whether moved by compassion or natural gallantry, took the weaker side, and laid about with his flail so effectively, as to disperse the assailants. He then conducted the King to his barn, where that Monarch requested a basin and a towel to remove the stains of battle

James V, employed himself to learn the summit of his deliverers earthly whishes and learned that they were the sole desire of possessing in property, the farm of Braehead, on which he then labored. The lands, administered by the Abbey of Kelso, chanced to belong to the Crown and James told him to come to the Palace of Holyrood on the morrow and inquire for the guidman (farmer) which name the King used on his adventures. Howie presented himself accordingly, and found with due astonishment, that he had saved the life of his King, and that he was to be gratified with a Crown Charter of the Lands of Braehead, under the service and Arms of presenting a basin and a towel, for the King to wash his hands when he shall happen to pass the Bridge of Cramond. The Howiesons of Braehead now possess the lands under ther original Charter. The heir of Braehead discharged his duty at a banquet given to King George IV, in the Parliament House at Edinburgh, in 1822.

He is the author of "De Acterna Dei Providentia;" written in Basel', Switzerland. He latinized his name, Hovacus, and was m. twice, out there are no records of the names of either of his wives, nor whether the children herein named were of the first or second.

Beloved benefactor of all who came under his service. His Learning was without pedantry; his wit without affectation; his judgement

In 1584, James Howie, m. Teens, Lady Glamorgan, dau. of Sir Robert Glamorgan of Glen-Perrin, Argyleshire, Scotland. They were a Highland Family, prominant in Court circles, and no doubt it was Glamorgan's influence which gained Howie his Sheriffdom.

A Archibald Howie, (James, James, William,) b.1589, in Glascow, Scotland; son of James and Teena, (Lady Glamorgan) Howie. He settled in Glascow where he comes on record as Burgess, in 1625.

James Howie, (James, James, James, William,) b. 1613, in Foggi-hillock, Ayrshire, Scotland; son of James and Despina (MacDonald) ASAB
Howie; m. 1641, in Edinburough, Scotland, Marjorie, Lady Wemyss, dau.
and heir of Sir John Wemyss of Caskyberry and Lathrisk, who was created
a Baronet in 1625, Lord Wemyss of Elcho, in 1628, and Earl of Wemyss,
Lord Elcho and Methil, in 1633. The mathh was a good one, as James,
though untitled, was extremely wealthy, and possessed many ancestral
Estates of the Howies in Ayrshire. He was confirmed by The Lord Lyon
King of Arms, in the undifferenced use of the Arms of that family, and
as head of the house of Howie, was privaledged to bear the patronomic
of Howie of Howie, or Howie of that Ilk.

James was in the Bishop's Wars 1639-1640; and served under the Marquess of Argyll, Archibald Cambell, in the Covenenters War 1644-45, in which James Graham, the Earl of Montrose, was defeated.

Sir John Wemyss Howie, (James, James, James, William.) b. 6 June, 1642, in Foggihillock, Ayrshire, Scotland; son of James and Marjorie, (Lady Wemyss) Howie; m. 1663. Mary Catherine Tyrconnell of County Ulster, Ireland. On behalf of his father Sir John. was very ac--tive in Irish Trade; especially with those Irish-protestants who suf--fered so heavily from the Navagation Acts passed by the English Par--liament in 1663, thereby ruining Irish shipping. Also, in 1666, the English Parliament passed a Commercial-Measure against Ireland that was to be in force 30 years; known as the Irish-cattle-Bill. Any fur--ther importation of Irish cattle to England was prohibited. Horses also, as English Landowners resented the competition from livestock more cheaply raised in Ireland. In circumventing this law, Sir John arranged to have the livestock secretly shipped to Scotland, and thence to England to be sold to the very landowners who'd instigated the Bill. At exceedingly exhorbitnat prices, they thinking that they were getting the best Scottish-stock. In this way he helped maintain many great Scot-Irish Families. who would have been ruined otherwise.

He served as an Officer under Prince William of Orange, in the Irish Wars, 1688 - 1691. Where, because of his great kindness in succouring 17 Irish-Catholic Families from the destructive-wrath of the over-zealous French-Protestant Troops in Galway; he gained the personal commendation of the Catholic-Commander of King James' Army, Lord-General Sarsfield. With this highly respected Generals safe-conduct pass on his person, and the permission of Prince William of Orange, Sir John proceeded to Dublin-Town. Where, at the Great-Cathedral there, he was awarded the highest honor bestowed on Protestants by the Catholic Church

"The Order of the Golden Spur." This by the authority of the Pope, 'His Excellency and Most Reverend Minister of God, Innocent XI.'

At the ceasation of hostilities he was created a Baronet by William of Orange, in 1693. After which he returned to his Estates on the Isle of Arran, where he d. in 1720, in his 78th year. A much lov-ed much respected man.

Sir Robert James Howie, (Sir John, James, James, James, James, William,) b. 9 April, 1667, on the Isle of Arran, Scotland; son of Sir John Wemyss and Mary Catherine (Tyrconnell) Howie; m. 1697, Mercia Helsa of Ayr, Ayreshire, Scotland. They settled in Ayr, where he became Bishop of St. Mary's Parish, ans was such for over 45 years. How he being the youngest son, succeeded to the Title, I am at a loss to explain. Unless, it was by Letters Patent before his fathers death.

His every son followed in his footsteps and became Churchmen.

But three of them were attainted from their Benifices and exiled from Scotland for their part in Prince Charles' abortive attempt to regain the Scot-English Throne in 1745.

He m. 1729, Gwenn Nina Fraser of Aberdeen, and succeeded to his fathers Title.

Sir John Knox Howie, (Sir Roderick, Sir Robert, Sir John, James, James, James, James, William,) b. 1 Mar. 1736, in Ayr, Ayrshire, Scot--land; son of Sir Roderick James and Gwenn Nina (Frser) Howie; he set--tled in Lochgoin, Ayrshire, Scotland, where, upon the death of his father he succeeded to the Baronetcy, there being no elder brothers about to claim it. Sir John was a Landowner of no mean talent, and de--dicated his life to the education of his children and the perfecting of his farms and properties.

In his book, "Lowland Lairds" (or Lords), Sir James Ferguson re-marks, that the Lairds (Lords) of Howie, have dwelt on the same prop-erties in and about Lochgoin, Ayrshire, Scotland, for over Forty two
generations. This alone proves the Howie's an extensive Pre-emminence
in Schtland. Also, the bulk of this genealogy is this point, is to be
found in a book entitled, "Scot's Worthies", by the above Sir John Knox
Howie of Lochgoin. from 1732 - 1803.

On the 3rd of Aug. 1759, he m. Althea Louise, Lady Hamilton, dauand heirø of Sir Ian Hamilton of the Chevoit. Their dates of death are unknown as are their place of burial, but as it was a family tradition to bury their peoples on their own land, from time long past, most of the graves were lost or plowed under with new tenants, who were little interested in someone elses ancestors. Also the continual Scottish-Wars destroyed much in the way of Municiple or Family records.

I cannot understand Sir John's reluctance to discuss his family 'biographically' in print, but such is the case, and for what little I have acquired, I am indebted to a few existing town and Church rec-ords

It is to be hoped that more information will be forthcoming in the near future, but as of now (1963) further clarification is not present. The bulk of this family is spread out far and wide across the United States and Canada, and primarily in rural regions. Let us keep in mind also that Vital-Stastistics, as we know them, were not kept by North American Governments until after 1898.

Margaret and John are both buried in the Howie Family Lot, in Sydney, Cape Breton Island, Nova Scotia; and it is the Compilers hope that in the not to distant future, he may be able to visit the Dominnion and secure formitive data and dates himself. ### A PLACE CALLED CONKIN:

The early history of Donkin and Port Caledonia, both located within district No. 11, Caps Breton County, dates back to the turn of the century.

Port Caledonia is sometimes called Big Glace Bay. This was to distinguish between Little Glace Bay, and now the Town of Glace Bay, Supposed to be the largest town in Canada. Before Glace Bay incorporated as a town in 1901, it was a part of the county.

The village of Donkin was known as Dominion No. 6 for many years. Early records show that it was a part of Little Glace Bay, la-ter a part of Morien, and finally a separate municipal district.

The change in name from Dominion No. 6 to Donkin was effected 9 Jan. 1940. The main reason for seeking a change was that the mail a sent to Dominion No. 6 often landed in Dominion No. 1 and it was on or about this period that communities named after a colliery began to look for a change. When a meeting was called in the No. 6 school house, the names Clifton, Banting and Donkin were suggested. The post office dept. finally agreed to Donkin.

This was in honour of Mr. Hiram Donkin, who was on the origi-nal C.P.R. survey, built the Cape Breton Railway, and the Sydney and
Louisburg Railway. He was the second General Manager of Dominion Coal
do. and later became Deputy Minister of Mines for Nova Scotia. It was
in his regime that Dominion No. 6 Colliery was opened in Donkin.

It was in 1904 that Dominion Coal Company opened a mine in Donkin. At this time only nine or ten families were in the community and most of them lived in Schooner Pond which is about one mile be-yound Donkin.

#### MANY HOMES:

Not long after the mine opened, homes were constructed in larger numbers. The community from this time on became known, though not officially, as Dominion No. 6 and developed as a typical mining community.

Within a few years, a move was underway to form a separate Municipal District, since at this particular time in h i s t o r y, Dominion No. 6, or Donkin, was a part of Municipal District 12, Fort Morien.

With this in mind, a committee of six, three from Morien and three from Pominion No. 6 met at the home of John M. Ferguson, Long Beach, Port Morien in the year 1907 to form a new district. Representing Morien were John M. Ferguson, Angus MacLeod, and Donald MacLeod. Representing Dominion No. 6 Isaac Howie, Dr. Hazard and John Alex - Robertson.

Mr. Howie, whose excellent memory has verified much of this story recalls that Mr. Ferguson produced a map and a compass and after considerable debate, settled on the following boundaries, and here a-gain Mr. Howie promes his excellent memory, and as far as it is known, the description agreed on in 1907 remains unchanged to this date.

Beginning at the Eastern Boundary of John M. Ferguson's in Long Beach, thence in a southwesterly ddirection to the head of Big Glace Bay Lake, thence along western side of Big Glace Bay Lake to sand bar, thence along shore line to John M. Ferguson's to place of beginning.

These boundaries were approved by the County Council and in the following year, Dominion No. 6 elected It's first Councillor, the honor going to the late William R. MacDonald, Mr. MacDonald had been active in forming the district and was to become Manager of No. 6 col--liery at a later date. During his later years he lived he lived in Glace Bay and was Chief Inspector of Mines.

Among other residents who served as County Councillor were Norman Robertson, Alonzo MacDonald, Donald Grant, John N. Reid, John W. MacLeod, Gordon MacGregor, Arthur Hatfield, David R. MacLeod. The present Councillor is Joseph Wadden.

### GOOD MINING:

A sketch of the earky years would not be complete without reference to the coal mine, No. 6 colliery, around which community life centered. The first Mines Manager was Robert "Skipper" Robertson from Sydney Mines. Other Managers were Charlie Mitchell, William R. MacDonald and Tom Chew. Mr William Blakey was appointed Manager during the 1925 strike and remained in charge till all equiptment was removed. The colliery never reopened after the strike.

Dominion No. 6 mine was noted for it's good miners and stead-y output. With never more than 380 names on the payroll, 1500 to 1700
tons was a regular daily output. A record of 1872 tons was hoisted in
a single shift in 1924. Even during the years of World War I the mine
continued to increase it's output. The mine operated on the Phalen Seam
with about 6-6" of coal and used the room and pillar system of mining.
About 40 horses were the maximum used in the mine.

The Phalen Seam, Mr. Howie maintains, extends from Flint Is. to New Waterford. The famous Caledonia Colliery has operated on this Seam since Confederation.

This seam was discovered by BillPhalen many years ago. He took a sample near the cliffs at Big Glace Bay. This, incidently might be the occasion to relate how Port Caledonia or Big Glace Bay as it is more commonly known, recieved it's name.

In the early years, in fact before 1900, the Caledonia Co. built a port or harbor near the Big Glace Bay Lake for shipping coal. The Clyde Company, which operated a mine near the present site of Big Glace Bay school also used this harbor, and for five cents a ton were permitted facilities of the harbor to ship their coal to market. Children from Glace Bay and Port Caledonia who like to swim at this a spot, now referred to as the old Harbor, might be interested to know it was a busy spot in years gone by, as steamers left this harbor laden with coal for Halifax and Upper Canada.

This was also the age when coal was loaded for five cents a ton. Mr. Howie, along with two other "Butties" would load sixty tons of coal a day for a total of \$3.00, and recieve ZZGO (1.00 each as their share of the labor. And this was the age when coal was sold by the Companies for twenty-five cents a ton.

Finally, saving what I consider to be the best part of my story for the last, I would like to conclude with some remarks about the people.

Scottish, Irish, English, Italian, Jewish, Newfoundlanders and col-ored folk who came direct from the homeland. These people all worked together in the mine at No. 6 and became great friends and neighbors. Always willing to help each other in times of need, sickness, death or disaster, it encouraged and developed a wonderful community spirit, which has continued to this day.

#### ACTIVE IN SFORT:

The community was always active in sport, especially hock-ey and soccer, and even in mordern times Donkin boys take a promin-ant part in sport throught Cape Breton. Donkin also claims the fin-est Scottish Band in Eastern Canada.

The people are peace-loving as a rule, and have little need for police protection. There are two schools, one in Domkin and one in Port Caledonia. Four churches serve the religious needs of the Community. A paved highway makes it convenient to reach Glace Bay within fifteen minutes.
