EXPLANATION.

Large figures, before a name, enclosed in a parentheses, thus, “ (4) Walter,” refer *back* to that number, on the margin, as all names included in the “ Pedigree ” stand in regular order from 1 to 168.

Names printed in capitals indicate the direct line from William to Lemuel B. Hatch. Names printed in small capitals indicate collaterals only.

The pedigree of each new subject is given at the beginning of his notice, running his line back through the several generations, to William, the emigrant ancestor. Thus, “ Lemuel B., son of James, (son of James, son of James,) &c.

GENEALOGICAL RECORD.

FIRST GENERATION.

William Hatch ; one of the earliest settlers of Scituate, Mass., was a native of Sandwich, County of Kent, England, from which place he emigrated to New England, before 1633, in which year he was made freeman of the Incorporation of Plymouth. In the course of a year or two, having established himself as an inhabitant and founded a comfortable home, he went back to England for his family, and returned March 17, 1634-5 in the ship *Hercules*, with his wife, five children and six servants. His house was in Kent street, and built as early as 1634 ; his house lot was the first south of Greenfield lane, so called, and undoubtedly the name of the street was called after the county from which he came.

He was a merchant, a man of means, and quick perceptions, possessed of more than ordinary business qualifications, and very soon became identified with the more prominent business affairs of the town and county.

He served on the jury at Plymouth, 1636-7 ; and Sept. 1638, was on the jury for the trial of Arthur Peach, Thomas Jackson, and Richard Stinnings for the murder of an Indian.

June 7, 1637, he was presented to Court for trespass on a piece of land, and the only punishment meted to him, was "to reap the crop thereupon, this year, and leave the land."

Sept. 3, 1638, there was granted to him "an Island called the Old Island, alias Hatches Island, lying on the south-west side of the North river, containing about 20 acres."

This property was afterwards sold to Joseph Tilden, in 1649 ; and the following deed of it is copied entire, retaining the original style of spelling.

" 1649.

BRADFORD, GOVERNER

Recorded according to order the thirtieth of Aprill. To all to whom these presents shall come William Hatch the Elder of Scituate in the government of New Plymouth in New England in america Youman [yeoman] sendeth greeting. Know yee that I the aforesaid William hatch for and in consideration of twenty pound of currant New England pay, to mee in hand payed by Joseph Tildine of Scituate aforesaid in the government aforesaid yeaman, wherwith I the said William Hatch doe acknowledge my selfe fully satisfied contented and fully paid and thereof and of every part and parcell thereof doth exonerate quite and discharge the aforesaid Joseph Tildine hee his heires Executors administrators and assigns for ever by these presents have freely and absolutely bargained and sold Enfeoffed and confirmed and by these presents doe bargain sell Enfeoffe and conferme from mee the said William Hatch and my heires to him the said Joseph Tildine and hee his heieres and assigns for ever one Island of vpland containing by computation Twenty acres more orless together with all the marsh meadow thereunto adjoining lyeing and being by the Riuer comonly called the North Riuer which said Land is knowne by the name of Old Island and is bounded toward the east to the aforesaid North Riuer oposite overagainst the Clift comonly called and knowne by

the name of the fourth or fflowe Clift and toward the East there is a Creeke wh prosedes from the North Riuer between the afforsaid Iland and mersh and the Iland commonly called and knowne by the name of Coopers Iland and so Trencheth about westerlie and on the north side it is bounded with a Creeke that prosedes out of the afforsaid North Riuer and Trencheth about Southerly neare to the afforsaid Creeke ther being but a Smale distance betweene the said Creeks towards there vpper ends with all and singular the apurtenances thereunto belonging or any way apertaining to all the said vpland and mersh or any pt. or parsell therof

TO HAVE AND TO HOLD the afforsaid vpland and mersh vnto the said Joseph Tilden hee his heaires and assignes for euer to the proper vse and behoofe of him the said Joseph Tilden hee his heires and assignes for euer TO BEE HOLDEN of our Soueraine Lord the King as of his manor of East Greenwich in the County of Kent in free and Common Sockage and not in Capete nor by Knights Service by the Rents and Services thereof and therby dew and of Right acustomed and with warrantice against all peopell whatsoever from by or vnder mee the said William hatch or by my Right or title claiming any Right title or Enterest of or in the aforsaid premises or any pt or parcell therof.

AND I THE SAID William hatch do also covenant and promise by these presents that Junne hatch my wife shall within one month next after the date herof yeald up and Resigne ouer her Right of the thirdes of the aforsaid lands vnto the aforsaid Joseph Tilden according to the custome of the cuntry and as law Requires in sutch a case AND I THE SAID WILLIAM HATCH doe further couenant and promise and graunt per these presents that it shall and may bee lawfull to and for the said Joseph Tilden either by himselfe or his attorney to Record or Inrowle thes presents or to cause them to be Recorded or Inrowled in his Ma'ties Court at New Plymouth afforsaid or in any other place in yt case provided. according to the vsual mannor of Recording and Inrowling Evidences.

IN WITNESS WHEREOF, I the said William hatch haue heervnto set my hand and seale the fourth day of October in the four and twentieth yeare of the Raigne of our Soueraine Lord Charles of England, Scotland France Ireland and New England King and in the yeare of our Lord God one Thousand Six hundred flourty and eight.

March 5, 1638-9, he was appointed Surveyor of Highways.

Sept. 27, 1642, was one of a Committee for Scituate, to provide forces for the war against the Indians.

Oct. 16, 1643, he was elected by his townsmen to be their Lieutenant, "for trayneing their men" in the art of war. He also had an earlier appointment in 1638, with William Vassall, for the same purpose.

March 5, 1643-4, he brought a suit against his servant, Hercules, (probably colored) as to whether he should serve him six or seven years. The Court decided six years as the extent of service, and then to be free July 3d, next.

In 1651, he sold lands to Serg't Humphrey Johnson.

Mr. Hatch was a member of the first Church till its division, one part under Rev. Mr. Lothrop, removing to Barnstable, and the other remaining in Scituate, under the pastorate of Mr. Chauncey, whose settlement took place in 1641. In 1643, Mr. Hatch was chosen Ruling Elder of the Second Church, which office he retained till his decease. The following is

"The last Will and Testament of Mr. William hatch of Scituate deceased, exhibited before the generall court holden at New Plymouth, the

3d of June 1652 on the oathes of Mr. William Wetherell and James Torrey.

November the fift 1651.

I William hatch the elder of Scittuate in the collony of New Plymouth in america Planter, being weake in body but of p'fect memory doe make this my last will and Testament in manner and forme following

Imprimis—I give and bequeath vnto Jane my wife two milch cowes and my executors to keep them Summer and Winter vpon my meddow grounds them and their encrease tell they exceed the number of six.

Item :—I giue vnto her halfe my dwelling house during her life time as alsoe halfe the frutes of the trees in my orchard.

Item—I will that my executors allow her yearly fifteen bushels of corne viz : foure of wheate foure of Rye foure of barley and foure of Indian corne, as alsoe sixtene Rods of broken vp ground and to be well dunged yearly for to sow hempe seed on.

Item—I give her the bed whereon I lye with two paire of sheets, two pillows two paire of pillow coates one bolster one Rugg one blankett therunto belonging.

Item—I give her one chamber pott, two household platters two pewter dishes one pewter drinking pott ; alsoe a little brase pott and a brase skillett two spinning Wheelles a paire of wool cardes, a Trunke, halfe a dozen of milke trayes a coupple of wooden dishes two wooden platters a milke pan two chayers foure spoones one of them being of siluer.

Item—a warming pan, one brandiron one paire of tongs one paire of pot hangers a fier slice

Item—I giue her a hogg and my great brase kettle

Item—I giue my daughter Jane Lovell one milch cow to bee deliuered by my executors at two yeares and after my decease ; and if the lord give my daughter Jane any more children then my will is that her next child shall have the first calfe of that calfe that I have given to her son John Lovell and the next child the next calfe and soe successively.

Item—I give my daughter Jane one paire of sheets

Item—a chest alsoe a pewter candlesticke one sawser two alchymy spoones.

Item—I give to my daughter Ann Torrey one milch cowe to her and her heires to be deliuered at two yeares and after my decease by my executors:

Item—I give to my grand child James Torrey a cow calfe and the first calfe of her breed to my grandchild William Torrey, and the next calfe of her to my grandchild Joseph and the next to my grandchild damaris and alsoe I giue my daughter Torrey the stripp pott : All the rest of my moveable goods lands and tenements I give and bequeath to my two sons Walter hatch and William hatch to them and their heires for ever to bee equally divided between them whom I appoint to bee the executors of this my last will and Testament, and to pay all my debts and legacies. Inventory of estate taken by Walter hatch and William Hatch jr. 1695.
3. 4. Presented to Court June 3, 1652.

Mr. Hatch died Nov. 6, 1651. Married in England, Jane ^{New} ~~King~~ who married for his second wife Elder Thomas King, March 31, 1653, and she died the same year, Oct. 8. Elder King's first wife, Sarah, died 1652 ; and after the decease of Jane, he married, third, Anne ———. He was chosen to succeed Elder Hatch in that office, in the Second Church. He came to

Scituate about 1634, and built his house on the top of the hill at Belle house neck. Six children. [Mr. King d. Dec. 1, 1711.]

2. JANE, born in England. Married John Lovell. Nine ch.:—John, b. —; d. young; Elizabeth, b. —, d. Jan 21, 1657; Phebe, b. May 19, 1650; John, b. May 8, 1658; Elizabeth, b. Oct. 28, 1660; d. —; James, b. Oct. 23, 1662; William, b. Feb. 24, 1665; Andrew, b. June 28, 1668; Jane, b. July 28, 1670.

3. ANNE, b. in England. Married Nov. 2, 1643, Lieut. James Torrey, b. —, 1617; d. July 6, 1665, from the effects of a gunpowder explosion. He had received orders from the Governor of Plymouth, to prepare for an expected invasion, by the Hollanders, and to make an examination into the state of the ammunition in his charge. The magazine was in the house of a Mr. Ticknor, and contained in two barrels. They were opened and some of the powder was taken out and spread upon some boards to dry, when, in some unaccountable manner, it caught fire, blowing the house to pieces, causing the death of Mrs. Hannah Ticknor and her child John, who were standing quite near, and burning the breast, face and arms of Mr. Torrey so badly that he died the next day. This affair happened July 5, 1665. He was a man of great usefulness, and highly respected by his townsmen. In 1653, he erected a clothing mill, on the "third cliff," so called, and in the vicinity where the Stockbridge mills have since been erected. Was Deputy to Gen'l Ct. from 1660, to 1665, and Town clerk, 1639 to 1644, and re-chosen 1650, which office he retained till his decease.

Ten Children :—James, b. Sept. 3, 1644; William, b. March 15, 1646-7, d. young; Joseph, b. March 18, 1649; Damaris, b. Oct. 20, 1651; Jonathan, b. Sept. 20, 1654; Mary, b. Feb'y 14, 1656-7; Josiah, b. 1658; Sarah, b. Feb'y 9, 1660-1; Joannah, b. May 4, 1663; Bethia, b. 1665, after the decease of her father.

4. WALTER, b. England. d. about Mar. 1701.

5. HANNAH, b. England. Married, Dec. 6, 1648, Samuel Utley. He was of Scituate, 1648. As nothing is known of him after 1653, it is probable he removed away. One child :—Lydia, b. Dec. 28, 1653.

6. WILLIAM, b. England; d. Virginia, about 1656. His will is dated, Sept. 13, 1653, in which he mentions his dau. and only child Phebe, to whom he leaves a legacy to be paid in 1668, when probably she would have arrived to her majority. Appoints wife Abigail, executrix. The will was written upon the occasion of his going "upon a journey to Virginia." Witnesses to the will were, GEORGE SUTTON; JAMES TORREY, aged 44 yrs.

Inventory taken Apr. 7, 1657, by Edw'd Jenkins and Thomas Turner. £56. 3. 4.

He md. — Abigail, dau. of John Hewes, "the welchman" of Scituate. Mr. Hewes was formerly of Plymouth, and came to Scituate about 1632. His house was on Kent street, and probably near Elder Hatch's, and was the second south of meeting house lane. A mistake is made by Savage and others in saying that he married Susannah Annable, which fact is disproved, by collateral evidence.

The following deed appears on record.

"Abigail Hatch, widow formerly wife of William Hatch of Scituate," sells to her father, John Hewes of Scituate, 13 acres of land on North river, with 5 acres of meadow lying higher up, belonging to the house, and given him, (said Hatch) "by my husband's father's will." It will be noticed in the will of Wm. Hatch, Sr., that he divides all his real estate between his two sons William and Walter. There were two by the name of William Hatch, living in Scituate at the same time, distinguished on record, as "William, Jr." and William, son of Thomas, who were cousins.—Thomas being a brother to Wm., Sr.

Feb. 10, 1655-6 the Court ordered Mr. Hatherly and Capt. Cudworth to take security of Abigail, the wife of William Hatch deceased, in the behalf of Phebe Hatch, his daughter, for the payment and making good of her portion given her by her father. Mr. Hatch left but

One child:—Phebe, who removed to Boston and was living there July 18, 1677, when her uncle Jeremiah Hatch, bought "her dwelling house and land lying on North river," being a portion of the estate left her by her parents, her mother being probably deceased at this time.

7. JEREMIAH, b. England; d. 1712-13.

SECOND GENERATION.

(4.) WALTER, son of William, was born in England about 1625. He made his will Aug. 20, 1698, proved, April 2, 1701, which in substance is as follows:—

He gives to his eldest son Samuel, a share in the Iron works, &c.

To sons John and Israel, the fulling mill, corn mill and 200 acres of land on North river.

To youngest son Joseph, the great lot at Freetown.

To the said four sons, gives in addition, 3,375 acres of land, he bought of his cousin Thomas Hatch.

He mentions his daughters Jane (Sherman) Bethia (Foord) and wife Mary.

In 1643, was old enough to bear arms, consequently he must have been over 16 years of age.

He settled on a point of land north-east of Stony cove, and south-east of the second Society's Meeting house. Freeman, 1658.

He was Constable June, 1654; and in that capacity, was threatened and abused by William Randall and his wife Elizabeth, while serving a process on them, and his warrant forced from him.

He was a shipwright, and had a yard about a mile below Union bridge, on the Scituate side, after 1677, and engaged in business, with his brother Jeremiah. He also owned an interest in the Iron mine, a notice of which appears in his will.

He married May 6, 1650, Elizabeth, dau. of Thomas Holbrook of Weymouth, and wife Jane. Mr. Holbrook died 1673. In his will he, among other bequests, gives his daughter, Elizabeth Hatch, a portion of his estate, after the decease of his wife Jane.

Elizabeth, d. — and he married 2d, Aug. 5, 1674, Mary ^{Stahly} who survived her husband. They were married in Marshfield, and her name on those records, is completely obliterated.

(12.) BETHIA, dau. of Walter, (William) born Scituate, March 31, 1661. Married, — 1683, Michael, second son of William Ford. She was his second wife.

William Ford, was born in England, 1594. He settled on the East side

of North river, in Marshfield, near Gravelly Beach, before 1640. He died 1676.

Children of Bethia:—Thomas, b. 1685 ; Susannah, b. 1689 ; Bethia, b. 1691 ; Ephraim, b. 1693 ; Elizabeth, b. 1694 ; Elisha, b. 1696.

(7.) JEREMIAH, son of William, born England. Will dated, Feb. 21, 1703-4, proved, March 16, 1712-13, in which he calls himself "aged." The following is his will, copied from the original, at Plymouth, a few unimportant words being omitted, which will be characterized by * *

"In the name of God Amen. The last Will and Testament of Jeremiah Hatch.

I Jeremiah Hatch being aged and Weake of Bodey but through mercy of perfect memory yet, in Just Expectation of my great change approaching do declare this to be my Last Will and Testament * * and as for what the Lord hath lent me of this world's goods I dispose of it in manner as followeth.

Impr.—I give unto Mary my dearly Beloved Wife all my household goods of all sorts within Doors with Liberty and choice of one lower fire Room and one Chamber in my Dwelling house with one end of the lonto and Cellar Room for her conuenience and to be provided for with conuenient fire wood att all Times and Liberty to keep one or two swine about the house after the manner of the family there Resideing as also the Liberty of the fruite of my Orchard for her use and Necessary help about her, furthermore I allow my said wife fifteen bushells of Corn yearly three bushels of it at Least English Graine and also Ten Rods of ground suitable to sow flax seed yearly and four Rods of ground well fenced and Diged for a garden and so yearly. furthermore I give her the Choyce of two cows and seven sheep to be kept for her, * * both summer and winter * * furthermore * * I leave in her hands all the rest of my living stock to dispose of according to her discretion furthermore I leave in her hands to dispose of as she shall see cause one right of common called a 47th Right Belonging to me as successor to John Huse.

Item—I give unto my son James 45 acres of land on the East side of my 85 acre Lott adjoyning to his present habitation at or near a place called Drinkwater as also Do hereby confirme unto him all my lands at Stonetown according to a Deed he had of me ordering him to pay to three of his sisters 21 pounds according to my Directions Viz : To pay to his sister Mary Turner 7 pounds within 3 years after my Decease, and to his sister Elizabeth Hatch 7 pounds two years after that, and to his sister Lydia Dillingham 7 pounds, two years after the second payment.

Item—I give to my Daughter Joanna Wing, 20 acres of Land according to the extent of a Deed given under my hand for 50 acres of Land at or Near a place called Drinkwater.

Item—I give to my Daughter Anna Smith 20 acres of Land out of my 85 acre Lott at Drinkwater on the West side of sd 85 acres according to the extent of a Deed given to her husband Joseph Smith now deceased.

Item—I give to three of my Daughters, Viz: To Mary Turner, Elizabeth Hatch & Lydia Dillingham £15 a peace, besides what I haue already or their mother may see cause to give them 7 pounds a peace to be paid by their brother James as above sd. * *

Furthermore, I give to my daughter Deborah, 30 acres land Lying Near a Road way going to Drinkwater. * *

Furthermore, I giue to my wife and all our children in equal proportion all my lands Lying near prouidence purchased of the Indians by some Hingham men as by Deed may appear. All the Rest of my goods Lands and Tenements I give and bequeathe to my son Jeremiah * * * whom I make Executor of this my last will and testament * *

Furthermore, I give to my five Grand-children their mother's part,

equall, with the Rest of my children in all my lands near the Town of providence comonly knowne by the Name of towns lands" * * *

"I James Torrey Testifie that about three years ago to the best of my remembrance or therabouts Jeremiah Hatch Now Deceased ordered me in the presence of Mary his wife to cancell or obliterate the first three Lines of the second page of his Last will & Testament. March 16, 1712-13."

"I Mary Hatch Widdow Testifie that I being present heard my Late husband Now deceased, give orders to James Torrey to Cancell the sd. three Lines which was Then Done to his content Also, I Declare that those five children mentioned in my late husbands will were the children of Mary Ede the wife of John Ede of Swanzey. Mar. 22, 1712-13."

Inventory of his Estate £94. 8s.

Dec. 8, 1666. The names of Jeremiah Hatch and his cousin William Hatch (son of Thomas) appear in a bond of £15, with Joseph Tilden, administrator, and son-in-law of Timothy Hatherly, for security, in the discharge of a legacy of £8 bequeathed by said Hatherly to Lydia, dau. of said William Hatch, and to be paid when Lydia should arrive at the age of 18 years, or day of marriage, and which payment was made Jan. 20, 1675. In the acknowledgment of her receipt she makes mention of Jeremiah Hatch as her uncle.

From some unaccountable reason Jeremiah is not represented in his father's (the elder) will. But all authorities agree, notwithstanding, that he must have been his son, from certain proofs and unmistakable evidence found on record. It is very probable he had at some time received his full proportion of worldly estate, making it unnecessary to notice him in said will. The following deed affords evidence in support of the above assertion. He had married a daughter of John Huse, who is mentioned in her father's will; his brother William had early deceased in Virginia, and his daughter Phebe, his only child, who subsequently removed to Boston, had also died some time previous, leaving her father entirely without issue, which somewhat explains the phraseology in an exchange of 14 acres with William Parker for 20 acres, May 30, 1705.

Seven of the 14 acres were granted to the successors of John Huse, and the balance, "to the successors of William Hatch jr. ye son of William Hatch the Elder. which grants of 14 acres granted by the present Committee ye 9th day of March. 1702-3, and claimed by ye sd Hatch as the lawfull successor to said John Huse and William Hatch: and sd. land. bounded as pr. 2d Book of deeds p. 19 & exchanged with William Parker. for 20 acres, said Parker being the lawful successor of William Parker. and was by order of said William Parker. laid out to sd. Jeremiah Hatch March 25, 1703, being at a place called Drinkwater in Scituate."

His being successor to the estate of William Hatch jr. and the same expression being used or applied to Wm. Parker, as successor to his father Wm. Parker, seems to make the matter very clear.

Mr. Hatch seems to have been a very prominent and active citizen. He was frequently on juries of inquest and trial. Selectman from 1672 to 1675, and again from 1679 to 1686. Deputy to Gen'l Court 1676, 1679, '80, '89 and '90. He was on the Grand Jury as early as June, 1657. March 3, 1662-3, appointed one of a committee to divide land on North river, and Oct. 31, 1666, was on a jury to settle a land division. June 3, 1674, he was chosen constable, but refused to serve. He was made freeman June 1, 1658, and settled near his bro. Walter, with whom he was engaged in ship-building a number of years.

Mr. Hatch married about 1657, Mary, daughter of John Hewes "the Welshman," and sister to Abigail, wife of his brother William Hatch. She survived her husband and was living in 1713. Her will proved Sept. 20, 1716. Fourteen children :

16. MARY, b. Feb. 14, 1658 ; d. before 1725. Married John Eady of Swansea.

17. JEREMIAH, b. Aug. 31, 1660. Will proved Oct. 20, 1727, in which he gives his son Isaac, 55 acres in Abington, "where I now dwell." To wife Mary, one half the produce of the aforesaid premises, and use of one half my house. To son Thomas what lands not given to son Isaac. To son Jedediah one quarter of all my lands not given to Isaac. To son John $\frac{1}{4}$ part of lands not given to Isaac : and in case said John should not return to Abington, the land to revert to his son John. To Jeremiah, son of son Jeremiah, dec'd all the remaining $\frac{1}{4}$ of land not given to Isaac. To dau.-in-law Deborah Hatch, (wid. of Jeremiah) the improvement of the house where she now lives, as long as she continues son Jeremiah's widow. Sons Thomas and Isaac, executors.

Inventory £149, 14s. He had land at Pembroke and Scituate.

May 31, 1703, he sold to his brother James, for £15, 15 acres of land at Drinkwater, and which was granted his father Jeremiah.

(This place called Drinkwater, once in Scituate, was afterwards included in the town of Hanover, when that place was set off in 1727.)

Mr. Hatch removed to Abington before 1723, at which date he sold to Thomas Rogers of Marshfield, "all that part of 2d pond lots lying partly in Scituate and Abington, at Drinkwater being 6 acres."

He married, 1st, Elizabeth —, who died Sept. 10, 1708 ; md. 2d, Nov. 28, 1710, Mary Johnson.

Six children :

John, b. April 10, 1690. He went to North Carolina, where he was living Jan. 9, 1728, when the guardianship of his son John, under 14 years, was granted to Wm. Witherell of Hanover.

Thomas, b. Oct. 20, 1692.

His will was dated June 13, 1728, and proved July 7, 1735, in which he calls himself quite aged and mentions his son Samuel, to whom he gives his sword, chisels, augers and one-half of his farm; son Isaac, daughters Desire Hannah Tincom, Elizabeth Bonney, two children of son Ebenezer, dec'd, viz.:—Ebenezer and Sarah, to whom he gives one shilling each. Six grandchildren, sons and daughters of son Josiah, deceased, viz.: Edmund Jabez, Josiah, Desire, Zervin and Mary. Sons Elisha and Ezekiel, to whom he bequeaths lands in Rochester; he appoints son Isaac, executor.

In 1704, he sold to Joseph Dotey, of Rochester, a large tract of land in that place; amount not specified.

Oct. 27, 1712, he sold to his son Josiah, of Rochester, 54 acres land, at said place, where his house stands. Witnessed by Peter Blackmer, Elisha Hatch and John White, Jr.

Nov. 10, 1718, he disposed of all his remaining lands in Rochester to his sons Elisha and Ezekiel, of Scituate.

May 9, 1719, for £260 he sold to Matthew Eastis, of Pembroke, 80 acres at Haudmer's Hook.

By these deeds we ascertain that he was both a farmer and shipwright. Haudmer's Hook was so called after John Haudmer, who was a resident of Scituate as early as 1639, whose house stood south of Colman's hills. He had a large lot of land in that part of Scituate now called Hanover Meeting House, which was sold to Jeremiah and Walter Hatch before 1680, of which there seems to be no deed. This, undoubtedly, is the same lot as referred to, situated at Drinkwater, and mentioned in the will of Jeremiah, page 8; and the will of Walter, (a fuller account of which will be given hereafter), the latter giving his share, 50 acres, to his son Samuel.

The name of his wife and date of marriage are unknown.

He appoints Benjamin Hatch, Jr., of Scituate, executor.

June 27, 1715, Mr. Hatch and his brother Elisha, of Scituate, and Joseph Hatch of Mansfield, with others, formed an agreement to build a sawmill on Pudding brook, at Beaver Dam, which was among a number of mills being erected about that time, in the vicinity of Drinkwater and various other places on the North river. Deacon of the church.

He married, 1st, Elizabeth, daughter of Thomas and Mary (Witherell)

Oldham, Mar. 7, 1704-5. Mr. Oldham was a householder in Scituate, 1650, and his house is supposed to have been near King's Landing. He married Mary, daughter of Rev. Mr. Witherell, 1656.

Mr. Hatch married 2d, Sept. 12, 1747, widow Mary Sylvester, of Marshfield, who survived him.

March 23, 1712-13, he and his brother Israel, divide the lands given them by their father's will, consisting of 260 acres.

"Also all my apparel, small brass scales and little leaden weights."

To youngest son Jonathan "all that part of my farm on which I live, on the east side of the highway, that runs through my farm, which was given me by my father Walter, with my part of the Grist mill, thereon standing; also, all my meadow in Scituate, bought of Joseph Hinkman, James, Nathaniel and Joseph Torrey and widow, Joanna Butler. Also the upper part of Green Island, bought of the town of *Marshfield* [written indistinctly, may be Marshfield]. Also the other half of Cedar swamp in Hanover. All my horseflesh, one half of my greater scales, meat, meat tubs, and a chest that I keep my writings in. Also a small cupboard, marked, W. II.

It is presumed that he lived at, or very near a locality called the Drinkwater, which, when the town of Hanover received an additional amount of territory from Scituate about 1727, it included the whole estate of Mr. Hatch, who was of Hanover at that time.

The earliest record we have of his land transactions, is May 31, 1703, when he bought of his brother Jeremiah for £15, 15 acres of land, granted by the town of Scituate to his father Jeremiah, at Drinkwater, which lyeth between a cartway that runneth over Indian Head river.

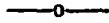

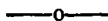
