This search was initiated in an effort to determine the parentage of Zilpha Stubbs said to have been a Hayes. She was the wife of Joseph³ Stubbs, son of Thomas² Stubbs and Deborah Maddock, and she is said to have died in Elkton, Ohio on November 6, 1807.

Joseph and w. Zilpha and children were rec'd (recievlion certificate from) Wrightsborough Monthly Meeting, Georgia dated 1805, 4, 6 at Concord Monthly Meeting, Ohio (Hinshaw, Ency. of American Quaker Genealogy, Vol. IV, p. 160).

Their children were as follows. They are recorded both in the Wrightsborough Monthly Meeting Records and in Concord ones with some variations in the birth dates.

Joseph Stubbs, father of these children, died 1816, 5, 1 at 53 and is buried at Stillwater (presumably Stillwater Meeting House, near Barnesville, Belmont County, Ohio).

The Stubbs went to Wrightsborough, Georgia from Cane Creek, North Carolina; i. e. Thomas², John² and Joseph³ Stubbs (all sons of Thomas² Stubbs and Mary Minor of Bradford Monthly Meeting, Pennsylvania) all went to Cane Creek Monthly Meeting, North Carolina and had previously been members first of Bradford Monthly Meeting and then Concord Monthly Meeting, Pennsylvania. Joseph Stubbs was received on certificate at Cane Creek 1763, 11, 5. He was called "now of Columbia, Ga." in Orange County, North Carolina court records in 1797.

From the evidence given here it seems reasonable to assume that Zilpha was the daughter of Jacob Hayes who went to Kennett M. M. in 1776 to marry Mary Pyle and who was disowned by New Garden M. M. in 1778 for entering military service.

I have been told a Jacob Hayes resided in New Hanover, North Carolina and hope to be able to search for further records there. I have already sent to The National Archives a request for a search for any Revolutionary War record which may be extant.

Although I have not tried to check Stubbs names for such similarity, the first names of the following group of Hayes suggests trying Joseph 3 Hayes (Joseph 2 third son of Henry 1) as shown on page 136 of The History of Chester and Delaware Counties by Gilbert Cope, as the father of Jacob who married Mary Pyle. Joseph 3 Hayes married in Swedes Church in 1753 Joanna Passmore. All that Cope shows re the children is that he had a son John who had large possessions on the Miami, in Ohio; but his brothers and sisters were Rachel, Isaac, Henry, Abigail, Caleb, and Ruth who married in 1754 Joseph Pyle. Caleb married Mary Baily. (It may be no more than coincidence that on the same day that Jacob Hayes requested a certificate to Kennett Monthly Meeting to marry Mary Pyle, Joel Bailey requests one to the same place in order for marriage with Judith Pyle, widow of John Pyle, the younger, 1776 SWS 3---but at any rate here are Hayes, Baileys and Pyles in close association.)

"About the Jacob Hayes name, it seems there must have been two..... There is the Jacob Hayes disowned for entering military service, 1777."

The other is Jacob Hayes, son of Mordecai. (Minutes Bradford M. M. R. S. 14 page 150) 1774 6mo 17 Mordecai Hayes produced to this Meeting from New Garden M. M. a certificate for himself, his wife and their three children-Jacob, Eli, and John. (Births and Deaths, H. 24.1 p. 36, 37. Jacob Hayes, son of Mordecai and Ann Hayes, b. 1766 9mo 7. Jacob Hayes departed this life, 22nd day of 12th month, 1788, in the 23rd year of his age.

There is not entered anywhere in the Bradford or other Minutes that I have found, anything to show that the Jacob of Military Service was ever reinstated. In which it does not seem likely that his death would have been recorded in the Minutes..
