THE INGHAM FAMILY

INGHAM, as a surname, is derived either from locality, as in Hereford, Lincolnshire, Norfolk and Suffolk, where we find parishes of this name, "ing" being the Anglo-Saxon for meadow, generally one lying low, near a river, or from "Ing," *i. e.*, the son of Inge, a Scandinavian name.

From the same source, we have Ingersoll, etc.

In the time of King John, there is mention of a family of this name, seated at the place of the same name in the county of Norfolk. An account in Bank's *Baronia Anglica, concentrata*, volume one, page 266, begins with one

JOHN DE INGHAM,

of Ingham, Co. Norfolk, who married Albreda, daughter of Walter (or William) Waleran (Harl. MS. No. 807, fo. 6⁺), a great feudal baron, and was, according to Dugdale (*Dugdale List of Summ*), grandfather of

JOHN DE INGHAM,

who, the 26th of Edward I. (1297), had summons to Carlisle, *equis et armis*, being in the writ styled a baron, the earls and barons being therein distinguished by their respective ranks (*Dugdale's List of Summ*). He died the 2d of Edward II., leaving Margery, his wife, surviving, and Oliver, his son and heir, *ae.* 23, which

OLIVER DE INGHAM

became a person of great note, and in the 2d Edward III. had summons to Parliament: also in the 4th to another Parliament at Winchester, and the same year to a great council to be holden at Oseney, as likewise to one to be holden at Nottingham.

He was *seneschal* of Aquitaine, and Justice of Chester for life. He died circa 18 Edward III. (1367), leaving Joana, the wife of Roger le Stranger, of Knockyn, his youngest daughter then living, *et.* 26, and Mary, the daughter of John Curzon, (by Elizabeth, his eldest daughter, deceased), then 9 years of age, his next heir (his son, John de Ingham, having died in his father's lifetime, 12 Edward III. *sine prole*), which Jane, afterwards, became the wife of Milo de Stapleton.

Elizabeth, the wife of said Oliver de Ingham, still surviving, had dowry in certain lands in the counties of Norfolk, Sussex and Wilts.

ARMS.

Per pale or and vert, a cross Recerale or Moline, gules.

In the chancel of the church at Ingham, under an arch on the north side, lie the effigies of Sir Oliver Ingham in complete armour, with 24 mourners about his monument and the sides thereof.

“Monsier Oliver de Ingham gi st icy, et Dame Elizabeth sa compagne que lui Dieux de les almes eit mercy.”

On the pavement of the chancel there is a knight in full armour, and a lady, in brass, with the inscription:

“Priez pour les almes Monseur Miles de Stapleton, et Dame Johanna, sa femme, fille de Monseuer Oliver de Ingham, fondeur de ceste mayson (founder of this house), que Dieu de leur almes eit pitee.”

The priory of Ingham was founded by Sir Miles Stapleton and the lady Joan, his wife, a daughter and co-heir of Sir Oliver de Ingham, in 34 Edward III. (1360).

Of the present-day representatives of the family, the

INGHAMS OF MARTON

bear as armory:

Qua. or and vert, a cross-moline qua. counter-changed, on a chief ar. a manneh sable.

Crest: two arms, embowed, vested, vert, cuff or, holding between the hands a maunch, sable.

That is, practically, the same arms as were borne by Sir Oliver de Ingham.

The family-seat is at Morton House, in Craven, Yorkshire.

The INGHAMS OF BLAKE HALL descend from a Norfolk branch, that settled in Ossett, Yorkshire, with one William Ingham, in the early part of the reign of Charles I. He died in 1670, leaving a son, William Ingham, of Ossett, born in 1635, who died in 1717, leaving issue.

From this branch descended the

INGHAMS OF SUGWAS COURT,

of which family was Judge Robert Wood Ingham.

There are reasons to believe that this family, in which we are particularly interested, was closely allied, if not directly de-

scended from EDINGHAM, or, as it was later on written, ENGHAM family of England or Ingham, Parish of Wood-churche, Co. Kent, which originated, as far as is known, at present, with one

of Engham or Ingham, in said parish, who lived in the middle of the 14th century, and who had a son

THOMAS ENGHAM

who married Petronella, daughter and co-heir of Thomas Plurindum of said place, and who had a son

WILLIAM ENGHAM

of Engham, who married Joanna, daughter and co-heir of Thomas Pickelsden, of said place, and had a son

WILLIAM ENGHAM

of Engham, who married Avicia, daughter of Horne of Horne-place, Appledore, and had a son

VINCENT ENGHAM

of Goodneston, Co. Kent, who married twice, first to Edith, daughter of William Goodneston, of said place, and 2dly, to a Searles of Kent, with whom he had a son

*Christopher,

With his first wife, he had

THOMAS ENGHAM

of Goodneston, Co. Kent, who married Elizabeth, daughter of Edward Morrins of Waldersahre, and who had several children, of which

SIR THOMAS ENGHAM

knighted in 1619, married Priscilla, daughter of Robert Honeywood, of Charing, Kent, and had, with several other children, a son, Edward, who continued the line, named Engham, and a son, named Rowland Engham, or Grays Inn, as appears from his funeral certificate, where the armorial bearings are given:

Ar. a chevron sable between three pellets of the second, on a chief gu. a lion pass., guard. or.

It is believed that he had a son, Edward, who is mentioned in the funeral certificate as his son, and that he married Phillippe, daughter and heir of Robert Gibbon, having several children, William, who married Martha, daughter of Nich. Hicks, John, Richard, Robert, Priscilla, Katherine, and Mary.

It is not possible to ascertain definitely, however, if these children were identical with the John, Richard, William and Robert Ingham, who occur about this time and who, evidently, were brothers, in Lancashire, although there are indications that they came from Kent.

John Ingham is progenitor of the line, in which we are, particularly, interested, and which will be given later on.

Robert Ingham, of Rochdale, Lancashire, was buried there Dec. 3, 1587, and his wife, Febr. 13, 1593. They had issue:

I. JAMES INGHAM

of Burnley, Lancashire, descended from a family of this name in Kent, and had several sons, viz.:

2. Robert, whose first wife was buried July 19, 1562, "uxor Roberti"; his second wife was buried June 24, 1574. On May 10th, 1577, he married Issabella Barcroft, who died in 1579, when he married, June 5th, 1581, Ellen Crosby.

II. JOHN INGHAM

came with his parents from Kent, settling in Burnley, Lancashire, where he was buried November 26th, 1563, his widow being buried May 20th, 1564.

He was a resident of that part called Ightenhill Park, as was his brother, Richard Ingham.

He had two sons:

1. Richard, baptized in Burnley. September 8th, 1562. who married. July 29th, 1602, Mary Sager, and

son of John Ingham, of Ighterhill Park, Burnley, Lancashire, and baptized there September 16th, 1563.

He married somewhere about 1587, and his wife died, September 7th, 1587, when he married again, his widow being buried November 27th, 1591.

John Ingham was buried June 23d, 1588.

His first wife was probably the Alice Swaynson, who with John Ingham had a son, John, baptized July 7th, 1587, and who died an infant, same year. The wife probably died in child-birth.

John Ingham, of Fulledge, had

called Junior, of Fulledge, baptized, after the death of his father, on Febr. 11, 1589, a posthumous child.

He married, November 12th, 1610, Susan Jacksone, and had issue:

baptized in Burnley, August 2d, 1618; was, at different periods a resident of Burnley-wood, and of Goodshaw, and married, Febr. 16, 1645/6, Lettice Pellard.

His wife died in 1653, and Joseph Ingham now removed to Langley, in Cheshire, where he bought a piece of land, consisting of 4 acres, one orchard, 3 acres of meadow, and two acres of pasture, being like all his people before him a yeoman, living the quiet and uneventful life of a tiller of the soil.

This land he sold, however, shortly after, and removed to Middleton, in Lancashire, where his children were born and baptized, and in which records he is described as "of Langley."

In the year 1707, he removed to Knowsley, and here his youngest son, James Ingham, was born.

Richard Ingham was a weaver of fustian, and is frequently referred to as "fustian-weaver."

Of his children, Ellis, and John followed his trade, while the youngest, James Ingham, is called a "mariner."

VI. JAMES INGHAM

born May 6, 1708, in Knowsley, Lancashire, a few miles north of Liverpool, followed the sea for his occupation, and until his death in 1799, he was known as the "mariner."

He married, June 4, 1729, Ruth, daughter of Stephen Langham, and had a son, who survived him, Joseph Ingham.

Administration was granted in 1799 after James Ingham, of Liverpool, "mariner," in the Probate Registry of Chester.

VII. JOSEPH INGHAM

born Nov. 8, 1742, in Liverpool, his parents residing on Pool Lane, now South Castle Street, next door to Samuel Wilkinson, whose son, Henry, kept the inn called the "White Hart," on High Street, and now the Exchange, in 1766.

He married, Apr. 18, 1767, Mehitable, daughter of Samuel Wilkinson, sister of Jacob and John Wilkinson, and widow of David Brown, whom she married on May 3, 1759, and who died August 4th, 1766.

They had issue:

1. David. b. June 13, 1768.
2. Joseph, b. Jan. 10, 1770, came over with his parents to the New World, and after his father's death, settled in the town of Schuyler, Herkimer Co., N. Y.
- He died in 1813, having left no will. Citation was issued to Cynthia, his widow, Alanson Ingham, his son, and Elias Palmer, heirs, Aug. 15th, 1815.

The inventory was appraised at \$1413.33.

Cynthia Ingham, of Schuyler, was appointed guardian over the minor children: Charles B., Geo. C., Mary L., and Cynthia Ingham.

Of these children:

Charles B. Ingham made his will, as of Schuyler, June 27, 1862, proved Nov. 20th:

"daughter Ann Eliza Meyers, \$900., son H. H. Ingham, \$1000., daughter-in-law, Arletta E. Ingham, wife of my son C. S. Ingham, \$2300., housekeeper, Isabella Hayes, \$125., son H. G. Ingham, residue, and appointed executor."

He died on July 5, 1882, and as heirs appeared:

—Horace S. Ingham, ae. 30, at Schuyler, Ann Eliza Meyer, ae. 44, at Frankfort, Hamilton B. Ingham, ae. 42, at Frankfort, and C. Smith Ingham, ae. 34, at Ilion.

—Cynthia Ingham, married Philo Reed,

—George C. Ingham had wife, Melissa, and lived in Schuyler, conveying, March 13, 1829, land in Russia to Ira Wilcox.

Of Charles B. Ingham's children:

—Horace G., made his will of Schuyler, Febr. 22, 1904, proved Dec. 21, 1905.

"brother H. H. Ingham, \$300., and lot on N. side of Rutger Street in Utica, N. Y., nephew, Herbert H. Myers, \$100., sister Ann Eliza Myers, Miss Maggie Brown, brother. C. Smith Ingham, homestead—farm * * *"

—Charles Smith Ingham married Arried Arletta Davis, and resided in Ilion.

3. Stephen, b. Nov. 17, 1771, d. Dec. 13, 1868, came with his parents to the New World, and went, afterwards, to Manheim, Herkimer County, N. Y., where he had wife, named Huldah, in 1837. He had 15 children, twelve of whom grew to manhood, and womanhood.

—David, m. Maria Ingham, of Manheim, and made his will, Aug. 18, 1873, proved January 21, 1878, in which he refers to:

"Son Willard A. Ingham, \$2000., and his wife, Rebecca.

"Daughter, Antemesia Ingham, residue of the estate. The daughter was appointed executrix."

—Angeline, of Elk Horn, Wisconsin,

—Silas A., b. Renselaer County, N. Y. April 3, 1817, had wife, named Elizabeth, to whom he gave \$2000. by his will, dated June 13, 1883, and probated Febr. 16th, 1886, in which he also

refers to son, Stephen A. Ingham, to have residue of the estate.

Children and grandchildren referred to, but not named.

The son:

On Jan. 2, 1826, Christopher P. Bellinger and Lana, his wife, of German Flatts, sold to Alanson Ingham, of said place, for \$450. land for erection of a carding machine fulling mill, out of lot No. 16, in the patent called Fall Hill.

This property he afterwards added to by purchase.

Alanson Ingham occurs frequently in the land-records, adding to his properties, from year to year by purchases.

He had, on May 1st, 1815, purchased land in Manheim from Adam Feeter and Polly, his wife.

Alanson Ingham was received in the Baptist Church, Little Falls, by letter from Fairfield, Jan. 27, 1830, and his wife, Samantha, was dismissed from said church, by letter, May 19, 1839.

At the request of the brothers and sisters of Warren, to the Baptist Church of Fairfield to "set a council," Elansony Ingham was appointed, May 28th, 1825.

Joseph Ingham, his wife, Mehitable, and their children, emigrated in 1790, to the New World, settling in Canaan, Columbia Co., N. Y., where he died.

Administration was granted on his estate to his widow, Mehitable Ingham, of Canaan, July 9th, 1791, and the inventory was filed in Columbia Co., (now Hudson Co.), on Oct. 13th, in which reference is made to

"a small Bible, Herveys Meditations, Pilgrims Progress, a pocket Dichsenery, Death of Abel, History of the Work of Redemption, etc.," all valued at £97.10.0., and appraised by Mathew Dorr, and Ebenezer Crocker.

After her husband's death, Mehitable Ingham, who, apparently, was a woman of strong personality and strength of character, went with her children farther West, settling, finally, in Herkimer Co., N. Y., where her brothers lived.

Here, at the death of her eldest son, Samuel, she with her brothers administered the estate, being appointed guardian over the minor children, William and Harvey.

It is of interest to note that Canaan was in 1795 divided into new parts, from which the town of Chatham was erected, March 17th that year, partly from Canaan, partly from Kinderhook.

The Schuyler family was settled in Kinderhook at a very early date, Peter Schuyler being a freeholder there in 1687.

Mehitable Ingham settled, first, at Warren, Herkimer Co., N. Y., from which the town of Columbia was formed on June 8th, 1812.

On July 21st, 1802, Mehitabel Ingham, of Warren, for a consideration of \$295. granted to Andrew Clapsaddle of Herkimer, and Samuel Williams, of Warren, two thirds of the 100 acres lot No. 42 of lot No. 5, subdivision No. 42, and lot No. 41, granted to twenty-seven persons in the said tract of 66 acres of land in Warren, the Surrogate, on May 19th, 1801, having decreed, upon petition of Mehitable Ingham, administratrix of the estate of SAMUEL INGHAM, late of Warren, deceased that his real property might be sold.

She sold, on May 20, 1801, the day after the decree, to William Lapon, 129 acres of land.

VIII. SAMUEL INGHAM

born in Liverpool, May, 10, 1774, came over with his parents, to the New World in 1790, settling, first, at Canaan, then in Columbia County, and after his father's death in 1799, emigrating with his mother and brothers to Herkimer County, N. Y.

He married Phebe, daughter of William Rowland, of Birkenhead, Liverpool, whose aunt, Elizabeth Rowland, of Woorchurch Parish, married, at Birkenhead, April 3, 1727, Thomas Nichols, a weaver.

The records of Canaan and Chatham, unfortunately, do not record any data of births or marriages previous to the year 1800, but from the fact that Schuyler Rowland Ingham was named "after his grandfather," and that his grandmother was named Phebe, and that William Rowland of Birkenhead, Liverpool, from which place Samuel Ingham came, had a daughter, Phebe, who both emigrated to Columbia County, N. Y., we can

conclude, with almost absolute certainty that Samuel Ingham's wife was Phebe Rowland.

Samuel Ingham died intestate, and administration was granted to his mother, Mehitable Ingham, October 13th, 1808.

Mehitable Ingham, John Wilkinson and Jacob Wilkinson (her brothers), on Oct. 18, 1808, bound themselves in the sum of \$300., Mehitable Ingham administratrix of the estate of Samuel Ingham, late of Warren. An inventory was taken, and among the "debtors" appear Joseph Ingham, Stephen, Ruth, Melinda, Alanson, and Mehitable Ingham, the administratrix.

The estate was appraised at £41.2.11.

"Whereas Mahitabel Ingham, administratrix of the estate of Samuel Ingham, late of Warren, deceased, has presented a petition to the Surrogate for a decree for the sale of real estate, and

"Whereas, WILLIAM INGHAM and HARVEY INGHAM, the only heirs of said Samuel Ingham, deceased, are infants,

"Now, therefore, Sanford Clark, Surrogate, appoints ANDREW CLAPPSADDLE, a discreet and substantial Freeholder of German Flatts, guardian of said Infants, April 2d, 1801.

(Andrew Clappsaddle had come from Burnets Field, Co. Albany, in 1769, settling on land south of the Mohawk river, which he purchased from Augustinus Clappsaddle).

Andrew Clappsaddle married Phebe Ingham, the widow of Samuel Ingham, and in his will, dated May 29, 1809, as of German Flatts, Herkimer Co., N. Y., he refers to "* * * wife Phebe, sons, George, Henry, Daniel, John, six daughters, Rebecca, Eva, Elizabeth, Cattrent, Harriet and Eunice Clappsaddle."

This will was probated August 12th, same year, and necessitated the appointment of a new guardian over the minor children of Samuel Ingham.

Consequently, on February 23d, 1811, Alanson Ingham, and Jacob Aldridge bound themselves on the former's bond for \$200., as a guardian over Harvey Ingham and William Ingham, minors, of Frankfort.

Phebe Clappsaddle was alive in 1825, when Henry Clappsaddle, of German Flatts, in his will, of October 11th, refers to wife Lucy, mother Phebe Clappsaddle, brother Daniel, sister Harriet Steel, wife of Nicholas Steel * * *

Phebe (Rowland) Ingham Clappsaddle died in May, 1846, ae. 78, hence born in 1768, and is buried in Fairview Cemetery, the Ingham Mausoleum, Little Falls, N. Y.

William and Harvey Ingham were, as we have seen on page 42, "the only heirs of Samuel Ingham," deceased.

1. William, born Oct. 12, 1794, consequently in Canaan, Columbia Co., N. Y., married Eliza, daughter of Samuel Schuyler and Abigail Fancher. She was born Jan. 30, 1804.

William Ingham was a "wool-carder," a tenor in the Baptist Church, Little Falls, enlisted in the War of 1812, and was at Sackett's Harbor in 1814.

Alanson and William Ingham, on June 19, 1829, purchased from Nicholas Moyer and Mary, his wife, of Little Falls, for \$25.50, four sq. rods of land in Little Falls, on the south side of Mohawk river, part of lot No. 16, in the Fall Hill Patent.

On Oct. 6th, 1831, they purchased more land in Little Falls, from C. P. Bellinger, and Mary C., his wife.

William Ingham was "baptized" in the Baptist Church of Little Falls, July 1st, 1838, and his wife, Eliza S. Ingham, joined the church, from Oppenheim, April 3d, 1830.

William Ingham, of Little Falls, 86 years of age, made his will, March 12th, 1881, probated Apr. 30th, 1891, in which he refers to "son Schuyler R. Ingham, to receive \$2000., son William H. Ingham, \$2000., residue to daughters: Mrs. Jennette F. Waterman and Miss Maria Ingham."

Geo. A. Hardin and Schuyler R. Ingham appointed executors.

Administration was granted to Geo. D. Waterman on Dec. 5, 1903.

Inventory was appraised, May 10, 1905, to \$43733.78.

William Ingham died Jan. 10, 1891, and lies buried in the Ingham Mausoleum, Fairview Cemetery, Little Falls, N. Y.

William Ingham's wife, Eliza Schuyler, died May 12, 1880, and is also buried there.

2. Harvey (son of Samuel Ingham and Phebe Rowland, on page 45), and named, perhaps, after the author of "Hervey's Meditation," which was one of the five books in his grandfather, Joseph Ingham's, library, as we have seen on page 36.

He came, it is said, in 1820, to Manheim, village of Inghams Mills, which place was named after him.

The Baptist Church was organized in 1818, and the meetings were held in Oppenheim.

Here we find Harvey Ingham residing in 1827, when he, on May 16th purchased from Joseph G. Snell, of Manheim, for \$50. one acre of land in Manheim.

In 1830, he purchased more land in Manheim, partly from Jacob Wire, partly from Christian G. Nestle.

On Jan. 24, 1829, Harvey Ingham, and Sarah, his wife, daughter of Samuel Schuyler and still of Oppenheim, sold part of his land in Manheim to Alexander Conner.

From a Census Report of 1835, we find that Harvey Ingham of Manheim had a family, consisting of 3 males, and 2 females, of which one unmarried.

Harvey Ingham lived to an advanced age, dying in 1888, having made his will, as of Oppenheim, Fulton Co., May 26th, 1888, proved Oct. 28th, same year, in which he refers to:

"children, Erastus, deceased, and his children: William Harvey, Darwin S., Walter D., and Harriett A. Schuyler, all my real and personal property * * *

"son Warren is not to have any part of the Estate (as he has already received his share) * * *"

A SKETCH OF INGHAM'S MILLS

Algona, Iowa, April 30th, 1910.

Dear Bro. Walter:

As to the History of the Mills, I fear I shall find myself short in what you are wanting, but will try. The first settlement by the Inghams when they came from Conn., as I have it, was about this way. They stopped in and about Herkimer. Stephen A. Ingham settled at the Mills, first starting the flour and saw mill, which gave the name. Later Father built the clothing works, wool carding and cloth dressing, and took Uncle Fanscher Schuyler in company with him. Years later the Doctor (Uncle Stephen as we all called him) lost his property consisting of the mills and farm on which he lived, through the workings of his son (H. H. Ingham, who was engaged heavily in the lumber business, running several mills in different places) he giving him full letters of credit to the banks. I never can forget his many calls to get Father to take his property and assume his debts (at this time Father had saved up something like \$25,000). He finally, with Uncle William Ingham, made the arrangement, a very unfortunate one for Father as he finally assumed the whole thing, letting Uncle William out of it, and so all of the Mills were finally owned by Father. I said unfortunate without thinking as to what came out of it. It gave the boys plenty to do in all kinds of work and developed them as nothing else could have done for their life work later on, and as I see it today, it was a grand good thing for us all. It introduced us to different lines of work and especially to habits in conducting business (that has been a help all along the way).

Old Settlers—At the Dam, once Valentine and Dolly Bateman. The Butlers family and Father's home, all on the East side of the Creek. In the West side, on the Island, H. H. Ingham. The Mill house and Uncle Fanscher Schuyler, now owned by the Sadlers, across the dike. Sherman Butler, the old quiet mill house and the home where I first practiced carpentry, just South of it. Uncle Stephen's home on the hill (as we called him, or the old Doctor). Then Mr. Stephen A. Bowen's home and store and tailor shop. The church, and then Archibold Walrath's home and store, and Aunt Ruth, living in her little home on the Creek near by. On the other side of the street, going back, we had the Jacob Powell home, hotel and shed and ball room, once a great resort, and before that, the distillery. Then the tailor shop and home, and then the Shall home and wagon shop, and then the David Snell home, grocery and tanning works; and so we are back to the forks of the road at the Daniel Walraths black smith shop, just at the top of the hill, and then down to the old covered bridge heading to the old home, and many are the marks left on the North side of the bridge, when the boys left marks and openings made by shots from their guns, and frequently I was not far from the gun when it went off and so left my mark too. Well what thoughts this all brings up of our boyhood life. Thoughts that will linger for all time to come with me. We were fortunate in being situated as we were, with the best of parents and with a mother whose equal I never expect to find.

Well I must bring this line of thought to an end, lest I become too sentimental and overdo it, at the same time my mind often reverts to our old home life with great satisfaction.

THE SCHUYLER FAMILY

The Schuyler family, it is said, derives its name from a small village in Holland, the immigrant taking his name from his birthplace, or the locality where he resided, previous to emigration, a proceeding which was quite common among the Dutch.

Two brothers, David Pieterse Schuyler and Philip Pieter-son Schuyler, came over from Amsterdam, in Holland, in 1650, settling at Beverwyck, the present Albany. Their middle name, Pieterse, indicates that they were sons of a Pieter, of unknown surname, possibly Davison, in any case not Schuyler.

For the descendants of David Davitse Schuyler, see later on.

PHILIP PIETERSE SCHUYLER

born in Amsterdam, Holland, about 1628, emigrated in 1650, to Beverwyck, the present Albany, was a trader with the Indians, commissary at Fort Orange, in 1658, Magistrate in 1656-7, 1661-79, commissary of Albany, 1678, Delegate to the Mohawk Indians in 1655, Vice Director or Deputy under Governor Stuyvesant, 1656-, Captain of a Company of Foot, in Albany, in 1667, and of one in Schenectady, 1669, laid out with others, the town of Esopus, in 1662, married, at Albany, Dec. 12th, 1650, Margareta Van Schlichtenhorst, daughter of Brant Aerten Van Schlichtenhorst, of Newkirk, director of Renselaerwyck.

He resided on a bouwery at the Flats below the present village of West Troy.

Philipp Schuyler, "old Magistrate of Albany, and Margareta van Schlichtenhorst," made a testamentary disposition of their property, on May 1st., 1683, in which they referred to "children, Geertruy, wife of Stephen van Cortlandt, Alida, wife of Robert Livingston, Peter, Brant, Arent, 22 years old, Philipp, 17 years, Johannes, 15 years, and Margriet, 11 years, to have the real and personal property. Executor and guardian of minor children the survivor (in this case the wife). Witnesses Mr. Cornelis van Dyck and Magistrate Dirck Wessells Ten Broeck, and Robert Livingston, secretary.

"Margaret Schuyler, widow of Phillip Schuyler, sometime of Albany, merchant, being of sound mind, and considering that there having been some unhappy differences among my children:

the youngest of them being apprehensive that by the strict rules of the common law, the will made by my said husband and myself on May 1st., 1683, might not be authentick enough to make such equal division among our 8 children. But that Peter Schuyler, eldest son of my deceased husband, might be entitled to all the real estate. Yet, not thinking that my son, Peter Schuyler, would himself endeavor to take any such advantage, he being present at the making of said will. I give to each of our 8 children, an equal part of all real and personal estate. And I being further willing to dispose of the real and personal estate, which, by the extraordinary blessing of God, I have acquired and purchased since the death of my husband. And my son Peter, at my request, being agreed with the 7 other children, by deed, dated Aug. 16, 1707, by which all further differences among them are prevented, I do give to my 8 children, Gertrudy, Alida, Peter, Arent, Phillip, Johanes, and Margaret, and to the 3 children of my son Brant Schuyler, namely: Phillip, Oliver, and Johanes, all my real estate, real and personal. Provided always, that my son, Philip shall have the farm called the Flatts, with the utensils, he paying therefor, the sum of £600., to the rest. And they are to pay an equal part of 9 bushels of good merchantable wheat yearly, to the Patroon or Lord of the Manor of Rensselaerwyck.

"Cornelia Schuyler, widow of my son Brant Schuyler," also referred to.

David Schuyler made his will, May 21, 1688, proved April 11th, 1691:

"I leave to my eldest son, Peter Schuyler, my house and lot in Albany upon the hill between the houses of Captain John Wendell and Mr. Wyndert Hermanse. I leave to my wife, Catalyntie, all that my great house where I now dwell (in Albany), on the east side of the street next to the north gate, for 99 years or during her natural life.

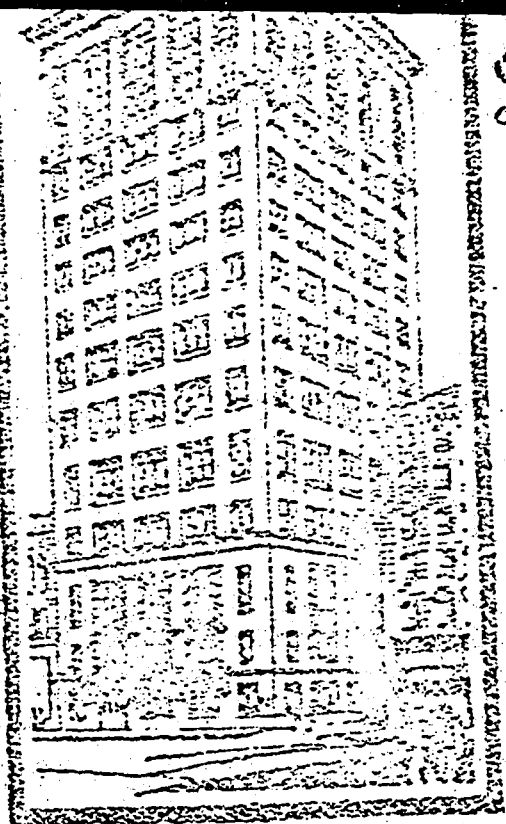
