This collection of records of the Ancestors and Descendants of Erasmus and Mary Sellers Jones is presented in this form for these reasons:

- 1. In trying to find information for the publication of the history of John and Mary Jones Kitchen Rife, by Rev. J. Merle Rife, Ph. D., New Concord, Ohio, it was allotted to the writer to search for the records of Erasmus Jones and Mary Sellers in the Philadelphia, Pennsylvania area. Since the publication of the Rife book so many facts have been uncovered that it seems wise that a record should be made of these so that future historians may know where to find them.
- 2. So much has been contributed by members of various branches of the family, it seems fitting that they should share the fruits of this search.
- 3. There are still so many breaches and unanswered questions in the history, this record is sent forth with the hope that it may come into the hands of persons able to furnish further information. If any of the readers are in the possession of such knowledge will they kindly send this to the writer so that copies may be made and sent to those wishing a more complete record.
- 4. We shall attempt to give an account of the time and place of residence of our ancestors, their occupation and religion. This, with a very few exceptions, is easy, for it is largely in church records that the history of this branch of our ancestors is preserved. In addition to these church records we have used information obtained from family traditions and records in family Bibles. Throughout the record will be found copies or condensations of certain wills and deeds which establish the facts of the record.

THE FAMILY TRADITION

The best statement of the family tradition is written by Mrs. Cynthia E. Wilson, now deceased. This is furnished by Mrs. Grizella J. (Walter A.) Hufford, Frankfort, Indiana.

"Early history of the Erasmus Jones Family given to me (Cynthia) by Alsa Kitchen, Springfield, Ohio. Aunt Keturah Jones her authority.

- 1. Rev.---- Thomas, First Baptist Preacher in Philadelphia, was the father of Leah Thomas, who was the mother of Erasmus Jones (our great grandfather.)
- 2. Samuel Sellers came to America in 1680 from England, in 1682 he was married to Ann Gibbons in the Darby Meeting House (Quaker). These were our ancestors, but we do not know how far back.
- 3. A family by the name of Sellers had a little son whose name was "George". He was stolen one day while his parents were at Market, in Philadelphia. Later another son was born and he too was given the name George. In the course of time the first George was found, then they had had a "big" George and a "little" George. Alsa said if she remembered

correctly one of these Georges was our great grandmother's father.

4. Mrs Anna Kitchen Rex, a grandaughter of Abraham and Matilda Kitchen, also a great grand daughter of Erasmus and Mary Jones, wrote me from Iowa, that the names of the parents of Mary Jones, mentioned above, were George and Sarah. Her authority was Aunt Keturah Jones, a sister of our grand mother Bate. She also told us of a Samuel Sellers who lived near Chad Ford, Pa. And the battle of Brandywine was fought on it. She did not know whether the Samuel Sellers was our relative or not.

Mrs Rex said that she had been told that Bucks Co. was the birth place of Erasmus and Mary Jones, while I was informed that Washington Co. was the place. She also says that they moved to Ross Co., Ohio, Chillicothe; while my record says Highland Co. was where they settled."

THE THOMAS FAMILY

"The Thomas Family of Hilltown, Bucks County, Penn'a". By Edward Matthews. Published by Arthur K. Thomas, Lansdale, Pa. 1884. This book of 68 pages is to be found, either in the Pennsylvania Historical Society Library, 1300 Locust Street, Philadelphia, or the Bucks County Historical Society Library at Doylestown, Pa. From this book and from a rare volume by Morgan Edwards on the Early Baptist Churches of Pennsylvania, published in 1770, we glean these facts.

Rev. William Thomas

Rev. William Thomas, great grandfather of Erasmus Jones, was born in the year 1678. The place of his birth was Llanwenarth, in Monmouthshire, Wales, a county at a distance from the seacoast, and bordering on the confines of England. He appears afterwards to have removed some distance, as before the time of his emigration he was living on a farm called "Blassaw of Wyn," in the Parish of Bedwlldy. His family were not of the poorer or peasant class, but possessed some means, and were freeholders of an estate of considerable value. Their condition also enabled him to secure a superior education compared with the majority of his countrymen emigrating in those times to America. He acquired the knowledge of a mechanical trade—that of a cooper—. He did not marry until over thirty years of age. His wife was Ann———. We have no record telling of her maiden name, but it is supposed to have been Griffith. She was two years his junior, born in 1680.

It appears that William Thomas had early in youth embraced religion and that his good character and his gift as a speaker and exherter had already secured from his brethern an entrance into the gospel ministry.

After the death of his parents he sold a patrimonial estate of considerable value and prepared to improve his fortunes in a land where liberty and equal laws offered better advantages, and to which Penn's broad invitation was tempting the generous, the hopeful, and the aspiring of all people's to come and make their abiding homes. It was a wintry

day in the beginning of the year 1712, at the age of thirty-four that William Thomas attempted to embark for America in a vessel bound from the city of Bristol. The pen of Rev. Joseph Mathias, as he wrote in his memoirs at Hilltown in 1833, now narrates a strange adventure.

"He with his wife and first born son, named Thomas (then an infant) left their native land to come to America. He agreed for passage with a vessel lying at Bristol, bound for Philadelphia. The value of his possessions was such that the prospect bid fair for him to become a land-owner to a large amount in this country, with plenty of cash to enable him to build, stock and improve to advantage. His cash, some valuables, together with all the clothing for himself and his family, except what would be necessary for their use for a few days, were all put on board the vessel. The freight was not all on board, nor the passengers all ready, but a day was assigned on which they should sail. In the interim he took his family to the country, intending to return at or before the appointed day. They did return before the appointed time assigned, but found to their great grief that the vessel had set but was not yet out of sight. Pursuit was made in some small craft, signals were hoisted and kept up, but to no purpose. The vessel was lost sight of, and the family left destitute. They agreed for and took passage on credit in the first vessel bound for Philadelphia, where they arrived safe on 14th of February, 1712. Upon inquiry, they found the vessel in which their property had been deposited, but the master of the vessel had absconded, the ship was in care and possession of others. They had the mortification to see some of their goods in possession and some of their wearing apparel on the backs of those who had purchased them from the dishonest master of the vessel, yet they were not able to recover anything!

The history then tells of how our ancestor took up his trade as cooper, moving to Radnor, now Deleware County, and in five years, was able not only to support a growing family, but was able to gain money sufficient to begin the purchase of land. He left Radnor and came back to Philadelphia, then on February 12, 1718 purchased 440 acres from Jeremiah Langhorne. On September 28, 1723 purchased from James Logan 300 acres. By subsequent purchases from Rowland Ellis and Benjamin Philips he had possession of 1258 acres, and all in Bucks County on the border of Philadelphia (now Montgomery) County, east of Line Lexington. This he divided among his seven children, building for each astone house.

His children were Thomas, John, Gwently (married Morris Morris, and from date on tombstone seemed to be a twin of John) Ephriam, Mannasseh, Anna and William.

"He possessed the judgment and shrowdness which combined with industry, enable men to acquire and hold property, and in material goods he became prosperous and wealthy, for those days.

"He did not, however, confine his labors soly to money-getting. He could not forget that he was a Christian and a minister of that gospel which in his youth he had preached in his native land. He had the education and gifts fitting him for a leader and instructor, nor did he shrink from the duty, though in the then condition of the settlement he could hope for no pecuniary reward for such spiritual labor."

He belonged to the Baptist church at Montgomery (now Colmar, Pa.) but that was several miles from Hilltown and farther from numbers of Welsh settlers living farther north.

In 1737 he built a church, furnishing four acres of land. A hollow gum tree block was his pulpit. Having had military training he wore his arms, laying them beside the pulpit while conducting the service. The men would stack their arms against the wall outside the door and one man stood guard against attacks of the Indian.

Here William and Ann, and their seven children are buried. The graves and the church property are kept by the proceeds of a fund in trust provided by William Thomas and kept now in a Doylestown Bank.

Ann Thomas died November 5, 1752, at the age of 72. William died October 6, 1757 at age of 79. A large, flat merble stone, inscribed with name, age, and epitaph marks each of their graves. The epitaph on Williams' grave is supposed to be of his own composition:

"In yonder meeting-house I spent my breath, Now silent, mouldering here, I lie in death: These silent lips shall wake, and yet declare A dread amen to truths they published there."

"We are told he was able-bodied, a short, thick-set, "chunky" man, of dark hair, eyes and complexion, rather bony and spare than fleshy, and sharp-spoken or sententious in speech." His physical and mental traits, as well as complexion, were transmitted to a large number of his descendants. Rev Joseph Mathias says; "he possessed an easy address, possessing a strong, discriminating and vigorous mind, and had a fair education in both Welsh and English."

We note he had a school in connection with the church. This a century before the public school system was inaugurated.

His will was written by Rev. Benjamin Griffith, of Montgomery, his pastor and brother in the ministery, on 11th of December 1753. This will has been often quoted, and is an some respects a classic of colonial wills. Original filed Doylestown # 919, Vol, 2, page 315. Three and one half closely written pages.

REV. JOHN THOMAS

The father of Leah Thomas Jones was John Thomas, second son of Rev. William Thomas. He was born soon after his parents arrived in America, December 9, 1913 (11), at Radnor, Chester County Pennsylvania. About the year 1738, having arrived at the age of twenty five, he married Sarah James of Radnor. He did not receive a call to the ministry till near middle life, in 1749, at the age of thirty six, and was ordained two years afterwards. In the early years of his ministry he appeared to have labored as an assistant to both Rev. Benjamin Griffith, at Montgomery, and of his father at Hilltown. In 1768 Rev. Benjamin Griffith, the veteran pastor of Montgomery, died at the age of eighty, after a long pastorate of forty-eight years, After his death John Thomas was installed as sole pastor of

the church, and continued as such for the next thirteen years. (From Historical sketch of Montgomery Baptist Church, by E. R. Clemens, on occasion of 210th anniversary, June 1929.—"Montgomery Baptist Church is the 91dest Church in the "Philadelphia Association" from point of Continuous Membership." John Thomas was the second pastor. This is the fact back of the tradition of "Rev.—— Thomas, father of Leah Thomas Jones being the first Baptist preacher in Philadelphia." Montgomery County was not formed until 1800 and it was in Philadelphia Association and Philadelphia County.)

The church had difficulty in maintaining peace during the Revolution, and it seems there was need of great grace and patience on the part of our ancestor, who in 1775 was a member of the Malitia, and has a Revolutionary Soldier's marker on his grave. On November 28, 1781 he, with fifty-four (54) members living near Hilltown, withdrew from the Montgomery to the daughter congregation at Hilltown. Here the labors of John Thomas were greatly blessed by a large increase in members. The last time he administered the rite of baptism was in June 1786. From the effects of a slight stroke he became so disabled that it was with difficulty he could be borneto the two places of worship and attend to his ministerial labors. At his request on March 26, 1789, the congregation chose Rev. James McLaughlin to succeed him. He died October 31, 1790, aged 79 according to the inscription of the tombstone. widow, Sarah, lingered on earth yet nearly fifteen years. At the age of ninety-four, she died April 5, 1805. Her's was the first funeral discourse preached by Rev. Joseph Mathias, from a text of her own selecting: "In Thy presence there is fullness of joy; at Thy right hand there are pleasures forevermore." Mathias in his Memoirs and Journal speaks of her as a "goodly, pious woman." The graves of John and Sarah are at the foot of the graves of William and Ann, parents of John. stone marking John's grave is inscribed with: "Here lieth the body of Rev'd. John Thomas who departed this life October the 51st, 1790, aged 79 years." "Faithful Minister of the Gospel,

A Useful Citizen&

A Sincere Friend."

This date would make his birth 1711, conflicting with Mathias as given above.

Rev. John and Sarah James Thomas had four daughters: Anna, married Nathan Brittain, Rebecca, married Daniel Pugh, Leah, married Samuel Jones and Sarah, married John Blackwell. To each of these was given a farm.

The home of John and Sarah was Fairhill, Pa. N. W. of Hilltown, $1\frac{1}{2}$ miles.

His will is in Recorder of Wills, Doylestown, #2294 and recorded in Book 5 page 195. This part is of interest to us.

"I give and devise unto my daughter Leah, the wife of Samuel Jones, my plantation now in occupation of Thomas Morris, containing about seventy acres, be it more or less, to hold said land and premises with appertenances thereunto belonging unto my said daughter Leah for and during the term of her natural life, And it is my Will, and I do order and direct that after the decease of my said daughter Leah (as soon as conviently may be) that my Executors or the survivors of them do

sell the aforesaid lands and Premises for as much as will bring and make good and sufficient Deed or Deeds to be paid to the Purchase Money as I myself might or could do were I alive and personally present, at the doing thereof. And the money equally divided among all the children of my said daughter Leah and her Heirs." The will written May 31, 1788. Codicile dated October 24, 1789. "After my death Sarah, my wife, shall have during her lifetime premises-(described home with 29 acres). At her death it shall belong to my grandson Samuel Jones; Also at my death my grandson Samuel Jones shall have all my veering apparel." Executors, Wife Sarah" (who waived because of advanced years), Grandsons, John Brittain and John Pugh. The other daughters (3) received farms.

LEAH THOMAS JONES

The mother of Erasmus Jones was Leah Thomas Jones the third daughter of Rev. John and Sarah James Thomas. She was born in 1742, married Samuel Jones. "We find that both she and her husband were members of the church (Montgomery) in 1770, and his name appears on the list of taxables in 1774. But in 1781 the names of neither are on the church records. Mathias says, "He raised a large family, and many years ago (1832) hearemoved to the Western country." The time of his removal is uncertain, nor does the writer know aught concerning his descendants." Mathews. Nothing is known of her death.

SAMUEL JONES

Late in the seventeenth century the Welsh began to use Family (Christian) names. A man called Thomas took this as his family name. In like manner James, Griffith, Evan became Evans, John became Johns and Jones. There were many different families of these names among the early Welsh settlers in Chester, Philadelphia and Bucks Counties. And Samuel Jones was a popular combination. In the first U. S. Census (1790) there is listed thirteen Samuel Jones in Pennsylvania, and in the part of Virginia records not burned by British in Washington in war of 1812, there are at least five.

Samuel Jones, father of Erasmus Jones, was born in Bucks County in 1742. He may have been the son of Samuel Jones Sr. whose will is on file in Doylestown, Pa. Will Book 3 page 133. "Samuel Jones, Sr. of Plumstead (Bucks Co.) Yeoman-October 28, 1765 proven. Wife Margaret and son Samuel executors; Beneficiaries; Sons, Samuel and John, a minor; Daughters Rachael Brittain and Mary; Grandson Samuel Brittain."

There were many other Jones at Hilltown and Montgomery. A Margaret Jones is buried in Hilltown cemetery who died in 1807, aged 95 years. She may have been the mother of Samuel.

There are some interesting war records of our Samuel Jones. Mrs. Maud Fields, daughter of Mrs Lewis Green, nee Delilah Jones, Valparaiso, Ind., made this note from a D. A. R. book; "Mrs Ann L. Jones Butler, Born in Mercer Co. Pa., D. A. R. No. 51104, Wife of Isaac Butler; Descendant of Lieutenant Samuel Jones and John Thomas of Pa. Daughter of Isaiah Jones and Sarah Hartford, his wife. Grandaughter of Samuel Jones and Leah Thomas, his wife. Great-grandaughter of John Thomas and Sarah James, his wife.

Samuel Jones (1742-1810) served in 1777 as Lieutenant and Paymaster of the 11th Regiment of the Virginia Line. He was born in Bucks Co. and died in Washington Co. Pa.

John Thomas (1711-1790) served in 1775 in Capt. John Lacy's Bucks Co. Malitia."

In "Historical Register of Officers of the Continental Army." by Heitmann, on page 61 it says; "In September 1778, the number of Virginia regiments were reduced from fifteen to eleven, and designated as follows; ***** Eleventh to the Seventh, ***** Fifteenth to The Eleventh."

Heightmann in same book; page 325; "Samuel Jones (Va) 2nd Lieutenant Virginia 15th, Nov. 25, 1776; Regimental Paymuster, Jan. 7, 1777; lst Lieut. Sept. 1, 1777; Dismissed June 6, 1778; Restored June 11, 1778 by Washington; Retired January 1, 1780.

Also on the same page; "Samuel Jones, 2nd. Lieutenant 15th Virginia January 22, 1777; 1st Lieutenant April 1, 1778; Captain January 1, 1780; Retired January 1, 1781."

Now let us turn to Saffell's "Records of the Revolutionary War." Page 256. "Name and Rank of the Field Staff, and other Commissioned officers and Privates of Col. Daniel Morgan's 11th and 15th Virginia Regiments, Incorporated as they stood from May 31, 1777 to November 30, 1778.

Daniel Morgan, Colonel; Abraham Buford, Colonel from May 15, 1778; John Cropper, Lieut. Col. from May 15, 1778; David Stephenson, Major; Philip Slatchter, Captain and Paymaster after June 1, 1778; Samiel Jones, Lieutenant and Paymaster, Albrighton Jones, Adjustant; John Barnes, Lieut. and Quartermaster; Mace Clements and John Davis, Surgeons; John Crute and William Death, Quarter Master Sargeants; Charles Erskine and Thomas Pollock, Sargeant Majors; Robert Sharman, Fife Major. Privates noted in Co. 1; John Brittain, enlisted March 14, 1777; Joseph Bates, enlisted May3, 1777."

Page 266: "Co. 11 as it stood November 30, 1778. James Gray, Captain; Samuel Jones, Lieutenant and Paymaster; etc."

Page 395. "Captain Samuel Jones, Of the Virginia Line, served in 11th Regiment as Lieutenant from September 1777 to January 1780, and as Captain from January 1, 1780 to January 1, 1781."

Page 397. Lieutenant Semuel Jones. Of the Virginia Line. There were two of this name, one of the 11th, and the other of the 15th Regiment. The one of the 15th Regiment was dismissed from service June 6, 1778, and restored by George Washington on the 11th of the same month."

There is doubt in the writers mind as to the identity of our ancestor. I am inclined to think Heitmann and Saffell have confused the identity. Therefore a record of Washington's report to Continental Congress in the last reports before leaving Valley Forge is of interest.

Saffell, Page 373.

"H. Q. Valley Forge, June 6, 1778.

Officers for duty; Brig. Gen. Patterson; Lieut Col. Coleman; Major Moore;

Court Martial. ******** At the same court, Lieut. Samuel Jones, of the 15th Virginia Regiment, was tried for "Concealing, denying that he had in his possession, a pair of mittens belonging to Capt. Hull; 2nd

Brig. Gon. Bannister;

for gaming on 12 of May, and sundry other times; 3rd for behaving in a manner unbecoming an officer and gentleman in treating Captain Hull with abusive language while under arrest, and endeavoring to incense the officers of his Regiment against him." The court, having considered the charge, and evidence, are of opinion that Lieutenant Jones is guilty of the charge exhibited against him, and do sentence him to be discharged from the service.

The General is entirely disposed to believe from the representations he has received in favor of Lieutenant Jones, that he was incapable of having retained the gloved with a fraudulent intention; but as he has been clearly proved to have been guilty of the pernecious practice of gaming, which will invariably meet with every mark of his disapprobation, he confirms the sentence of dismissing Lieutenant Jones.

Some historical facts will throw light on this incident. Col.Daniel Morgan was absent from Valley Forge at his home in Virginia during the Spring of 1778. There is a record of one of his men being "lashed" and the anger of Morgan when he returned. Morgan's regiment had been the turning influence at the battle of Saratoga, were then ordered to report to Washington at Valley Forge. When Clinton evacuated Philadelphia June 16, 1778, only five days after this report, Washington's army pursued and engaged the British at Battle of Monmouth in New Jersey. Here again Morgan's army gave good account of themselves. No Regiment in the Continental Army had a better record, and were favorites with Washington.

It would seem that Samuel and Leah left Hilltown early in the 1770's and settled some where in the region of Winchester, Va. Then after the Revolution moved to West Augusta County, Va. part of which is now Greene, and Washington Counties, Pa.

In Samuel Bates History of Greene Co. Pa. Waysburg. 1888. "Goshen Baptist Church was organized Oct. 7, 1776. In minutes of Baptist Association Sept. 26, 1800, the Clerk, Benjamin Jones. Also Benjamin and Robert Jones among ministers and Messengers from Goshen."

There is not available a list of the children of Samuel and Leah. These we know; Samuel, Erasmus and Isaiah.

At a family reunion of the Thomas Family at Chalfont, Pa. Aug. 23, 1902, greetings were sent by Rev. Jefferson Harrison Jones, Alliance, Ohio, age 89, known in earlier days as "The Boy Preacher", a grandson of Leah Thomas.

THE SELLERS' FAMILY AND IT'S NAME

Excerpts from a paper furnished by The Media Research Bureau, and sent by J. Forrest Kitchen, Attorney, Springfield, Ohio.

"The name of SELLERS is said by some authorities to have been of local origin and to mean "of the cellar", but it seems more probable that it was taken from the office of Cellarer, a position of some importance in the ancient feudal houses. It is found on ancient records in the various forms of Celler, Seler, Selers, Celers, Cellers, Cellars, Sellars, and Sellers, of which the last is the most generally accepted form today.


There was also an ancient German family of the name of Soller or Seller from which several of the American families of Sellers are descended.

Among the early records of the family in England are those of Adam de Celer of Yorkshire in the year 1273, Rodger de Celer of the same place in the latter part of the thirteenth century, Alicia, Adam, Juliana, and Agnes del Seler of Yorkshire in 1379, and Thomas Sellers of St. James Clerkenwell in the latter sixteenth century, who had a sone named Robert who was living in the year 1617."

THE SELLERS' COAT OF ARMS.

The coat-of-arms of the English family of Sellers from which we descend is described as follows:

Arms. --- "Gules, a chevron between three covered cups argent." Crest. -- "A demi-swan, wings endorsed argent." (Arms taken from Burk's "General Armory", 1884)

"Thomas and Elizabeth Sellers, "of an old and well connected family of Derbyshire, England whose ancestors had held position for generations." Their children are as follows:

- 1. John, baptised 8,20,1648--buried 4,28,1664.
- 2. Elizabeth, " 1,13,1649. 3. Mary, baptised 9,6,1651.
- 4. George, "2, 3,1652, came with Samuel to America, killed within a few years after coming to America. Was not married.
 - 5. Samuel, baptised in Duffield church, Derbyshire, 2,3,1655.
 - 6. Sarah, " 6,20,1663."

SAMUEL SELLERS I (Belfar, Derbyshire, England)

In 1681 or 1682 George and Samuel Sellers came from Belfar, Derbyshire England in one of the ships that came with William Penn. They settled in Chester County, Pa. (Upper Darby) The first minute in the Women's Meeting of Darby is the account of the marriage of Samuel Sellers with Anna Gibbons, it reads thus: (5,2,1684) "Samuel Sellers and Anna Gibbons declared their intention of taking each other in marriage, it being the first time." At a Monthly Meeting at Darby the 6th day of 6th month 1684, Samuel Sellers and Anna Gibbons declared their intentions of taking each other in marriage the second time."

Anna Gibbons was the daughter of Henry and Eleanor Gibbons of Parrich, Derbyshire, England. The father had suffered imprisonment for his refusal to conform to the Established Church. These all came to America in 1682.

It is said that the Friends had no house of worship and that Samuel and Anna were married in the home of one of the Friend families. After the second declaration Samuel took Anna behind him on his horse and thus they rode the two or more miles from Darby to Upper Darby and for the first year they lived in a "Cave" on the farm he bought in 1690.

This couple was prominent in the affairs of the Darby meeting. Of Samuel it was said; "he was a prominent and respected citizen." He held many public offices, farmed; but spent most of his time weaving.

His will was proven at West Chester, Chester Co. 12,15,1732. It is recorded in Book 1 page 389. The original will and papers are filed in Papers 471. The original will is legible, but the paper is about to fall to pieces.

The children of Samuel I and Anna Gibbons are as follows:

SAMUEL SELLERS II

Samuel Sellers II, born 3, 12, 1690, and died 6, 3, 1773, was the only surviving son of Samuel Sellers I and Anna Gibbons Sellers. lived on the same premises, followed the same trade of weaving as his father. Me was somewhat noted for his mechanical ingenuity. He erected the first twisting-mill, it is believed, in Pennsylvania (a complex machine for twisting worsted), and became famous for coverlets and camlet weaving." Futhey's History of Chester County, furnished by Nathan Rambo, Esq. West Chester, Pa.

The Pennsylvania Gazette of June 9, 1773 says of Samuel; "A kind husband, a tender parent, a good neighbor, and above all an honest man."

Samuel and Sarah were life long members of the Darby Meeting and their names appear many times in the minutes. Sarah seemed especially active. Samuel Sellers and Sarah Smith "declared their intentions" in Darby Meeting, 7, 3, 1712 and 8, 8, 1712. Sarah died 5, 24, 1778. The children of Samuel and Sarah Smith Sellers were as follows:

The will of Samuel Sellers II on record at West Chester, Pa. Paper 2771, (the original) and recorded in Book 5, page 413. The will proven June 15, 1773 by William Parker, Susanna Marshall and Isa. Pearson. Who had witnessed it's being written. Being written January 20, 1772. Sons in law John Hunt and David Gibson, Executors.

There are items in this will that may be of great revelation to us who descend from Mary Sellers Jones. It is a commentary on the character of the father, in his consideration for his sons, especially Joseph. We shall give sketches of the will as they relate to Joseph.

"Item (two) "I give to my two sons-in-law, John Hunt and David Gibson to each the sum of ten pounds of lawful money in Pennsylvania, for and on account of twenty pounds which they advanced some years past on behalf of my son Joseph Sellers, and in order the better to make them whole, for that kindness my will is that interest shall be allowed them out of my estate for the same to be reckoned thereon from the time of such advancement until the time of payment."

"Item (three), I give to my son-in-law, Lewis Davies and to my son John Sellers to each the sum of Five Pounds money aforesaid in regard of Ten pounds, which they advanced some years past on behalf of my said son Joseph, and as it is my will and mind that they shall be paid interest for the same in like manner as it is before expressed for my two sons-in-law, John Hunt and David Gibson."

"Item (four) I give to my son Joseph all my wearing apparel and my gun or firelock to be delivered to him in one month next after my decease. I also give and bequeath to my son Joseph my clock and the clothes press in my parlor--(after my dear wife's decease.) I also give my said son Joseph

the sum of twenty pounds lawful money aforesaid to be paid him at the end of one year next after my decease." (Farms had been given to each Samuel III and John.

SAMUEL SELLERS III

To try to establish the identity of the grandfather of Mary Sellers Jones, it is necessary to examine the records of the families of each of the three sons of Samuel II and Sarah Smith Sellers. We shall show the records of children of Samuel III and the children of his two sons Samuel and Jonathan.

Samuel Sellers III, b. 5,20,1715, died 12,31,1785; married 7,28,1737, to Jane Wood, daughter of George and Hannah of Darby, she was born 9,5,1716, and died 3,5,1790. They removed from Darby to West Bradford, now Pocopson soon after marriage. This to a four hundred acre farm near the Brandywine. The records of their children are taken from the minutes of the Bradford Monthly Meeting, Vill proved 1,14,1786 No.3756, Vol. 8,P.25. and from records of Charles Coleman Sellers, Secretary of Sellers Association.

The children of Jonathan Sellers b. 1755 and Deborah Taylor, married 10,2,1777, and Tainor Haney, as given in will of Jonathan, 1817. Elizabeth Nichols, Littia Archer, Hannah Wickersham and Sarah; by Deborah Taylor. Asanah, Joseph, and perhaps others by Tainor Haney. Charles C. Sellers says this list may well be incomplete. But since Mary Sellers Jones was born January 22, 1777 she could not be daughter of Jonathan, although there is a tradition that she was raised by her Uncle Jonathan. If there is any foundation to this, other than she memed her son Jonathan Sellers, then Samuel II, or Samuel III must have had a son not shown in the records.

JOHN SELLERS

The history of John Sellers, son of Samuel and Sarah Smith is to be found in many accounts. He was an enterprising manufacturer and scholar. But we will not pause to review the illustrious record of John and his descendants, who are still prominent in many circles in and about Philadelphia. are only interested to discover if Mary Sellers Jones born 1,1777 could have been his grandaughter.

It seems that Mary Sellers Jones could not have been born of either of these two lines, and it does not seem probable that there could have been a son Thomas, of either Samuel L of Samuel II, as some traditions would imply. So in our search we try to discover records of Joseph and Hannah Paschall Sellers, and find if there is a possibility of Joseph and Hannah being the parents of George, the father of Mary Sellers Jones.

JOSEPH SELLERS

Joseph Sellers, b. 4,15,1726. Son of Samuel Sellers II and Sarah Smith. Certified by the Darby Meeting 11,6,1747 to Laycock Meeting, Darby, Min. Darby Meeting record of marriages says, "Joseph Sellers, of Boro of Lancaster, County Lancaster was married to Hannah Paschall of Darby, 1,13, 1751. Hannah Paschall was the daughter of William Paschall and Hannah Roberts and was born at Whiteland, Chester Co. 10,3,1723." (Minutes of Goshen Meeting.) William Paschall was born 1,8,1697, son of Thomas Paschall and Margaret Jenking, Thomas was the son of Thomas Paschall, Sr. and Joanna Sloper, b. 3,13,1635, d. 7,13,1718, emigrated from Bristol, England, 1681. (Morris Family of Philadelphia, Vol.II p551.) The Paschall family is a prominent family living near Wilmington.)

Darby Meeting granted a certificate to Hannah to Sadsbury Meeting, Lancaster County, 3,1,1751, just six weeks after she married Joseph Sellers. Sadsbury Minutes show no record of Joseph and Hannah ever uniting. But we next find a record of two children of Joseph and Hannah Sellers in the Wilmington, Eel. Meeting, viz; Paschall Sellers, son of Joseph and Hannah, born 12,7,1753, almost three years after they were married. Also Hannah, daughter of Joseph and Hannah Sellers, born 2,7,1758. Then again a Certificate dated 'Wilmington, Del.Monthly Meeting, 13th 6th mo. 1764. To Darby Meeting. Dear Friends, Joseph Sellers being removed within the verge of your meeting has requested our Certificate for himself, his wife, Hannah, and two Children to wit Hannah and Sarah in order to be joined to you, therefore on Enquiry we find their lives and Conversation hath been in a degree orderly and attended our Religious Meetings, their affairs are settled to Satisfaction as far as we know, the Children being young we can't say much more but recommend them to your Christian Care and remain your Friends, Brethern and Sisters. (Signed with 35 names) (Furnished by Mrs. A. Stanley Ayers, Custodian of Records, Wilmington.)

A Darby Minute indicates a committee was appointed to wait on Joseph and Hannah, and 11,1,1764 they were received into Darby.

The Wilmington records had no account of the birth of Sarah, and no record of a transfer of Paschall, who was ten and a half years of age when the certificate of transfer was given to Darby Meeting. The records of Wilmington are manifestly incomplete of this family. There is the probability that there were other children.

Paschall Sellers died in Philadelphia in 1832, willing his small estate to his sister Hannah, who had married William Rose in the German Reformed Church, in Philadelphia, June 7, 1777 and for this dismissed from the Darby Meeting.

Joseph in 1764 was evidently going through great financial difficulties. Perhaps before this time his father had helped, as well as his brother and brothers-in-law. (see will) The father died in 1773 and the mother in 1778. There could have been no blot on his character, for on date of 10,29,1789 Darby Meeting certified Joseph and Hannah Sellers to the Philadelphia Meeting, they having been members since Wilmington gave them a letter of standing. The records of Deaths of Philadelphia Meeting tell that "Hannah Sellers wife of Joseph Sellers, was buried in the Philadelphia Meeting Cemetery, June 5, 1791, aged about 68 years." Minutes 1686-1807, page 487. "Records of Administration of Estates, 1808 - K - page 325. Joseph Sellers, Blacksmith, Letters of Administration were granted to Sarah Sellers on estate of Joseph Sellers, dec'd. Oct. 13th, 1808. \$800"

Aunt Keturah Jones is authority for the statement that "George and Sarah Sellers were the parents of her mother, Mary Sellers Jones, and that George was a descendant of Samuel and Anna Gibbons Sellers." The records of the children of Samuel and Anna Gibbons, as well as of their only surviving son, Samuel LL and his wife Sarah Smith Sellers, and the records of their two sons, Samuel III and his wife Jane, and John and his wife Ann seem to be complete. But the records of the remaining son of Samuel II and Sarah Smith Sellers, viz; Joseph and his wife Hannah Paschall Sellers are not complete; therefore the logical conclusion would be that they had a son George, that was stolen, later another son George was born before the first George was recovered.

The traditions of a relative having a farm near Chadd's Ford, over which the battle of Brandywine was fought, are satisfied in the fact that Samuel III, brother of Joseph Sellers, had this farm during the Revolution and, at his death, it was divided between his two sons, Samuel IV and Jonathan Sellers.

GEORGE SELLERS

A clipping reporting the speech of James Hatfield, made on the occasion of a marriage anniversary of John and Mary Jones Kitchen Rife, told of the father of Mary Sellers Jones "marrying a Swedish girl of the Swedes from down toward Wilmington, Del." The Records of Holy Trinity (Old Swedes) Church in Wilmington give these two records; page 744. "George Sellers married Sarah Clifferd, Dec. 6, 1775." page 760, "George Sellers married Ann Matson, Dec. 6, 1786." George Sellers and Sarah Clifferd, married Dec. 6, 1775 must have been the parents of Mary Sellers Jones, born January 22, 1777. To date we have not found any further records of George and Sarah. The name Clifferd may have been a variant spelling of Clifford which would seem to be an English name. However Sarah's mother may have been of Swedish extraction.

ERASMUS AND MARY

Erasmus Jones, son of Samuel and Leah Thomas Jones, was born at Fair-hill, Bucks County, Pa. (near Hilltown) February 1, 1767, and died at Selma, Ohio, March 1, 1850.

The Samuel Jones family moved from Bucks Co. about 1770, for "the Western Country." They may have stopped in Chester County, but, since Samuel was in the Virginia Line Regiment of Colonel Daniel Morgan, made up of men west of the Potomac River and formed at Winchester, Virginia, it would seem that he settled in the general region of Berkley County, Va.

The first record we find of Erasmus is "the court record of Erasmus Jones signing a surity bond in Augusta Co., Va. in 1790, because of a "hurt on his arm" he signed by making his mark."

Mrs. Lewis Green sent part of the notes of Mrs. Myrtle Richie of Washington County, Pa., a genealogist making a search for Mrs. Green. "I find that Erasmus Jones was on the 1793 census list of Washington County. In 1796 the part of Washington in which they lived was cut off into Green County. And prior to 1780 this section was claimed by Virginia." West Augusta County embraced that part of Pennsylvania south of the Ohio River and West of Laurel Ridge Mountain.

An Indenture recorded in the Recorder of Deeds office in Doylestown, Bucks County gives conclusive evidence as to date of moving to Ohio. Record of Deeds, Vol. 30, page 337. "An Indenture made November 6, 1799, between Samuel Jones of Ross County by his attorney, John Brittain of Ross County in the North Western Territory of the United States of America, of the one part, and Isaac Swarts of Hilltown Township********** second part." This to sell the expectancy of Samuel Jones (son of Leah) in the 29 acres willed to his grandmother, Sarah Thomas, who had agreed on an annual rental of 12 pounds for the remainder of her life. This states; "Samuel Jones hath by his attorney given under his hand and seal the Twenty Eighth of November Anno Domini 1797, acknowledged before Samuel Shannon Esq. one of the justices of the Peace in and for the County of Washington, ets."

John Brittain was a grandson of John Thomas and one of the executors of his will, also Mathias writes that John had moved to the banks of the Scioto River, N. W. Territory.

"Ross County, the sixth such political division in the state of Ohio, was formed by the proclamation of Govenor St. Clair on August 20, 1798 and was named after James Ross, who moved into that region from Allegheny County, Pa. The first surveys were made in 1792 by Colonel Massie, Chillicothe was laid out by Massie, petterned after Philadelphia, in 1796, and incorporated January 4, 1802." History of Ross County.

Stafford McCullough, Clifton, Ohio, sends word that the original survey of Ross County cornered at a point located about a mile east of Clifton. So both statements in our tradition are true. Erssmus and Mary did come to Ross County, but by 1809 when their daughter Matilda was born, their home was in the new County of Highland.

Erasmus and Mary evidently moved to Ross Township, Greene County before 1815, as the history of Erasmus Jackson Jones, though giving a wrong

date for his birth, stated he lived and practiced medicine in the same house in which he was born. This near Selma.

In Greene County Recorder's Office Vol. 20, page 365 in recording the deeding of an acre of land by William Thorno, given for school property, Erasmus Jones is mentioned as one of the School Directors. Also Vol. 15. page 145 two transfers of land, Oct. 13, 1833 which Erasmus and Mary his wife had purchased from James Taylor and Keturah, his wife.

My mother told of how her mother, Martha Matilda Jones, rode behind her father on horse back to the Baptist Church which stood on the north bank of the little Miami River a mile east of Clifton. Thirty years ago there was still some evidence of the cemetery of this church, but now there seems to be no mark and very few people remember of such a place of worship in the pioneer days.

It has always been my conviction that Mary Sellers Jones was raised in Philadelphia. In the history of Erasmus Jackson Jones, M. D., you will note the phrase, "Dr. Jones mother was well educated." There are many dishes in our family that are kept as heirlooms as belonging to Grandmother Kitchen's family. The thought has always been held before us that these were brought from Philadelphia, when they moved from there. This is true of two meat platters now in possession of Margaret B. Rife, Cedarville, Ohio. Mrs. Gretta Harris of Clifton has a glass dish, Erasmus carried in his saddle bag from Philadelphia and gave to our grandmother on the sixteenth anniversary of her birth, this would be 1825. Annt Keturah told of a china store in Philadelphia, owned by relatives.

The Erasmus Jones farm was south of Selma, Ohio, perhaps a mile. It is now in possession of a Mir. McDorman. He has a table made from the walnut boards that were used in the walls of the parlor of the old home.

Erasmus and Mary were true pioneers, industricus, (a coverlet of true Sellers weave, woven by Mary is in possession of my sister Mary Rife Collins, shows the handiwork of Mary and her daughters.) They were religious and of high character. Their descendants have maintained these traditions and many of them have held positions of honor and trust.

Erasmus' and Mary's graves are in the Bloxom Cemetery, and abandoned cemetery, one mile west of Selma. Their descendents should take early action to preserve these graves.

The graves are marked by large marble slabs, with these inscriptions:

COPY OF THE WILL OF ERASMUS JONES GREENE COUNTY, OHIO

Proceeding in probate before the honorable John Probasco, Daniel Martin, John Fudge and William Mills, Esquires, also circuit Judges of the Court of Common Pleas within and for the county of Greene in the State of Ohio on the minth of April in the year of our Lord 1850.

The State of Ohio, Greene County. Be it remembered that heretofore to wit on the day and year of the aforesaid the last will and testament of Erasmus Jones late of Greene County, deceased, was brought before the court for probate and was duly proven by the oaths of John Holmes and Joseph A. Houston, subscribing witnesses thereto, whose examinations at the time of executing the will was of sound mind and memory, over twenty-one years of age, acting freely and voluntarily and without restraint, it is ordered that said will and the proof so reduced to writing be recorded, which is done accordingly as follows: to wit:

In the name of the Benevolent Father of All I. Erasmus Jones of the County of Greene and State of Chio, considering the uncertainty of this mortal life, being weak in body but of sound mind and memory, blessed be God for the same, do make and publish, this, my last will and testament.

First, I will that all my just debts be paid within six (6) months after my decease. Second, I will that Mary, my dear wife during her natural life remain in quiet possession of the house and lot now occupied, with a yearly income of \$150.00 to be paid half yearly. To my sons George Washington and Erasmus Jackson, original purchasers of my real estate, with the privileges of firewood and timber to keep up the fences (the firewood shall be good hickory timber if required) and after her demise I will that my youngest child Keturah Ann, should she remain unmarried, over her equal share with the rest of the children, \$300,00 to be paid her as the law directs. I will also that all my effects be disposed of according to law and equally divided amongst my surviving children or their heirs as follows: Sarah, Rebecca, Rachel, Jonathan, Mary, Elizabeth, Matilda, Hannah Ann, George Washington, Erasmus Jackson, and Keturah Ann and in case of any of my children dying without lawful issue, to be divided equally amongst the survivors, the share of my daughter, Mary, deceased, to be divided amongst her three children as follows: Jones, Lewis Erasmus, one half of the whole and James Washington Jones the other half, lastly I do hereby nominate and appoint George Washington Jones, and Erasmus Jackson Jones, executors of this my last will and testament hereby revoking all former wills made by me, in witness whereof I have here* unto set my hand and seal this 8th day of February 1848.

ERASMUS JACKSON JONES, M.D. Tenth child of Erasmus and Mary Sellers Jones. Born near Selma, Ohio, 1816 or 1817, (the date uncertain, his death nor birth being recorded in George Washington Jones family Bible, as he was still living when "Uncle Wash" died.)

Married (1) Susan McCafferty in 1836. Susan died ___ 1839 and is burin the Bloxom Cemetery in the adjoining lot to Erasmus and Mary Jones. Beside her grave are the graves of their twin babies; Erasmus and Susanah.

Married (2) Elizabeth Bullard, of Xenia, Ohio. Six children were living in 1884; Theo. C., Mary J. Sovereign, Laura Terry, Joseph A., Schuyler C. and Willie.

An excerpt from Porter and Lake Counties, by Goodspeed and Blanchard, 1884, published by F.A.Battey and Co., Chicago. p. 301. Furnished by the Librarian, of Indiana State Library, and sent through Rev. J. Merle Rife, Ph. D. is as follows--

"Dr. Erasmus J. Jones, physician at New Porter, was born in 1814 (?) in Ohio; he is one of twelve children born to Erasmus and Mary Sellars Jones, both natives of Virginia.

The elder Jones was one of the first settlers of Chillicothe, Ohio, in 1778. (1798) Dr. Jones' mother was well educated, and as there were few or no educational facilities in those days, she educated her son to nearly all he received, but, as the Doctor is a self-made man, he early became interested in the study of medicine before he had the least idea of making it a profession, and did so only because he was urged to.

The Doctor lived, married, studied and practiced medicine in the house in which he was born, until 1846; he had studied and reported progress to a physician near, but as M.D.'s were "few and far between" and it was a sickly season, he was pressed into practice when sixteen years old. In 1840 he went to Philadelphia and attended the Jefferson Medical College. In 1848 he went into partnership with his brother—in—law, Dr. J.G.Kyle, an excellent physician in South-Western Ohio, but, on account of his wife's health, he concluded to go West in 1851, and procured a "four-horse" team and driver and started, intending to go to Iowa. Upon arriving in Porter County, his family took sick, which caused him to stop, and, on account of inducement offered by the people of Grosset settlement, he located there, intending to stay but a short time, but remained until 1859.

In 1859 he was elected County Clerk, and lived in Valparaiso for two terms. He then removed to Chesterton, where he resumed practice, and was in the drug business until 1881; then came to New Porter, where he still resides and practices. (1884) His robust constitution enables him to do more than the share of one physician.

He was elected Justice of the Peace before he was twenty one, and had to wait tillof age for his commission. Dr. Jones has always been a strong Abolitionist and a Republican. He was married, in 1836 to Susan McCafferty, a native of Ohio. She died in 1839. In 1846 he married Elizabeth Bullard, a native of Xenia, Ohio. The Doctor has six children, living; Laura Terry, Theo. C., Mary J. Sovereign, Joseph A., and Willie."

Keturah Ann Jones, b. 10, 9, 1821; d. , , 1907

"Aunt Keturah" was an invalid most of her life, for many years bedfast; later her eye-sight and hearing became greatly impaired. Yet her mind was as clear and sharp as any one enjoying perfect health. To many of us, who thought we could escape detection in some escapade, it seemed that her hearing and eye-sight must be more than perfect.

The last years of her life were spent in the home of her niece, Aunt Margaret Ann McCullough in Clifton, Ohio, though she had lived several years in the home of her nephew Uncle Jonathan Sellers Kitchen, Springfield, Ohio.

If the writer had had the forsight to have preserved a record of the many incidents she narrated concerning her parents, we would have many facts of vital interest now lost.

Keturah Ann is buried in the Pleasant Grove Cemetery, near the grave of her sister, Martha Matilda Kitchen.

His grave is beside his father's in the Bloxom Cemetery, near Selma, Ohio. Benjamin and Keturah were twins.

ERASMUS.

The name, Erasmus, seems to have come to the Thomas and Jones families through Erasmus Kelly, son of John Kelly. John Kelly was a coworker with Rev. William Thomas, and donated land for a church, the third of the Montgomery Baptist circuit. There were many Erasmus Kellys for several generations, in Bucks County.

There was an Erasmus Thomas, a son of Ephriam Thomas, Jr., grandson of Ephriam Thomas, and great grand son of Rev. William Thomas, and also of John Kelly, also third cousin of Erasmus Jones. This Erasmus Thomas had seven sons, one named Erasmus. He with his family left New Britain, Bucks County, in 1838 and with his family settled in the State of Indiana, on the banks of the Wabash.

CONCLUSION

In concluding this absorbing study of our ancestors, pioneers for two centuries in America, we feel that our reactions are expressed in the words of "The Sweet Singer of Israel" in Psalms 27 and 103:

"Wait on the Lord, and keep His way; and He shall exalt thee to inherit the land --."
