## APPENDIX A.

### THE FAMILY OF TERRY OF THE MANOR OF CRONDAL.\*

---

THE FAMILY OF TERRY has been for a long time established in the Manor of Crondal in the northern part of Hampshire. From a bundle of Court Rolls of the Manor of Crondal, now deposited in the Public Record Office in Chancery Lane, London, I find, October 1426, the name of John Terry, 16 October 1431, John Terry, 20 May 1432, John Terry, 7 May 1487, Thomas Terry, 3 April 1494, Thomas Terry, 22 October 1510, Robert Terry, Thomas Terry, John Terry, 29 April 1511, John Terry, 10 October 1516, Robert Terry, Thomas Terry, John Terry, 21 April 1517, Richard Terry, 4 October 1529, Thomas Terry, Richard Terry. The account rolls for the Manor of Crondal with the Dean and Chapter of Winchester from 1529 to 1538 inclusive, are signed Richard Terry bailiff, and in a valuation of the Manor of Crondal made in 1541, I find the fee of Richard Terry, bailiff, marked at forty shillings.

In the Crondal Customary dated 10 October 1567, I find our Stephen Terry in possession of lands that came to him from this Richard Terry, but at the same date, I find him holding lands that came to him from William Terry, but it is quite impossible to tell the degree of relationship existing between them.

From this time I have however fixed and certain dates, the will of Robert Terry of Long Sutton in the Manor of Crondal, dated 19 February 1576/7 and proved 18 April 1577,

at Winchester, appoints "my brother Stephen Terry of Long Sutton one of my Overseers". The will of Stephen Terry of Long Sutton dated 1<sup>st</sup> November 1606, and proved 24 January 1606/7, appoints "my brother John Terry one of my Overseers". The will of John Terry, the brother of Stephen, was dated 1608, and all are filed at Winchester.

ROBERT TERRY of Long Sutton, Hants, *m.* Alice and had five children

- 1 Richard Terry the eldest was admitted at Winchester in 1581. scholar of New College Oxford 21 August 1588. Fellow of New College 21 August 1590. Resigned his fellowship in 1605. Was Rector of Saham-Toney Watton, Norfolk, and *d.* 1625.
- 2 Stephen Terry *m.* Johana Cooper, dau. of John Cooper, and *d.* at Aldershot 1598. Will dated 1<sup>st</sup> February 1597/8. Proved May 1598.
- 3 Robert Terry of Long Sutton, will dated 1624. Of this will his cousin Thomas was witness.
- 4 Elizabeth Terry.
- 5 Joane Terry.

STEPHEN TERRY of Long Sutton, Hants, Manor of Crondal. Will dated 1<sup>st</sup> November 1606, inventory taken 10 December 1606, will proved 24 January 1606/7. He married prior to 1555 and had five children. His wife died before her husband.

Issue—

- 1 John Terry the elder, *b.* 1555, see suite.
- 2 John Terry the younger, living in London in 1634, Aldersgate Ward, sometime Sheriff of London. *m.* Elizabeth Gale, dau. of William Gale of London, and had two sons William Terry and John Terry. See the Heralds Visitation of London 1634. Harleian Society.
- 3 James Terry, living in London. 1625 mentioned in will of his brother John the elder, was a pewterer. Had a son James, mentioned in will of Stephen Terry, also two daughters, Elizabeth Terry and Susan Terry, both mentioned in will of their grandmother Elizabeth Peacocke, widow, of London, dated 27 July 1620, proved 17 March 1622. He *m.* Ann Peacocke, dau. of the above Elizabeth (see N. E. Gen. Register January 1899, page 17).
- 4 Roger Terry died prior to his father. Left two daughters, Ann Terry and Amy Terry, mentioned in will of Stephen Terry, 1606.

- 5 Thomas Terry, was residuary legatee and executor of the will of his father Stephen Terry, was witness to the will of his cousin Robert Terry in 1624, was living in Long Sutton in 1625, when he is mentioned in will of his eldest brother, John Terry the elder. In a Lay Subsidy granted to the King by the Parliament which met at Westminster 16 January 1620/1, there were only five persons in the whole Hundred of Crondal, who paid a larger tax than Thomas Terry of Long-Sutton.

JOHN TERRY the elder\*, *Familiâ eminenter ingenuâ*, b. 1555, at Long Sutton, Hants, in the Manor of Crondal; the eldest child of his father Stephen Terry. He was admitted to Winchester College in 1572, he succeeded to a scholarship in New College Oxford 10 March 1574/5 and at the end of two years was admitted a fellow of New. He resigned his fellowship in 1590 in consequence of his presentation to Stockton in Wiltshire. He was ordained by John Pierce, Bishop of Sarum and soon after became domestic chaplain to Thomas Cooper, Bishop of Winchester, who presented him to the Rectory of Stockton.

He published in 1600 a work with the title "The Trial of Truth" which was dedicated to Henry Lord Bishop of Sarum. He published in 1602 the second part of "The Trial of Truth", dedicated to Dr. Rives, Warden of New College Oxford. The above works can now be found in the library of the British Museum. He also published in 1617 a sermon with the title "The Reasonableness of wise and holy truth; and the absurditie of foolish and wicked Errour" and dedicated to the Right Rev. Father in God, Arthur Lord Bishop of Bath and Wells; Warden of New College Oxford. I now have a copy of this sermon belonging to me. He died on 10 May 1625 of an atrophy, and was buried, by his own request, among the poor in the churchyard of Stockton "as neere the parsonage house as it may conveniently be". The funeral service was read by Thomas Crockford, vicar of Fisherton de la mere, and a sermon

was preached by John Antraw, minister of Langford Little. Die veneris 13 May 1625. By his will he gives to the Church Wardens of Long Sutton, where he was born, to them and their successors forever, "one annuitie or yearly rent of twenty six shillings eight pence," "for the poor of Long Sutton, which is due unto me out of a certayne house lyinge in Alton." He also gives to "the Church Wardens of Stockton and their successors forever" certain sums of money, the income of which shall be paid forever to the parish Clerk of Stockton to encourage him to teach the children of the said parish the points of Catechisme established by Authoritie in this kingdom. "Item I gyve unto my brother in law John Whyte, Rector of Dorchester, my two gownds, and to my brother in law Stephen Whyte of Stanton in the County of Oxford gentleman, my best cloake, which two (John and Stephen Whyte) I do by these presents make and constitute the Overseers of this my last will and testament." His will was dated 25 April 1625. The oldest monument in the Chancel of the Church in Stockton is over the Chancel-door on the north wall. It is a mural tablet of black marble enclosed in an alabaster border, with this inscription:

If men should be silent this stone shall  
 speake the due prayes of God's Gra  
 -ces in John Terry lately a faythful payn  
 -ful vigilant and fruitful minister of God's  
 truth in this Church of Stockton. He  
 was borne of substantial and religious-  
 parentage at Long Sutton in Hampshire  
 bredde a well deserving membre of Newe  
 Colledg in Oxford, freely presented to  
 this charge by the R<sup>t</sup> R<sup>d</sup> Bp of Winton Cos  
 -per Ano Dom. MDXC and now in his ripe  
 age of LXX. A. D. MDCXXV. May XXX, slee  
 -peth happily in the publique cæmeterie  
 of this Church, till the last Trumpet  
 shall awake him to a joyfull  
 ressurection in Christ.  
 "He lived, he learned, he wrot, he taught,  
 Well, much, truly, duly, he broughte  
 Hoame the lost sheep w<sup>ch</sup> Christs bloud bought,  
 Against Hell's power he stoutly fought."  
 Terræ terra datur, cœlum sed spirit' ornat  
 Mundus habet famam, lusa Gehenna fremit.



John Terry *m.* about 1590 Mary White, dau. of John White of Stanton St-John Oxford, and sister of the Reverend John White, rector of Dorchester, "the Patriarch of Dorchester." Six sons were born of this marriage who all, except the eldest, survived the father. They are entered in the parish registers of Stockton as follows

- 1 Stephanus Terry, bapt. 20 August 1592, *d.* in Oxford 28 July 1608. Mentioned in will of his grandfather Stephen Terry 1606.
- 2 John Terry, bapt. 1<sup>st</sup> November 1593.
- 3 Samuel Terry, bapt. 6 July 1595.
- 4 John Terry, bapt. 25 May 1597. In his father's will he is called Josiah.
- 5 Nathaniel Terry, bapt. 11 November 1599.
- 6 Stephanus Terry, *b.* 25 August, bapt. 31 August 1608.\*

MARY (WHITE) TERRY, wife of John Terry, was the eldest child of her father John White of Stanton St-John, Oxford, who was the nephew of Thomas White, chancellor of Sarum, who *d.* 11 June 1588.

John White was probably the son of Robert White, brother of Thomas.

Mary White was born about 1570, and must have been some 55 years old at the death of her husband. In the will of John Terry, dated 25 April 1625 and proved 5 July 1625, she is made the residuary legatee and sole executrix. In the will of her father John White, dated 30 Sept. 1616, and proved 26 September 1618, I find a gift to her of twenty pounds. In the will of her brother John White of Dorchester, dated 29 March 1648 and proved 14 June 1649, I find a gift to his sister Mary White of twenty shillings, but this may have been his sister in law, Mary White, the widow of his eldest brother, Josias White, who died in 1623. I find no other record of Mary (White) Terry.

STEPHEN TERRY, born at Stockton, Wiltshire, 25 August, baptized 31 August 1608, was the youngest child of John Terry. At the death of his father, 10 May 1625, he was less than 17 years old. His uncle and guardian, John White of Dorchester, was at that time busy with his plans for the settlement of New England. The family were puritan to the very bone. Small wonder then that we find in 1630 Stephen Terry, a boy of 22, at Dorchester Mass. He was admitted freeman, 18 May 1631. Here he married, but I have found no record of his marriage. He went with the Conn migration to Windsor Conn. I find him in 1663 in Hadley with his wife and his two daughters, Elizabeth and Abigail. His dau. Mary was already married to Richard Goodman. His son John Terry never removed to Hadley but settled in Windsor. Mr. Stephen Terry was one of the Selectmen of Hadley in 1667. Judd, in his Hist. Hadley, writes that his wife died in June 1647, if so, he must have married again. He died aged 60. His will which is on file at Northampton, was dated 19 September 1668. The inventory was dated 22 September 1668. There is no date of Probate. In the Probate the Court describes him as *Mr.* Stephen Terry, a prefix not so common then as now. The witnesses to the will were Henry Clark and Andrew Bacon. "I give unto my dear and beloved Wife my house, and barns, and orchard, and all my lands in Hadley while she lives, and all the household stuffs." His widow, Elizabeth Terry, survived him nearly 15 years and *d.* 11 August 1683.

#### ISSUE—

- 1 Mary Terry, *b.* 31 December 1635, *m.* 8 December 1659 Richard Goodman, and *d.* in Deerfield in 1692 while on a visit at the house of Jacob Warner who married her daughter Elizabeth. Richard Goodman, deacon, was in Cambridge in 1632. Hartford 1634, one of the signers of the Agreement, dated Hartford 18 April 1659, one of the first settlers of Hadley, one of the Selectmen in 1662, and 1673. He was killed by the Indians at Hockanum and buried 3 April 1676, aged 67. He had eight children and a few years ago his descendants were still living in Hadley.
- 2 John Terry, *b.* 6 March 1638, *m.* 27 November 1662 Elizabeth Wardsworth and resided in Windsor, Ct.
- 3 Elizabeth Terry, baptized 9 January 1641, *m.* 10 January 1666 Philip Russell and was slain by the Indians 19 September 1677

in Hatfield. She had four children two of whom were slain by the Indians. Philip Russel *d.* 19 May 1603. He was the son of John Russell and the brother of Rev. John Russell, the first minister of Hadley.

- 4 Abigail Terry, baptized 27 September 1646. *m.* 9 May 1667 Joseph Kellogg of Hadley. His second wife. She had eleven children and survived her husband many years. The will of her husband Joseph Kellogg was dated 27 June 1707, and proved 10 February 1707/8. He probably died in January 1707/8. Her will is on file at Northampton, dated 29 May 1717, and was filed at the Probate Court Northampton 31 October 1726, but no date of Probate. Her two eldest sons, Stephen Kellogg and Nathaniel Kellogg are named executors. The three witnesses to her will were Samuel Partridge, Daniel Dwight, and Abel Roberts.

THE WHITE FAMILY\* from whom came Mary White, the wife of John Terry.

There were three brothers, Thomas, Robert and Richard, and one sister Edith.

- 1 Thomas White, *b.* 1514 at Leckford in Hants. was Warden of New College Oxford, Chancellor of Sarum, died 11 June 1588. buried in Salisbury Cathedral. Will dated 4 June 1588, proved 19 June 1588.
- 2 Robert White, mentioned in will of his brother Thomas White. The father of John White of Stanton St-John, of Alice and Avys.
- 3 Edith White, mentioned in the will of her brother Thomas White. Was married and had a son Harry.
- 4 Richard White of Ealing near to Southampton. Mentioned in will of his brother Thomas.

## II. Children of Robert White<sup>1</sup>

- 1 John White of Stanton St-John Oxford gentleman, probably the son of the above Robert. Will dated 30 September 1616, proved 26 September 1618. In it he mentions his children, his two

sisters, and gives a bequest to New College Oxford. He appoints his two sons in law, John Terry and Thomas Gardner, Overseers of this his last will, and gives them forty shillings each for their trouble.

- 2 Avys White *m.* 29 June 1573 Simon Perrot of Oxford gentleman. See Herald's visitation of Oxfordshire. She married secondly Sumers. She is mentioned in the will of her uncle Thomas White, and also in that of her brother John White of Stanton.
- 3 Alice White *m.* Cannon. She is mentioned in the will of her brother John White of Stanton St-John, Oxford.

### III. Children of John White of Stanton St-John, Oxford

- 1 Mary White, eldest child, *b.* about 1570, *m.* about 1590 John Terry, rector of Stockton in Wiltshire, was living in 1625. She had six sons. Her granddaughter Abigail Terry *m.* in 1607 Joseph Kellogg of Hadley. She is mentioned in the will of her father John White of Stanton, and also in the will of her husband John Terry, dated 25 April 1625, proved 5 July 1625.
- 2 Josias White, *b.* about 1573. He *m.* Mary——, was at New College Oxford in 1592, B. D. from New College in 1610, was a clergyman and *d.* in 1623. He is mentioned in will of his father John of Stanton.
- 3 John White, *b.* 1575. "The Patriarch of Dorchester." He *m.* Anne——He had four sons of whom the youngest Nathaniel was his executor. His will was dated 29 March 1648, proved 14 June 1649. He was a scholar of Winchester, fellow of New College Oxon 1595. He was one of the Overseers of the will of his brother in law John Terry of Stockton 1625. He was rector of Holy Trinity and St-Peter's Church Dorchester from 1606 to 1648. He was a leading Puritan Divine, a member of, and one of the Assessors of the Westminster Assembly of Divines in 1643. He had much to do with the early planting of New England and his name is still held in honour amongst the descendants of the Puritans in America. He died 21 July 1648, and was buried in the porch of St-Peter's Church in Dorchester.
- 4 Steven White of Stanton St-John, Oxford, gentleman. Residuary legatee under, and sole executor of the will of his father John of Stanton, 1618. Overseer, along with his brother John of Dorchester, of the will of his brother in law John Terry of Stockton, 1625.
- 5 Martha White *m.* Cooke, mentioned in will of her father John of Stanton, and perhaps *m.* secondly Moore, if so, is mentioned in will of her brother John White of Dorchester.
- 6 Elizabeth White *m.* Thomas Gardner. He was one of the Overseers, along with John Terry, of the will of her father John White of Stanton. Perhaps she *m.* secondly Allen, and if so, she is mentioned in the will of her brother John White of Dorchester.

### ARMS OF THE TERRY FAMILY.

From the Visitation of London in 1634 :

ERMINE, on a Pile Gules charged with a Lion's face jessant from a Fleur de Lys or.

### ARMS OF THE WHITE FAMILY.

From a Mural tablet in the Church of Stanton St-John, Oxford :

AZURE on a cross quarterly Ermine and or, between four falcons argent beaked of the third, a fret gules between as many lozenges of the field, Crest. Out of a ducal coronet per pale or and gules, a camel's head eared or, gorged with a chaplet of lilies also proper.

#### APPENDIX IV.— WOODBURY FAMILY.

---

There were two brothers of the name of WOODBURY who settled in New England. John Woodbury, the elder of the two, came over first about 1624 leaving his son Humphrey Woodbury in England. After some three years he returned to England where he remained about half a year, and again set sail for America, this time in company of his son Humphrey. They arrived in Salem Mass. about the month of June 1628. See the deposition of Humphrey Woodbury, son of John Woodbury, in the matter of the Mason Claim, 16 February 1680/1.

He had received a good education, was proficient in Mathematics, and was an excellent surveyor of lands. In the Mass. Records, under date 28 September 1630, we find John Woodbury was chosen Constable of Salem.

Salem Book of Grants 25 January 1635/6 shows a grant of 200 acres of lands to John Woodbury in what is now North Beverly.

The Parish Registers of Burlescombe in Devonshire, near the border of Somersetshire, show that on the 21 June 1596 John Woodbury was married to Joanna Humphrey, by Wyllyam Bestleigh, clerk. The vicar of Burlescombe informs me that the Registers of the Parish go back to about 1580 and that many entries of baptisms, marriages etc. of the Woodbury family are recorded therein. He married for his second wife, about 1635, Avis Derby, widow of John Derby of Marblehead. She survived her husband and died 14 February 1672. John Woodbury died 1641, leaving two sons and two daughters.

I WILLIAM WOODBURY the younger of the two brothers was born about 1589. The Parish Registers of South Petherthon in Somersetshire about 12 miles from Burlescombe, show the following entries :

29 January 1616/17 William Woodbury and Elizabeth Patch were married.

#### BAPTISMS—

9 April 1618, Nicholaus Filius Wilhelmi Woodbery.  
 7 May 1620, Wilhelmus Filius Wilhelmi Woodbery.  
 9 March 1622/3, Andreas Filius Gulielmi Woodbery.  
 The Registers of South Petherthon go back to 1574, but the vicar informs me that he has failed to find any other entries of the name of Woodbury, except the above, so that it seems possible that William may have strayed over from Burlescombe where the Woodbury family lived. The year in which he came over to New England with his family is unknown, but it was probably about 1630, as references are made to his lands soon after that date.

Stone's History of Beverly states that about 1630, William Woodbury had forty acres in Beverly. On 23 September 1670, William Woodbury and Elizabeth his wife conveyed "the dwelling house I now live in, and 14 acres of land in Beverly" to Nicholas Woodbury. He died in January 1676/7, ae. 88. His wife Elizabeth died 29 November 1676. His will was dated 5 June 1663 and was proved in June 1677. There were six children as follows

II NICHOLAS WOODBURY, born in South Pertherton in England, bapt. 9 April 1618, came with his father William from England, and *d.* in Beverly Mass. in May 1686, ae. 68. He was granted a ten acre lot in Salem, 15 October 1637. His will was dated 1<sup>st</sup> August 1685 and was proved in Suffolk Registry of Probate 19 May 1686. By his will he gave all of his property and estate in Great Yarmouth, Norfolk Co. England, to his wife Anna who must have brought it to him. He married in Charlestown Mass. prior to 1651 Anna Paulsgrave or Palsgrave, who survived him and *d.* his widow in Beverly 10 June 1701. ae. 75.

She was *b.* at North Yarmouth, England, baptized 29 October 1626, the dau. of Richard Paulsgrave who on 24 January 1625/6, *m.* Joan Harris at North Yarmouth. Richard Paulsgrave or Palsgrave *d.* 30 May 1630, and his widow Joane *m.* secondly Rev. John Youngs, a minister of St-Margherets Suffolk, who came to New England later than 1637, and *d.* in Southold L. I. in 1672. Anna Paulsgrave came over with her mother and stepfather.

There were nine children, names taken from Salem Records.

- 1 Abigail Woodbury, bapt. at Salem Mass. 10 December 1653, *d.* young.
- 2 Joane Woodbury, bapt. at Salem 10 December 1653, *m.* Samuel Plummer of Wenham.
- 3 Nicholas Woodbury, *b.* 1654, *d.* young.
- 4 Abigail Woodbury, *b.* September 1655, *d.* 28 January 1741/2, married 26 December 1671, Richard Ober. He was bapt. at Abbotsbury England in 1641, and *d.* in Beverly 6 March 1716.
- 5 Nicholas Woodbury, *b.* 22 November 1657, and *d.* in Barbadoes 13 October 1691. His will was dated 12 October 1691 and he left his lands and houses in Yarmouth England, to his only son William Woodbury. He *m.* 4 June 1684 Mary Eliott, and after his death she *m.* secondly Captain Kinsley Hall of Exeter N. H.
- 6 Joseph Woodbury, *b.* 20 September 1659, see suite.
- 7 Isaac Woodbury, *b.* 1661, baptized at Salem 20 November 1661, and *d.* October 1733. He *m.* Elizabeth Herrick.
- 8 Andrew Woodbury, baptized 1665, *m.* 1688 Emma Elliot and *d.* prior to June 1695. His widow Emma *m.* secondly 23 July 1702 the Reverend Thomas Blowers.



- 9 Benjamin Woodbury, baptized 26 April 1668 and *d.* prior to 27 November 1698. He *m.* 23 March 1694 Mary Woodbury, dau. of Isaac and Mary (Wilks) Woodbury (Isaac<sup>3</sup> Humphrey<sup>2</sup> John<sup>1</sup>). She *m.* secondly, 24 November 1708, Michael Farley of Ipswich, and *d.* 22 October 1712 ae. 38.

III JOSEPH WOODBURY, *b.* 20 September 1659, baptized at Salem 20 November 1665, at the same time as his brothers Isaac and Andrew. He *d.* 14 October 1714 at Manchester. His name appears on the list of residents in Manchester in 1684. He *m.* 19 December 1687 Elizabeth West, dau. of Thomas and Elizabeth West of Beverly. She was *b.* 26 September 1663. There were nine children all born in Manchester.

- 1 Sarah Woodbury, *b.* 27 August 1688.
- 2 Joseph Woodbury, *b.* 22 May 1690. He *m.* prior to 1716 Ruth——secondly 28 June 1723 Elizabeth Dolan.

Cooley's Company, term of service 20 Sept. to 24 Nov. 1756, and again we find his name on the Muster roll of Capt. Jacob Abbott's Company under date of 9 August 1757. He passed his old days in Leveritt at the house of his son John Woodbury, where he *d.* 15 July 1820 aged almost 93. He had nine children all born in Brookfield.

Upon the twenty seventh day of June one thousand seven Hundred and seven, in the sixth year of the reign of our Sovereign Lady Anne by the Grace of God of England Scotland France and Ireland Queen, Defender of the Faith, etc., I JOSEPH KELLOGG OF HADLEY, in the county of Hampshire, within the Province of the Massachusetts Bay in New England. I hope, having a suitable sense of the many infirmities the considerable old age that I have now come to hath exposed me to, all which giving me warning that I may shortly, when it pleases God to call, yield to Death and lay down this earthly tabernacle, being at present, through the great goodness of God, of sound mind and perfect memory, and accounting it my duty to set things in order with reference to that portion of estate God in His goodness hath given me, and therefore I do make this my last WILL and TESTAMENT as followeth: I commit myself, soul and body, into the hands of God, who made them, and my dear Redeemer the Lord Jesus Christ, who hath redeemed men, and in whom I trust and believe, will be my advocate with the Father at the great day of His appearing, and in and through His merits and satisfaction to obtain acceptation. My body, which I leave to my Executors for a christianly comely burial, in hopes of a blessed resurrection when soul and body shall, by the mighty power of God, be reunited and be with Him forever in that place of everlasting

I give and bequeath unto my loving son John Kellogg all that piece of land on which he now lives, it being bounded by the dividing fence east, on land of Samuel Partridge west, on an highway north, and on the river south, to be to him, with this Proviso, that either of his sons Joseph or Samuel, after his decease, shall enjoy it, to him that possesses it, to be to him and his heirs forever, but in case they both dye before either of them possess it, then to revert to my family from whence it came, the intent is only that land that lies within the town ditch. Also I give to my son, John Kellogg above named, four acres of my forty acre allotment lying at the Fort-River at the south end of the lot ; This, together with about ten pounds I have already given him, to be to him and his heirs forever. I give and bequeath to my son Martin Kellogg four acres of my forty acre allotment at the Fort River in Hadley next to that I have given to my son John abovesaid. Also, beside what I have given him already, which amounts to sixteen pounds, I give him twenty shillings in current country pay, all of which to be to him and his heirs forever.

I give and bequeath to my loving son Edward Kellogg, the full sum of five pounds in current country pay, which together with what I have already given him, which I esteem at sixteen pounds, to be to him and his heirs forever. I give and bequeath to my son Samuel Kellogg four acres of my forty acre allotment at Fort-River in Hadley next to that I have given to my son Martin Kellogg as above, which, together with five pounds I have already given him, to be to him and his heirs forever. I give and bequeath to my daughters Joanna Kellogg alias Smith, and Sarah Kellogg alias Ashley, together with what I have already given them. which I esteem to be

fifteen pounds a piece, I give them forty shillings a piece, to be paid them by my Executors in such pay and at such time as it can be made good to them out of my estate. I give and bequeath to my loving sons Stephen and Nathaniel Kellogg, considering that I had a considerable estate with their mother out of father Terry's estate, therefore I give to them all that allotment that was my father Terry's lying in Hockanum in Hadley, bounded by the land of John Smith north east, and the land of Thomas Hovey south west, abutting on the river both north and south, to be equally divided to them after my wife's decease, not to have the use or possession of said land till then, and then to be to them and their heirs forever, this, together with forty shillings a piece, I have already given them, I account a full portion for them. I give and bequeath to my loving daughters Elizabeth Kellogg alias Nash, Abigail Kellogg alias Smith, Prudence Kellogg alias Merrill, as an addition to what I have already given them, which I esteem at fifteen pounds a piece, forty shillings a piece in such pay and at such time as my Executors can make it good to them out of my estate. I give and bequeath to my loving sons Ebenezer Kellogg and Jonathan Kellogg my allotment in the Plain in the great meadow in Hadley bounded by land of Nathaniel White east and land of Timothy Eastman west, abutting on a highway south and on the adjacent furlong north, as also I give them ten acres of my forty acre allotment at Fort River next unto my son Samuel's gift there, both lots to be equally divided between them to be to them and their heirs forever, and also I give unto them eight pounds a piece in such time and in such pay out of my estate as my Executors hereafter named, can do it.

I give and bequeath to my loving son Nathaniel Kellogg four acres of my forty acre allotment at Fort River at the North east end of it joyning the land of Timothy Eastman, and to be to him and his heirs forever. I give and bequeath to my son Joseph Kellogg all that my allotment in the Plain on the east side of the Town in Hadley containing sixteen acres or thereabouts, as also I give him twenty five Pounds out of my

estate to be paid to him in good countrypay, to be paid as my Executors can and at such time as they can do it. And where as my son Joseph approving himself a loving son in his care and helpfullness to me in my weak condition, and to my wife, I recommend it to my wife to make such further additions out of the Houseing land or other estate I have reserved to her disposal as may be an encouragement and recompense to him for his care and trouble as aforesaid.

I give and bequeath to my dear and loving wife Abigail; who hath borne the burthen with me in all my long continued weakness and infirmities; my House and Homestead with my Barn and Houseing, Orchard, Garden, Yard situated in Hadley aforesaid, as also that allotment next to Samuel Smith's allotment as we go to the Fort Meadow in Hadley, with all other of my lands in Hadley or elsewhere not given in this my WILL otherwise, with all rights of outlands or commons or any land that may grow to be of right to me within the bounds of the township of Hadley or elsewhere, with all moveable goods or estate within doors or without in Hadley or elsewhere, to be for her comfortable livelyhood while she lives, she keeping the Houseing and Barns in good repair, as also I give her full liberty to remove the houses barns or fences as she shall judge best and most advantageous for her, and for them that my enjoy it after her decease. Also I give her full liberty and power, provided by good advice she see cause to make sale of said Houseing and Homestead, then to do it, provided always the said estate that she shall leave, either in the aforesaid houseing and land and moveable estate when she dye, it shall be by her disposed of amongst those children I had by her, and to them or any of them as she shall see meet to dispose it. I herby order and it is my WILL that as to those gifts I have given in this WILL in moveable goods to several of my children; if my moveable goods, chattles, credits will not reach to the payment of my debts funeral expenses and other charges and uses I may have for it while I yet live, and for so much reserve for my wifes necessity while she lives, that each legatee in proportion to their gifts the sum of them, shall all abate accordingly.

I ordaine constitute and appoint my dear loving wife Abigail Kellogg, and my loving friend Captain Samuel Partridge to be joynt Executors of this my last WILL and TESTAMENT adnulling and making void all former or other WILL or WILLS TESTAMENT or TESTAMENTS by me formerly or otherwise made. ## NOTE

NATHANIEL KELLOGG, *b.* in Hadley 8 October 1669, *d.* in Amherst 30 October 1750, made no Will and no record appears in the Probate Court of any settlement of his estate. The tax lists of Hadley show that he owned one of the largest estates in the Town. It seems probable that he divided his property amongst his children during his life.

IN THE NAME OF GOD AMEN this thirtieth day of March one thousand seven hundred and seventy I NATHANIEL KELLOGG OF HADLEY in the County of Hampshire in the Province of the Mass. Bay in New England. Gent, being advanced in years, yet of perfect mind and memory and knowing that it is appointed unto men once to die, do make and ordain this my last will and testament, that is to say, principally, and first of all, I recommend my Soul into the Hand of God who gave it; and my Body I commit to the dust to be decently interred by my Executors believing I shall receive the same again at the general resurrection by the mighty Power of God. And as to my wordly estate I give devise and dispose of the same in the following manner——

I give and bequeath to my beloved wife Elizabeth an honourable maintenance out of my estate so long as she shall, being my widow, continue and live with my children, but if she shall remove and live with her own children, or any where else from my children, then to have no further maintenance out of my estate, as by agreement.

Item. I give and bequeath to my son Daniel Kellogg

five shillings lawfull money together with what I have before given him, which I esteem to be his full part or share of my estate.

Item. I give and bequeath to my son Joel Kellogg five shillings lawfull money together with what I have before given him, which I esteem to be his full share or part of my estate.

Item. I give and bequeath to my son Abraham Kellogg five shillings lawfull money together with what he has before had given him by me, which I esteem his full share or part of my estate.

Item. I give and bequeath to my daughter Sarah Kellogg the sum of eighty pounds lawfull money to be paid in money or in personal estate, in her infirm and declining state to be dealt out to her at the direction of my said son Daniel Kellogg, and, so long as she shall remain single, I give her the use of the south lower room of my dwelling house on the south lot. Also my will is that, if she shall need more than the said sum of eighty pounds for a suitable maintenance she shall be well supported by my two sons Gardiner Kellogg and Moses Kellogg out of that part of my estate which I shall leave in their hands and if she shall not live to expend so much as the said sum of eighty pounds, the remainder thereof be to them my said sons Gardiner and Moses: they paying or sharing equally.

Item. I give and bequeath to my daughter Prudence wife of Josiah Parsons of Northampton, in addition to what she has already received of my estate, six pounds thirteen shillings and four pence lawfull money to be paid her, within five years of my decease, in money or in rough land, at the election of my executors.

Item. I give and bequeath to my daughter Phebe wife of Eleazar Nash of Granby, in addition to what she has already received of my estate, ten pounds lawfull money to be paid her within five years after my decease, in money or in rough land, at the election of my executors.

I give and bequeath the remainder of my estate real and personal to my two sons Gardiner Kellogg, and Moses Kellogg,

to be equally divided between them, or as they shall agree: to be to them their heirs and assigns forever, after my just debts and legacies are paid, provided nevertheless, my will is, that my Homestead be divided in the manner following viz. that the north lot be to the said Gardiner with the buildings thereon, and the south lot be to the said Moses with the buildings thereon, saving the Liberty of using one room in the house as bequeathed to my daughter Sarah, and the middle lot be so divided, as to make the north and south lots equal in value, when joined therewith.

And I make and ordain my said sons Daniel Kellogg, Gardiner Kellogg, and Moses Kellogg executors of this my last will and testament. IN THE NAME OF GOD AMEN, I MOSES KELLOGG OF HADLEY in the County of Hampshire and Commonwealth of Massachusetts Gentleman, being in usual health and of sound Memory and understanding but, considering the uncertainty of this transitory life, do make, publish and declare this my last will and testament in the manner and form following, viz:

First.— My soul I commit to God who gave it in hope of a glorious resurrection through the merits of a gracious Redeemer, and my body to the dust to be decently buried at the discretion of my Executors hereinafter named.

Secondly.— I give and bequeath to my affectionate wife Mary the use and improvement of one third part of my estate real and personal for and during the term of her natural life. I also give to her the said Mary the South room in my dwelling house to be for her own use and that of her disposal during her natural life.

Thirdly.— As I have heretofore given to my Son Whiting his full proportion or share of my Estate, I give and bequeath to him the sum of One Dollar only.

Fourthly.— To my Daughters, Molly and Electa I give and bequeath one half of my household furniture with the privilege of living in my North room as long as they shall continue unmarried. To each of my said Daughters I also

give and bequeath the sum of forty Dollars in addition to what each of them shall have acquired to herself at my decease by her own industry.

Fifthly.— To each of my Daughters Abigail Sheldon Belding wife of Elisha Belding, and Experience Smith, wife of Aristobulus Smith I give and bequeath (in addition to what I have heretofore given them) the sum of twenty Dollars.

Sixthly.— To my Son Samuel I give and bequeath one third part of my Home lot on which I now dwell, to be taken from the South side of the same, to have and to hold to him the said Samuel his heirs and assigns forever.

Seventhly.— To my Sons Moses and Samuel I give and bequeath as a compensation for the support of myself and my wife the sum of fifty Dollars per annum reckoning from the first day of January in the year of our Lord one thousand eight hundred and six to the time of my decease.

Eighthly.— To my Sons Moses and Samuel I give and bequeath two third parts of all the rest and residue of my estate both real and personal (after payment of my just debts and funeral charges) to have and to hold to them the said Moses and Samuel, their heirs and assigns forever in equal shares.

Ninthly.— The remaining one third part of the said residue of my estate, I dispose of as follows, viz — The said third part being divided unto nine equal parts. I give and bequeath four of the said nine parts to Horace Kellogg and Charles Austin Kellogg Sons of my son Benjamin Kellogg late of Hadley aforesaid deceased to have and to hold the said four parts to them the said Horace and Charles Austin their heirs and assigns forever in equal shares. And the remaining five of the said nine parts, I give and bequeath to the five Daughters of the said Benjamin, viz: — Marmy Warner the wife of Seth Warner of Sunderland, Amelia Kellogg, Elizabeth Kellogg, Martha Kellogg, and Angelina Kellogg to have and to hold the said five parts to them the said Marmy, Amelia, Elizabeth, Martha and Angelina their heirs and assigns forever in equal shares.
