

PREFACE

HE following pages do not aspire to be a history of the whole Kendall family, to write such would entail the tracing out and back the several families of the name who lived and flourished in Westmorland, Cumberland, Yorkshire, Hertfordshire, Derbyshire, Leicestershire, Warwickshire and Cornwall, until the original person of the name, doubtless some John or Thomas of Kentdale, and the common ancestor of these various families, was arrived at. This would be the work of a lifetime of an expert genealogist.

That which I have got together is merely a mass of detail concerning our direct forbears, collected by me as an amateur at long intervals during spare moments, and as such I present it to my children and relations for whom alone it is intended.

I was induced to search for facts of our past history by my father once telling me that his Aunt Lucy (Kendall) Lumb had said to him on her death bed: "Always remember, Henry, that you are a Kendall of Austrey," and also by the circumstance that my living relations seemed neither to know anything of, or care for the past history of their family.

Such research as I have made has proved extremely interesting as throwing a light on the lives of our ancestors.

Nichols' History of Leicestershire, a splendid and most voluminous County History, fortunately contains a great deal of the information I sought and the rest I found in the MSS. at the British Museum, the Library of the London Institution and at Somerset House, where the Ancient Wills proved a mine of wealth. To do the work properly I should search the Record Office and other sources, but I am now too old and lazy to undertake that. Perhaps some of those who come after may take an interest in such research, and do the work I have left undone and in a more workmanlike manner.

The facts I have given are all supported by documentary evidence, as quoted. The only liberty I have taken is the sketch of the two "Bosworth" Kendalls in Twycross Church window. The painted glass has long since been destroyed, only a few pieces of coloured glass remaining, but my sketch represents what Burton, the Antiquary, saw and described in 1622.

I have found some of the Harleian MSS., mostly pedigrees signed at Heralds visitations of Counties, to be incorrect, names misspelt, a date wrong, a generation left out, etc., but I have been able to correct one by another and have I believe got at the truth. In one instance three different authorities assign a grant of Arms to a man in 1485, when on indisputable evidence his grandson lived and signed a document in 1433! I am indebted to my friend George Cokayne, then Lancaster Herald, now Clarenceux King of Arms, for some help at the Heralds College, gratuitously given, and also for a copy of our pedigree signed by himself. Also to my cousin, Colonel Henry Graham, whose intimate knowledge of Heraldry and genealogy has been a great help, and to Mr. William Clement Kendall, of Kirby Lonsdale, who professionally a genealogist and Topographer, good enough to style himself my remote kinsman, has most kindly supplied information tending to show the connection of the Westmorland and Hertfordshire Kendalls with our Leicestershire, Derbyshire and Warwickshire families, pointing to the probability of a common descent from people who took their name originally from the town of Kendal.

THE KENDALLS

HE family of Kendall was, according to early authentic records 21.9. 1301.

dating from 1301, settled on the borders of the three Counties of
Leicestershire, Warwickshire and Derbyshire, where its members
held the Manors of Shepshed, Twycross, Snibston and Blaby in
Leicestershire, of Austrey in Warwickshire, and of Smithsby in Derbyshire.

Through alliances with the families of Shepey, Walcote, Walleis, 21.D. 1066. Comyn and Fitzherbert, their descent is traced from Hugo de Burdet and Herbert Fitzherbert, Norman Knights who came with William the Conqueror, and from Sieur de Quincey, another Norman Knight, as is shown hereafter.

Ancient documents demonstrate that there were Kendalls or Kendales in Westmorland as far back as the year 1243, and on the evidence of the Close Rolls Lincoln, the fact that there were Kendalls owning land in Leicestershire, disputing about lands at Kendal in Westmorland, makes it probable that the family took its name from that town.

That the name of our Leicestershire and Warwickshire family was originally spelt Kendale is proved by a document, extant, forming a title deed of the Manor of Aldestrie, dated 10th of Hen. VI. (1433), where it is so written.

The chief alliances of the family were with Fitzherbert of Twycross, Shepey of Smithsby, Alstre of Aldestre, Redishe of Redishe, Willenhall of Willenhall, Jennens of Westminster, Repington of Amington, Sacheverell of Radcliffe, Co. Notts., Armestrong of Rempston, Co. Notts., Noel of Kirby Mallory, Babington of Rothley Temple, Pickering of Belton, Savile of Blaby, Errick of Frisby-in-the-Wreke, Brooks of Haselover, Dyson of Inkberrow, Cotton of Haigh, Co. York, Irton of Irton, Co. Cumberland, Lumb of Silcoats, Co. York.

A.D. 1301

Of the Leicestershire Kendalls our earliest ancestor in direct male line was BARTHOLOMEW KENDALL, of Shepshed. All I have been able to ascertain about him is that he owned lands at Shepshed in 1301. Nichols, in his History of Leicestershire (Vol. III., fo. 1012), says:—"The "property which the Abbot and Convent of St. Mary de Pratis at Leicester "held in this lordship is thus entered in their Register 'Habemus in "Shepished ex domo fundatoris nostre et habemus vi. acras prati "'pro decima feni jacentis extra Borealem de Alyn forth inter prata "'Bartholomei Kendall ex utraque partem . . . " There is nothing to show that there was a manorial residence at Shepshed, but later, Thomas Kendall, son of the above, is described by Burton (MS. No. 253, pedigrees of Kendall and Fitzherbert) as "of Shepshed," which often indicates lordship of a manor or residential property.

A.D. 1345.

Of **THOMAS KENDALL**, of Shepshed, there is no information beyond the aforesaid reference to him in Burton's MS., dated 1345.

A contemporary of Bartholomew was William Kendall, who died in 1309, leaving a daughter and co-heiress married to Laurence Cotterell. He had held a moiety of the Manor of Darley, Co. Derby. Darley (the Derelei of Domesday) was according to Vincent (in his "Derbyshire" Roper's Pedigree) "parcel of the ancient demesne of the Crown. In the "reign of Edward the 1st, it was in moieties between the families of "Kendall and Darley who held under the Crown."

According to the same authority, Alice the other co-heiress of William Kendall, married William le Herberjour of Chaddesden and Darley became the inheritance of their co-heiress Margaret. It seems probable that this William Kendall was a brother or cousin of Bartholomew, but leaving no male heir the manor of Darley descended to other families.


Shepshed is written Schepeshved in Domesday, is ten miles from Leicester and marches with the parish of Gracedieu. Nichols (Vol. III. fo. 1012) says: "This lordship became very early the property of the Earls "of Leicester. Robert Bossu, Earl of Leicester, the founder of Leicester "Abbey, gave thereto the Church of Shepshed. From him the lordship "of Shepshed came by marriage to Roger de Quincy, Earl of Winchester. "Three daughters co-heiresses of Roger de Quincy married Ferrers, Zouch, "and Comyn made partition of this lordship.

"John Comyn, Earl of Buchan, gave the Nuns of Gracedieu 100 acres "of land in Whitwick and Shepshed (Esch. 34, Edw. I. No. 180.")

About THOMAS KENDALL of Shepshed and Twycross Co. Leices, the next in descent, there is more information.

By marriage with the heiress of Richard Fitzherbert of Twycross he he became possessed of that manor (Tuicros of Domesday).

A.D. 1400.

Richard Fitzherbert was a younger son of the house of Fitzherbert of Norbury, a very distinguished Leicestershire family. Of them Sir Bernard Burke in his History of the Commons of England (Vol. I) says: "The "family of Fitzherbert whose name appears in the Roll of Battle Abbey "descends from a Norman Knight named Herbert, one of the companions "of William the Conqueror, which name, in conformity with a prevalent "custom among the Normans of describing themselves as the son of some "eminent ancestor, became the patronymic of the family. In Latin Filius "Herberti, In Norman Fils or Fitz Herbert.

"From this family the Earls of Pembroke are said to have sprung. "In the year 1125 (25 Henry I.), William, Prior of Tutbury, by his Charter, "attested by Robert de Ferrers, Earl of Derby, the superior lord of "Tutbury, and his two sons, Robert and William de Ferrers, Hawise "his wife, the Bishop of Lichfield and others, granted to

Nichols, in his Hist. of Leicestershire (Vol. IV. fo. 860), says:—

"The heir general of Fitzherbert (of Twycross), was married to

"Kendall. The arms of Kendall are gules, a fesse chequée or and azure,

"between 3 eagles displayed or, and to both these families the following 21.50. 1474.

"deed of 1474 has reference, 'omnibus qui, &c., &c., Bartholomew Kendall

Nichols also says:—"Geoffery de Bewmes, Prior of Tutbury, and his "bretheren granted to Richard Fitzherbert and Pretiosa his wife a virgate 21.20. "of land at Twycross, &c., &c."



It appears from a Harleian MS. (No. 1439, fo. 27b and 28) in the British Museum, and from a Burton MS. (No. 253) in the College of Arms, copies of which I annex, being pedigrees of Fitzherbert and Kendall families, that Thomas Fitzherbert entailed the manor of Twycross on his brother Richard whose heiress Thomas Kendall married. It is a curious fact that Richard Fitzherbert bore a quite different Coat of Arms to his elder brother of Norbury, the latter being Argent a Chief vaire Or and Gules over all a bend sable, those of Richard of Twycross being, Party per fesse gules and ermine on a chief argent, a fleur de lys between two cross crosslets fichée sable. These last named were described by Wyrley, the Staffordshire Antiquary, as being, in 1596, quartered with Kendall, together with other arms showing the family alliances, in the windows of Smithsby Knowing they should be Fitzherbert he put a (?) to them. I consulted my cousin, Colonel Henry Graham, who is an expert genealogist, and he consulted several of the present Heralds, who all agreed that it was highly improbable that two brothers should bear quite different charges on their shields, being contrary to Heraldic rules. However, the event proved

that this instance was an exception. Colonel Graham, in Long Leat library, happened across a Deed quoted in Hollin's (large edition), of John Fitzherbert, father of the above-named Richard, appointing certain exors to his child and ward, bearing date 29, Edw. III., and attached to it his seal with the Arms in question. I have since found the same given in Nichols' History of Leicestershire (Vol. IV. fo. 850) as Fitzherbert of Twycross seal. Annexed is a copy of it.



In Twycross Church there was, in the time (1622) of William Burton, the Antiquary and Topographer of Leicestershire, a window to two great grandsons of Thomas Kendall. Says Burton:—

"In the South window of the Chapel of Twycross, Leicestershire, "is the picture of two men kneeling, the one having an arrow fixed in the "head, the other an arrow in the middle of the body under whom is "written: 'Orate pro animabus Thomæ et Ricardi Kendall,' The inhabitants "report that these two Kendalls were slain with arrows at Bosworth Field, "1485." Only a few pieces of coloured glass remained when I was there about five and twenty years ago, but I annex a fancy sketch of what Burton saw and described.

The battle field is three miles South of Market Bosworth, Twycross but a few miles distant, so that the Kendalls had not far to march to join

their Standard. A spring of water from which King Richard is said to have last partaken is protected and is called Richard's Well. On which side they fought there is nothing to show, but there was another Kendall who fought at Bosworth on King Richard's side, and who was the King's Secretary, namely John Kendall. I don't know if he was one of the family, but it is not unlikely he was a grandson of Thomas Kendall, and son of John Kendall, who died in the City of London and was buried in the Church of St. Mildred, Poultry, and who, by his will (of which I give a copy in the appendix) orders a payment "to the High Altar of the Parish Church of "Shepshed, where father and mother are buried." He being therefore a A.D. 1420. son of John Kendall of Shepshed, about 1420.

The following records of John Kendall, the King's Secretary, are interesting:—In a Wardrobe account for the Coronation of King Richard III., is included an order for clothing, etc., for retinue; amongst other items, "To the Treasurer and to John Kendall, Secretary unto our saide Souveraine Lord the Kynge, VI yerdes Scarlet Cloth to each."

Then he appears to have been in favour with the King, for in a Cal. of Patent Rolls, 1467—1477 (fo. 375), occurs the following:—

"20 July, 1461. Grant for life by the King by word of mouth, to "the King's servitor, John Kendall, esquire, of the office of Comptroller of "King's Works within Westminster Tower and elsewhere. With customary "fees." And again: "7 May, 1464. Grant for life to John Kendall of the "office of Ranger of the Forest of Dene, Gloucester. Receiving fees as in "time of Edw. III. from issues of the Co. of Gloucester, with all other "profits."

Thereafter he seems to have fallen into disgrace, but "10 May, 1474. "General pardon to John Kendall, late of Westminster, Notary, alias "Scrivener, alias Yoman, alias late of York, clerk, of all offences committed "before April 11th, last."

Finally, after King Richard's overthrow and death, his name is found in a list of those attainted and their lands confiscated by an "Act of attainder of notables supporting Richard III." of the 1st Parliament of Henry VII., his name occurring thus:—

"John Kendall, late secretarie to the said Richard, late Duke "(of Gloucester)." Another "Act of confiscations in favour of King Henry "VII.," includes "The Baronie Lordshippe and Mannor of Kendall and "Lordshippe of Weardale."

To return to **Twycross**. There is a fairly ancient Church Register. One entry is of the baptism of George, son of Henry Kendall, Esquire, and Frances, his wife, on 26 June, 1638, and is signed by the said Henry Kendall in the court hand of that time.

The manor remained in the possession of the Kendalls for seven generations, until George Kendall, who was born there and baptised as above mentioned, seems to have disposed of it to the Jennens family, from which descended the celebrated Sarah, Duchess of Marlborough, for it seems to have been in their possession in 1773, when Charles Jennens of Gopsall and Twycross, left these estates by will to Edward, Viscount Wentworth, and Sir Robert Burdet, Bart., in trust for Penn Assheton Curzon, ancestor of the present Lord Howe.

It is a curious coincidence that George Kendall, sixth in descent from Thomas, married a daughter of John Jennens of Westminster as his first wife.

H.D. 1462.

BARTHOLOMEW KENDALL, son of the above named Thomas, became possessed of the Manor of Smithsby, Co. Derby (Smidesbi of Domesday), by marriage with Margaret, daughter and heiress of John Shepey of Smythesbye.

Smithsby is situated just over the border from Leicestershire, and only a mile or two from Ashby-de-la-Zouch, and was the most important of the six manor estates held by Kendalls in those times. It is described by various authorities as follows:—


Lyssons in his Magna Britannia (fo. 245) says:-


"The manor of Smithsby, which, in the reign of Edward the "Confessor belonged to Earl Edwin, is described in the survey of Domesday "as the property of Nigel de Stafford, it afterwards belonged to the family "of Comin" (or Comyn, and later Cumming), "whose heiress married "Shepey. In the year 1330 it belonged to John Shepey, who, in answer to "a 'quo warranto,' stated that his ancestors had, from time immemorial, had "a park within their Manor there. The heiress of Shepey married Kendall. "It was purchased in 1660 by the ancestor of Sir Henry Crewe, Bart., the "present (1817) proprietor. Smithsby Hall, formerly the seat of the "Kendalls, is now a farm house. In the parish Church are some "monuments of the Kendall family, viz.: William Kendall, Esquire, d. 1500, "and Henry Kendall, Esquire, d. 1627."

The Topographer (part II., page 158) says:-

"In a book of Church Notes" (Burton's) "in the British Museum, "before quoted, we find the following of this place:—

"'Smithesbie is placed in the South East Skirts of Derbyshire, near "'unto Ashby old Parke whear ryseth the head of Meas broke which from "'foote to head makyth himself a limitarie judge betweene the two Counties "'of Derby and Leicester. This Smithesby is the Lordship of the family "'of Kendall.' So far says the manuscript. 'Tis true the Kendalls were an "ancient family of respectability and had a large stone mansion at this place

"close adjoining the Church, some of whose walls are still remaining and "the rest converted into a farm house. In the Church are these arms " (they are the same as described by Wyrley, as stated later on).

- J. C. Cox, in his "Notes on the Churches of Derbyshire" (1877), has the following:-
- "Smithsby. When Wyrley, the Staffordshire Antiquary, was here in "1596, he noted in the windows of the Church these arms to which we add "the names:-
 - "Argent 3 garbs gules (Comyn).
 - "Azure 6 martlets or (Appleby).
 - "Azure a cross or fretty gules (Shepey).
 - "Argent a chevron between 3 mullets sable (Birch).
 - "A quartered coat of Reresby and Darley impaling Dethick.
- "Gules a fesse chequy or and azure between 3 eagles displayed of the "second (Kendall) quartering argent a fesse gules, in chief a fleur de lys "between 2 cross crosslets fitchy sable on base 3 ermine spots (Fitzherbert "of Twycross).
- "The same quartered coat as the last impaling quarterly:— 2nd. On a cross five fleurs de lys (Walcot). 3rd. Comyn. "4th. A lion rampant (Walleis).
- "In 1710, four of these Coats remained, but in 1792, there were only "the Coats of Comyn and Shepey. There are now none left.
- "The Manor of Smithsby, at the Domesday survey, pertained to "Nigel de Stafford, shortly afterwards it was held by the family of Comyn. "William Shepey, circa 1300, married Alice, dau. and co-heiress of Sir John "Walcot by the heiress of Walleis. The issue of this marriage was a son, "John Shepey, whose son Edmond died without issue, and his sister Margaret Shepey became the wife of "Margaret became sole heiress. "Bartholomew Kendall of Twycross, circa 1480. Thomas Kendall of "Shepshed, grandfather of Bartholomew, had married Elizabeth, daughter "and heiress of Richard Fitzherbert of Twycross, and we suppose the "quartered coat as above came to Kendall thro' this match."

The conjunction of the Coats of Arms of Kendall and Darley above shown makes it probable that William de Kendall, who died seized, of the Manor of Darley, in 1309, was a progenitor of the Kendalls of Twycross and Smithsby.

"Wyrley also gives an imperfect copy of the following inscription Egerton MS.
"which was on an alabaster stone in the floor of the Chancel: 'Hic jacent 1093, 10. 986. 11. 1093, 10. 986. "'Willelmus obiit vii. die mensem junie Anno Domine MCCCCC.' "effigies of a man in armour with a dog at his feet, and of his wife, were "incised on the stone.

"This inscription is given in Bassano's notes (1710) in Nicholl's, "Leicester, Vol. IV., p. 985, also in the Topographer, and in Meynel's MSS. "notes taken about 1817, but we looked in vain for this stone which seems "to have quite disappeared. Bassano gives the date of the death as 27 May, "1500, and mentions that there were the small effigies of a boy and two "girls at the bottom of the slab."


In 1880, through the kind offices of Mr. Sale, the Vicar's Churchwarden, I found that the slab was in the Chancel as described by Wyrley, much worn by the feet of the choir, and in 1896, when the Church was restored, the Chancel floor being altered, this monument was built into the wall of the Chancel for its protection, as was also the monument of Dame Bakpuz (see Burton Chronicle, 28 May, 1896).

I. C. Cox, continues:—

"William Kendall, the son of Bartholomew, by the heiress of Shepey, "married Elizabeth, daughter and co-heiress of Henry Aldestrey, alias Their son William, of the monument just described, married "Anna, daughter of . . . Redische of Redische, Co. Lancaster. Their son "George, married the daughter and heiress of John Jennings (Jennens) of "Westminster, and Henry, the issue of that marriage, married the daughter "of Henry Sacheverell of Ratcliffe-on-Soar. To his son Henry there is "now (1877) a monument extant, on the North wall of the chancel, in "which he is represented kneeling facing his wife, with 9 sons (two in "shrouds) below him, and 7 daughters (one in a shroud) below their mother. "The inscription is as follows: 'Here lyeth the bodye of Henry Kendall, "'Esquire, who married Elizabeth, daughter to Gabriell Armestrong, of "'Remson in the Co. of Nottingham, Esquire, by whom he had issue "'9 sons and 7 daughters: Henry, Gabriell, William, George, Thomas. "'Stephen, John, Thomas and John; Elizabeth, Margaret, Jane, Dorothy, "'Elianor, Hannah and Abigail.' At the top of the monument (which is "sadly out of repair) are the Arms of Kendall, impaling Armstrong (gules "3 dexter arms vambraced argent, hands proper).

"Henry, the eldest of the sons, sold the Smithsby Manor estate in "1660 to the ancestors of Sir John Crewe, Bart., in whose hands they now "remain. Smithsby Hall, for so many generations the seat of the Kendalls, "adjoins the churchyard on the West side. It has now long been used as "a farm house.

"Against the West wall of the aisle is a large alabaster monument "which though much mutilated is of exceptional design and interest. It had "long been hid beneath the pews and was only brought to light of late "years. It consists of a slab 6ft. 9in. long and 28in. broad, and has "originally stood on an altar or raised tomb. Round the margin has been

"an inscription in Norman French of which some parts are still legible. "In the centre is the figure of a lady sculptured in slight relief. The head "and face are a good deal worn, but she wears a head dress with falling "lappets, has a long mantle over her shoulders, her hands clasped on her "breast, and two small dogs at her feet. On each side of her head is a "shield the dexter one is worn away but the sinister shield has the 3 garbs "of Comyn. To our great satisfaction we have been able, after no small "pains, to identify this interesting monument. Wyrley gives the following "inscription as then (1596) extant at Smithsby. '... de Bakpuz fuit "'jadis (?) dame de Smithesbie morute 1350 le tiers jour de marche.' That "part which can now be read is the Christian name 'Johan,' a portion of "the date, 'mil trois cents quarante dis,' and the usual supplication with "which these inscriptions ended, 'sct prie seignos p lui qe dieu de sa "'alme... mercy amen.'

"Joan, daughter of Comyn of Smithsby, as mentioned above, married "for her first husband William de Shepey, and after his death she married "Sir William Bakepuz. It is said that she died in 1347, but if we have "rightly read the above much defaced inscription it would seem that the "date is 1350."

Dame Joan de Bakepuz the original of this monument was therefore great grandmother of William Kendall of the other monument.

The following extracts are from Magna Britannia (fo. cix.) "Shepey "of Smithsby, a younger branch of the Shepeys of Shepey, in Leicestershire, "married the heiress of Comyn The heiress of Shepey of "Smithsby married Kendall before the year 1500."

From the same authority (fo. exxxiv.)

"Kendall of Smithsby. Five descents of this family who possessed "Smithsby by marriage with the heiress of Shepey are described in the "visitation of 1611." (Harleian MSS. No. 1093 fo. 98b and No. 1537 "fo. 71 and Egerton MS. No. 996 ff. 70b and 81.)

"The Smithsby Estate was sold in the reign of Charles I.

"The present (1817) representative of this family is John Kendall, "Esquire, of Thorpe Langton, in Leicestershire."

In 1894-5 the old Church was restored and was reopened with much ceremony in the latter year as is described in the Burton "Chronicle" of 28 May, 1896. I was present on that occasion having taken some interest in the restoration and subscribed a few pounds to the same.

Annexed is a picture of the old Hall at that date. It was built of stone and must have been standing for 400 years or more. It is very interesting as having been the principal home of the family for eight generations, for the monuments of our forbears in the Church and for the

fact that a tournament was held in old times either on the estate or on land between it and Ashby-de-la-Zouch, a fancy description of which Sir Walter Scott introduces into the story of "Ivanhoe" for which purpose he studied the lie of the land from the roof of Smithsby old Hall and it is said wrote some of the account there.

The property appears to have been sold by Henry the eldest of the 9 sons of Henry Kendall of the monument.

John Shepey, whose heiress Margaret brought the Smithsby estate to Bartholomew Kendall, was the scion of a very old Leicestershire family. He was descended from Wm. de Shepey (temp. 21 Rich. II.), who was descended through Joan daughter and heiress of Comyn, of Smithesbie, from Comin younger son of Alexr. Comin, Earl of Buchan, who was descended through Elizabeth, daughter and heiress of Saier de Quincey from Saier de Quincey a Norman Knight (temp. 1190)—(Nichols' Hist. of Leicestershire, Vol. III. pt. 1, fo. 66).—This pedigree is given in full later on.

WILLIAM KENDALL the son of Bartholomew and Margaret Shepey, married Elizabeth, daughter and one of three co-heiresses of Henry Alstre, or Aldestrey, of Aldestrey (now Austrey), Co. Warwick. In the partition of the properties of Henry Alstre, her portion was the Manor of Snibston and lands in Raunston and elsewhere.


The other two heiresses Margaret and Agnes were married to John Kendall, brother of William, and William Banwell respectively.

John Kendall got with his wife the Manor of Aldestrey and lands in Tamworth and elsewhere and will be treated of later. William Banwell got with his wife the Manor of Halford and lands in Twycross, Norton, Shepey and elsewhere.

Of **Snibston** (originally Snypestone) the manor which came to William Kendall, Nichols writes, "It was sometime belonging to the Priory "of Coventry and was held of the honor of Chester.... The manor "was, circa 1280, the property of Robert Halford and soon after that date "came to.... Aldestrey by marriage with the heiress of Halford and "after four descents to Henry Aldestrey whose daughter and co-heiress "Margaret married William Kendall."

It must therefore have been sold by William Kendall and repurchased by Henry Kendall of Smithsby, for Nichols continues (Vol. III., fo. 930) "after the suppression of Monasteries it came by purchase to the Kendalls "of Smithsby, Co. Derby, and by descent to Henry Kendall, gent.; who "was living in 1642 (Burton MS.). In 1654 Snibston was the inheritance "of Henry Kendall of Smythesbye, Co. Derby, Esquier, who beareth gules "a fesse Chequée or and azure between 3 eagles displayed or."

This Henry Kendall was apparently a loyal subject since, on the authority of a paper in the possession of Matth. Gregson, Esq., of Liverpool quoted by Robert Simpson in his "History and Antiquities of Derbyshire," pub. 1826, page 86, is the following: "In a list of subscriptions by the "Nobility and Gentry of Derbyshire to a fund to aid the Queen Elizabeth "to resist the Spanish invasion," his name occurs thus:—"Henrie Kendall "of Smythesbye, Gent: £25." A large sum in those days.

Burton continues:-

- "The arms in the Church were:-
- "Argent 3 garbs gules (Comyn).
- "Sable on a bend argent 3 garbs gules.
- "Gules a fesse chequée or and az. between 3 eagles displayed or "(Kendall).
 - "Or a chevron wavy argent between 3 Stags heads proper.
 - "Per chief gules, or chequée azure.
 - "Parti per pale gules and azure a lion rampant or impaling,
 - "Or a fesse gules between 3 helmets azure."

WILLIAM KENDALL of Smithsby, son of the last named 25.20. 1500. William, married Anne, daughter of . . . Redishe, Esq., of Redishe, Co. Lancaster. His younger brother Cristopher married . . . and had issue, John, who married Margaret, daughter of . . . Sadler, Esquire, of Castle Bromwich, and their son Humphrey married, 1st, Margaret, daughter of Agustin Swayfield of Braunston, Co. Rutland, and 2nd, Susannah, daughter of Leeson, Esq., of Sulgrave, Co. Northants, and relict of Savile, Esq., of Blaby, Leicester, and from her became possessed of that manor, A.D. 1619. It had belonged to the Abbey of Leicester. In April, 1539, according to Nichols (Vol. I., fo. 274), "The Abbot and Convent of Leicester "surrendered the valuables and large revenues of the Abbey to Cromwell "The original instrument for this purpose is signed by

- "John Bouchier, Abbot of Leicestere.
- "Richard Duckytt, Prior.
- "Richard Webbe, Sub-Prior.
- "Thomas Kendall.
- "Hugh Shepey," and others.

WILLIAM KENDALL of Smithsby, son of the above William, married

His son, GEORGE KENDALL of Smithsby, married 1st , daughter of John (or Bartholomew) Jennens of Westminster, and 2nd, Mary, daughter of Francis Repington of Amington, Co. Warwick.

His first wife... Jennens brought him a valuable property at 21.20. 1566. Westminster, for in his Will dated 27 September, 1566, of which a copy is

given in the Appendix, he disposes of "all my lands, tenements, and "hereditaments in the City of Westminster, Tothill, and in the parishe of "Sainte Martin in the felde."

His daughter, Margaret, married her cousin, Henry Kendall of Austrey thus uniting the Smithsby and Austrey branches.

M.D. 1592.

His son, **HENRY KENDALL** of Smithsby and Snibston, married Helen, daughter of Henry **SACHEVERELL** of Radcliffe, Co. Notts., of the same family as the celebrated Dr. Sacheverell.

H.D. 1588 to 1627. His son, HENRY KENDALL of Smithsby, married Elizabeth, daughter of Gabriel Armestrong of Rempston, Co. Notts., and is the original of the monument in Smithsby Church.

His daughter, Katharine, married Thomas BABINGTON of Rothley Temple. Of her there is a very fine portrait extant. Of its existence I was made aware by the courtesy of Sir John Harpur Crewe, Bart., the then owner of Smithsby, since deceased, and I went to Rothley Temple to see it with the permission of the then owner, Mr. Harry Parker, who is a descendant of the Babingtons, and had a copy made of it. Rothley Temple has since passed out of the possession of Mr. Parker, and the portrait was bought by the wife of Mr. J. S. Gilliat of Chorley Wood, herself a Babington.

It is interesting to note that in the Will of Katharine Babington's father, Henry Kendall, copy of which is in the Appendix, he leaves to her the jewels which had belonged to his wife, her mother, and in the portrait these jewels are seen about her person.

Quoting Nichols' (Vol. III., fo. 1139) "The following inscriptions for "the family of Sacheverell are from Dr. Pegge's MS. collection for "Derbyshire, 'within an iron rail against the N. wall of Morley Church. "'Here lyeth the bodye of Kateryn Babington, late wife of Thomas "Babington and daughter of Sir Henry Sacheverell, nyght, the which saide "Kateryn died XXVI. day of August, MCCCCXVII."

Apparently Katharine Kendall married her 3rd cousin, Thomas Babington.

Motts. Bisbop's MSS. Wysall, 1638.

Gabriel Armestrong, her grandsather, according to an entry in the Bishop's MSS., Notts., "was buried in our Chancel, 28 April, 1638."

A.D. 1611 to 1662. **HENRY KENDALL** of Smithsby, son of the last named Henry, married Frances, daughter of William Noel, Esq., of Kirby Mallory.

His son, **GEORGE KENDALL** of Smithsby, Twycross and Snibston, married Elizabeth, daughter of Thomas Pegge, Esq., of Yeldesley. He seems to have been the last of the family to hold the manors of Smithsby and Twycross.

The further descendants of the Smithsby Kendalls will be found in the detailed pedigree which follows.

Coming now to the Austrey Branch:-

JOHN KENDALL, second son of Bartholomew Kendall of Smithsby, married, as already stated, Margaret one of the three co-heiresses of Henry Alstre, and so became possessed of the Manor of Alstre or Aldestrey (now Austrey) together with other lands at Tamworth and elsewhere.

Austrey was the Aldulvelstrea of Domesday, and is situated near Atherstone, Co. Warwick, on high land from which five neighbouring Counties can be seen.

Robert Halford, Lord of Halford and Snibston circa A.D. 1280, left three daughters co-heiresses, Mary, married to Thos. Walron, Margery, married to . . . Aldestrey, and Isabel, married to Peter Chynell.

Aldestrey and Margery had issue Henry Aldestrey, who had issue William Aldestrey, who had issue Henry Aldestrey. His son Henry left three daughters co-heiresses, Agnes, married to William Banwell, Margaret, married to John Kendall, and Elizabeth, married to William Kendall of Smithsby.

There is extant a deed of partition of the properties of Henry Alstre among his three daughters, and forms one of the title deeds of the Manor of Austrey. It is entitled a "Tripartite Indenture," and is deposited with Messrs. Collyer-Bristowe & Co., 4, Bedford Row, London, as Solicitors of the present owner, Mrs. Angelina Gelinger Symons, only surviving daughter of the late squire Edward Kendall. It is dated toth of Hen. VI. (1433) and being a very interesting old document in Court hand, I had it photographed together with a later copy which is easier to read, and is shown opposite page 20. This Manor of Austrey has been held by Kendalls in direct male line from 1433 to the present time 466 years. At the death of the present owner it ceases to be the property of a Kendall.

It is a curious coincidence that it was the portion of one of three co-heiresses of Robert Halford, then the portion of one of three co-heiresses of Henry Alstre, and is finally the portion of one of the three co-heiresses of Edward Kendall.

Austrey Hall has entirely disappeared, a farm house has been built upon its foundations within the last hundred years or so. There is a fine old Church and there are altar tombs in it, but no inscriptions left to identify them. There is a register dating back to 1558. The present Vicar, the Rev. B. Hesketh Williams, was good enough to extract a number of the entries of births, marriages and deaths of our people from 1564 to 1716. These are interesting and some of them curious and they will be found in the Appendix. To John Kendall, above mentioned, were confirmed by Clarencieux, King of Arms, the Arms he was entitled to bear. The document is dated 22nd of August 21st of Hen. VI. (1448). The original

is in the Herald's College. On page 37 is a copy of it, also the full shield of Kendall of Austrey.

Edward Kendall of Austrey, the ninth in descent from John Kendall, the first Lord of this Manor, purchased Dan y Park, in the parish of Crickhowell, Co. Brecon, on the banks of the Usk, from the widow of Mr. Skrine, as he had founded, in conjunction with his brother Jonathan, Iron works at Beaufort, Parish of Llangattock, about A.D. 1780. A lease of all the mines and minerals in the parishes of Llangattock and Llanelly, had been obtained from the Duke of Beaufort, and smelting works were In 1798 some 250 men, says Jones in his History of Brecon (p. 490), were employed in the works. It is now a large industry employing thousands. The enterprising Edward left, by Will, his share of the property to his son Edward Kendall. His brother and partner Jonathan did likewise, so that the whole property should have come to Edward. however, married late in life and revoked the bequest to his nephew, leaving his share to his wife, Mercy. They had no issue and the property or part of it went to her family the Wests of Bath. With the above exception the Kendalls of Austrey appear not to have migrated, and the family generally down to the 18th Century to have lived, married and died mostly in their own Counties, exceptions being John Kendall, who migrated from Shepshed some time prior to 1468 to London, where he became a member of the Pewterers Company. A copy of his Will is given in the Appendix. Henry Kendall also, we find at Bloxham, Co. Oxford, prior to 1604, bearing the Arms of Kendall of Smithsby (Herald's College). He was probably a son of William Kendall, a younger son of George Kendall of Smithsby (b. 1527) by his second wife, Mary, daughter of Francis Repington of Amington. A copy of his widow's Will is given in the Appendix. (Harl. MS. No. 1476, fo. 191b, Visitation of London, 1633). George Kendall, younger brother of Henry Kendall of Austrey, had a property, Acklington Park, at Warkworth, Co. Northumberland.

From a Register of Sales of Bishop's lands, 1647-1651, we find on 21 March, 1648, the Manors of Thurgarton and Skyton, Co. Norfolk, purchased by James and John Kendall for £495 198. 5d., and the Manor of Aldingborne, Co. Sussex, purchased by William Kendall for £3,004 98. 10d. (Collectanea Topografica, &c., 1834, also the Will of William Kendall).

The following documents are cited to show the connection of the Kendales of Westmorland with the Capital town of Kendal and with the Kendalls of Leicestershire, although as far back as the 13th Century there is no actual evidence of their being of the same family.

Of these Kendales, John Kendale was Prior of Belvoir, A.D. 1228.

Sir Edmond de Kendale is mentioned in a Roll of Arms of Henry III., 28.29. 1243. as in Westmorland.

Hugh de Kendale admits owing 5 marks to Ilerius Bocard, "amount 28.20. 1275. "to be levied on his lands and chattels in County Leicester, in default of "payment." (Close Rolls Cal. 15, 3, 905 Lincoln).

Robert de Schepsheved (the Domesday name for **Shepshed**), County 21.276. Leicester, and others were imprisoned at Warwick for death of Thomas, son of Alan de Everton. (ibid.).

Hugh de Kendale mentioned as guardian of the Bishop of Norwich. (ibid.). 28.20. 1278. Hugh de Kendale ordered to give £100 to Queen Eleanor, and "fined 28.20. 1279. "£10 by the Sheriff of York for having been about some Jews' business," and as "receiver of goods of condemned Jews in various Counties." (ibid.).

Nicolas, son of William, son of Geoffery de Crook, by his attorney 28.20. 1282. offers himself against Adam, son of Robert de Kendale, in a dispute about lands at Helsington. Judgment to be taken. "Let the lands of the "aforesaid Adam in the hands of the King be taken to the value, &c., and "he to be summoned to be at Shrewsbury on the morrow of St. Martin." (De Baneo Rolls. Easter Term 10 Edw. I., Westmorland.)

William de Kendale. Order of Sheriff of Lancaster to deliver William 28.20. 1283. de Kendale, imprisoned at Lancaster for death of Matilda, daughter of Thomas de Bare. "The King understands William de Kendale is charged "out of malice and hatred and not because he is guilty thereof." (ibid.).

Kendalls of Hertfordshire.

Both these families bore quite different Coats of Arms from our Leicestershire and Warwickshire families, and there is nothing to prove relationship, but it is probable that all had their origin from the town of Kendal in Westmorland.

There is a very slight piece of evidence of a relationship between the Hertfordshire and Derbyshire families, in the fact that Sir Aston Cokayne, in some poems published in 1658, calls Henry Kendall of Smithsby, his "honoured Kinsman," the lines are as follows:—in the "Topographer" (Part I., 1791). "Topographical extracts from the poems of Sir Aston Cokayne, "printed 1658.

- "To my honoured Kinsman, Mr. Henry Kendall, the Younger
- "Your grandmother was hospitable, did
- "Invite me often to her house, and bid
- "Me hearty welcome, and I hope to prove
- "The like effects hereafter of your love
- "Poets of old were prophets held, and I
- "For once will venture in a prophecy
- "You shall at Smithsby flourish, gain the hearts
- "Of all your country, by your worthy parts."

Sir Aston's ancestor Reginald Cokayne of Bury Hatley, Co. Beds., was connected with the Hertfordshire Kendalls. He married Beatrix, daughter and heiress of John Waleys, she being a granddaughter of Sir Edward de Kendale, son of Sir Robert de Kendale, Lord of the Manor of Hicche (Hitchin) and of Titeberst (now called Kendalls), Co. Herts.

According to Mr. William Clement Kendall, Sir John Kendal, Knight of Rhodes, bore as Arms not only Ar. fretty gules, a chief azure, but also gu. a bend chequée or and az. which is very like the Coat of Kendall of Austrey, minus the Eagles. This Sir John Kendall was Prior of the Hospital of St. John of Jerusalem, Patron of the Vicarage of Standen in 1498. A market was granted to the same at Baldock by King Henry VII. in the 1st year of his reign. There is a handsome medal with his effigy in the British Museum. I have a copy of the same. The following notes are from Clutterbuck's History of Hertfordshire:—

Robert de Kendale received from King Edward I. a grant of a fair in his Manor of Hicche, and of free Warren in Mendesden, Madecroft, Titeberst (now Kendalls) Aspeden and Wakelee. The original grant is in the possession of Wm. Wilshere, Esq., of Hitchin, and is witnessed by the Primate, the Bishop of Winchester, the Earl of Pembroke, Humphrey de Bohun, Earl of Hereford and Essex and others.

"This Robert de Kendale was an eminent man in his day and in the "first year of King Edward III., holding then the office of Custos or "Warden of the Cinque Ports, had summons to attend the King at "Newcastle-on-Tyne, fitted with horse and arms to march against "Robert de Bruce, &c."

"In Hitchin Church is a slab on the floor with the inscription, "Here lieth Wm. Pulter, Esq., late of Hitchin, who died the 23 daye of "Maye, anno 1549, and ye third yeare of Edward ye sixte.' The stone "on which this inscription is inlaid is of more antient date, and has the "following inscription round the edge:—

"'ROBERT DE KENDALE GYST ICY PRES A DEV PVR "'LALME DE LUY KE IL LY PACE VER ... MERC "'... MEN."

In Hitchin Church North windows are three figures. Two of these consist of a Knight in armour and his lady, which, though now separate, appear to have formerly lain beside each other, probably on the cover stone of an altar tomb, and represent Sir Edward Kendale, Knight, lord of Hitchin, who died anno 47 Edward III., and his lady, who died two years afterwards. On the breast of the male figure are the Arms of Kendale, viz. Ar. a bend vert surmounted by a label of 3 points gules in a chief or, deeply carved.





Bequests to his wife, also to Robert Kendall, his son, and to Thos. & Jane Lacey, son-in-law and daughter and to Mr. Thos. Babington of Rothley as supervisor (This Thomas Babington married Katharine Kendall, daughter of Henry Kendall of Smithsby), entd. at Leicester by Wm. Clement Kendall.

Ancient document, being one of the title deeds of the Austrey Manor estate, late the property of Edward Kendall, Esquire, deceased, now of his daughter, Mrs. Jelinger Symons, and deposited with her solicitors Messrs. Collyer-Bristow & Co., 4, Bedford Row.

This 3ndenture Tripartite made between Wyllyam Banwell and Agnes his wyfe, JOHN KENDALE and Margarete hys wyfe and WYLLYAM KENDALE and Elizabeth hys wyfe of a particon to be made and hadde between the pties aboveseid of all those Maners, Landes and tentes which late were Henr: Alstre thelder and Edithe hys wyffe. And of all those Maners Londes and tentes rentes, rendcons and services with apptences called Cheynell Londes and Watson Londes late recowed wheche of right owe to dyscende unto the seid Agnes Margarete and Elizabeth as cosynnes and heires unto the seid Henr: and Edith, that is to say doughters unto Henr: Alstre the yonger Son and heir unto the seid Henr: the elder and Edith in maner and forme as hereaftyr appereth. Fyrste it is aggreed that the seid Wyllyam Banwell and Agnes hys wyffe shall have for their part the Maner of Halford with apptces called Halford Maner with allodyr londes and tentes in the same Towne beyng withyune the Countie of Warw:. A tente with apptences in Whateley with half the Grove called the Shawe which tente with apptences and Grove are now in the holdyng of Wyllyam Boteler with these parcelles called Poolyford Sukkyng and Blakepole beyng in the Paryshe of Hynnesbery in the same Countie. A mes: and a yerd londe and dv: with apptences in Twycrosse nowe in the holdynge of Robt. Fermor in the Countie of Leyces: ij partes of a Mes. with certain londes and tentes with apptences in Norton nowe in the holdyng of John Dyson and a Croste in Shepey now in the holdyng of Robt: Boseton Smyth in the same Countie of Leyces: To have and to holde unto the seid Wyllyam and Agnes and to the heires of hyr body lawfully begotyn, and for defaulte of such Issue to remayne unto the seid Margarete and Elizabeth and to the heires of their bodies lawfully begoten.

And for defaulte of such Issue to remaign to Agnes Johane and Elizabeth doughters unto the seid Henr: theldyr according to a Wille made by the seid Henr: Alstre theldyr. And the seid John Kendale and Margarete hys wyffe shall have for their part the Maner of Alstre with apptces called Alstre Maner with all Londes and tentes in the same Towne beyng in the Countie of Warw: all the Iondes and tentes in Tamworth in the same Countie and the reidcon of a house in Tamworth that Margaret Bayly moder unto the seid Agnes Margaret and Elizabeth hath for termes of her lyve and ij closes called the Bache and Saltwatyr for the which close called Saltwatyr the said John and Margarete and hyr heires muste pay and discharge the chefe rente of Bache Saltwatyr Soolyford Sukkyng and Blakepole. To have and to hold unto the said John and Margarete in maner and forme as is aboveseid. And the seid Wyllyam Kendale and Elizabeth his wyffe shall have for their part the Maner of Snypston with apptnces and all odyr londes and tentes with apptnces in the same towne in the Countie of Leyc: called Alstre londes Cheynel londes and Watson londes and all the londes and tentes with apptnces in Raunston in the seid Countie of Leyc: and after the disceasse of the said Bayly and John Watson to have and to holde unto the seid Wyllyam and Elizabeth in maner and forme as aboveseid. And it is agreed between the seid parties eithyr for to depart with odyr equally in money as it is at this day in every parte unto the tyme that all the seid Maners londes and tentes be wholy unto the seid partys discended. And also if it happyn any odyr londes odyr thenne these londes here named to discende unto the seid pties to remaigne to all. And if any cause of accon or troble happyn to fall for recording of any such londes or in defendyng of suche londes as they have nowe in possescon, to be borne and defendyd equally among them all.

In Witness whereof the pties aboveseid either unto odyr have put their Seales Yenyn the X° day of Maye the vere of the reigne of King Henr: the VII^{te} X^{te}.

Allso I give to my good lord the Erle of Huntingdon a Ringe of gold weying twoo gold angells asking him to be supervisor &c. Alexr. Barlowe, Ottwell Hollinshed, Thomas Reddish, Peter Eccarsall to be executors.

Thomas Widdowes, Robert Nicholas signed & seled in the presence of John Repington, William Parrie, Rich. Nicholas, Peter Bradshawe.

Codicil signed 27 Septr. 1566, granting to his wife the use of all his goods "within my house at "Smithsbee" until majority of his heir. Mr. Hollinshed enquired if he meant "she should have the "whole Corn and hey in the barnes and the saide George Kendall answered "no ffor his meaninge was but Implements within the house. Yet the same Mr. Hollingshedd demanded further whether she "should have the plate and he answered noo (sic) for that was a thing moast reddie for his exors. to "discharge his legacies withall," but she should have "fyve Keyne" besides legacies already bequeathed.

"This 3ndenture Made betweene the most excellente prince and our most dread soveraigne "ladye Elizabeth by the Grace of God Queene of England, ffrannce, and Ireland defendor of the fayth "&c. of th'one part, And Wilm. Skipwirth of the other ptie."

Appoints Willm. Skipwith guardian "of Henrye Kendall her highess ward, sonne & next heire "of Henrye Kendall esquire decd." In case of death before the age of 21, without issue, then to be guardian of the next heir and so on.

Costs of the wardship to be paid out of the rents of the "mannors messuages, lands houses & here"ditaments in the Counties of Derby and Leicester beinge in the hand and possession of our saide
"sovraigne Ladye by the mynoritye of the saide Henrye Kendall."

A Schedule to be made of all the "mannors landes &c. &c. whiche be now descended or hereafter "shall come & descende to the saide heire . . . with very best and uttermost value of them and every "of them by yeare."

An auditor or "other personne or personnes appointed or authorized by the Mr. and Councell of "the Court of Wards & Liveries" at the expense of the Estate.

The said Wm. Skipwith covenants "not only to bring up and intertayne the sayd Henry Kendall "and all his heire or heires male hereafter hapeninge to be the Queen's mag* wardes . . . in good erudcon vertuous and decent qualities as to the queen's honor" but also to well and truly manage the estates giving account of all happenings to the Court.

Any other properties or patronage coming to the heir to be notified to the Court.

"Provided and the saide Wm. Skipwith covenanteth . . . by these ptes that nether he nor his "assigns shall geve grannte comutte bargain or sell this said grannte or the Custodye of the said "Henry Kendall . . . unto any personne or personnes beinge nexte of kyn to the saide heire . . '
". . . shall within two monethes nexte after the deliverye of the bill of the grannte of the said "Wardship signed by the queen's m^{ty} to the clark of the said Court of wardes and liveryes prosecutte "forth her highness t^{res} patentes under the great Seale of England and after the sealinge thereof bringe "the same patente . . . to the Auditor g^{rall} of the saide Courte to be inrolled"

The said Wm. Skipwith or his assigns "shall once in every IVth yeare . . . when and as "soone as the same heir shalbe of the age of tenne yeares & more at such time as the tearme is kept, "bringe the saide heire to the Mr and Councell of the said Courte of Wardes & Liveryes and cause the "saide warde to remayne either in London or in some other place where the saide Mr and Councel "lyeth and presente and bringe the bodye of the saide Henry Kendall openly unto the saide Courte to "the saide Mr and Councell untill suche tyme as the saide heire be vewed and seene and also examined "and talked wthall in such sort that his manners educacon and profittinge in lerninge may be understanded "and perceaved uppon paine of forfeature of the saide Warde."

For possession of these two interesting documents, I am indebted to the Kindness of the Rev. Reginald H. C. Fitzherbert, Rector of Somersall, Herbert, Derbyshire, who knowing our remote forbears were related, and feeling that the docts. were of more interest to me than to him, generously made me a present of them.

Concerning Dean Swift.

John Kendall, vicar of Thornton in 1691, died 1747, he married Jane, daughter of Thomas Errick (or Heyrick), Vicar of Frisby in the Wreak. Abigail Errick, Dean Swift's mother, was also a daughter of this Thomas Errick, and was married in 1665 to Mr. Jonathan Swift. She was left a widow about 2 years after this with one child, a daughter, and again pregnant. About 7 months after the death of her husband she was delivered of a son whom she called Jonathan, in memory of his father, and who was afterwards the celebrated Dean of St. Patrick's During the remainder of her life she was treated with the utmost duty and affection by her son (Dean Swift), and sometimes visited him after his settlement at Laracor. A memorandum he made in May 1710, is as follows:—"On Wedy. "between 7 and 8 in the evening, May 10th, 1710, I recd. a letter in my chamber at Laracor "(Mr. Percival and Jo. Beaumont being by), giving an account that my dear mother, Mrs. Abigail "Swift, died the morning of Monday, 24 April, 1710, about ten o'clock, after a long sickness, being ill "all winter, and lame I have now lost my barrier between me and death. God grant I may "live to be as well prepared for it, as I confidently believe her to have been. If the way to Heaven "be through piety, truth, justice, and charity, she is there. Jon. Swift."

In Foster's life of Dean Swift, a letter of the Vicar, John Kendall, to his nephew Dean Swift and the reply of the latter are given. "'The people is a lying sort of beast,' says Swift, referring to "rumours of his getting into a marriage entanglement, 'and as to what Mr. Kendall said of his "'great prospects of making a fortune, it was a kindness that had only looked on the best side.'"

"Mr. John Kendall, a descendant of the ancient family of Kendall of Twycross, forming his own "estate, was born at Thornton, and is the son of Mr. Thomas Kendall of that place, who was the son "of the Revd. John Kendall (many years Vicar of Thornton), by Jane, daughter of Thos. Errick of "Frisby on the Wreke, who was niece to Dean Swift's mother Mr. John Kendall, another son "of the Vicar travelled into France, Germany and Holland, with the Earl of Clanricarde

"The present Mr. Kendall possessed the original letter to the Vicar of Thornton, which appears "in the Dean's works, but presented it to Mr. Lloyd the poet. He is the only surviving trustee of the "late Mr. Hanburys Charities, at Church Langton."

Concerning Crinoline.

The following curious story is from Chambers' Journal, 1 Sept., 1908. The subject of it, living in Derbyshire, might be the daughter of one of the Kendall's of the Smithsby line.

"It was customary to carry garlands at the funerals of maidens in bygone times, and hang them "over seats they used to occupy in the Church. At South Wingfield, near Alfreton, Derbyshire, remains "to this day an interesting example. It was carried at the funeral of Ann Kendall, who died of a "broken heart on 14 May, 1745. The Story of her death is very sad. She was killed by the heartless "conduct of her lover, but according to local tradition he did not long survive her death. The grave "had only closed over her for a short time, when, as he was riding on horseback past the churchyard, "the bells of the church commenced to toll and the unexpected sounds startled the horse so that it "stumbled throwing him to the ground, breaking his neck by the fall.

"The young lady used to dress in a fashionable manner, and always adopted the latest style, and "it is still related of her, that her hoops were so large that when she attended church she had to pass "through the door sideways. The families of the deceived and the deceiver have long been extinct in "the parish, but stories of her fall and her foibles of fashions, are still told in the old village.
