# DESCENDANTS OF JOHN KITZMILLER, OF LANCASTER COUNTY, PA.

The starting point for this genealogy was a remark which Rebecca Kitzmiller Bishop made to her daughter sometime before 1879, and which the daughter put into a letter in 1933: - that Rebecca and her sister were orphans, and that she and Jacob Bishop were married at Carlisle. Orphan's Court records of Cumberland County there gave the name of Rebecca's father as Jonathan, and the Zeamer file of records of that county (State Archives at Harrisburg) showed that Jonathan was born in the 1780s. So it was thought that he should appear in the 1790 census as a minor son in some Kitzmiller family - but that census showed no less than seven such families in Pennsylvania at that time, each of which included at least one son under 16.

Here the investigation got off on an interesting side track. Gettysburg in Adams County, just south of Carlisle, still has many Kitzmiller families, most of them descended from one Johannes who landed at Philadelphia in September 1728. His son and grandsons were mixed up in a shooting scrape with some Marylanders in 1751, and the earliest volumes of the Penna. Archives contain all the proceedings in the case. With the help of the York County Historical Society this family was thoroughly traced, resulting in quite a genealogy. Three of the seven Kitzmiller families on the first census were located in detail, but nowhere in this line was there a single Jonathan.

A second search of the Zeamer records was then made, and it appeared that Mrs. Catherine Kitzmiller died in 1832, at the age of 88, at the residence of Jonathan. And a second study of the Archives found another Johannes applying for land in Lancaster County in June 1728. So the search moved east across the Susquehanna River. Much miscellaneous data resulted, but it was not until the oldest records of Christ Lutheran Church (Tulpehocken) at Stouchsberg, now in private hands, were located that Jonathan and his mother Catherine showed up.

In the 1890s a gentleman by the name of W. H. Egle started the publication of la volumes of miscellaneous items of early Pennsylvania genealogy, without which data this genealogy would still be incomplete. His records were supplemented by county records at Harrisburg and Lancaster.

There still remained one gap - Jonathan's grandfather was missing. A time chart was then made, and unless there were some early members of the family who left no records at all the grandfather was John, a son of the Johannes who was there in 1728.

Most of the family records after 1740 center in what is now the southeast corner of Lebanon County, which was part of Lancaster County till 1785, then partly in Dauphin County till 1813. Christ Lutheran Church stands on an elevation near Tulpehocken Creek, between Myerstown and Stouchsberg. Other records are from churches only a few miles away. Bethel Twp. has as one boundary Swatara Creek, a few miles north of the Tulpehocken. Jackson Twp. adjoins Bethel on the southeast,; Schaefferstown is less than ten miles to the south. The family apparently had its baptisms, confirmations and weddings performed at whichever of the neighborhood churches had a pastor at the time.

That the present genealogy represents the whole picture fairly well seems to be proved by the fact that every Kitzmiller who was born before the Revolution and of whom any record has been found fits into place, and that the four families who appear in the 1790 census of Lancaster and Dauphin counties have been, with a few minor discrepancies, fully accounted for.

On June 28, 1728, a Johannes Kitzmiller, "late from Germany", applied for a grant of land on Little Conestoga Creek, which runs through Earl Twp., Lancaster County. (Pa.Arch. Ser. 2, XIX, 757) Thus he cannot be the Johannes Kitzmiller who arrived in Philadelphia on the "Mortonhouse" in August 1728, who was the first of the York County family. His second marriage is reported by Egle (1896, p.81) who lists him from Earl Twp. In 1736 he and his wife appear as sponsors at the baptism of his grandson John Jacob (3-8), at Christ Lutheran Church, Tulpehocken, (near Stouchsberg). Bethel Twp. where he died is a few miles north of this church. A John Kitzmiller died near there in February 1745, but this is believed to have been his son (2-2). He appears to have lived for some years in Lancaster County near or on his original grant, but in his latter years about 30 miles to the north. Egle (1900, p.198) states that he died before March 5, 1747, and lists his children as below, but there could be a question as to whether the Phillippina Christina listed as a daughter was a step-daughter by his second wife, his daughter-in-law, or possibly both.

JOHN KITZMILLER, JR. (2-2)

Egle (1896, p. 81) lists this marriage, and a few pages further on lists the marriage on August 4, 1745 of Phillippina Christiana Kitzmiller to Florian Buringer. The name is so unusual that both must refer to the same woman. "Early Pennsylvania Births" by Chas. A. Fisher, 1946, lists a gravestone inscription: "John Kitzmiller, b. 169, d. Feb. 26, 1745", as being in the Old Cemetery, Trinity (Tulpehocken) Reformed Church, near Millardsville, This corresponds well with the date of the widow's remarriage. The only other record of John comes from the confirmation records of his children, at Christ Lutheran Church, Tulpehocken. Three are listed as being his children, two are children of his brother Jacob, and for the other no father is named. In no case is the nother's name given. The Rev. John Casper Stoever, who married the parents, lists another child (Egle 1896 vol.). No record has been found of any other John Kitzmiller who was old enough to have been the father of the following:-

Maria Elizabeth b. about 1732, was 16-4 in Sept. 1748

John apparently lived in Earl Twp. at the time of his marriage, but later, like his father, moved north to the Tulpehocken district, where his children remained till at least 1760.

Could the two men listed on the previous page be one and the same?

Rev. Stoever recorded the marriages, eight months apart, of two John Kitzmillers, Sr. and Jr., to women of the same surname. John Sr., was in 1736 sponsor at the baptism of a grandson (3-3). Another John, (3-4) had children born in 1761 and 1766.

The confirmation records of Christ Lutheran Church, Tulpehocken, furnish the only evidence as to the children of John (2-2); in fact, those records and his marriage are the only positive records we have found that he ever existed. Egle lists the children of John (1-1), and four of the children in each of these records have the same name and are listed in the same order. All could have been born of either of the two marriages which Stoever performed.

Anna Margaret, daughter of (1-1), appears only in the Egle record, but she could have outlived her father, yet have died before reaching the age of confirmation. John Leonard (3-6) is listed by Stoever as having been born in 1745, the son of John, but he may have died young, as no further record of him has been found.

The heirs of John (1-1) in 1747 as given by Egle include Phillippina Christina, presumably the same woman who had married John (2-2) in 1731, and who remarried in August 1745. This evidence is the basis for the belief that, despite duplicate lists of children, there were two John Kitzmillers as here listed.

Granted this, there is still the possibility that the lists of children of the two men represent only one group, and that, except for sons John and John Jacob, there was no duplication. John, presumably (2-2), died Feb. 26, 1745, while Egle has the father of the children he names dying "before March 5, 1747". Where he obtained this information is not stated. While the naming of sons John and John Jacob in every generation seems to have been practically a standard Kitzmiller custom, the duplication in names of the daughters as well, and in the same order, certainly warrants speculation.

Orphan's Court records of Lancaster County confirm this, also that he owned 125 acres in Bethel Twp. at the time of his death. The marriage record is given in Egle (1896, p. 81) Jacob took title to 350 acres in Lancaster County in 1738 (PA-3-XXIV) There are three records of the birth dates of the children, which correspond fairly well, as some may be the dates of baptism, rather than birth. Trinity Lutheran at New Holland, Earl Twp., lists the seven oldest; Muddy Creek Reformed Church of Cocalico Twp., a few miles to the north, lists all nine; while Nev. Stoever lists them all as children of "Jacob Kitzmiller of Swatara" (Egle 1896, p. 54). Swatara Creek is a boundary of Bethel Twp. Confirmations of two children were recorded at Christ Lutheran, Tulpehocken, in 1748-9; the youngest listed in the New Holland record was born in 1744, so between these years Jacob and his family probably moved from Earl Twp. into Bethel. It is during these

The data as to his marriages comes solely from the baptismal records of the two children at Christ Lutheran, Tulpehocken.

The record of Jacob's confirmation lists no parents.

In April 1788 Jacob Kitzmiller, a tailor of Earl Twp. Lancaster County, borrowed 200 pounds from Philip Snyder (Deed Book HH)

In the 1790 census there was a Jacob Kitzmiller in Earl Twp., Lancaster County, with one son 16 or over, three under that age, and one female. From the list of known children there would be only one son missing to fit this listing, and it is possible there was another son born between 1773 and 1778; also the other minor child would not under the census listing necessarily have to be an own son - so long as he was part of the family.

In this census there were also two Jacobs listed in Dauphin County, each with one boy under 16 and four females. Neither of these fit with the known facts about Jacob (3-5); one has been definitely placed from other records as (3-8), and the other was probably of the 4th generation. Baptismal records for the children of this family are from three churches in the vicinity; the names of the parents vary, but in each case there is no other couple known who could be the parents. Two of the children, baptized at different churches seven years apart, had the same sponsors. Lacking further information it seems safest to place all these children with this family.

The Dauphin County Orphan's Court records at Harrisburg include the estate of a Jacob Kitzmiller who died in 1912. The estate was small and was administered by a John Kitzmiller. No final report filed. The 1790 census of Dauphin County lists two Jacob Kitzmillers, each with a family of one minor son and four females. One has been identified as Jacob (3-8), and the above man could have been the other one, as he was of the right name and age, and not otherwise identified.

In searching the Cumberland County records for Jonathan the name of John Kitzmiller was found in several real estate deals in the western part of the county during the period 1820 - 1840. The weathering of an old gravestone could make it possible to misread either 1767 or 1781 as 1761, so this man could be either (4-14) or (4-19).

A John Kitzmiller married Susan May at Harrisburg Oct. 22, 1818, both being from Cumberland County.

Lancaster County, Pennsylvania, was organized in 1729; York County was taken from it in 1749, and Adams County taken from York in 1800. Conewago Twp. Adams County was originally included in Heidelberg and Manheim Twp., York County. So it would be possible for a man to live in several townships, in three counties, during his life, while remaining right on the same farm. The town of Hanover is almost on the line between the two counties.

This search was not carried much beyond 1800 as it was made only in an attempt to locate a Jonathan Kitzmiller who was born in the 1780s. Adams County records and cemeteries, particularly at Carlisle, will yield much data of later dates.

He arrived in Philadelphia Aug. 24, 1728 on the ship "Mortonhouse", which had cleared from Deal, England on June 15th. The passengers were 80 families of immigrants from the Palatinate, and included 69 women and 56 children. Christophel Bencker, father of Juliana below, was also on this ship (Rupp)

John appears as sponsor at the baptism of a grandchild in 1731, and with his wife again in 1734. It is not known whether he died before or after his son's settlement in York County.

#### JOHN MARTIN KITZMILLER (2-2)

son of John Jacob

Martin and his wife both arrived with their parents in Philadelphia in August 1728. He appears first in the record in 1737, when he purchased land near Conewago. A "History of York County", 1886, says he was an early Palatine immigrant and settled near Hanover in 1736.

He could not have been the John Martin Kitzmiller who arrived in Philadelphia on the "Windsow" in Sept. 1753, nor has any record been found of this later arrival.

Martin bought property in Manheim Twp. in 175h; sold lands to his children in 1760 and 1765; was twp. supervisor in 1756; shows on the tax list for 1762, but not for 1783; his will was dated April 10, 1786, and was probated May 27,1788.

Feb. 26, 1752 Martin and sons fought off a party of Marylanders who were attempting to oust him from his land, and during the fight Dudley Digges was killed. The account of the Kitzmiller trial and acquittal is written up fully in Pa. Arch. 1, I & II. The testimony gives data as to Martin's children, his wife, his residence in Manheim Two and his mill. This is mentioned in "History of Adams County", 1886, as having a door stone on which was carved "Hanson Martin Kitzmiller, August 1738". The grist mill was on Little Conewago Creek near the. Monocacy Road, which was put through this section about 1740, running from Frederick, Md., to York, Pa. Washington travelled along this road in July 1791. The Kitzmiller family attended Churtst Reformed Church, organized May 6, 1747, a couple of miles west along this road. Old maps (1792) show the location as "Kitzmillers".

Jacob is named in the Digges testimony as being the oldest son of Martin, and over 19 in 1752.

In 1776 he was a saw-miller in Germany Twp., and a miller there in 1794. He was an overseer in that Twp. in 1768, on the tax list there in 1762, 1783 and 1799, with large holdings.

He was listed as the head of a family in the 1790 census, the family including one male over 16, one under, and three females.

He was the administrator of the estate of his brother John in 1804.

His own will, dated Oct. 29, 1804, probated Oct. 21, 1808, mentions his wife and seven children, both sons and daughters, including one son Martin and two married daughters. (His sons-in-law were the executors). Baptismal records have been found for a son John Jacob, to whom the executors made payments. Three daughters are known, but nothing has been found about the other two children. Since the census records indicate two sons and two daughters, it is probable that these other two were daughters - that the three older daughters had been married by 1790 and were no longer listed

as in his family. His will states: -"I have kept no account of what I

gave my daughters when they married --- I have never given them much". He left a large estate.

In 1760 his father sold him 194 acres in Manheim and Germany Twos. which the father had bought in 1751. John was then a blacksmith. He bought 180 acres in Manheim and Germany Twps. in 1770, and he and Mary granted water rights on it in 1773 to his brother George. He was taxed in Manheim in 1762; in Manheim and Hanover in 1783; in Conewago in 1801; was overseer in Manheim in 1773 and supervisor in 1778.

Listed in the militia records of York County at various times 1780-85, mainly as paying fines for non-performance of duty. His brother Jacob administered his estate.

The 1790 census lists him as head of a family consisting of three boys under 16 and two females, which by making one correction, matches with the ancestry of Jacob as given in "History of Stark County, Ohio", by W. M. Perrin, 1881. That says that Jacob was born about 1773 in Adams County, Pa., - had a sister, and brothers Martin and John, and that they were the children of Martin who had emigrated from Germany to Pennsylvania when that country was new. If this account had listed Jacob as being the grandson of Martin the record would be clear, and such a mistake could happen in a biography written 35 years after Jacob's death. Records of the family in four counties of Pennsylvania fail to show another Jacob not otherwise accounted for, and if the one who moved to Ohio was the son of John (3-5) the record of the children is as below:-

His will of May 22, 1815 was probated Mar. 27, 1824; son Michael was the executor. It named his wife, two sons, five daughters and son-in-law Jacob Dewalt. His estate was large, and appears in court records till 1833
