## CHESTER McKINLEY LAWSON

CHESTER M. LAWSON, the son of JAMES and SARAH (CHESTER) LAWSON, was born in Fall River, Mass., on January 4, 1901. He was educated in the Malden public schools and obtained further education by taking University Extension courses and also attended the Wentworth Institute.

His early days were spent the same as those of most boys at that time. Initiative, perseverance, and ability were some of the traits he possessed which enabled him to advance and become Assistant Superintendent of the Angier Chemical Company, of Allston, Mass.

In April, 1933, his early ambitions were realized when he started his own machine business, and in 1937 it became known as the Lawson Machine and Tool Company, of Malden. In 1935 he became a sub-contractor of the Pratt & Whitney Aircraft Company. Through the ingenuity of Chester M. Lawson, the Lawson Machine and Tool Company continued to grow very rapidly all through the depression, and in 1939 the success of the company was assured when Mr. Lawson was able to obtain a contract from the U. S. Navy Department, through the Pratt & Whitney Aircraft Company.

A beautiful building was rehabilitated in Malden, Mass., in which building the most modern facilities for the convenience and the protection of all employees were provided.

On March 22, 1943, the Army-Navy "E" for efficiency and cooperation with the war effort of World War II was awarded the company, at which time a letter was received by Chester M. Lawson, as head of the firm, signed by the Secretary of the Navy, James Forrestal. The first thought of Mr. Lawson was to have befitting exercises so that he could inform his employees that the award belonged to them and not to the company. Such exercises were held subsequently. High officials of the Army and Navy, and city and state officials, including Governor Saltonstall, were present. The above was the first of five Army-Navy E awards.

Those who know Chester M. Lawson admit that he is a capable business man and that without his ability, soundness

and thoughtfulness, the Lawson Machine and Tool Company would never be what it is today.

He is an active member of the following organizations: the Malden Rotary Club; Converse Lodge A. F. and A. M.; Malden Chamber of Commerce; Boston Yacht Club, Marblehead; Salem Country Club; Bear Hill Golf Club, Stoneham; the National Association of Manufacturers; the Melrose Council R. & S. M.; Malden Club; Boston Chamber of Commerce; Royal Arch Chapter Tabernacle; Corinthian Yacht Club, Marblehead; Malden Y.M.C.A.; Associated Industries of Massachusetts; Navy League of the U. S.; National Aeronautics Association of the U. S.; Kernwood Club of Malden; and charter member of the Navy Industrial Association. He is President of the Malden Chamber of Commerce.

His membership in the foregoing organizations is indicative of the high esteem in which Chester M. Lawson is held in both the social and business world.

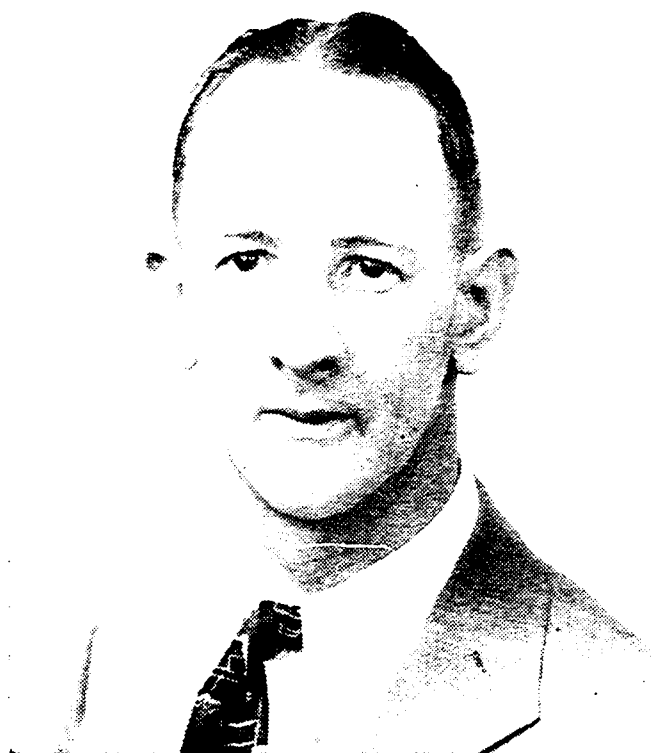

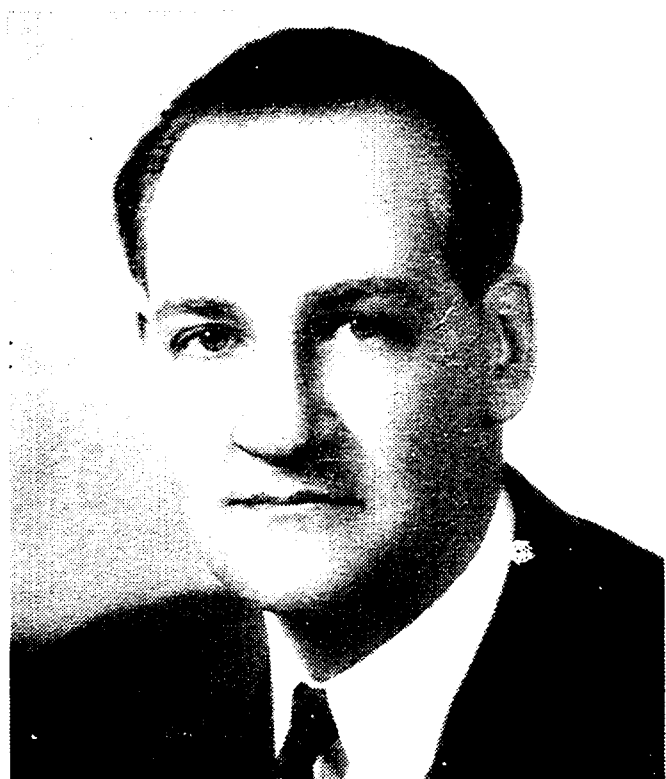

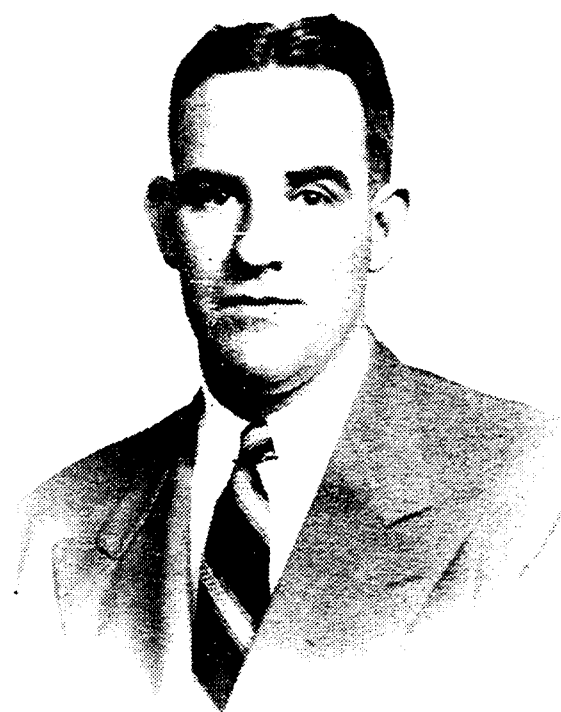

## JAMES ROUE LAWSON GENEALOGY

1. JAMES ROUE LAWSON was born June 26, 1831, in Slatefield, Forfarshire (Angus), Scotland, the son of ANDREW and JANE (ALLAN) LAWSON. He died Feb. 21, 1904, in Sheffield, England, and was buried in Darnall Cemetery in that city. His father was a cabinet maker. He married Dec. 28, 1851, in Montrose, Forfarshire (Angus) Scotland, MARY MILLAR, daughter of WILLIAM and JANE (LOW) MILLAR. She was born July 6, 1827, in Craigo, near Montrose. She died at Bristol, England, May 10, 1873, and was buried in Westbury-on-Trym in or near Bristol. He was an engineering pattern-maker.

They had six children:

- A. ELIZABETH LAWSON was born in 1854 in Arbroath, Forfarshire (Angus), Scotland. She died October 7, 1868, in Kingsdown, Bristol, Gloucestershire, England, and was buried in Westbury Churchyard, Bristol.
- B. JAMES LAWSON was born Dec. 16, 1858, in Forfarshire (Arbroath), Scotland. He died Feb. 3, 1937, in Malden, Mass. He married Aug. 13, 1881, in Trinity Church, Bristol, England, SARAH CHESTER, daughter of ELI and CAROLINE (VAUGHN) CHESTER. She was born Nov. 7, 1861, in Yeovil, Somersetshire, England.

In Bristol, England, he worked for the Parnell Co. which opened an agency in Fishponds, over which agency he was manager. In 1886 he moved to Cardiff, Wales, and was an engineer for a wagon company. On May 29, 1893, he came to Boston, Mass., on the *Catolonia*, and then to Fall River to his wife's sister. He remained in Fall River until 1902, and worked for the Reid and Creighton Co. as a machinist. Then he moved to Malden, Mass., and worked for the Cochrane Manufacturing Co. as a machinist and engineer. Later, he became a member of the Planning Board of the Charlestown Navy Yard. He was a member of the Saint Paul's Episcopal Church and a life member of the Converse Lodge of Masons. He acquired his citizenship when he became naturalized on Oct. 13, 1899, at the Second District Court at Fall River, Mass. On Aug. 13, 1931, he and his

wife celebrated their 50th Wedding Anniversary. His perseverance, initiative, calmness and kindness were instrumental in his success as a master mechanic and steam engineer.
