CONCERNING JOHN LAPHAM AND SOME OF HIS DESCENDANTS

On 16 May 1903, there was published in the Newport, R. I., Mercury an article written by the late Stephen Farnum Peckham of Brooklyn, N. Y., entitled "Concerning John Lapham and Richard Scott and Some of their Descendants." These two families, prominent among Rhode Island Friends, were united when Augustus Lapham, a descendant of John¹ Lapham in the fourth generation, and Mary Scott, a descendant of Richard¹ Scott in the sixth generation, were married on 6 April 1775, in the Friends' Meeting House at Providence, R. I. Prof. Peckham states that in the family of Augustus Lapham, who was his great-grandfather, there was an old family record, made by Augustus Lapham and preserved by his descendants, entitled, "Some Account of the Family of Lapham taken down in the year 1782." In this Account it was related that: *

* S. F. Peckham quoted only a part of this old Account, probably from a copy known to have been in the family of his grandmother, Eunice (Lapham) Farnum. The writer has quoted the entire Account as given in a copy preserved in the family of Job Scott Mann of Smithfield, R. I., who was a grandson of Augustus Lapham. It is evident that copies have been in the possession of Lapham descendants other than those of Augustus Lapham. In 1864, the Hon. Increase A. Lapham of Milwaukee, Wis., issued a Lapham Chart in which he quoted from the Augustus Lapham Account. The late Emory D. Lapham of East Rochester, N. Y., left at his death in 1927, the manuscript of a Lapham Genealogy containing some six thousand descendants of John² and Mary (Russell) Lapham. This manuscript is owned by the St. Petersburg, Florida, Public Library. In his introduction he mentions the Account written down by Augustus Lapham. These three sources will be referred to herein as the Lapham Account, the Lapham Chart and the Lapham Mss.

"John Lapham, the first we find any account of in America, came from Devonshire, England, a weaver by trade, to Providence, at which place he married Mary Mann and settled near burying place hill. The Indian War breaking out they were obliged to retire to Rhode Island and their house was burned by the Indians. Sometime after he went to Dartmouth and settled there and had four sons and one daughter.

"Thomas, their second son, after arriving at man's estate, built a house in Providence on one of the seven acre lots toward the lower end of the town near where Dr. Gibbs has since lived but soon after died a single man well beloved by his neighbors.

"William, their third son, lived to grow up, fell into a melancholy state of mind and put an end to his life by hanging himself to a tree.

"John, the eldest son, married Mary Russell, daughter of Joseph Russell of Dartmouth, whose wife was Elizabeth Fobes of the family of Fobes at Bridgewater and sister of William Fobes in Seconnet, by whom John had five sons and nine daughters, viz: Elizabeth, John, Thomas, Rebecca, Joseph, Mary, Frances, Benjamin, Ruth, Bathsheba, Joshua, Hannah, Sylvia and Elizabeth.

"Elizabeth, the eldest, married Amos Taber of Dartmouth by whom she had two children, Hannah and Jethro, and died from fever when her son was about three months old.

"John, the second child, married Desire Howland, daughter of Benjamin Howland of that town, by whom he had two sons and one daughter, Benjamin,

Jonathan and Jemima. His wife died in the year 1760 odd. He has since married a widow White and now lives at the Nine Partners. He has lived some part of his life at Smithfield near Providence.

"Thomas, the third child, married Abigail Wilbur, daughter of Benjamin Wilbur, by whom he had four sons and five daughters, viz: Sylvia, David, Phebe, Abigail, Thomas, Bathsheba, Jethro, Augustus and Lillis. David died when near twenty one, Abigail at the same time aged about sixteen, and both were buried in one grave. Lillis died about eight months old. The others all lived to marry and have children. He died when near seventy four and his wife Abigail about the same age.

"Rebecca, the fourth child, married Barnabas Howland of Dartmouth, son of Benjamin Howland, by whom she had two sons and four daughters. All lived to marry and have children.

"Joseph, the fifth child, married Mary Ballou, daughter of Jonathan Ballou of Smithfield, by whom he had nine children, viz: Abner, Rebecca, Amy, Lovina, Naomi, John, (Frances), Mary and Abigail. Amy died aged one year, nine months. Lovina died in her seventeenth year. Naomi lived only two weeks. The others all lived and had children. He now lives in Cumberland.

"Mary, the sixth child, at about twenty years of age grew melancholy and became delirious but not very troublesome. She lives now with her niece at Gloucester.

"Frances, the seventh child, married Nathan Bowdish, son of William Bowdish of Dartmouth, by whom she had two children. Both are married and now

live at Oblong.

"Benjamin, the eighth child, married Lydia Ballou, daughter of Samuel Ballou of Smithfield, by whom he had three children, James, Mary and Lydia. They are all deceased and their mother also. He married the second time Mary Mann, daughter of John Mann of Smithfield, by whom he had ten children, viz: Lydia, Sarah, Stephen, Gideon, George, Elizabeth, Abigail, Silas, Benjamin and Ruth. All are living except Gideon. Silas, Lydia, Sarah and Stephen are married. They moved from Smithfield to Hoosac about twelve years ago. (Note. This is obviously a mistake in copying. It should read: All are living except Gideon and Silas. Lydia, Sarah and Stephen are married.)

"Ruth, the ninth child, married Seth Sherman, son of Daniel Sherman of Dartmouth, by whom she had two sons and three daughters of which one son died young. The other children all married. She died about 1758.

"Bathsheba, the tenth child, married John Gifford, son of Benjamin Gifford. They live now at the Nine Partners.

"Joshua, the eleventh child, married Hannah Sherman, daughter of David Sherman of Dartmouth, by whom he had ten children, all living but one. He lives now at Hoosac.

"Hannah, the twelfth child, married three husbands, Joseph Brown, Jacob Aldrich and Richard Estes. The last is now living. She had four children by Joseph Brown. They are all living.

"Silvia, the thirteenth child, died young.

"Elizabeth, the fourteenth child, lived to marry, had one child and died. Her husband's name was Benjamin Sherman, son of Thomas Sherman of Dartmouth.

"Nicholas (son of John^l Lapham) lived till old and married Mary Arnold, daughter of John Arnold of Smithfield, and had three sons and two daughters, viz: Abigail, Solomon, Rebecca, Nicholas and Arnold. Rebecca died after a woman grown, unmarried. Arnold became non compos mentis. The others all married.

"Mary (daughter of John^l Lapham) married Charles Dyer who settled a little west of Providence. They had six children, viz: Charles, Mary, John, Samuel, Elizabeth and William."

SOME ACCOUNT OF THOMAS LAPHAM'S CHILDREN

TAKEN DOWN 4TH OF 3D MONTH 1819

"The oldest, Silvia, married Ephraim Whipple by whom she had three sons and one daughter, David, Job and Ephraim. She was divorced from him and then married Solomon Lapham, son of Nicholas Lapham of Dartmouth, by whom she had six children, viz: Rebecca, Thomas, Rhoda, William, Dutee and Ruth who all moved into the country except William. He now lives in Glocester where his father moved. All of Solomon's children are married and have children.

"The next was Phebe who married Eleazer Ballou, son of Samuel Ballou of Smithfield, by whom she had eleven children, viz: Lydia, David, Jesse,

Susanna, Jirah, Charlotte, Orvilla, Roena, Prussia, Arba and an infant who died young.

"Thomas married Mary Harris, daughter of Jonathan Harris of Smithfield, by whom he had eight children, William, David, Jonathan, Olive, Job, Chloe, Isaac and Phebe.

"Bathsheba married a son of Stephen Wilcox of Dartmouth, by whom she had nine children, Willard, Wilbur, William, Elizabeth, Phebe, Mary, Asenath, Josiah and Bathsheba.

"Jethro married Amy Bassett, daughter of Joseph Bassett. She died after having three children, viz: Abigail, Jesse and Levi who married and had children. He married a second wife, Sarah Whipple of Glocester, but had no children by her.

"Augustus, who writes this Account, married Mary Scott, daughter of John Scott of North Providence, by whom he had nine children, Amos, Lydia, Sarah, Ruth, Thomas, David, Abigail, Eunice and Hannah. Sarah died aged sixteen of fever. Ruth died aged fifteen and a half years of the same disease. Thomas died aged five months, three days. Hannah died aged two years, seven months.

"My brother Thomas lost three children. William and David lived till men grown and died of consumption. Chloe died of throat ale aged sixteen years."

This old Account is of special interest because it gives the surname

of Elizabeth, wife of Joseph² Russell of Dartmouth, Mass. The early records of the John Lapham family are found, with a few exceptions, in Dartmouth, Mass., Rhode Island, Berkshire County, Mass., and New York State. There are very few differences between these records and the Augustus Lapham Account and these are probably due to mistakes made in copying the Account.

FIRST GENERATION

1. John¹ Lapham, born 1635 (he testified in 1680 that he was 45 or thereabouts); died at Dartmouth, Mass., 1710. His will was made 5 Dec. 1709, proved 5 April 1710 (Bristol Co., Mass., Probate Recs., vol. 2, p. 276). He married at Providence, R. I., 6 April 1673, Mary Mann, born 1640; died at Dartmouth after 1710, daughter of William and Frances (Hopkins) Mann.

Mann Line: William Mann came to New England from Yeovilton and Ilchester, co. Somerset, England. He was active among the early Friends at Providence where he died about 1650. Frances Hopkins was born at Yeovilton, 28 May 1614, died 26 Feb. 1700, at Dartmouth, at the home of her son-in-law, John Lapham. She was the daughter of William and Joan (Arnold) Hopkins. Joan Arnold was the sister of William Arnold, original proprietor of Providence and early settler of Pawtuxet, R. I. He came to New England in 1635; in his party were his niece, Frances (Hopkins) Mann, her husband William Mann and her brother Thomas Hopkins. The latter was the great-grandfather of Stephen Hopkins, Governor of Rhode Is-

land and Signer of the Declaration of Independence. He was also the great grandfather of Esek Hopkins, the first Commander-in-Chief of the American Navy. Before coming to New England, the Arnold, Hopkins and Mann families were neighbors in Yeovilton and Ilchester in England. It is possible that John Lapham knew them in England. Yeovilton and Ilchester are near the Devonshire border and Laphams were still living in the vicinity of these towns in the early nineteenth century.

Children of William and Frances (Hopkins) Mann:

S. F. Peckham writes: "John Lapham appeared in Providence about 1660. He was an ardent Quaker and soon became actively identified with the sect in Rhode Island, though there are no records known to me that he was subject to persecution amounting to personal violence. He lived in a house near the North Burying Ground, then on a hill at the north suburbs of the town. At the outbreak of King Philip's War, in 1676, when Providence was burned, John Lapham's house was burned and he fled to Newport with most of the inhabitants of Providence.

"1673. John Lapham was freeman in Providence and Deputy to the General Court; in 1675 he was constable.

"1682. He went to Dartmouth, Mass.

"1699, Jan. 6. At a meeting held at John Lapham's house in Dartmouth the following agreement was made: 'At a man's meeting in the town of Dartmouth, the 6 day of the 11 month 1698-9, at the house of John Lapham, wee underwritten, Peleg Slocum, Jacob Mott, Abraham Tucker and John Tucker, the day of the year above written, undertake to build a meeting house for the people of God in Scorn called Quakers, 35 foot long, 30 foot wide and 14 foot studs, to worship and serve the true and living God in according as they are persuaded in Continnence they Ought to Do, and for no other use, Interest or purpose, but as afores'd and when one or more of us decease, then immediately the survivors Choose others in our room, together with the consent of the assembly of s'd people, so to be and Remain to us and them forever as Afores'd, which s'd House shall be completely finished at or before the 10 day of the 8 month next Insuing the date hereof.

'In witness hereto wee subscribe our names with our own hands. And further wee of said Society of people toward the building of said House of our own free will Contribute as followeth:

"This was the original Apponegansett Meeting House, the first Friends'

Meeting House built in Dartmouth. Since then another and larger one has been built on the same spot. The house was built the same year. At one time John Lapham owned 250 acres of land in and about Providence."

In his will, John Lapham names his wife, Mary, his two sons John and Nicholas and his daughter Mary Dyer.

SECOND GENERATION

2. John² Lapham (John¹), born at Newport, R. I., 13 Dec. 1677; died probably at Smithfield, R. I., after 1758; married at Dartmouth, Mass., 3 April 1700, Mary Russell, born at Dartmouth, 10 July 1683; died there May 1752,* daughter of Joseph² (John¹) and Elizabeth (Fobes) Russell. He probably married, secondly, at Smithfield, 4 March 1756, Elizabeth, widow of Samuel Buxton.

Fobes Line: John¹ Fobes, by tradition a native of Scotland, was in Duxbury, Mass., in 1636; removed to Bridgewater, Mass., where he was an original proprietor and where he died in 1661/2. His wife was Constant Mitchell, a sister of Experience Mitchell of Plymouth and Duxbury, Mass. She married, secondly, in 1662, John Briggs of Portsmouth, R. I.

*The date of Mary (Russell) Lapham's death is uncertain. The Town Records of Dartmouth give her death, — May 1752. Dartmouth Friends' Records call her "dec'd", 1 Feb. 1748, when her youngest daughter Elizabeth Lapham married Benjamin Sherman at Dartmouth.

Russell Line: John¹ Russell, born about 1608; died 13 Feb. 1694/5; married Dorothy ---- ; died 18 Dec. 1687. John and Dorothy Russell were in Marshfield, Mass., as early as 1642-3. On 20 Mar. 1661, he bought from the attorney of Miles Standish, his share of the town of Dartmouth, Mass., and thereafter he lived at Dartmouth. There is no proof that John Russell of Marshfield and Dartmouth, Mass., was related to Ralph Russell of Taunton, Mass., as is often stated.

Joseph² Russell (John¹), born at Marshfield, Mass., 6 May 1650; died at Dartmouth, Mass., 11 Dec. 1739; married Elizabeth Fobes, born 6 Mar. 1657; died at Dartmouth, 25 Sept. 1737, daughter of John and Constant (Mitchell) Fobes.

S. F. Peckham writes: "The prominent Russells of New Bedford and vicinity were descended from the twin brothers, Joseph³ and John³ Russell. Joseph³ and his son Joseph⁴ were the founders of New Bedford and the whale fishery. The latter presented to New Bedford Friends the lot on which their Meeting House stands. Joseph³ and Joseph⁴ sent the first whale ship around Cape Horn into the Pacific Ocean."

John² and Mary (Russell) Lapham were probably married in the Apponegan-sett Meeting House in Dartmouth. Austin states (Gen. Dict. of Rhode Island, p. 120) that John² Lapham was of Dartmouth and Smithfield, R. I., and that

he was freeman in Smithfield in 1734. Although the land records of Smithfield show that he owned considerable land in Smithfield, much of which he sold to his sons when they settled there, it is doubtful if he himself went there until the latter part of his life. All of his fourteen children were born in Dartmouth and most of them were married there. When his daughter, Hannah, married Joseph Brown, 27 June 1751, he was still called "John of Dartmouth."

The Lapham Account mentions no second marriage of John² Lapham, but there is strong probability that after the death of his wife, Mary (Russell) Lapham, he went to Smithfield and that he married there a second time. On 25 March 1754, Thomas Lapham, "of Smithfield in the county of Providence, Colony of Rhode Island", sold land in Smithfield to John Lapham, "of the same Town, County and Colony." (Smithfield Deeds, 3:369.) John Lapham and Elizabeth Buxton, "both of Smithfield", were married 4d 3m 1756 (Smithfield Friends' Recs.). Only John² or his son John³ could have been the John Lapham of these records and John³ Lapham and his wife, Desire (Howland) Lapham, were both living at this time at Nine Partners, N. Y., where they had removed from Smithfield.

Elizabeth Buxton was the widow of Samuel Buxton of Smithfield who died there in June 1753. On 12 Sept. 1758, John Lapham of Smithfield sold to Joshua Lapham a tract of land in Smithfield, his wife Elizabeth, consenting and signing the deed with a mark (Smithfield Deeds, 4:425). In the will of Samuel Buxton Jr., made 22 Sept. 1774, he made provision for the

maintenance of "my honored mother , Elizabeth Lapham," (Smithfield Probate, 1769-1797, p. 132). This would indicate that John² Lapham died in Smithfield after 1758 and before 1774. He evidently died intestate.

John² Lapham's five sons all left Dartmouth and all lived at some time in Smithfield, R. I. John³ went to the Quaker Settlement at Nine Partners, Dutchess Co., N. Y. Benjamin³ and Joshua³ were early settlers of East Hoosuck (Adams) Berkshire Co., Mass. Thomas³ and Joseph³ remained in Rhode Island.

* These two records in Uxbridge, Mass., V. R., are probably the marriage records of the daughters of Joseph and Hannah (Lapham) Brown. They doubtless went to Uxbridge with their mother when she married Jacob Aldrich. They are the only, Abigail and Phoebe Brown, of that locality, of a suitable age and not otherwise accounted for. David Gaskill was a nephew of Sarah Gaskill who was the first wife of Richard Estes.

Y., married first, at Dartmouth, 9 March 1725/6, Desire Howland, born at Dartmouth, 29 Aug. 1696; died at Nine Partners after 1760, daughter of Benjamin³ (Zoeth², Henry¹) and Judith (Sampson) Howland. She was the sister of Barnabas Howland who married her husband's sister, Rebecca³ Lapham. He married secondly, at Nine Partners, 1 Oct. 1777, the widow Rachel White.

John Lapham left Dartmouth and went to Smithfield, R. I., about 1732, and lived there until after 1744. In April 1744, he sold his Homestead Farm in Smithfield to his brother Thomas Lapham, his wife Desire, signing the deed with him. (Smithfield Land Recs., 2:296.)

John Lapham was in Nine Partners, Dutchess Co., N. Y., by 1747 or 1748, when his ear mark was registered. He may have gone first to Long Island, N. Y., as he is said to have gone to Nine Partners from Long Island and to have been one of the original "Nine Partners". (American Ancestry, 2:70.) John Lapham's name appears a number of times in Records of the Friends' Monthly Meetings at Oblong and Nine Partners; in 1757 and 1758 under "Sufferings of Friends" which would indicate that he was subject to some persecution. ("Old Northwest" Genealogical Quarterly, 3:172.) John Lapham and wife are mentioned at Nine Partners as late as 3d month 1760; the Lapham Account states that she died "1760 odd". His second marriage is given in Nine Partners Friends' Recs., as: "John Lapham of Nine Partners and Rachel White of Nine Partners, 1d 10m 1777, at Paul Upton's over the Creek."

Wilbur Line: Thomas³ and Abigail (Wilbur) Lapham were the ancestors of S. F. Peckham. Samuel¹ Wilbore (Wilbour, Wilbur) and his first wife, Ann (Smith) Wilbore, were in Boston, Mass., by 1633; he became a follower of Anne Hutchinson, a founder of Aquidneck (Portsmouth), R. I., and a signer of the Portsmouth Compact. Although the authors of The Wildbores of America (2d Edition, 1933, by J. R. Wilbor and B. F. Wilbour) list William among the children of Samuel¹ Wilbore, as William², they explain that they do so because he

may have been brought up in Samuel's family, as his son, although he was not his son but probably his nephew.

William² Wilbur, b. 1630; d. at Little Compton, R. I., 1710; m. 1653, Martha ---- . He lived at Portsmouth and Little Compton, R. I. The youngest of his ten children was Benjamin Wilbur, b. Portsmouth, 1670; d. Dartmouth, Mass., 1729; m. (1) 22 Jan. 1700, Mary Kennicut, d. 14 Feb. 1708, daughter of Roger and Joanna (Shepardson) Kennicut; m. (2) 2 Nov. 1710, Elizabeth Head, b. 1682; d. 1734, daughter of Henry and Elizabeth (----) Head of Little Compton. The eldest child of the second marriage was Abigail, who married Thomas³ Lapham, as above.

Thomas Lapham was admitted freeman at Smithfield, 4 Feb. 1733; was Deputy to the General Court almost continuously from 1747 to 1752; was appointed a Commissioner to run a boundery in 1750; was Judge of the Court of Common Pleas, 1750-60 and 1763-4.

It was the opinion of S. F. Peckham that Thomas Lapham moved from Dartmouth to Smithfield soon after his marriage in 1730. He settled in the Blackstone Valley where he built his first house near the village of Albion. In 1763, he built another house on the high land nearly a mile and a half due west of Manville. This was a large two story house typical of that period and locality and is still (1947) standing. In his will he left this property, his Homestead Farm, to his son, Augustus Lapham, who lived there until his death in 1828. In a field back of this house is an old Lapham Burying Ground where Thomas and his wife are undoubtedly buried. There are

some twenty stones there but, as was the custom among Friends, few of them are marked. Among those marked are the stones of David, Abigail and Lillis, the three children of Thomas who died in November 1753. (Note: The writer was told that these children were first buried on the farm near Albion and later removed to this Burying Ground.)

S. F. Peckham writes: "The Laphams must have owned a large tract of land west of Manville and Albion. Here he (Thomas Lapham) carried on large farming operations, was clerk of the Friends' Meeting and later an Elder. * * * * Whether he assisted in organizing the Smithfield Upper Friends' Meeting at Union Village, now a part of Woonsocket, I know not, but it is quite certain he was very active in organizing the Smithfield Lower Meeting near Lonsdale which has been called 'The Old Friends' Meeting House' for more than a century." Thomas Lapham's will, made 17 Aug. 1775, is recorded at Smithfield. (Smithfield Probate, 1769-97, pp. 392-3) He mentions his wife Abigail, his three sons Thomas, Jethro, Augustus and his daughters Silvia Lapham, Phebe Ballou and Bathsheba Wilcox. He leaves thirty three pounds to be equally divided between his three grandsons, David, Job and Ephraim Whipple.

His father, John² Lapham, sold him 92 acres of land in Smithfield, 1 Sept. 1733. He sold this property 29 Aug. 1752 to his brother Joshua Lapham, calling it "my Homestead Farm where I now dwell * * * it being the whole I had a deed of from my father John Lapham of Dartmouth, dated Sept. the first A. D. 1733." (Smithfield Land Recs., 1:64, 3:237.)

He later lived at Cumberland Hill, R. I., on a farm which he left in his will to his sons, Abner and John Lapham. This farm, where his son Abner later lived, was situated at the junction of the old Furnace Road with the road to Providence. (Ballou Genealogy, p. 209.) In the records Joseph Lapham is called "miller." His will, dated 26d 5m 1786, was recorded in Cumberland 18 Mar. 1797 (Cumberland Probate, 1784-1792, 6:528.) In this will he mentions his wife Mary, sons Abner and John and daughters, Rebecca Bartlett, Mercy Chase, Mary Wilkinson and Abigail Meade. Frances, given in brackets in the Lapham Account should be, Mercy.

Benjamin Lapham was freeman in Smithfield, 3 Apr. 1744. His first marriage ended with the early death of his wife and two of their three children, all within a few days. He is said to have lived in Smithfield from 1744 to 1770 on the original Jabez Brown farm. He moved from Smithfield to East Hoosuck about 1770, his brother Joshua going there at the

same time. The Friends' Records of East Hoosuck show that at one time he was in New York State, perhaps for only a short time. On the 21 Apr. 1785, the Monthly Meeting at Saratoga, N. Y., informed the Monthly Meeting at East Hoosuck, Mass., of the removal of Benjamin Lapham and his son Benjamin, and of his wife Mary Lapham and her daughters Abigail and Ruth, from the Saratoga Meeting to the East Hoosuck Meeting. The homestead which he erected in East Hoosuck, about 1775, is on Friend Street in the present town of Adams, Mass., and is marked by a memorial tablet bearing the following inscription:

Benjamin Lapham's will is dated 15 Dec. 1787; probated 4 Sept. 1804; he mentions all the children by his second wife except Gideon and Silas. He also mentions "my grandson, Pardon Kelly, so called."

medicine for many years in Connersville, Fayette Co., Ind. During his lifetime he made three trips back to his old home in New York State and to the home of his grandfather, Benjamin Lapham, in Adams, Mass. In 1867, soon after his last trip, he published an autobiography which is of great interest to the descendants of Benjamin³ Lapham as it contains many pages of genealogical material which he obtained from his many Lapham uncles, aunts and cousins whose homes he visited on these trips. A copy of this book is in The Indiana State Library at Indianapolis, Ind.

He is the ancestor of a branch of the Lapham family that is very numerous in Massachusetts, New York State and the Middle West. He and his family owned a great deal of land in and about the town of Adams. His farm was situated on both sides of the East Road and his house stood until 1906 when it burned. Joshua Lapham and his wife are buried in unmarked graves in the old Friends' Meeting House Burial Ground at Adams. The site of his house is marked by a tablet bearing the following inscription:

His will (Gloucester Probate Recs., 3:44) names his wife Silvia, his daughters Rebecca Brown, Rhoda Harris and Ruth Thayer, and his sons Thomas, William and Duty and his sons-in-law Elisha Brown, Nathan Harris and Isaac Thayer. This is the Augustus Lapham who, in 1782, wrote down "Some Account of the Family of Lapham." He lived all his life in Smithfield, inheriting the Homestead Farm of his father which was near the town of Manville, R. I. He and his wife were members of the Smithfield Friends' Lower Meeting near Saylesville, R. I. He and his wife and their children who died young are buried in unmarked graves in the Burial Ground back of the house which his father built in 1763. His wife, Mary (Scott) Lapham, descended from Richard¹ and Catharine (Marbury) Scott, through John², Sylvanus³, John⁴ and John⁵ Scott. She was a sister of Job Scott, the famous Quaker preacher. Augustus Lapham made his will, 4 Nov. 1826 (Smithfield Probate Recs. 5: 74.) In it he mentions all his children except the four who died young.

Arnold gives her name, Mary Mowry, but the original record gives it, Marcy Mowry. She was undoubtedly, Marcy, youngest daughter of Oliver and Dorcas (Whipple) Mowry. (Nathaniel Mowry Book by William A. Mowry, p. 62.) There are a number of records in the Cumberland Probate records regarding the settlement of Abner Lapham's estate, in all of which his wife signs herself, Marcy Lapham. Cumberland deeds show that he and his brother, John Lapham, were engaged in the business of "making and refining iron" near Furnace Unity. He lived at Cumberland Hill on the farm left him by his father. He was admitted freeman in 1757; was a member of the General Assembly from Cumberland in 1768 and was listed a resident of Cumberland in the Census of 1774 and in that of 1790.

There are records in Smithfield from 1744 to 1778 of this Nathaniel Bucklin whose identity has not been clearly established. Certain deeds prove that Silvanus Bucklin of Smithfield was his son. Silvanus Bucklin died in Smithfield, 13 Mar. 1816, apparently without an immediate family since he left his entire estate in his will, made 4 Jan. 1816, to his brothers and sisters or their heirs. (Smithfield Probate, 3: 607.) Among those mentioned in his will are "the heirs of my sister, Amy Lapham."

John Lapham was: "President of the Town Council of Cumberland in 1777 to 1781 inclusive, and was appointed by the General Assembly in May 1778 to pay the bounty allowed to each Revolutionary soldier in Cumberland. He served in the Revolutionary War as Private in Capt. Reuben Ballou's Company, Col. John Mathewson's Regiment, 1st Division, August 27, 1778; he also was on the list of Lieut. Ebenezer Gould's Division, January 6, 1777." He migrated about 1800 to Lapham Corners in what was then Paris Township, later Kirkland Town and Marshall Town, Oneida Co., N. Y. He and his wife are buried at McConnell's Corners Cemetery near Clinton, N. Y.

When he went to Macedon "this rash act of settling among wild beasts and savages" was condemned by the Friends and he was disowned but later was reinstated. His second marriage was also against Friends' discipline as he married his first wife's sister and his brother's widow. He helped to build the original Farmington Meeting House; this and

the Hicksite Meeting House directly across the highway are called the Farmington Quaker Churches and are well known in New York State. Abraham Lapham is said to have died in Collins, Erie Co., N. Y., where he was then living and where he was buried but his body was later brought back and buried in the Burial Ground adjoining the Farmington Orthodox Meeting House.

31. Noah⁴ Lapham (Nicholas³, Nicholas², John¹), born at Dartmouth, Mass., 14 April 1770; married at Dartmouth, 15 April 1793, Rachel Russell, born at Dartmouth, 13 Feb. 1772, daughter of Thomas and Edith (Sherman) Russell and grand daughter of Seth and Ruth³ (Lapham) Sherman.

There are no records in Dartmouth of Noah Lapham except those of his birth and marriage. He probably left Dartmouth and settled in New York State where so many of his Lapham cousins had gone. In Macedon, Wayne Co., N. Y., there are records of Thomas Lapham, born at Macedon in 1795; married Deborah Clapp, and of Humphrey S. Lapham, born in 1797; married Rachel ----. Humphrey S. Lapham and Rachel, his wife, are buried in the old Macedon Center Quaker Cemetery; the inscriptions on their grave stones read: Humphrey S. Lapham, died 1m 20d 1863, age 66 years; Rachel, his wife, died 11m 13d 1853 in 57th year.

Humphrey S. Lapham's will, made 10 Feb. 1854, is recorded in Wayne Co., N. Y. He evidently left no children. He mentions his wife Rachel, as deceased; mentions his brother Thomas and names his four children; mentions his sister Clarissa, "wife of Henry Purdy" and names their six children, the oldest of whom was Noah Lapham Purdy. Thomas and Humphrey S. Lapham and Clarissa (Lapham) Purdy of Wayne Co., N. Y., may be the children of Noah⁴ and Rachel (Russell) Lapham of Dartmouth, Mass.

32. Thomas⁴ Lapham (Nicholas³, Nicholas², John¹), born at Dartmouth, probably about 1781; died at Dartmouth, 1824; married first at Dartmouth, 30 Nov. 1803, Sarah Russell, born at Dartmouth, 23 Aug. 1784, daughter of Elijah and Hannah (Brayton) Russell; married second at Dartmouth, 1 Jan. 1810, Bathsheba Sherman. On 7 Dec. 1824, Bathsheba Lapham, widow of Thomas Lapham, late of Dartmouth, was appointed administratrix of his estate. In the distribution of the estate the following heirs were mentioned: Thomas Lapham, Perry Lapham,

Eliza Ann Lapham, Richard Lapham, Phebe Lapham and Mary Ann Lapham; another mentioned heir was Sally Sherman. On 19 July 1825, Bathsheba Lapham was appointed by the Court guardian of Perry, Eliza Ann, Richard, Phebe and Mary Ann Lapham, all minors under 14 years of age.
