l. Corrections to the "Lockwood Book"

History of the Lockwood Family, compiled by Frederic A. Holden and E. Dunbar Lockwood--published 1889. donated to the Perrot Memorial Library, Old Greenwich, Conn. by Nelson U. Lockwood and corrected by the late H. Stanley Finch, for many years Judge of Probate in Stamford.

Corrections added by others

References in long hand pp. 2-8-15-etc. evidently carrying on "Edmund Lockwood" corrections. Do not know whether they are Finch's notations or not.

Typed material opposite p. 8-

"Edmund Lockwood b. England, came to Mass. in 1630

He married Ruth-in England and she probably died soon after they arrived in Mass. He m. Elizabeth Masters, daughter of John Masters at Cambridge abt. 1631. He died at Cambridge before Mar. 3, 1635, leaving a son Edmund, b. England, and one or more children by his first wife, and a son John, b. Cambridge, Nov. 1632, by his second wife. This is verified by the references in the appendix pages 633 to 642 of the Lockwood Family Book of 1889.

John Lockwood, b. at Cambridge, Nov. 1632-d. at New London, Conn. in

1683, without issue.

The New London Probate Records show that his brother Edmund Lockwood of Stamford was his heir-See Caulkin's History of New London. Edmund Lockwood (son of Edmund) moved from Mass. to Stamford, Conn. bout 1646, where he married Hanna Scot Jan. 7, 1655 and became a large land owner. He died at Stamford, Jan. 31, 1692, and his widow Hannah died Apr. 12, 1706.

He left seven children viz.

1. John, b. about 1657-died Stamford without issue soon after his father. A deed in 1754 Stamford Land Records-Book F, p. 115 from Joshua Lounsbury (son of Micall and Sarah) shows John died after his father.

2.Edmund (no.35 of the Lockwood Family Book) died at Stamford, Feb. 6, 1740, without issue.-see copy of will in Lockwood Book-page 49-3. Mary (no. 36 of Lockwood Book) married Joseph Garnsey, Mar. 2, 1693.

4. Joseph (no. 14 of Lockwood Book) married 1st. Elizabeth Ayers, May 19, 1698-2nd. Margery Webb, Aug. 10, 1715. He was born in Stamford abt. 1674 & died at Poundridge, N. Y. in 1759.

5. Daniel (no. 29 of Lockwood Book) married Charity Clements, Nov. 5, 1702 at Stamford. She was the daughter of William and Elizabeth Clements. Daniel always resided at Stamford & died there in 1744--see copy of his will in the Lockwood Book at p.40

6. Sarah (no. 16 of the Lockwood Book) married Micall Lounsbery

June 19, 1707 at Stamford. 7. Abigail (no. 37 of the Lockwood Book) married Joseph Clark after 1707 and resided at Stamford. She probably left no issue. The Probage proceedings of the Estate of Edmund Lockwood at Fairfield, Conn. in 1692 and later; on the estates of his descendants in the Court of Probate at Stamford; and the record of the births, marriages, and deaths of his descendants in the Stamford Records

show the facts. Edmund Lockwood, who d. in 1692 and his children were large land owners in Stamford, and deeds too numerous to mention recorded in Stamford Land Records, show the truth concerning many inconsistant statements and mistakes in the Lockwood Family Book -- By H. Stanley Finch." Jan. 17, 1923, Stamford, Conn.

Stanley Finch, Judge of the Probate Court of Stamford, are at present in my custody, They include reference to a Stephen Lockwood (A), B.@ Greenwich, d. in Stamford in 1802 (B), and to his wife Elizabeth (C), who d. 1831. They had 5 ch. as shown in the 1814 (D) distribution of Stephen's estate; I, Mary, who m. Ebeneezer Lockwood; 2, Elizabeth, wife of Enos Knapp of Old Greenwich; 3, Olivef, who m. 2d, Polly, dau. of Nathaniel Mills; 4, Stephen Jr, who m. 4 Apr. 1828, Sally Ann Weed; and 5, Henry (E) who, according to Judge Finch's notes, was b. cir. 1789, m. Susan (F) and had 5 sons: I, Rufus, who m, a scofield girl, and had 1 son, Harry; 2 Alanson; 3, George; 4, Charles Henry (G); and 5, Sylvester, who m. but left no issue, but had anadopted son, George W. Lockwood of Long Ridge.
