# FOREWORD

## AN EXPLANATION

---

In 1914, the late Howard Marston of Boston employed me to do some genealogical research for him. During the progress of the commission he became interested in the English progenitors of his race and asked me if I could do any English work on his Marston line. It being already known from a shipping list that the Marstons came from Ormesby, Norfolk, or its vicinity, I told him that it would probably not be difficult to learn more of them. At this time, Mr. J. Gardner Bartlett being in England I asked him to investigate the matter for me. He did considerable work on the family and rendered his final account to me in March 1916, which I then handed to Mr. Marston.

After Mr. Bartlett's return to this country, he advertised his English discoveries in the *Boston Transcript*, for some reason including the Marston work. A gentleman of the name in New York seeing this wished to purchase it as he was engaged in getting out a new genealogy of the Marston family. Mr. Bartlett spoke to me about the matter saying that if the man was going to publish a genealogy of the family it was better to have it begin with the new English ancestry. At the time, Mr. Howard Marston was discussing with me the advisability of printing the material in the *New England Historical and Genealogical Register* but on my explaining the situation to him, he very generously gave me the whole material to handle as I saw fit, stipulating only that it should not be tied up indefinitely as he wished the family to have it and that he should have a copy of the book when published. In this way, through Mr. Bartlett, I sold the rights to publish the material to Mr. Marston in New York on the understanding that his rights expired if it were not published within a year. Our entrance into the war soon followed and he went into service. When the year had elapsed, I did not feel, nor did Mr. Howard Marston, like enforcing the exact terms of the agreement, but that under the circumstance more time should be allowed and so the matter drifted. When another year had passed, I asked Mr. Bartlett to communicate with the New York man at different times and I know that he did so, but obtained no satisfactory reply. Finally Mr. Howard Marston died without seeing the English ancestry which he had secured, printed so that it was accessible to the family. A year ago I again spoke to Mr. Bartlett feeling that Mr. Marston's wishes should be carried out and he said that he thought the New York man was not going to do anything in the matter and that his rights had certainly expired years ago.

In arranging the material for publication, I have printed the data furnished by Mr. Bartlett exactly as sent, with two exceptions, these being the change in some instances of the abbreviation, "b." to "bp." and of "d." to "bur." as English records deal with baptisms and burials and not with births and deaths. The pedigree arranged from the records has been recently done and includes a brief account of the various Marston Immigrants. The compiler wishes to thank Mr. George R. Marvin, expert genealogical editor, for his help in arranging the English records furnished in Mr. Bartlett's reports to her.

The book now goes to press as a tardy act of justice to the late Howard Marston.

Dear Mrs. Holman:—

I enclose results of the second search on Marston, ordered last Autumn.

The work done and ground covered includes:

1. Examination of manuscript calendars of wills in all courts at Norwich from beginning in 1416 to 1661 for Marston wills; results, eight Marston wills found in addition to those previously reported.

2. Abstracts of 7 of above 8 wills. (The earliest will, that of John Marston of Wiveton in the Archdeaconry of Norwich, between 1469 and 1513, was not abstracted;

but this testator was probably not of our line, as Wiveton is in a part of the county remote from Bastwick and Ormesby.)

3. Examination of manuscript calendars of wills in all courts at Norwich from 1600 to 1660 for Salter wills. Result, 20 Salter wills found.

4. All these Salter wills were read in the hope of finding mention of the children of Thomas and Margaret (Salter) Marston of Ormesby who were married in 1610; but none of the testators mentioned any Marstons.

5. A search was made for the court rolls of the manors of Ormesby, and they were found at Yarmouth; but as the earliest preserved begin in 1674, they are too late for our purpose.

6. Examination of some fragments of 16th century court rolls and rental rolls of Ormesby at the Public Record Office, London. Result, a couple of Marston mentions found.

7. Examination of a few fragments of 16th century court rolls of Hemesby preserved at the British Museum, London. Result, no Marston mention found.

8. Examination of all Chancery suits at the Public Record Office, London, 1603-1649, in which Marstons were plaintiffs. Result, 32 Marston suits were found and read, but none of them were of Norfolk.

9. A recent manuscript collection at Norwich of the heraldry in all the churches in Norfolk was examined for Marston arms, but none were found. At Martham is a tomb of a Dr. Thomas Marston who died 30 Jan.

1838, aged 53 years; but it has no arms. As he was a professional man, it is likely he would have used arms if the family were entitled to them. I can find no evidence that the Marstons of Norfolk were armorial.

10. Preparation of material and charting results.

As a result of this work, the pedigree has been carried back to a Thomas Marston born about 1435, thus giving a line back nearly 500 years, with six generations in England, viz: Thomas<sup>1</sup> of Bastwick, b. about 1435; Robert<sup>2</sup> of Bastwick, b. about 1465; Thomas<sup>3</sup> of Bastwick and Ormesby, b. about 1495; Henry<sup>4</sup> of Ormesby, youngest son, b. about 1540; Thomas<sup>5</sup> of Ormesby, third son, b. about 1585; and John<sup>6</sup> of Ormesby, b. about 1616, who emigrated to Salem, Mass. in 1637.

As Thomas<sup>5</sup> and Henry<sup>4</sup> Marston, evidently father and grandfather of the emigrant John<sup>6</sup> Marston, left no wills, and the early registers and manor court rolls of Ormesby are lost, it has been impossible to secure absolute legal proof in England *alone* as to the descent of the American Marston emigrants from Henry<sup>4</sup> Marston of Ormesby; but the evidences that are available in England *plus* the evidences in New England, establish their descent from Henry<sup>4</sup> Marston beyond any doubt, as recapitulated below.

1. The sailing list of the ship *Rose* of Yarmouth, on 11 Apr. 1637, for New England, names John Marston aged 20 years as servant of Mary Moulton of *Ormesby*.

2. A William Marston (b. about 1590) came from Norfolk about 1636 and settled in Hampton, N. H.,

with sons Thomas, b. about 1617, William, b. about 1625, and John, b. about 1627. (There was a large party of emigrants from Ormesby who settled in Hampton, N. H.)

3. A Robert Marston settled early in Hampton, N. H., where he died without issue in 1643, and administration on his estate was given to John Marston and Thomas Marston "for his heir Simon Marston in England." Records in England show that this Robert<sup>6</sup> Marston was born at Hemesby (adjoining Ormesby) in 1608, a younger brother of Simon<sup>6</sup> Marston, and son of Robert<sup>5</sup> and grandson of Henry<sup>4</sup> Marston. Thomas Marston, one administrator, was certainly the son of William of Hampton; and John Marston, the other administrator, was certainly John of Salem, b. 1616 (as John of Hampton, son of William, was in 1643 a lad of only 16 years.) It is evident these two administrators were own-cousins of the deceased Robert<sup>6</sup> Marston, and as such were his nearest kin in New England; and as this Robert<sup>6</sup> Marston is proved by records in England to be son of Robert<sup>5</sup> and grandson of Henry<sup>4</sup> Marston, therefore the father of John<sup>6</sup> Marston of Salem and the father of Thomas<sup>6</sup> Marston of Hampton (*William*<sup>5</sup>) must also have been sons of Henry<sup>4</sup> Marston of Ormesby.

4. Wills in England of his relatives show that Henry<sup>4</sup> Marston of Ormesby had sons Robert<sup>5</sup>, John<sup>5</sup>, and Thomas<sup>5</sup>, and "other children," among whom we must include William<sup>5</sup> of Hampton for reasons given above.



5. While positive proof is lacking that it was Thomas<sup>5</sup> Marston who was father of John<sup>6</sup> and William<sup>6</sup> of Salem, (and Henry<sup>4</sup> Marston may possibly have had some other [unknown] son who was father of John<sup>6</sup> and William<sup>6</sup>), yet we have no evidence of any other unknown son; and as both John<sup>6</sup> and William<sup>6</sup> of Salem each had a son named Thomas<sup>7</sup>, there can be no reasonable doubt that Thomas<sup>5</sup> Marston was the son of Henry<sup>4</sup> Marston who was their father.

To Henry Marston, my son, when 21, 40s. & 40s. each year until £10 is paid—also a mare or else 26s. 8d. for her, when 21.

If any children die, each to be the other's heir.

Residue at executors' disposition for good & comfort of my soul & good deeds, etc.

To Dorothe, my wife, all my lands and tenements in Martham, West Somerton, Potter Heigham, or elsewhere, for term of her natural life, and then to Thomas Marston, my nephew, & his heirs, on condition that he pay these legacies: to each of his sisters 40s., & to each child of Reignolde Watson & Mary, his wife, 20s., to the child<sup>n</sup> of Elizabeth, wife of Bartram Browninge, 10s. each, to the child<sup>n</sup> of Henry Marston 10s. each, & shall also pay to Henry Marston, his uncle, during Henry's life, 13s. 4d. a year—also to W<sup>m</sup> Love, son of Tho<sup>s</sup> Love, 40s., and also to William Roo, son of Rob<sup>t</sup> Roe, £5, & if said W<sup>m</sup> Roe die, then to Brigette Roo, his sister,—also to poor of Martham £5.

If said nephew Thomas should die without issue before he enjoys said lands, etc., then I bequeath them to my nephew Symon Marston & his heirs, on same conditions.

To Alice Allen, my mother, £5.

To Simon Marston, my nephew, £5.

To Tho<sup>s</sup> Ratte, my servant, 40s.

To Dorothy, wife of Robert Roo, a milch cowe "color brindle."

To Margaret Alison, my wife's dau<sup>r</sup>, a milch cow.

To Mary Lynne, my wife's dau<sup>r</sup>, a milch cow.

To each godchild (except Tho<sup>s</sup> Marston & W<sup>m</sup> Love) 12d. each, when 21.

To Robert Russe, servant with M<sup>r</sup> Clippesbie, a bay mare and her "fole."

Robert Folsham, minister of Martham, oweth me 20s., but if he will pay my executrise 10s. at Michaelmas, he shall be quit of the rest.

Residue of goods, etc., to wife Dorothy, sole executrix.

She gave all her moveable goods to Henry Marston, her son, to whom she did deliver them, to carry them home to his house & enjoy them after her death.

Also she gave him a debt of £4 due to her from her son John Goodman, and all her other goods and things she gave to her said son Henry Marston.

To Rebecca, my youngest dau<sup>r</sup>, £100 & a bedstead, featherbed & furniture thereto.

£40 among children of John Brightmer of Cayster, equally, at 21.

To Symon Smyth of Ormesby £20, & to Rich<sup>d</sup> Smyth, his son, £10 at 21, (Mary, wife of s<sup>d</sup> Symon Smyth, my dau<sup>r</sup>).

To s<sup>d</sup> Symon Smyth 5 coombes of seed barley.

To Reginald Watson of Hemesby 40s. & to each of his child<sup>n</sup> 3s. 4d. when 21.

To each of my brother Henry Marston's children at 21, 3s. 4d.

To Edmund Brownyng, son of Bartram Browning of Scrotby, 20s., at 21.

To every child of my sister Browning which she had by her first Husband John Clarke, 3s. 4d., at 21.



To my son Thomas Marston £3 a year until he shall enjoy the land in Martham or Hemsby which he hath in reversion.

To s<sup>d</sup> Thos. & his heirs 4 acres of land in Hemsby field, bought of John Buttolph, now occupied by Reginald Watson. Also to s<sup>d</sup> Tho<sup>s</sup> lands & tenements free & copy hold in Hemsby & Winterton, bought of Adam Goodwyn of Hemsby, on death of s<sup>d</sup> Adam & Alice, his wife.

When my son Tho<sup>s</sup> shall come to enjoy the lands in Martham bequeathed to him by the will of my brother William Marston, then my executor to pay him £30 to discharge the legacies in said William's will.

To John Gree of Ormesby £4, & W<sup>m</sup> & Ann, his child<sup>n</sup>, 20s. each, at 21.

To son Tho<sup>s</sup> Marsten, posted bed and featherbed & things belonging to same, silver spoon, black grey colt 4 years old, brass pott, kettle & pewter platters.

To child<sup>n</sup> of Henry Merston, late of Ormesby (Robert Merston excepted) 3s. 4d. each, at 21.

To Margrett, my wife, over & above the profits of lands assured to her upon marriage, £5 a year for life, she making no claim on other lands.

To said wife 2 geldings & 2 milch neat, & half my linen to be divided between her & Symon Brightmer by John Brightmer & Roger Lomax, except a table cloth & 6 napkins which I bought in Fraunce & 2 pair of sheets for my great posted bed & the featherbed to same & the best covering, pair of blanketts, 2 doune pillowes with the pillowbicres, best framed table & livery cupboard & a square table in the parlour—all to her for life, she dwelling in Ormesby, & on her decease to Symon Brightmer & his heirs with said great posted bed and featherbed.

To said wife half my household stuff and all her body linen and woollen. To her my still with such wool & hemp as may be in her custody.

To said wife 5 coombs malt & 5 coombes wheat & also a chalder of coals & half a hundred of wood yearly for her life, & half my swine and all my pullery.

To children of said wife, Edward, Ann, & Suzanne, £5 each.

To each child of John Yonges, my bro<sup>r</sup>-in-law, 6s. 8d. (Margaret Yonges excepted).

To Margaret Younges, my goddau<sup>r</sup>, 20s.

To child<sup>n</sup> of John Gree, late of Scrotby, 10s. each, at 21.

My executors to hold lands for 7 years to pay legacies, etc. (most are paid at intervals) except such as are to be paid by Symon Brightmer as hereafter set out, & such legacies as I ought to pay by the wills of John Merston & John Goose.

To Rich<sup>d</sup> Smyth, son of Symon Smith w<sup>h</sup> he had by my sister Mary, £5 at 21.

To each godchild (Symon Brightmer, Tho<sup>s</sup> Smyth & Margaret Youngs excepted), 3s. 4d., at 21.

To Roger Lomax, for use of James, John, & Mary, his children, 20s.

### TRANSCRIPTS.

Ormesby St. Margaret is in Flegg Hundred of co. Norfolk, and there are about 23 other parishes in the Hundred, around about Ormesby, of which register transcripts are preserved, each for about the same ten years as for Ormesby St. Margaret. These parishes are: Ormesby St. Michael, Rollisby, Filby, Winkerton, E. Somerton, W. Somerton, Burgh St. Margaret, Burgh St. Mary, Caister, Ashby, Oby, Thirne, Repps, Bastwick, Clippesby, Billockby, Thrigby, Stokesby, Herringby, Mautby, Runham, Martham, and Hemesby. The transcripts existing were examined for all of these 23 parishes, but no Marston item was found in any of them except in Martham and Hemesby; and later the original complete registers of these two parishes were examined from their beginnings in 1558 to as late as 1650, the results of which I give.

**1 THOMAS MARSTON** of Bastwick, co. Norfolk, Eng., born about 1435, died before 1507, is called "father" in will of Thomas Marston of Bastwick in 1507.

Children, at least:

**2 ROBERT MARSTON** (*Thomas*), born probably in Bastwick, Norfolk, Eng., about 1465, died there in 1514. He married about 1490, Margaret — who died after Dec. 1514.

Robert Marston is called "brother" by Thomas Marston, the testator of 1507, who also speaks of his nephews, Robert and William Marston and his niece Margery Marston, and of Thomas Marston, undoubtedly also his "nevy."

**3 THOMAS MARSTON** (*Robert, Thomas*), born probably in Bastwick about 1495, died in Ormesby, parish of St. Margaret, Norfolk, between 17 Apr. 1548 and 27 Mar. 1549. He married about 1525, Alice —, who died between 10 Jan. 1586/7 and 11 July 1587. She married secondly — Allen.

Thomas Marston of Bastwick, the testator of 1548, moved to Ormesby St. Margaret before 1523, as he appears there in a subsidy of that year and in one of 1545. Alice his wife is called, "mother Alice Allen," by their son William in 1583. She, "Alce Allen *alias* Marston, widow," had a nuncupative will.

4 JOHN MARSTON (*Thomas, Robert, Thomas*), born probably in Ormesby St. Margaret, Norfolk, about 1525, died there between 6 Jan. 1588–9 and 15 Apr. 1589. He married about 1556, Lettice —, who survived him.

Children, probably born in Ormesby or Hemesby:

Henry Marston was the chief heir of his mother, Alice (—) (Marston) Allen in 1586–7. Both he and his son, Robert, are mentioned in the will of Simon Marston in 1603, and there is no doubt that he was father of the rest of the children credited to him.

Thomas Marston is mentioned in a subsidy of Martham in 1597. His children were all minors when

he made his will. His wife and William were to have the lands in Martham and Hemesby and, in 1619, a court roll of Martham shows that William "took up" the lands on the death of the said Mary at a court held 29 Dec. 1617. Thomas Marston is mentioned in the wills of his father, John, and his brother, Simon, being called "late of Martham" in the latter's will in 1603.

Children, all born in Hemesby and Martham, Norfolk:

At a court held at Hampton 8 Oct. 1672, Sabina Marston, executrix of her husband William Marston, Sr., reserved her right of dower. She was given the use of the estate until the child to whom it was willed was eighteen years of age or married with her mother's consent.

**10 ROBERT MARSTON** (*Robert, Henry, Thomas, Robert, Thomas*), baptised in Ormesby St. Margaret, 18 Sept. 1608 (transcript), died in Hampton, N. H., in 1643. He apparently never married.

John Marston and Thomas Marston were appointed administrators of the estate of Robert Marston, for the heirs who were in England. (Court held at Salem, 28 Dec. 1643. Essex Court Files, 1: 57). The records of Hampton state that his heir "Symment" Marston sold

his lots. John and Thomas Marston were cousins of Robert; John being the son of his uncle Thomas, and Thomas the son of his uncle William. Simon, his heir, was his only brother.

**11 JOHN MARSTON** (*Thomas, Henry, Thomas, Robert, Thomas*), born probably in Ormesby St. Margaret about 1616, deposed, aged about 50, in 1666, about 57, in 1673, died in Salem, Mass., 19 Dec. 1681. He married 4 Aug. 1640, Alice — (supposed to have been Alice Eden, a fellow-passenger), who survived.

On 11 Apr. 1637, John Marston, aged 20, passed his examination to go to New England. He settled at Salem, Mass. He was one of the administrators of his cousin Robert Marston of Hampton, N. H.

He left so imperfect a will that the Court would not accept it but appointed his son John as administrator.

"I John Merstone senier, being sicke and weake in body, am willing to set my house in order; and as for my outward substance I am willing amd do heareby give unto my wife all my whole estate for her lifetime; except my sonne John Merstone 2d. & y<sup>e</sup> rest of my children twelf pence apeece; I do also make my sones John Merstone & Manasseh Merstone my joynt exsecitors for all my house & land unsold; and for my sonne Benjemen I do give him five pounds att my wives decease, if their be so much left . . . and for the movebls to be given to my two daughters, Sarah & Abigail as my wife see convenient. This is John Merstons last will and testament

12 WILLIAM MARSTON (*Thomas, Henry, Thomas, Robert, Thomas*), born probably in Ormesby St. Margaret about 1622, deposed in Salem Court, 2 July 1674, aged about 52 years, died after 1686. He married about 1650, Sarah —, who died after 1686.

He probably came to the colony after his brother John and was made Freeman in Salem, 23 May 1666. He left no will, and no administration was taken on his estate. The deaths of himself and his wife are not recorded. The last mention found of him is in a mortgage deed to John Marston, Sr., of Salem, in 1685–6.



His son Thomas was a mariner and in his will, 14 Oct. 1700, left a bequest to his brother William, if living and his sisters Hannah and Deliverance, mentioning also, his own son Thomas, his daughter Elizabeth, his wife Elizabeth and his cousin, Manasseh Marston (*Essex Co., Probate*). This son Thomas is the only child whose birth or baptism is not recorded.
