AN OLD TIME VETERAN

"Henry Brady, of Warren township well merits the title of this article. He is certainly one of the oldest, and for his age, one of the most active citizens of the county and I have thought that a brief sketch of his life would not be uninteresting to your readers.

He was born near Chambersburg,Pa., on the 16th of Sept.1794. His father, who was acting sheriff of Franklin Co. was suddenly taken sick while attending to his duties in the Court House and died before he could be removed to his home, leaving a widow and young Henry, a baby 2 months old. His mother eventually took a second husband, John McLaughlin and in 1804 the family crossed the mountains and settled near Geneva,Pa., on the Monongahela river. In 1807 they came further west and located near Zanesville,Ohio. Here Henry's boyhood was passed and in 1813, filled with a desire for martial glory he enlisted and became a member of Capt.Cairn's company in the 27th Regiment U.S.infantry.....

In 1819 he was married to Miss Hannah Dunn and in 1820 the young couple came to Ind. and settled near Brownstown,Jackson Co. where he taught school during the winter seasons. In 1823 he removed with his wife to Marion Co.& stopped for awhile with Mr.Zenas Kimberly, south of the city & afterwards occupied a cabin built by Mr. Bland. In 1823

he located 160 acres of land in Marion Co. the same being a part of the land on which he has ever since resided. The Land Office was in Brookville and he made the trip on foot and arriving there one evening when the office was closed and not having more than enough money to enter the land, he was compelled to sleep in a hay-mow. The next morning he entered the land and started for home on foot and on the way to the land he had entered he only passed 14 houses on the Brookville Rd. For many years he kept a sort of Wayside Inn, entertaining travellers constantly and occasionally distinguished guests. In 1831 he was elected for the first time to the House of Representatives. In 1834 and 1837 he was made State Senator."

The McLaughlins and the Kimberlys were neighbors or friends near Zanesville, Ohio and James McLaughlin came to Indianapolis, either with his half-brother Henry Brady or a bit earlier with the Kimberlys, to do what farming was needed on the Kimberly land.

"In the name of God Amen I John McLaughlin of Highland Co. in the State of Ohio being weak in body but of sound and disposing mind & understanding considering the certainty of death and the uncertainty of the time thereof - and being desirous to settle my worldly affairs & thereby be the better prepared to leave this world when it shall please God to call me hence do therefore make and publish this my last will & testament in manner & form following: that is to say - First & particularly I commit my soul into the hands of Almighty God & my body to the earth to be decently buried at the discretion of my Executors herein after named & after my debts & funeral expenses are paid -

I give and bequeath unto Henry Brady my step-son one hundred dollars as promised him by letter some time ago to be paid out of the first money- I give and bequeath unto my oldest son James McLaughlin heirs the sum of two hundred dollars to be equally divided among'st them to be paid out of the last money- I give and bequeath unto my son John McLaughlin my second son the sum of three hundred dollars to be paid out of the first money- I give and bequeath unto Asa McLaughlin my third son the sum of three hundred dollars to be paid out of the first money- I give and bequeath unto Alexander McLaughlin my fourth son the sum of three hundred dollars to be paid out of the first money- I give and bequeath unto my daughter Susannah Phillips the wife of Leven Phillips one hundred & fifty dollars to be paid out of the last money- I give and bequeath unto my second daughter Ruth Kent the wife of William Kent the sum of one hundred and fifty dollars to be paid out of the last moneys- I give and bequeath unto my third daughter Elizabeth Dickey the wife of Jesse Dickey the sum of one hundred & fifty dollars to be paid out of the last moneys.

I devise and bequeath all the rest and residue of my estate both real and personal to be equally divided among my sons John McLaughlin, Asa McLaughlin, & Alexander McLaughlin in equal proportions share and share alike & lastly I do hereby constitute & appoint my son Alexander McLaughlin & Jesse Dickey my son in law to be sole Executors of this my last will & testament & notifying & confirming this and none other to be my last will & testament In testimony whereof I John McLaughlin have to this my will set my hand and seal this eleventh day of June in the year of our Lord One Thousand Eight hundred and Thirty-nine:-

With the above will are papers of John McLaughlin, at Court House, Hillsboro, O., showing his signature in a good steady hand. His land consisted of 316 acres bought in 1829, 1830 & 1831, some in Highland Co. & some in Adams Co. These two counties join boundaries part of the way, Concord twp. being on the line and Brush Creek running southeast from Concord to Meigs twp. Adams Co. where Susannah lived in 1830, 1840 & 1850 census, & perhaps much later.

There was a JOHN McLAUGHLIN, Revolutionary pensioner who lived in Meigs twp. Adams Co. & died there in 1836. It would seem that there must be some connection between the two Johns, not only because he was in the same twp. & Co. with Susannah Phillips but also because his pension papers show several names that are also shown in the papers of John of Highland Co.

Especially the John T. Wilson name is used by both. He was paid, as attorney the last amount of the pension in 1836 & also in the other John's papers, were notes to him for various amounts. Then, too, in the pension, mention is made of Capt. Brady & also of the Pattersons & John Hunter. John Hunter was a buyer at the sale of farm & home articles following the death of John of Highland, while part of the land bought by our John was from a Patterson. No will exists of the pensioner. A fire in the Ct. Hse. in Adams Co. may be the reason. This John did not write his name, used his mark.

S 9009 - Adams Co. Ohio, Aug. 1, 1834, aged 73 yrs. resident of Meigs twp.
Volunteered Aug. 1778, Capt. Swearingen, Col. John Stinson, Gens. Wm. Crawford & McIntosh. Next, 1779 abt. March 1, same officers.
Resided Washington Co. Pa., marched down the River and assisted in the building of Ft. McIntosh. Marched to Tuscarawas ~~XXXX~~ and had a skirmish with the Indians. While there, built a stockade fort afterwards known as Tuscarawas Fort. In Nov. 1778 returned to Ft. McIntosh, winter quarters. Was discharged in Dec. Again entered service in spring of 17 under Capt. Sam'l. Cunningham, Col. Thos. Patterson, Gen. Marshall (then Lt.) 1st. Co. 1st. Va. Regt. Again enlisted under same officers 1 mo. While assisting in building a block house at Yellow ~~XXXXXX~~ Creek, smashed the ankle joint of his leg in so much that he has never got it healed yet & still continues lame in consequence thereof. He afterward served as an Indian spy under Capt. Brady & scouted along the Ohio River. In 1792, spring, Vol'd. under Capt. Davis, Gen. Wilkerson and in 1793 Gen. Wayne took command and was discharged by him in 1795.

Was born 1760 Lancaster Co. Pa. Has no record as all books and papers were destroyed by fire with his house. Since the war has lived in Ky. and Ohio. Received discharges from Gen. Wm. Crawford and Col. Stinson for 6 months service. Refers to James Spurgeon, Ralph Wilson, Cornelius Patterson, Joel Smith, Reuben Smith and John Hunter who can attest to his veracity, etc. Rev. Stephen Clark and Joel Smith depose acquaintance.

The above John McL. half brother of James, was with or near Henry Brady, his half brother. Later the family went to Ill. His 2 sons, Jas. W. & John B. were to gether in Company G, 89th. Ill. Vol. Cavalry in Civil War. Jas. W. died in 1895, June 23, at Valverde, Cal. John B. who lived at 126 Silver St. Galesburg, Ill. Feb. 21, 1907, died Feb. 24, 1911.

JAMES McLAUGHLIN and Henry Brady came to Marion Co. when Indianapolis was made the capital of the State. James patented 80 acres of land in Oct. of 1824 in Perry twp. & in 1831 added 24 more acres. He was a farmer. The little farm was near Pleasant Run & the men of the neighborhood had to clear the forest to make space for their crops. They rolled the logs to the Run to send them down to the larger streams. At a log-rolling James lifted a too heavy log and soon after died of "quick consumption". There were 7 children, all born on the farm.-

To my beloved daughter Ann McLaughlin I give and bequeath 100 lbs. specie, to be paid to her by my executors in 4 annual payments, also her first choice of one cow from my flock. To my affectionate grandson Alexander Mairs, I give and bequeath my young mare or in lieu thereof the sum of 50 lbs. specie to be paid by my executors in 2 annual payments. To my grandson John McLaughlin, son of my daughter Ann, I give and bequeath 50 lbs. specie, to be paid by my executors in 2 annual payments. To my beloved daughter Elizabeth Mairs, I give and bequeath all that plantation on which I now live including a survey of 50 acres made by virtue of a warrant in the name of Abraham Gabell, also all my other property of every kind after my funeral charges, the before mentioned legacies and just debts of every kind are paid. I do hereby appoint Dr. Robert Johnston & Capt. Abraham Prather executors of this my last will and testament and do revoke all other wills by me heretofore made. In witness whereof I have hereunto set my hand and seal this 10th day of May in the year of our Lord one thousand seven hundred and ninety-six.

We draw the conclusion that the above SIMON was the father of our American line, from the fact that Rupp has listed but one Philip Drum and he arrived in 1738 and was 36 years of age, so could not have been a son to Simon.

According to the tombstone inscription at the grave of our Philip Drum, he was born in 1721, so in 1739 when Simon Drum arrived he was 18 years of age, so it seems most probable that Philip came with his father SIMON. The two names have occurred many times in the later generations.

....

In the Easton Public Library, Easton, Pa. is an article to "Free Press" by Ethan A. Weaver, June 1901, about the DRUM family of Northampton & Westmoreland Cos. The following is copied from it. "In that honor roll of patriots of the Revolution, constituting the first Committee of Observation or Safety of Northampton Co., appears the name of Philip Drum, who was the representative on that committee from Moore twp. This committee was elected at a meeting of Freeholders and Freemen of the county held in the old Court House on Dec. 21, 1774, conformable to the Ass'n. of the Continental Congress and during the war for Independence was engaged in devising means & raising troops in support of the cause." A State D.A.R. marker was placed on his grave by Liberty Bell Chapter, of Allentown, Pa. in recognition of his services.

This Philip Drum and his wife are buried in the churchyard adjoining the "Stone Church", Zion's Ev. Luth. Congregation at Kreidersville, Pa., and their graves are still in good condition and the stones well-preserved. On them the name is spelled "Drummin", and her given name is "Janche". It is from here that we get the dates of their births and deaths. The pastor found in the lists of communicants the following spellings of her name. In 1777 it was spelled Johannette, in 1781 (spring) Janchen, Nov. 1781, Johanizin, in May 1782, Jona, and in April 1783, Jean, Sept. 1783 Jean, in 1785 Janchen, in 1788 Janica. The inscriptions are in German.

"In the Name of God Amen, I, Philip Drumm of Moor twp. in the Co. of Northampton and Commonwealth of Pa., Yeoman being of sound mind and memory & judgment, thru the Mercy & Goodness of God, do make this my last will & Testament as follows viz: First I do order all my just & lawful Debts & also the Expences of my funeral (which I desire may be as moderate as decency will permit) to be honorably paid & discharged by my Executor hereinafter mentioned. And I do hereby give & bequeath unto my beloved wife Jonahan All my Plantation & land whatsoever with the appurtenances Situate in the Co. of Northampton to hold to her the said Jonahan for & during the Term of her natural life or widowhood & also her choice of two of my cows, two sheep two iron Potts one copper Kettle one dozen of Pewter plates one doz. spoons Six Knives & six Forks One of my Cupboards & a Bed & furniture. But if she the said Jonahan should choose to marry then & in that case My Executor hereinafter named shall Rent out my Plantation & land & pay to her yearly & every year during her natural life One third part of the yearly Rent thereof.

I will & Order my Executor hereinafter named as soon as my funeral charges are paid to divide the overplus of the cash that shall be in the house among my seven children namely Philip Drum, Simon Drum, John Yost Drum & Catherine the wife of Henry Strause, Elizabeth the wife of Philip Swartz, Anna Maria the wife of Bartle Lawfer & Mary Angle the wife of Ludwig Bartholomew, equally share & share alike. I will & order my Executor hereinafter named as soon as convenient after my decease to dispose of all my personal Estate except what is reserved for my wife Jonahan at public auction that after all my just debts & funeral expences are paid I order that the money arising out of the sale thereof be equally divided among my seven children above named within one year after my decease. Also I will & order that after the decease of my beloved wife the several Articles I have given her together with my Plantation & all my land whatsoever & wheresoever shall be sold by my Executors hereinafter named for the best price that can be reasonably gotten for the same that out of the money arising from the sale of my land I give & bequeath to George Snyder (formerly married to my daughter Catherine deceased) one English shilling, that the residue of money arising from my whole Estate shall be equally divided among my Seven children share & share alike namely, Philip Drumm, Simon Drumm, John Yost Drumm, Catherine the wife of Henry Strouse, Elizabeth the wife of Philip Swartz, Anna Maria the wife of Bartle Lawfer & Mary Angle the wife of Ludwig Bartholomew, charging each of my children with the several sums of money charged to them respectively in my accounts against them. And the better to enable my Executor hereinafter named to make sale of my lands I do hereby empower him to make execute, acknowledge & deliver to the purchaser or purchasers a good & sufficient Deed or Deeds of Conveyance or Conveyances to hold to them the Purchaser or Purchasers their Heirs & Assigns forever. And lastly I do hereby nominate & appoint my son-in-law Henry Strause to be the sole Executor of this my last will & testament hereby revoking all others by me heretofore made & declaring this only as & for my last Will & Testament. In Witness whereof I the said Philip Drumm have hereunto set my hand & seal this Thirtieth day of September in the Year of our Lord One thousand seven hundred & eighty-eight.

THE SON, PHILIP DRUM

PENSION BUREAU-Revo. & 1812 Wars Section-

I have to advise you from the papers in the Revolutionary War pension Claim, S.22218, it appears that PHILIP DRUM was born in Moore twp. Northampton Co.Pa.

He enlisted in Northampton Co.Pa. in June 1776, served 6 months as private in Capt.Nicholas Kern's Company of Infantry, Colonel's Peter Kichlein's & Hand's Pa. Reg.; & was part of the Flying Camp in the battle of Long Island, Aug. 27, 1776. While a resident of Westmoreland Co.Pa. he enlisted in Feb. 1778 and served one month as private in Capt. Christopher Truby's Company,

Col. Perry's Pa.Reg., he went on an expedition against the Indians. He enlisted in Dec. 1778 & served more than one month as private in Capt. John Cribb's Co., Col. Smith's Pa. Reg; he went on an expedition against the Indians.

He was allowed pension on his application executed Feb. 26, 1833, at which time he was 81 years of age & a resident of Franklin twp. Westmoreland Co.Pa. The soldier died in 1845 and his wife, her name not stated, died prior to that date. In 1857 the children, no names stated, were all of age.

There is no further family data on file and the above noted is the only PHILIP DRUM who served with the Pa. troops found on the Revolutionary War records of this Bureau.

The above Simon Drum who brought the suit was son of Simon who was son of above Philip Drum & sister of Isabella Kimberly. He and one sister, Julia Drum McLaughlin remained in Pa. when in the 50s their mother, who had been Martha Carlin & their sisters, Kate, wife of John Eagle, Mary Drum Brown, Elizabeth Drum Barr, Martha Drum Spratt, Nettie Drum (hunchback), Eliza Drum Tarleton, afterwards Kurtz, came to settle in Indianapolis, Ind.

The Simon Drum who was the grandson of Philip of the Revolution, was mayor of Allegheny, Pa. at one time. He had two daughters, Mrs. Julia Drum Lustenberger, Pittsburgh, and Mrs. St. John also of Pittsburgh.

A John Drum whose wife was Sarah Ann Long, is supposed by his descendants to be a son of Philip of the Revolution. Bruce D. Millar of Pittsburgh, Pa. is a descendant.

Elizabeth, wife of Richard Lanning or Lenning was a daughter of Philip of the Revolution.

Item. - I give & bequeath to my eldest Son Jacob Erb a certain Plantation & tract of land situate in Moore twp. being his dwelling Plantation bounded by Nicholas Miltenberger land & land late John Ritters. My other land & land late Frederick Becks millroad to Easton road thence southerly along Easton road to the line between the said Plantation & my other land that I purchased from John Grove thence along said line to the place of beginning computed to contain 62 acres be the same more or less. Also part of one other tract of land not yet patented lying in said twp. bounded by land late of George Jacoby, Peter Buntie & by George Palmer's Land to be surveyed off from the West end of the aforesaid tract about the quantity of 45 acres as the same is set forth in an article between my son Jacob and me dated the 15th day of Jan. 1784. To hold to him my son Jacob his Heirs & Assigns forever Under & subject to the Payments mentioned in said article which 2 tracts of land shall be his full share of all my Estate.

Item. - I give & bequeath to my beloved Cousin Elizabeth Hoy, the sum of 25 lbs. to be paid to her one year after my decease & also the following articles to be delivered to her Immediately after my decease viz; One cow, my case of drawers or desk with glass doors, her choice of a Bed Bedstead & bed clothes, 6 pewter plates, 6 spoons, an iron pot, one iron kettle valued at 25 shillings, one frying pan one washing tub, two pails & my late wife's Side Saddle & spinning Wheel. My Will & desire is that my Executor hereinafter named get as soon as convenient the House & 10 acres of land appraised where my son Michael now lives the land to be laid out on the East side of Easton Road & the south side of Becks mill road by 3 men Indifferently chosen & also 6 acres & $\frac{3}{4}$ of ground which I purchased from Frederick Gutekunst & that he my son Michael shall have his choice to keep the aforesaid Premises at the appraisement. That all the residue of my Estate both real & personal be sold by my Executor hereinafter mentioned at Public Vendue for the best price that can be reasonable got for the same within 2 Monthafter my decease & also the aforesaid land if my son Michael should not choose to take it at the appraisement & that out of the sale or full value of all the residue of my Estate after my Debts & funeral Charges are paid I will & order my Executor between my 4 children namely - Laurence Erb, Michael Erb, Margaret the wife of Philip Drumm & Elizabeth the wife of David Blackley share & share alike always reckoning to Michael the aforesaid appraisement if he chooses to take the premises aforesaid & also accounting & reckoning to each of the aforesaid children with the several sums that each stand charged with to me in my accounts or by bond note or otherwise. And the better to enable my Executor hereinafter named to make sale of my lands or any part thereof I do hereby empower & fully authorize him to make execute acknowledge & deliver a good & sufficient Deed or Deeds to the purchaser or purchasers & also to my son Michael for the aforesaid 2 Lotts if he takes them at the appraisement. And lastly I do hereby appoint & constitute my well beloved Brother-in-law Peter Seip to be the sole Executor of this my last will & testament.....In witness whereof I have set my hand & seal this 29th day of Apr. in the yr. of our Lord 1788.

They were married Mch. 16, 1755 & had 9 children all of whom came to Cleveland, Ohio between 1803 & 1820. No connection with Jordans, unless members of the same church.

James Jordan was born early in Aug. 1759 or 60, in Mill Creek Hundred, New Castle Co. Delaware. While he was still a child, his parents moved to Morristown, Morris Co. East New Jersey where he was reared & lived until he entered the army. His father died before the War. After serving in the army he came back to Morristown, his mother then residing in Chester CO. Pa. who came after him & he went with her to Chester CO. Pa. To Allegheny Co. 1811.

While a resident of Morris Town he enlisted in the fall of 1777, served as private in Capt. Luce's Company, Col. Israel Shreve's N.J. Regiment. They were marched from Valley Forge to Mt. Holly. Retreated from there to Black Horse 10 miles and encamped. Next summer encamped at Quaker meeting-house and British surrounded them in the night. They soon retreated out of the back door to town Crowpicks (?) four miles. Had to retreat into a swamp. Was at the Battle of Monmouth & was discharged after 3 years service."

Soldier married Dec.23,1783 in New Castle Co.Del.,Margaret Armstrong. Apr.17,1849 she appeared, aged 93 & was allowed pension on her application. She was a resident of said Plum twp. She married James Jordan 1783 in New Castle Co.DeI. by a Presbyterian minister named Wm. McKinnan, in whose home the ceremony took place. It was near the line of Chester Co.Pa. They had 3 children born prior to 1794, whose names are John, Ephraim & Margaret. Nancy Armstrong, a resident of Franklin twp. Westmoreland Co. made affidavit that she was the widow of John Armstrong deceased in 1849 & that they lived with the Jordans for 2 years between 1790 & 1794. She was 77 years of age & was married in 1793.

To my beloved wife Margaret I give & bequeath all my chattels, property of every description that may be left after paying my just debts, funeral expenses, administering my estate etc.,& likewise all the rents, issues & profits of my farm on which I reside that may be left after paying taxes, repairs,etc., during his natural life to my grandson, James Jordan (son of my son James) I give & bequeath my farm on which I reside to go to him at the decease of my wife if he should be 21 years of age at that time, if not, when he arrives at the age of 21 years, but in case my grandson James (aforementioned) does not live to have lawful heirs it is my will that my farm goes to my grandson Michael Jordan & if Michael should not live to have lawful heirs, it is my will that my grandson Thomas Jordan heirs my farm & if he should not live to have lawful heirs it is my will that my grandson Ephraim Jordan have my farm (all sons of my son James).

To my son Ephraim I give & bequeath three dollars.

To my son James I give & bequeath three dollars.

To my daughter Margaret Jordan I give & bequeath one hundred dollars to be paid to her by my grandson James aforementioned one year after the decease of my wife.

To my daughter Elizabeth Zimmerman I give & bequeath two hundred dollars to be paid to her by my grandson James aforementioned in 4 equal annual payments the first to be paid 2 years after the decease of my wife, & so on fifty dollars a year until all is paid.

COPY OF WILL OF MARY ANSLEY GOODLIN ROBBINS -

"In the Name of God Amen. I, Mary Robbins (widow) of Hempfield twp. Westmoreland Co. & State of Pa., being old, blind, feeble & in a delicate state of health, but of sound mind, memory & understanding (thanks be to Almighty God for the same) being mindful of my mortality do make & constitute this my last will & testament.

First & principally I commend my immortal spirit to God who gave it in hopes of a Joyful Resurrection & my body to the earth (when it shall please God to separate my Soul & body) my body to be interred decently, at the discretion of my Executors etc. And as to such worldly Estate, wherewith it hath pleased God to bless me with, I give and dispose thereof in the following manner.

First, I will & devise the amt. of a note, the interest thereon, I hold against the Rev. John Ansley, now in the hands of H. Markle, Esq., to the children of my son James Goodlin, deceased, share & share alike, which is to be in full of their share of my estate.

Second, to my dau. Elisabeth Jourdan, I will & devise my best bedstid & bedding that I laid on.

Third, to my dau. Mariah Hayes, I will & devise, 1 bead bedding & bedstid &-
Fourth, to my dau. Juliann Hayes I will & devise 1 feather cover & 1 blue quilt & 1 blanket.

And as to the rest & residue of my personal effects, whatever they may be I allow my Executor to dispose of the same as the law directs, etc. And collect all my outstanding debts dues & demands, whatever they may be.

And out of the first moneys arising from any part thereof pay all my just debts & funeral expenses & allowing my Executor to have suitable grave stones with proper inscriptions thereon set to my grave, as soon as convenient after my decease & the costs & charges of the Stone & erecting the same, is also to be taken out of the first moneys coming into the hands of my Executor.

And as to the rest & residue of my estate, after costs & charges in setting etc. are paid, I allow any balance remaining to be divided into 6 shares equal, one share thereof I devise to my daughter Elisabeth Jourdan & one share to my daughter Polly Shaner & one share to my daughter Juliann Hays & one share to my daughter Mariah Hays & one share to the heirs of my son William Goodlin deceased & one share to my son John Goodlin being the 6 shares, to be share & share alike.

And further it is my will in the event that my son John Goodlin should not want his share, or come for it, in that case, I want his share divided, equal amongst the 5 of my last named heirs, etc.

And further it is my will that the share of my son William Goodlin heirs suffer a deduction of \$95.00, being money he got from me in his life time. I have also given my daughter Mariah Hays \$100.00, for which sum I hold her bill & allow her share to suffer that deduction, etc.

And lastly I nominate & appoint my neighbor George Mechling, Esq., of Hempfield twp. Westmoreland Co. to be my Executor of this my last will & testamt I publish & declare this & none other to be my last will & testament. In witness whereof I have hereunto set my hand & seal the twenty-first day of Feb. in the year of our Lord one thousand eight hundred & fifty-nine.

Although I have gathered much Ansley information the above is all that can be considered conclusive as relating to our line. Some data found is circumstantial evidence but of course may be true too. Mr. Harold Ansley Davidson 's book "Our Ansley Family" claims as the father of our Mary, the John Ansley who lived in Dearborn Co. Ind. for about 20 years.

Also Mrs. Harry Boyd of Greensburg, Pa., a descendant of James Goodlin, son of Mary Ansley Goodlin says that an Elmer Goodlin of Saltsburg, Pa. said some years ago that a Dr. Ansley, now gone, said he was a cousin of his.
