

## Introduction

HE pedigrees, wills and records of the Moss family of Staffordshire and of the various families recently connected by marriage are gathered together in this book to form a permanent record. It is hoped that it may be of some slight interest to the local

social historian and genealogist as well as to the families concerned.

Searches in working out the Moss pedigree, which is completely proved back to Hugh Moss, born c. 1640, were made at a number of parish churches; at the College of Arms; the Public Record Office, London; the Birmingham Probate Registry; the William Salt Library; and at a number of local libraries.

Much time and trouble has been taken in an attempt to prove the parentage of Hugh Moss, c. 1640, and the College of Arms had the search in hand for some time, but without success. There is little doubt that he was the son of Thomas Moss, of Norton Canes, but the parish registers for this district during the Commonwealth period were very badly kept, and two of them—Bushbury and Cannock—were destroyed, hence the difficulty of proof. Also the wills for the vital period 1640-1660 are missing, as also are the various manor rolls of the district.

In view of the fact that Moss is an uncommon name, it is assumed that families of the name living in Staffordshire prior to 1750 are very largely of the same descent.

As there is the possibility of a member of the family wishing to continue the search at some future time, a list of all the records consulted is included here so that he may begin where the writer ended.

## The Family of Moss

EAR Lichfield, in Staffordshire, within the Manor of Shenstone and to the south-west of Shenstone Church, is a place called "The Moss." It is described fully in Shaw's History of Staffordshire, and a picture is given of the mansion situated there. The place derives its name from its marshy situation; the name for bog or marsh in Saxon times being meos, which later became Moss or sometimes Mess or Meece. There is little doubt that the Staffordshire family of Moss received its name from this place. The Windsor Herald of the College of Arms, who undertook the earlier part of the genealogical search, found that a Henry de le Mosse apud le Mosse (1305) and a Robert atte Mosse (1328) were both mentioned in Shenstone Charters. The place in his opinion gave the family its name.

The branch of the family with which this History is principally concerned has lived within ten miles of Shenstone for the last 3-400 years at least; but it is improbable that it lived in the locality continuously since 1300, as some early sixteenth-century records of Shenstone make no mention of the name. Whether the Moss was at one time a Manor and whether the Mosses were ever Lords of the Manor appears to be uncertain, but on page 47, volume II, of Shaw's History of Staffordshire, there is this sentence: "This place the possessor calls the Manor, so do old records and in the collection of Dr. Wilks: his words are 'In the Manor of Shenstone was a Manor called the Manor of the Moss.'" Also in Volume XVII of the Historical Collection of Staffordshire there is the following note: "In the Exchequer Depositions, Hillary No. 5. 44 Eliz. 1602. William Parker of Chesterfield, aet 80, declares he 'doth know a place in Neather Stonnall feyld where a chapple hath sometyme stoode, which is now decayde wherein there hath bin courts kept for the Manor of Mosse.'"

The tradition that the Moss family is descended from the Earls of Warwick is significant in view of the fact that at the time the Mosses lived at Shenstone Moss, the Earls of Warwick were then Lords of the Manor of Shenstone, which came into their hands in 1233.

Occupations run in families to a very marked extent and in the Staffordshire family of Moss the number of yeomen and ecclesiastics is remarkable. The members of the branch whose pedigree is shown facing page 6 have been yeomen for at least 300 years; and another branch who lived at Meece

Hall, near Eccleshall, produced incumbents and yeomen for a long period. It is doubtful whether race or heredity is the dominant factor in the determination of a family tendency to a particular occupation; it appears far more likely to be due to the environment, the father passing his knowledge and his capital in the form of land, stock and implements on to his children. The yeoman for this reason was particularly prone to remain in his ancient groove. The yeoman caste is peculiarly English, forming as it did a large free middle class with connections with the peasantry on the one side and the gentry on the other. They were described thus by Thomas Fuller in the early seventeenth century:—

"The yeomanry is an estate of people almost peculiar to England. France and Italy are like a die which hath no points between sink and ace, nobility and peasantry—. The Yeoman wears russett clothes but makes golden payments having tin in his buttons and silver in his pockets. In his own country he is a main man in Juries. He seldom goes abroad and his credit stretches farther than his travel."

The seventeenth-century middle class lived very simply and in great contrast. to the luxuries of today. The inventories and wills shown in this book indicate a standard of living which we would consider very low nowadays. Also money was scarce, but it had a much higher buying value than it has now: 250 years ago a £1 would buy what £15 to £20 would buy today.

The family does not appear to have distinguished itself in any way: none of its members having taken any notable or notorious part in the nation's history. The name Moss is not numerous either in Staffordshire or elsewhere, but Staffordshire, Lancashire and Cheshire appear to contain more Mosses than the rest of the country. Moss is not an unusual place name in Lancashire and the north of England, and this no doubt accounts for the families of that name in those parts prior to 1700.

The famous head-master of Shrewsbury, Preb. Henry Whitehead Moss, was believed to be connected with the Staffordshire family, but the writer has found no confirmation of this. According to his son the Rev. Claude Beaufort Moss, the family came from Lincoln, and traces its descent from Thomas Moss, of Thorner, *circa* 1730.





- 1. Josiah Mosse, Sheriff of Lichfield, 1671. "Three hanks of Cotton between three billets." This description is vague and heraldically incorrect. See Shaw's *History of Staffordshire*.
- 2. CLEMENT MOSSE. College of Arms, c. 1620. "Ermine, a cross patée sable charged with a bezant."
- 3. EDWARD and ARTHUR MOWSE in com Beds. See Harleian Society Publication Visitation of London, 1633. Arms described fully in Vol. II page 117. (Mowse or Mowsse may not be a variant of Mosse in this instance, but possibly of Mouse or Mous.)

### Pedigree of Howell of Co. Salop.




### Pedigree of Cotton of Penkridge, Co. Stafford




This pedigree is proved back to John Cotton, born 1732. The part prior to this date is tentative, but there can be no reasonable doubt that a close relationship exists between the Cottons of Penkridge prior to 1732 (Cottons were living in Penkridge in 1550) and those after that date. No relationship has been traced between the Penkridge Cottons and the famous Staffordshire family of Cotton, whose pedigree is given in Shaw's History of Staffordshire. It is probable, however, that the families are remotely connected. The tentative part of this pedigree has been worked out from the Parish Registers of St. Michael's, Penkridge. The difficulty in tracing back from 1732 is caused by the large number of people of this name living in Penkridge parish in the 17th and 18th centuries. Also here are no Cotton wills calendared for Penkridge between 1558 and 1729.

### Pedigree of Jones of Mathrafal, Montgomeryshire.



An account of the earlier part of this pedigree was given by Mrs. Jane Jones, of Trefonen Hall in 1884 but it must be pointed out that it has not been proved by the usual searches in parish registers, wills tax papers, etc.

## Pedigree of Warington of Newington, Co. Kent.



This pedigree, originally drawn up in paragraph form by a member of the Warington family, has been worked out from family records and not from parish registers, wills or other official records.
