

# REED FAMILY HISTORY

Origin of the name and early history of the family in England and America.

Ancestry of Duncan Reed, pioneer, and founder of the family branch at New Horton, New Brunswick, and a partial list of his descendants.

# Origin of the Family Name

The name, at present generally spelled as Read, Reed, and Reid, has nad no less than eighteen variations in spelling. It is found, not only in England, where it has been common from the time surnames came into use, and as a clan name before that time, but also in Ireland, Scotland, and countries of Europe. There have been various opinions concerning the origin and meaning of the name. Some believe it denoted a red or ruddy complexion, a characteristic of the race. Others think it was used to denote an occupation, from the Saxon "Raed" - speech, discourse. In Anglo-Saxon England it was compounded as in Ethelred, Reed the Good; Conrad, Reed the Powerful; Eldred, Reed the Elder; Alfred, Reed the Shrewd.

The History of the Reed Family, written by Jacob Whittemore Reed in 1861, states that according to tradition the name was derived from Rhea, a goddess of ancient Greek mythology, and was given to the clan or tribe which had its origin in Phoenicia.

### Early History

About 500 B.C., during the Persian invasion of the Grecian states, the clan fled from Ionia and found their way by sea to Ireland, where they were known as Dalraids. During the following centuries, they over-ran Ireland and about A.D. 180 they crossed to Caledonia, where they scaled Agricola's Wall and put the Romans to flight. They occupied the territory between Agricola's Wall and Hadrian's Wall until the end of Roman occupation of Britain. This tradition is generally borne out by ancient history.

The Reads or Reeds of England were descended from this clan known as Raids, Redes, or Reedhas, living in the vicinity of River Reed, a branch of River Tyne in Redesdale, a part of Northumberland.

# Line of Descent in England

Recorded history of the Reed family of Kent, England, begins with Brianus of Morpeth, on the Emsback River, who was registered as Brianus de Rede, A.D. 1139:

- 1. Brianus de Rede had three sons: Robert de Rede; William, Bishop of Chichester; Thomas of Redydale.
- 2. William had a son, Robert.
- 3. Robert had a son, Galfrinus.
- Galfrinus had three sons: William; Thomas of Redydale; Robert.
- 5. Thomas of Redydale had two sons: Thomas and Edmond.
- 6. Thomas married Christiana De Lapole; they had a son, John.
- 7. John, who was Mayor of Norwich in 1388, had a son, Edward.
- 8. Edward married Isiod Stanley; they had a son, William.
- 9. William, born about 1450, had a son, William, born 1490.

- 10. Sir William Reade married Ann Menis; they had a son, William.
- 11. William, born 1510, married Rebecca Menis; they had a son, Matthew.
- 12. Matthew married Alice Ward; they had a son, William, born 1572.
- 13. William married Lucy Henage; they had two sons: John, born 1598; and William, born 1605. John came to America in 1630. William came to America in 1635 and settled in Weymouth, Massachusetts.

## History of Family in Massachusetts and Connecticut

John Read of Rehoboth, the first of this branch to settle in America, was a son of William and Lucy (Henage) Reade. He was born at Maidstone, County Kent, in 1598, and sailed from London in April 1630, with the Great Fleet of eleven ships accompanying Governor John Winthrop, arriving at Salem, Massachusetts, June 22, 1630. He was recorded in Weymouth in 1637, in Dorchester in 1638, and removed to Braintree, Mass., where he was recorded a Freeman May 13, 1640.

In 1643 or 1644 he joined the company of Reverend Samuel Newman in founding the settlement of Rehoboth. His name is third on the list of estates, according to which the allotments of land were distributed. He was an early member of the Ancient and Honourable Artillery Company and served as Sheriff. He was proprietor of an inn, and was a leading citizen.

He married Sarah Lessie of Blyborough, England, and they had nine sons and four daughters recorded at Rehoboth, besides Josiah, who, according to several authorities, was probably the eldest son.

There was no list of the passengers in the Great Fleet and it is not known if Josiah Read was born in England or America. Nothing is known of his early history, but according to the Genealogical and Family History of the State of Connecticut he was among the early emigrants from Massachusetts who accompanied Governor Winthrop to Connecticut and settled near New London as early as 1652. He was among the original proprietors of home lots in Norwich in 1662, and among those enrolled on a list of accepted inhabitants in 1702.

Josiah merried Grace, daughter of William Holloway, of Marshfield, Mass., in November, 1666. They had eight children, including four sons: Josiah, b. 1668; William, b. 1670; John, b. 1679; Joseph, b. 1681. Josiah, Sr., died July 3, 1717; Grace, his widow, died May 9, 1727.

John Read, b. Aug. 15, 1679, in Norwich, married in January, 1700, Deborah Niles, at Lyme, Conn. They had three sons: John, b. 1705; Jonathan, b. 1707; Samuel, b. 1709. John, Sr., died Apr. 16, 1768.

Samuel, b. Dec. 11, 1709, married Sarah, daughter of John and Sarah Harvey, and had several children, including William,

Samuel, Jr., Ezra, and Duncan. Samuel Read was appointed Lieutenant of the North Lyme Train Band in October, 1749. In 1760 he conveyed away the last of his Lyme real estate and with his family joined the Saybrook colony's migration to Horton, Nova Scotia, where he was allotted land in the Cornwallis Grant. The oldest gravestone at Wolfville, Nova Scotia, is that of Sarah, his wife, who died Feb. 9, 1774, aged 48.

### Founding of Family in New Horton, N.B.

Duncan Reed, founder of the family in New Horton, New Brunswick, born in Lyme, Conn., in 1747, was married, according to parish records of Grand Pre, Sept. 22, 1769, to Jerusha Post, who was born in 1748 at Saybrook, Conn. She was the daughter of Stephen and Elizabeth (Clark) Post, Connecticut colonists to Cornwallis. Stephen Post was a direct descendent of Stephen Post, one of the founders of Hartford, Conn., where his name is on a monument. About 1783 Duncan purchased a tract of land which was part of a grant to Colonel John Burbidge in Shepody, located in what is now Albert County, New Brunswick.

He moved with his family from Horton and founded a new settlement and gave it the name of New Horton. He was a Justice of the Peace, and was known as Squire Reed. He was a man of inflexible character, generous to his children, but afraid of showing partiality. There is a story that when Guilford, his youngest son, went to Granville, Nova Scotia, to bring back his bride, Anne Shaw, he left his house in process of construction two storeys high. His brothers' houses extending along the road for more than a mile were all built only one storey and a half high, so during his absence Duncan ordered the roof of Guilford's new house to be cut down so that it would be the same as the others.

Previous to the end of the last century, a huge willow tree towered above a spring beside the road in New Horton. It was said to have grown from a green willow walking stick brought from Horton, Nova Scotia, by Duncan.

In the old burying ground in New Horton, there still can be seen the gravestones of Duncan Reed, Esq., a native of Connecticut, Mar. 9, 1821, 74 years, and Jerusha, Feb. 17, 1817, a native of Saybrook, Conn.

The descendents of Duncan Reed continued to live in New Horton for three generations, until during the latter part of the nineteenth century they removed to various parts of Canada and the United States. Before that time the name had been spelled as Reed, but since then, for no explained reason, it has generally been spelled as Reid.

At the present time, Roy M. Reid and his family are the only descendents of Duncan Reed remaining in New Horton.

### Wallace Family

- John Wallace, a descendant of Sir William Wallace, famous in Scottish History, was born in Donegal, Ireland, about 1738, and emigrated to Nova Scotia in 1769. He married Catherine Cochrane in 1771. He hired a farm in Norton, N.S., from Joseph Gray, moved to Hopewell, N.B., in 1788, and to Petiteodiac about five years later. He died Jan. 18, 1835, aged 97. Catherine died in 1812, aged 61. There were three sons and seven daughters.
