EXPLANATION.

THE plan of arrangement adopted in the following genealogy is a common one. It is explained as follows:

"The numbers inserted in the parentheses on the left are the numbers of the paragraphs or articles, containing the notice of one entire family. The Roman numbers immediately after, indicate the generation of the family, including the first person named. The descendants are doubly numbered—first in consecutive order, and secondly by each family separately. The figures in brackets after the name, refer back to these numbers of the descendants, indicating the family and connections to which the individual belongs. The numbers inserted in the parentheses on the right, against the name of a child, show the subsequent paragraph or article where a notice of the family of such child may be found."

For the sake of brevity a different arrangement has been adopted in the appendix. The descendants, instead of being doubly numbered, are indicated by Roman letters, and the articles or paragraphs by figures in parentheses.

It was the wish of the compilers to make the Register of the family of William Smith complete, but for want of records, and the failure to receive the requisite information, some blanks occur. They would here express their sense of obligation to those who have rendered assistance in collecting materials, and particularly to William H. Smith, Esq., of St. Louis, Mo., for special aid and encouragement.

GENEALOGY

OF THE

FAMILY OF WILLIAM SMITH.

(1.) I. Robert Smith of Moneymore, county of Londonderry, Ireland, son of James Smith of Ireland, came to this country with a number of families, in the autumn of 1736, and spent the following winter at Lexington, Mass. He was a tanner and brought with him considerable property. Most of the company made a settlement in Lunenburg, Mass. Some of his brothers settled in Virginia. Four children came with him and settled in Peterborough, New Hampshire. He died Jan. 14, 1766, aged 85. His wife was Elizabeth Smith, daughter of James Smith of England, who was the son of James Smith of Scotland. She died at Lunenburg, Sept. 28, 1757, aged 74.

For the character of the first settlers of Peterborough, see the add ss, delivered at the centennial celebration, 1839, by Rev. John H. Morison. "In the year 1759," Mr. Morison says, "there were forty-five or fifty families, from Lunenburg, Mass., Londonderry, N. H., and some immediately from Ireland. They all, however, belonged to the same stock. They came to this country from the north of Ireland, and were usually called Scotch Irish."

The name of the town from which Robert Smith emigrated is variously spelled, Munnihaugh, Moneymar, and Moneymore. An original certificate of church-membership, dated June 24, 1737, has it Moneymore. It is so

spelled on a modern map of Ireland. It is situated in the south-east part of the county of Londonderry, near Lough Neagh.

H., and was distinguished for industry, economy and energy.

His ever active mind and ready talent could draw forth alike the budding powers of childhood, or those of ripened age.—With wisdom, purse or hand, he was ever ready to counsel, aid or direct his fellow men." - (7.) III. JEREMIAH SMITH, [10-6,] LL. D., distinguished from his earliest years by "an intense love of knowledge," began the study of Latin at the age of 12 years, entered Harvard College 1777, about the same time enlisted for two months in the army, and was in the battle of Bennington. After residing two years at Cambridge, he entered Queen's (now Rutger's) College in New Jersey, a year in advance, and graduated 1780. He remained nearly two years undecided what profession to take. began the study of law in Aug. 1782, with Shearjashub Bourne, Barnstable, Mass., being at the same time a private teacher in the family of Brigadier Otis. Remaining a year in Barnstable, he spent the next year in Andover Academy, as assistant instructor to Dr. Pierson. he read law at Salem, Mass., under the direction of William Pynchon, taking charge of a small school of young ladies at the same time. Mr. Smith was admitted to the bar by the Court of Common Pleas, Hillsborough county,

N. H., in the spring of 1786, and almost immediately took his place at the head of the bar. His office was in a chamber of his father's house at Peterborough. employed in the business of the town, held the office of town clerk, and for several years was one of the select-He made great efforts for the improvement of the public schools. Through his influence five new schoolhouses were built in 1791, better teachers were procured, and a lasting impulse given to the cause of education.— During three years, 1788-89-90, Mr. Smith represented the town in the General Court. In Dec. 1790, he was chosen a member of the 2d Congress, and was elected for three more successive terms. In 1797, he removed to Exeter. In July of that year he was appointed U.S. Attorney for the District of New Hampshire, and in the same month resigned his office as member of Congress. In the fall of 1800 he was appointed Judge of Probate for the County of Rockingham, and continued in that office for about two In Feb. 1801, he was appointed a Judge in the U. S. District Court. On the repeal of the Judiciary Law, in March, 1802, his office was abolished, but in May of the same year he was appointed Chief Justice of the Superior Court of Judicature in New Hampshire. In 1809, he was chosen Governor of New Hampshire, but failing of a re-election, he returned to the bar. Under a new Judiciary act in 1813, Mr. Smith was again appointed Chief Justice; but this act was rescinded in 1816, and he returned once more to the practice of law. In 1820, at the age of 61, he withdrew from the active duties of his profession with an ample fortune, the fruit of his own industry and judicious economy. Mr. Smith was a student at the Academies of Andover, Mass. and Exeter, N. H. He began business as a trader

at Peterborough, was active, energetic and enterprising, and commenced manufacturing establishments in the present village of Peterborough. He may justly be regarded as the founder of the village. He was elected a member of Congress in 1813, but resigned his seat after attending the first session and part of the second. He held the office of Postmaster in Peterborough from to
