#### INTRODUCTION

In 1883 my grandfather, the Rev. George C. Street, Canon of the Cathedral of SS. Peter and Paul in Chicago, compiled and had privately printed some notes on our branch of the Street family, together with material on the Lockman family and the Porter family. Being interested in our family affairs I have been collecting information about the family in a somewhat casual fashion for a number of years and not long ago some members of the family suggested that I have my notes mimeographed so that all those who are interested might have copies. This led to more correspondence and more material for my notes, with this book — if it can be dignified by that title — as the result.

The information about the earliest members of the family and the material about the Lockmans and the Porters has been taken from Canon Street's book. In some cases this is indicated by quotation marks, but as I have regarded this book in some degree as a new edition of Canon Street's book, in most cases there is no acknowledgment other than that which I am making here, of the material that I have taken from his book. Some additional information about our family and information about the Street families in the United States has been obtained from "The Street Genealogy" compiled by Mrs. Mary A. Street and published in 1888.

There seem to be four principal families in the United States bearing the name of Street — the descendants of Nicholas Street of New Haven, Connecticut; the Virginia Streets; a Quaker

family living originally in Philadelphia, and our own branch, which goes back to early ancestors in Worcester, England. As far as I know no connection has been established between these four principal families, though the Virginia Streets have Catharine wheels on their coat of arms and so presumably have some remote connection with our family. In addition to these four families, Mrs. Mary Street's genealogy list a number of isolated families and a number of individuals bearing the name of Street who seem to have no connection with any one of the four families.

With regard to the origin of the name, Canon Street says, "The most remote mention of the family name which I have succeeded in discovering, occurs in Domesday Book, in connection with the tenure of certain estates; a circumstance which gives a clue to the rationale of the name. Thus, 'Alice de Street,' or 'Alice le Street,' who is mentioned in that ancient record, was, in all probability, the name given to a lady of that time well known as the owner of property lying somewhere on one of the great roads or streets, constructed during the Roman occupation of the island, such as 'Watling Street'; and this, if it be a correct hypothesis, will readily account for different families of the same name, yet in no way related to each other, and consequently bearing different coats of arms. By the same line of reasoning, it may be assumed that all the various families of the name bearing the Catharine wheels, are more or less remotely connected."

A few words may be in order about the arrangement of the genealogy. It will be noted that as a general rule the name of each member of the family who has a family of his own, appears twice; once in his proper place in the family of which he was a child and

again as head of his own family. The number in front of his name where his name appears in his parents' family makes it possible to find his own family in the next generation, and the number in parenthesis after the name of the head of each family refers back to his mother or his father in the generation before. The first chapter of the book has to do with the early Streets up to William Street (the great grandfather of the generation to which I belong) who was born in 1780 and came to Canada in 1832. As these notes are primarily concerned with the descendants of William Street and Mary Ann Porter, his wife, Chapter II is devoted to her family — the Lockmans and the Porters. Then follows a chapter each for the family of each of eight children of William Street and Mary Ann Porter. The last three chapters have to do with the New Brunswick Streets, the family of Edmund Street, and the Australian branch of the family.

I have made every effort to have the material in this book as accurate as possible. It is incomplete in some places but it has seemed better to have the material mimeographed as it is, rather than to put off publication in the hope of getting more information. In spite of my efforts I know that some errors and omissions will be found and I shall be glad to have any corrections or additions that any members of the family can supply. Many members of the family have been interested in what I have been doing and have been helpful in providing information about the branches of the family to which they belong. Space prevents my mentioning them all, but special thanks should go to Mrs. Hugh Langton of Toronto and Mr. Julian Street of Lakeville, Connecticut, for their help. I believe that this new edition of the "Herd Book" will be

of interest both to the older members of the family whose memories go back to the days when the grandchildren of William Street and Mary Ann Porter were living and kept in touch with each other, and also to the younger members of the family. The younger generations will, I hope, be glad to have this record of the family history and also to learn more about their relations in different parts of the world, many of them unknown to each other, but, as one of our Australian cousins has put it, all "stamped with the hallmark of the three Catharine wheels."

#### CHAPTER ONE

## The Early Streets

The earliest records of our branch of the Street family are to be found in Worcester, England. As far back as the time of Queen Elizabeth the Streets seem to have been a prominent family in that city. The name was spelt Street, Streete or Streete. As Canon Street has it

"A rose by any name will smell as sweet Let it be Street or Streate or Streete."

In 1568, (the 13th year of Queen Elizabeth) Francis Streate and Richard Bellingham were joint members of Parliament for the city of Worcester; in 1658-9 William Collins, Esq. and Thomas Streete, Esq.; in 1660, Thomas Hall and Thomas Streete; in 1661, Sir Rowland Berkeley and Thomas Streete; (Apr. 9, 1661, Sir Rowland Berkeley polled 615 votes; Counsellor Streete, 589, Mr. John Nanson, 544;) in 1678, Sir Francis Winnington and Thomas Street. ———

Rev. Richard Street was rector of Naunton in Worcestershire in 1511, before the Reformation.

Henry Streete held municipal office in Worcester, 1557.

Francis Streate, above mentioned, was a member for the city in 1563, (the 5th year of Queen Elizabeth).

John Streete, probably a son of Francis, held office in the municipality of Worcester, 1610-11, and died, 1622.

John Streete, his nephew, b. 1584, was the John Street who killed two of the Gunpowder Plot conspirators with one shot and for which he received a pension.

Records are lacking to show just where Richard Street and Henry Street come in, but we can trace the family back to Francis Street with some degree of assurance. The genealogy of these early Streets is as follows:-

GEORGE STREET, (2), b. 1594; Mayor of Worcester in 1635; d. Jan.4, 1643, ae. 49; buried in St. Andrews church. On the north side of the chancel was a monument over a large raised tomb, bearing a Latin inscription to his memory and that of his wife, ELIZABETH, probably, ANDREWS, who d. Feb. 7, 1644. The inscription is "Parentibus optimis, Thomas Street, primo genitus in aeternum obsequii pigmis sacravit," freely translated is, "To the best of parents, Thomas Street, their eldest born, has dedicated this token of his devotion." Below are the arms of Street impaling those of Andrews, the name of the wife's family.

THOMAS STREET, (2), d. Nov. 18, 1648; m. ELIZABETH She d. Jan. 12, 1649. On the east wall of the North aisle of St. Andrews church, Worcester, was a monument to himself and his wife, in which they are both represented as kneeling in prayer. Under his figure are six sons, and under hers seven daughters. They had thirteen children. Above him are his arms, gules, 3 Catherine Wheels or, with a Canton Argent. Below the monument is the following inscription:

"Here lieth Thomas Street, Gentleman, He died the 18th day of November 1648."

"Elizabeth Street, his wife departed this life the 12th day of Jan. 1649."

JOHN STREET, (3), b. 1584; d. 1633; m. MARY \_\_\_\_\_. He was the John Street who in 1604 killed two of the Gunpowder Plot conspirators at one shot, for which he was granted a pension by the Crown. "It seems that Sir Richard Walsh, Sheriff of Worcestershire, accompanied by many gentlemen of that part of the country, and a posse comitatus, were in close pursuit of the fleeing conspirators, who hastily fortified themselves in a house called Holbeach, belonging to one of their confederates. Here they were brought to bay by their pursuers; and, in the course of the affray, Gatesby and Percy, who were standing back to back, were shot as above stated. In the State-paper Office, there still exists a warrant for the payment of the arrears of the pension referred to, in the 3d year of the reign of Charles I., which is described to be 'for the extraordinary service performed in killing those two traitors, Piercie and Gatesbie, with two bulletts at one shott out of his muskett."

In his will, dated Nov. 7, 1632, John Street refers to his pension money. He also makes mention in the same document, of his wife, Mary, and of his cousins, "Francis Streate, Esq., and George Streate."

## FOURTH GENERATION

# No. 7

Sir THOMAS STREET, (4), b. 1625, Worcester; d. Mar. 8, 1695. Educated at the University of Oxford. He was held in such high esteem by his fellow citizens that they returned him to four successive Parliaments, dating from 1659. He was called to the bar by the Inner Temple, on Nov. 25, 1653, and rose to the position of bencher in 1669. In 1667 he was appointed a judge of Assize; and the next Michaelmas term, he was honored with the coif. From this he was promoted on Oct. 25, 1678, to be King's Sergeant. April, 1681, he was constituted a Baron of the Exchequer, and he was knighted at Whitehall, June 9, 1681. In Oct., 1684, Sir Thomas Street was removed into the Court of Common Pleas. At the Revolution he retired to his native city, where he died; buried in Worcester Cathedral. M. (1)\_\_\_\_; m. (2) late in life, PENELOPE, dau. and coheiress of Sir Rowland Berkeley, of Cotheridge, in Worcestershire, his colleague in Parliament in 1661. Arthur L. H. Street of Minneapolis has a law book which, he says, "bears authentic evidence of having been owned by Sir. Thomas Street."

From three Streets of the eighth generation, James Wallis and his cousins Samuel Denny and Thomas, come the three main branches of our family. These three branches together with the Australian branch include all the members of the family of whom I have any contemporary record.

James Wallis Street married John Lockman's granddaughter. His son William married Mary Ann Porter, another granddaughter of John Lockman and his mother's first cousin. The William Streets came to Canada in 1832. They had nine children; from them comes our immediate branch of the family.

Samuel Denny Street fought with the British in the Revolutionary War. After the war he settled in New Brunswick. He had twelve children of whom eight had families of their own.

Samuel Denny Street's brother Thomas remained in England. He was the father of George Edmund Street the architect.

This book is mainly concerned with the family of James Wallis Street and his son William. I am including however in the last three chapters such information as I have been able to pick up about the family of Samuel Denny Street, Thomas Street and the Streets in Australia.

#### CHAPTER TWO

# Lockman - Porter - Street

The story of our branch of the Street family is very closely interwoven with that of two other families - the Lockmans and the Porters. The following account of the three families has been taken, with some editing, from the accounts by Canon Street and Margarett Wray in the family book.

# JOHN LOCKMAN

John Lockman was born in the year of our Lord 1698, probably in the village of Petersham, in the county of Surrey, England. Of his early years, no particulars appear to have been recorded. He was a man of such amiable, inoffensive disposition, that the wits of his time gave him the soubriquet of "The Lamb." It is said that the only occasion on which he was ever known to have deviated from the air of gentleness peculiar to that animal, was when Cooke, the translator of Hesiod, abused his poetry to his face. "It may be so," retorted Lockman, "but, thank God! my name does not appear at full length in the 'Dunciad'" — a poem written by Alexander Pope, in which he very severely satirized several of the writers of the day, and Cooke among the number.

He was the author, among other works, of A History of England by Question and Answer, which he dedicated to Arthur Onslow, the

Speaker of the House of Commons; and which, as a school-book, ran through a host of editions. He was also distinguished for some of his translations of epigrams and short pieces from the French of L'Abbe de Chaulieu. Voltaire's Henriade also was translated by Mr. Lockman; and William Oldys, Esq., Norroy King-at-Arms, says in his Diary: "Saw Mr. Lockman. Told me that he had finished his Life of Mr. Samuel Butler, for The General Dictionary....."

The General Dictionary here referred to was a work in ten volumes, folio, published between the years 1734-41; and, upon the share which he bore in its compilation, Mr. Lockman's literary reputation seems mainly to have rested. His various biographers all pay special tribute to his great literary industry. There is a list of his published works in Watts' Bibliotheca Britannica and the biographical notices of him occur in Nichol's Bowyer and in Chalmers' Biographical Dictionary.

One of the great commercial enterprises of the period in which Mr. Lockman lived, was known as "The British Herring Fishery," which was much promoted by the Government of the day, not only for its mercantile uses, but as a nursery or training-school for young sailors, who might thus be prepared for service in the Royal Navy. Mr. Lockman was appointed to the Secretaryship of this Department, and used his leisure, occasionally, by composing some patriotic songs for it. In one of the biographical notices of him, we find the following amusing passage: "Being a man of much literary industry, especially as a translator, he frequently went to Court, to present his poems to the royal family; and, after he became Secretary to the

British Herring Fishery, he tendered, to the same illustrious personages, presents of pickled herrings, together with his small literary ware; all which, both poems and herrings, he took care to inform the public 'were graciously received.'"

Mr. Lockman married Mary Boucher, and the family lived for a long time in Brownlow Street, Long Acre. He died, much lamented, at his house in Brownlow Street, February 2nd, 1771, at the age of 73 years. As illustrating the high estimation in which he was held by those who knew him best, his daughter Kitty, writing a letter to her sister Arabella, in which she describes her future husband — the Rev. Moses Porter, says: "I am sure I need not, neither can I, add anything stronger to recommend him, than the telling you that his disposition is greatly like that of our dear, dear father: the same sympathy with distress, the same universal readiness to oblige."

John Lockman had three daughters:-

- I. Sarah, who married a Mr. Bennett Her daughter, Sarah, married James Wallis Street, "of Abbott's Langley, Hertfordshire and Blackwell Hall Middlesex."
- II. Arabella, who took care of the Porter children after her sister Katherine's death, and never married.
- III. Katherine, who married the Rev. Moses Porter.

The records I have do not give the dates of the births of the three Lockman sisters, but there was sufficient difference in age so that Katherine's children and Sarah's grandchildren were contemporaries.

Mr. James Wallis Street and his wife (Sarah Bennett) lived at Abbott's Langley. The Porter children often visited them there,

and the five Porter children and the eight Street children had many happy days together. The relationship between the two families was a continuing one. A letter written by Richard Porter in 1800, less than two months before his death shows him to have been visiting the cousins at Abbott's Langley at that time.

# MOSES PORTER - KATHERINE LOCKMAN

We now turn our attention to Katherine Lockman and the Porters. Katherine Lockman - Kitty, as she was called - seems to have been a person of rare charm and high spirits. A great friendship existed between Mr. Lockman's family and that of Sir John Fielding, who was a son of the celebrated novelist. There is an old Journal-pocket-book of Katherine Lockman's in which are some entries about one of her visits at Sir John Fielding's. One of these entries is about "working an apron for Mary Ann" — the daughter — who was her friend, and describes where she went with Lady Fielding, etc. It is highly probable that she named her own daughter, "Mary Ann" (afterwards Mrs. William Street) after her friend.

Kitty Lockman used frequently to stay with some family friends at Clapham — Mr. and Mrs. de Vismes. They seem to have been wealthy people, very kind, and well known in the neighborhood. It was here that she met the curate of Clapham Church — "The New Church" as it used to be called in those days. The Rev. Sir James Stonhouse, Baronet, D.D., was the rector, but did not at that time reside in his living; so that the curate — the Rev. Moses Porter — had sole charge. In one of her pocket-book entries, Kitty Lockman referring

to him, writes: "The Parson improves upon acquaintance." Frequent intercourse led to a sincere mutual attachment, and to their marriage in 1771. Their five children were born at Clapham: John Fitzroy, William Warren, Richard Cornewall, Eliza, and Mary Ann. Theirs was a tender and happy union, and their children had a careful Christian education.

The Rev. Moses Porter was a truly earnest pastor, watchful over his flock. There is a little book still to be met with, entitled — Waldo's Guide to the Holy Communion — with a Preface to it which was written by Mr. Porter, and bears his signature. In this he earnestly presses upon his parishioners the duty of a frequent and worthy reception; and tells them, that, in order to help those who find difficulty in regard to time, he has arranged to celebrate Holy Communion at 8 o'clock in the morning, as well as at a later hour.

Katherine Lockman Porter died on December 10, 1788, and was buried at Walcott Church, in Bath. Moses Porter died within three years — on September 5, 1791. After Katherine's death, Arabella Lockman, the unmarried aunt, devoted herself to the care of the Porter children, and made a very warm place for herself in their hearts.

In order to make the record complete, the following table of descent of Moses Porter is reproduced from the family book.

FRANCIS HARRIS and ALICE STONE were married by Dr. Morley, Bishop of Winchester, at St. Gregory's Chapel, near St. Paul's Cathedral, London, October 19, 1663. They had twelve children, of whom all but Elizabeth, the eldest, were born at Great Missenden, Bucks. Elizabeth was born in St. Margaret's parish, Westminster, on Tuesday, August 30, 1664.

ELIZABETH HARRIS and MOSES PORTER were married at St. Margaret's, Westminster, March 17, 1686. They had six children, of whom the third, Richard, was born February 6, 1691. He was a surgeon in the Royal Navy.

RICHARD PORTER and RACHEL HILLS were married February 24, 1727-8 and had eight children. He died at Gosport, Hants, February 5, 1778. The children of their marriage were as follows.

- I. Richard Porter, b. Nov. 29, 1728 and d. in infancy.
- II. Peter Tropicus Porter, was born on board the H.M.S. Soleby and was baptized at the time, June 6, 1730, by Capt. Matthew Norris, Capt. Peter Warren, Lieut. John Ambrose, and the mother being the sponsors. He died at New York the following year.
- III. Richard Norris Porter, b. at New York, Dec. 26, 1731. He entered the Royal Navy and died at Antigua May 20, 1750.
  - IV. Ann Porter, b. Sept. 22, 1733; d. Oct. 26, 1817. She was buried at Boldre Churchyard, Hants.
  - V. Moses Porter, who married Katherine Lockman, was b. in July 1735 and d. Sept. 5, 1791.
  - VI. Peter Porter, b. Titchfield, Jan. 29, 1736-7. He was killed at the siege of Manilla.
- VII. Gilbert Porter, b. Titchfield, Jan. 1740 and d. in infancy.

The children of Moses Porter and Katherine Lockman were as follows:

- 1. John Fitzroy was born in 1774. He entered the Navy and died at the age of twenty-three on board the "Blenheim" at the time of the victory of Sir John Jervis over the Spanish fleet in 1797.
- 2. William Warren Porter was a Priest of the Church of England and Fellow of St. John's College, Oxford. He was born May 10, 1776 and died of "rapid consumption" June 14, 1804.
- 3. Richard Cornewall Porter, was born in 1778. He entered the Navy when he was still very young. He served under Lord Howe and lost a leg in a battle with the French fleet in 1794. He returned to London and was given a position in the Navy "Victualling Office." He died in Sept. 1880.

children in 1832. It is the story of her descendants that makes up most of this book. She died in Dundas, Canada, in 1864.

Margarett Wray, who collaborated with Canon Street in the preparation of the family book, was a daughter, by a previous marriage, of the Robert Wray who married Eliza Porter. In the family book is to be found the account she wrote for Canon Street of the way Mary Ann Porter Street, his mother, told her of Mr. Wray's marriage to Eliza Porter. She writes -

"One of my earliest and most pleasant remembrances is of being sent on a visit for awhile (no doubt in order that I might be out of the way just then), to the care of your dear mother, at your home in Buckinghamshire; I being at the time about five years old.

"I had happy games with you children in the garden, and happy walks in the Springs days, finding violets on the banks, and in the woods.

"But the thing that so especially impressed me was, that it was at this time (on the 31st of March, 1817) that your mother's sister became my father's second wife. And a most happy and blessed event it was for me and all my family.

"The way in which I heard of it was, that, as I knelt at your mother's knee for my evening prayers, she gently stopped me when I was saying 'Pray, God, bless my dear Papa,' and said, 'But you must pray God to bless your dear Mamma, too!' I looked up wonderingly; and then she told me that Miss Porter was now my new Mamma. I knew Miss Porter well, and loved her very much; and it seemed to me so NATURAL to belong to her, that I received the idea at once, without comprehending how LARGE a circumstance it was.

"I tell you all this concerning myself, because I wish to express my deep value of the event which thus gave me the blessing of such a beloved mother, and which brought your family and ours together; and also, because it has always seemed to me such a sweet trait in YOUR mother's character, that she should have waited to tell me this new thing, till she should teach my child-ish lips to bring it before God in my evening prayer. Since that day, what cause I have had to thank God for it!"

He settled there, naming it Elysian Fields, and was of great service to government in distributing lands He was on military service at Fort Howe in 1781, to new settlers. and there in 1784 established business as Notary Public and Conveyancer, and in 1785 as attorney was admitted to the Court of New Bruns-On the organization of New Brunswick he was appointed Clerk wick. of the Peace and Clerk of the Inferior Court of Common Pleas for Sunbury; also a Master of Chancery. In 1802 he became Clerk of the Samuel Denny Street was thick set, short in stature, wore a House. cue, knee breeches and gaiters. For many years he resided in Fredericton, afterward Sunbury. He died there in 1830, in his 79th year, surviving all the first House and Council, the first Bar and Bench of New Brunswick.

GEORGE EDMUND STREET, b. at Woodford in Essex, 1824; d. Dec. 18,1881; m. MARIQUITA PROCTOR (1830 - 1874), daughter of Robert Proctor, Esq. He obtained his architectural education in the office of Mr. Owen Carter in Winchester, and afterwards worked as an "improver" with Sir Gilbert G. Scott in London. At an early age he became deeply interested in the principles of Gothic architecture, and devoted an unsparing amount of time and labor to studying and sketching the finest examples of mediaeval buildings in England and on the conti-He was a draughtsman of a very high order; his sketches are masterpieces of spirit and brilliant touch. In 1855 he published a very careful and well illustrated work on the brick and marble architecture of Northern Italy, and in 1865 a book on the Gothic architecture of Spain, with very beautiful drawings by his own hand. His personal taste led him in most cases to select for his design the 13th Century Gothic of England or France, his knowledge of which was very great, especially in the skilful use of rich mouldings. By far the majority of buildings erected by him were for ecclesiastical uses, the chief being the Convent of East Grinstead, the theolotical college of Cuddesden, and many churches, such as St. Philip and St. James at Oxford, St. John's at Torquay, All Saints' at Clifton, St. Saviour's at Eastbourne, St. Margaret's at Liverpool, and St. Mary Magdalene at Paddington. His largest works were the nave of Bristol Cathedral, the choir of the cathedral of Christ church in Dublin, and, above all the new Courts of Justice in London, second only in architectural importance (during this century) to the Houses of Parliament. After a prolonged competition he was appointed architect in 1868, but the building was not complete at the time of his death. Much unfair criticism has been lavished on this building; but it should be remembered that he was hampered both by want of a sufficiently large site and by petty economies in money insisted upon by the commissioner of Though perhaps deficient in unity of composition, this great building possesses much grace in its separate parts, and has great refinement of detail throughout. Mr. Street was elected an associate of the Royal Academy in 1866, and R.A. in 1871. At the time of his

death he was professor of history in the Royal Academy, and had just finished a very interesting course of lectures on the development of mediaeval architecture. He was also a member of the Royal Academy of Vienna, and a knight of the Legion of Honor. His sudden death on Dec. 18, 1881, was hastened by overwork and professional worries connected with the erection of the Law Courts. He was buried in Westminster Abbey. On the slab in Westminster is "Fidelis inter perfidos," the Street family motto.

### CHAPTER THIRTEEN

## The Australian Streets

On page 5 of these notes mention is made of Lawrence Street who was born in 1625 and married in 1647. It will be recalled that he had three sons. The name of the eldest is not known. The name of the second son was Lawrence, and from the third son, John, our branch of the family is descended. In the family book Canon Street says about this family, "The Christian name of the eldest son does not appear; but that of his son -- John -is mentioned and that 'he lived at Ripley'. I have no further record of that branch. I may add, however, that happening to visit Brighton, England in the year 1872, I met then a Mr. Henry Street of Guilford; and, upon comparing notes, we came to the conclusion that he was descended from the eldest of the three brothers of whom I have spoken." Mrs. Mary A. Street in the "Street -Genealogy" quotes this passage and says that she was able to find no other record of this branch of the family. It has recently developed, however, that there is a large family of Streets in Aus-Their coat of arms is the same as ours, and correspondence with Kenneth Whistler Street, Judge of the Supreme Court at Sydney, Australia, and K. Leslie Street of Brooklyn, New York, makes it clear that they are descended from the eldest son of Lawrence Street. According to their family records Lawrence Street bought "Birtley" an estate near Bramley, in Surrey about 1687 "in the reign of James II". The details of the next three generations are not entirely clear, but there is no question about the line of descent.

Mr. Justice Street has in his possession a receipt for money collected by "John Street" in 1699. He also has a riding whip, which has been handed down in the family, marked "J. Street, Bramly,

1747".\*

There is more information about Henry Street, the son of the John Street of the riding whip. He had a son John who was born in 1758 and died in 1821 and a daughter who died at the age of 15. John married twice. His first wife was Lucy Duncomb, the daughter of the Rev. Thomas Duncomb, rector of the Shere for 40 years. He is mentioned by John Evelyn in his diarry. John Street and Lucy Duncomb had five children ---

1. John, b. 1780, d. April 13, 1853. His son John was born in 1780 and came out to Australia, arriving in Sydney in 1822. On April 16, 1825 he married Maria Wood Rendall, whom he had met on the boat coming out to Australia. They had seven children.

<sup>\*</sup> NOTE: In order to see how these generations might have gone, K. Leslie Street has worked out the following hypothetical dates --

Lawrence Street's son whose name we don't know,
b. 1648, married 1674.

It is also of interest to note that Bramley, Ripley and Shalford are all close together, within a few miles of Guilford in Surrey.

By Elizabeth Ellis, his second wife, John Street's children were:

- 1. Mary, who married John Bicknell.
- 2. Frances, who married Arthur Row.
- 3. Ann, who married a Mr. Sparker, first name unknown.
- 4. Sophia, who married James Mallock and had two children.
- 5. Ellen, who died unmarried.
- 6. Henry, who married twice. By his second wife, Ruth Parkinson, he had a son Henry William. Henry William married Barbara Layard and they had two sons, Henry Layard and George Campbell. Both these sons were in the navy and lost their lives in the war of 1914-18, one of them in the battle of Jutland. The family estate, Birtley, remained in the family for many years. For some reason that is not clear, John Street left the estate not to his older sons by his first wife, but to Henry, his youngest son by his second wife. The property was sold by Henry William Street in 1879. This must have been the same Henry Street whom Canon Street met at Brighton in 1872.

We go back now to the John Street who emigrated to Australia in 1822. Of his seven children two died in infancy; of the others two sons and two daughters married and had families of their own; another son married but died without issues. It does not seem worth while for the purposes of these notes to take the space that would be required to give details of these families — especially as the Australian Streets are well supplied with genealogists of

their own in the person of Kenneth Whistler Street and K. Leslie Street. A word should perhaps be said however about the family of John Rendell Street, John's third son. John Rendell Street was born in 1832 and died in 1891. He married Susannah Caroline Lawson and had eight children. His second son was Philip Whistler Street (1863-1938). He was judge of the Supreme Court of Sydney, Australia for 18 years and Lieut. Governor from 1930 to the time of his death in 1938. Philip Whistler Street's eldest son, Kenneth Whistler Street, from whom much of this information about the Australian Streets has come, was made a judge of the Supreme Court at the age of 37. This is said to be the only instance in the British Empire of a father swearing in his son and both sitting in the Supreme Court at the same time. His second son, Lawrence Whistler was killed at Gallipoli in 1915. The third son, Ernest Whistler Street is a lawyer practicing in Sydney. Kenneth Whistler Street has two sons and four daughters "from twenty down to twelve" (in 1939) and Ernest Whistler Street has one son and two daughters.

K. Leslie Street, a younger son of John Rendell Street, with whom I have been in correspondence about this branch of the family is now (1941) living in Brooklyn, New York. His address is 649 St. Johns Place.

# Note On The Street Coats Of Arms

The following note on the coats of arms and crests of the different Street families is reprinted from a note in Canon Street's book.

- THOMAS GEORGE STREET, of Kilburn. <u>Coat of Arms</u>. A covered cup with handles, between three Catharine wheels. <u>Crest</u>: On a mount <u>vert</u>, a Catharine wheel, charged with a cup.
- STREET, descended from Derbyshire. Coat of Arms: Three horses courant. Crest: An arm embowed, vested, holding a bell pendant.
- STREET, of Sussex, Hampshire, and Kent. <u>Coat of Arms</u>: Three martlets, sable (two and one). <u>Crest</u>: An esquire's helmet.
- STREETE. Azure, three Catharine wheels, argent: a canton of the last.
- STREETE or STRETE, of Worcester. <u>Coat of Arms</u>: <u>gules</u> (red), three Catharine wheels, <u>or</u>. <u>Crest</u>: A lion rampant, <u>or</u>., holding a Catharine wheel between the fore-paws (one and two).
