

INTRODUCTION.

The following pedigree does not pretend to be in any way a family history. It has been printed in order to place beyond the reach of loss by fire or other cause a large mass of genealogical facts that represent many years of labour and research.

The compiler hopes that in the future he will be able to print a regular family history, including all the families of the name of Sandwith that have existed at various times in various counties. Some of these were undoubtedly akin to the family whose pedigree is here recorded, but whether the "missing links" that bind them together will ever be found is a question that the future alone can reveal.

- I. George Sandwith, of Oswaldkirk, co. York, gent. He was probably a tenant of the Abbey of Rivaulx. On the dissolution of monasteries he bought the estate of Snyleswath from Sir William Pykering, knt., to whom it had been granted by Henry VIII. He first occurs in 1525 as executor of John Rogerson, of Rivaulx. He married, according to Dodsworth, one of the *Preistmans* of Newton Grange, an ancient yeoman family. He died 12 Nov. 1560, and was bur. at Oswaldkirk. He had issue,

He was buried at Oswaldkirk 30 Oct. 1605. He married *Mary*, dau. of Nicholas *Segrave*, of Scalford, co. Leicester, esq., by Jocosa his wife, dau. of Rowland Digby, of Welby, esq. She was bur. 4 July 1597. They had issue,

- XIII. **Humphrey Sandwith,** of Hull, M.D., F.R.C.P. Born at Helmsley 25 May 1792. Educated at Beverley Grammar School and St. Bartholomew's

Hospital, London. M.D. St. Andrew's 1834, Licenciate of the R.C.P. 1840. Practised first at Beverley then at Bridlington, Hull, London, and Beaconsfield. Consulting physician Hull General Infirmary, F.R.C.P.S. 1859, was for some time editor of the "Watchman." Died 25 July 1874 at Todwick, co. York, and is buried there. He married, at the Priory Church, Bridlington, 5 Sept. 1818, Jane, dau. of Isaacs Ward, of Bridlington Quay, shipowner, by Ann, his wife, dau. and subsequently sole heiress of John Dale, of Bridlington. She died at North Anston, co. York, 2 May 1891, aged 94. They had issue,

- (i). Jane, b. 27 Sept. 1819 at Bridlington, mar. 23 June 1838 at St. George's, Queen Square, London, to the Rev. Henry Ward, d. at St. Barnabas Vicarage, London, 2 July 1862. Had issue 17 children.

Born at Bridlington and bp. there 12 April 1822. Educated at King's College School and University College, London. Joined General Williams' army at Kars in 1855, and was throughout the siege. It was defended by 15,000 Turks, against 50,000 Russians, under Mouravieff, for over five months, when it surrendered through famine, and he was sent home with despatches. Created C.B., and made D.C.L. Oxford, Colonial Secretary of Mauritius 1857—1859, accompanied the special embassy under Lord Granville to Moscow for the coronation of Alexander II, 1856. Throughout the Franco-Prussian War of 1870, Servian-Turkish War of 1876, and Russo-Turkish War of 1877. Died in Paris 16 May 1881. He married at St. Stephen's, Paddington, 29 May 1860, Lucy Anne, dau. and coh. of Robert Hargreaves of Bank House, Accrington, esq., J.P., by Louisa his wife, dau. of Samuel Broomhead Ward, of Mount Pleasant, Sheffield. She was born at Accrington, 2 Dec. 1841, d. in Algiers 6 May 1882. They had issue,

 - William Sandwith, C.B., lieut.-general Bombay Army, (iv). bp. at Helmsley 20 Sept. 1782, joined the H.E.I.C.'s service in 1800, and appointed to the European Regiment (now the 2nd bat. Dublin Fusiliers) 1801, employed in the expedition to Kurree, in Guzerat, under General Alexander Walker in 1802, and present at the battles and siege of that place in 1803-4, he was actively employed with his regiment against the rebels in Malabar, and in 1804 at the reduction of Savendroog. He accompanied an expedition under Major-General Sir George Holmes from Baroda in 1809, and a field detachment under Lieut.-Col. Jardine into Candeish in 1818. He was promoted captain 1810, and major 1818, and lieut.colonel in 1822. He was employed on the staff for several years, and received the thanks of government for his services. In 1819 he commanded that distinguished corps, the Bombay European Regt., in the Deccan, and proceeded with a field detachment under the command of Lieut.-Col. Jardine from Surat into Candeish, with a view to assist in intercepting the Paishwah, who was then proceeding through that district to the northward. Commanded in succession the Surat division, the Southern Coucan, the troops with Guicwar Subsidiary Force, the Subsidized Force in Cutch, and Baroda Subsidiary Force. The honour of C.B. conferred on him on the occasion of the Queen's coronation. He was promoted colonel in 1829, major-general in 1838, and brevet lieut.-general in 1851.
