HERALDIC FAMILY COAT OF ARMS THE SARGENT FAMILY

In that ancient fuedal castle, where the first heraldic honor was conferred by the reigning monarch upon his noted countryman, there began the custom upon which the lore of heraldry is based. Through the centuries, whenever a man was to be rewarded for chivalry, genius, patriotism or industry, he was granted the privilege of bearing Coat Armor, to display to the world his coveted position. This privilege is inherited by his descendants. A Coat-of-Arms has become an object of pride and display; in the modern sense it is used to preserve for posterity the record of ancestry and as a testimonial of authentic descent.

An instinctive reverence for our forefathers, a legitimate pride in some distinguished ancestors impels most of us to a fuller knowledge of our family history. But often, through the years, these valuable records establishing the right to a Coatof Arms are lost, or the owners are unaware of their rightful heritage to them.

From an authentic record of the College of Arms, in England, Professor H. Bernard Robinson, an heraldic specialist, and a great friend of the compiler of this Geneological history of one branch of the Sargent Family, gives a description of the Sargent emblazonment, thus:

SARGENT: Argent, a chevron between three ARMS

Dolphins, embowed, naiant, sable.

CREST: A dolphin as in the Arms.



Edwin Everett Sargent, the compiler of a most detailed and authentic genealogical history in his book entitled "The Sargent Record" published at St. Johnsbury, Vermont, Feb. 15, 1899 by the Caledonian Co., publishers, state that "the same year that witnessed the completion of Mr. Sargent's manuscript for his Book also records his death which occurred on June 24, 1898," and they further state that "it is to be regretted that he did not live to see the Book completed and receive the congratulations of every Sargent, wherever he may be, upon the success of his arduous task". In closing, the publisher says finally that "it was the crowning effort of his life and to it he literally sacrificed his life."

I would therefore recommend that every Sargent obtain for himself a copy of "The Sargent Record" as mentioned above and add to it where the compiler left off, the record of those Sargents who have followed in these generations as it concerns the particular Branch of the Sargent Family in which an individual may be interested. Perhaps some day another great genealogist may come along and combine the records from the various Branches of the Sargent Family into one huge Sargent Record.

SARGENT GENEALOGY

WILLIAM SARGENT I. Son of Richard Sargent and Katherine Steevens, was born in London, England in 1602. A record in the Abby Church at Bath gives the date of his baptism as the 28th day of March 1609. Other children mentioned being baptized were Elizabeth, baptized the 28th of October 1603, and Joane, on the 26th of October 1603.

William Sargent was a seaman in his younger years as he is designated as a "seaman or mariner" in his will and other documents, but he doubtless later in life followed other occupations with it.

He settled at Ipswich, known at that time as Agawan, Massa-The first recorded record of William Sargent is found chusetts. in the General Court records of Massachusetts Colony in April, 1633, by an act by said court protecting certain guarantees of land then at Agawan, now Ipswich, Massachusetts in their rights, and "Willm Srjeant" was one of them. The next record is that of his oath of allegiance and fidelity in 1639, and his name is recorded "Willi: Sergent" but neither is as he spelled it. Edwin Everett Sargent in his "Sargent Record" states that "it is shown by records and deeds that William Sargent," our American ancestor, "was later one of the first settlers at Wessacucon, now Newbury, in 1635; at Winnacumet, now Hampton, New Hampshire, in 1638; at South Merrimac, now Salisbury, Massachusetts, in 1639 and that ''Wm. Sargent', townsman and commoner of Salisbury, tax rate December 25, 1650, 7s 4d."

William Sargent married Elizabeth Perkins in 1633. She came to America with her parents, Quartermaster John Perkins, Sr. and wife, Judith Gater (daughter of Michael Gater of Hillmorton Co., Warwick, England, -See "Family of John Perkins of Ipswich, Massachusetts". (Also Burke's Landed Gentry of Perkins Family p. 2863 by Dr. George A. Perkins.) The Perkins family came over in the ship "Lion" in the spring of 1631 with Roger Williams. Elizabeth Perkins, wife of William Sargent, was born in 1618, in or near Bath, England. She died before September 18, 1670 for he married on that date Joanna Rowell who survived him and married Richard Currier of Amesbury.

William Sargent was one of the "Prudential" men in Amesbury in 1667; he resided in part of the town known as the "West Parish", and built a house near the church and academy. He died in March 1675, and was buried in the cemetary at the "Ferry". His will is as follows, and probated at Salem, Massachusetts in 1675.

71 "In the name of God Amen. The 24th day of March $16\overline{72}$ I, William Sargent of the town of Amesbury in the County of Norfolk, Massachusetts in New England, Seaman, being in pretty good health of body and of sound and perfect memory (praise be given to God for the same) and knowing the uncertainty of this life on earth and being desirous to settle things in order do make this my Last Will and Testament in manner and form, that is to say, first and principally I commend my soul to Almighty God my Creator assuredly believing that I shall receive full pardon and free remission of all my sins and be favored by the precious death and merit of my blessed Saviour and Redeemer, Christ Jesus, and my body to the earth from whence it was taken to be buried in such decent and Christian manner as to my executors hereafter named shall be thought mete and convenient.

And as touching such wordly estate as the Lord in mercy hath lent me my will and meaning of the same shall be

employed and bestowed as hereafter by this my will is expressed. And first I do revoke, renounce, frustrate and make void all wills by me formerly made and declare and appoint this my Last Will and Testament Item I give unto and bequeath to my grandchild William Challis five pounds and to my grandchildren Elizabeth, Lydia, Mary, and Philip Watson Challis to each of them twenty shillings Item I give and bequeath unto my grandchildren Dorothie and Elizabeth Colby to each of them twenty shillings Item I give unto my grandchild William Sargent thirty shillings and I give and bequeath unto my daughter Elizabeth, the wife of Samuel Colby five pounds and I give all the remainder of my estate (these my legacies and my funeral charges being first paid) unto my daughter Sarah both housing and land, chattel and other movable things forever always provided that if she die without children that these housing and lands to be equally divided: unto my four children hereafter named, i.e. my sons Thomas and William and my daughters Mary and Elizabeth and I do constitute ordain and appoint my son Thomas Sargent and my daughter Sarah Sargent Executors unto this my Will and Testament and do make my loving brother in law, Mr. Thomas Bradbury and my esteemed friend, Major Pike my overseers to take care that this my will may be performed according to the true intent and meaning thereof.

And to this my last Will and Testament I do hereunto set my hand and seal the day and year above named.

WILLIAM SARGENT II. Son of William Sargent I. and Elizabeth Perkins was born in Salisbury, Massachusetts November 2, 1645. He married September 23rd, 1668 Mary Colby of Amesbury there. She was born September 19, 1647. He died 1712 at Amesbury where they resided and are buried. He was a farmer and held public office. He took the oath of allegiance and fidelity December 20, 1677 at Amesbury before Major Robert Pike. His estate was probated at Salem, March 31, 1712. Mary Colby was the daughter of Anthony Colby and Susannah Haddon. Anthony Colby is said to have been the son or grandson of Thomas Colby of Roos Hall, Beccles Co., Suffolk, England which he built 1583 whose great grand father Sir Thomas Colby, member of Parliament for Rochester was created a Baronet 21 June 1720 and died 23, September 1729 when the title became extinct. Anthony Colby emigrated to America in the Winthrop ship with the Rev. John Winthrop. As early as 1630 he was in Boston, was proprietor in 1633 in Cambridge and in 1635 owned two houses there. He was admitted a freeman May 14, 1634. He sold out his property in Cambridge and removed to Salisbury, Massachusetts, where he received land on the first division in 1640 and again in 1643. He was among the first commoners of the town of Amesbury in 1654 and 1658 and his widow received grants in 1662 and 1664 upon his rights. He sold his house and two acres of land in Salisbury in 1647 to William Sargent I. seaman, and removed west of the Powow river between Salisbury and Amesbury. His name, Anthony Colby, is 93rd on the list of church members in the record of the First Church, Boston.

PHILIP SARGENT III. Son of William Sargent II and Mary Colby, was born at Amesbury, Massachusetts August 12, 1672. He married on December 7, 1693 Mary Tewksbury of Amesbury, there. He was a farmer and resided at Amesbury where he died in 1742. His will was probated at Salem 1742. Mary Tewksbury, his wife, was born Jan. 13, 1670. There is no record as to the date of her death which occured in Amesbury. She was the daughter of Henry Tewksbury and Martha Copp, widow of William Harvey. Henry Tewksbury took the oath of fidelity May 17, 1669 thus it is written in the "Old Newbury" records and this record had reference to Henry Tewksbury of English birth and parentage in the Borough of Tewk. He is believed to have come to America several years at least before he sat down at Newbury and took the oath of fidelity there in 1669 for he was in Boston and married there November 10, 1659 to Martha Copp as above given. In 1669 he sold his lands and removed to Amesbury, was made a freeman in 1690 and was Tithingman in 1693.

PHILIP SARGENT IV. Son of Philip Sargent III and Mary Tewksbury, was born in Amesbury, Massachusetts, April 7, 1703. He married Martha Hadley who was born October 23, 1704. The date of their marriage is given as July 23, 1724. Martha Hadley was a descendant of George Hadley, the founder of the New England branch of the Hadley family who came from England to Ipswich, Massachusetts before 1639. George Hadley emigrant ancestor was born in England about 1600. He married first ? Proctor; second marriage June 29, 1668 to Deborah Skillings. He removed to Rowley, Massachusetts about 1655 but returned to Ipswich where he was living in 1678. His will may be seen in the Massachusetts Historical Rooms in Boston. Geroge Hadley had a son, Samuel who had a son, Samuel. This latter Samuel of Amesbury was born Jan. 20, 1703-04 and marri-They were the parents of Martha Hadley who as ed Dorothy Colby. mentioned above married Philip Sargent IV.

(Dorothy Colby was the daughter of Isaac Colby and Martha Jewett. Isaac was born 1640. He was called a "Planter" of Salisbury in 1633. He died in 1684; Martha, his widow died in Amesbury July 13, 1730. See "Old Families of Amesbury" by Hoyt.)

PHILIP SARGENT V. Son of Philip Sargent IV and Martha Hadley, was born in Amesbury, Massachusetts May 9, 1731. He married about 1753 to Hannah Hadley of Weare, New Hampshire there. She was born 1738, d. Jan. 25, 1811. He died March 3, 1809. He was a farmer and resided at Amesbury, Acworth, and Weare. He signed at Weare, New Hampshire the Association Test of 1776.

ROBERT SARGENT VI. Son of Philip Sargent V. and Hannah Hadley, was born in Weare, N. H., 1771. He married Miriam Fuller of Andover, N. H., there, August 23, 1791. She was born April 18, 1772, died February 7, 1869, Lunenburg, Massachusetts and buried there. He died December 1844. Trunbridge, Vt. where they resided and he is buried. They moved from Andover each on horseback with a child in their arms and made 50 miles in a day. He was a blacksmith. From the "History of Andover" N. H. (1751-1906) by John R. Eastman, published by Rumford Printing Company, Concord, N. H. 1910 we gather only fragmentary data on the Fuller family. They trace their lineage to one, Giles Fuller of Hampton. married 1650 to ? He died April 6, 1687. Their son, John, born at Hampton, married March 19, 1677 to Rachael Braback. John died in Hampton 1719. Their son, James, born 1679, at Hampton, married Mary?; their son, Joseph, married Joanna Seavey in 1733 their son, James born April 30, 1743-44, He, James, came from Hawke to Andover in 1778 and settled in the "Fuller Place" in "Flagpole"; He married Mary "Mollie" Clough (daughter of Jabez and Miriam (Brown) Clough. She was born at Podlin, July 4, 1747-8, and died in Andover, N. H. April 9, 1807. He, James, died in Andover, N. H. in 1837. James Fuller and Mary "Mollie" Clough had six children; among them were:

MOSES SARGENT VII. Son of Robert Sargent VI. and Miriam Fuller, was born at Tunbridge, Vermont, September 15, 1812; married April 28, 1839 Mary Jane Nichols, Esopus, New York where she born March 27, 1818. He was a blacksmith at Stamford, Conn. He died at Stamford, Conn., Oct. 14, 1896. She died in Stamford, Conn., April 3, 1908.

She was a descendant Of Pieter Ostrander and wife, Tryntje, who came from Holland in the ship "De Bonte Koe" to America, April, 16, 1660. Children of this marriage were Pieter Peterson, b. 1650, m. Rebecca Traphagan, b. 1662; Tryntje or Caterina, b. 1652; Giertje, b. 1654; other children born in America, among them Sophrina, b. 1661. The family first appeared in records at Esopus, N. Y. and moved later and settled in Kingston, N. Y. From Sophrina

Ostrander's side of the house is mentioned the Nichols Family, among them John, Seymour, Joseph, Edith, Amanda and possibly a Lottie and William. Other members of the Nichols family mentioned are John, Joseph, Nathaniel, Nicholas, Solomon, Morris, Robert, Catherine, Mary Jane (who m. Moses F. Sargent) Hannah, and Polly.

Cemetary near Hackensack, N.J. 2nd marriage of Robert Smith Sargent to Georgiana Louise Felton of Brooklyn, N. Y. on Dec. 24, 1890. Further records follow.

ROBERT SMITH SARGENT VIII. Son of Moses F. Sargent and Mary Jane Nichols, was born in Astoria, N. Y., July 26, 1841. He married 1st, a widow, March 12, 1865, Mrs. Evelina E. Dean (maiden name Dunn) Brooklyn, N. Y. She was born in Stanwich, Conn. 1842 and died May 10, 1890 in Ridgefield Park, H. J. Robert Smith Sargent m. 2nd, Georgiana Louise Felton of Brooklyn, N. Y. Dec. 24, 1890 at the Methodist parsonage on Pineapple Street, in Brooklyn.

She was born in Wilbraham, Mass., March 9, 1859 and died Jan. 7, 1945 in Ridgefield Park, N. J. interred in Evergreen Cemetary "Felton Plot", Brooklyn, N. Y. She was the daughter of George L. Felton and Martha Louise (Nee DeRondo) whose mother was Martha Louise (Nee Beekman) (nearly allied with the original Beekman family of New York where she was brought up on her grandfather's farm- that of William Beekman, in lower Manhattan and Streets such as John, Ann, William were named after members of the Beekman Family) Returning now to Robert Smith Sargent, from "Field, Fort and Fleet" a book written by M. Quade, we read an interesting outline history of the Grand Army of the Republic with a history of the Rankin Post No. 10, G.A.R. including sketches of members, printed by the Detroit Free Press Publishing Company: "Previous to the war he was engaged in steamboating. On May 22, 1861, he enlisted in Co. B. 17th New York Volunteers for two years. He took part in the First Battle of Bull Run, Williamsburg, Winchester, Hanover Court House, Fair Oaks, Seven Days Fight, Malvern Hill, Second Battle of Bull Run, South Mountain, and Antietem. At the expiration of his term of service he was honorably discharged and on September 17th, he enlisted in the U.S. Navy as fireman. He was assigned to the U. S. Crusader, connected with the North Atlantic Blockading Squadron stationed at Chesapeak Bay. He was honorably discharged on September 17, 1864 at Norfolk Navy Yard, his term of service having expired. He followed thereafter the occupation of mechanical engineer. His army record may also be found in

Vol. I, pages 386-7 of the Adjutant General's Office, State of New York, printed by Comstock & Cassidy, Albany, N. Y. entitled "A Record of the Commissioned Officers, Non Commissioned Officers, and Privates of the Regiments which were organized in the State of New York and also into the Service of the United States to Assist in Suppressing the Rebellion". Here his name is spelled "Robert Sergeant" Rank, Private, age 19, enlisted at Portchester, N.Y. enrolled by Captain Bartram for a period of two years. later years when incapacitated he applied to President McKinley for a pension which was allowed by the Adjutant General's Office in Washington, D. C. He had served his terms of service both with the Army of the Potomac and the Navy with tha Atlantic Blockading Squadron in which he took part in the sinking of the Merrimac. He lived at Sorrento, Florida and Lisbon, Florida in his last years, departing this life on November 29, 1930 and buried in Forest Cemetary, Mount Dora, Florida.

Y. and University of Florida, Gainesville, Florida, also graduated from the Ridgefield Park Business College, of which Miss Winifred Poole for many years was the principal. Listed in "First Families of America" published by Virkus Co., Chicago, Ill. and Genealogy of the Sargent Family - The Sargent Record" by Edward Everett Sargent. He was for a number of years engaged as private secretary to officers of both the Union Trust Company and Bankers Trust Company, New York, respectively, and was a chorister at Trinity Chapel, N. Y.,

- St. Thomas' Church, N. Y., St. John's Church, Jersey City, N. J. and a member of the Amphion Glee Club of Bergen County, N. J. From an item in the Radio World they wrote "He is a young American singer who had received his entire musical education in this country and has attracted attention with his church, concert, oratorio and radio work both in the North and in the South and since his entrance into the field of music has been steadily winning the enthusiastic approval of the public and the press." Again, the "Jacksonville Times Union" stated "as one of experience in both the choral and concert field he is coming to the front in the musical life of Central Florida. He has a very pleasant lyric Baritone voice full of resonnance and artistic tone production and together with a pleasing personality is as much at home before his public as he is in the studio". The Orlando Morning Sentinel stated "the two song recitals given by Mr. Sargent over WDBO Rollins College, Winter Park, Florida, this past season will long be remembered by radio listeners for their fine tone quality and pleasing rendition." This was at a time when Radio Station WDBO was a mere infant in the radio field and was just getting established. He came to Florida in 1924 to make his domicile and has been associated as Secretary to the Commissioner, Dr. Wilmon Newell, state Plant Board and Dean of the College of Agriculture at the University of Florida; later he became a reporter for Masters in Chancery in Orlando; Parish Secretary at the Cathedral Church of St. Luke, Orlando and in 1951 was advanced as Secretary to the Bishop of South Florida of the Episcopal Church. He was also a Notary Public for the State of Florida at Large under appointment by a number of Governors of the State thru the years. He served in World War I with the Gas Defense Division, Chemical Warfare Service, U. S. Army; enlisting at Washington, D. C. November 30, 1917; promoted to Corporal September 9, 1918 and Sergeant in November the 26th, 1918, and was honorably discharged February 6, 1919 with the remarks "Honorable Discharge: No A.W.O.L. or absence from duty under G.O. 45, War Department: Character Excellent. He is a member of Barracks #237 Orange Co., Veterans of World War I, in Orlando; The Florida Society of the Sons of the American Revolution; National Order of the Guild of St. Vincent at Washington, D. C. Member of Mosaic Lodge 194 of Ridgefield Park, N. J. and a member of The American Association of Retired Persons, Washington, D. C.
- 6. Joseph Jeffries Sargent b. Sept. 14, 1892 at Ridgefield Park, N. J. educated in public schools Ridgefield Park, and Business College, Washington, D. C.
