- WILLIAM SCOTT-1 Born about 1635. He first appears on the scene, as far as any records show, when he came to that part of Hadley, now called Hatfield, Mass., about 1668.

 "Among the archives of Memorial Hall at Deerfield, Mass. is the last will of William Scott, dated Feb. 15, 1716. The will was never probated as no record of it can be found at Northhampton, where it should appear. He married, Jan. 28, 1670, Hannah Allis, born about 1649. Their third child was William.
- WILLIAM SCOTT⁻² William⁻¹; b. Nov. 24, 1676, probably at Hatfield, Mass. He moved from Hatfield about 1715 to Sunderland, Mass., of which town he was one of the early settlers. Married Mary-----, who died Dec. 7, 1711. They had four children. The third child was Samuel. As a second wife, William married Elizabeth -----, in 1715. She died Nov.6, 1762. They had seven children. William⁻² died Nov.20, 1759.
- SAMUEL-3 (William-2, William-1). b. May 3, 1707. M. in 1731
 Elizabeth-----. Their children were born in
 Sunderland, Mass., and, at least, a part of the family
 moved to Bennington, Vt. in 1762.

CHILDREN:

- 1. Samuel, 2. Moses, 3. Phineas, 4. Oliver (who was the fourth). The names of these four sons appear on the muster roll of the first company of militia in the town of Bennington, Vt. The company was organized by Captain John Fassett, Oct. 24, 1764. The records of Rupert, Vt. previous to 1800 have been lost, so that no further record of the Scott family is found there. The rest of the record of Oliver4 may be found in the "History and Genealogy of the EASTMAN family of America, compiled by Guy S. Rix, Concord, New Hampshire, 1901., as follows:
- OLIVER-4 (Samuel-3, William-2, William-1) b. in Sunderland, Mass. on Feb. 27, 1739. Died----; Married (in Bristol Vt.) a Bathsheba Eastman, b. 1751, in Norwich, Conn.; d. about 1843, in Theresa, N.Y.

(In the Newberry Library, Chicago, Ill. may be found "The Scott Genealogy" by O.P. Allen, Palmer, Mass. The library number is E.7.S. 425. In the same library is found "Eastman Family of America" number E.7.E. 1295. Pages 134 and 267 refer particularly to the families of Oliver—4 and Bathsheba Eastmen Scott and their children, Oliver—5 and Jonathan—5)

The following account of OLIVER SCOTT is found in "Rolls of Soldiers in the Revolutionary War", 1775 to 1783, from Vermont, published in Rutland, Vt., 1904, by John E. Goodrich. Pages 100, 152, 157, 210, 460 & 632. The record may also be obtained in certified form from the State Adjutant General, Montpelier, Vermont.

Page 100. Oliver Scott is on the pay roll as Private in Captain Tehan Noble's Company of Col. Warren's regiment of militia for service done on frontier, by order of the Governor and Council. Entered the service Nov.7, 1778, discharged Nov.13, 1778. For 7 days service he was paid 11 shillings, 8 pence.

Page 152. Oliver Soott is on the Pay Roll as Sergeant in Capt. Daniel Smith's company, Col. Ira Allen's regiment, of militia in an alarm to Skeensboro, March 1780. For 2 days service and 20 miles travel he was paid 9 shillings, 10 pence.

Page 157. Oliver Scott, is on the Pay Roll, as Sergt. in Capt. Daniel Smith's company, Col. Ira Allen's regiment of Militia in an alarm to Mount Independence in March 1780. For 3 days service and 60 miles travel he was paid 1 pound, 9 shillings, 6 pence. Page 210. Also in the same Company and Regiment, as Sergt. in an alarm to Castleton, Oct. 1780. For 19 days service and 81 miles travel he was paid 2 pounds, 16 shillings, 11 pence.

Page 460. Also in the same Company and Regiment as Sergt. in an alarm to Castleton, Oct. 21, 1781. For 10 days service and 30 miles travel he was 1 pound, 5 shillings.

Page 632. Oliver Scott on the Muster Roll as private of the First Company of Militia in the town of Bennington, Vt., organized Oct. 24, 1764.

(Probably the four sons served in the War of 1812; at least Jonathan did, and was a captain of a militia company, and Oliver was captain of an artillery company. In some papers left and written by Oliver Barnes Scott, son of Oliver-5, and now (1914) in possession of Lestina M. Scott, Centerville, Pa., there is a statement that his father (Oliver) and three brothers David, Stephen, and Jonathan served in the War of 1812; Oliver was Captain of an artillery company and Jonathan was captain of a militia company. This statement also says his grandfather served in the Revolutionary War.).

Mrs. Lestina M. Scott, of Centerville, Pa. (daughter of Dorcas Scott Carpenter, who was daughter of Oliver-5, under date of Jan. 21, 1914, writes that she has often heard her father-in-law, Oliver Barnes Scott, speak of his Uncle Jonathan, and that she has also heard him and her mother Dorcas speak of their uncles (probably meaning their grandparents) that served in the Revolutionary War, but says that as she did not write down such items, she has forgotten them and dares not give them as proof positive.

OLIVER SCOTT⁻⁵ (Oliver⁻⁴, Samuel⁻³, William⁻², William⁻¹) b. July 2, 1772, in Rupert, Vt. d. about 1846. Was Captain of an Artillery Company in War of 1812. Married at Middleton, Vt. Sept.18, 1796, to Dorcas Pryor, b. Sept.21, 1777, Norwich Conn.

- JONATHAN SCOTT⁻⁵ (Oliver⁻⁴, Samuel⁻³, William⁻², William⁻¹) Born Sept. 9, 1778, in Rupert, Vt., died in Grand Rapids, Mich., Feb.6, 1861, at the home of his daughter, Mrs. Hannah Calista Barnard. He was a Democrat in politics, and in religion a Universalist. He married, first, Hannah Wood, Sept. 14, 1800; she was b. Mar. 3, 1784, in Middleton, Vt. Their children were:

Jonathan-6 married a second time - Lucretia Ellsworth, by whom he had one daughter. Both mother and daughter died years ago. No record.

Jonathan⁻⁶ married third time - Miranda V. Scott, in New York, Dec.6, 1854. They lived together about 42 years. Four children:

- JONATHAN SCOTT-5 Married second time, Rachel Wheeler Cook, b.Nov.3 1782, in Chesterfield, N.H. Her maiden name was Rachel Wheeler, and she was a daughter of a soldier of the War of the Revolution. She first married a Mr. Cook, and they had one daughter, Laura, who was the mother of Euretta Frost McDermott. Rachel Wheeler Cook Scott was a Baptist. Laura married Benjamin Frost. They had two children, Euretta and Elizabeth, who died at age seven. Euretta Frost McDermott is still living in Traverse City, Mich., at the age of 80 yrs. She (Rachel Wheeler Cook Scott) died Feb. 16, 1855, in Georgetown, Michigan. Their children were:

- MARIA BATHSHEBA SCOTT-6 b. Aug. 17, 1817, in Ellisburg, Jefferson Co., N.Y. Married, April 5, 1846 in Georgetown, Mich. where they lived on a farm about one mile south and one mile west of Jenison, Mich. She married Liberty Tanner Beardsley (nearly always called Bursley). She died Mar.18, 1872, in Georgetown, Michigan where she was buried. Their children were:

 - (3) Ida Euretta (4) Asa A. Liberty Tanner Beardsley was born in Richfield, N.Y. on March 13, 1821; died Jan. 10, 1905, in Georgetown wident Mich. His father's name was Liberty Beardsley, one was of the first settlers in Stratford, Conn. in 1835, an account of whom is found in "The History of the Beardsley Family, by I.H. Beardsley.
- (1) MARY CALISTA-7, b. June 7, 1851, in Georgetown, Michigan. Married March 16, 1870, in Georgetown, Mich., to Byron Benjamin Godfrey, M.D. Dr. Byron Benjamin Godfrey was born March 1, 1848, in Hannibal, Oswego, Co., N.Y. His father was Almon Thos. Godfrey, born in Berlin, Ransselaer Co., N.Y. Aug. 5, 1806 and died in Hudsonville, Mich., April 7, 1884.

His mother was Lovina Beardsley Godfrey, born in Hannibal, N.Y., Sept. 10, 1812 and died Jan. 10,

1892, in Hudsonville, Mich. Her father's name was James Beardsley, brother of Liberty Beardsley-1, mentioned above, and hence, also a descendant of William Beardsley, of Stratford, Conn. Dr. B.B. Godfrey was at one time Principal of the Grandville, Mich. Public School. He began his professional studies at Detroit Medical College, and afterwards entered Rush Medical College, Chicago, from which he graduated in 1878, and opened an office at Lamont, Mich., where he practiced until 1880, when he moved to Hudsonville, Mich. He practiced there until 1895, when he moved to Holland, Mich., where he again was engaged in the active practice of medicine for many years. He was Health Officer of that city for several years. In 1890 he was a candidate for Congress from the Fifth District of Michigan, on the Prohibition ticket, and although he was defeated, he received a large number of votes. He is a member in high standing in both the Masonic order and the Odd Fellows.

They had six children, four of whom died during infancy or very early. The following is an account of their two children Pearl Cleo and Almon Tanner:

Pearl Cleo-8 was born Feb. 16, 1873, in Tallmadge Township, Lamont, Mich., was graduated from Hope College Preparatory School in Holland, Michigan, June, 1890. She became the wife of Rev. Isaac Van Kampen on June 28, 1893, and has resided in Saddle River, New Jersey, since that time, where her husband has been pastor of the Dutch Reformed Church for over 20 years. The parents of Dr. Van Kampen were among the early Dutch settlers of Holland, Mich. Dr. Van Kampen graduated from Sweenburg's Business College, Grand-Rapids, Mich., Hope College, Holland, Mich., receiving degree of A.B. in 1890; took his theological course in New Brunswick, New Jersey, finishing there in June 1893; later on he took a course in Sociology in the Wesleyan University, Bloomington, Ill., and after several years of home study spent one year in residence work at that institution, where he received the degree of Doctor of Philosophy in June, 1900.

Their children are as follows: Godfrey Raynard, b. June 13, 1899; Gertrude Mary, b. Dec.5, 1905; Beardsley Clyde, b. Feb.15, 1907. Godfrey Raynard Van Kampen entered the "D" class, Hope College Preparatory School, Holland, Michigan, Sept., 1912.

Almon Tanner Godfrey was born Feb.8, 1877, at Lamont, Michigan, and at the age of three years, his parents moved to Hudsonville, Michigan, where he spent his boyhood days. In Sept. 1893, he entered the "C" class in the Preparatory School, Hope College, Holland, Mich., from which institution he received his A.B. degree in June 1900. That same year he received a scholarship in Northwestern University Medical School, Chicago, and began the study of medicine there in Oct. 1900, receiving the degree M.D. there in June, 1904, after which he began the practice of medicine in Holland, Mich. He was appointed instructor in Chemistry and Physics in Hope College, 1904; assistant professor, 1908; and elected Professor of Chemistry, 1909. At the writing of this

article, March, 1914, he is still connected with Hope College as Professor of Chemistry, and Medical Director, besides devoting a portion of his time to the practice of medicine, having an office with his father, Dr. Byron Benjamin Godfrey, at the corner of College Avenue and Tenth Street. Both father and son are members of the Ottawa County Medical Society; Michigan State Medical Society; and the American Medical Association. Almon Tanner Godfrey is also a member of The American Association for the Advancement of Science.

June 15, 1904, he married Harriet Mary Free, a niece of Mr. and Mrs. Joseph Totten, Hudsonville, Mich. She was a daughter of Mr. Andrew P. Free and Hattie Turner Free. She was born in Russell, Pennsylvania, March 29, 1882. Both Almon Tanner and Harriet M. Godfrey are members of Hope Reformed Church, Holland, Mich., having formerly belonged to the Congregational Church, Hudsonville, Mich.

(2) EVA MARIA-7 (daughter of Maria Bathsheba Scott and Liberty
Tanner Beardsley) b. June 21, 1853, in Georgetown,
Mich., married to John M. Larkins, Nov.1, 1880, in
Georgetown, Ottawa, Co., Mich. Mr. Larkins was a
native of Ohio, born
, at
; died June 20, 1908, in Traverse City,
Mich., where he was buried.

After marriage they located at Long Lake, near Traverse City, and a few years later, moved to Bingham, Mich. In both of these places, he owned and managed a large saw-mill. They moved to Traverse City about 1898, where Mr. Larkins engaged in the coal business.

They had one daughter, Ida Maria, b. 21, 1883, in Long Lake, Michigan. She graduated from the Traverse City High School; then spent one year at the University of Chicago; and finally spent three years in the study of music at Hope College, Holland, Michigan. On June 23, 1914, at Traverse City, Mich., she was united in marriage to Lowell Morse. Mr. Morse was also a graduate of the Traverse City High School. Immediately after their marriage, they went to make their home on a large ranch near Dewdrop, Saskatchewan, Canada, and were very shortly joined by their mother, Mrs. Eva Maria Larkins.

⁽³⁾ IDA EURETTA⁷ Born July 6, 1855, in Georgetown, Mich., married Feb.3, 1874, in Grandville, Mich. to Edwin Philander Hoyt, who was b. Aug.23, 1847, in Rochester, N.Y. They lived in Hudsonville, Mich., 1874 to 1884; and in Chicago, Ill., 1884 to 1889. He died Aug.5, 1889, at the home of her father, in Georgetown, Ottawa Co., Mich., as the result of an injury received in the Civil War, the bullet having never been located and removed.

Edwin P. Hoyt was a private in Captain M.N. Cook's Company I, 8th Regiment of New York Volunteers Heavy Artillery, who enrolled on Feb. 14, 1863, to serve three years or during the war, was discharged June 6, 1865, at Manson's Hill, Va. He was wounded at Cold Harbour, Va., June 3, 1864. After his death, Mrs. Hoyt and daughter Lottie, lived in Hudsonville Mich., 1889 to 1896; in Holland, Mich., 1896-1907; after which Mrs. Hoyt lived with her daughter in Grand Haven, Mich. Lottie Maria, daughter of Edwin P. and Ida E. Hoyt, was born April 8, 1881, Hudsonville, Mich. She attended Hope College, Holland, Mich., 1896 to 1906. She married Dr. William De Kleine, who graduated from Hope College, with degree A.B. in June 1902. He received a scholarship in Northwestern University Medical School, Chicago, Ill., and Oct. 1902 entered upon his medical course in that university, from which he received his M.D. degree in June 1906, after which he located in Grand Haven, Michigan Dr. De Kleine is one of the most popular and successful physicians in Ottawa Co., and has been very active in promoting the "Good Roads System" in Ottawa County. He is a member of the School Board in Grand Haven, and takes a very active part in all civic and political affairs. On Feb.20, 1914, he received an appointment of Sur-

geon for the Grand Trunk Railroad. Dr. and Mrs. De Kleine have one son, Edwin Hoyt De Kleine, born June 11, 1909, in Grand Haven, Mich. They are both members of the Second Reformed Church of that city.

(2) Maud Beardsley, b. Apr.23, 1883; m. Apr.24, 1901, Kiah Green, and lived on a farm north and east of Hudsonville, Mich., for a few years, later living in Hudsonville, and still later in Grandville, Mich. where Mr. Green was engaged in the retail grocery

⁽⁴⁾ ASA A. BEARDSLEY⁻⁷ b. Jan.15, 1857, in Georgetown, Ottawa, Co., Mich. Married Alice Cole, Sept.27, 1879. She was born Sept. 27, 1861. They made their home for years on his father's farm, and about 1907 moved to Grand-ville, Mich., where he engaged in carpenter work. They had four children: (1) Liberty (2) Maud (3) Garret (4) Lulu.

⁽¹⁾ Liberty was b. Sept.30, 1880; died Jan.1, 1905, and buried in Georgetown cemetery. He married Anna Seeley of Traverse City, Mich. They had two children: (1) Donald Beardsley, b. April, 11, 1901. (2) John Beardsley, b. June 27, 1903. She married as a second husband Albert Zeigler, and are making their home in Traverse City, Mich.

business. They have three children: (1) Florence Genevieve, b. June 20, 1903; (2) Russell Erwin, b. Feb.17, 1907; (3) Freeman Maxwell, b. Oct.6, 1909.

- (3) Garret Beardsley, b. Aug. 24, 1885, in Hudsonville, Mich. He served in the United States Marine Corps from Feb. 22, 1906 to Feb. 21, 1910, when he received an honorable discharge. GEORGE WASHINGTON SCOTT-7 born Oct.18, 1843, in Ellisburg, Jefferson Co., N.Y. He left that place Sept.25, 1844, for Michigan. (For brief account of which trip, see history of Hannah Calista Scott Barnard, which follows). He was united in marriage to Mary Jane Brittain, in Ottawa County Mich., Dec.24, 1869, from which union was born one child, Delora Louise, born May 1, 1872, in Big Rapids, Mich. She m. a Mr. Baxter, and lives on Fifteenth Ave., Seattle, Wash,

Shortly after Mr. Scott's marriage he moved to Big Rapids, Mich., where he lived until 1876, when he moved to Grand Rapids, Mich., and lived there until the death of his wife in 1880. In 1882, he married Mary Isabelle Babcock, and lived in Coopersville, Michigan. He conducted a hardware business there until 1886, when he sold out and went to Seattle, Wash., where he lives at #6533 Wilson Ave. He has been a carpenter by trade nearly all his life except during the time he lived in Coopersville, Mich. Mr. Scott has been employed a number of years in the United States Navy Yard at Puget Sound, and is still on the roll at the present time, March 1, 1914. From the union with his second wife, three children were born:

Mr. George Washington Scott enlisted from Ottawa County, Michigan, to serve three years or during the war, and was mustered into the United States service at Grand Rapids, Mich., on the 23d of Dec.1863, as a private in Captain Joseph C. Herkner's Company "D", 1st Regiment Michigan Engineers and Mechanics, Colonel William P. Innes, later John Yates, commanding. Besides doing a great deal of construction work on roads, bridges, repairing railroad tracks and running trains, this regiment took part in engagements at Mills Springs, Ky.; Farmington, Miss., Siege.of Corinth, Miss.; Perryville, Ky.; Lavergne, Chattanooga, Tenn.; Siege of Atlanta, Savannah, Ga., and

Bentonville, N.C. The regiment was with Sherman in his celebrated March to the Sea. It took part in the Grand Review at Washington, D.C., May 24, 1865, and early in June was ordered to Louisville, Ky., and from there to Nashville, Tenn., where it was employed upon the defenses until Sept.22, when it was mustered out under command of Col. Yates, and was honorably discharged Oct.1, 1865, at Jackson, Michigan. Mr. Scott took part in all the services of his command during 1864 and 1865. A more complete account of this war record may be obtained from The Historian of the "Soldiers and Sailors Historical and Benevolent Society," Washington, D.C.

 Mr. Scott has been a tinner by trade, and was located in Grand Rapids, Mich., for five years, after which he engaged in the tin and hardware business in Ravenna, Mich., and later on, in Coopersville, Mich. in 1884, he moved to North Yakima, Wash., following his trade there for some time, when he again moved to Seattle, where he lived until 1909. He then moved onto a ranch at North Yakima, Wash., where he lived until 1911, when he sold out and retired in San Diego, Cal.

One child, Asa Edmund, was born Oct.9, 1888, in North Yakima, Wash. His present address is Wapato, Wash. He married Mable B. Cole, Dec.25, 1910 at North Yakima, Wash.

HANNAH CALISTA SCOTT-6, (Jonathan-5, Oliver-4, Samuel-3, William-2 William-1) She was born March 1, 1822, in Ellisburg, Jefferson Co., N.Y., which place she left Sept. 25, 1844, and came to Grandville, Kent Co., Mich. She had a good education and was a school teacher, both in New York state and in Michigan. She married

Darwin E. Fischer in 1846; he died Feb.24, 1853. No children. In 1854 she married William R. Barnard. He was born in Buffalo, N.Y., Aug.16, 1813. They conducted the Eagle Hotel in Grand Rapids, Mich., for one year, and then built the Barnard House, which they ran as a first class hotel until 1862. No children.

Mrs. Barnard made her home with her neice, Mrs. Ida E. Hoyt, for years, and died at her home in Holland, Michigan, Feb.18, 1902, and was buried in the Georgetown cemetery, Ottawa Co., Mich. She was a woman of most beautiful Christian character. A short record of her life may be found in "Portrait and Biographical Record of Muskegon and Ottawa Counties" in Graves Library, Hope College, Holland, Mich. When Mrs. Barnard came as a young lady to Michigan in 1844, she wrote a short story of her trip, parts of

She, together with Mr. Rawls (father of Irene Rawls), Maria Bathsheba Scott, Laura Cook Frost, and daughter Euretta Frost (later McDermott) came in an emigrant wagen from Ellisburg, N.Y. to Grand Rapids, Mich., by way of Rochester, Buffalo, thru Ontario, Detroit, Pontiac and Ionia. They left Ellisburg Sept. 25, 1844; and reached Grand Rapids Oct. 15, 1844. She states that when they reached Buffalo they saw "the cars come in". They crossed the river at Buffalo at Black Rock ferry, and went along the north shore of Lake Erie for some distance on their way thru Ontario to Detroit. At night they usually stopped at some inn or tavern, having made about 30 to 35 miles a day. She writes of Detroit (Oct.9, 1844) as a village. From Detroit they passed thru Mount Piety, Pontiac, Ionia and stopped at the Lake House two and onehalf miles from Grand Rapids, and reached Grand Rapids Oct. 15, 1844. She writes that Grand Rapids then had 28 stores and 3 churches.

Those of her family who came by boat from Ellisburg, N.Y., to Grand Haven, Mich., were Jonathan and Rachel Scott, their son Asa A. and his wife Irene Rawls Scott, their two children George Washington and Nettie C. and Mrs. Rawls, mother of Irene.

Jonathan Scott's-5 home in Ellisburg, N.Y., consisted of about 100 acres of land, on which was a large square red brick house, two and one-half stories high, built one of four corners and used as a tavern. The front door opened into the bar-room; this room and the partor, which opened off from it, took up all the front; back of the parlor was a large kitchen where they ate, and a pantry. The stairs went up out of the bar-room into a hall or ball room which extended across the front of the second story. On one side of the hall was Hannah Calista and Maria's bedroom, with closet and fireplace, and on the other side, another bedroom, which was used by Jonathan and his wife. Jonathan Scott paid more attention to the tavern than the farm, which he left to his sons and hired men to run. They were always well to do in those days, but Jonathan lost a great deal by signing notes with different

people. Finally his son Asa A took over the farm with the understanding that he was to take care of his father and mother the rest of their life, but hearing so much about Michigan and the great opportunities offered there, traded the farm for land in Georgetown, Ottawa Co., Michigan, where they built two log houses near a Mr. Bosworth's.
