THE NAME.

Shaw as a cognomen is included among the names of local origin. A "shaw" or "schaw" was a small woody shade or covert.

"John Atte Schawe" appears in the old Parliamentary Rolls, and "Thomas de Shaghe" among the

early writs of Parliament.

Both of these gentlemen would be styled "Shaw" were their names recorded to-day.

THE SHAW ARMS.

I. Shaw of Kenward and Eltham, Kent, Baronet.

Arms: Argent, a chevron between three fusils ermines.

Crest: Six flighted arrows interlaced saltireways or, flighted and headed argent, tied together with a belt gules, buckle and pendant or.

Motto: Vincit qui patitur. He conquers

who endures.

2. Shaw of Kilmarnock, Ayrshire, Baronet.

Arms: Azure, three covered cups, two and and one, or, on a chief argent, a merchant ship under sail proper, a canton gules charged with a mace of the city of London, surmounted with a sword in saltire also proper, pomel and hilt of the second.

Crest: A demi-savage affrontee, wreathed about the head and waist proper, in the dexter hand a key or, the sinister holding a club reversed, also proper.

Motto: I mean well.

3. Shaw of Ardesley, York; granted December 4, 1707.

Arms: Argent, a chevron ermines, on a canton gules a talbot's head erased or.

Crest: A talbot passant ermines, eared argent.

Crest: (Another) a talbot statant sable.

Motto: Multo labore multaque cura.

4. Shaw of Ayrshire, Scotland.

Arms: Azure, three covered cups or.

Crest: A demi-savage, wreathed about the head and middle with laurel and holding a club over the shoulder proper.

Motto: I mean well.

5. Shaw of Ireland.

Arms: Ermine, a chevron between three mascles sable.

Crest: A cock's head issuing from the wreath gules.

6. Shaw of Bargaran, Scotland.

Arms: Azure, a fesse chequy argent and gules between three covered cups or.

7. Shaw of Rothiemurchus, Scotland.

Arms: 'Or, a lion rampant gules armed and langued azure.

Crest: A demi-lion gules holding in the dexter paw a sword proper.

Motto: Fide et fortitudine. By fidelity and fortitude.


8. Shaw of Sauchie, Scotland.

Arms: Azure, three covered cups or.


Crest: A phoenix in flames proper.

9. Shaw of Sornbeg, Scotland.

Arms: Azure, three mullets in fesse between as many covered cups argent.



SHAW -AVRSHIRE (Kilmarnock, Bart.)





Crest: A dexter hand proper holding a covered cup argent.

Motto: I mean well.

10. Shaw of Scotland.

Arms: A demi-lion rampant couped or between three covered cups of the second.

Crest: A lion rampant gules armed and langued azure.

Motto: Mens immota. A constant mind.

11. Shaw.

Arms: Argent, a chevron between ten crosses, crosslett gules.

Crest: A griffin's head erased ermine, collared, lined and ringed or.

12. Shaw.

Arms: Argent, a chevron wavy between three eagles displayed sable.

Crest: A hind's head couped, with an arrow through the neck or.

13. Shaw.

Arms: Sable, a chevron between three lozenges ermine. Another adds a bordure gules.

14. Shaw.

Arms: Argent, a chevron between three fusils ermines.

15. Shaw.

Arms: Argent, a chevron between three lozenges ermines.

Shaw of Bushy Park, Dublin, Baronet.

Arms: Or, on a chevron engrailed between three eagles displayed sable as many trefoils slipped of the field.

Crest: A hind's head couped azure, the neck transpierced by an arrow in bend

or flighted argent.

Motto: Te ipsum nosce. Know thyself.

17. Shaw of Bristol, England, confirmed 1602. Arms: Argent, a chevron between three fusils ermines, a chief gules,

18. Shaw of Colchester, Essex; and London,

1586.

Arms: Or, a chevron, wavy between three

eagles displayed sable.

Crest: A hind's head or pierced with an arrow of the first, headed and feathered argent.

19. Shaw of London.

Arms: Ermine, two chevrons, between three mascles sable.

Crest: An arrow erect or, feathered and headed argent, passing through a mascle sable.

20. Shaw of Woodhouse, Staffordshire.

Arms: Or, a chevron invected pean between three eagles displayed sable.

A hind's head quarterly argent and or pierced through the neck with an arrow headed azure, feather broken and dropping argent.

21. Shaw of Barthomley and Lawton, Cheshire; London, and the United States.

Arms: Argent, a chevron between three lozenges ermines.

Crest: A dexter arm embowed in armour to the wrist, grasping a spear, point downwards.

Motto: Au fait.

Clan Shaw (as depicted in Browne's "Scottish Highlands," 1838).

Arms: Azure, three covered cups or.

Crest: A naked man from the waist up, wreathed around the forehead, holding across the shoulder in the dexter hand a club, all proper.

Supporters: Two bearded, naked men, wreathed about the foreheads and middles, holding clubs over their shoulders, the dexter in the dexter hand, the sinister in the sinister.

Motto: I mean well.

SHAW FAMILIES.

Shaw of London; Kenward and Eltham, Kent; and Coltshall, Suffolk.

I. Hugo De Shaw, of the county palatine of Chester, behaving well, under the Earl of Chester, in an enterprize against Llewellyn, Prince of Wales, near the castle of Ruthin, had divers manors, and a daughter of the said Earl in marriage.

2. Randal de Shaw, his son, of Haslington-hall, married ———, daughter of Reginald Venables, of Agdon, in the said county, from whom, in a lineal

- I. Sir John Shaw, Knt., the second son (besides other considerable rewards) had, by letters patent, the farther dignity of a Baronet conferred on him, for the assistance he gave King Charles II at Brussels and Antwerp, by lending him large sums of

money, during his exile, when, according to the policy of those times, there was little or no view of any restoration. Thus his integrity to his Prince procured him a seat in Parliament, without the trouble of canvassing; he was one of the farmers of the customs, temp. Car. II. He married, first, Anna, daughter of Sir Joseph Ashe, Knt., by whom he had a son, Sir John, his successor, of whom hereafter; and a daughter, Elizabeth, who died unmarried; secondly, Bridget, Viscountess Kilmurry, relict of Charles, Viscount Kilmurry, and daughter and coheiress of Sir William Drury, of Besthorp, in Norfolk, Knt., by whom he had two sons, Charles and Robert, a merchant, who died unmarried, as did also a daughter, Elizabeth. Charles Shaw, of Lincoln's-Inn, Esq., son and heir, by the second wife, married Elizabeth, daughter and coheiress of Philip Harbord, of Stanning-hall, in Norfolk, Esq. (by Anne, his wife, the other daughter and coheiress of Sir William Drury, of Besthorp, Knt.) and died at Besthorp, April 26, 1716, leaving two sons, John and Charles, and one daughter, Elizabeth, wife of King Gould, Esq., deputy judge-advocate (by whom she had two sons, Charles and Paston). John Shaw, of Besthorp, Esq., eldest son and heir, was a captain in the guards and died without issue, 1722, when the estate descended to Charles Shaw, of Besthorp, Esq., his only brother, who married Frances, daughter of —— Lightfoot, of Hampshire, and died, leaving Elizabeth, his sole daughter and heiress.

To return to the elder branch:

II. Sir John Shaw, Bart, only son by the first wife, succeeded to the title and estate, and married, first, Margery, daughter and heiress of Sir John Peake, Knt., Lord-mayor of London, by whom he had two sons, and two daughters; Sir John, his succesor, and William, who died an infant; Sarah, wife

of William Smith, Esq., one of the six clerks in chancery; and Elizabeth, of Stephen Ram, of Hackney, in Middlesex, Esq., son of Sir Abel Ram, of Dublin, in Ireland, and formerly an eminent banker in Lombard-street, by whom she had no issue; her husband died, October 16, 1746; and she, September 2, 1760, and was buried in the family vault, under the north aisle of the parish church of Eltham, in Kent. John married, secondly, Sarah, daughter and coheiress of William Paggen, Esq., of London, merchant, by whom he had three sons and six daughter. William Shaw, of Cheshunt-house, in Hertfordshire, Esq., who married Elizabeth, daughter and heiress of John Blandy, of Inglewood, in Berkshire, Esq.; 2. Paggen, a merchant, at Smyrna. 3. Peter, a merchant, at Aleppo; of the daughters, I. Judith was wife of Richard Arnold, Esq., deputy secretary at war; 2. Catharine, wife, first of the Rev. Mr. Thomas-Davies Bovey, of Stow-hall, in Cambridgeshire, and, secondly, of Mr. John Spencer, paymaster of the East-India Company. 3. Mary. 4. Rebecca, of George Coldham, surgeon. 5. Jane, and 6. Anne, of Mr. Samuel Tomkins, of London, mercer.

III. Sir John Shaw, Bart., eldest son by the first wife, succeeded his father in dignity and estate, and married, September, 1716, Anna-Maria, eldest daughter and coheiress of Sir Thomas Barnardiston, of Ketton, in Suffolk, Bart., who died 1743 (by Anne, daughter of Sir Richard Rothwell, of Stapleford, in Lincolnshire, Bart.) by whom he had two sons and one daughter; John, who died an infant; Sir John, his successor; and Anna-Maria, the wife of Peter Delme, Esq., son and heir of Sir Peter Delme, Knt., Lord-mayor of London, member of Parliament for Luggershal, in Wiltshire; she died, May 24, 1740. Sir John, dying March 4, 1738-9, was succeeded in dignity and estate by his only surviving son,

- IV. Sir John Shaw, LL. D., Bart, born November 22, 1728, who married, February 4, 1750, Elizabeth, daughter of William Hedges, of Alderston, in Wiltshire, Esq., by whom he had one son, John, born December 22, 1750, and died May 16, 1661. Sir John Shaw married, secondly, 1752, Martha, daughter and heiress of John Kenward, of Yalding, in Kent, Esq. (niece of Sir Gregory Page, Bart.) who died his widow in 1794, by whom he had three sons. 1. Sir John-Gregory, his successor. 2. the Rev. John-Kenward Shaw, vicar of Eltham. 3. John Barnardiston Shaw, who died young, 1757. Sir John died 1779, and was succeeded in title and estate by his son,
- V. Sir John-Gregory Shaw, Bart., born July 25, 1761, who married, 1782, Theodora, daughter of the late Lord Monson, by whom he has four sons and two daughters.

LINEAGE.

(son of John Shaw, Esq., of London, and of Shaw's Court, in Surrey), having rendered most essential services to King Charles II, by the advance of money during that prince's exile, became one of the farmers of the customs after the Restoration, and was created a Baronet on the 15th of April, 1665. A SCOTCH SHAW.

Shaw, Sir James, Baronet, of Kilmarnock, in the

county of Ayr; b 26th of August, 1764.

This gentleman, who was a merchant of London, having been elected alderman in 1798, and having served the office of Sheriff in 1803, was chosen Lord-Mayor of London in 1805, when he had the honor of entertaining his present Majesty, then Prince of Wales, attended by his royal brothers and a long train of nobility, at a civic feast in the mansion house. He, subsequently, represented the city of London in Parliament, and was created a Baronet on the 21st of September, 1809, with remainder to John Shaw, Esq., of Whitehall-place, in the city of Westminster.

SOME SCOTCH SHAWS.

Shaw, a surname, the origin of which in Scotland, says Nisbet, is commonly attributed to one Shaw, second son of Duncan, Earl of Fife, who was cupbearer to Alexander III, and whose descendants assumed their surname from his proper name, and their armorial bearings from the badge of his office. In England the word Shaw means a small wood or copse. In the county of Dublin, Ireland, there is a family of the name of Shaw, possessing a baronetcy, which were originally Scotch, and formed part of the clan Chattan.

In the Ragman Roll is the name of William de Shaw, one of the barons who swore fealty to Edward I. in 1296. He was the progenitor of the Shaws of Hailly and Sornbeg, an old family in Ayrshire. The principal family of the name was that of Shaw of Sauchie, Stirlingshire. John Shaw of Sauchie was comptroller to James III. The lands of Greenock were acquired in marriage by one of his progenitors with one of the coheirs of Galbraith of Greenock in the reign of Robert III. In the reign of James V. Alexander Shaw of Sauchie gave the lands of Greenock in patrimony to John Shaw, his eldest son by his second wife, Elizabeth, daughter of William Cunningham of Glengarnock. The family of Sauchie failed in succession about the end of the seventeenth century, and have since been represented by that of Shaw Stewart of Greenock and Blackhall. (Nisbet's Heraldry, Vol. i, p. 43).

The family of Shaw of Bargarran, Renfrewshire, derived their descent from a younger brother of the family of Sauchie. The remarkable case of Christian Shaw, a daughter, eleven years old, of John Shaw of Bargarran, who in the end of 1696 and beginning of 1697, represented herself as being grievously tor-

mented by witches, is one of the most extraordinary in the annals of witchcraft in Scotland. In the Old Statistical Account it is stated that "one of the last trials for witchcraft which happened in Scotland, had its origin in this parish in 1696-7. The person supposed to have been bewitched or tormented by the agency of evil spirits, or of those who were in compact with them, was Christian Shaw, daughter of John Shaw of Bargarran, then about eleven years of age. A short account of this trial may be seen in Arnot's "Collection of Criminal Trials." Three men and four women were condemned to death, as guilty of the crime of witchcraft, and were executed at Paisley. This may furnish ample matter of speculation to those who object it is to trace the progress and variation of manners and opinions among men. The subsequent history of this lady is, however, more interesting to the political inquirer. Having acquired a remarkable dexterity in spinning fine yarn, she conceived the idea of manufacturing it into thread. Her first attempts in this way were necessarily on a small scale. She executed almost every part of the process with her own hands, and bleached her materials on a large slate placed in one of the windows of the house. She succeeded, however, so well in these essays as to have sufficient encouragement to go on, and to take the assistance of her younger sisters and neighbors. The then Lady Blantyre carried a parcel of her thread to Bath, and disposed of it advantageously to some manufacturers of lace, and this was probably the first thread made in Scotland that had crossed the Tweed. About this time a person who was connected with the family happening to be in Holland, found means to learn the secrets of the thread manufacture, which was then carried on to great extent in that country, particularly the art of sorting or numbering the threads of different sizes, and packing them up for sale, and

the construction and management of the twisting and twining machine. This knowledge he communicated on his return to his friends in Bargarran, and by means of it they were enabled to conduct their manufacture with more regularity, and to a greater extent. The young women in the neighborhood were taught to spin fine yarn, twining mills were erected, correspondences were established, and a profitable business was carried on. Bargarran thread became extensively known, and, being ascertained by a stamp, bore a good price. From the instructions of the family of Bargarran a few families in the neighborhood engaged in the same business, and continued it for a number of years. It was not to be expected, however, that a manufacture of that kind could be confined to so small a district, or would be allowed to remain in so few hands for a great length of time. The secrets of the business were gradually divulged by apprentices and assistants. Traders in Paisley availed themselves of these communications, and laid the foundation of the well-established and the extensive manufacture of thread, which has ever since been carried on in that town."

A SCOTCH FAMILY.

A family of the name of Shaw was settled at the farm of Mosshead, parish of Riccarton, Ayrshire, since the fifteenth century. One of its descendants, Sir James Shaw, baronet, alderman and city chamberlain of London, was born there, 26th August, 1764. In his fourth year his father removed to Kilmarnock, about two miles from Mosshead, where he opened a public-house. In the 16th or 17th year, young Shaw went to America, to fill a situation in a commercial house procured for him by his brother, David Shaw, who was secretary to General Crosbie, barrack-master

at New York during the revolutionary war. He afterwards returned to Britain, and became a junior clerkin a mercantile house in London, and by diligence and ability gradually rose till he became a partner in the firm. In 1798 he was elected alderman for the ward of Portsoken. In 1803 he served the office of sheriff, and in 1805 he was elected lord mayor, the first Scotsman that had ever filled that situation. The following year he was chosen one of the members of the city of London, which he represented till 1818, when he resigned his seat. On 21st September, 1809, he was created a baronet. On 14th January, 1813, he obtained a second patent, with remainder to his nephew, John McFie, son of John McFie of Greenholm, Ayrshire, by Margaret, sister of Sir James. His nephew had assumed the name of Shaw, by royal sign manual, October 6, 1807. In 1831 Sir James was appointed chamberlain of the city of London, when he resigned his aldermanic gown. He died October 22, 1843, in his 79th year. He was extremely charitable, and particularly liberal in his donations to the people of Kilmarnock, in which town a monument was soon after his death erected to his memory. He was succeeded by his nephew, above mentioned, Sir John Shaw, 2d baronet, born December 21, 1787.
