

THE "SPRINGER" COAT OF ARMS.

(FROM RIESTAP'S ARMORIAL GENERAL.)

ESCUTCHEON ON SHIELD—The first and fourth quarterings. Sable: a stag (Or) springing, counter passant forward and upward; stag sustained by a hill, (1'ert). The stag is of the kind called Springer or Springbock: and indicates courage, enterprise and endurance, as well as the name of the family entitled to wear the arms. The second and third quarters, Argent: with bars, Azure.

HELMET—Showing honors of knighthood; with head, neck and shoulders. Vizor down.

CROWN—Showing royal line. Crown of the royal house of Loraine

CREST—Stag issuing from between two wings expanded and conjoined, cut evenly off at tip. Wing over face of helmet. Sable and Or; body of wing Sable, border around edge, Or. The other wing Argent, with border Azure. These two wings with stag represent the Springer ancestry who ruled the eastern and western empires. The two wings conjoin in the crown of Loraine. The wings cut off at tip indicate that the Springer family became deprived of hereditary royal rights.

The Springer Genealogy

Compiled by REI'. IS.IAC E. SPRINGER, D.D.

We have biblical warrant for the compilation of a Family Geneology. Aside from legal purposes, they have a valuable moral mission. Heredity has an unconscious influence in the currents of traits and tendencies; and a very conscious one upon our feelings as we come to historically face the virtues and vices of our ancestry. Thus, a family genealogy may be at once a pleasure and a mortification; and so a valuable good may grow out of an ancestral retrospect. It ought to arcuse a dislike for the vices, and an appreciative desire for the virtues of the ancestry. It ought to awaken a realization that our own personality will live in its influences through succeeding generations. And it ought to stimulate a desire both to improve upon the past and to be worthy of the future.

In compiling this genealogy, there has been scant pleasure in noting the royal lines. Our highest glory must ever be in personal character, not in official position. To each one is given the privilege of being sons and daughters of the Lord God Almighty, the King of kings and the Lord of lords; and through His divine grace being made "kings and priests unto God," and reigning with Him forever and ever.

Interested parties have given careful research into the public and family records, in tracing the Springer genealogy. While there is no break in the list of personalities, there is incompleteness at times with regard to details; sometimes but little more than the name and relationship. This will account for the meagerness ir some of the entries.

It is desirable to give the Springer pedigree far back of the Springer family name. It should be remembered that prior to the Norman conquest in 1066 very few German or Frank people bore a family name Usually, like the people in bible history, people had but an individual name, with no family cognomen. Wher family names did arise, they grew out of some loca circumstances; such as color, location, occupation, personal peculiarities, etc. The family name of Springer began in this particular line with Louis (or Ludwig) the Springer, in the beginning of the twelfth century as hereafter narrated. But the pedigree of that Springerhas been traced back to the fifth century of the Christian era; and this account begins then.

- 1. PHARMOND. First king of the Sigambi German tribe which was eventually incorporated with the Franks. Began his reign A. D. 420. Died A. D. 427.
- 2. CLODIO. Son of Pharmond. Succeeded to the kingship of the Sigambi tribe. Died A. D. 448.
- 3. ALBRO. Son of Clodio. A younger son; so did not succeed to the kingship, but was a prince with the title of Duke of Moselle.

- 4. VANBURTUS. Son of Albro. Duke. Became an ecclasiastic. Was Bishop of Mentz. Died A. D. 528.
- 5. ANSEBERT. Son of Vanburtus. A Noble of the realm. Died A. D. 571.
 - 6. ARNOLD (1). Son of Ansebert. Marquis.
- 7. ARNOLD (2). Son of Arnold (1). Marquis. Bishop of Metz.
- 8. ANSEGISE. Son of Arnold (2). Mayor of the Royal Palace. This position was one of great power, in which he largely influenced the policy of the kingdom; the "power behind the throne."
- 9. PEPIN of Heristal. Son of Ansegise. Mayor of the Royal Palace. Reigning Duke of the Austrasian Franks. Founder of the Carlovingian line of Frankish kings.
- 10. CHARLES (Martel). Son of Pepin of Heristal. Born A. D. 689. Reigning Duke of Austrasia. Mayor of the Royal Palace. In command of the royal forces, he successfully resisted the invasion of the Saracen Arabs, A. D. 732, in the battle of Tours, Poitiers; one of the decisive victories in the world's history. For this, Charles was called "Martel," the Hammer. Died A. D. 741.
- 11. PEPIN (the Short). Son of Charles Martel. Born A. D. 714. Reigning Duke of Austrasia. Mayor of Royal Palace. Assumed the crown as King of Franks (now France), A. D. 752. The Emperor of the East demanded the restoration of certain territory to the Lombards. Pepin collected the keys of all the cities in the disputed territory and sent them to the Pope;

thereby giving the temporal sovereignty of those cities to the Pope, and securing his political favor and military aid. This famous "donation of Pepin" became "the patrimony of St. Peter," and foundation of the temporal sovereignty of the papacy. The Pope conferred on Pepin, in return, the title of Patrician of Rome. Pepin died A. D. 768.

- 12. CHARLEMAGNE. Son of Pepin the Short. Born A. D. 742. King of France. He subdued the Saxons in Germany, and became their king, A. D. 777. Invaded and subdued Lombardy in A. D. 778, and became their king—"Charlemagne of the Iron Crown." He attained a great reputation as soldier, statesman, and founder of the German Empire. His sovereignty included the kingdoms of France, Germany, the Netherlands, and parts of Italy, Hungary and Spain. Died A. D. 814.
- 13. LOUIS (1). Son of Charlemagne. Born A, D. 777. Called "Le Debonaire." King of France, and Emperor of the West, which included Germany.

GERMAN LINE.

At this point the Springer pedigree divides into two lines—French and German; to be reunited later. The German line ran as follows:

14. LOUIS (2). Son of Louis (1), Le Debonaire. Became king of Germany. Married Emma, of the royal house of Spain. Died A. D. 875.

- 15. CARLOMAN. Son of Louis (2). Became king of Bavaria. Died A. D. 880.
- 16. ARNULF, or ARNOLD. Son of Carloman. King of Germany. After a series of brilliant military victories, was crowned Emperor through the influence of Pope Formosus.
- 17. LUITGARDA. Daughter of Arnulf. Married the illustrious Otto, Duke of Saxony.
- 18. HENRY (1) the FOWLER. Son of Otto and Luitgarda. Born A. D. 876. Great confusion in Germany followed the deaths of the Emperor Arnulf and Kings Louis and Conrad. The General Assembly (or Diet) united in offering the crown to Henry. The Commission found him hunting, or fowling, in the Hartz mountains; hence the after designation of "the Fowler." He was a wise sovereign, brave and warlike. He added the Province or Dukedom of Loraine to Germany, and adopted its crown in his heraldry. Died A. D. 936.
- 19. GEBERGA. Daughter of Henry the Fowler. Married Louis IV (d'Outremer) of France Thus uniting the two Springer ancestral branches of the direct descendants of Louis I, King of France.

FRENCH LINE.

The French line (though unnumbered) will now be indicated.

CHARLES II. Son of Louis I, King of France. Born A. D. 823. Became King of France. Was called Charles the Bald. Died A. D. 877. LOUIS II. (The Stammerer.) Son of Charles II. King. Short and uneventful reign.

CHARLES III. Son of Louis II. Born A. D. 897. King of France. Married Edgifa, daughter of Edward the Elder, king of England, and granddaughter of King Alfred the Great.

LOUIS (d'Outremer). Son of Charles III and Edgifa. Born A. D. 919. Educated in England. King of France. Married Geberga, daughter of Henry the Fowler. Thus reuniting the German and French ancestral lines.

- 20. CHARLES. Son of King Louis and Geberga. Duke of Loraine. Heir to the throne of France; but prevented by Hugh Capet, his cousin, who usurped and held the crown. Hence the "clipped wings" in the crest of the Springer coat of arms. The genealogy so far, shows that this Charles represents royal ancestry of Germany, France. England and Spain.
- 21. LOUIS (or LUDWIG), the Bearded. Son of Charles, Duke of Loraine. Became Duke of Loraine and Count of Thuringia. In 1036, his relative Conrad, Emperor of Germany, appointed Louis titular ruler of Thuringia, as Landgrave; a title of great distinction, and conferring certain judicial powers. Died A. D. 1056.

LOUIS THE SPRINGER.

We have at last reached the interesting personage in whom the Family name began; and a larger space will be given to the account. 22. LOUIS THE SPRINGER. Ludwig, the German form of the name. Son of Louis the Bearded. Born A. D. 1042. Count and Landgrave of Thuringia. He founded the towns of Frieburg, Neumberg, and Eisenach. In 1067 he built the mountain castle of Wartburg near Eisenach: the only royal castle of that period now surviving.

The Superintendent (or Palsgrave) of the visits and residences of the Emperor in the various palaces in Thuringia, was Count Frederick, whose wife was the beautiful Adelaide, daughter of Otto of Nordmark. One day while traveling in his chaise, Count Frederick was attacked and murdered by three Thuringian nobles: Deitrich and Ulrich of Dedenlaben, and Reignhardt of Reignhardt. In 1087 Louis married the widow Adelaide. This created the suspicion in the minds of Frederick's relatives that Louis may have been concerned in the murder of Frederick; and soon after the marriage they persuaded the Emperor Henry IV to permit Louis to be arrested. This was done, and he was imprisoned in the old castle of Giebrichtenstein, near Halle, by the side of the river Saale. Once securely imprisoned, Louis' enemies were content to thus get him out of their way, and never brought him to trial. His room was on the side of the castle which was flush with the river. One day, in A. D. 1089, about two years after his imprisonment, when the eye of the keeper was temporarily off from the prisoner, Louis made his escape by springing through the narrow embrasure in the wall which served as a window, into the river, and escaped,

He was afterwards retaken and brought before the Emperor, who expressed great admiration at his courage; pardoned him; restored to him the title of his estates, and in sport gave him the name of "The Springer." And thus the Family name of Springer began in this line of descent.

SIDE LINES.

Two side line items of general family interest may be given at this point.

One, concerns the States of Thuringia and Hesse. Through Louis (or Ludwig) and Henry Haspe, sons of Louis II, The Springer, the state of Thuringia continued under the ducal rule of the Springer line; and during the rule of Henry Raspe, the important State of Hesse was added to the Thuringian Graviate. Raspe was a reigning prince of the empire. The lineal descendants of The Springer ruled this territory for over seven hundred years; and only ceased to be a reigning family in A. D. 1886, when its territory was annexed to Prussia.

The other item concerns the House of Wettin. Herman Springer, great grandson of Louis The Springer. Count and Landgrave of Thuringia and Hesse, married the daughter of King Otto the Great. He died A. D. 1216. Juditi Springer, daughter of Herman, married Prince Dietrich, of the House of Wettin. Of this marriage, came Henry Wettin, the Noble; Count and Landgrave of Thuringia and Hesse. From this Henry descended the royal house of Wettin, represented in King

Edward, sovoreign of England. As Prince of Wales, Edward renounced the succession as heir presumptive to the royal Dukedom of Saxe-Coburg-Gotha, now (A. D. 1909), held by the Duke of Edinburg.

DIRECT DESCENT RESUMED.

The direct line of descent of the American Springers from Louis The Springer is now resumed:

- 23. CHRISTOPH LUDWIG (or Louis). Son of Louis The Springer. Born A. D. 1091. Count of Waldenburg. Died A. D. 1120.
- 24. WINFRIED SPRINGER (1). Son of Christoph Ludwig Springer. Born A. D. 1120. Count of Waldenburg. Died A. D. 1198.
- 25. WINFRIED SPRINGER (2). Son of Winfried Springer (1). Born A. D. 1142. Count of Waldenburg. Died A. D. 1221.
- 26. GOTTLOB HERMAN SPRINGER. Son of Winfried Springer (2). Born A. D. 1166. Count of Waldenburg. Died A. D. 1204.
- 27. CHRISTOPH GOTTLIEB SPRINGER (1). Son of Gottlob Herman Springer. Born A. D. 1191. Count of Waldenburg. Died A. D. 1249.
- 28. CHRISTOPH GOTTLIEB SPRINGER (2).
 Son of Christoph Gottlieb Springer (1). Born A. D.
 1217. Count of Waldenburg. Died A. D. 1289.
- 29. CHRISTOPH GOTTLIEB SPRINGER (3). Son of Christoph Gottlieb Springer (2). Born A. D. 1240. Count of Waldenburg. Died A. D. 1296.

- 30. GOTTFRIED SPRINGER (1). Son of Christoph Gottlieb Springer (3). Born A. D. 1272. Count of Waldenburg. Died A. D. 1340.
- 31. GOTTFRIED SPRINGER (2). Son of Gottfried Springer (1). Born A. D. 1298. Count of Waldenburg. Died A. D. 1363.
- 32. GOTTFRIED SPRINGER (3). Son of Gott-fried Springer (2). Born A. D. 1323. Last Count of Waldenburg in this line. Died A. D. 1399.
- 33. JOHAN GOTTFRIED SPRINGER. Son of Gottfried Springer (3). Born A. D. 1348. Married Gertrude Heller. Died A. D. 1399.
- 34. JOHAN JACOB SPRINGER. Son of Johan Gottfried Springer. Born A. D. 1385. Married Dorothy Fisher A. D. 1415. Died A. D. 1464.
- 35. DANIEL WILHELM SPRINGER. Son of Johan Jacob Springer. Born A. D. 1432. Married Matilda Strubing A. D. 1460. Died A. D. 1493.
- 36. FRANGOTT LEBRICHT SPRINGER. Son of Daniel Wilhelm Springer. Born A. D. 1468. Married Eliza Catherine Pressley. Died A. D. 1519.
- 37. JOHAN JACOB SPRINGER. Son of Frangott Lebricht Springer. Born A. D. 1496. Married Eliza Catherine Histenfelt. He was contemporary with Martin Luther; and was the owner and occupant of the castle in the Wartburg in which Luther found a retreat from May. A. D. 1521, to March, A. D. 1522. Died in A. D. 1531.
- 38. JOHAN CHRISTIAN JACOB SPRINGER. Son of Johan Jacob Springer. Born A. D. 1520.

- 39. CHRISTOPH CHRISTLIEB CHRISTIAN SPRINGER. Son of Johan Christian Jacob Springer. Born A. D. 1550. Died A. D. 1630.
- 40. CERISTOPHER SPRINGER. Son of Christoph Christlieb Christian Springer. Born A. D. 1592. By the treaty of Westphalia, A. D. 1648, certain German territory was ceded to Sweden. Christopher Springer lived in this ceded territory, and so became a subject of the Swedish sovereign. He finally removed to Stockholm; attracted attention by his eminent abilities; received high offices under the crown; and attained to many estates.

THE AMERICAN SPRINGERS.

Three sons of the above Christopher Springer came from Stockholm and settled in America. The compiler of this record has no information at hand as to whether these three brothers—Lorenz, Carl (or Charles), and Jacob—came together or at different times. The eldest, LORENZ, was born A. D. 1616. Settled in America in Rhode Island. Died A. D. 1701; and was buried at Tiverton, R. I.

The youngest son, JACOB, was born in Stockholm, Sweden, A. D. 1668. Settled in America on Long Island, N. Y. Died A. D. 1731.

The farther line of descent for this compilation, will be that of the other son, CARL (or Charles):

11. CARL (or Charles) SPRINGER. Son of Christopher Springer. Born in Stockholm, Sweden, A. D.

1647. When twenty years old, he was sent to London to study English, and became an inmate of the Swedish Ambassador. One night he was seized by a band of ruffians, "shanghied" on board a merchant vessel, carried to Virginia, America, and sold as a "labor slave" for the term of five years. At the expiration of the five years, he found his way to Wilmington, Delaware, where was a small colony of Swedes. He attained an honorable position in the community, and held positions of trust. He was devotedly religious, and greatly aided the Swedish Lutheran church at Wilmington. He died at Wilmington, Del., A. D. 1738, at the age of 91.

Much interest has gathered around the question of a supposed vast "Springer estate." presumed to have been accumulated and left by this Charles Springer. The following from the newspaper Every Evening, Wilmington, Del., date of Dec. 8, A. D. 1908, probably sets forth the exact facts:

NO RECORD OF A SPRINGER ESTATE.

A great deal has been published about the mythical Springer estate, which, some persons appear to believe, comprises land in and near Wilmington to the value of from \$75,000,000 to \$100,000,000, representing what was reported to have been once owned by Charles Springer, a resident of Wilmington about 200 years ago. His heirs in all parts of the world have been interesting themselves in the report from time to time, and cently many have written to the local authorities, attorneys and others for information on the subject, some

believing that the estate is about to be settled and others being of the opinion that all that is required is a little effort on their part. In a recent publication in a Canadian newspaper one of the heirs was reported as saying that he understood that Mr. Springer had leased the land to "the Anglican church in Wilmington" for 99 years and as the lease had expired the land would soon become the property of the heirs. As this was evidently confused with the land purchased by Old Swedes Church early in its history, inquiry was made of Charles M. Curtis, an officer of the church, who has access to the church records, as well as the public records, for information concerning the church property, and Mr. Curtis has very kindly furnished the following information, which clears up the myth:

Editor Every Evening: Your representative asked me about the Springer claims, but I never heard of the claims of descendants of Aaron Springer or of the matters referred to in the Canadian newspaper, but I know that the claims of Springer heirs to valuable land in Wilmington have ceased to be a joke and have become almost a nuisance—for county officers, judges, the mayor and other city officials, as well as lawyers have been besieged with inquiries about these vague, fictitions and clusive claims to great wealth. In one fortnight one law firm had visits from two Iwayers representing associations organized to press the claims, one lawyer from Michigan and the other from District of Columbia, and the inquiries by letter are frequent. What is it that is claimed? No one seems to know. In some way the claims are connected with Charles

Springer or Charles Christopher Springer, as he was also called. The claimants think that Springer owned a large tract of land and in his life time leased it for a long term of years, which has or is about to expire, whereby the title to the land will be vested in those who now constitute the heirs at law of Springer, the lessor. This is about as definite as the claim is usually made. No one has ever found such a lease on record at the County court house, and its existence is probably mythical. There are of record conveyances of land in this county to Charles Springer, and also conveyances of land from him, and it is probable that the conveyances of records made by him do not cover all the conveyances to him, and on the record it may be that he was entitled to land at the time of his death. But there are diculties apparently insurmountable, though the loss of some of the deed record may account for the appearance of ownership, in the way of heirs who try to get the land. (1) The land must be identified and located; (2) the statutes of limitations would prevent suit being brought to recover the land if it could be found, for it must be remembered that Charles Springer died in 1738, now nearly 170 years ago, and by the laws such suits must be brought within 20 years of the accruing of the right, so that even making the widest and most liberal allowance for the claims of minors and married women, the time within which suit could be brought would seem to have long since elapsed beyond any possibility of extension, revival or rejuvenation; (3) the difficulties of identification of the claimants.

Charles Springer left no will of record here, though he died here and was buried in the churchyard of Holy Trinity (Old Swedes Church), probably under one of the walls of the south portico, built after the church was erected to prevent the spreading of its walls. No letters of administration were issued upon the estate of Springer, and there is no record of any settlement of this estate here, if he left any. The absence of a will or other evidences of the settlement of his estate would seem to indicate that he did not have very large possessions of worldly property in Delaware at his death.

In some way or other the Springer claims are supposed vaguely to relate to the land of Old Swedes Church, and the expiration of some lease or other figures in the myth. But nothing could be more abusrd than the asserting of any right to any church land by anyone claiming under Charles Springer. He was a very valuable member of the Swedish colony, and was described by Rev. Ericus Bjork, the pastor of the church, as a "plain, honest, pious man." Before the coming of Bjork in 1697, Springer had, as a zealous and devout layman, maintained divine services in the absence of a regular minister. Later he became one of the church wardens, and continued to be such until his death at the ripe age of 91 years.

His connection with the church land was wholly official, and he was faithful in the discharge of his duties. Shortly after the present church was completed, in 1699, the Swedish congregation turned their attention to the purchase of glebe land, or priest land, and John Stalcup agreed in writing on September 29th,

1699, with Rev. Ericus Bjorck, minister, and with Charles Springer and others, church wardens of the Christina congregation, to sell, for £160, 500 acres to the church for the minister to live upon. This agreement is recorded in the office of the recorder of deeds. John Stalcup, having died without making a deed, pursuant to the agreement, a deed was made May 18th, 1703, by Anne Stalcup to Charles Springer, church warden, or trustee. and his successor, for the Swedes congregation at Christina, conveying by metes and bounds two tracts of land, one containing 228 acres and the other 272 acres, and aggregating 500 acres. This deed is also recorded. In 1722 Jonas and Israel Stalcup, sons of John Stalcup, by deed conveyed to Charles Springer and others, church wardens, etc., a tract of land containing by metes and bounds about three acres adjoining the land on which the church has been built.

It will be noted that in all these transactions Charles Springer acted as church warden olely.

The glebe land above mentioned did not adjoin the church, and only one of the tracts can be definitely located, viz., the 228-acre tract, which can be exactly located and lies wholly within the present limits of the city of Wilmington. It began on the Christina river at Stalcup's Run, then up the run nearly parallel with Poplar street and west of it to about Seventh and Poplar; then in a northwest direction more than a mile to Rattlesnake Run, near Thirteenth and du Pont streets; then about at right angles to the south for 1,200 feet, about to Tenth and Lincoln streets, then

southeast at that width to Third and French streets, then southerly down French street to the Christina Creek, and thence easterly to the place of beginning. In general the land was boot-shaped and ran diagonally across the heart of the city. In several places, even in the built-up portions of the city, the lines are still observable. The present value of such a tract of land would, of course, be very large, but unfortunately little of it may be claimed by the church, and none of it by any heir or descendant of Charles Springer.

Willingtown was founded about 1735, and after William Shipley became interested in developing the new town, the church people took steps to boom their property on the real estate market by appointing a trustee to act with two of the church wardens in leasing the land to those desiring building lots. Charles Springer was one of the church wardens charged with the dtuy, and until his death, in 1738, disposed of part of the land within the new town for the benefit of the church. These conveyances were in the form of ground-rent deeds.

Later the land was put in the hands of Timothy Stidham, Henry Colesberry and Andrew Tranberg to sell outright, and they made numerous sales and deeds. In 1759 the charter was granted for the congregation and all the title to all the unsold land was vested in the corporation, since which time all conveyances have been made by the corporation. After the granting of the charter, most of the conveyances made of parts of the church land were leases for 2,000 years and some few for 99 years.

The making of these long-term leases has evidently given rise to the queer notions which prevailed as to Charles Springer's interest. The general lease was made to or by the church, as seems to be thought generally, and he never had any connection with the land except officially, and all his interest in it ceased at his death, and no estate or interest in it was transmitted to or is claimable by his descendants.

There are many things of interest concerning the church land, especially to lawyers, but as they have no relation to Charles Springer, they may be passed over. Enough has been told to show the unreality of any dream of wealth to be had by any Springer heirs from land of their ancestor in Wilmington. Still associations have been and probably will be formed to raise funds to prosecute this claim and it will be a great relief to many in Wilmington when the futility of such efforts will be widespread throughout all the tribe of Springers to the last generation. It is said that several years ago the late William G. Whiteley made an exhaustive examination of the claims, and by pamphlet or otherwise gave wide circulation to their mythical character, but this valuable contribution is apparently not accessible, if in existence. Many are curious to know something definite on this subject and the above is all that I can find out.

- SALLY SPRINGER, daughter of John Springer (1). Married John Peters, of Brighton, Champlain Co.; Ill. One of the Peters daughters, SARAH, married Michael Brown, of Brighton, Ill. Another Peters daughter, EMILY, married a Mr. Maghee. Another Peters daughter, MARTHA, married a Mr. Henderson; and their daughter married Mr. T. Springer, of Jacksonville, Ill.

SUSAN SPRINGER, another daughter of John Springer (1). Married a Mr. Burnett. The had two children: JAMES B. BURNETT and CYNTHIA BURNETT. Cynthia married Rev.
