THE SHERWIN FAMILY

The earliest record of any person by the name of Sherwin in New England is that of John Sherwin, of Ipswich, Mass. There is no doubt but what he was the common ancestor of all the Sherwins in New England, and possibly all in the United States. He settled in Ipswich as a single man, probably in 1666, for on January 13, 1667, the town granted him trees to make 300 rails to fence some land. There is no doubt but he had then just arrived in Massachusetts, or at least had not been there more than a year or such a matter.

On November 25, 1667, he married Frances Lomase, of Ipswich. She was the daughter of Edward Lomase. They both joined the church in full communion April 12, 1674. There are a number of other notings concerning him in "The Hammatt Papers, Early Inhabitants of Ipswich, Massachusetts," all commendable and relate mostly to church matters. To John and

Frances (Lomase) Sherwin were born the following children:

1. Robert, born — He settled in Vir-

ginia before his father's death.

2. Elizabeth, born ——. She married James Carlton.

3. Hannah, born —. No record of

marriage.

4. Ebenezer, born —. See following.

5. Mary, born in August, 1679. She married Caleb Foster, of Ipswich.

6. Frances, born 27th January, 1682. She married Isaac Cummings, of Ipswich. Some time after the birth of Frances, John Sherwin's wife, Frances, died, and he married for his second wife Mary Chandler, of Andover, Mass., on the 30th of September, 1691. She was the daughter of William and Mary (Dade) Chandler, and to them were born the following children:

7. John, born 1692. He died at Ipswich on the 13th of January, 1706.

8. Alice, born 21st January, 1694. I find no record of her marriage or death.

9. Abigail, born 4th May, 1695. She mar-

ried Isaac Fitts, jr., on Ivlarch 1, 1722.

10. Elenor, born 28th June, 1696. She married Jacob How, of Charlestown, Mass., on the 20th of January, 1722.

11. William, born 27th July, 1698. He married Mercy Cooker on the 30th of October, 1725. He died at Ipswich on the 14th day of February, 1741.

12. Jacob, born 17th October, 1699. I can

find no record of his marriage or death.

John Sherwin died at Ipswich on the 15th of October, 1726, aged 82 years—hence he was born in 1644 and was 23 years of age when he married his first wife, Frances Lomase.

The first four of the above-named children are not found in the record of births in the town records of Ipswich, where they were born, nor do they appear in Savage's Genealogical Dictionary. These omissions have been a stumbling block to all who have heretofore made an attempt to trace the ancestry of Daniel Sherwin, of Townshend, Mass. The names of these first four children of John and Frances (Lomase or

Loomis) Sherwin are revealed in the settlement of his estate, all of record in the Probate Court of Essex county, Mass., at Salem. His eldest son, Robert, was in Virginia at the time of the settlement of the estate, and his next oldest son, Ebenezer, had married and died at Boxford, Mass., leaving three children, who heired and received the share of the estate that their father would have received. The next oldest son was William, and he it was who administered upon the estate. The above-named Ebenezer Sherwin married Susannah Howlett of Topsfield, Mass., on the 1st of February, 1700. They took up their residence at Boxford, Mass., where were born to them the three following children:

- 1. Susannah, born 6th August, 1701. She married Mathias Cowdrey on the 20th of May, 1725.
- 2. Jonathan, born 8th January, 1704. He married Mary Lurvey on the 26th of November, 1728. He died at Boxford on the 6th of May, 1746.

3. Ebenezer, born 5th January, 1706. See

following.

The Ebenezer Sherwin who married Susannah Howlett died at Boxford between 1706 and 1712, as his estate was administered upon in the latter year, as shown by the Probate records for Essex county, at Salem.

Of the above-named children Ebenezer Sherwin married Hepzibah Cole on the 21st of September, 1726. Their first residence was at Boxford, Mass., where were born to them the following children:

1. Ebenezer, born 12th March, 1728. He

married Sarah Hovey.

2. Daniel, born 6th September, 1729. See following.

3. John, born 15th May, 1732. Died young.

All the above-named children were born in Boxford. Ebenezer and his wife, moved to Dunstable, Mass., with all of their family in 1746 or 1747, and in that town were born to them the two following children:

10. Sarah, born 18th February, 1748.

11. Jonathan, born 17th June, 1753.

Ebenezer Sherwin, the father of the foregoing children, died at Dunstable in 1763, and his wife, Hepzibah, died at the same place on the 1st of April, 1756. His son, Ebenezer, who had married and was living at Boxford, administered upon his estate. Guardians of the younger children were appointed by the Probate Court at East Cambridge. Jonathan, the youngest, after he was fourteen years of age chose his brother, Daniel, of Townshend, for his guardian. The foregoing information is derived from the town records of Boxford and Dunstable, and from the Probate records of Middlesex county, at East Cambridge, Mass.

What has been another "stumbling block" to those who have heretofore searched for the

ancestry of Daniel Sherwin, of Townshend, is found in the fact that an error exists in the town records of Boxford with regard to the name of one of the children born to Ebenezer and Hepzibah Sherwin. In those records Jonathan appears as the second child of Ebenezer and Hepzibah, whereas it should be Daniel. The proof that this error exists in the Boxford town records is found in three facts—first, Daniel was a son of Ebenezer and Hepzibah, as shown by the settlement of his, Ebenezer's, estate; second, Daniel was selected as the guardian of his youngest brother, Jonathan; and, third, the tombstone of Daniel gives the date of his birth the same as that given to Jonathan in the Boxford town records. The town records of Boxford show no record of the birth of any Daniel Sherwin, though it is certain that Ebenezer and Hepzibah had a son Daniel, who was born there; and that he was one of their older children is shown by the fact that he was appointed the guardian of his youngest brother, Jonathan, after his father's death.

Of the foregoing children of Ebenezer

and Hepzibah (Cole) Sherwin, Daniel Sherwin married Susannah Proctor. They took up their residence in Townshend, Mass., where were born to them the following children:

1. Daniel, born 3rd May, 1757. He married Abigail Manning, of Townshend. He, with his wife and family, moved to Chester, Vt., about 1793, and died in that town April 17, 1831. His family subsequently moved to Ohio.

Daniel Sherwin, sr., died at Townshend on the 25th of June, 1804, and his wife died at the same place on the 6th of July, 1813. Daniel Sherwin, sr., was at the battle of Bunker Hill and his two sons. Daniel and John, were in the Revolutionary army, as shown by the accomping certificates. Following is a copy of Daniel's

will. The executor gave a thirty thousand dollar bond.

In the Name of God Amen. I Daniel Sherwin of Townsend in the County of Middlesex & Commonwealth of Massachusetts, Gentleman, being weak in Body, but of sound Mind & Memory, do this tenth Day of Septr. Anno. Domini one thousand eight Hundred & three Make & publish this my Last Will & testament, in Manner Following that is to say.

Imprimis I Give to my beloved Wife the use of all my Household goods During her Life, and notwithstanding I have Made Provision for her support another way yet I also Give her thirty Dollars in Money, to be paid

by my Executor after my Decese.

Item my will is, that after my just Debts are paid by my Executor, hereafter named, all the Remainder of my estate both Real & personal, be Devided between all my Children within one year after my Decese, in the Following Manner, that is to say, my sons Daniel, John, Zimny, Salome, Azariah, Levi & Derias, to have equally between them including what thay

have had and receipted me for and to be Made up twice as Much as the Girls; and my Daughters Susannah Kidder, Lucy Spafford, & Martha Pritchard, to have Equilly out of my Estate & half as Much as the Sons; including the accoumpt which I have left of the things each Girl had at the time of their Marriage, and after the Deceace of my Wife my will is, that my household Goods be Devided by my Executor amongnst all my children in the same Manner that the other Estate is Devided and

Lastly I Do constitute & ordain my said Son Levi Sole Executor of this my Last will & testament in Testimony whereof I do hereunto set my hand & Seal the Day & year above

written.

The foregoing information has been derived from Townsend town records, from vital statistics of Middlesex county, and from the Probate records at East Cambridge, Mass., and from Ipswich, Andover, Boxford and Topsfield town records.
