


FOREWORD

The Material upon which this genealogical record of the Sutphen family in the United States is founded was originally collected by Mr. A. V. D. Honeyman of Plainfield, N. J., and was intended for use in the New Jersey Historical Quarterly of which magazine Mr. Honeyman was then editor. The Quarterly having suspended publication, Mr. Honeyman very generously placed his notes at my disposal, and they were collated and arranged by Mr. Louis L. deBoer, late archivist of the Holland Society.

There are, of course, many gaps, omissions, and probable errors in the record; but Mr. deBoer advises immediate publication, in the hope and expectation that members of the family into whose hands this volume may fall will send in their corrections and additions for incorporation in a second and future edition.

It will be seen that the record covers a period of two hundred and forty-six years, antedating by nearly a century the birth of the Nation. Nine American generations are enrolled, and there are listed at least two male members of the tenth generation.

NOTES ON THE HOLLAND ANCESTRY

COLLECTED AND ARRANGED BY

LOUIS P. DE BOER

THE ORIGINAL HOME of the van Zutphen family was the city and county of Zutphen in Gelderland; the name meaning South Fen or South Marsh. The numerous swamps and moors still existing around Zutphen sufficiently attest the origin of the cognomen.

During the reign of Julius Caesar these wild, half-submerged regions were inhabited by Saxon tribesmen. In the fifth century they separated themselves from their immediate kinsfolk, and joined the warlike league of men known as the "Franks." The Franks of Zutphen were called Salian Franks, and they were distinguished for their complete and authoritative system of jurisprudence. Many of them took part in the conquest of Gaul in the fifth century, the subjugated territory being renamed Frankland in France. Other Salian Franks crossed to Britain in the fifth, sixth, and seventh centuries, and aided in the establishment of the seven Saxon kingdoms which were later united under the generic name of England. The patronymic Zutphen or Sutphen¹ is not uncommon in the British isles.

¹ The spellings Zutphen and Sutphen are mere matters of Dutch orthography. The majority of educated Hollanders pronounce f and s where the modern orthography has v and z. For example, the words "fader" and "far" are spelled "vader" and "var," but are generally pronounced with the f sound. The orthographic change from f to v goes far back, but that from s to z is more recent; it took place gradually, beginning in the late seventeenth century, and reaching final adoption by the middle of the eighteenth century. Thus "Suyder See" became "Zuider Zee," "Sutphen," "Zutphen," and "self," "zelf." At this period the Hollanders in the English colonies of North America still spoke and read Dutch, and the orthographic changes were reflected in their family patronymics. Most of them, however, kept to the old spellings: "Suydam" did not become "Zuidam," nor "Swartout," "Zwartout." etc.

The early Saxons of the "South Fen" not only extended their relations South and West, but also to the North; in the time of Charlemagne ships from Zutphen made frequent voyages to Denmark. Finally these hardy adventurers found their way eastward into what is now Germany, a vast, unknown region sparsely inhabited by Wends and Huns, savage warriors who painted themselves blue and who lived in the depths of illimitable forests. In France these wandering Saxons became merged with the Gauls, in Britain with the Celts, and in Germany with the Wends; but around Zutphen their descendants still live unmixed in blood.

In the middle ages Zutphen flourished, and took an active part in the Hanseatic trading ventures; in the year 1300 ships from the "South Fen" frequented the Baltic provinces and the iron-bound coasts of Muscovy.

At the time of Charlemagne Zutphen was already an earldom, and continued to be invested with that dignity under the Saxon emperors. When the last earl of Zutphen died without male issue his only daughter, Ermingarde van Zutphen, married a count of Gelder, and Zutphen became one of the constituent parts of the later dukedom (now province) of Gelderland.

Seafaring and travelling in general makes for broadmindedness and the culture of the humanities. Accordingly, we find that learning and scholarship flourished among the merchant sons of Zutphen in the fifteenth and sixteenth centuries, and many of the younger scions of these great trading families dedicated themselves to the monastic life, and took an active part in the educational work carried on by the Church throughout the Low Countries.

Near Zutphen was the famous monastery of Windesheim where Gerard Groote lived and worked as the founder of the Brothers-of-the-Common-Life; he was also the author of one of the numerous books of religious devotion known under the general title of "Imitatio Christi." His school was one of the great agencies in bringing about the Re-

formation, and in nurturing the flame of religious and civil liberty that should later be carried across the seas to the Western world.

When, under the reign of Charles V in the sixteenth century, the Netherlands were finally united and the economical barriers between the numerous petty sovereignties were removed, the commercial importance of Zutphenin-Gelderland increased rapidly, and the sphere of its cultural influence became proportionately enlarged. It is at this period that the patronymic van Zutphen first appears in civil and ecclesiastical records.

In the year 1525 Arnold van Zutphen, a citizen of Amersfort in the province of Utrecht, established a regular freighting line on the river Rhine, between the cities of Utrecht and Cologne. Even after the nominal union of the Netherlands the petty mediaeval lords along the great arteries of trade endeavored to maintain their local custom houses, levying taxes and imposts for the use of the roads and waterways; as a result, there were frequent conflicts of authority. It is recorded, for instance, that in 1527 cargoes belonging to Arnold van Zutphen were seized by one of these small river barons for non-payment of tolls. But the central authority had been steadily growing stronger, and the sequestered goods were quickly released.

In 1527 the name of Egbert van Zutphen appears on the registry lists of Hattem, a city on the Yssel river not far from Zutphen. He also was a shipowner, navigating the Yssel and the Rhine between Hatten and Cologne.

At this same period there lived in Utrecht a certain Gerrit van Zutphen, who may be regarded as the more immediate ancestor of the modern family. Together with Franz van Echten, he was sent, on May 24, 1521, to the city of Cleves to make a commercial treaty on behalf of the city of Utrecht; he is described as being "a man experienced in the knowledge and practice of law."

By the year 1517 the cause of the Church Reformation had made great strides throughout the Netherlands, and in 1521 the first criminal ordinances were published against it. The shortsighted Hapsburgian rulers of the ancient Burgundian territory were thus committed to the policy of destroying through religious intolerance the prosperity which had been created by political union and economic progress. Eventually their ruinous bigotry would lead to the war of Independence and to the birth of the Dutch Republic.

In 1543 the final barrier between separated Gelderland and the other provinces of the Netherlands fell with the death of the last duke of Gelderland, for many years a sovereign only in name. The Hapsburgian lord of the Low Countries, Charles V, immediately instituted religious persecutions in Gelderland, coincident with a more severe attitude towards the Protestants in all his dominions. and thousands of the most industrious, prosperous, and progressive citizens of the Netherlands began to leave the country. In 1544 occurred the first great exodus. refugees went either to England, where Edward VI was on the throne, or to the Western German states, where local Protestant princes were able to withstand successfully the emperor's intolerance. It was not until 1572, after the first victories of the Dutch arms, that these exiles and their descendants ventured to return to their native land; they settled chiefly in the free Northern Netherlands, and assisted the cause of Dutch independence by every means in their power. The revolt against the successor of Charles V. the even more bigoted and tyrannical Phillip II, gathered new impetus and spirit with every passing day. William of Orange, surnamed the "Silent," who was the owner of large estates in Brabant, Holland, Zeeland, and Gelderland, was the natural leader of the revolutionists. Under his inspiring guidance the war was prosecuted with increasing success, and after his death, in 1584, his son Maurice pressed onward to the final triumph of the Republican cause.

Among the Spanish strongholds along the Southern battlefront in Brabant was the walled city of Breda, since the thirteenth century a personal possession of the house of Nassau. In 1590 Maurice of Orange-Nassau decided to

attempt the recapture of this formidable fortress; its strategical importance made it a prize well worth acquiring. But the city was strongly garrisoned and impregnably fortified; the only chance was that craft might possibly accomplish what open warfare had failed to bring about.

The Spanish garrison of Breda was regularly supplied with fuel from the outlying countryside by means of small vessels which plied along the canals, and were admitted to the city through the carefully guarded watergates. The plan was to smuggle a small number of Revolutionary soldiers into the fortress by concealing them under the loads of firewood and peat blocks. Once within the city gate the comparatively small guard would be overpowered, and the way opened for the entrance of the Dutch army. Discovery, of course, meant certain death.

Volunteers were called for, and out of the many applicants sixty men were selected for this desperate adventure; among them was one soldier named Dirck van Zutphen, then about twenty-eight years of age.

The enterprise was a complete success, the Spaniards were driven out of Breda, and the evacuation of a large portion of Brabant and Zeeland followed, a welcome fillip to the spirits of the Dutch patriots. Only one of the sixty adventurers fell in the attempt. The surviving heroes were all commissioned as officers in the army of the Dutch Republic; also each man received a gold medal and freedom from taxes for life, provided he elected to settle at Breda.

Only one other Dutch-American family, that of van Nes, can claim the honor of being ancestrally represented, with the van Zutphens, in this daring deed of arms, one of the most picturesque episodes of the Dutch war of Independence.

Dirck van Zutphen (b. 1562.) seems to have belonged to that branch of the family which sheltered abroad after the edicts against the Protestants promulgated in 1543. By the year 1565, when renewed persecutions drove out several thousand people from the Netherlands, the refugee colonies in England, as well as those in Western Germany or the

Rhineland, had greatly increased. Churches of the Reformed faith were founded by these exiles in many places, among them the congregation at Franckendale in the Palatine. Fortunately the Franckendale parish records have been preserved, beginning with the year 1567, and they contain a number of entries relative to the van Zutphen family.

In 1598 mention is made of a Frans or Francois van Zutphen and of his wife Susanna. Prior to that date two sons had been born to them: Dirck Fransen van Zutphen (circa 1585), and Frans Fransen van Zutphen (circa 1593). In 1598 Francois van Zutphen appears as a baptismal witness for the child of Pieter Canon; and in 1601, for the child of Jacob Dietz; and in 1606, together with Jacob de Peyster, for the child of Jacob Edwards. New Amsterdam family names abound in the Franckendale records.

On September 1, 1601, Margaret, daughter of Francois and Susanna van Zutphen, was baptized in the Dutch Reformed Church at Franckendale. Susanna van Zutphen seems to have died shortly afterwards, and, in 1608, her widower was married en seconde noces, to a lady named Francyntje or Francina. Of this marriage was born a son, Daniel van Zutphen; he was baptized in the parish church on May 18, 1610. The name of Francois van Zutphen recurs several times in the register as a baptismal witness for some of his own grandchildren, the last entry being in 1617.

Dirck Fransen van Zutphen (b. 1685) married in 1609 Judith Damen. Their children were: Francina, baptized July 12, 1610, (witnesses, Pieter Damen and Francina, wife

¹ Members of the Damen or Daman family (Latinized Damannus) also lived at this period in the Dutch refugee colony at Cologne, where they intermarried with the Beeckmans. With the first dawn of Dutch liberty the Damens returned to the Netherlands, and in 1580 the Rev. Sebastian Damen was a colleague of the Rev. Wilhelmus Baudartius, the maternal grandfather of Wilhelmus Beeckman, the American ancestor of the Beeckman family. Both Damen and Baudartius were ministers of the Reformed Church which had been established in the newly liberated city of Zutphen. Other members of the Damen family returned from abroad, and settled in Utrecht. To this branch belonged Jan Damen, later a resident of New Amsterdam.

of Francois van Zutphen); Abraham, baptized December 16, 1611, (witnesses, Francois van Zutphen and Margarete, wife of Michael van Keerbergen Jr.); Judith, baptized July 19, 1618, (witnesses, Jan le Veau, and Judith de Fosse, wife of Michael van Keerbergen Sr. of Frankfort); Daniel, baptized September 3, 1620, (witnesses, Daniel le Veau, or de Voe, and Catherina, wife of Pieter Kip).

Susanna van Zutphen (b. 1591), daughter of Francois van Zutphen and Susanna his first wife, married Nathaniel de Cerf at Franckendale in 1611. Her husband was born at Franckendale in 1590, the son of Andries de Cerf¹ and Perina his wife. Their children were: Sara, baptized December 1, 1611, (witness, Francois van Zutphen Sr.); Elizabeth, baptized April 11, 1613, (witness, Francois van Zutphen Sr.); Peryna, baptized July 30, 1620, (witness, Perina van Oudenburg, the grandmother).

Francois van Zutphen Jr. (b. 1593), son of Francois van Zutphen and Susanna his first wife, married Anna Maria Becker at Franckendale in 1616. Their children were; Maria, baptized November 9, 1617, (witnesses, Dirck Fransen van Zutphen, the uncle, and Maria Becker, the grandmother of the child); Matheis, baptized January 30, 1620, (witnesses, Pieter Matheis, and Catalyntje de Veau, wife of Daniel de Veau).

In February, 1622, the name of Francyntje van Zutphen, widow of Francois van Zutphen Sr. appears as a baptismal witness at Franckendale; *ibidem*, July 11, 1622, Judith van Zutphen, widow of Dirck Fransen van Zutphen. This is the last of the van Zutphen family records at Franckendale; in all probability the troublous times compelled the Hollanders to seek a more secure place of refuge.

In the year 1618 the Thirty Years war broke out in

¹ This de Cerf family was connected by marriage with the van Harlingens. The mother of the Rev. Johannes van Harlingen, the American settler, was a de Cerf. The patronymic van Harlingen is preserved in the name of Harlingen, a small hamlet on the State highway between Somerville and Princeton.

Germany, still another phase in the series of religious conflicts of the seventeenth century. It was the culmination of the long struggle between the local Protestant princes and the head of the Holy Roman empire who, together with the Pope, stood for centralization and autocracy. France was on the side of the reactionists, and in 1622 a large French army invaded the Palatine; the Dutch settlers aided in the stubborn but vain resistance. Frederick V, prince of the Palatine, was a grandson of William the Silent on the distaff side; he joined forces with his uncle, Maurice of Orange-Nassau.

Prince Frederick had married Elizabeth Stuart, daughter of James I of England. In the year 1621 he had been elected king of Bohemia, and he endeavored to maintain his crown against the powerful opposition of the emperor. In 1622 his army sustained severe reverses in the field, and Frederick was obliged to take refuge in Holland. He reached the Netherlands in 1623, and made his residence in the province of Utrecht, surrounded by many other refugees from the Palatine. Having worn the crown of Bohemia for only one winter, he was familiarly known as the "Winterking."

Most of the dispersed Palatine troops took service in the army of the Dutch Republic against the common foe, for Spain, still at war with Holland, stood as a matter of course, with the Emperor, the Pope, and France against the free princes of Germany.

Maurice of Orange-Nassau died in 1625, and his younger brother, Frederick Henry, succeeded him as head of the Dutch army. He prosecuted vigorously the campaign on the East front (Westphalia), and also on the South front (Brabant). In 1629 he captured Bois-le-Duc, or s' Hertogenbosch, and the surrounding country, thus reclaiming a large part of the Netherlands for the Union.

The spirit of the Reformation, however, had been pretty well killed in rural Brabant during the long and cruel Spanish occupation. Virtually all of the freedom-loving population had left the country, leaving behind only a dull, unprogressive peasantry.

Immediately after Frederick Henry's success in 1629, the States-General of the United Netherlands began to repopulate Brabant with Protestant colonists. These were chiefly descendants of former Brabant refugees, not a few of them being Brabanders from the Palatine. Among the Holland-American families thus represented may be mentioned the Ackermans and the Kips.

Political and social conditions, however, continued to be uncertain in North Brabant, and the imported Protestant colonists never quite succeeded in making their footing good among the rural Catholic population of the province.

When the peace of Westphalia, in 1648, put an end to the conflict between Holland and Spain, and also terminated the Thirty Years war the boundaries of the Dutch Republic were finally fixed, and living conditions became measurably stabilized. But the Protestant settlers in North Brabant, immensely outnumbered by the Roman Catholics, grew more and more dissatisfied with their anomalous position; from 1650 onward there was a constant and increasing exodus to the Dutch colonies of North America and South Africa. The farmers among them went first, and emigrants from the State-General's military garrisons in North Brabant soon followed them.

One of these garrisons was Tongerle, and among the officers of the Dutch army stationed there was Jan van Zutphen, born circa 1600. He was a son either of Francois van Zutphen of Franckendale or of Dirck van Zutphen, the hero of Breda; the latter is the more probable, since Tongerle and Breda belonged to the same chain of fortresses. He had a son, Harmen Jansen van Zutphen, recorded as living at Tongerle in 1675, and his grandson, Dirck Jan van Zutphen, was baptized in the Dutch Reformed church of Tongerle in the same year. This Dirck Jan van Zutphen also followed a military career, and received a commission in the Dutch army, being stationed at the fortress of Sluys on the Brabant-Flemish border. It is known that he bore

three eight-pointed stars in his shield, and in the "Familienblad" (Vol. VII, p. 39) it is stated that his widow, Maria Oortberger, married, en seconde noces. Pieter Ruys at Sluys in Flandres, April 18, 1744.

A remarkable engraving of the arms of a certain Jan van Zutphen (A. D. 1637.) appears on a fraternity wine cup belonging to the "Illustre Société" of s' Hertogenbosch in Brabant. In the first and fourth, or paternal, quarterings are charged the familiar three eight-pointed stars of the van Zutphen family. This Jan van Zutphen was undoubtedly the father of Dirck Jansen van Zutphen, the progenitor of the American branch of the family, and the grandfather of Dirck Jan van Zutphen of Sluys in Flandres. Their common ancestor was probably Dirck van Zutphen of Breda.2

Dirck Jansen van Zutphen, who came to New Amsterdam (the present city of New York) circa 1676, was born at Tongerle in 1645. The Dutch villages on Long Island were, for the greater part, settled by immigrants of Belgian-Palatine and Wesphalian-Saxon descent. Many of these colonists had come by way of Utrecht, where their immediate ancestors had lived for several years prior to

¹ The following families, all originating from the neighborhood of Zutphen, bear three eight-pointed stars on the shields of their coat-armour:

1. Greverade	gold on blue
2. Piso	
3. Wolschatter	gold on black
4. van Zutphen	
5. van Huessen	

Of the above-named families Nos. 1, 2, 4, and 5 were represented in Colonial America. Greverade, Piso, and van Huessen sent cadets to Dutch Brazil prior to 1654, the most distinguished of these expatriates being Dr. Wilhelmus Piso, the botanist and naturalist. He was the author of "Historica Naturalis Brasiliana," written at the instance of the Dutch West India Co.

The coat-of-arms of the van Zutphen family is thus described in J. B.

Rietstap's "Armorial Général" (Second edition):
Zutphen (van), Hollande. De gueules à trois étoiles (8); cimier, une étoile d'or entre un vol de guelles et d'or. (Translation.) A red (shield) bearing three eight-pointed stars; crest, an eight-pointed star between two wings of red and gold.

² The record of Dirck van Zutphen may be found in the "Kronyken van het Utrechtsch Hist, Genootschap," (1861.) p. 124.

the general exodus. These Dutch exiles kept alive the memory of the old country by naming their tiny settlements "New Utrecht," "New Amersfort," and the like; and young van Zutphen naturally found his way to these familiar-sounding localities. In 1680 he married Elizabeth, daughter of Aucke van Nuys. Their children were: Hendrickje, b. 1681; Jacob, b. 1684; Jan, b. 1685 (died in infancy); Jan, b. 1687; Geertje, b. 1689; Dirck, b. 1689; Gysbert, b. 1693; Isaac, b. 169-; Abraham, b. 1696; Elsje, b. 169-; Elizabeth, b. 1699.

¹ Aucke Jansen van Nuys was a contractor and builder of considerable repute in the New Netherlands. He built a number of houses in New Amsterdam; also the First Dutch Reformed Church of Midwoud (now Flatbush), Long Island.

No. 1.—DIRCK JANSEN VAN SUTPHEN, the New-Netherlands settler, married, in 1680, ELISABETH (Lysbeth) VAN NUYS, daughter of Aucke Jansen Van Nuys.

No. 2.—Jacob Sutphen [Dirck]¹, bap. at Flatbush, L. I., Jan. 20, 1684, m. about 1716, Antje Bennet, (dau. of Adriaen Williamse Bennet and Angenietje Jans Van Dyck) of New Utrecht.

On Dec. 6, 1718, Jacob purchased 333 acres of land at "Wencougak," in Freehold township, Monmouth Co., N. J., from Jan Johnson, of New York City, (Monmouth County, Deeds, Book G, p. 50); at that time Jacob was stated to be of King's County, N. Y. He removed to Monmouth Co., N. J., between 1717 and 1721, as in the latter year he became a member of the Marlborough Dutch Church.

On Dec. 29, 1749, he sold to Archibald Crego 14 acres out of his farm. (Trenton Deeds, Book F. 2, p. 495.)

He inherited from his father the home plantation, and remained on it a number of years, becoming one of the important personages in New Utrecht. In 1713 he was made a deacon in the Dutch Church there, which office he held until 1717, when he removed to Freehold, N. J., whither his brothers Jan, Dirck, Guisbert and Abraham had preceded him. In 1721 his name appears upon the list of members of the Dutch Church at Freehold. On documents he signed his name "Jacob van Zutvin," or "Jacob Sutvin."



He settled near the old Tennent Church, and may be the Derick who served in the Revolutionary War, in Captain Waddell's Company, and in Captain Smock's Company.

His tombstone in the Tennent churchyard, gives his age at death as "in his eighty-fourth year." This would make his birth about 1712, and not 1717, as sometimes has been stated. The tombstone gives his wife's name as "Mary." His will of Jan. 7, 1795, probated July 21, 1796, ("Trenton Wills," Book 36, p. 60.), devised his farm to his sons,

JOHN and DAVID; and to JOSEPH, "the land on which he now lives." He signed the Will "Derick Sutfin." Some of his descendents spell their name "Sutphin."

Mr. Van Arsdalen was admitted to the Presbytery of New Brunswick, June 19, 1771, and in 1774 took charge of the church of Springfield, where he served for a quarter of a century, leaving it because of ill health, in 1801. No. 10.—Jacob Sutphen, [Dirck, Jacob], of Amwell, N. J., bap. at Marlborough, N. J., Nov. 6, 1720, twinbrother of William, who follows. He m. Nov. 12, 1741, Marietje Schenck, (dau. of Roelif Schenck and Engeltje Van Doren, of Monmouth Co.), who was b. June 3, 1720, and d. about 1755.

He removed from Monmouth to Hunterdon Co. about 1752 when he purchased several tracts of land, on one of which, of 220 acres near Lorison's Corner, he resided. He had a tract of 200 acres near Reaville. (See Snell's "History of Hunterdon and Somerset Counties," pp. 330, 354.)

Jacob's will, of May 3, 1802, probated May 6, 1806, (Hunterdon Wills, Book A. p. 132), states that his daughter, Margaret Smith, is deceased, his son, John infirm, and names many grandchildren. To Roelif (Ralph), he devised the homestead, called "plantation"; to the wife of John, the 172 acres on which John lives, during his life and her widowhood, after which it should go to Christian and Joseph, children of John. His son, Ralph, and grandson, Christian, were his executors.

One of his children, Elias Van Arsdalen, Jr., was b. in 1801, and graduated from Princeton in 1819. He was admitted to practice law in 1822; was clerk of Essex Co. 1827-1839, and on the death of his father, in 1846, succeeded him as president of the State Bank of Newark.

Another son, Jacob Van Arsdalen, of Newark, N. J., b. about 1817, graduated from Princeton in 1835, and in 1838 was admitted to practice law. He was prosecutor of the pleas of Essex Co., from 1852 to 1857.

Derick followed his brother, Guisbert, to Bedminster Township about 1749, as in that year he made two purchases of land "at Pepack." On Aug. 11, he purchased 139 7/10 acres of the Johnston tract, and on Dec. 29, added 63 acres from the Leslie tract. (Trenton Deeds, Book G., 2, pp. 446, 455). On the same dates Guisbert also purchased there. Subsequently Derick must have disposed of these tracts, as he owned in his later life, and resided on what was lately known as the Thomas Blackwell Farm at Burnt Mills.

In 1754 Derick was on the salary list of the Lamington

Presbyterian Congregation, but after 1758 he probably went to the Bedminster Church, where he was a deacon in 1766.

He was buried in the Bedminster churchyard and has a tombstone there. On it his name appears as "Dirick Sutfin." In a newspaper advertisement of 1758 his name is spelt "Zutfin." In his will he signed "Derick Sutfin."

His will of Mar. 29, 1775, probated May 1, 177-, (Trenton Wills, Book 18, p. 574), directs his realty to be sold, and therein names his children.

¹The name "Ryck" enters various branches of this generation. It is a medium between the official "Richard," and the unofficial "Dick." "Dick" wrongly was deemed to be identical with "Dirck." "Dirck" in its fuller forms is "Diederick," or "Theodo-rick," meaning "ruler of the people," while "Ric-hard" means "strong ruler." Liberally, we might translate "Richard" as "absolute ruler," and "Dirck" as "constitutional ruler." Such is the fate of names when no longer understood.

Sutphen (Dirck), of Freehold, who settled in Somerset Co. The records concerning him and his family have been more accessable than those relating to his brothers.

His children were all by the first wife, Ariaentje. Adriaentje Van Pelt came from the same Laenen stock as the Lane family of Bedminster. She was the daughter of Aert Teunisz Van Pelt, who was the son of Teunis Jansen Laenen (Van Pelt), brother of Matthias Laenen.

Guisbert and Ariaentje were first cousins, a Jan Aertse Van Pelt being a brother of Geertry Van Pelt, Guisbert's mother. Jan Aertse Van Pelt had married Feb. 8, 1716, with Catherine Hageman, of New Utrecht. Some data respecting them appear in Guisbert's family record, which is now in possession of the family of Arthur Peter Sutphen, Esq., of Somerville, N. J. (Oct. 3, 1841-March, 1911), Guisbert's great-grandson.

Guisbert's sister, Elizabeth Sutphen, (b. Feb. 18, 1723) married on the same day of Guisbert's first marriage (Nov. 18, 1743), with Matthias Lane, their Monmouth Co. neighbor. Both left the parental roof and sought farms in the best portion of Somerset Co., near the North Branch of the Raritan River. Guisbert is said to have gone first, but this is uncertain. Snell's "Hist. of Huntingdon and Somerset Counties," p. 705, says:

"He came to Bedminster Township about 1743, traveling with "a yoke of oxen and a cart, on which were his family, household "goods, and a chest of carpenter's tools. He first purchased a "tract of land containing about 300 acres on the Johnson and "Willock tract. This land he sold to his brother-in-law, Matthias "Lane, Sr., about 1745."

The date of his arrival and first purchase given here, may be correct, but it is doubtful if he made a sale of it to Matthias Lane, Sr. Matthias' known purchases are recorded elsewhere.

The only purchases of Guisbert were both made in 1749, simultaneously with those of his brother Derick Sutphen. Both purchases show he was there previously and that he

had a "house." In 1748, moreover, his name occurs on the salary list of the Lamington Presbyterian Congregation.

On Aug. 11, 1749, "Gysbert Sutfin, of Pepack," purchased of Johnston and Johnston 76 9/10 acres of land "at Pepack," beginning at Middle Brook; running S. W. "to the road that runs by the house of said Gysbert Sutfin, towards Peter Dumond, thence along the road S. W. over a stream to said Middle Brook." He also bought a tract of 79 9/10 acres, beginning at Middle Brook and adjoining George Leslie, Johnson, and Longstreet. (Trenton Deeds, Book G. 2, p. 448.) This is said to be the farm lately owned by William Heath, now deceased. It is true that this purchase and the next one, give the location "at Pepack," but in that time all lands north and west of the present Pluckemin (and perhaps even farther south), were designated "Pepack," and the term was not, as now restricted to the present Peapack and its vicinity.

On Dec. 29, 1749, "Gysbert Sutfin of Pepack" purchased of George Leslie and wife, of Perth Amboy, 101 1/4 acres "at Pepack" beginning at Middle Brook; adjoining "former land of Gysbert." (*Ibid.* p. 452). This same land and the Johnston land previously bought from some cause were again conveyed to him, Aug. 13, 1753, by Stephen, Thomas and John Crane of Elizabeth, for 35 pounds. Perhaps the title had been defective. This is said to be the farm owned by Amos Crater Sutphen and Sering P. Dunham in late years.

On May 30, 1751, he purchased of Johnston and Johnston, of Perth Amboy, 221 1/4 acres, adjoining his own land, Peter Dumond and Middle Brook, for £276.11.3. (Deed not recorded.)

On May 10, 1754, he purchased 68 acres of land of Derick Longstreet, for £202.15s., bounded by Longstreet, Derick Sutfin, and Hopstick brook. (Deed not recorded.)

On Feb. 12, 1762, he purchased of Albert Vorhais (Voorhees), of Bedminster, a small piece of land for £18.4s. (Deed not recorded), and Feb. 1,——, a small tract of Daniel Handy, of Tewksbury Township, Hunterdon Co., for £56. (Deed badly damaged and not recorded.)

In 1787 Guisbert was assessed for 338 acres of land. His will accounts for 340 1/2 acres, 233 on which he lived, (said to be the tract bought May 30, 1751, and 107 1/2 acres occupied by his son, Guisbert. The land on which he lived last and where he died, was certainly that, recently comprised in the farms of Amos Crater Sutphen and Zachariah Smith.

Guisbert Sutphen was early appointed Justice of the Peace, perhaps first in 1769. ("New Jersey Archives," Vol. 18, p. 23.) His docket from 1770-1773, and also a commission dated Sept. 13, 1776, are still preserved and are in possession of the Somerset County Historical Society. In 1782 he was again appointed Justice.

The family tradition is, that upon the breaking out of the Revolutionary War, he was so incensed at the royal authority under which he had been commissioned Justice of the Peace, that he burned up his commission, and enlisted in Capt. Jacob Ten Eyck's Company. But he was certainly re-commissioned later.

It is an interesting fact that Guisbert Sutphen, (b. 1720), his son Peter, (b. 1762), his son Peter, (b. 1800), his son, Arthur Peter, (b. 1841), and his son, William Ross Sutphen, (b. 1871), were all appointed or elected Justices of the Peace, although the second named Peter did not qualify, while his brother, Arthur Van Pelt Sutphen, former Surrogate, did. Had Peter qualified, it would have made five generations of justices in one direct line.

Guisbert could hardly have been in active service, as his years forbade it, although the Trenton records show a "Guisbert Sutphen in Capt. Duryea's Company, Somerset. But he was a member of the Township Committee of Observation and Inspection, and in 1775, with his co-committeeman, John Wortman, was sent to the Provincial Congress at Trenton, upon business of the Committee. The small expense of such a trip would be noteworthy in this day. (See Melick's "Story of an Old Farm," p. 289.)

When in the year 1756, steps were taken to erect a new

Lutheran Church in Pluckemin, one of the liberal subscribers to the fund was Guisbert Sutphen, although he was not a Lutheran. Evidently at that time Guisbert attended the Lamington Presbyterian Church, as he repeatedly contributed to it. His name also appears upon the early salary lists of that congregation in 1748 and 1758. (Also in 1782 and 1783, unless this was another Guisbert.)

When the Bedminster Reformed Church came to be built, (1758?), he offered two acres of land for the purpose, but the offer was not accepted. He also agreed to furnish one-half of the oak timber necessary for the frame, and this was accepted, the church's receipt therefor being yet in existence. For a number of years Mr. Sutphen was treasurer of this church.

The marriage bond entered into for Guisbert's second marriage, with Peternella Voorhees, dated Oct. 10, 1789, is now in possession of the family of Arthur Peter Sutphen, Esq. of Somerville. Singularly enough, it is not signed by him, but has her "mark."

Both Guisbert Sutphen and his first wife, Ariaentje Van Pelt, are buried in the Bedminster Church cemetery. His name appears on the headstone as "Guisbert Sutphen, Esq.," and hers as "Areantie, Wife of Guisbert Sutfen, Esq." Her tombstone gives her age at the time of her death (May 31, 1788) as 68 years, 3 mos. and 18 days. This would make her birth-date Feb. 11, instead of Jan. 11, 1720. But the family-record gives the latter date.

The inscriptive verse on Guisbert's stone is unique. It runs:

Age and disease in a throng
Attack'd his house that stood so long,
And mocking all attempts to prop
They tore the earthly fabric up.
Tho' dead, he speaks; and thus he cries:
"O friends, secure your house above the skies."

His will, made Jan. 11, 1790, and probated Dec. 10, 1796, is signed "Guisbert Sutfen." (Trenton Wills, Book 35, p. 520.) In it he mentions his wife "Peternelly," and his chil-

dren, Peter, Guisbert, John, Herchy (Gertrude), whom he states to be deceased, and having been the widow of Guisbert Sutphen, Esq. (having children Derick and Auriantje.), Catherine, (deceased, wife of Cornelius Powelson, whose children he gives as John, and "a sister."), and Eleanor, wife of Robert Blair.

His executors were his son Peter Sutphen, and his son-in-law, Robert Blair.

By this will he devised to his son, Guisbert, the 107 1/2 acres "whereon he now lives," and to Peter, the 233 acres upon which the testator lives. He directed his two slaves, Lina and Margery, to be sold.

The will also speaks of a bond he holds "against William Sutphen, of the State of New York." This is doubtless his grandson, son of John.

¹ Cornelius Powelson was b. June 28, 1748, and d. Feb. 21, 1822. His father's will of 1784 gives these as his children: John, Jean, Cornelius, Catherine, Anna, Abraham, Powel, Hendrick, Sarah and Minea. Guisbert Sutphen, Esq., was one of his executors.

Cornelius Powelson and his family resided on a farm north of Pluckemin, Somerset Co., N. J., known lately as the "John M. Brown Farm," which he sold to Abram Brown, Apr. 1, 1787. He appears as member of the Lamington Presbyterian Church prior to and in 1797. In 1802 he was elected Elder of the Bedminster Reformed Church.

After the death of his first wife, Catherine Sutphen, in 1790, Cornelius Powelson married, Eleanor Voorhees, (b. June 2, 1763; d. Jan. 18, 1851), by whom he had eleven children. His will of May 3, 1817, probated March 9, 1822, (Somerset Wills, Book C, p. 77), mentions most of his children. He and his first wife are buried in Bedminster cemetery. The children of Cornelius Powelson and Catherine Sutphen were: Elizabeth Powelson, (d. young), and John Cornelius Powelson, who spelt his name Powlison.

John Cornelius Powlison, of Galesburg, Mich., b. Jan. 24, 1788; d. May 5, 1859. He m. 1812, Catherine Van Arsdale, (dau. of Philip I. Van Arsdale and Margaret Wortman) b. July 25, 1789; d. Aug. 23, 1888, at Absaraka, North Dakota, in her one hundredth year. Mr. Powlison resided in New York City after his marriage, until 1818, when he removed to near Rochester, N. Y., and later to Michigan.

Peter, like his brothers, went to Somerset County. On May 17, 1750, he purchased of Peter Brokaw 200 acres of land in the vicinity of North Branch, and on Apr. 7, 1760, he sold 130 acres of the same to Peter Wortman. (Trenton Deeds, Book K 2, p. 97.) On May 1, 1760 he purchased of Andries Ten Eyck 298 1/2 acres in Bridgewater Township, on the west side of the North Branch of the Raritan, adjoining the East and West-Jersey partition line, and bordering on George Willock and Matthew Ten Eyck. (*Ibid.* p. 102.)

On Oct. 29, 1773, "Peter Sutfin," with Peter Dumont and others conveyed to Evert Duyckinck a mill property on the same North Branch of the Raritan. (*Ibid.* p. —.)

Peter and his wife attended the Readington Church. He united with it April 18, 1785, when sixty years of age.

Peter Sutphen's will of Mar. 20, 1778, probated June 1, 1797, (Trenton Wills, Book 37, p. 21.) mentions his wife, Catherine, and these children: John, Peter (deceased),

William Himrod was Captain of the Militia, in 1797; in 1801, Major; in 1804, Lieut.-Col., and Major-General during the War of 1812. He died at Ovid, N. Nicholas Van Zandt was b. Dec. 25, 1737 and d. 1805. His father, Bernardus Van Zandt, was b. in Holland, Oct. 3, 1700, and emigrated to America. He purchased 226 acres of land, near Blawenburg, N. J., and died there, Mar. 27, 1778. The farm descended from him to Nicholas, and from this to Capt. Bernardus.

Capt. Bernardus Van Zandt was b. Mar. 3, 1768 and d. Nov. 7, 1850. In 1809 Capt. Van Zandt was living on the homestead farm of his father adjacent to a childless farmer, James Nevius, and the latter persuaded him to leave the homestead and live with him. In 1811 Mr. Nevius died and willed his farm of 291 acres to Van Zandt, the latter to pay the nominal price of \$20 per acre. It is the same farm on which a descendent, the late James Nevius Van Zandt, recently resided. It is one of the best farms in Somerset Co., with attractive buildings. Capt. Van Zandt was Captain in the Militia in his earlier years.

The children of Capt. Bernardus Van Zandt and Sarah Sutphen were:



A marriage license issued Sept. 12, 1778, to one Jacobus Sutphen, of Somerset Co., to marry Elizabeth Voorhees, may indicate a second marriage, of the same Jacobus.

The parents of the last four children are given differently; James, bap. 1781, and John, bap. 1784, are given as sons of Jacobus and Elizabeth; the mothers of Nelly, bap. 1779 and William, bap. 1789, are given as "Maria" and "Sarah." (1), Feb. 8, 1764, Gertrude Sutphen, [Dirck, Guisbert, Guisbert], his first cousin, dau. of Guisbert Sutphen (No. 22) and Ariaentje Van Pelt. Her parents also were first cousins. She was born Oct. 14, 1745, and died March 26, 1788.

He m. (2) (supp.), JANE POWELSON, (dau. of Johannes Powelson and Horentje Messler), who was b. 1750, and d. 1831.

During the life-time, at least, of his uncle and father-inlaw, Guisbert Sutphen (No. 22), he went by the name of Guisbert Sutphen, Jr. It is believed that he was the Guisbert Sutfin, who in 1778, was appointed one of the judges of the Court of Common Pleas of Somerset County. His name also is frequently followed by "Esq."

After the death of his first wife, he is thought to have married Jane Powelson, as she was not married until after 1789, and she centainly was the wife of a Guisbert Sutphen, of Sussex Co., N. J., whose estate was administered by a Derick Sutfin, April 2, 1800. (Trenton Administrations, Book 38, p. 517.)

Guisbert, of Sussex, was a resident of Sandyston Township, where he was collector of that district.

The fact that Guisbert, son of Derick, does not appear in any other records relating to Somerset County; that having been a Judge in Somerset, he is likely to have been re-appointed for Sussex, after his removal there; that he had a son Derick, (as per Guisbert, Sr.'s his uncle and father-in-law's will in 1790); and that, after his widowed mother returned from Sussex in 1802, and joined the Bedminster Church, and Mr. John M(essler?), Sutphen also returned from Sussex, and joined the same church, making the identity of this Guisbert as good as complete.

to settle some property belonging to them and was never again heard from." About 1910, an old lady of over 80 years old, said that about 68 years before, when she was a girl of twelve, her parents lived at Hancock Co., N. Y., and had a neighboring family of John Sutphin, then middle-aged people. This John, she thought, might have been the missing brother of Joseph Sutphen.

Nothing is known of his children, than that there was a son Derick, and "his sister."

Jane Powelson afterward (before 1802) married Casper Berger, (?) of Readington, the hotel keeper there during the Revolution, a mill owner and large land owner. (See Snell's "Hist. of Hunterdon and Somerset Counties, p. 487.)

(Melick's "Story of an Old Farm," p. 290.)

This John Sutphen, the tavern keeper, is probably the same who served in Duryea's Company in the War of the Revolution. He resided on the David Dunham (now Sering P. Dunham) Farm.

He is known to have had a son: WILLIAM PHOENIX, who is prob. the same as the "William" mentioned in his grandfather, Guisbert Sutphen's (No. 22) will. He resided in the State of New York.
